[57] **CLAIM**

The ornamental design for bait cast fishing reel, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a bait cast fishing reel illustrating our new design;
FIG. 2 is a rear perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a front elevational view thereof;
FIG. 6 is a rear elevational view thereof;
FIG. 7 is a left side elevational view thereof; and,
FIG. 8 is a right side elevational view thereof.
The broken lines defining the boundaries of the claimed design form no part thereof and the broken lines directed to the remainder of the bait cast fishing wheel are for illustrative purposes only and form no part of the claimed design.

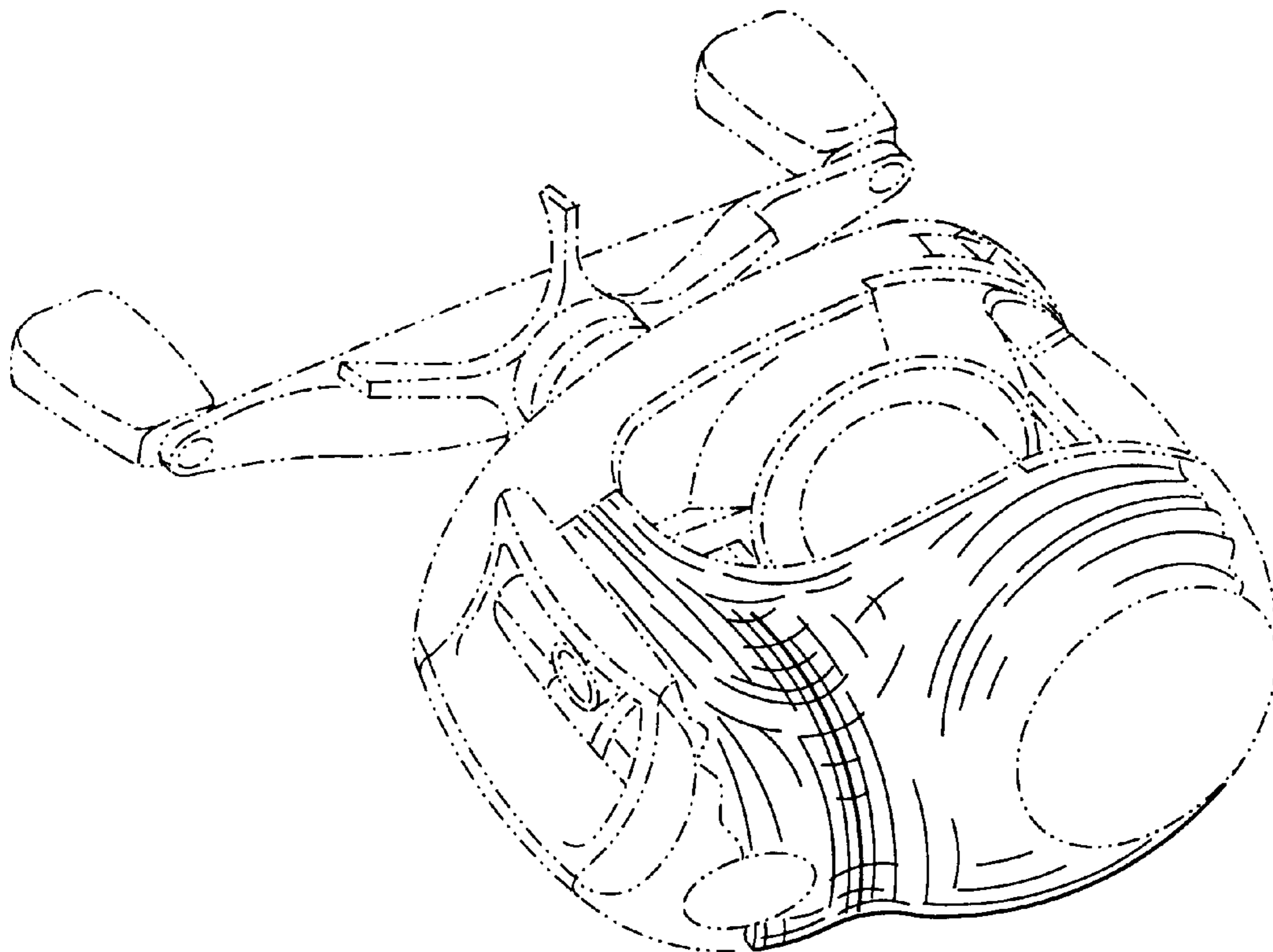

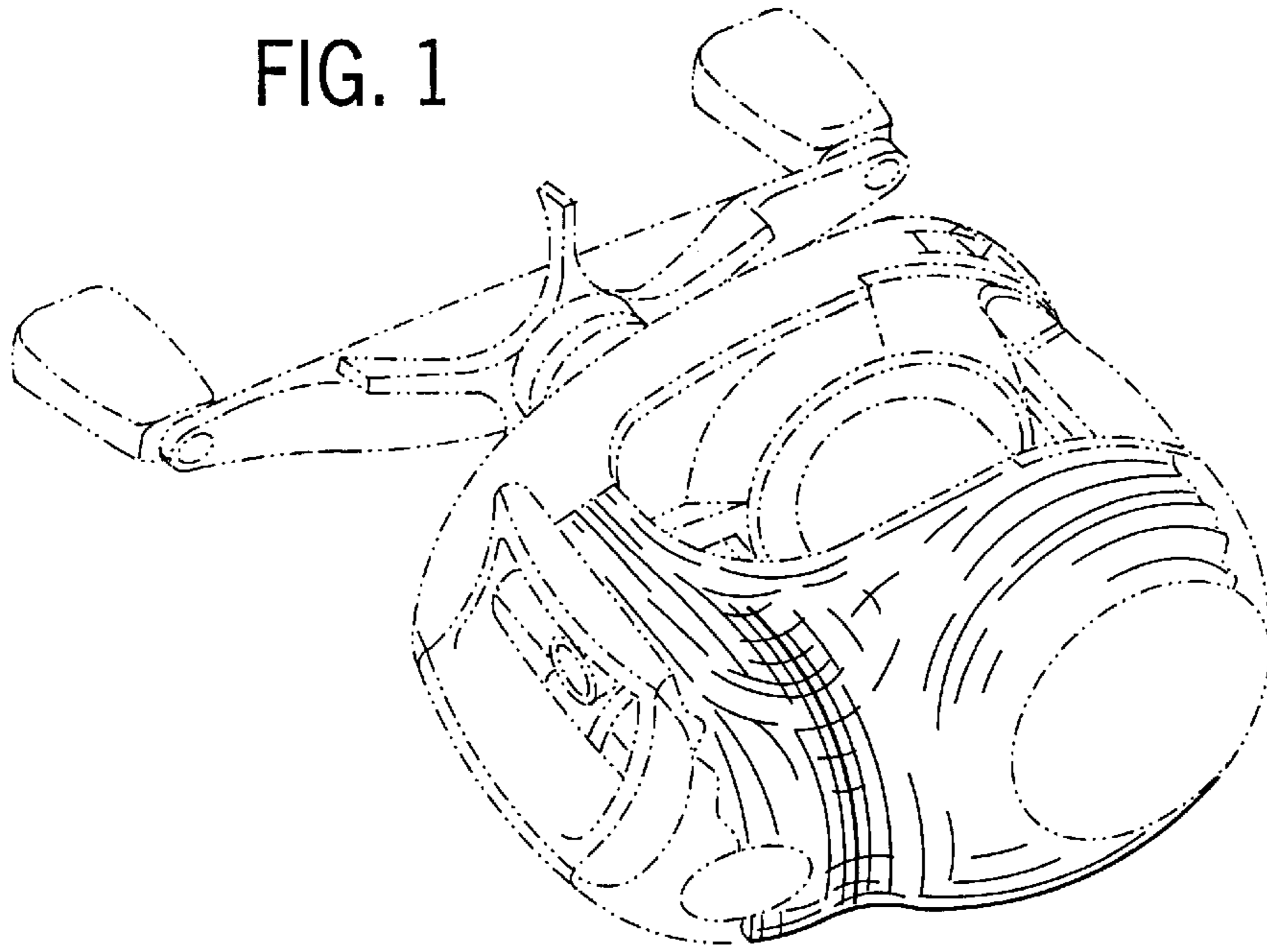

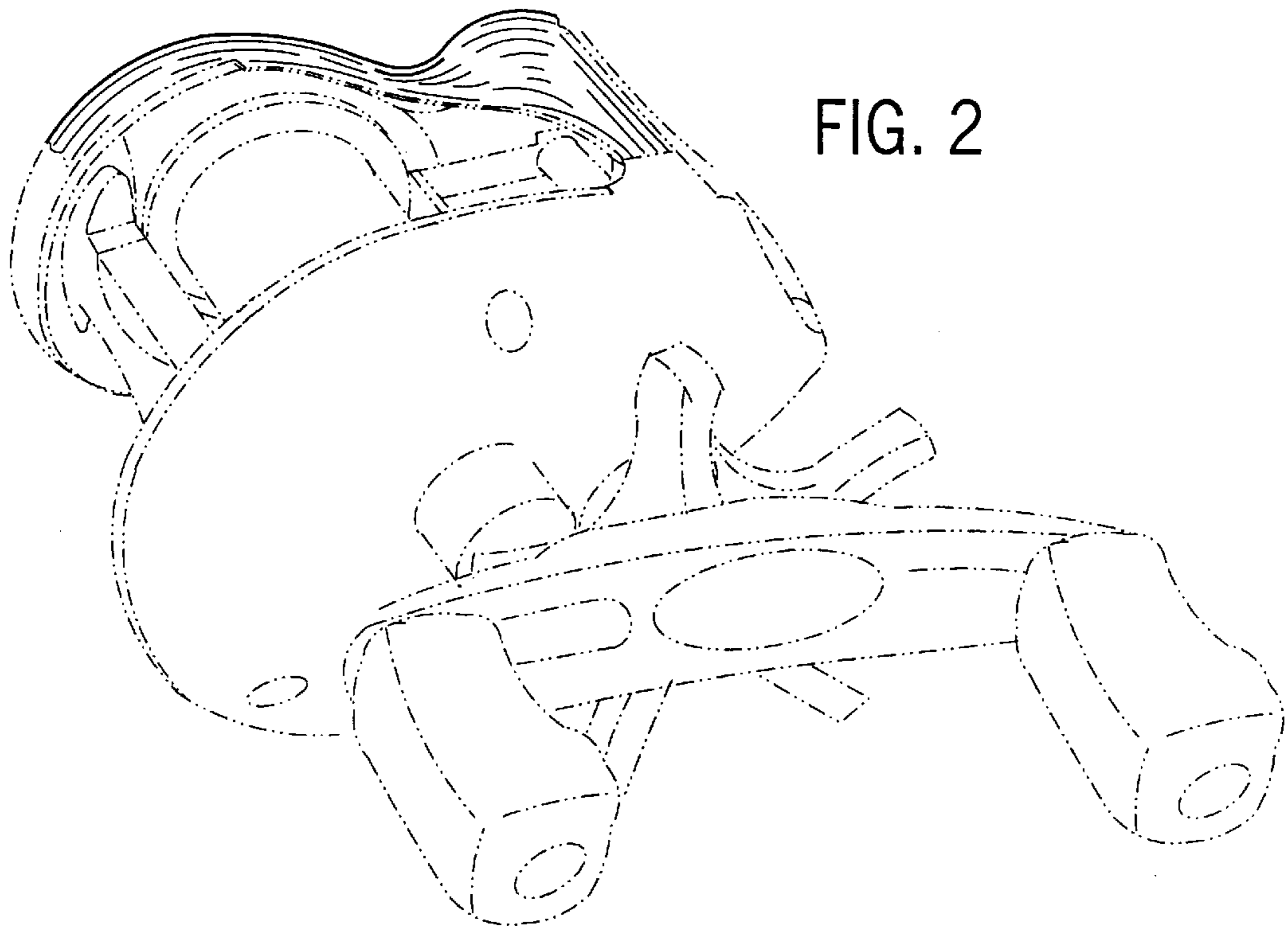

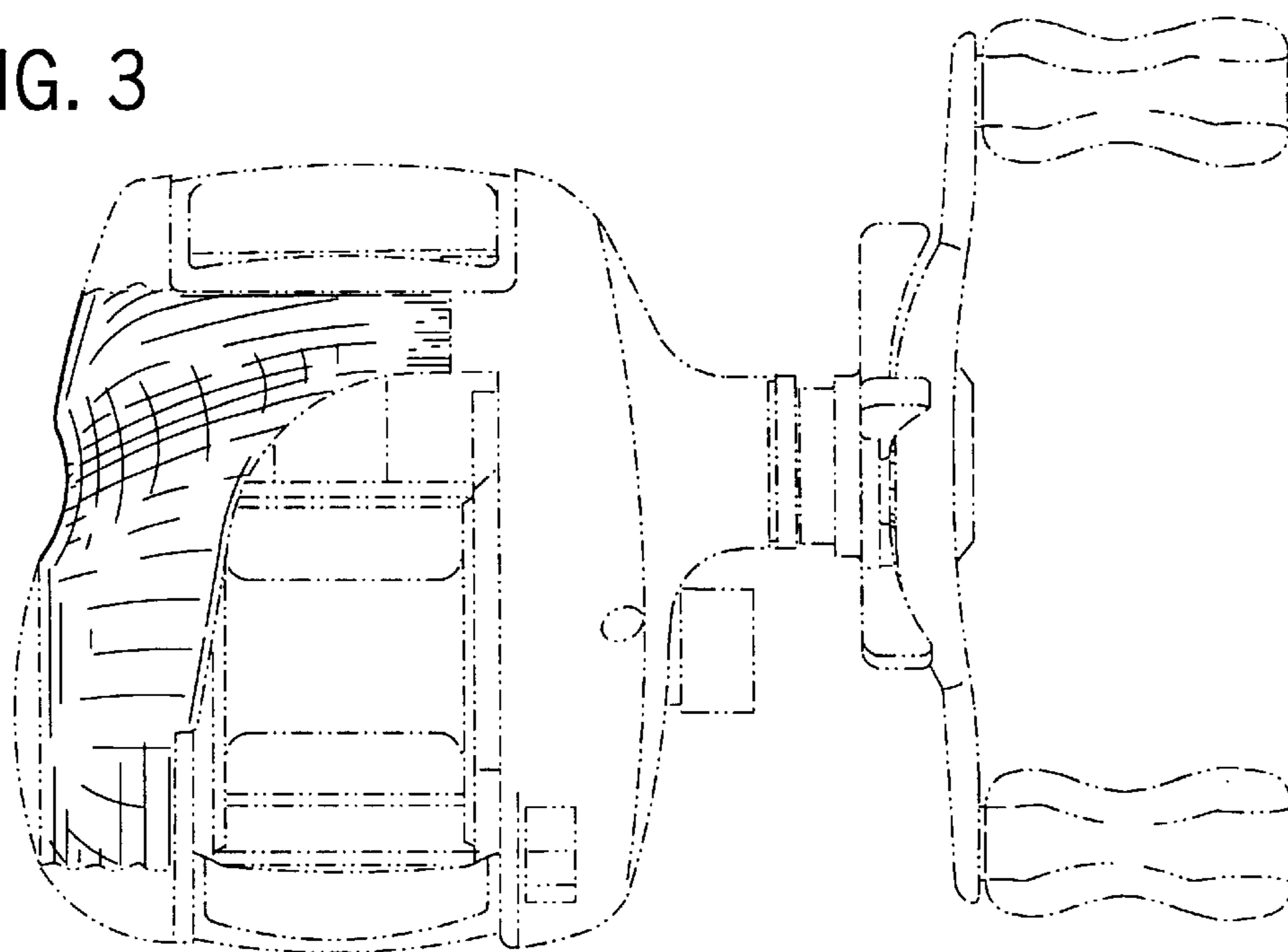

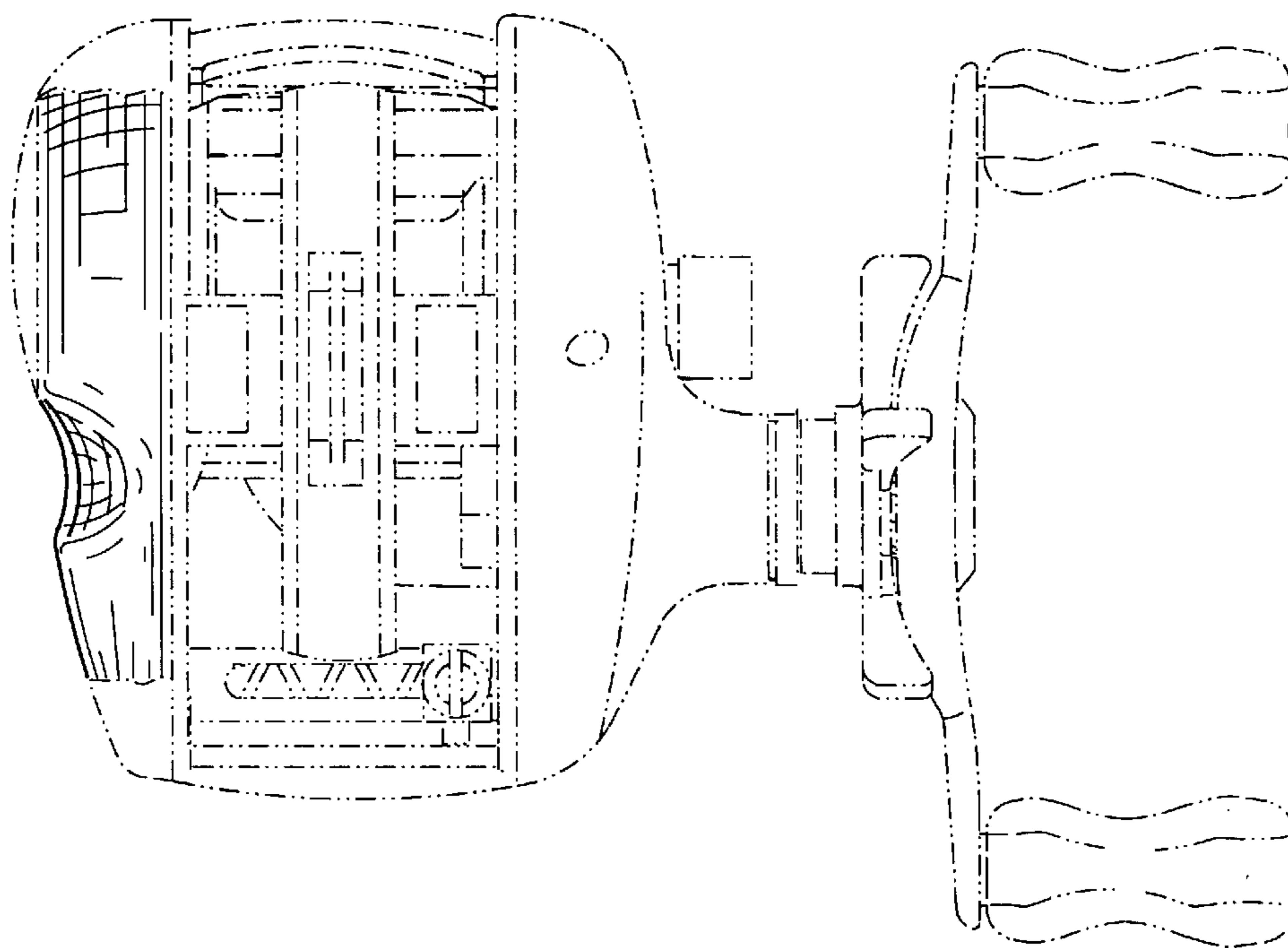

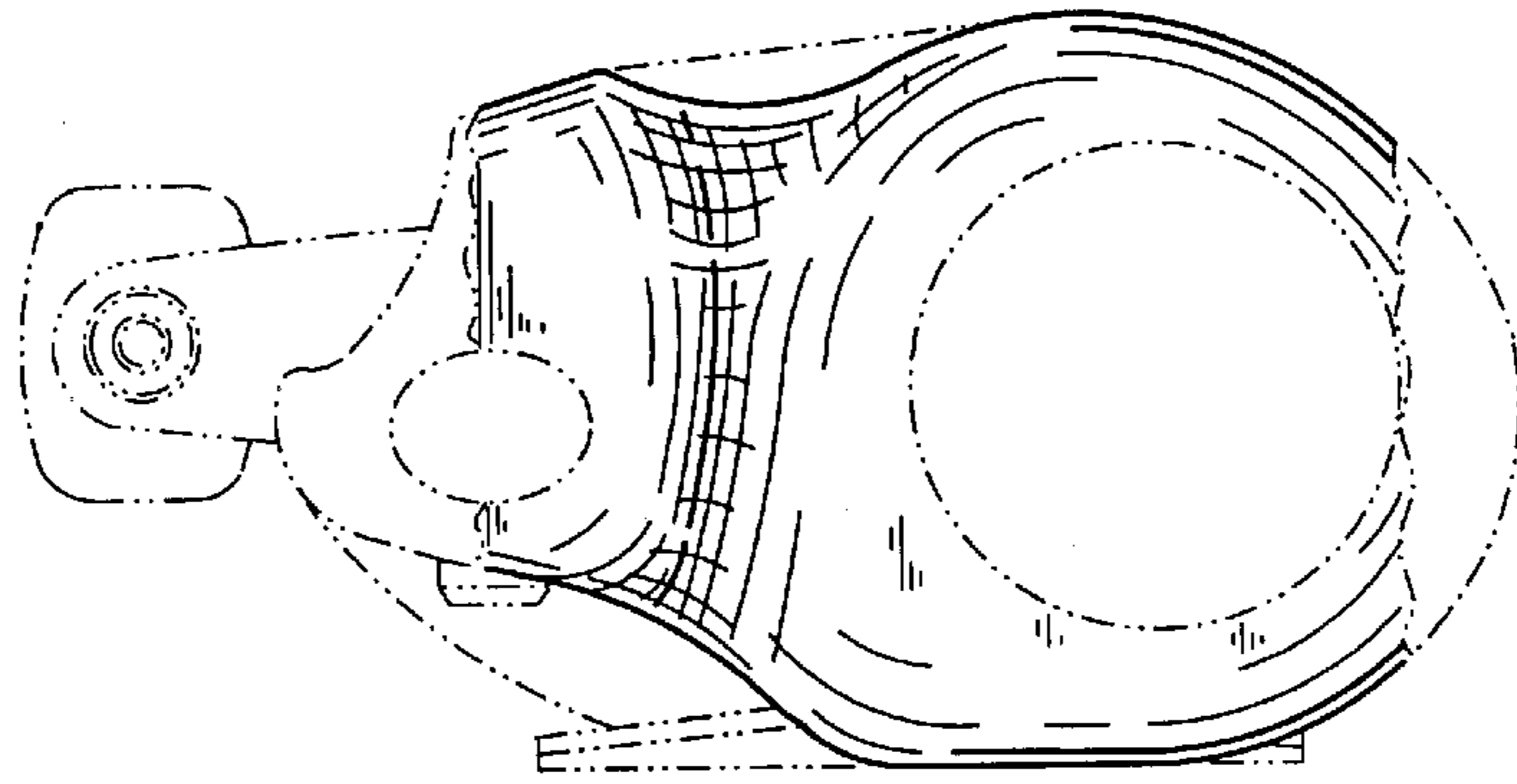

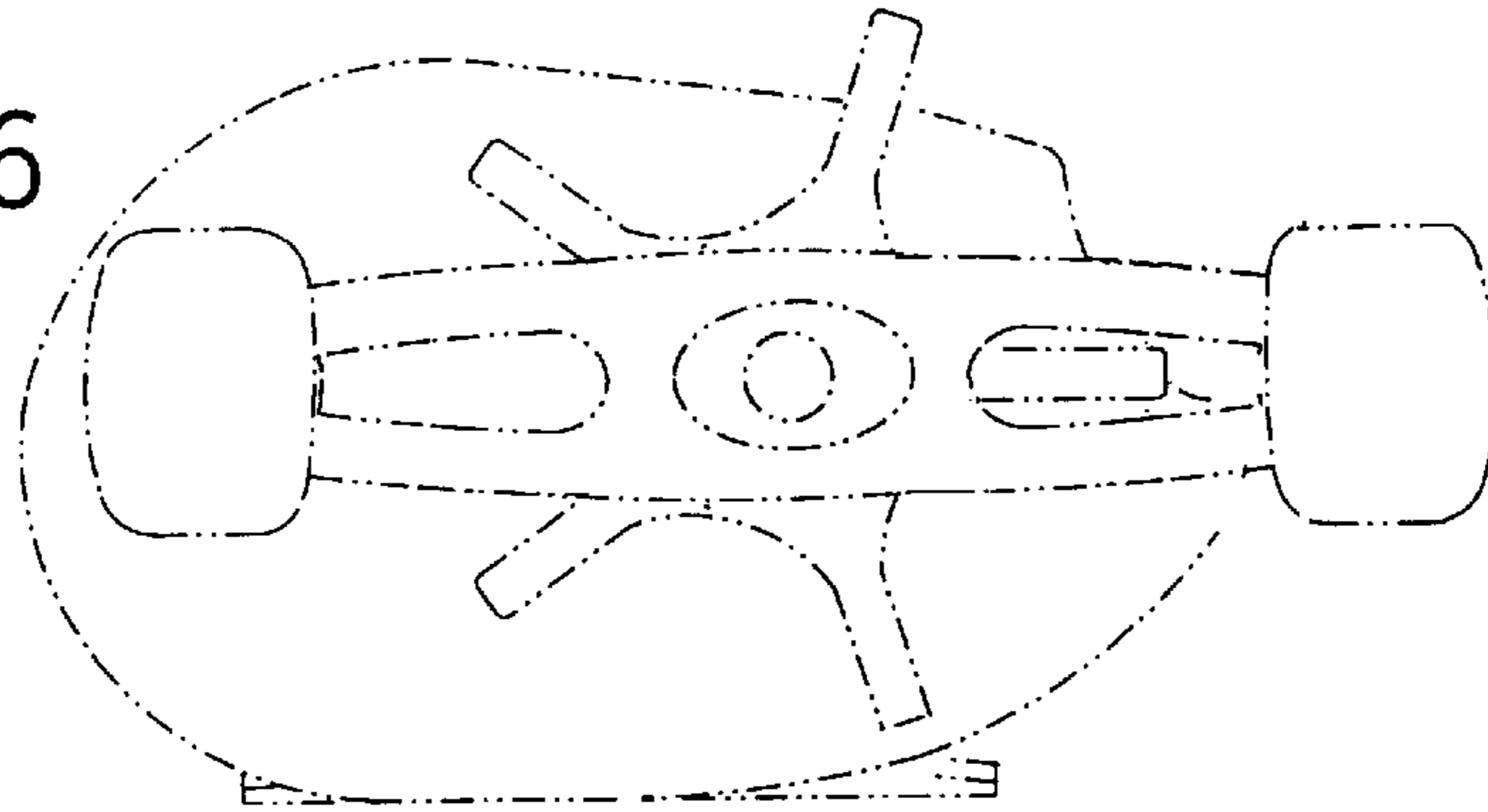

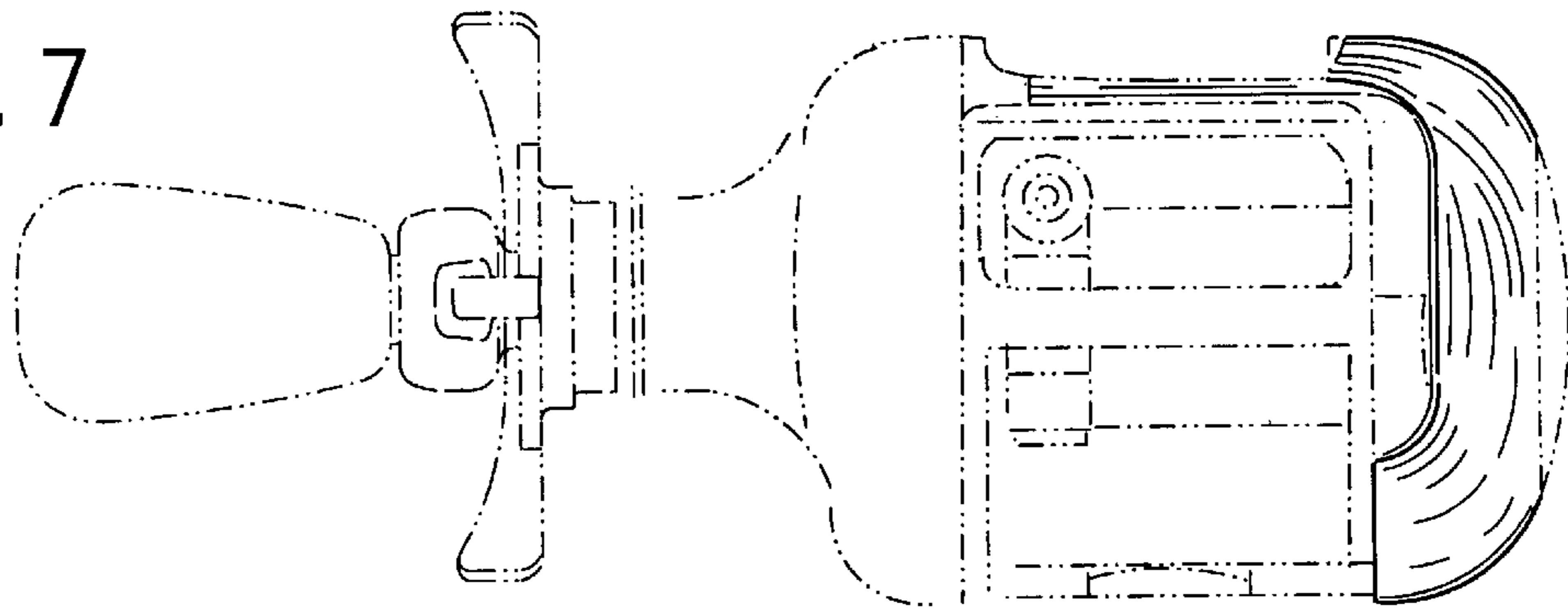
