#### DESCRIPTION

FIG. 8 is a top and bottom plan view thereof.

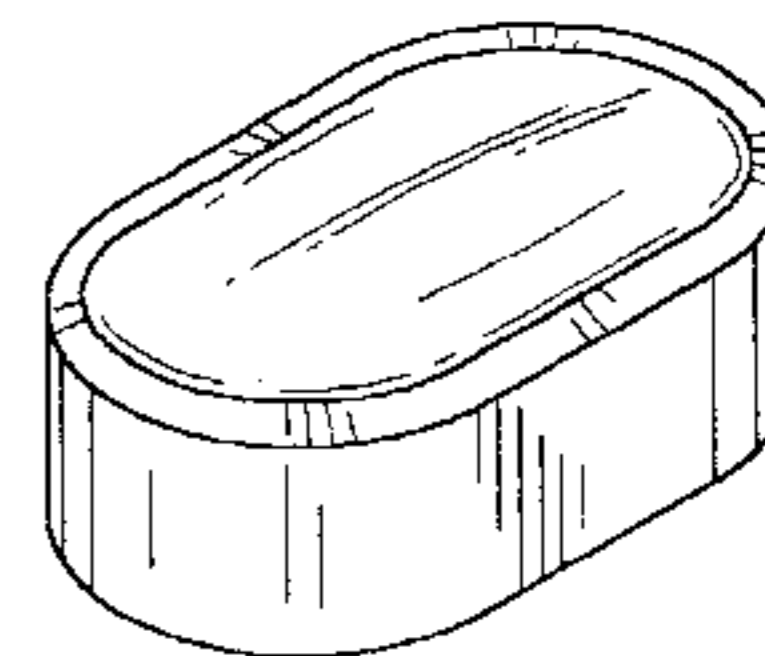
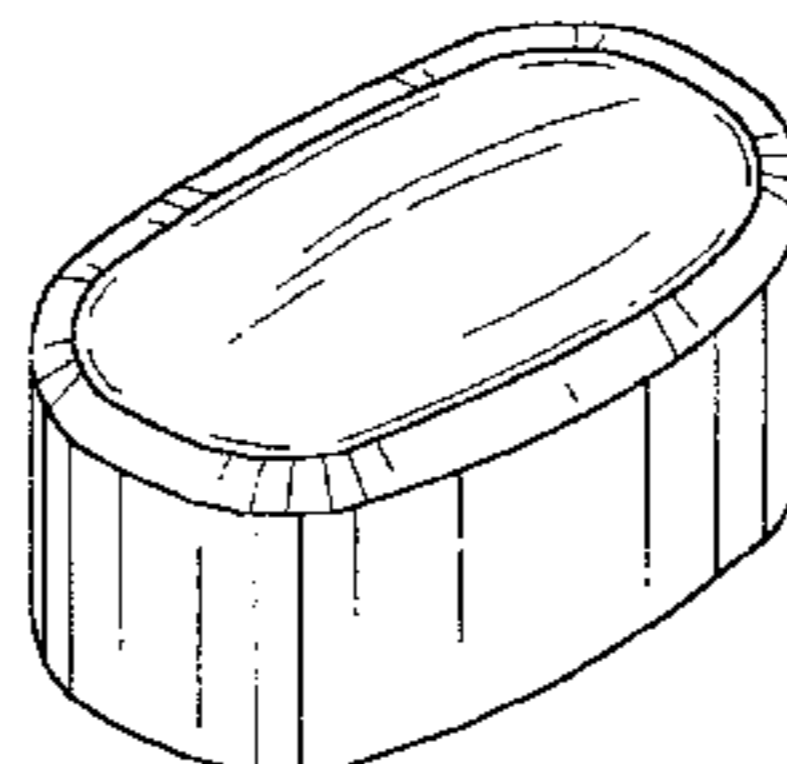
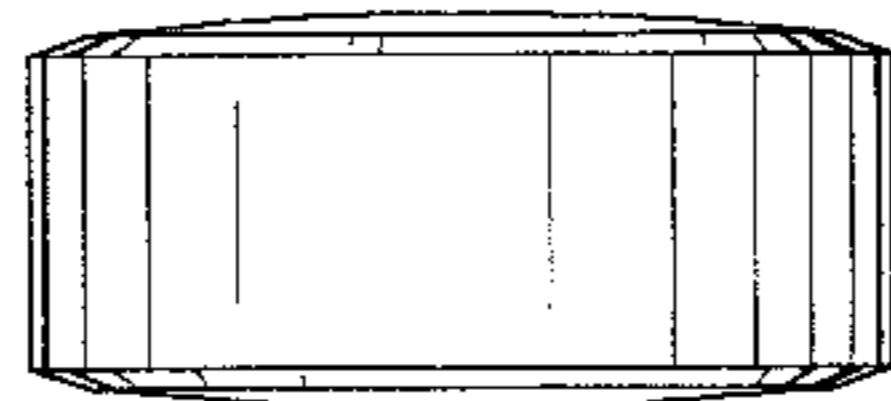
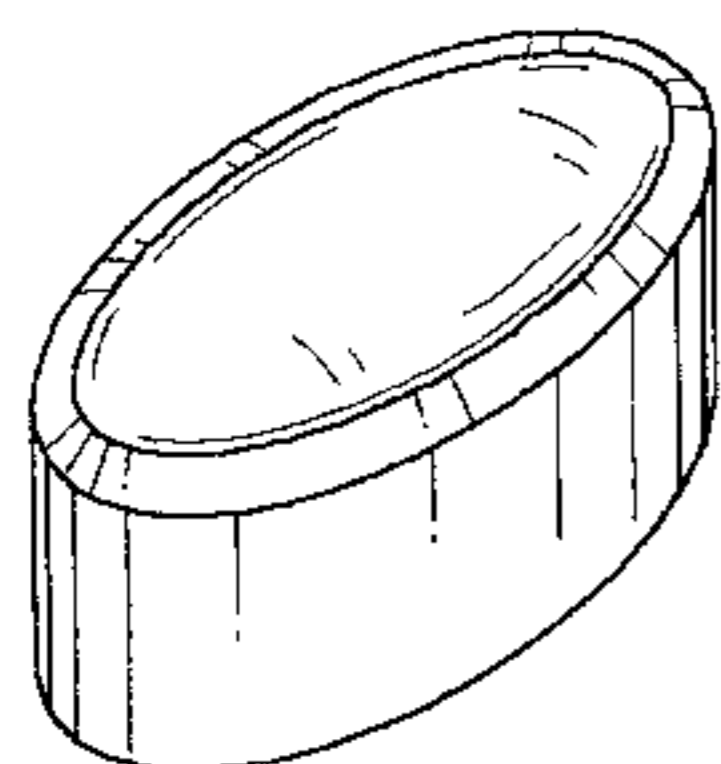
FIG. 9 is a perspective view of a third embodiment of the detergent tablet of our design.

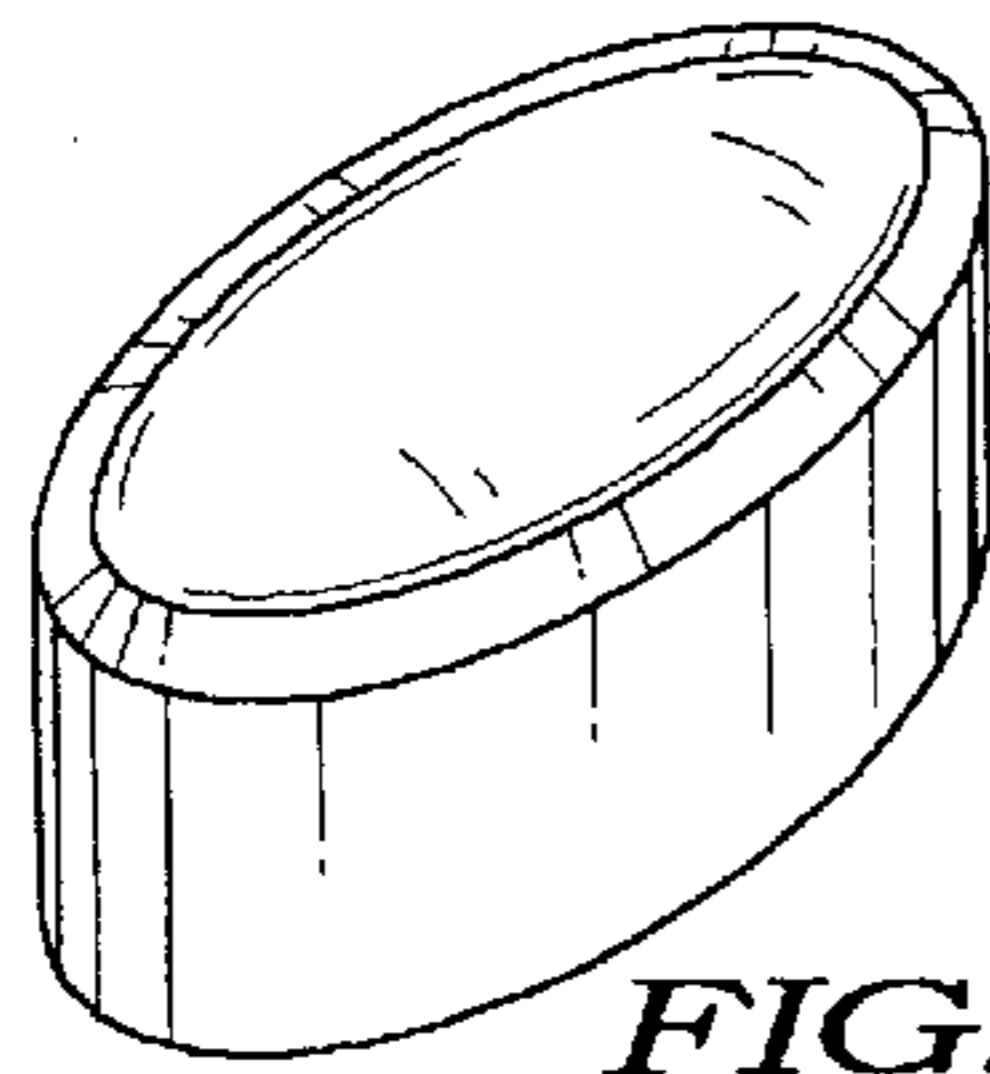

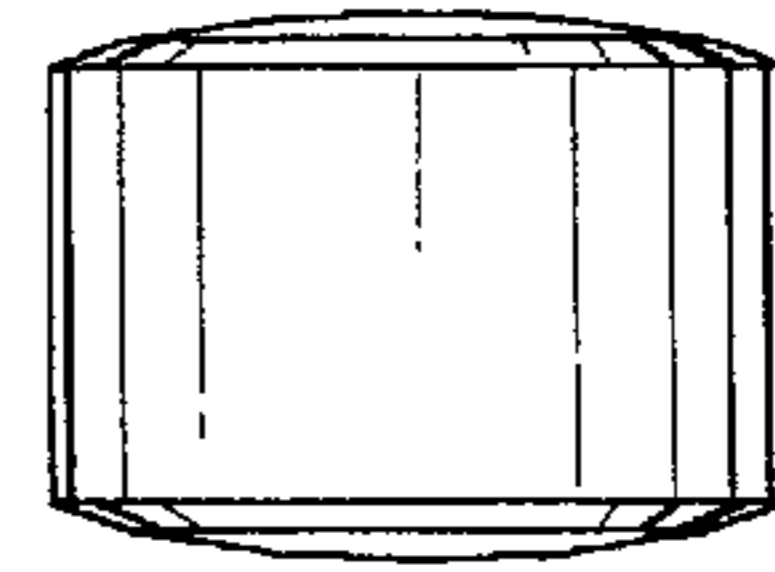

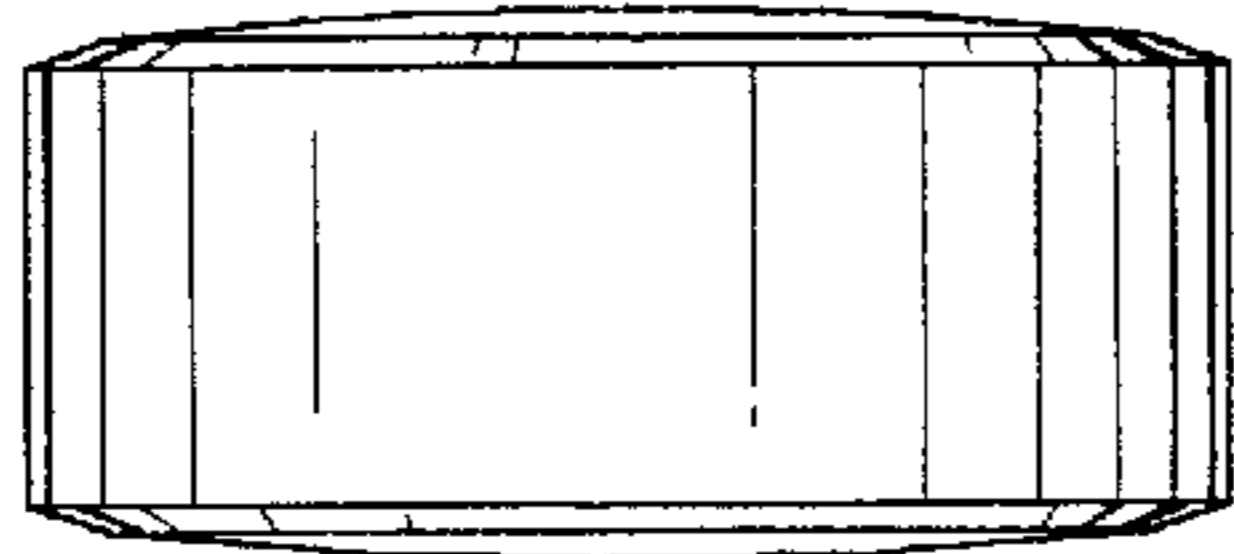

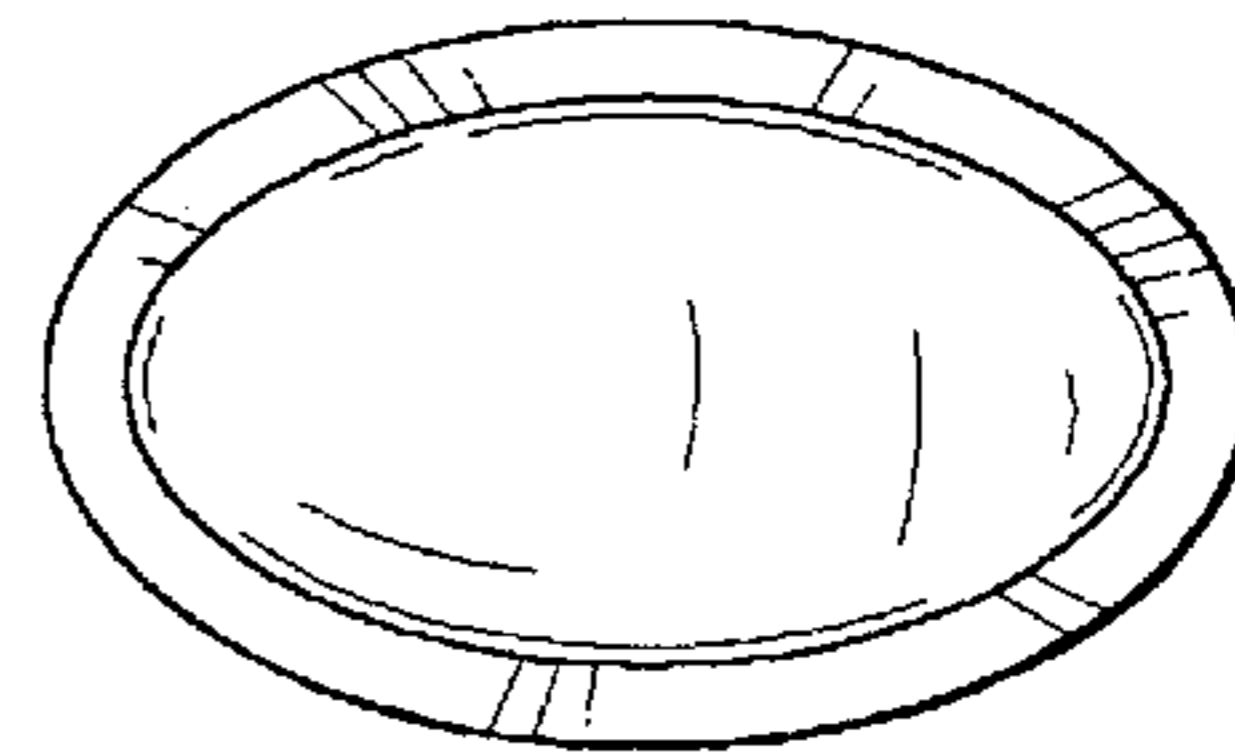

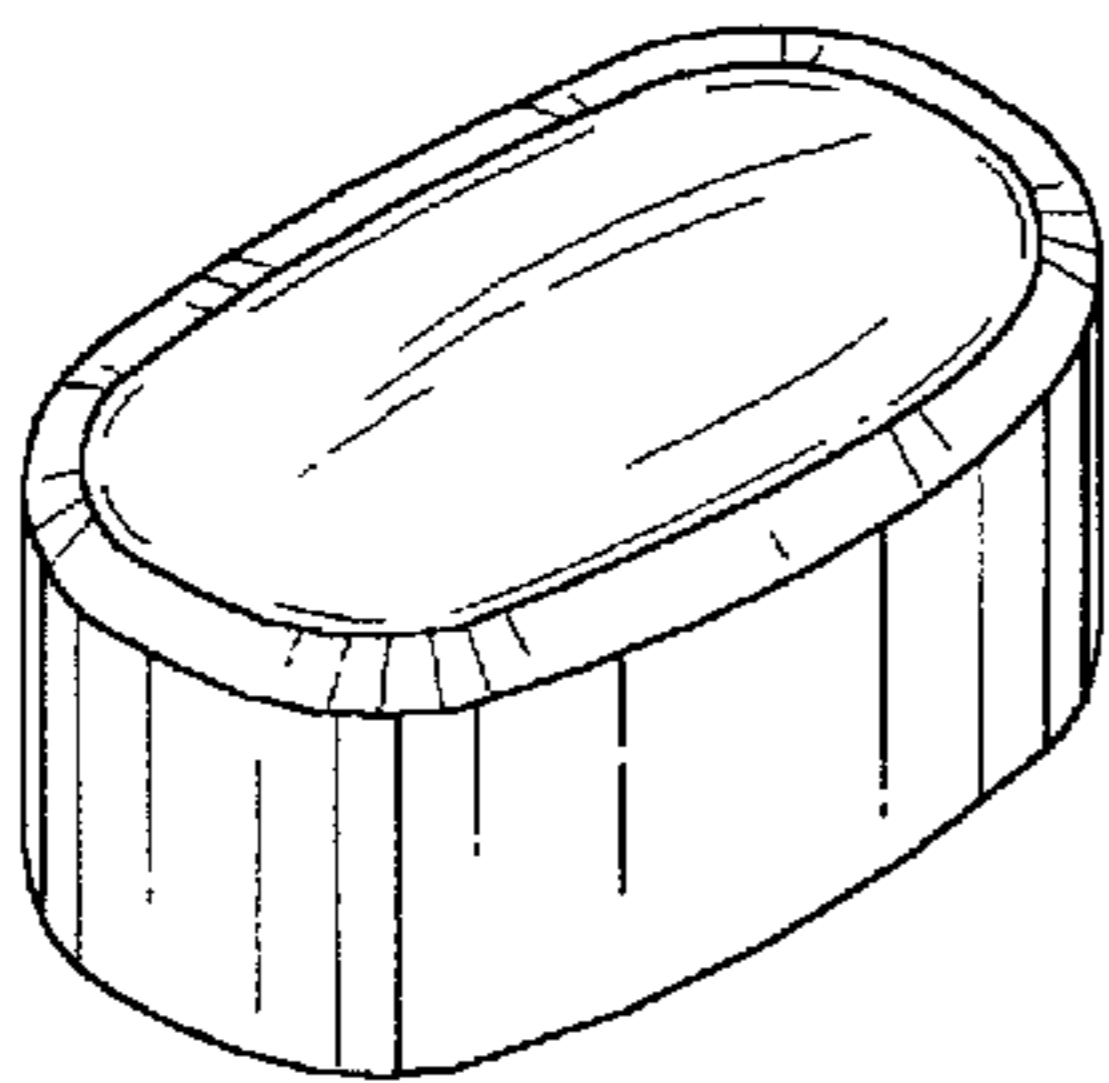

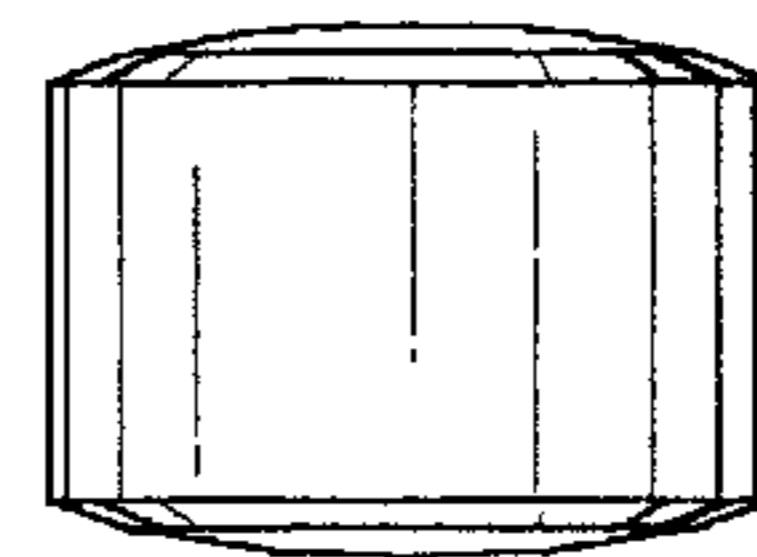

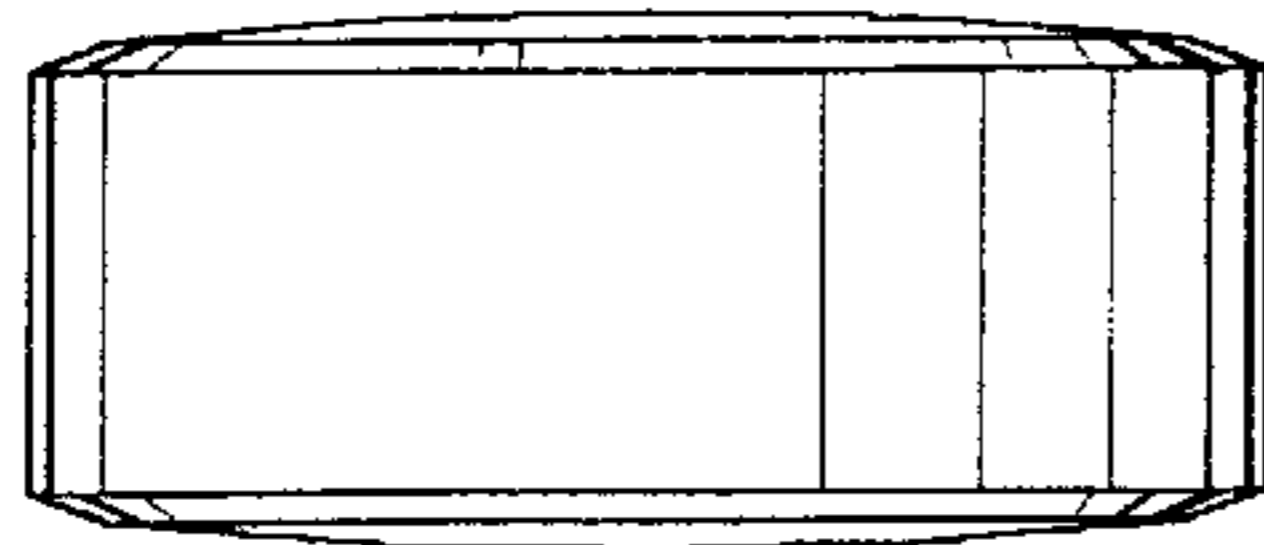

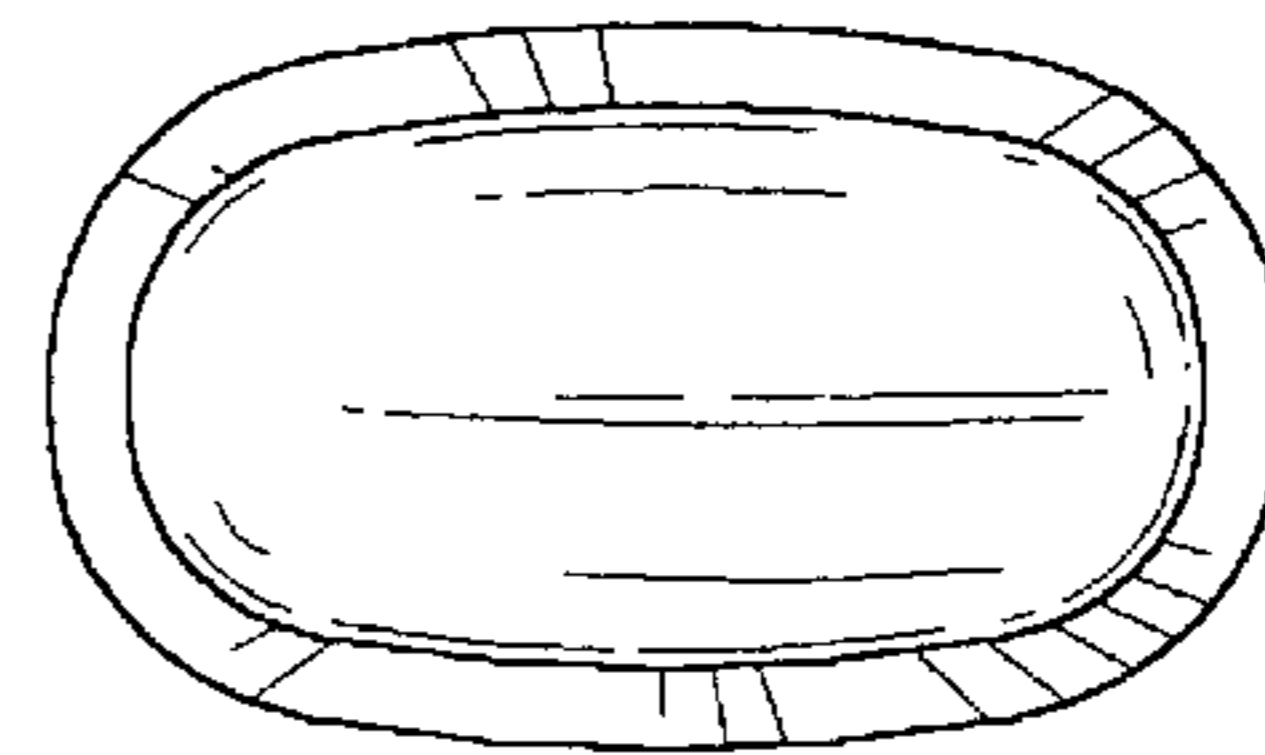

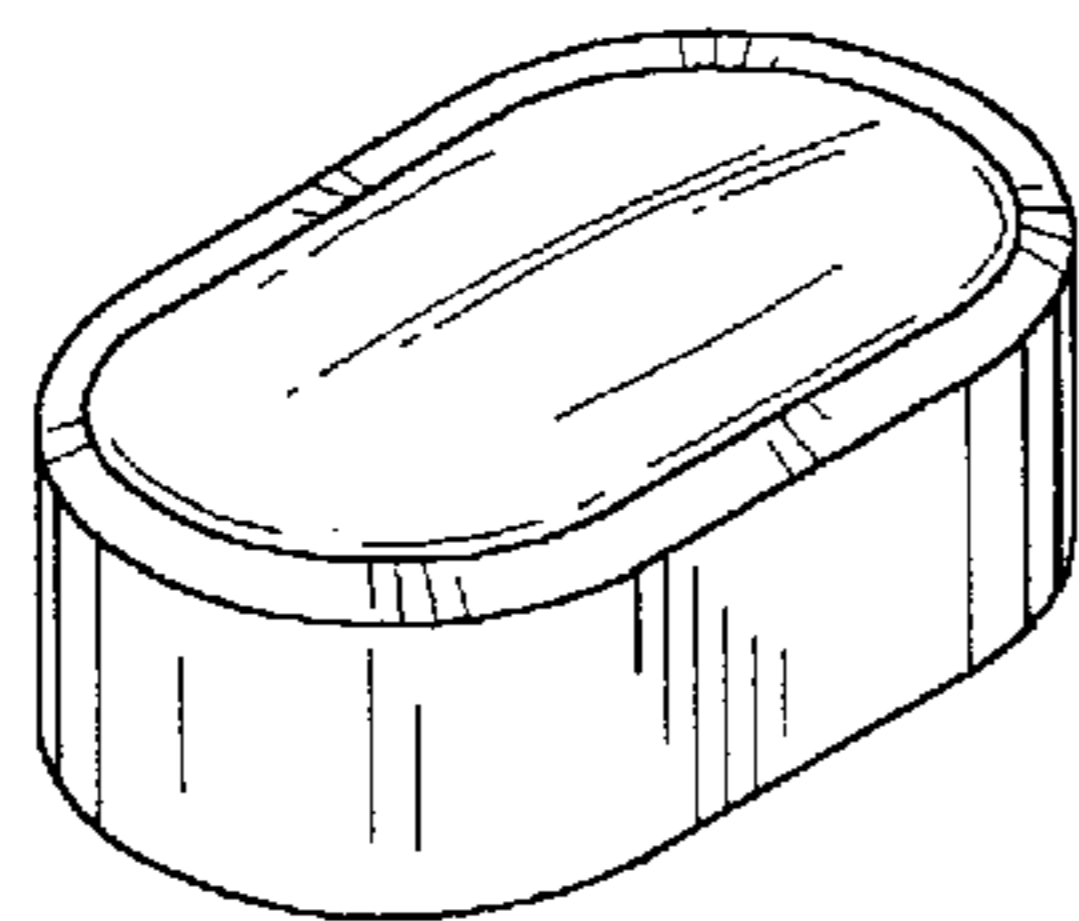

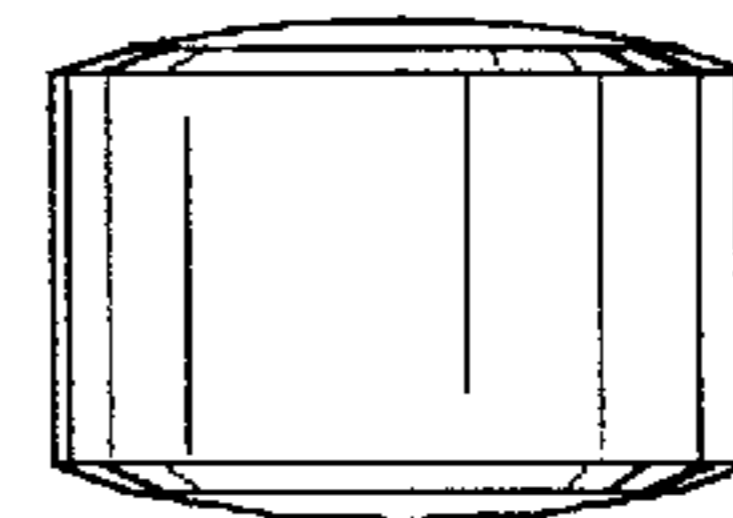

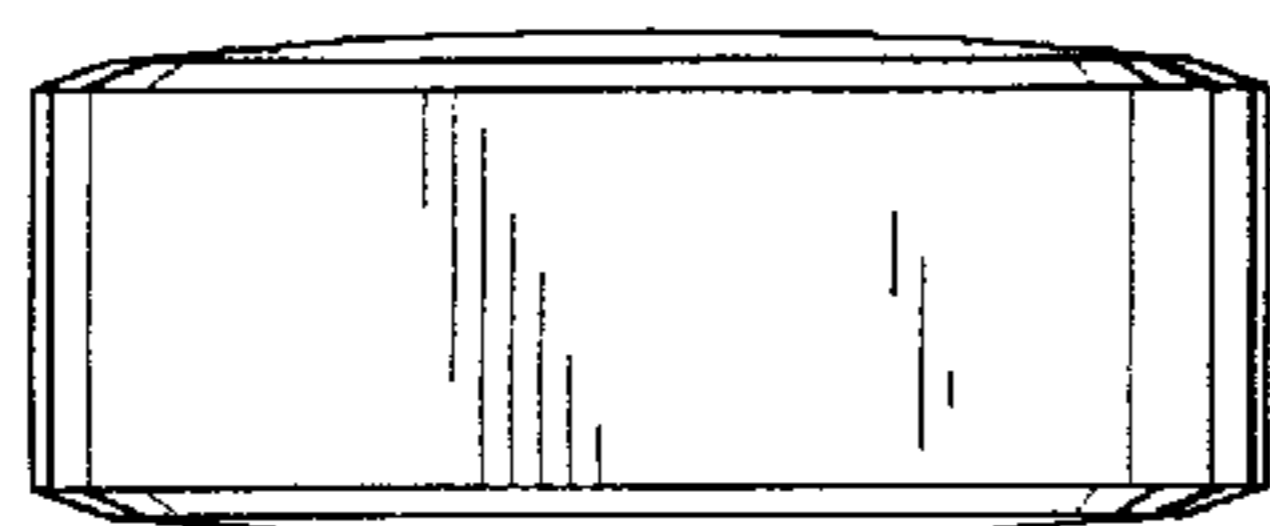

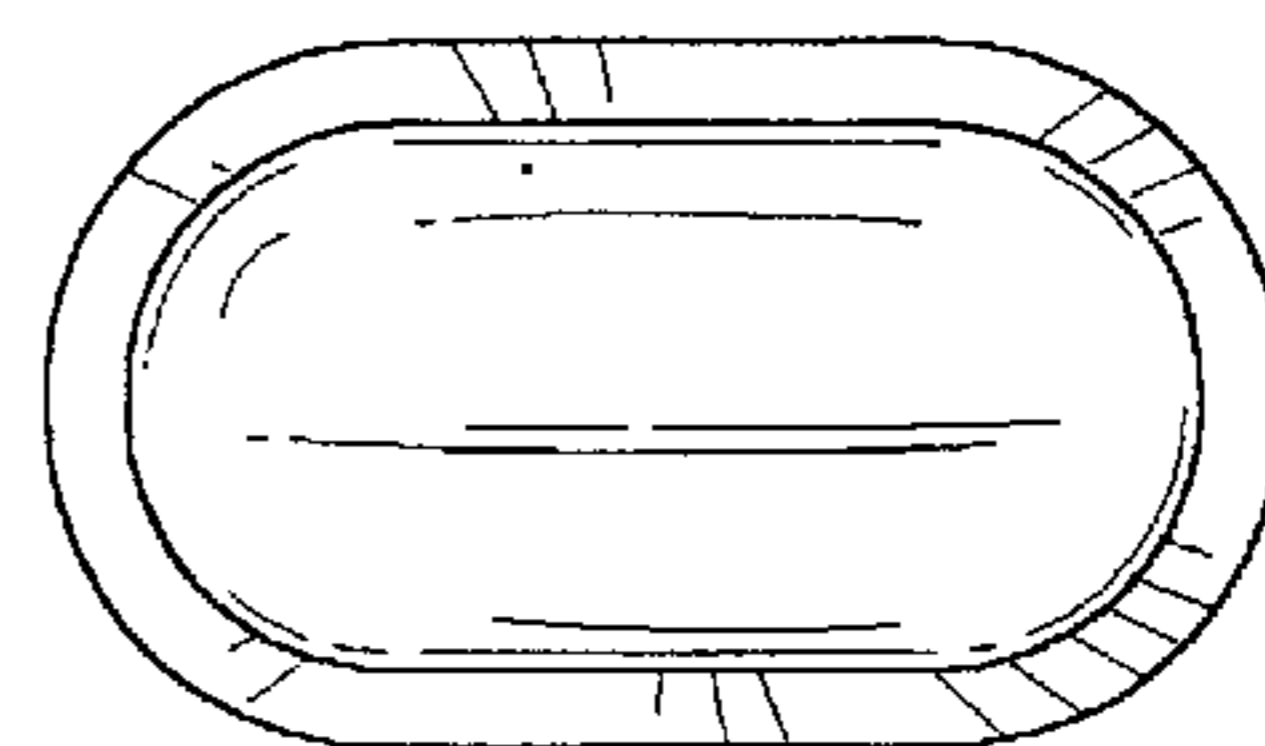
