[57] **CLAIM**

The ornamental design for a foot protector, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the foot protector; FIG. 2 is a side elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; and, FIG. 6 is a bottom plan view thereof.

The broken line showing in FIG. 1 is for illustrative purposes only, and forms no part of the claimed design.

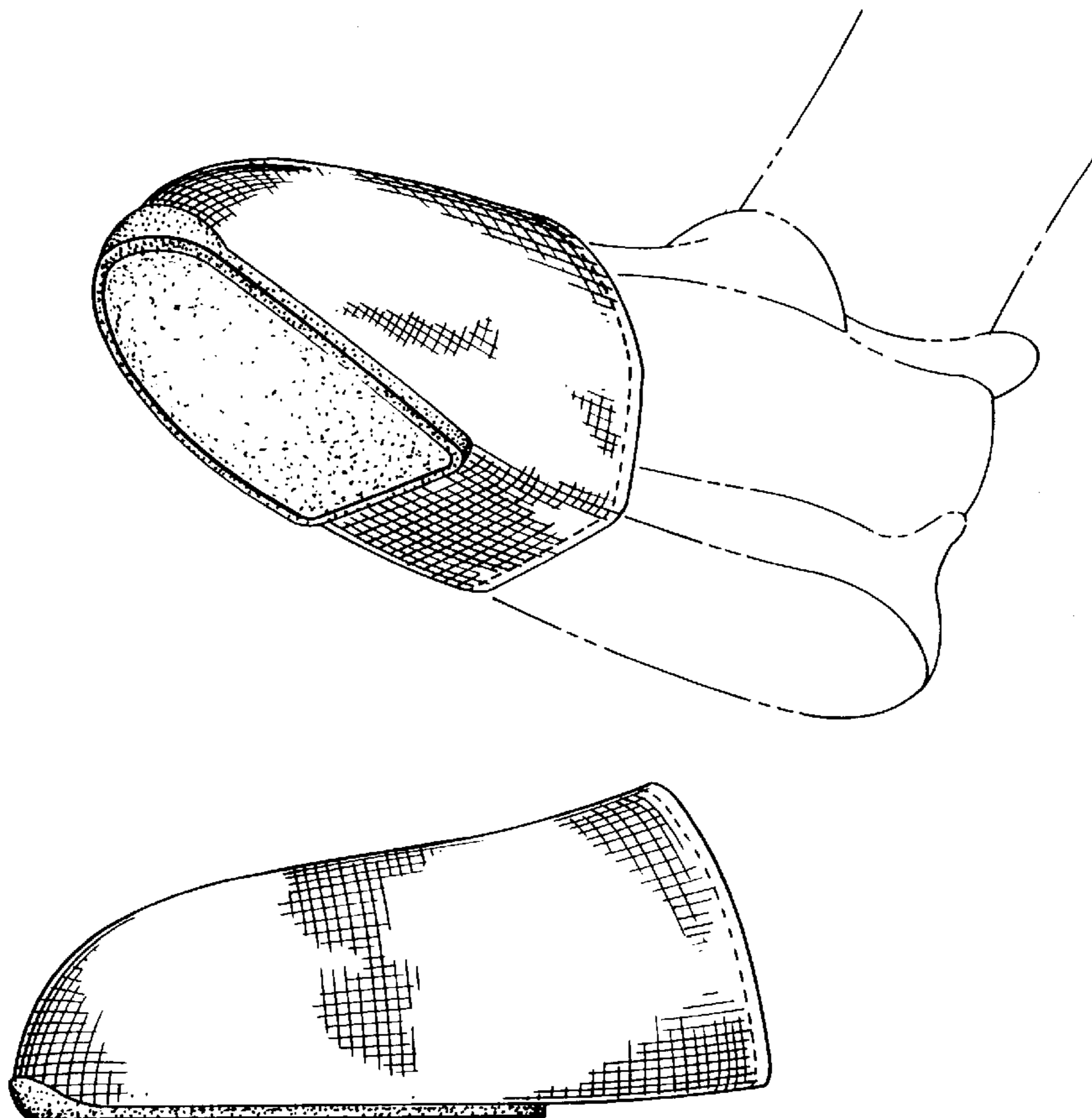

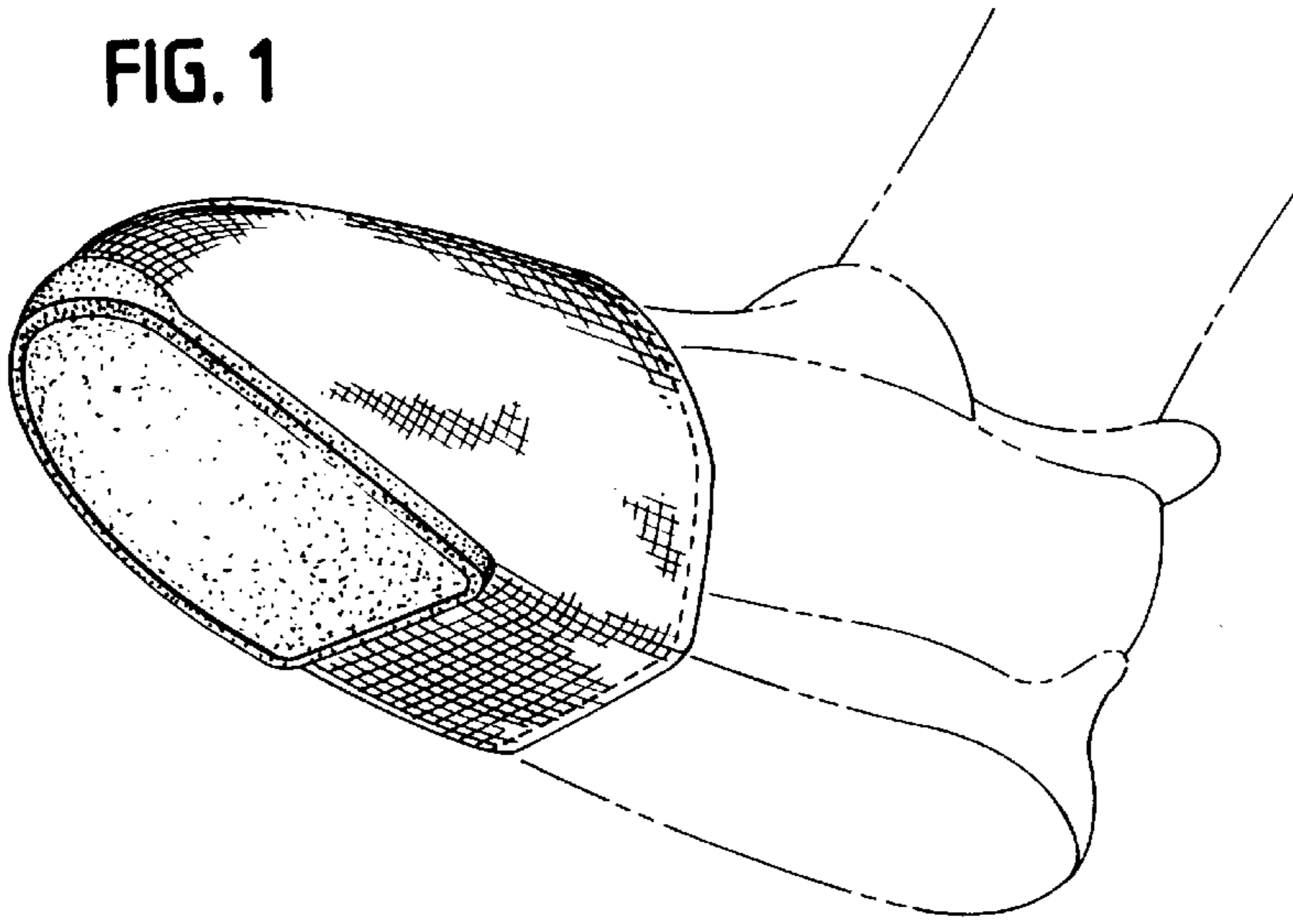

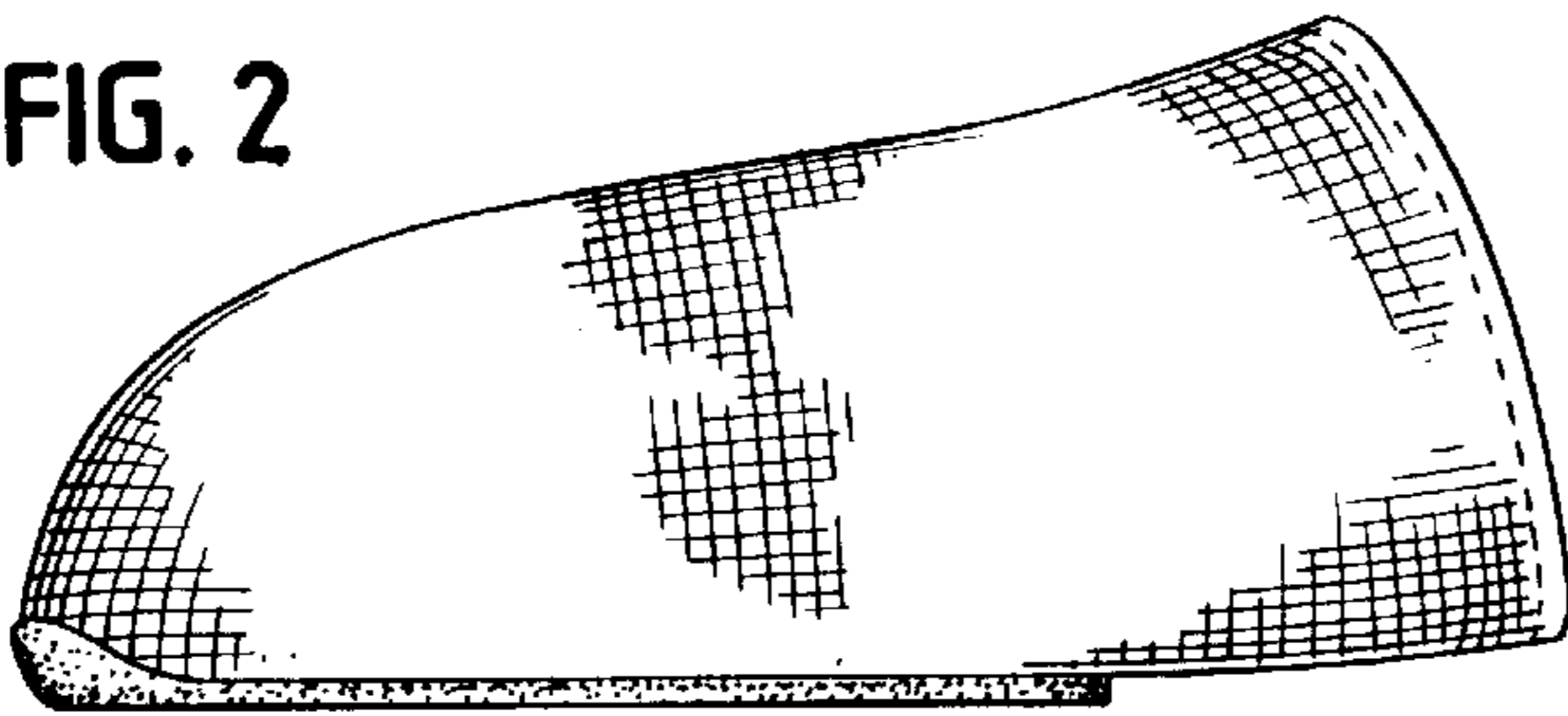

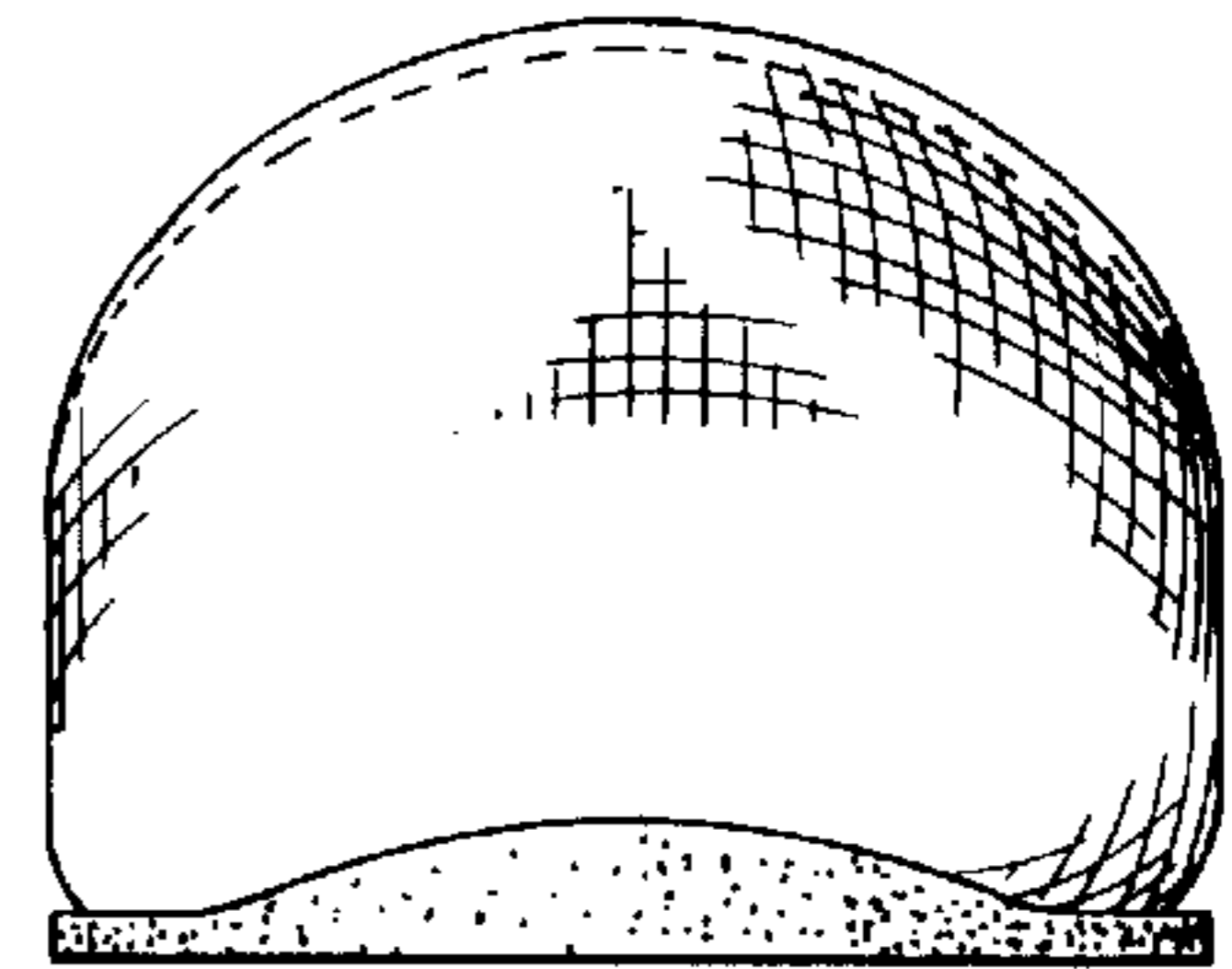

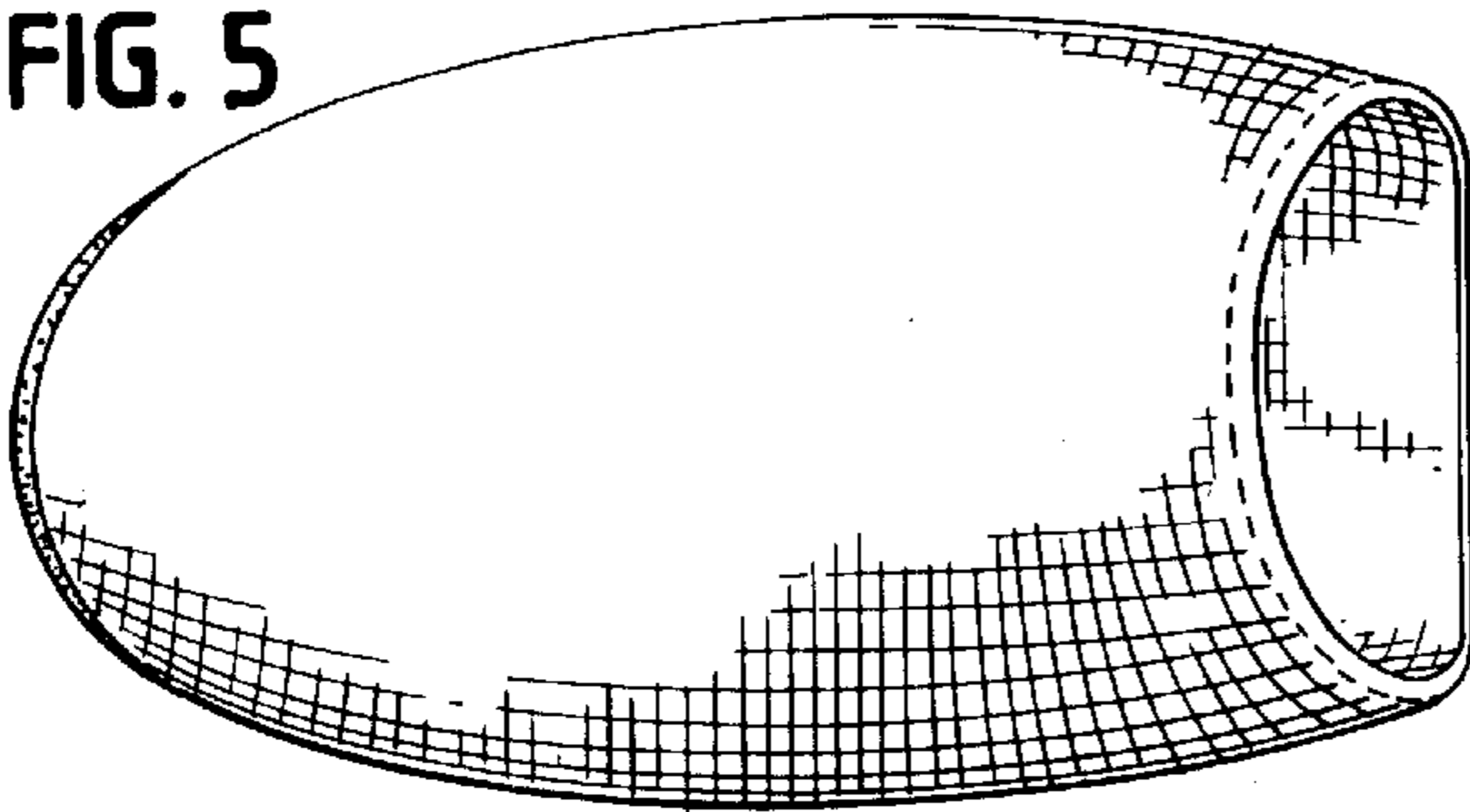

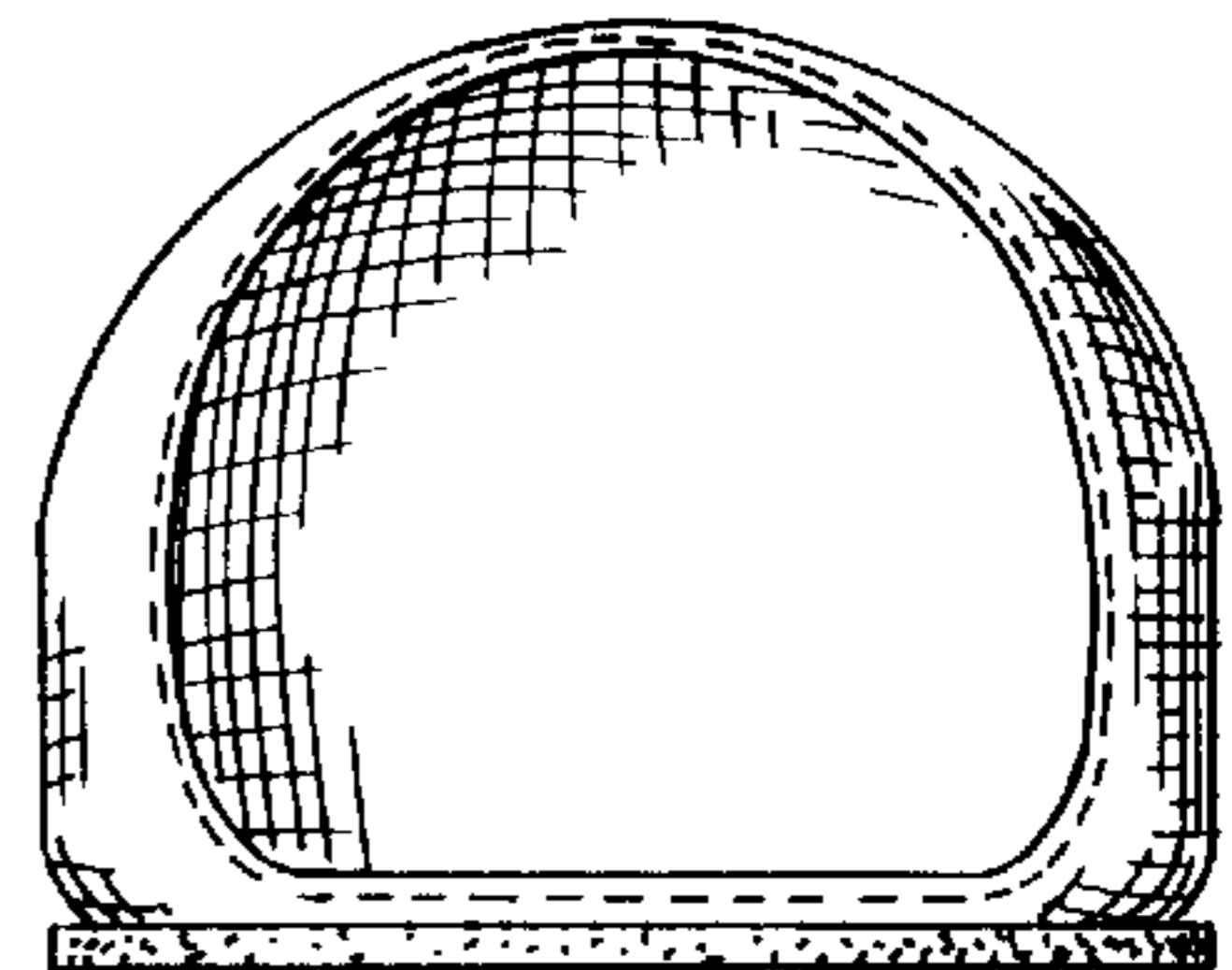
