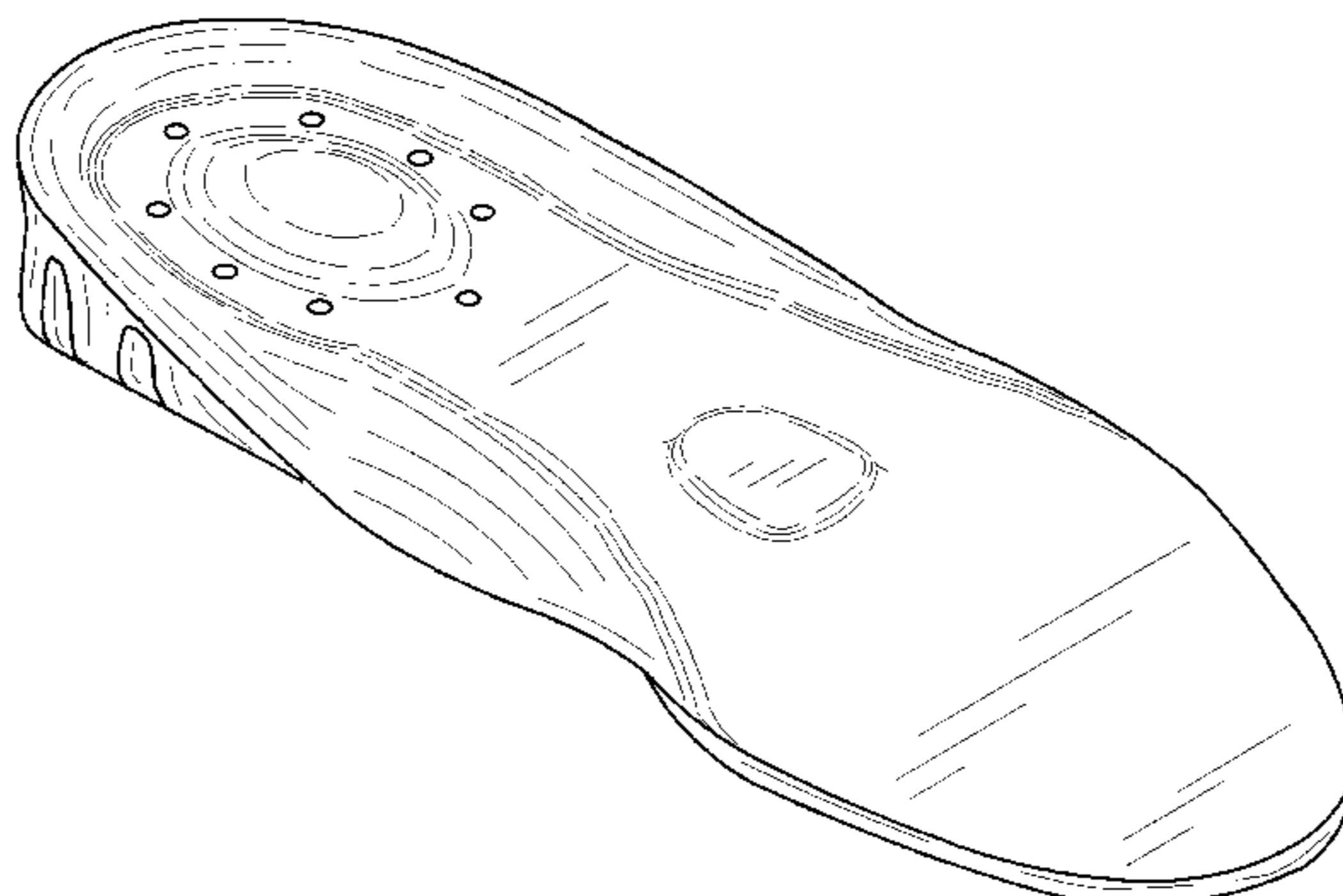
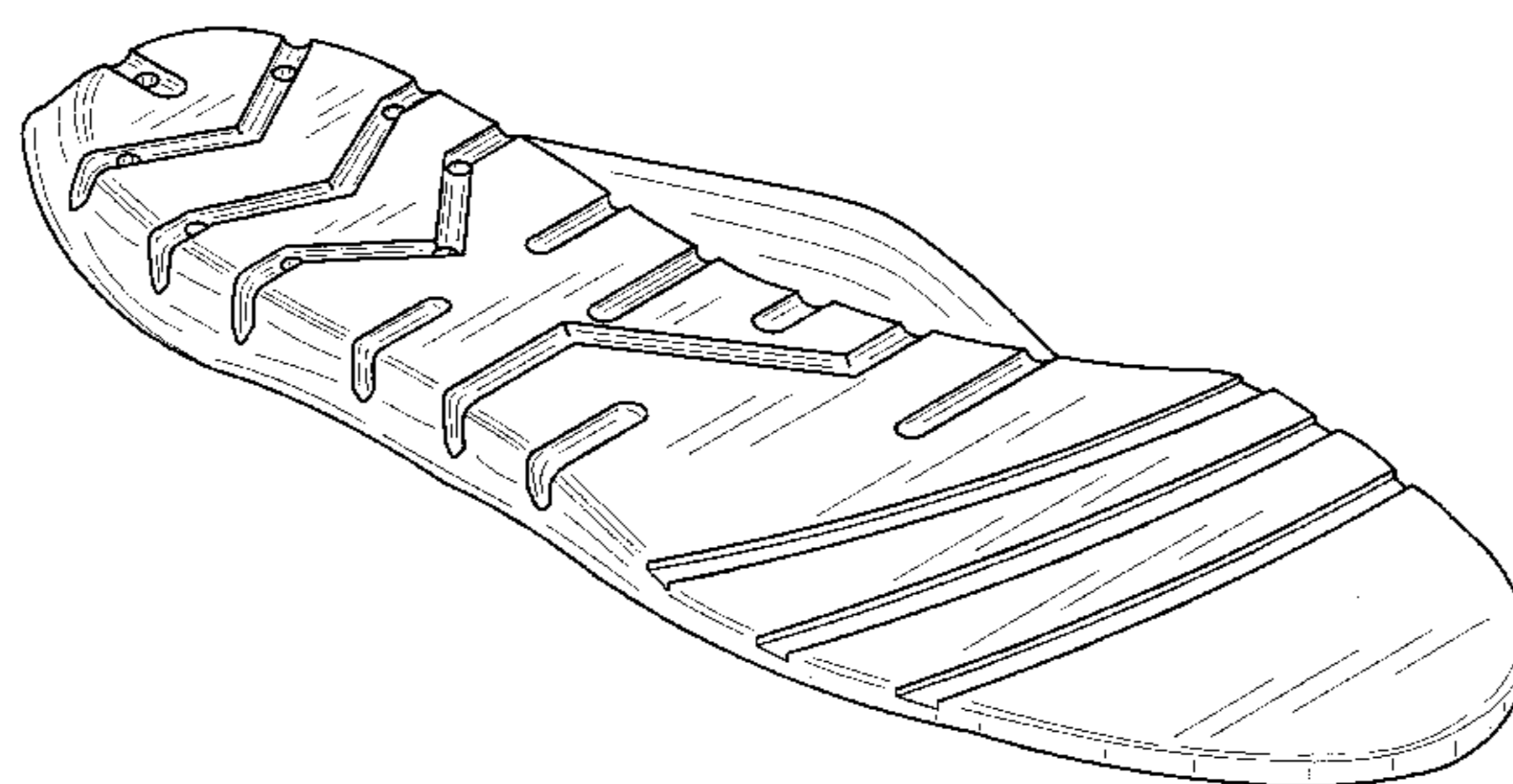
[57] CLAIM

I claim the ornamental design for an aerated insole, as shown.

DESCRIPTION

FIG. 1 is a bottom perspective view of an aerated insole, showing my new design;
FIG. 2 is a bottom plan view;
FIG. 3 is a top plan view;
FIG. 4 is a left side elevational view;
FIG. 5 is a right side elevational view;
FIG. 6 is a rear elevational view;
FIG. 7 is a front elevational view; and,

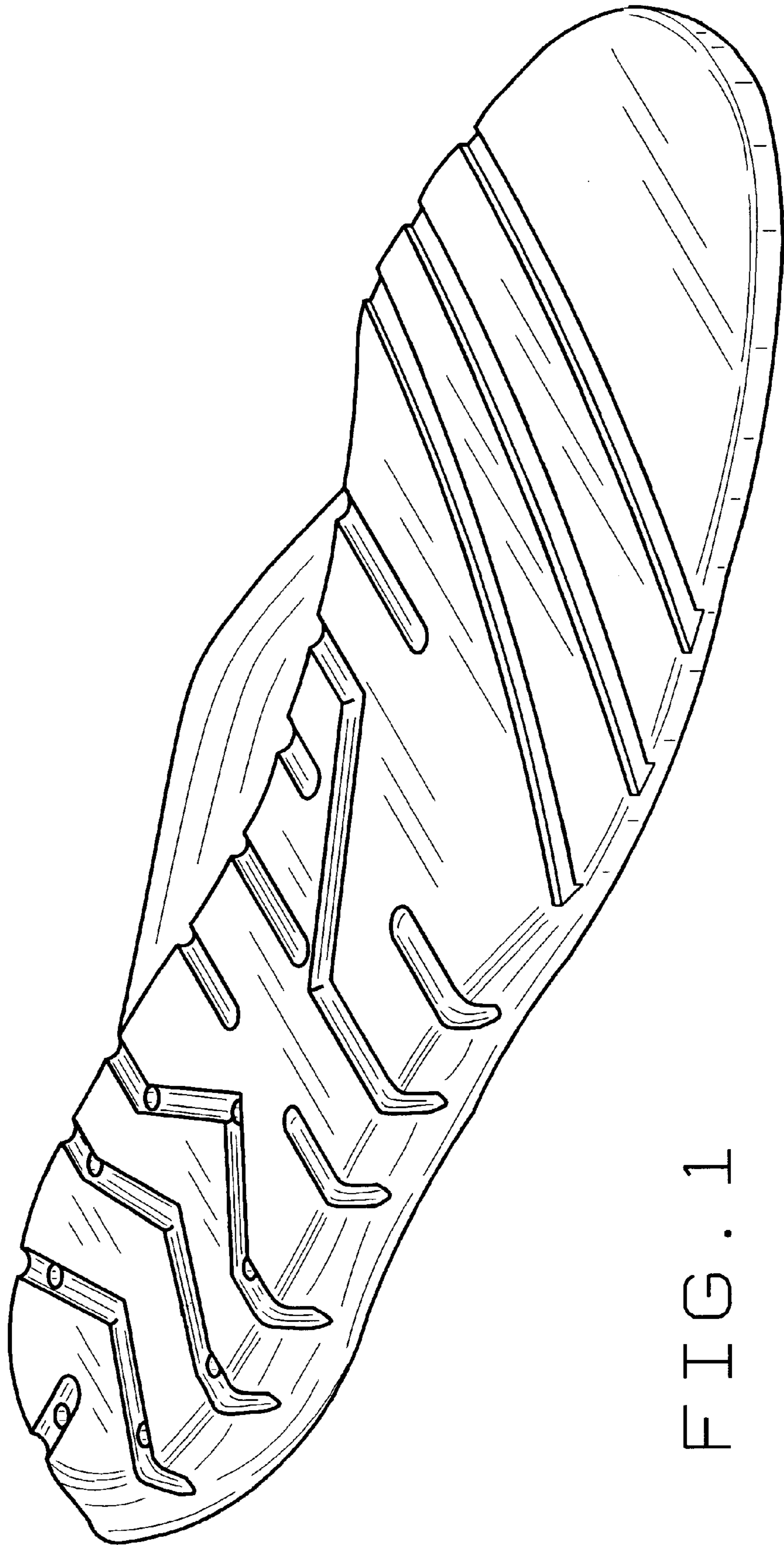

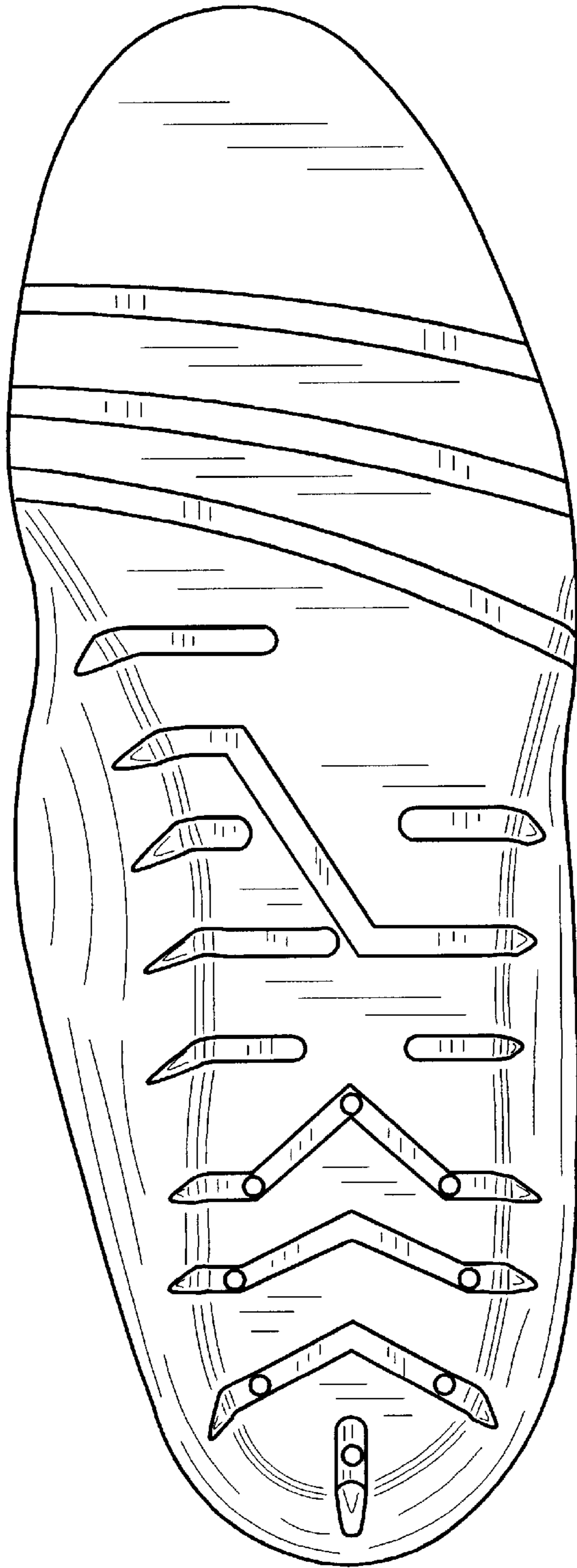

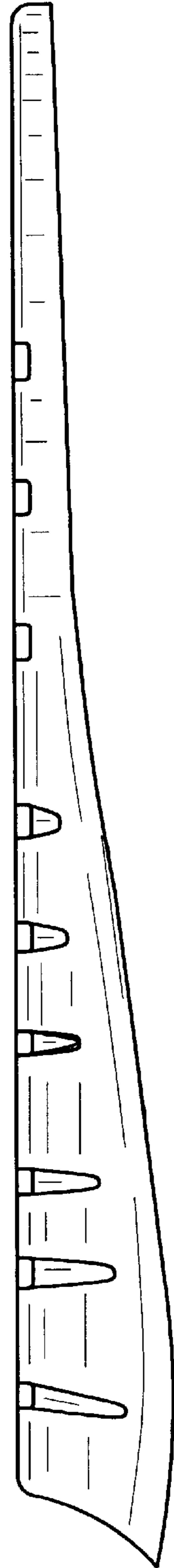

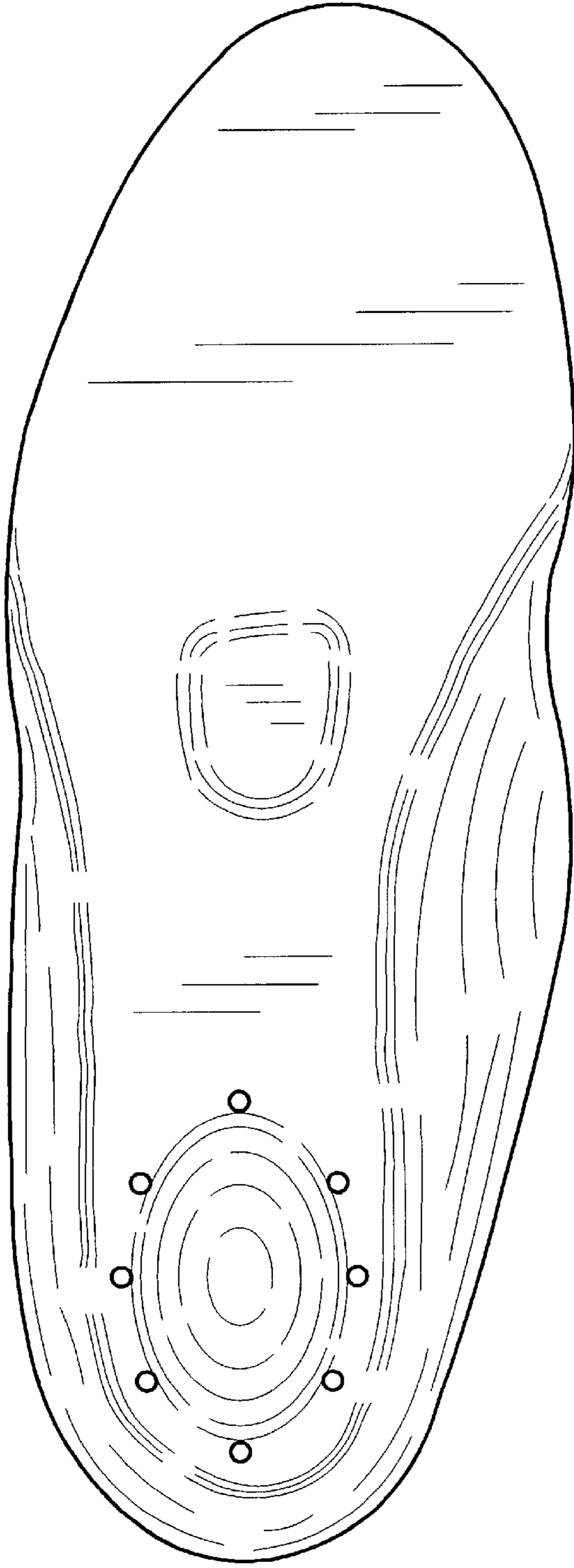

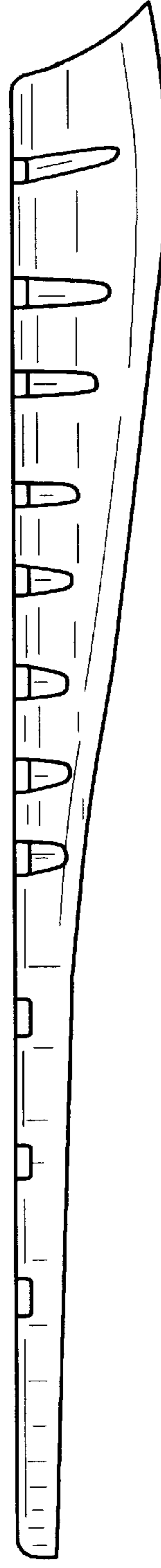

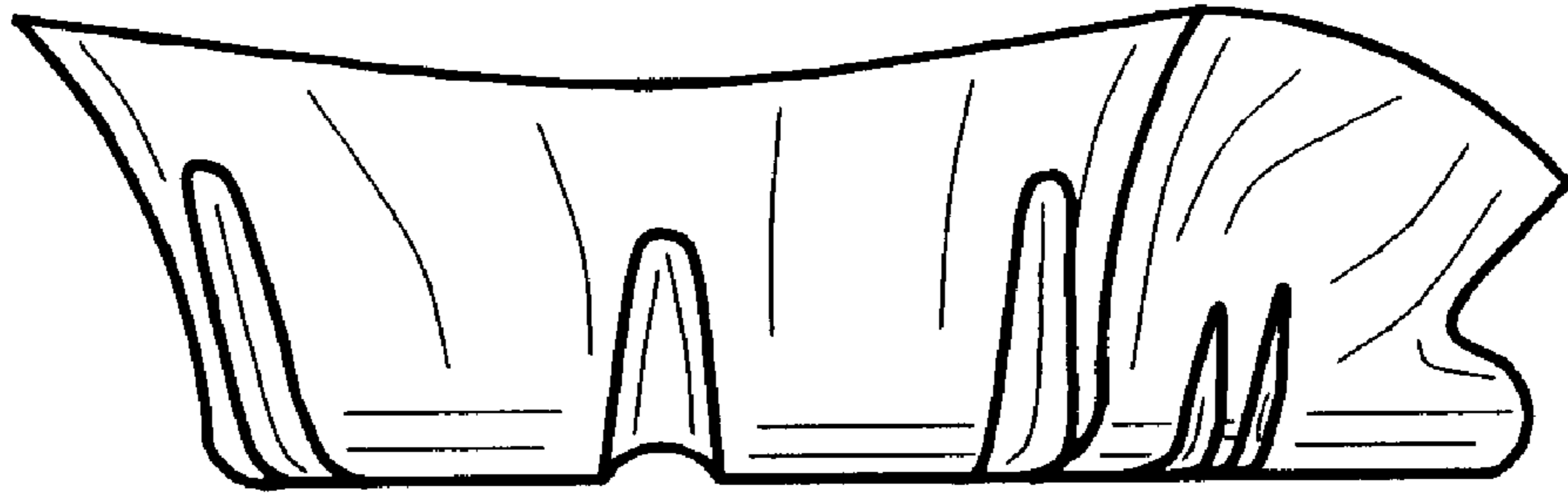

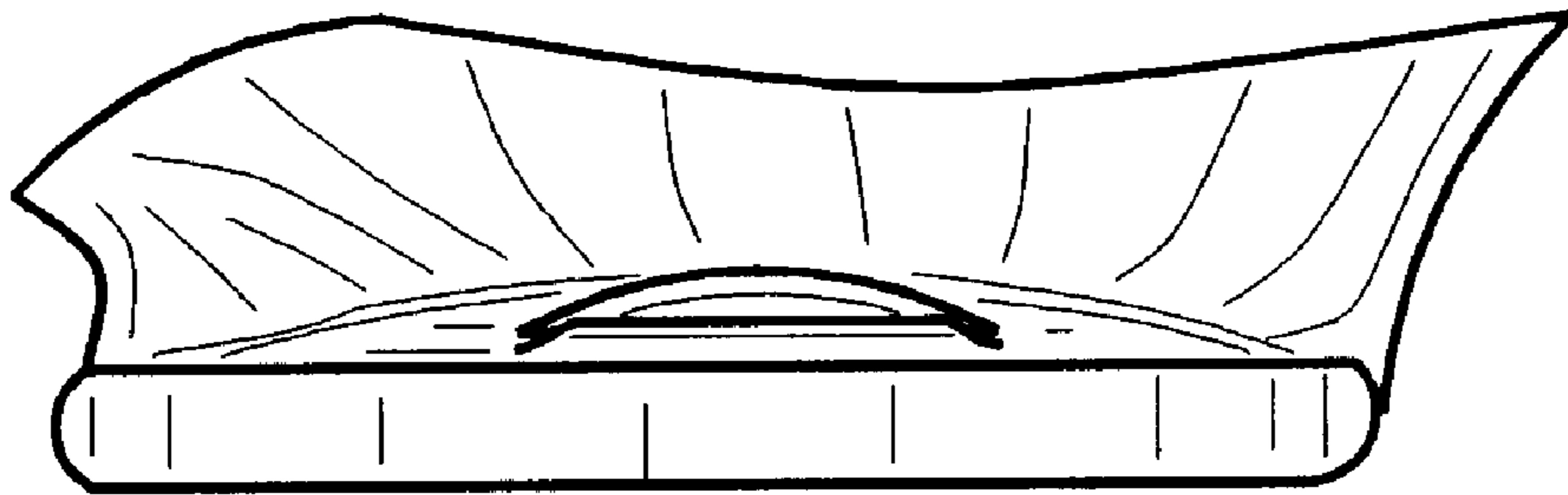
