[57] **CLAIM**

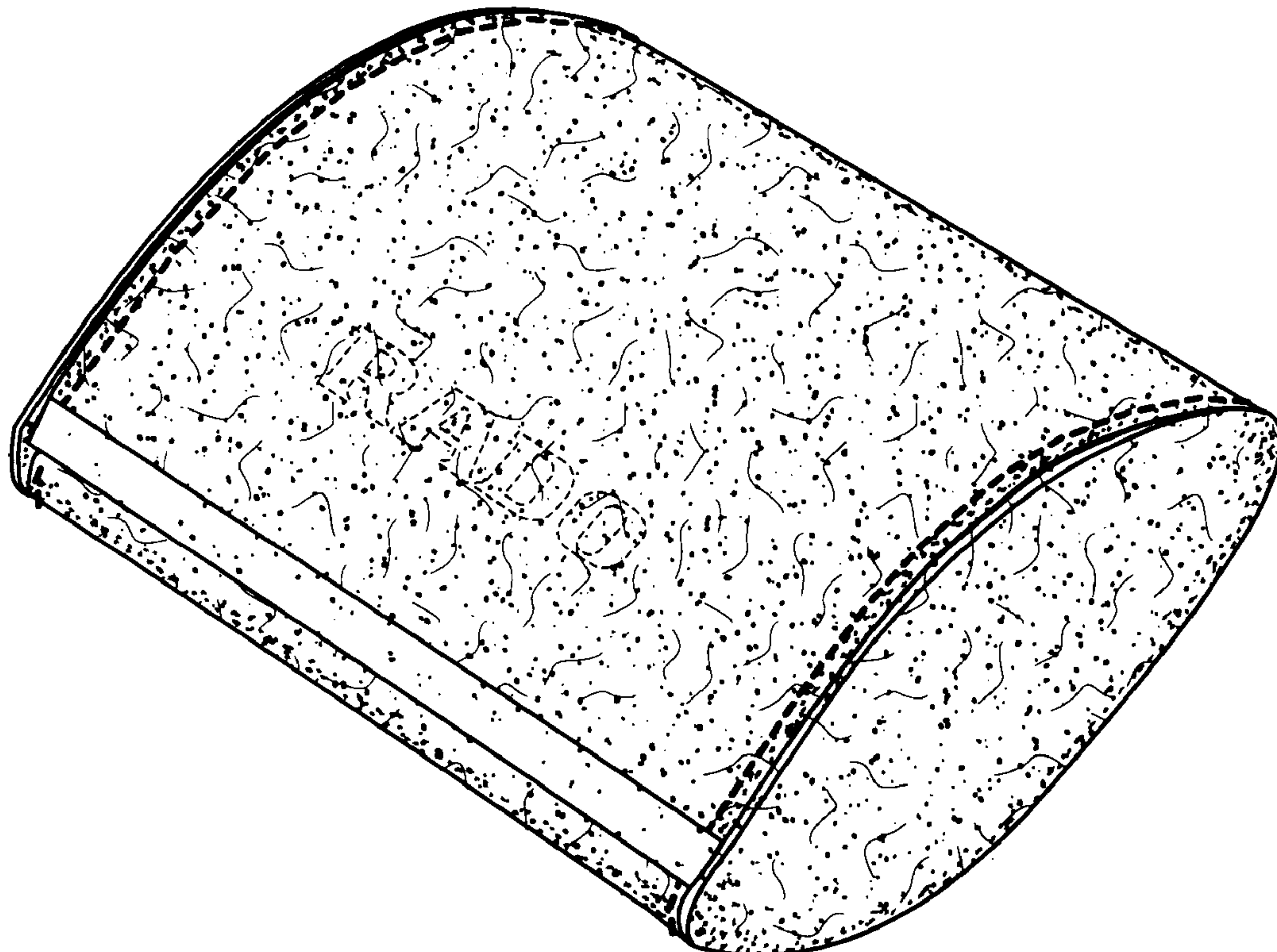
The ornamental design for a presentation case, as shown and described.

DESCRIPTION

FIG. 1 is a top view of my new and ornamental design for a presentation case;
 FIG. 2 is a bottom view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a rear view thereof;
 FIG. 5 is a left side view thereof; the right side view being a mirror image thereof;
 FIG. 6 is a front perspective view thereof;
 FIG. 7 is a top view of the presentation case with the cover open;
 FIG. 8 is a bottom view of FIG. 7;
 FIG. 9 is a front view of FIG. 7;
 FIG. 10 is a rear view of FIG. 7;
 FIG. 11 is a left side view of FIG. 7;
 FIG. 12 is a right side view of FIG. 7; and,
 FIG. 13 is a front perspective view of FIG. 7.

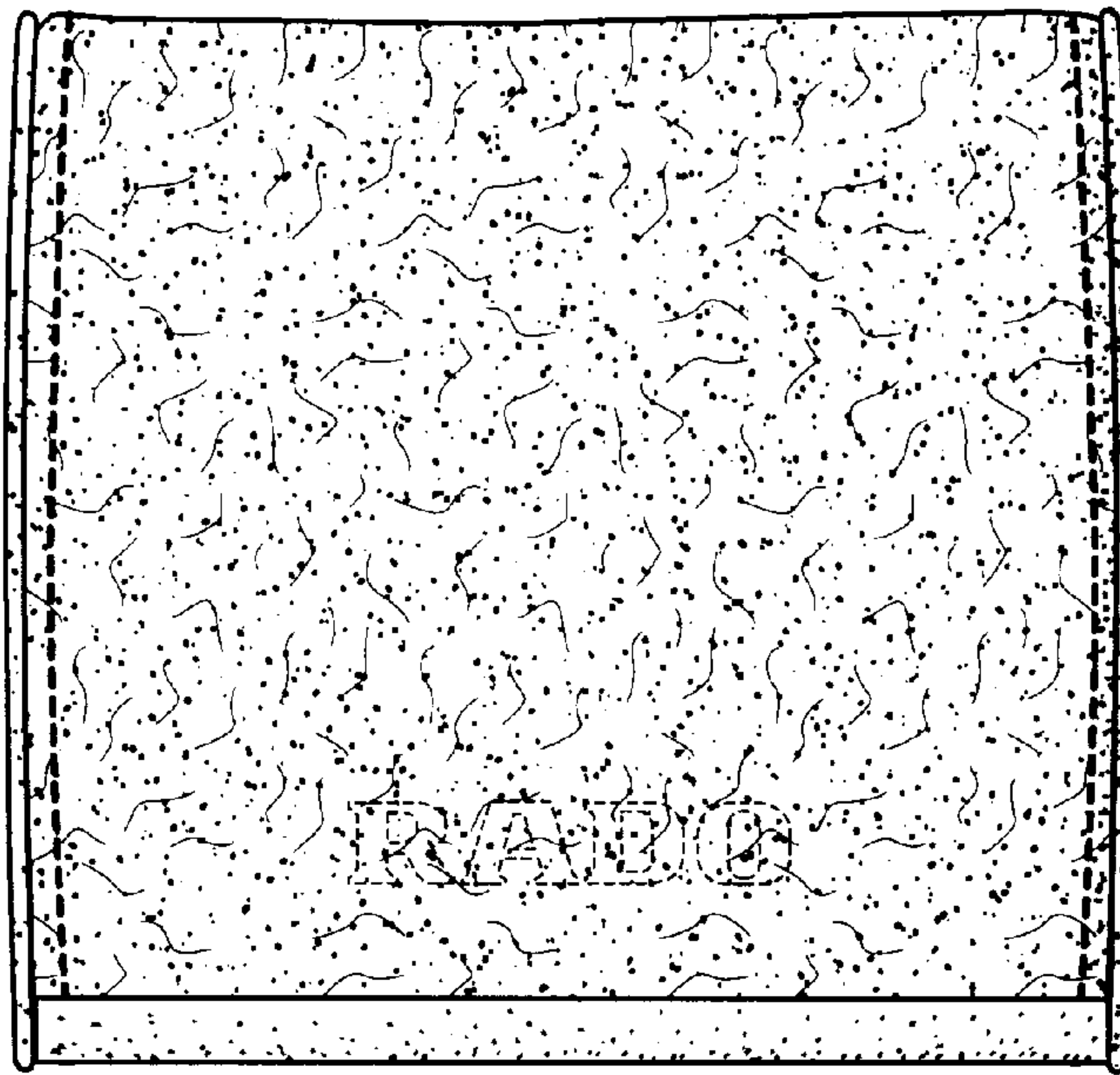

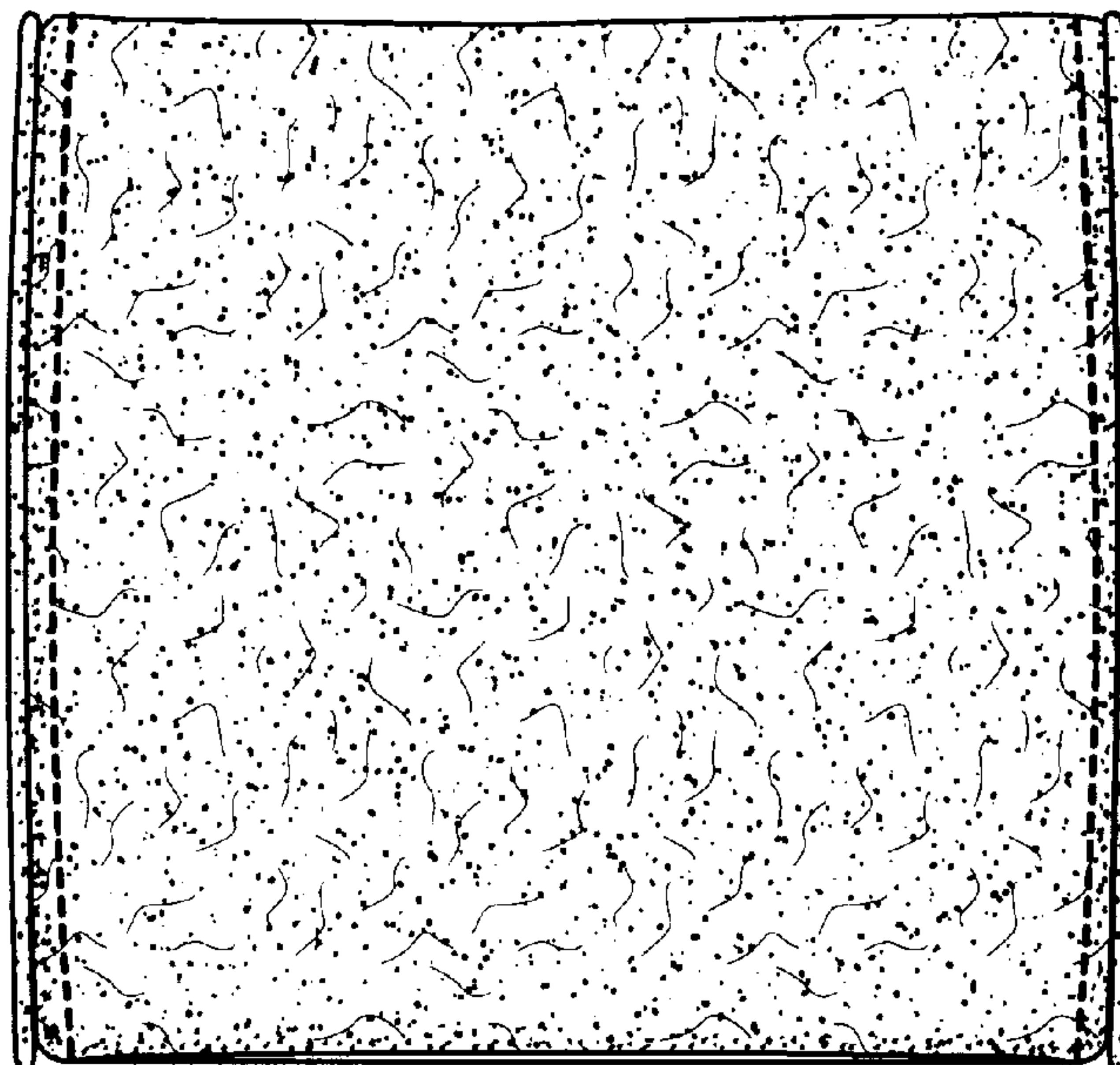

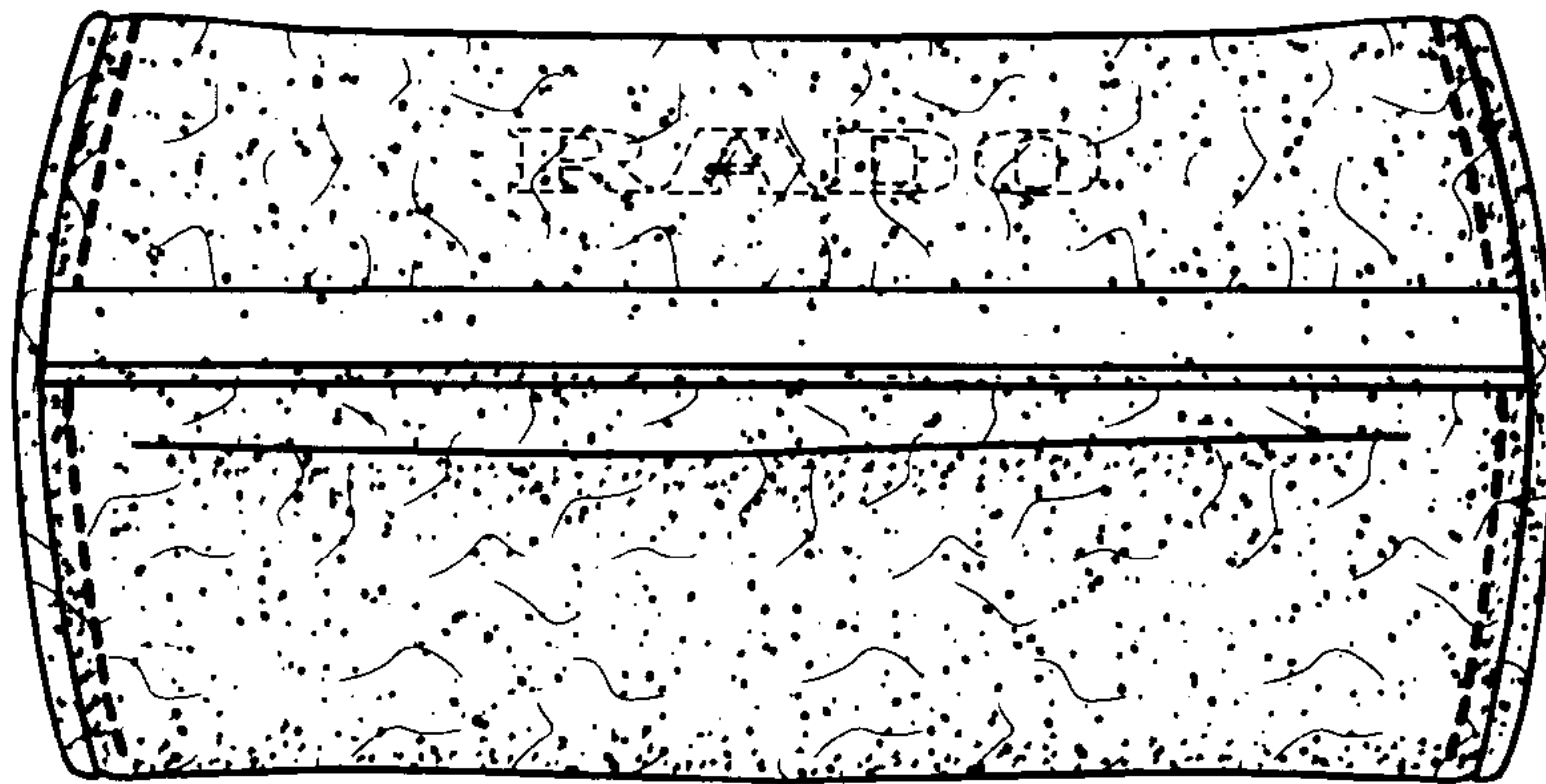

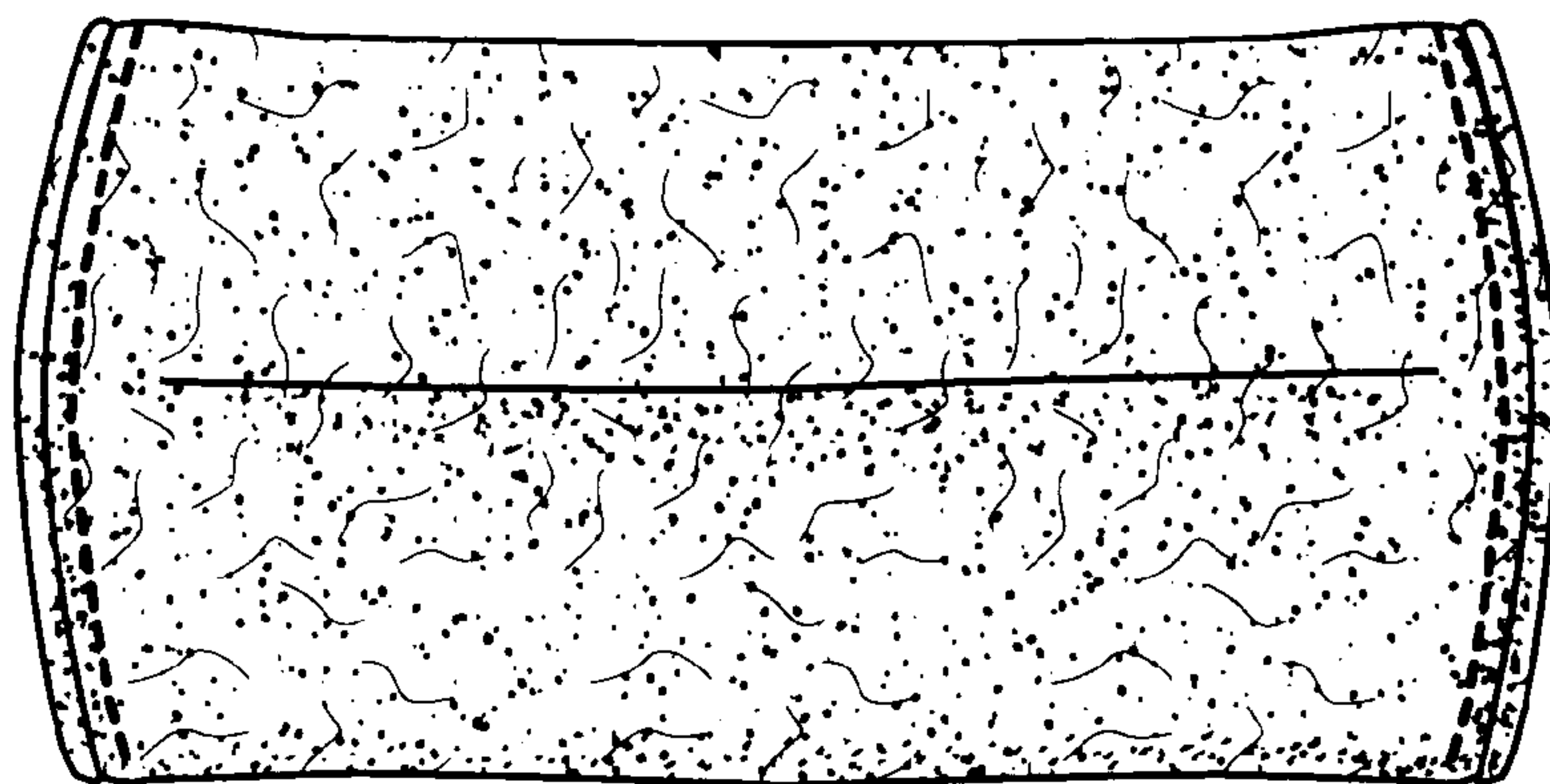

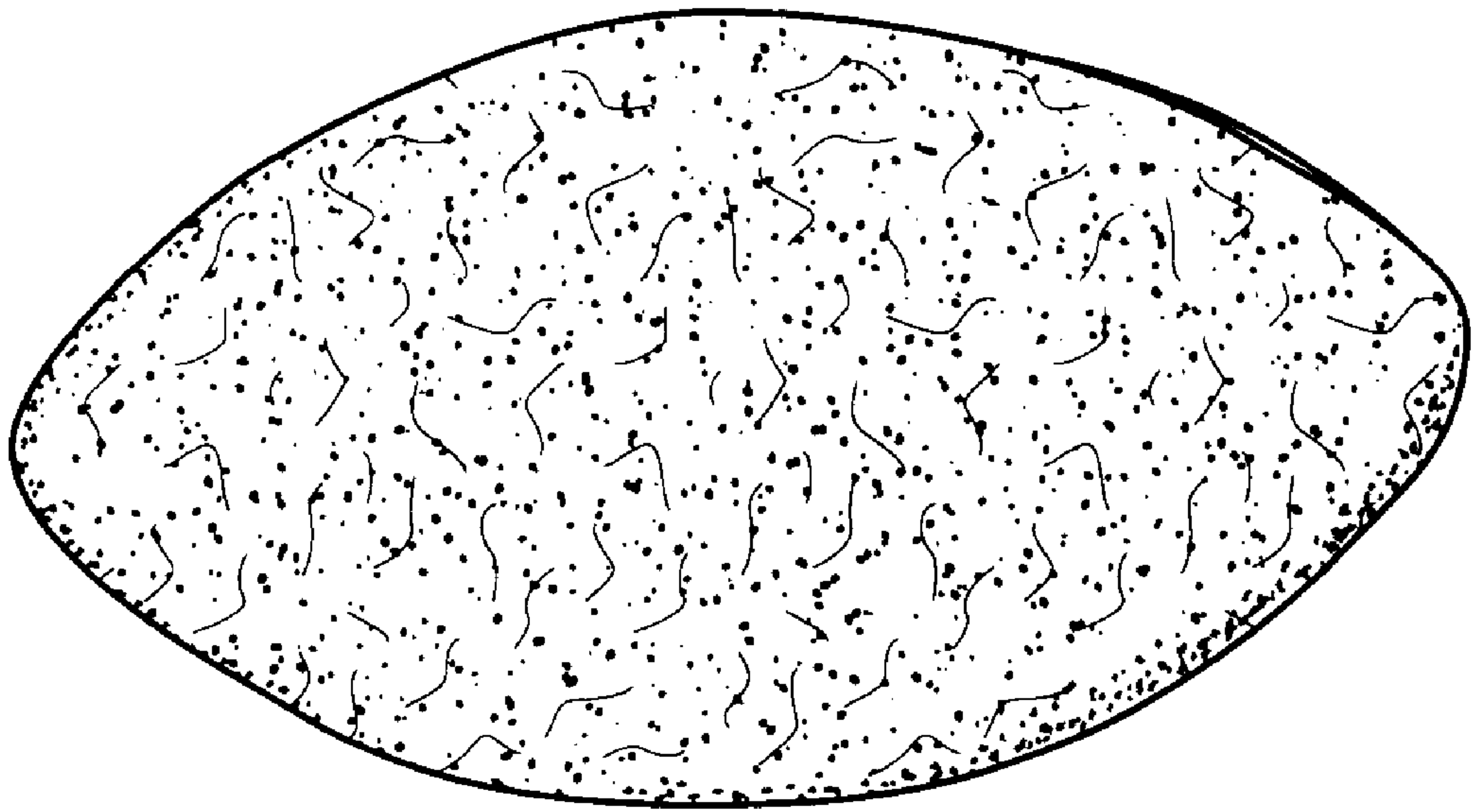

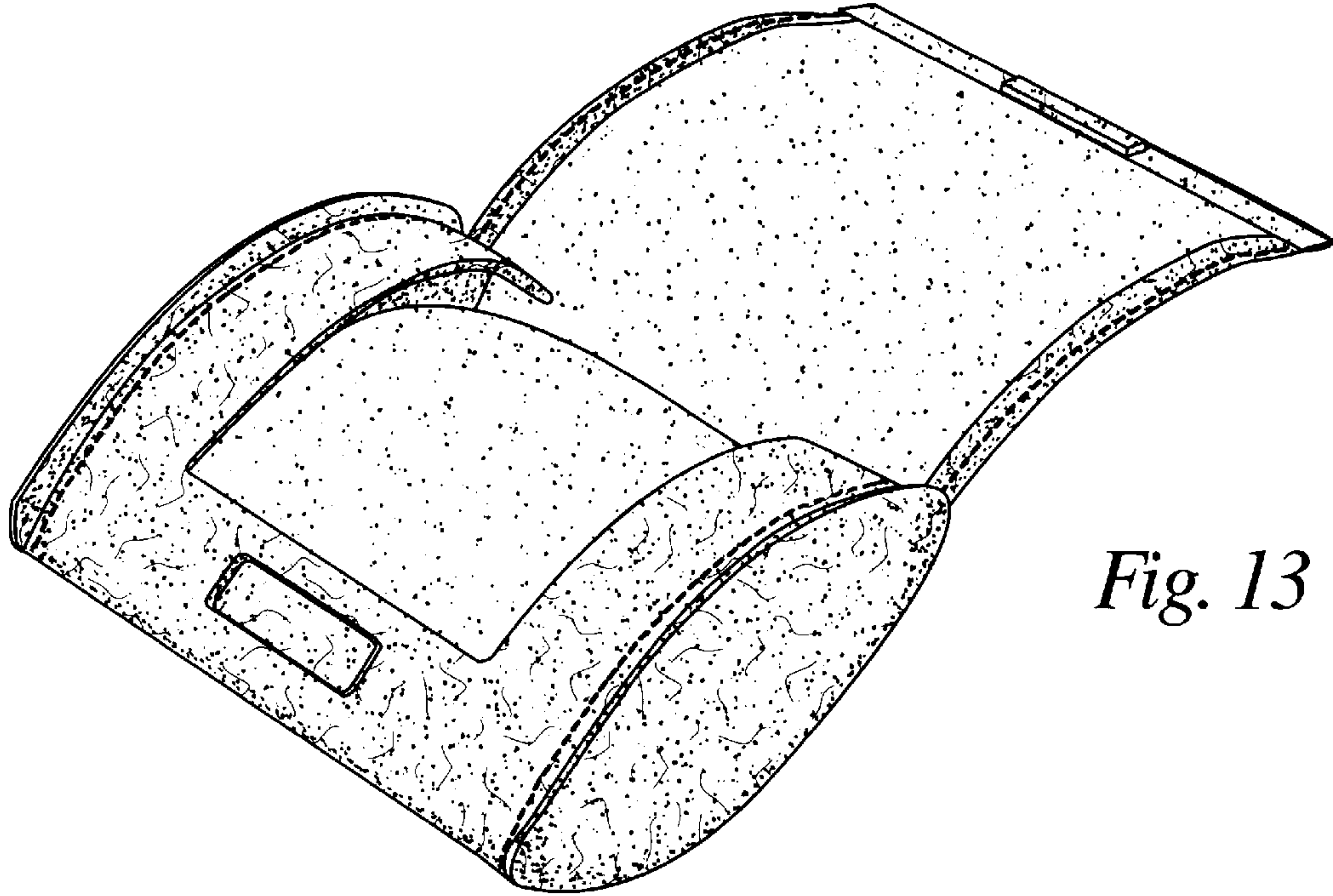

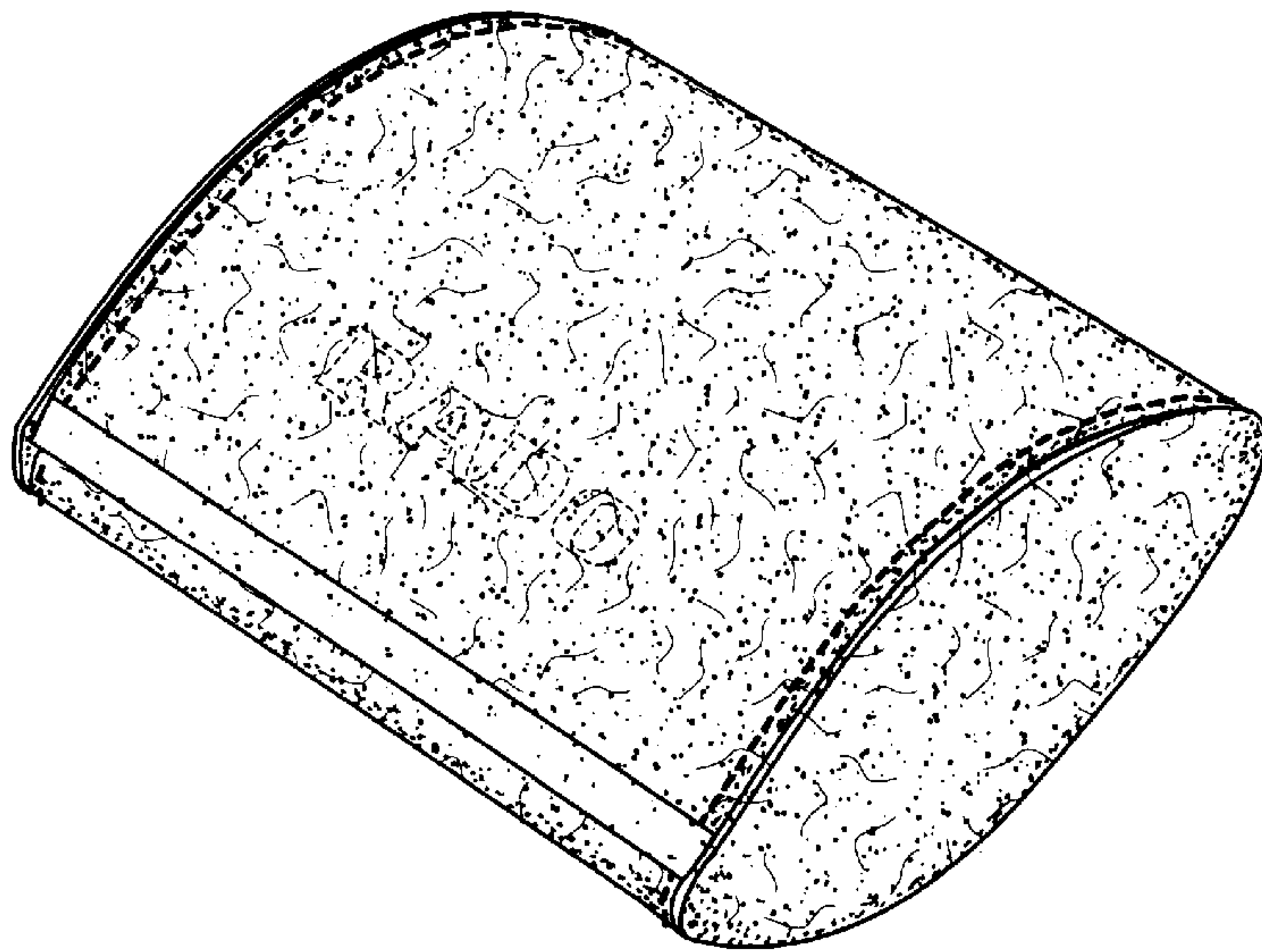

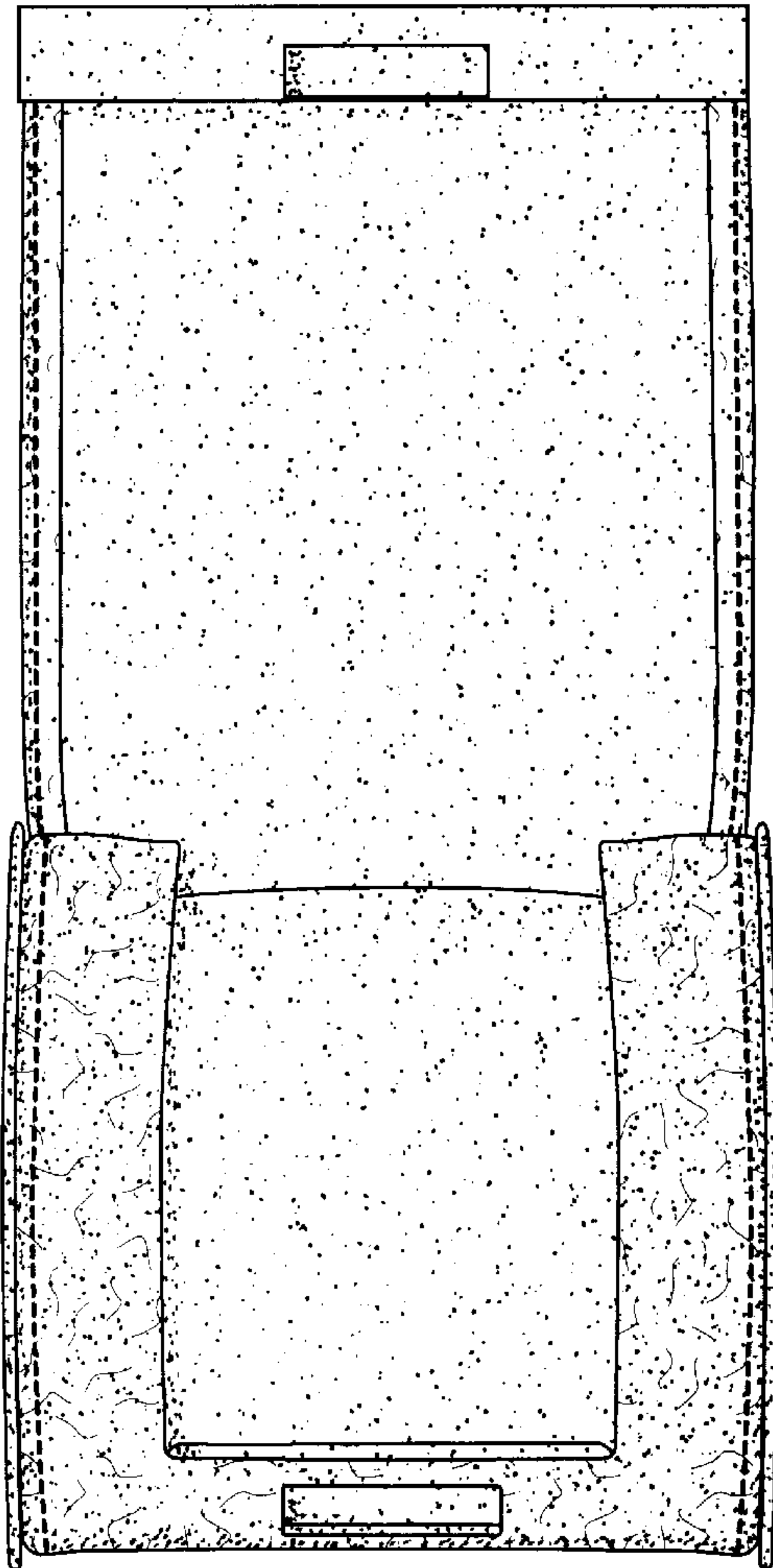

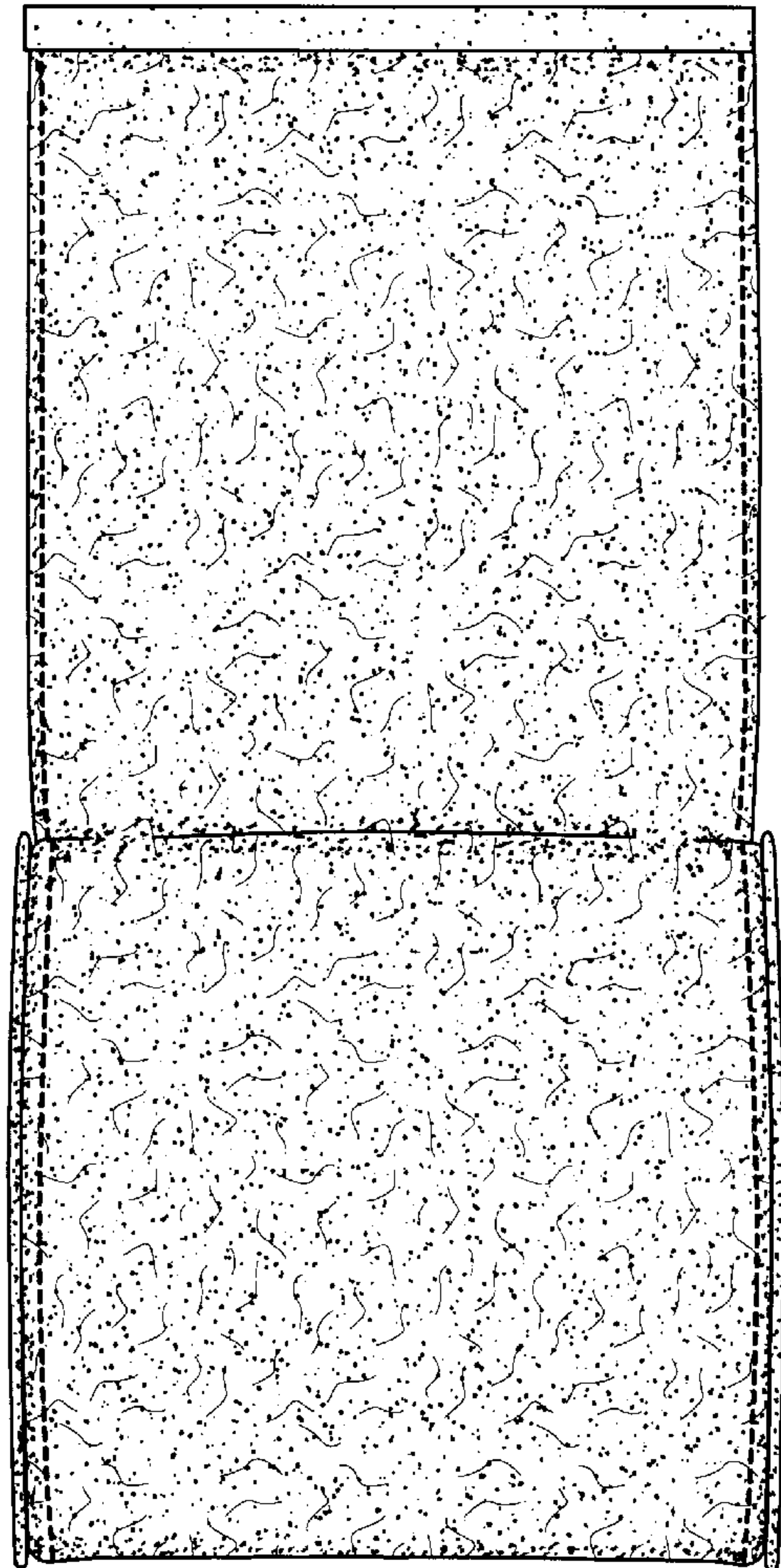

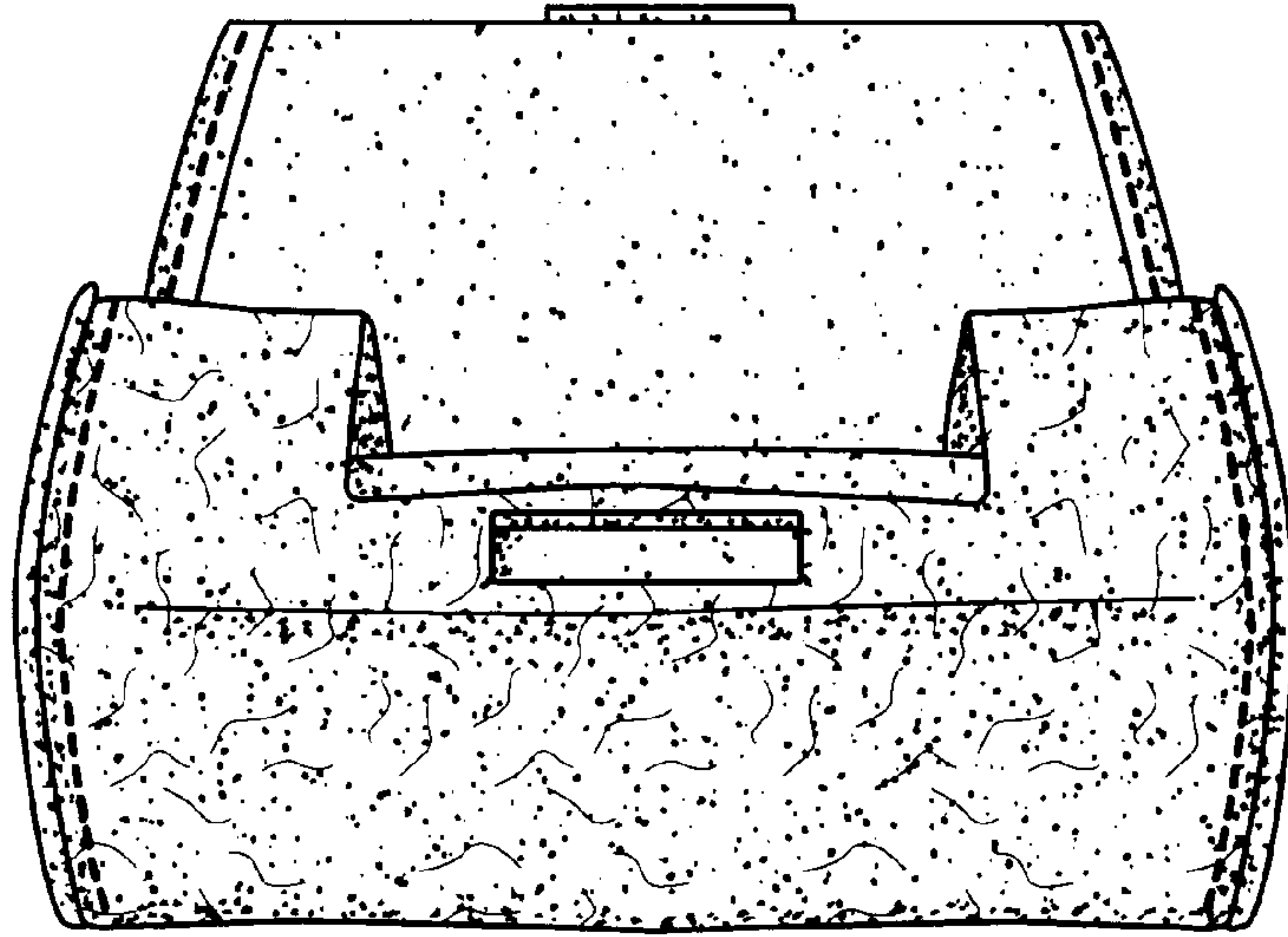

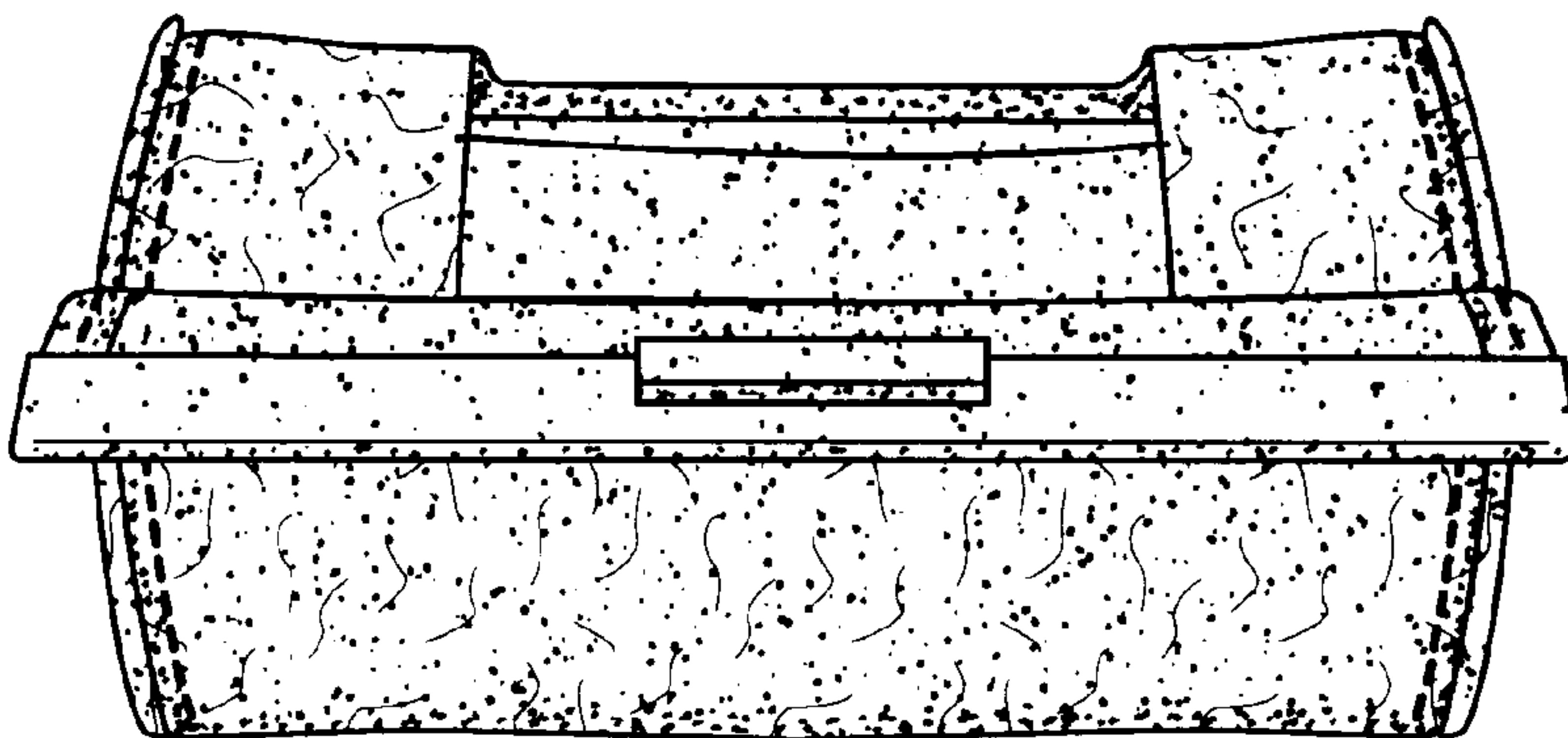

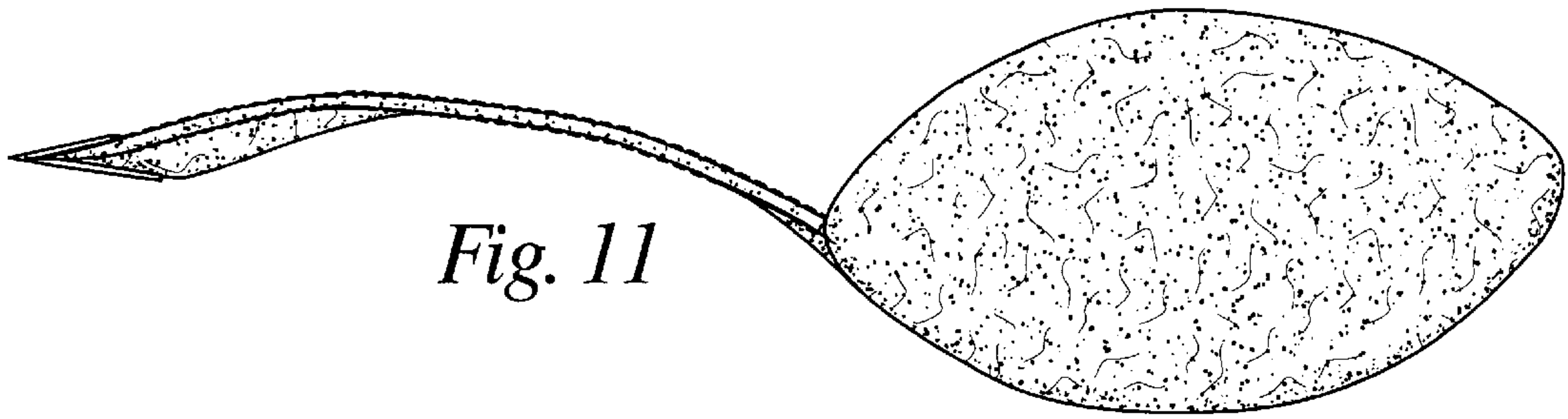

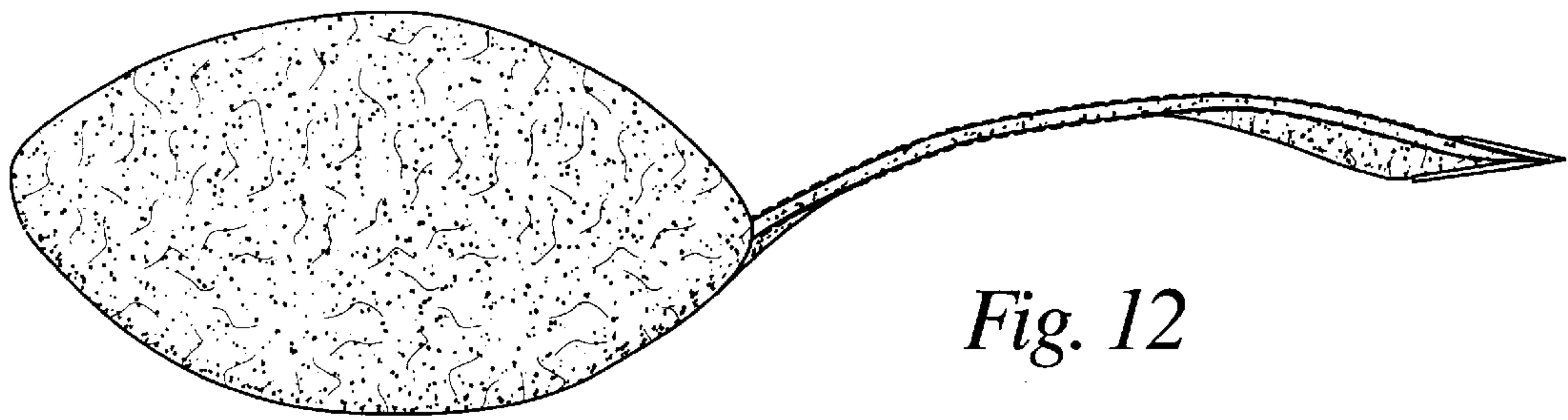
