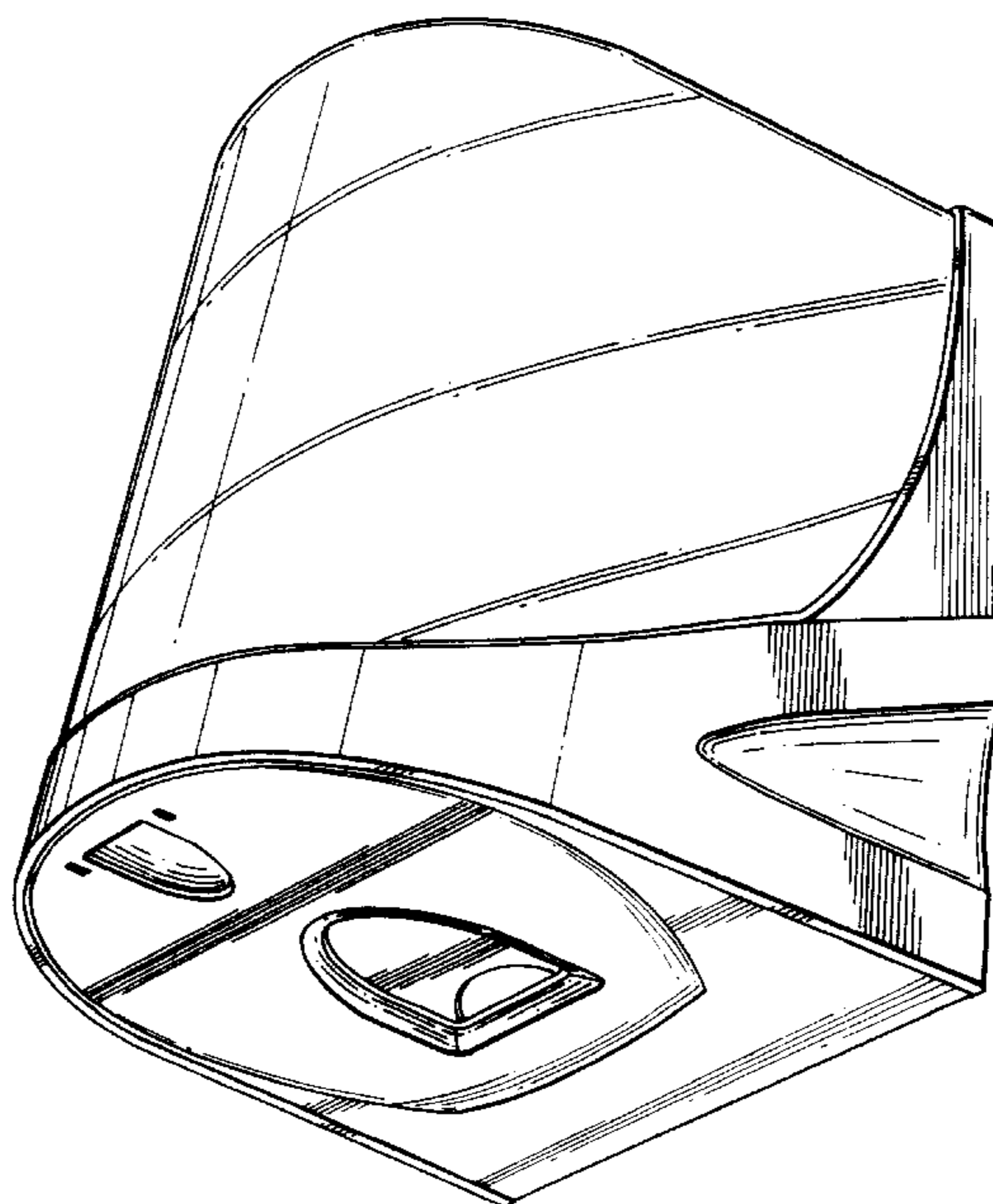
[57] **CLAIM**

We claim the ornamental design for the sheet material dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a left front perspective view of the sheet material dispenser showing our new design;
FIG. 2 is a bottom plan view thereof;
FIG. 3 is a front elevation thereof;
FIG. 4 is a rear elevation thereof;
FIG. 5 is a right side elevation thereof;
FIG. 6 is a left side elevation thereof; and,
FIG. 7 is a top plan view thereof.

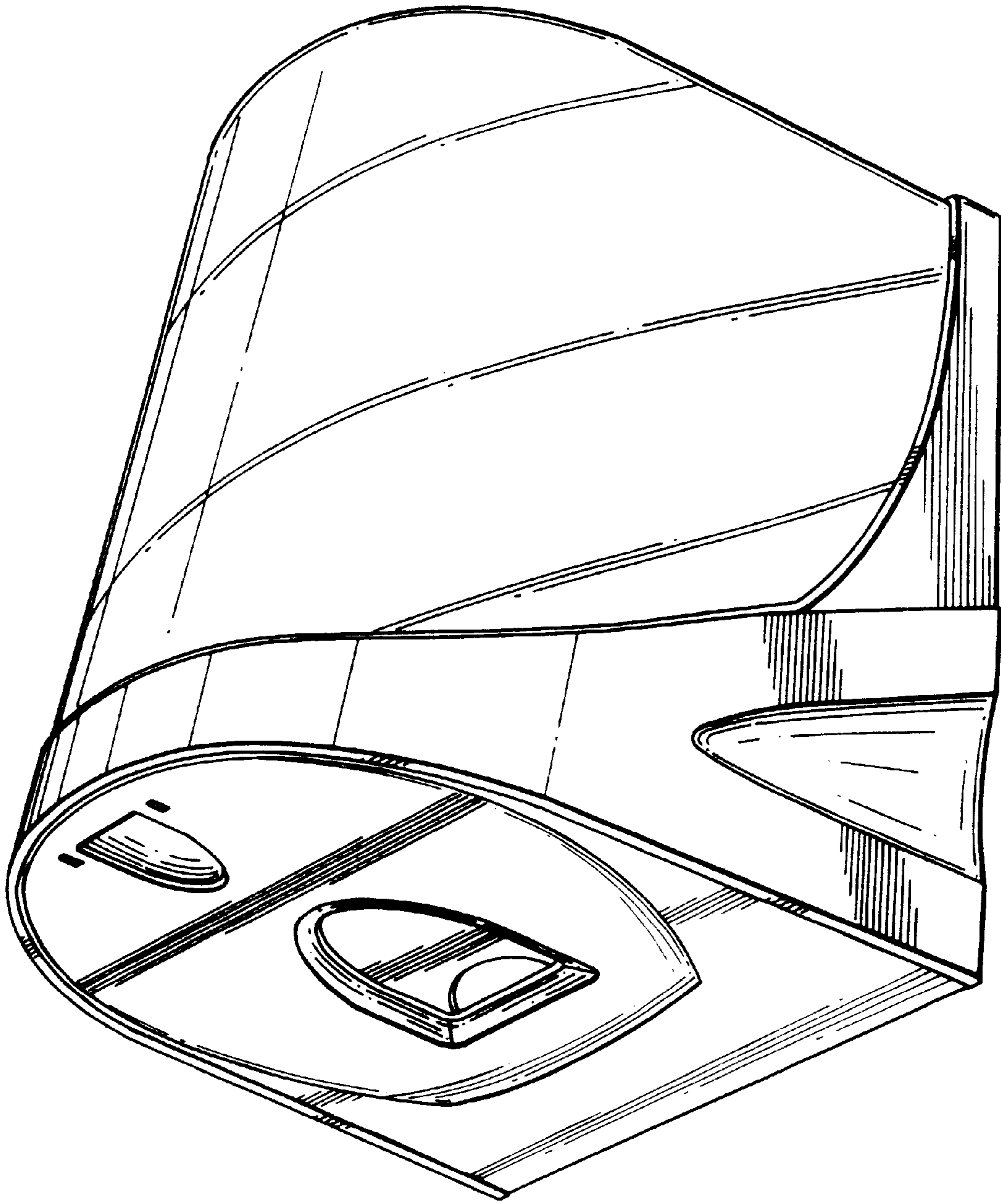

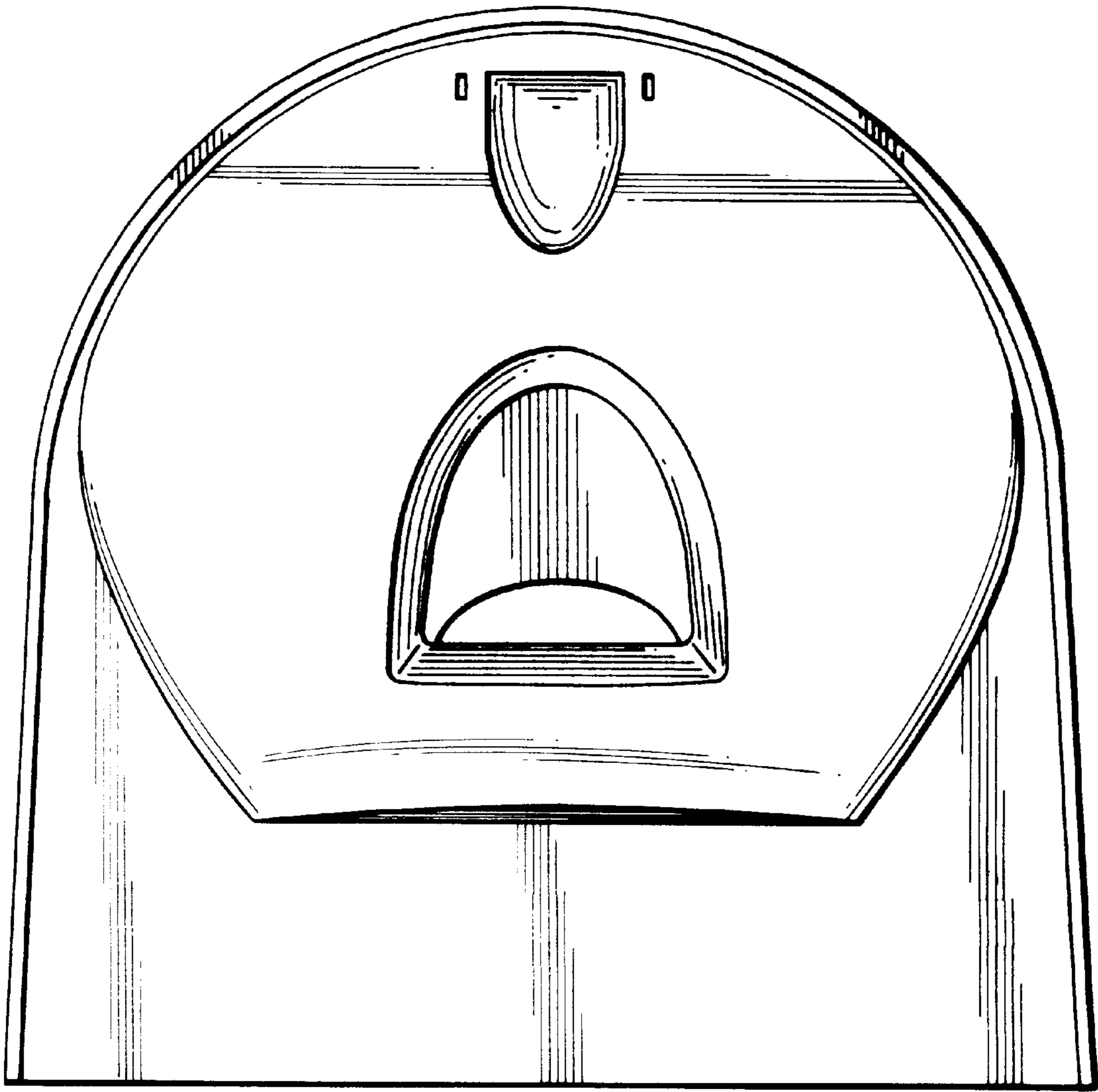

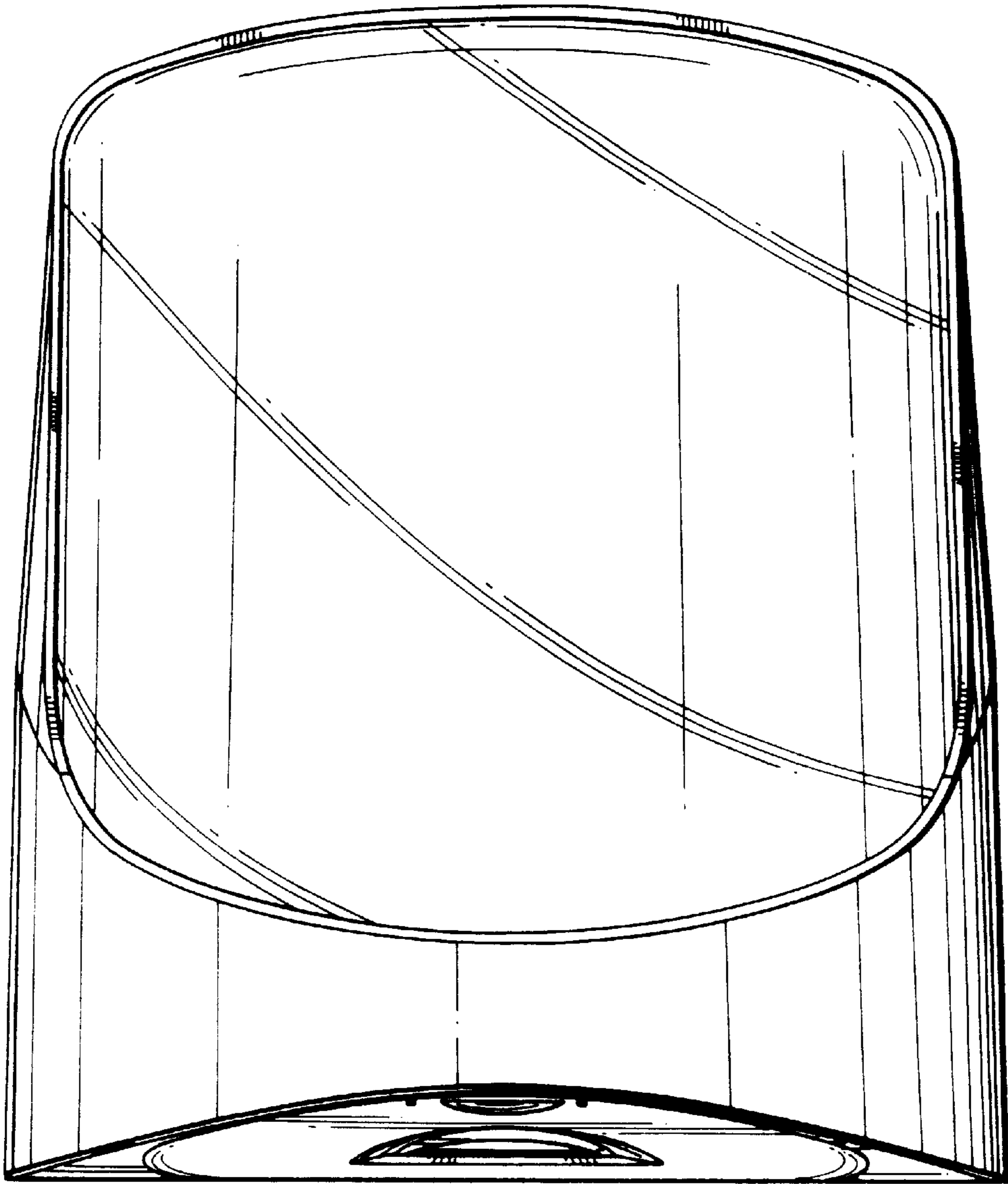

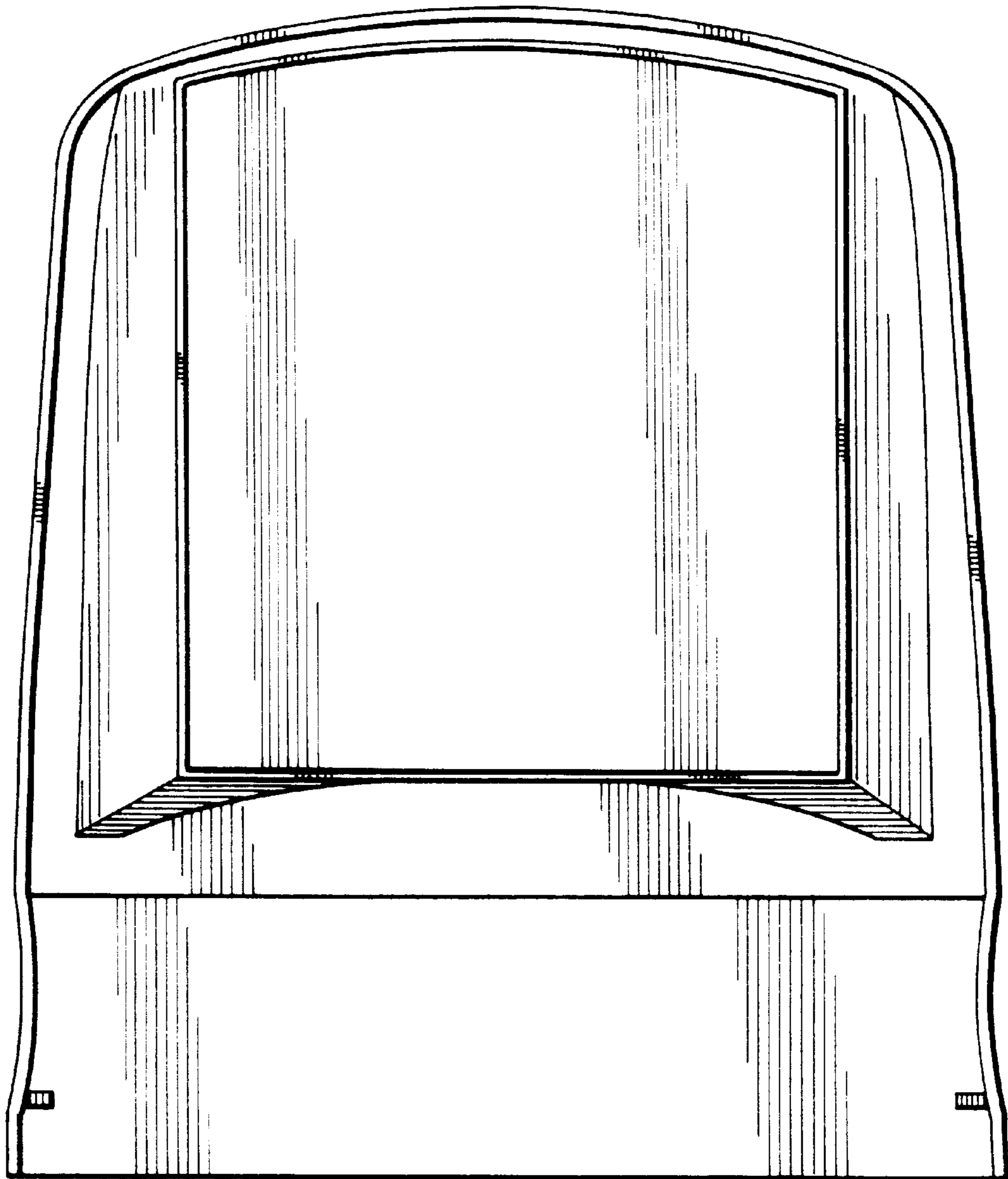

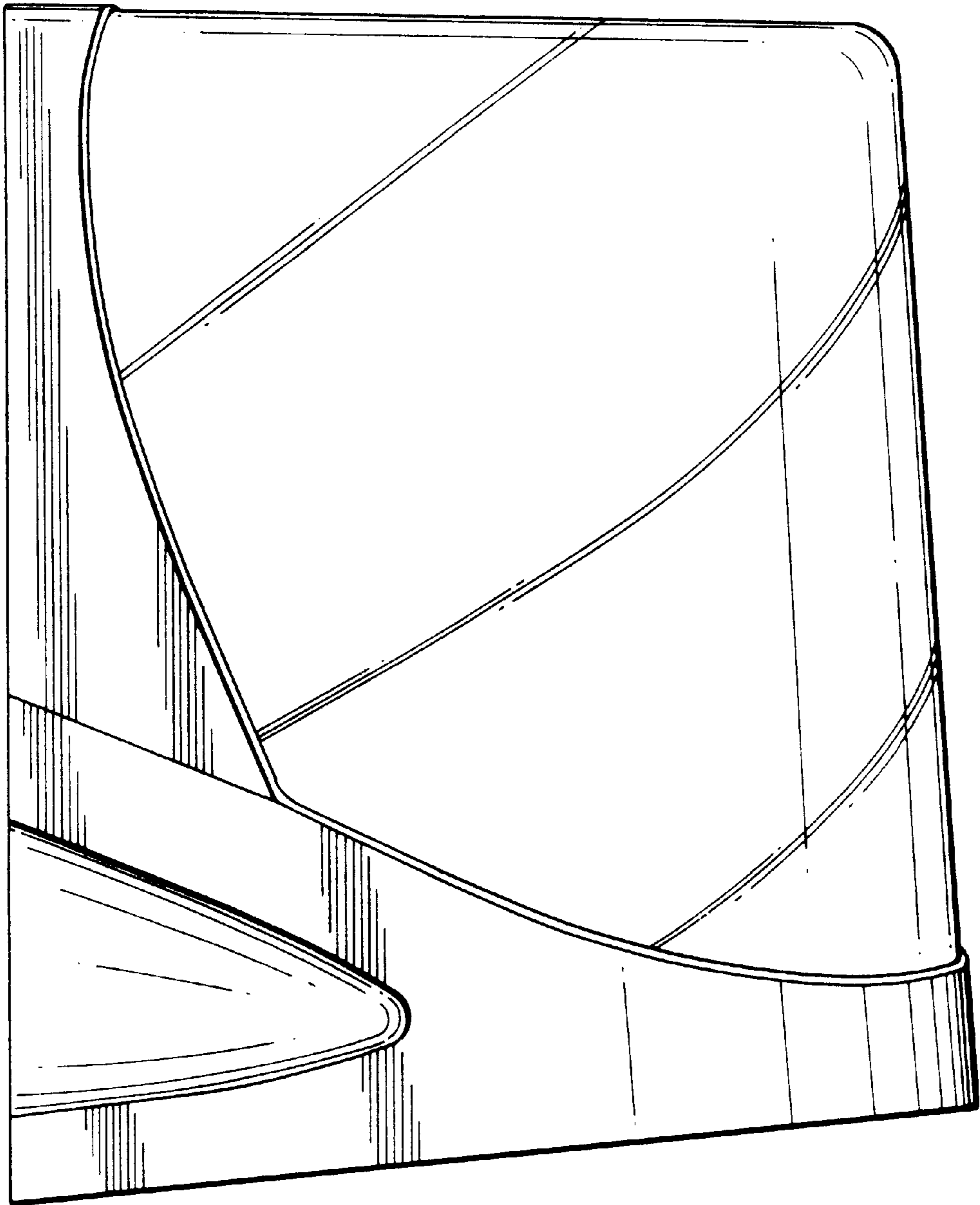

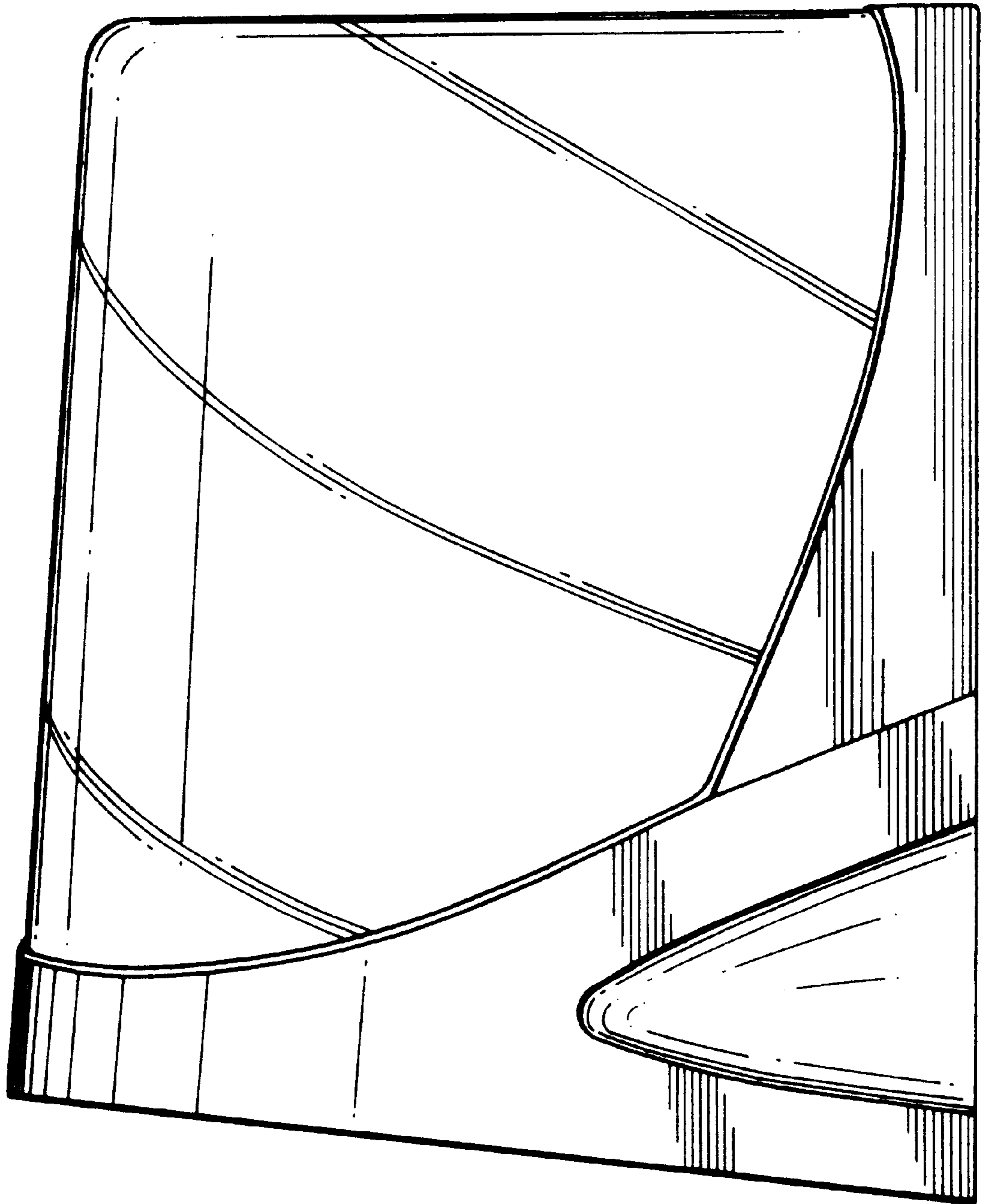

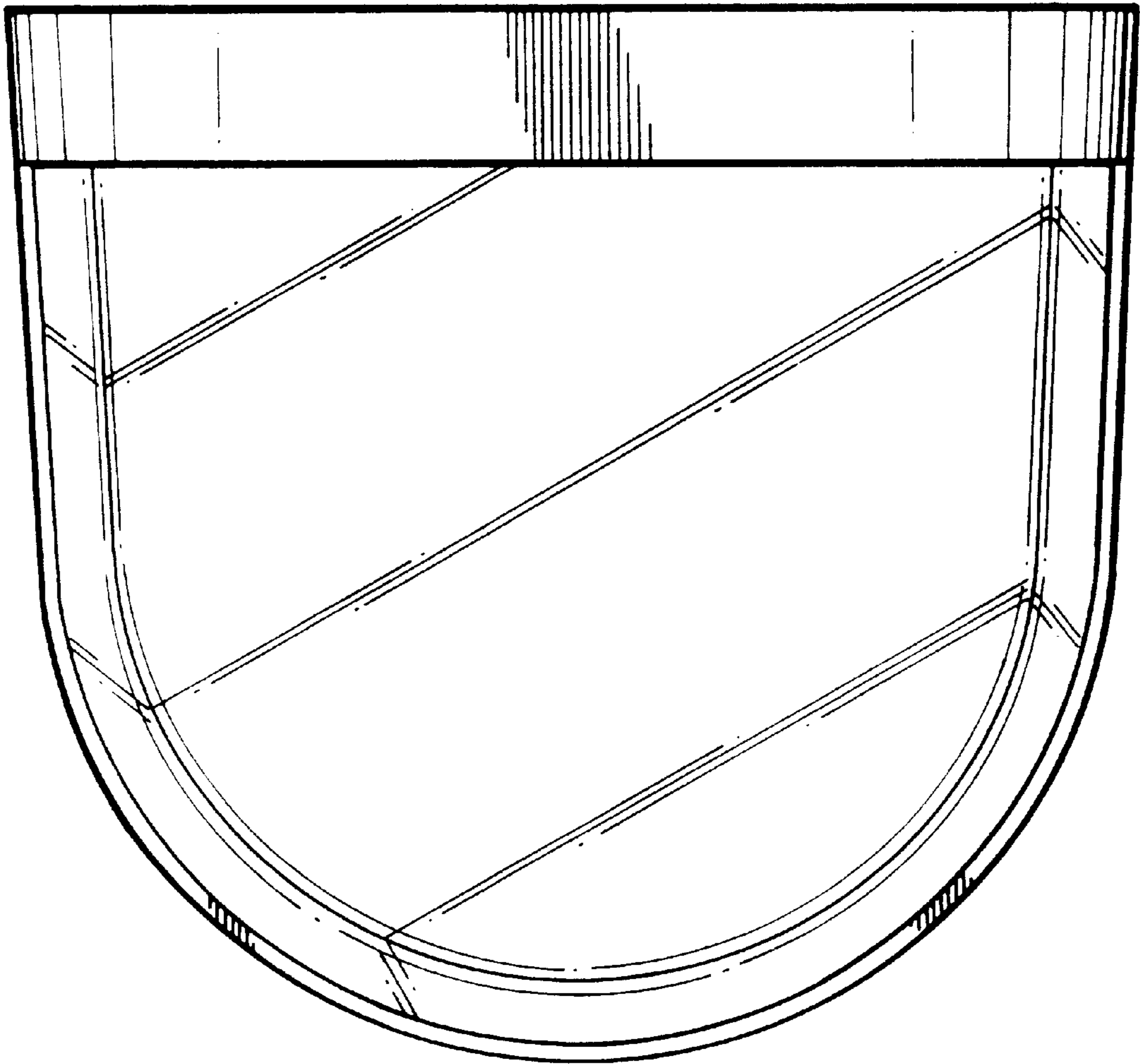
