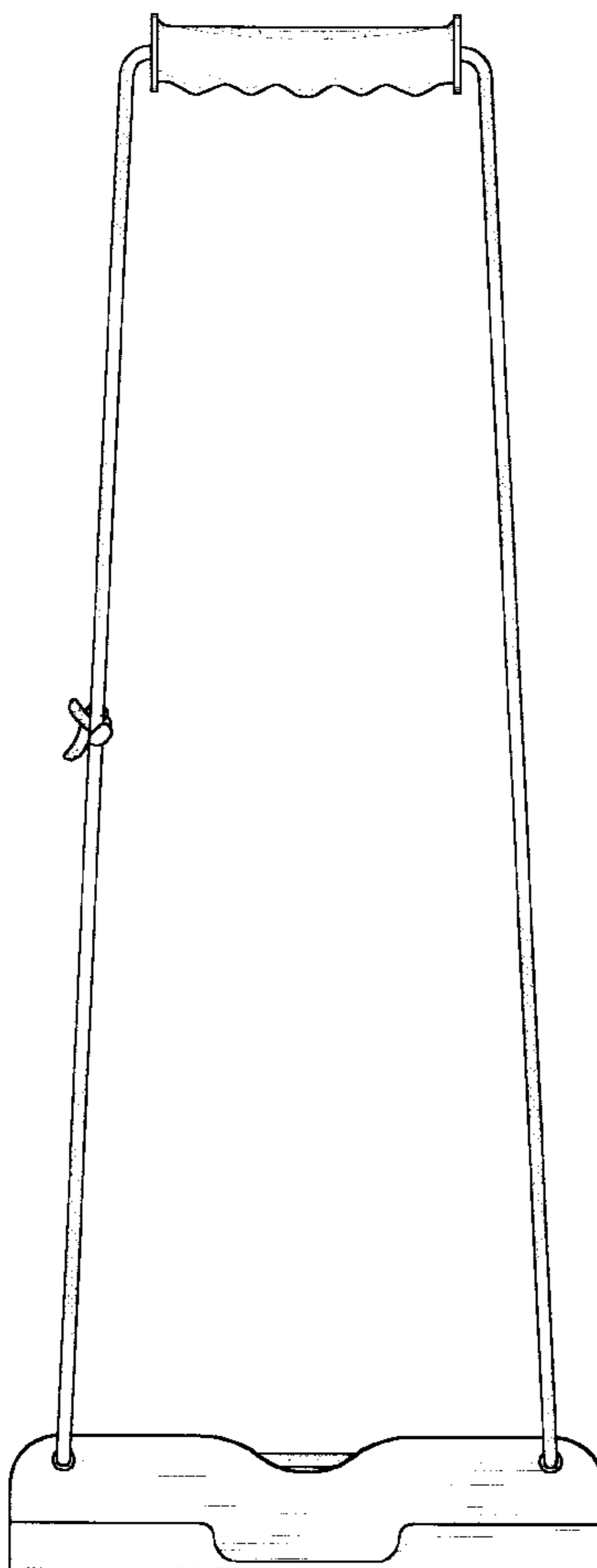

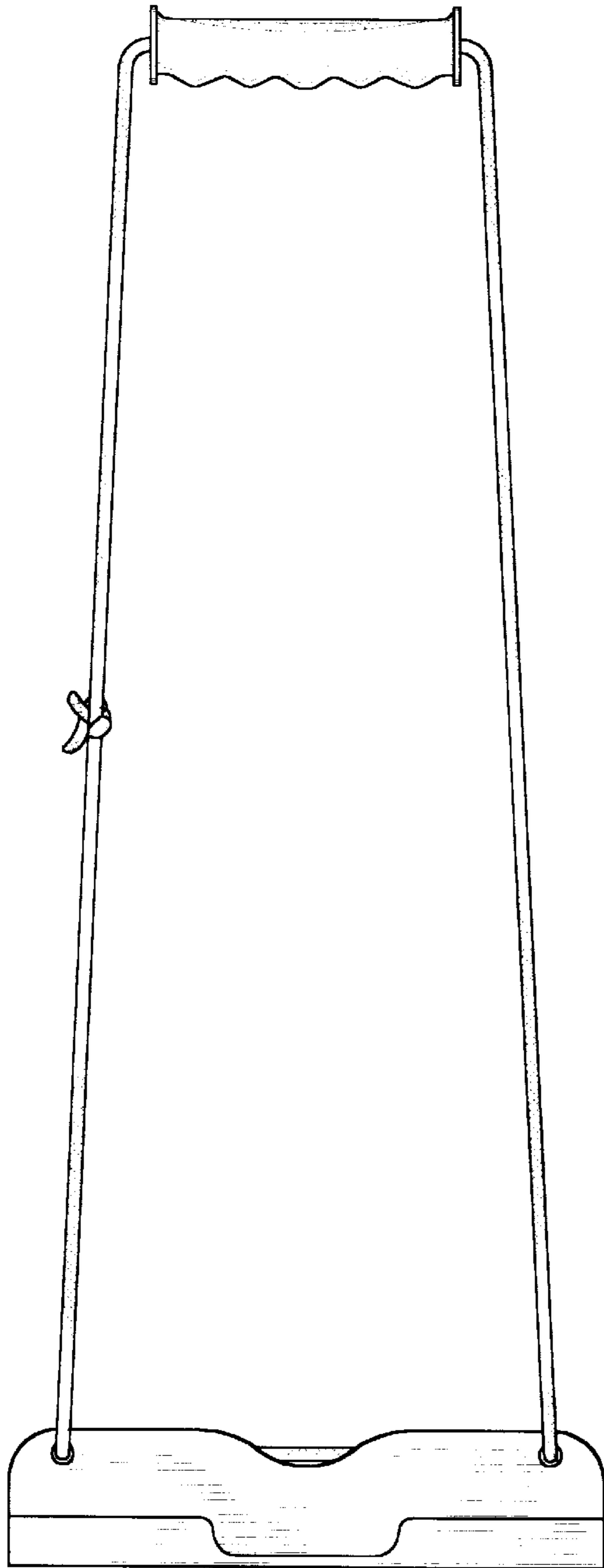
The ornamental design for a handle for carrying wallboard, as shown.

**DESCRIPTION**

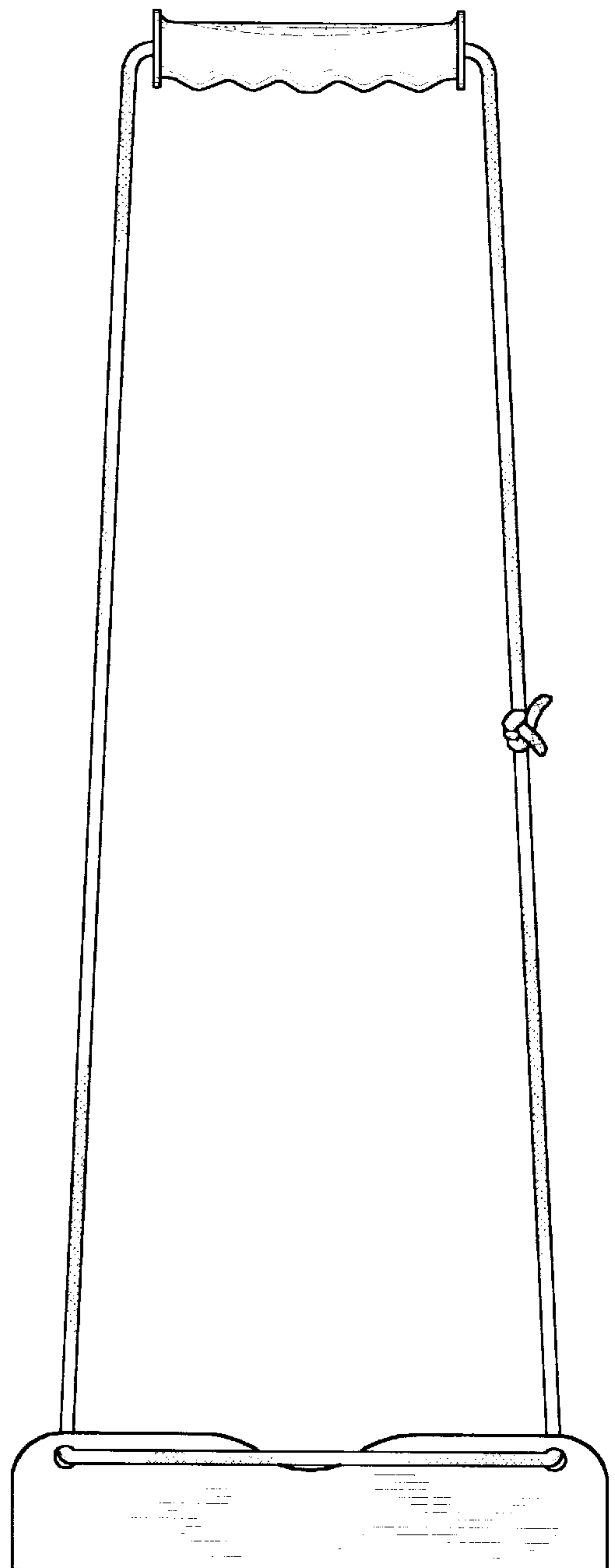
FIG. 1 is a front elevational view of the handle for carrying wallboard of the present invention;

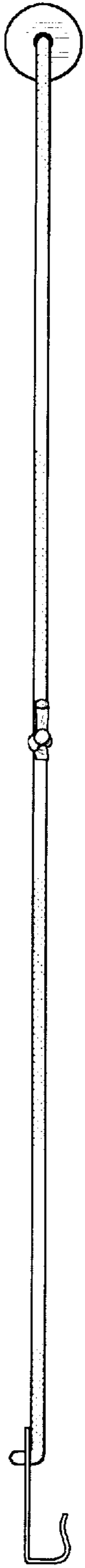




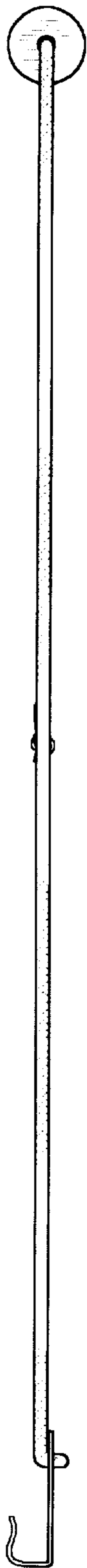

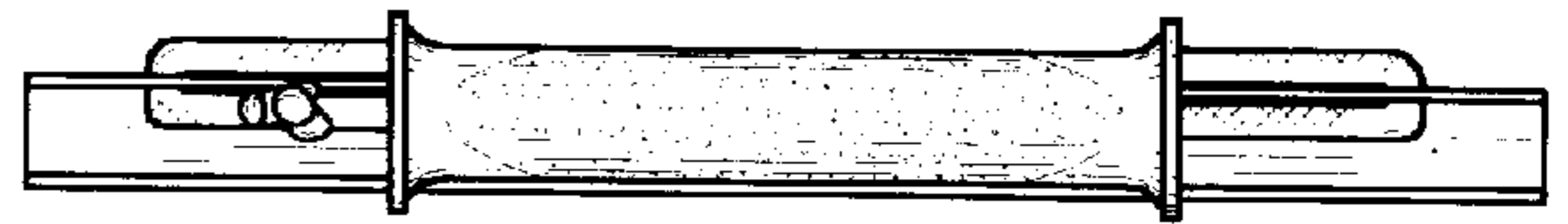

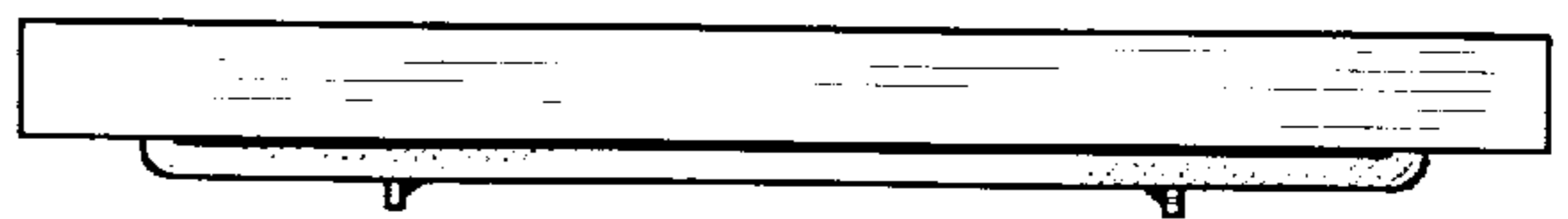
