[57] **CLAIM**

The ornamental design for a bag holder, as shown and described.

**DESCRIPTION**

FIG. 1 is a diagrammatic perspective view of the bag holder in full lines with a bag shown in broken lines representing environmental association matter being for illustrative purposes only and forming no part of the claimed invention. FIG. 2 is a front elevational view thereof, the rear elevational view being a mirror image of the front view. FIG. 3 is a top plan view thereof. FIG. 4 is a bottom plan view thereof. FIG. 5 is a left side elevational view of the bag holder; and, FIG. 6 is a right side elevational view thereof.

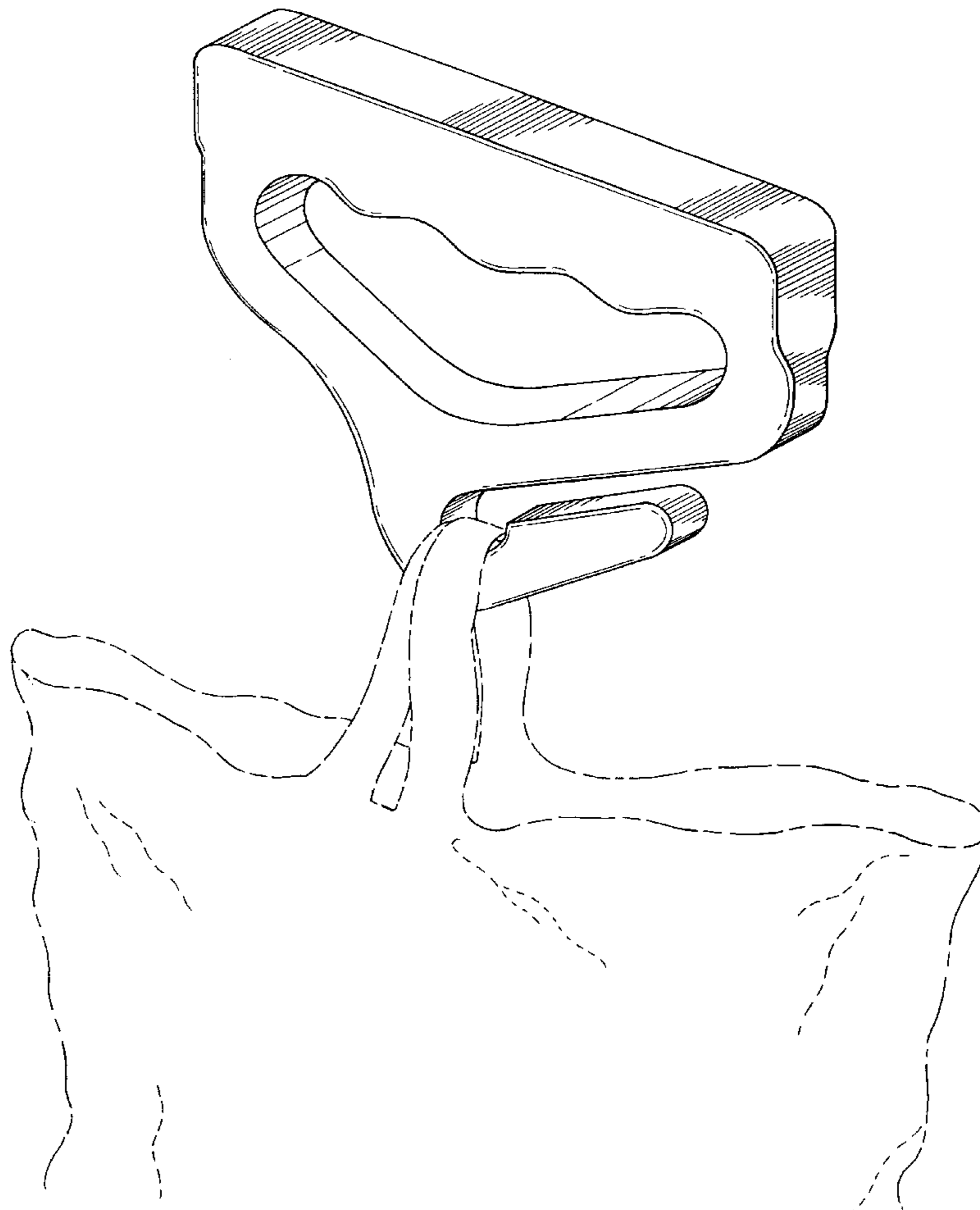

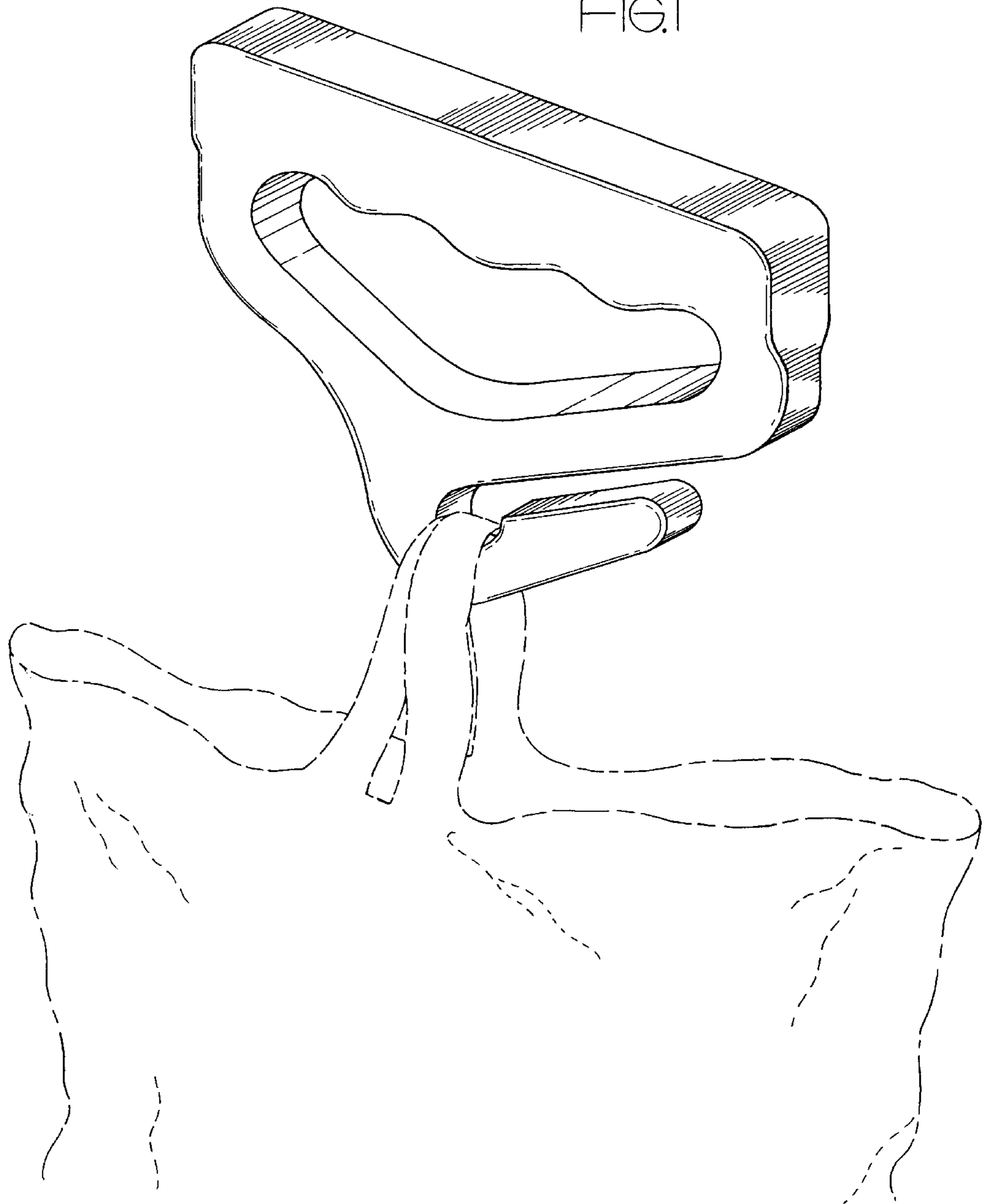

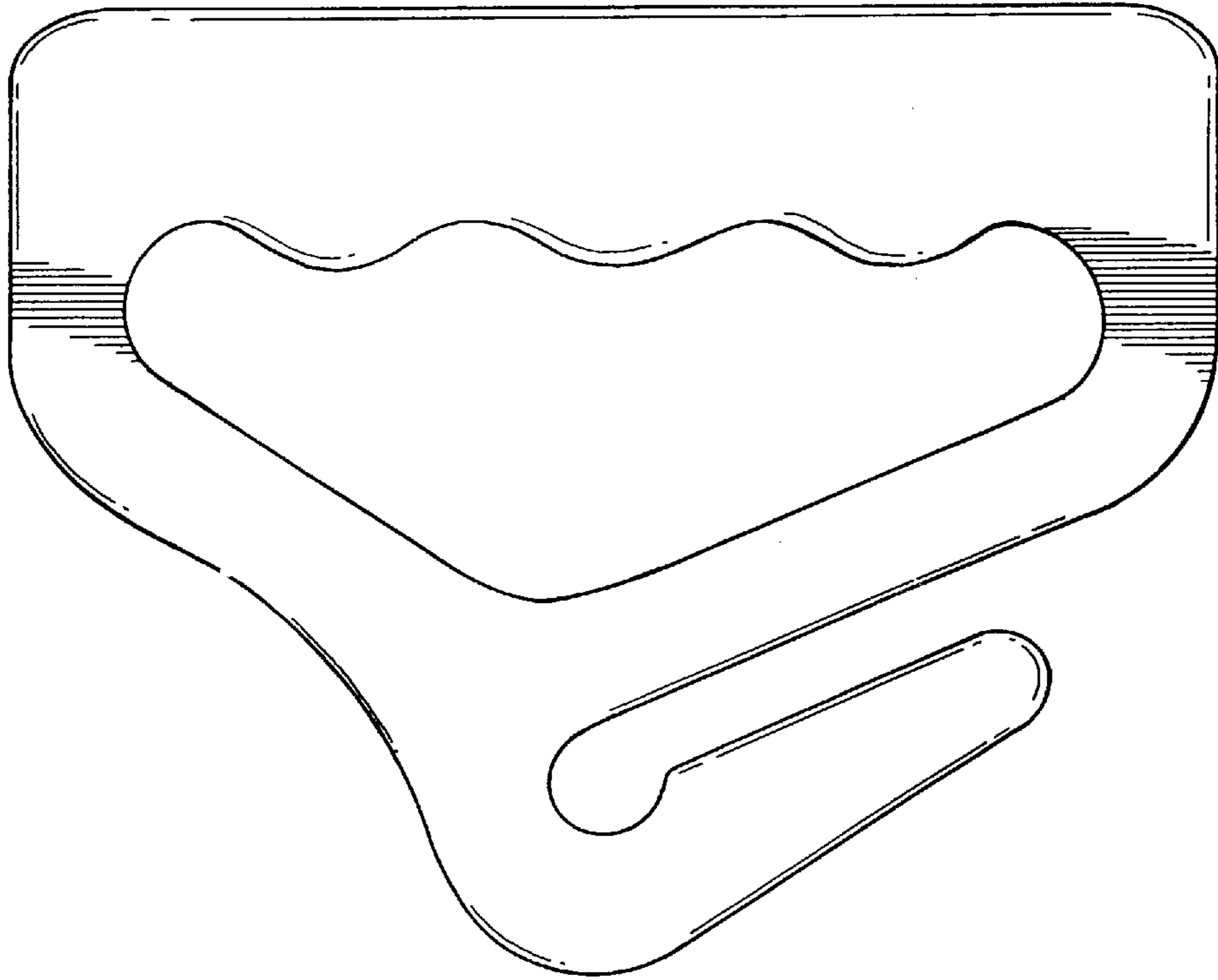

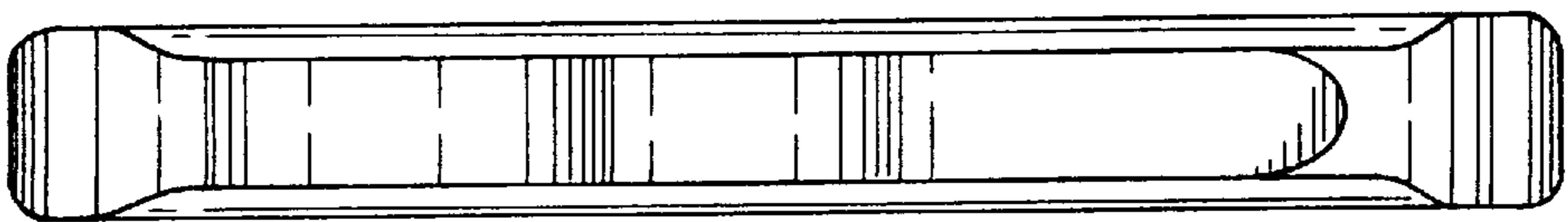

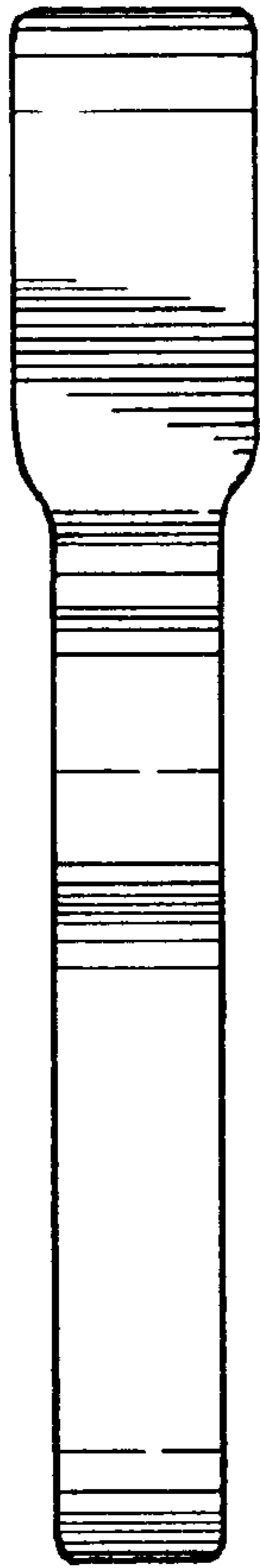

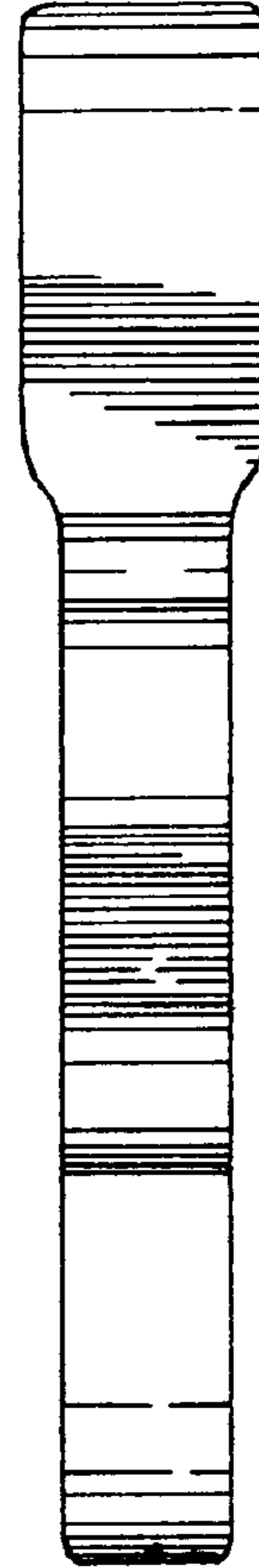
