[57] CLAIM

The ornamental design for a light box, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the light box of our design. FIG. 2 is a front elevational view of the light box of FIG. 1. FIG. 3 is a right side elevational view of the light box of FIGS. 1 and 2.

FIG. 4 is a top view of the light box of FIGS. 1-3.

FIG. 5 is a rear view of the light box of FIGS. 1-4.

FIG. 6 is a side elevational view as seen from the left of the light box of FIGS. 1-6.

FIG. 7 is a bottom view of the light box of FIGS. 1-8.

FIG. 8 is a front elevational view of a second light box embodiment of the inventive design.

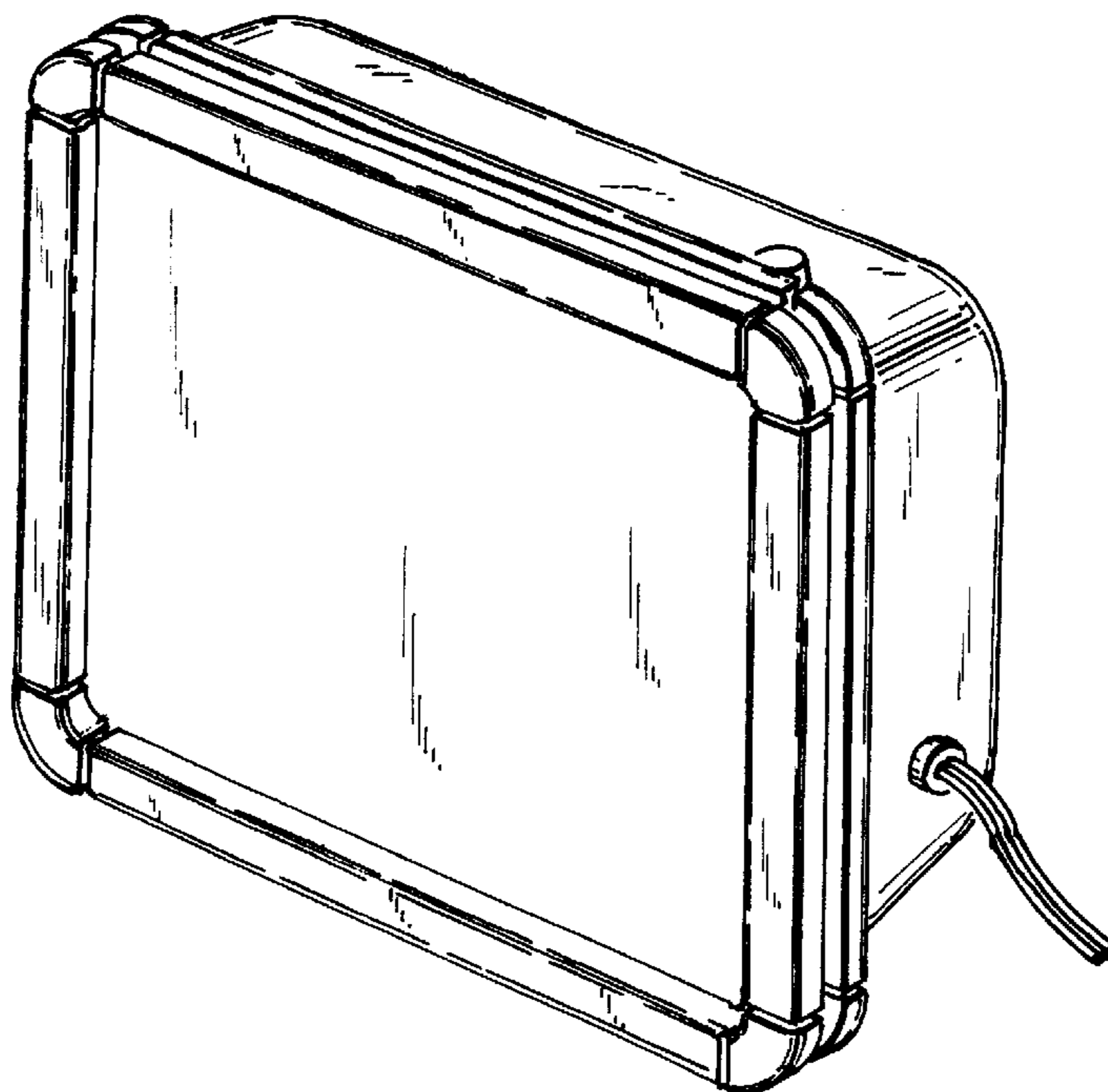
FIG. 9 is a rear elevational view of the light box of FIG. 8.

FIG. 10 is a right side elevational view of the light box of FIGS. 8 and 9.

FIG. 11 is a left side elevational view of the light box of FIGS. 8 and 9.

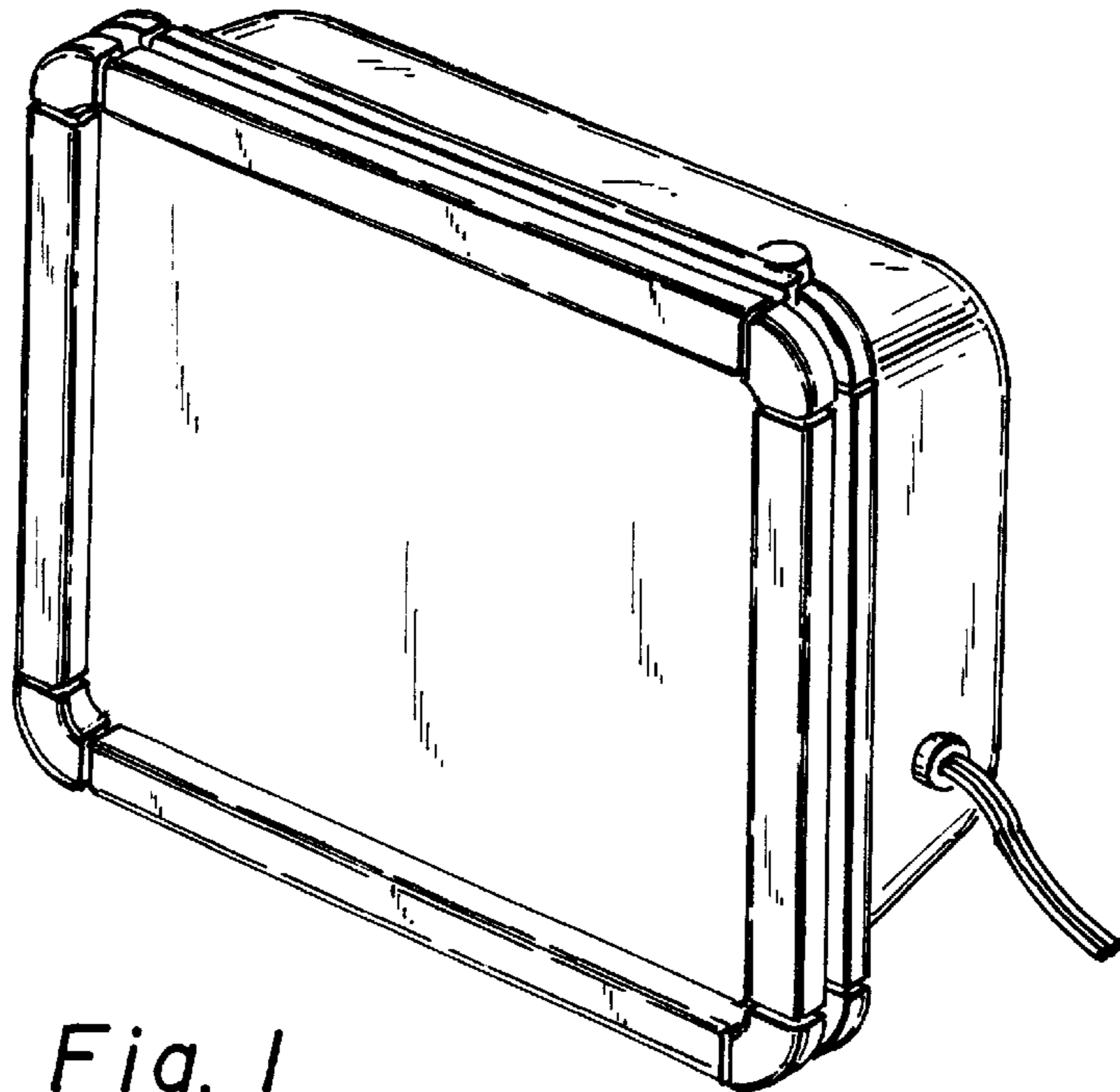

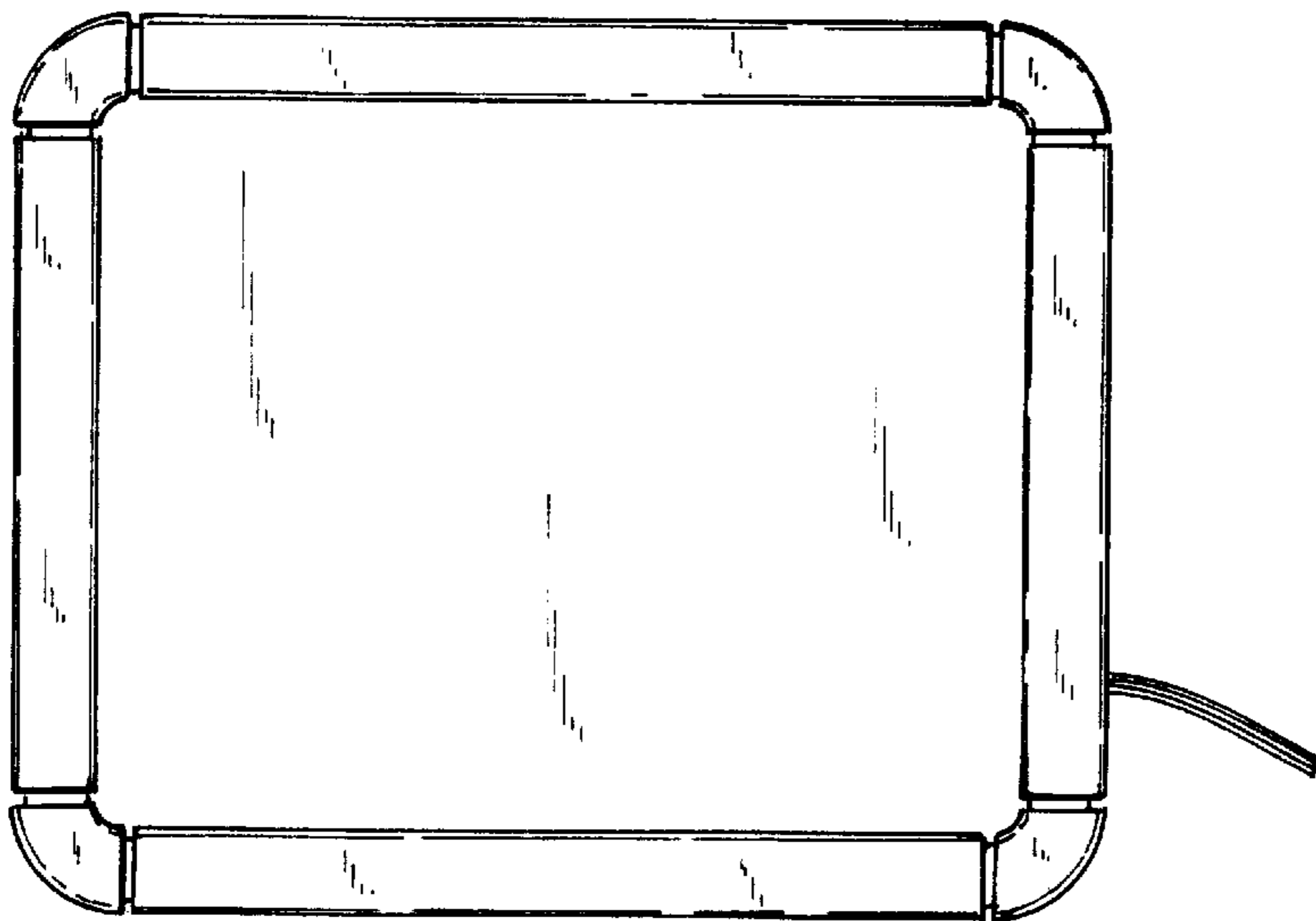

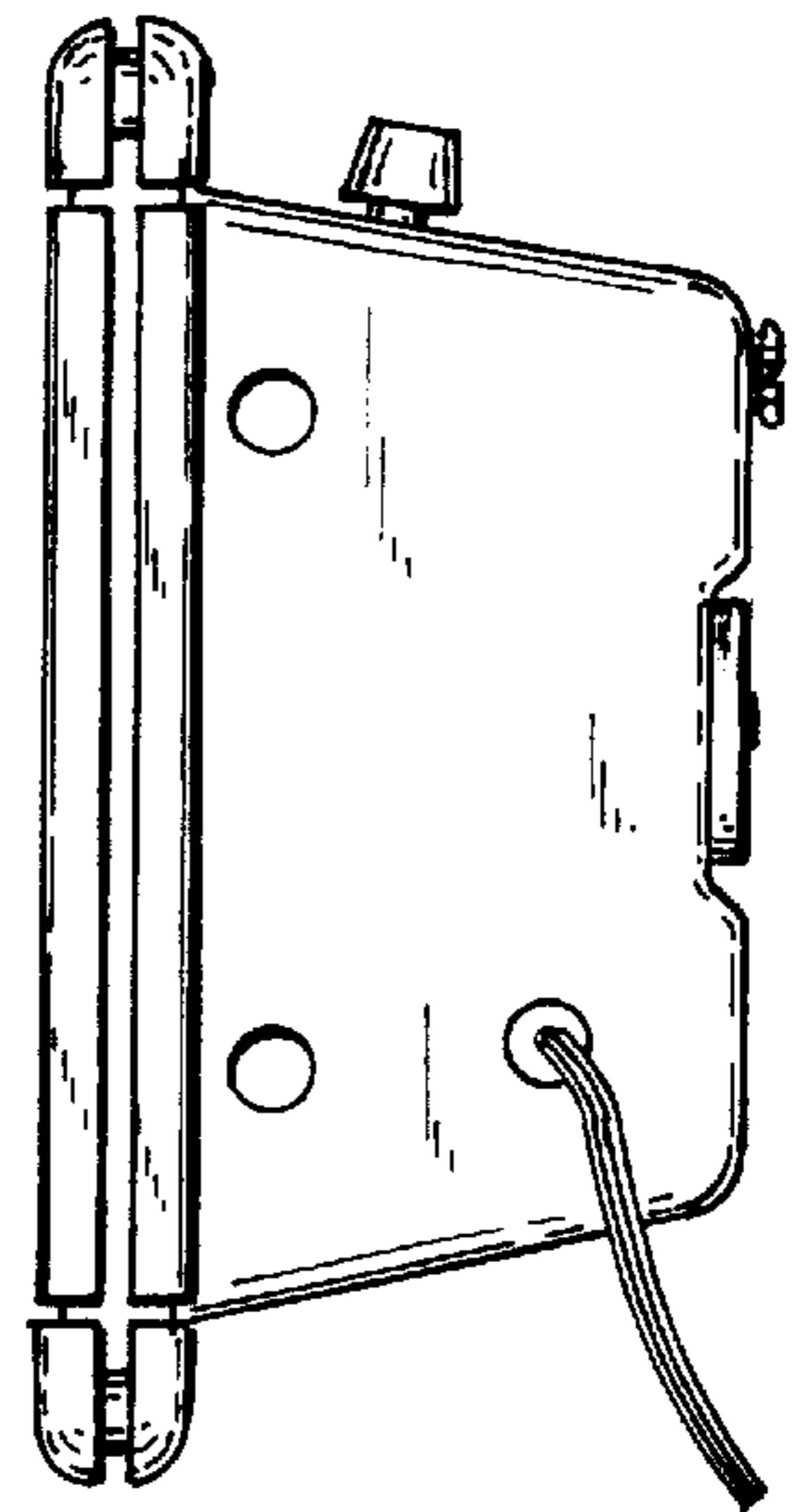

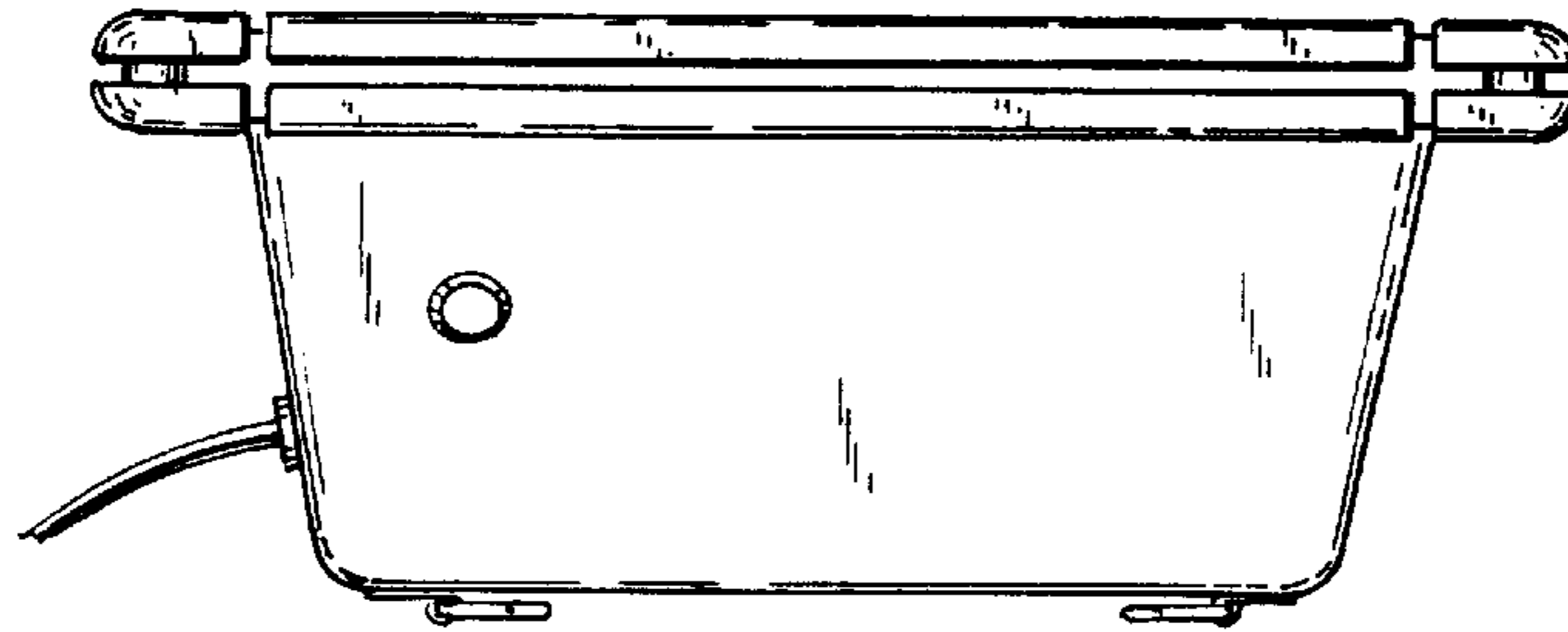

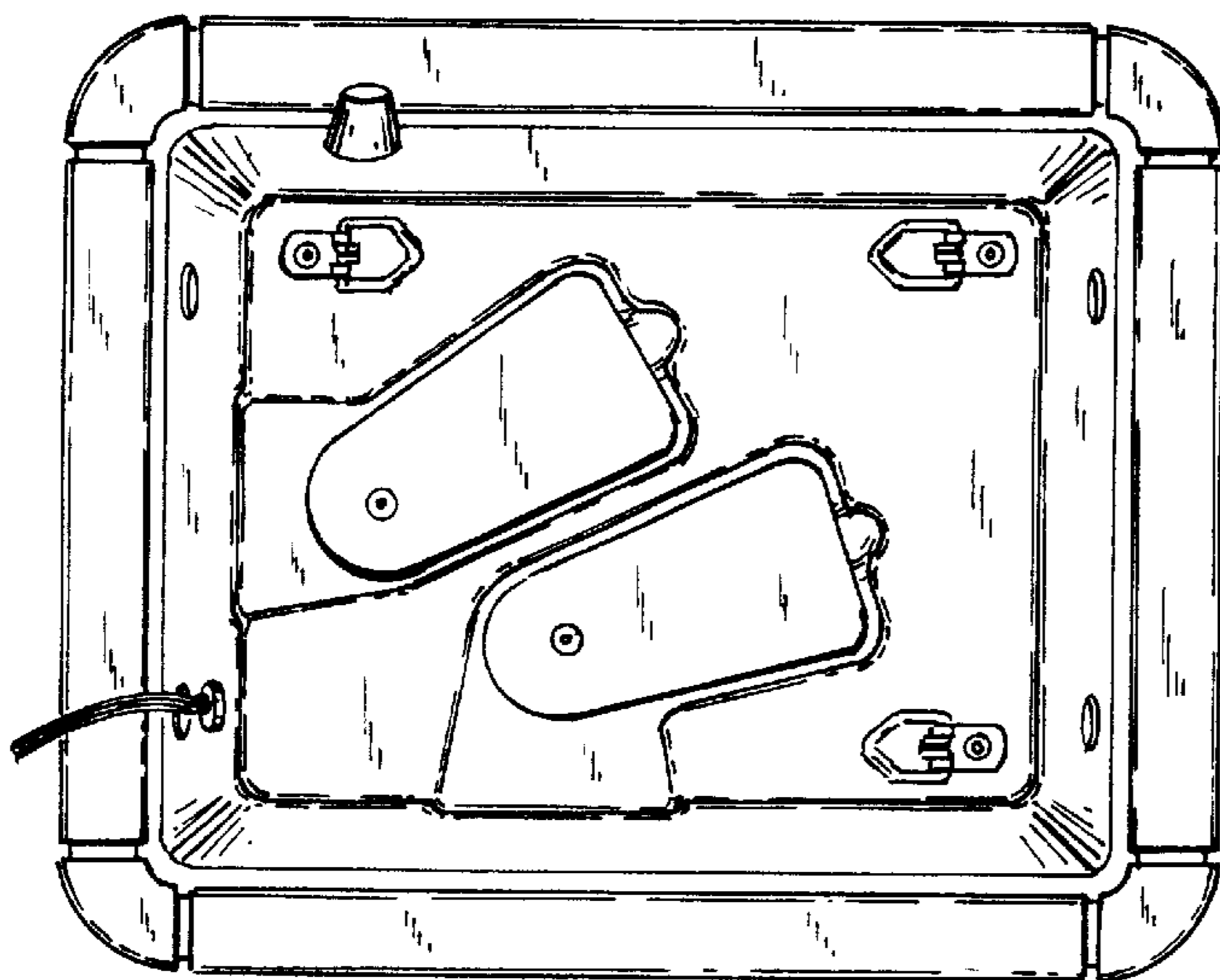

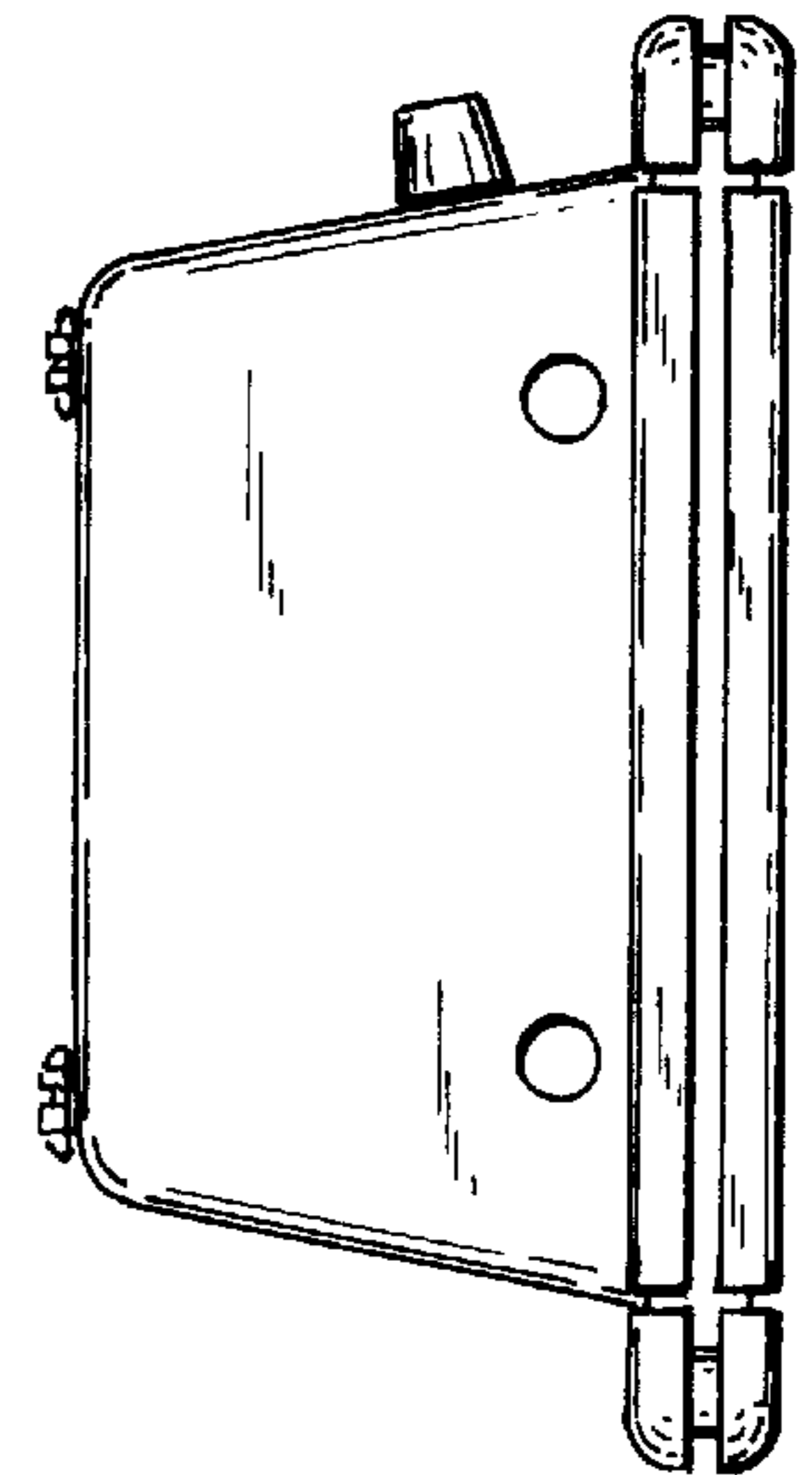

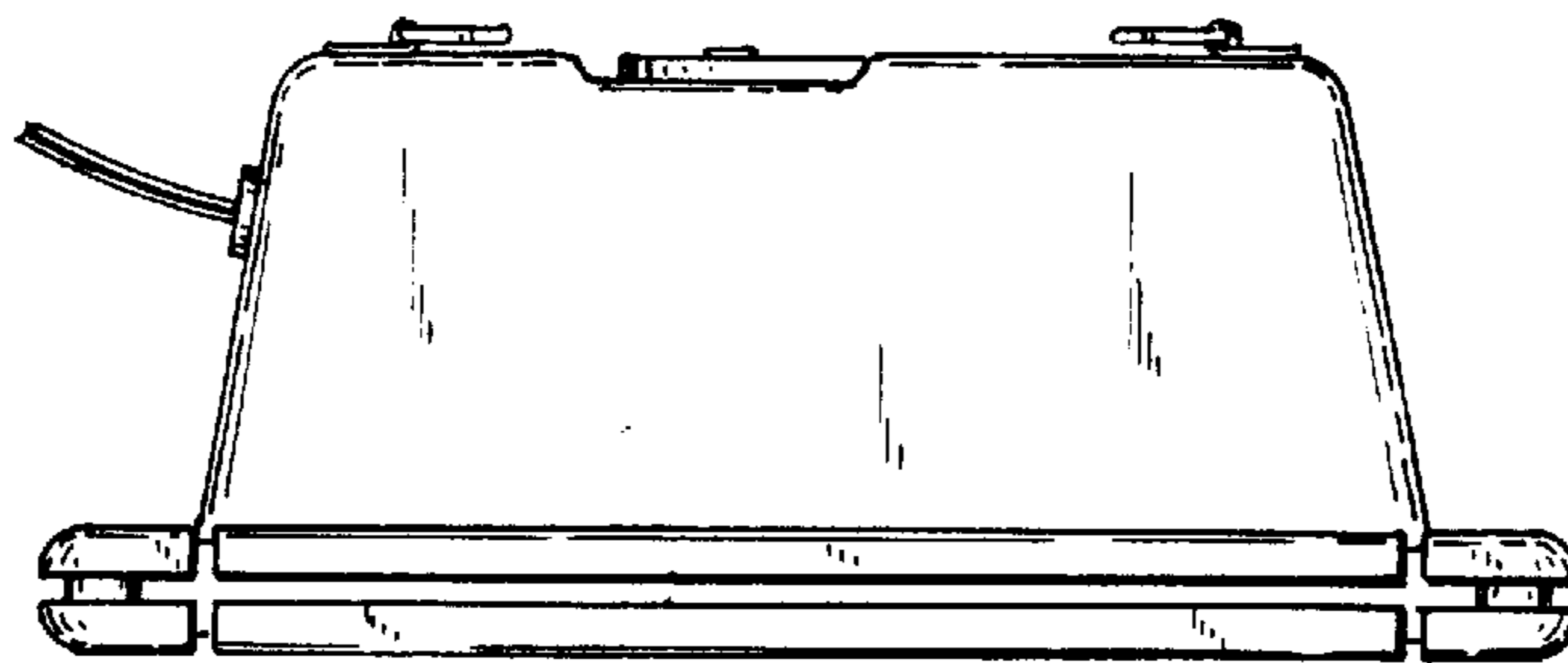

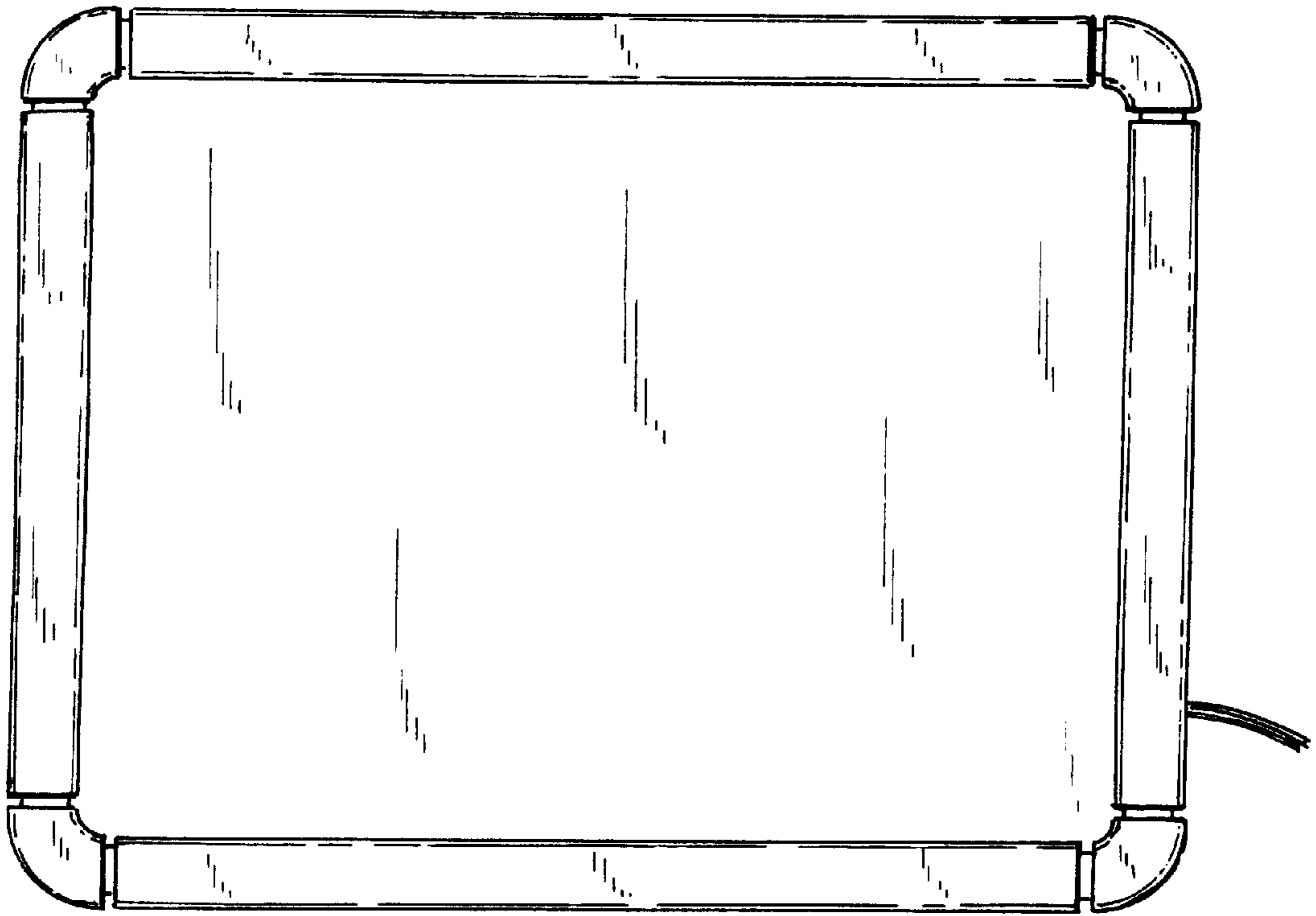

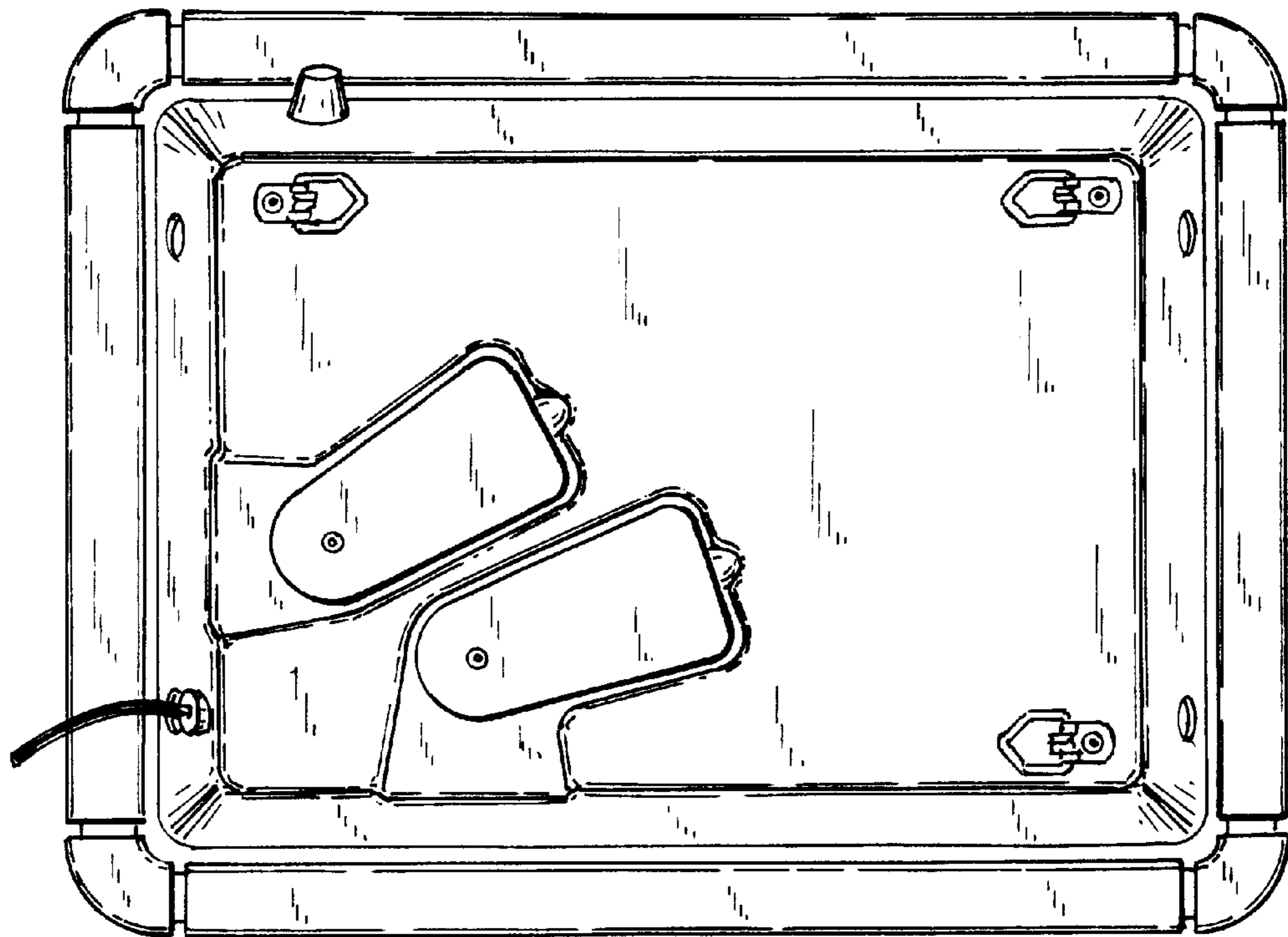

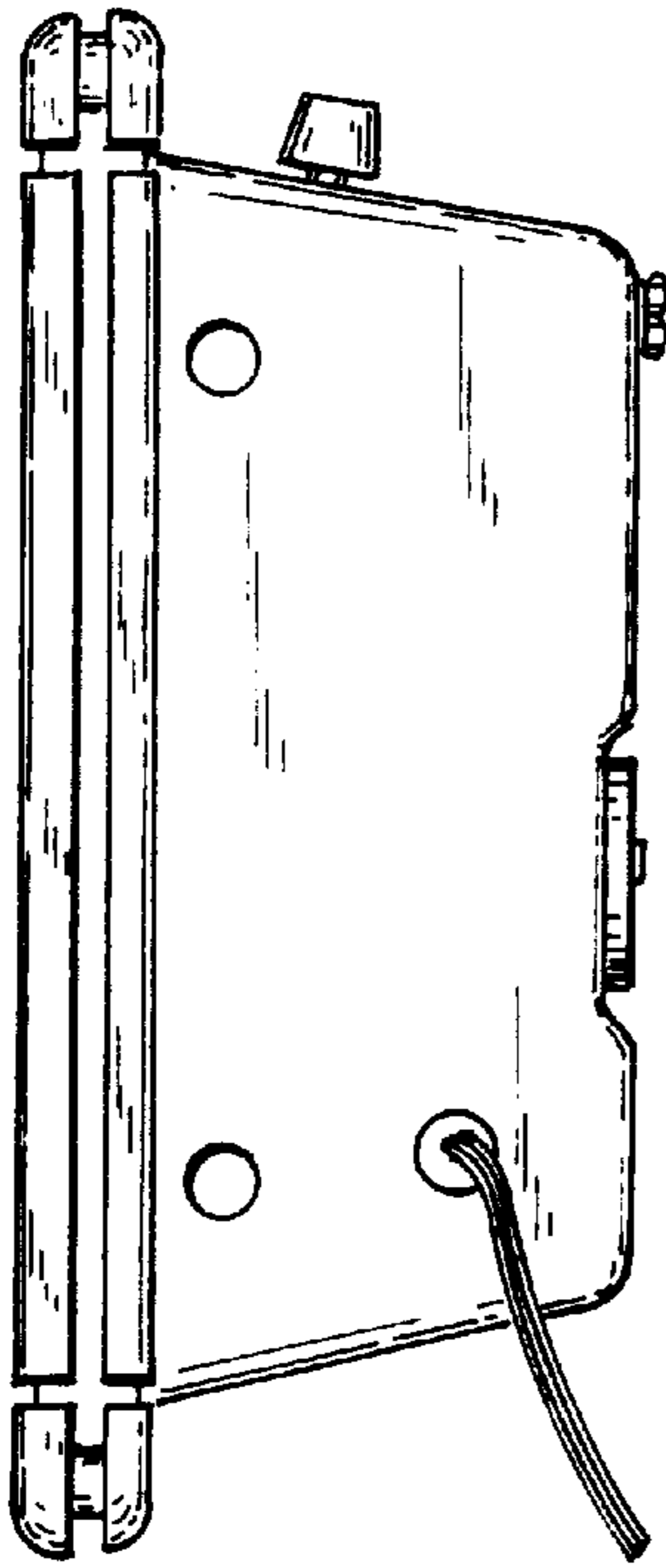

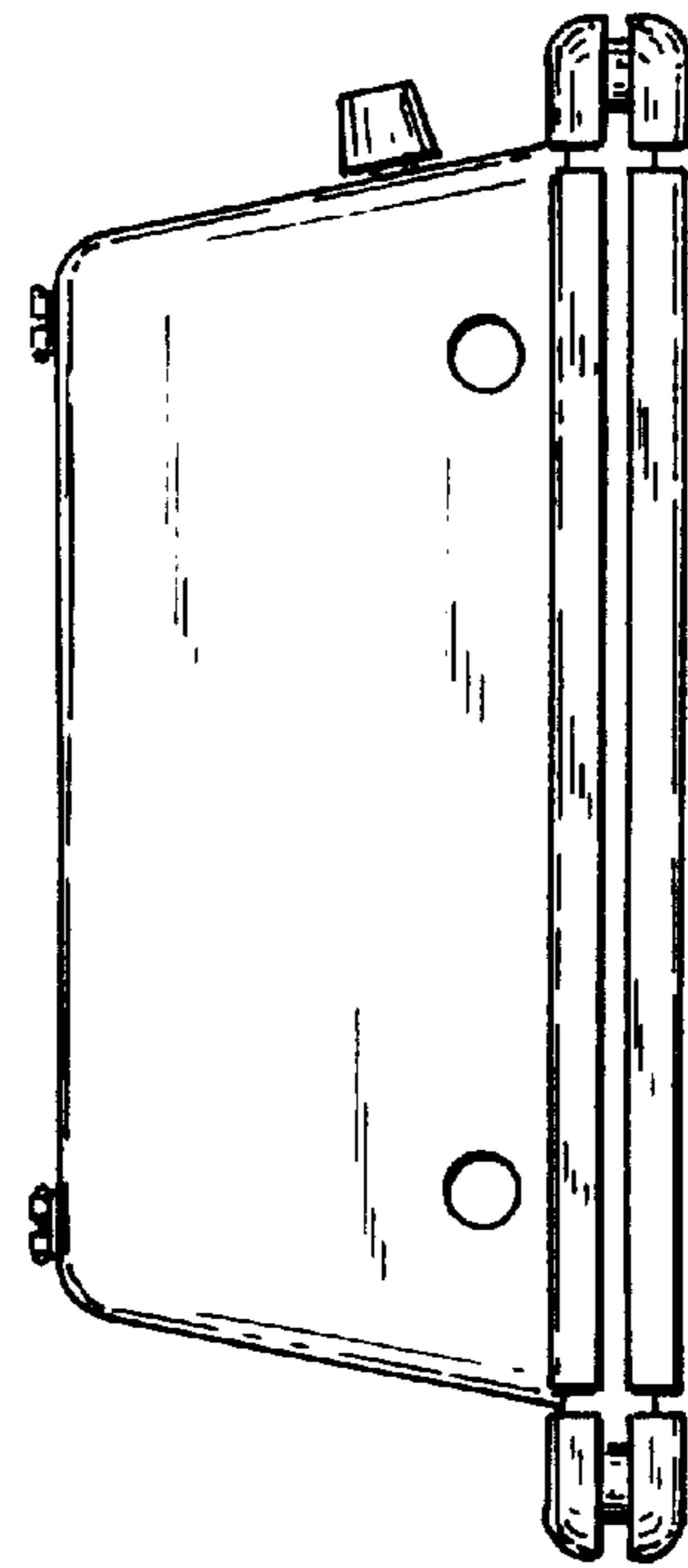

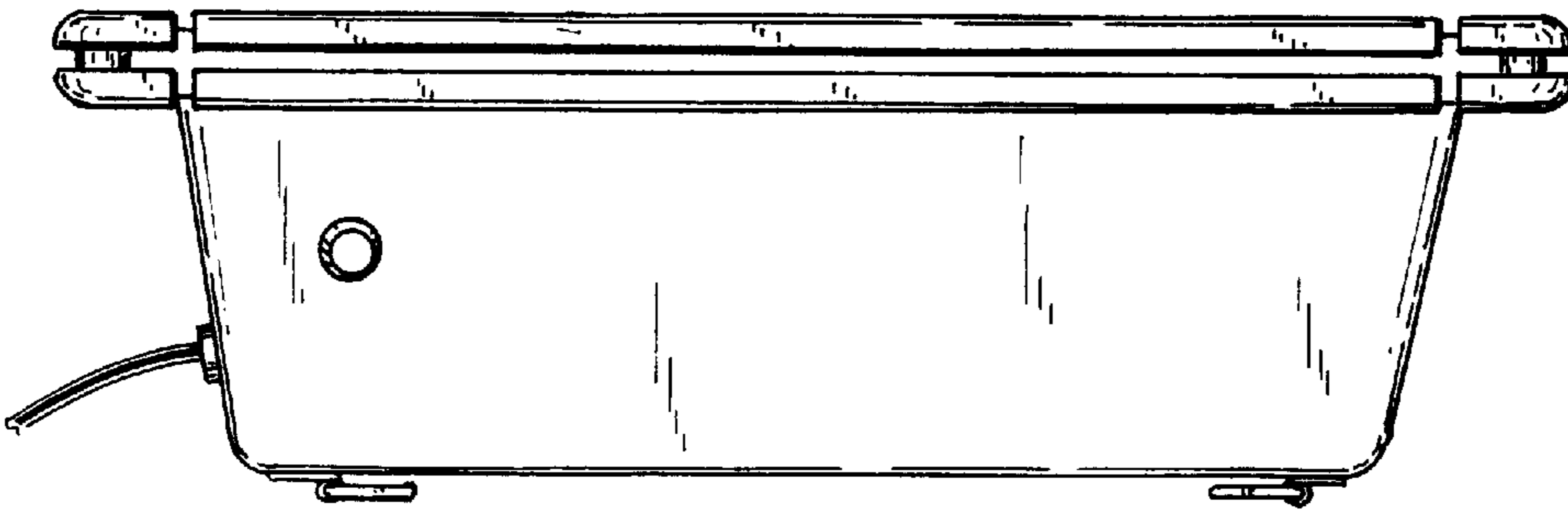

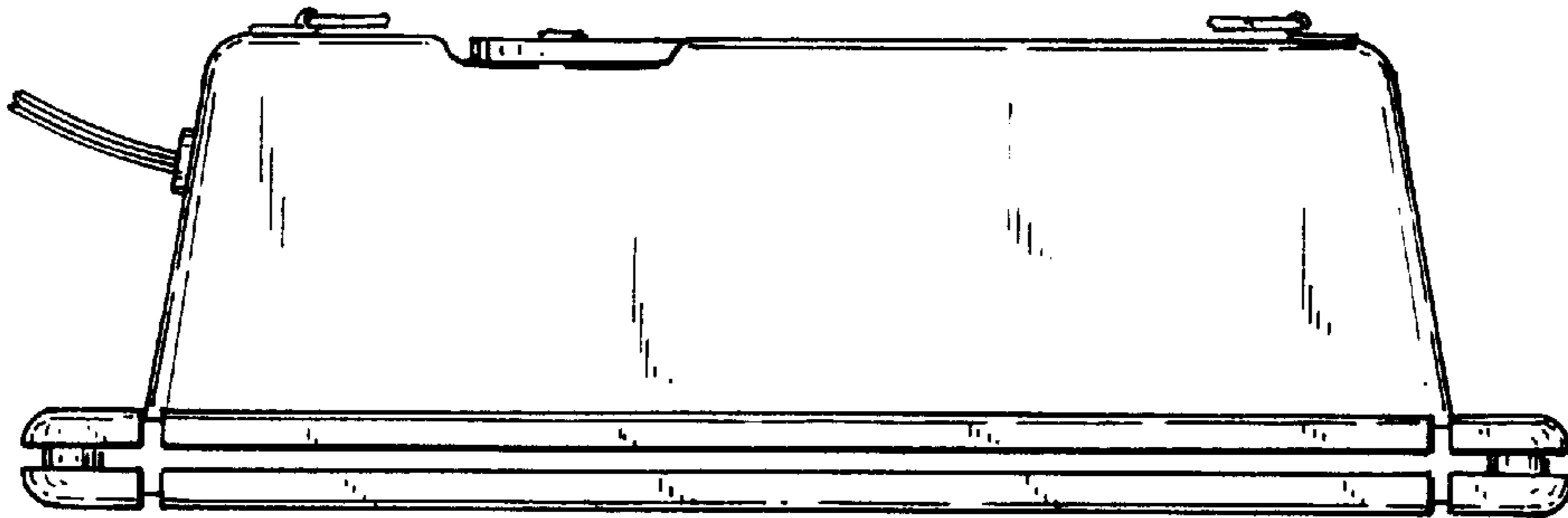
