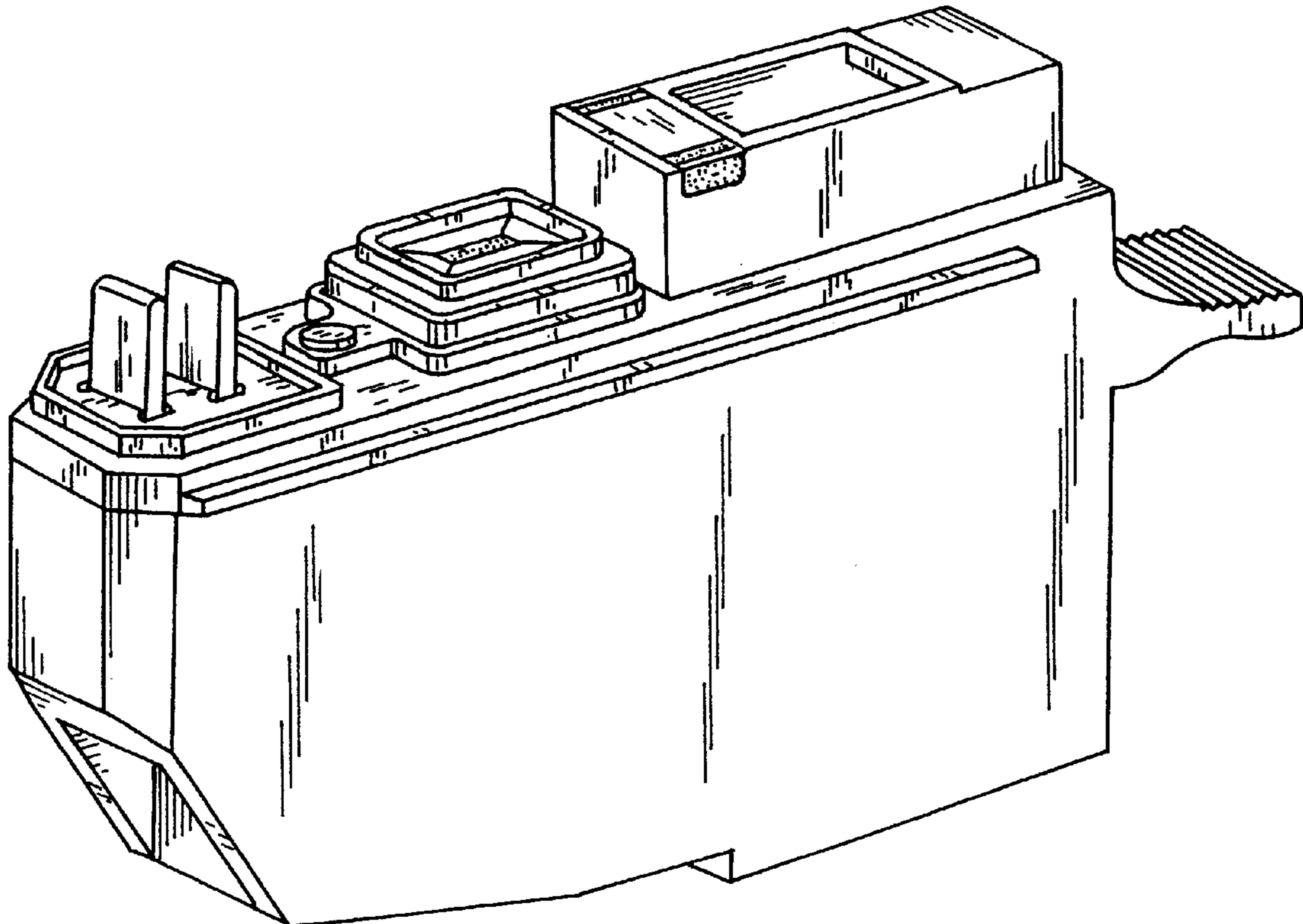

**DESCRIPTION**  
FIG. 1 is a bottom plan view of a printhead service station showing our new design;

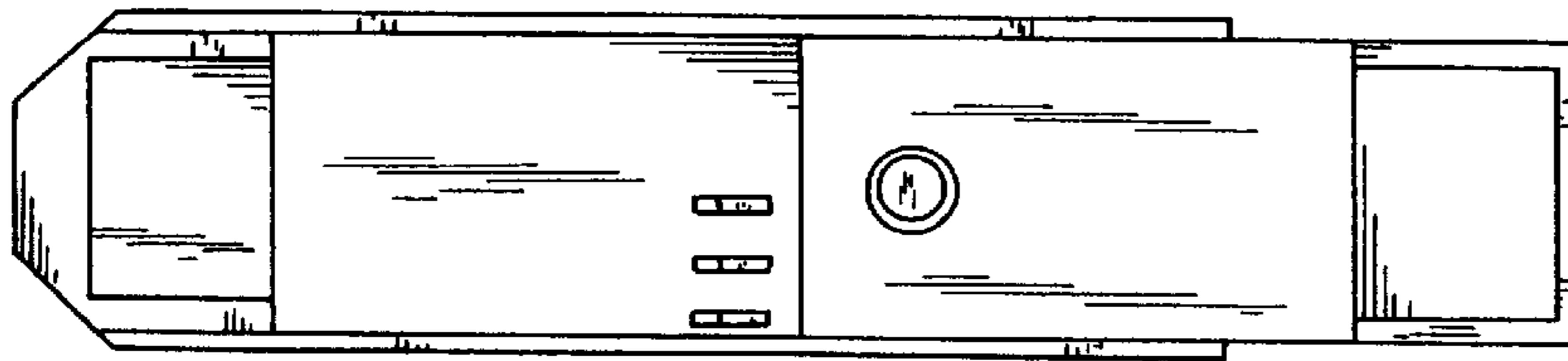

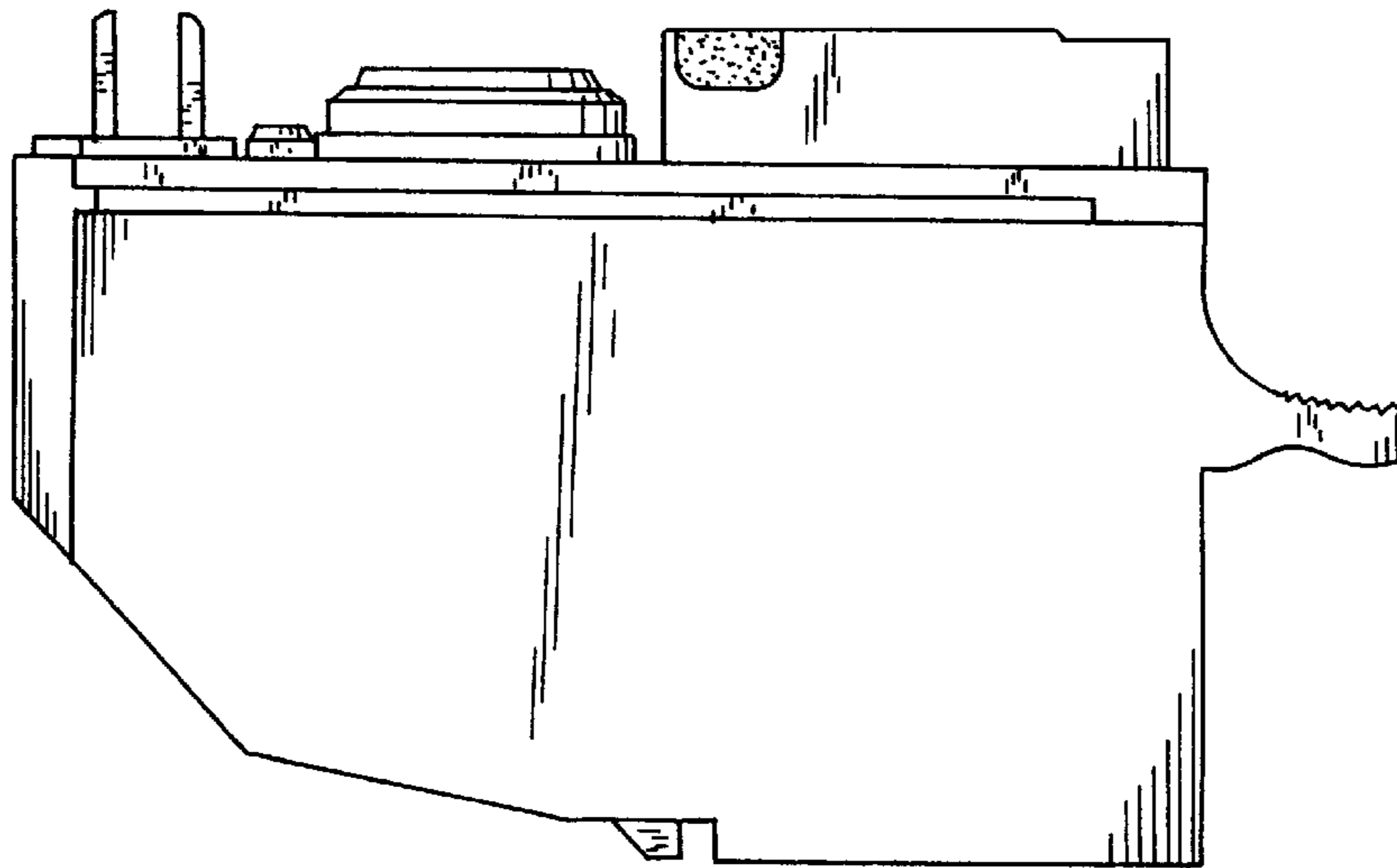

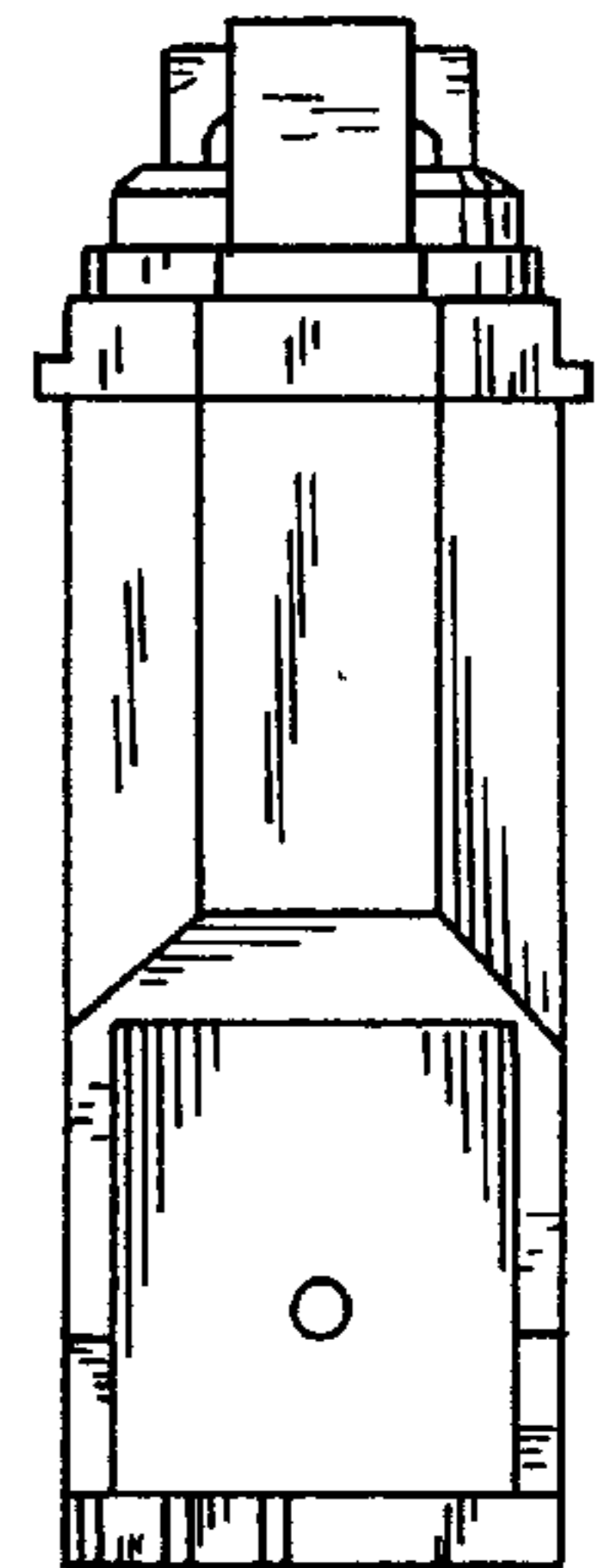

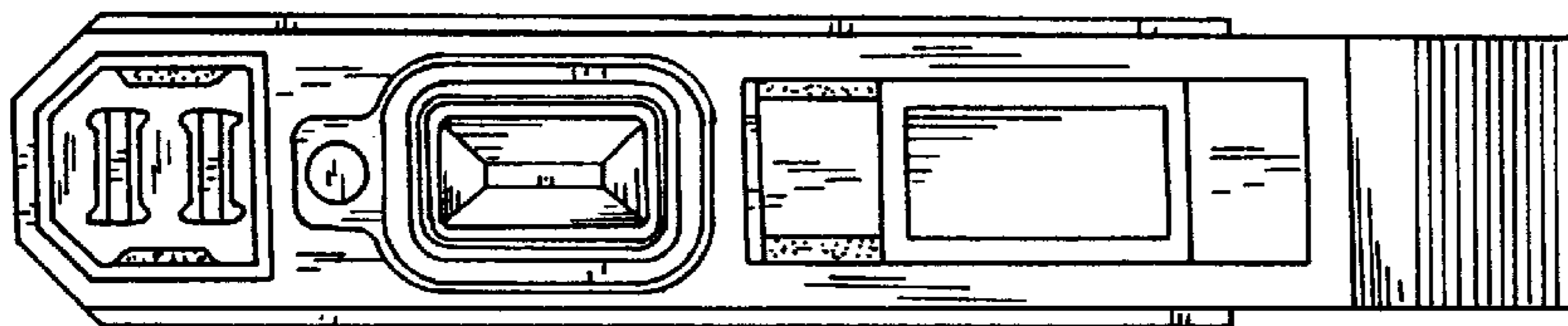

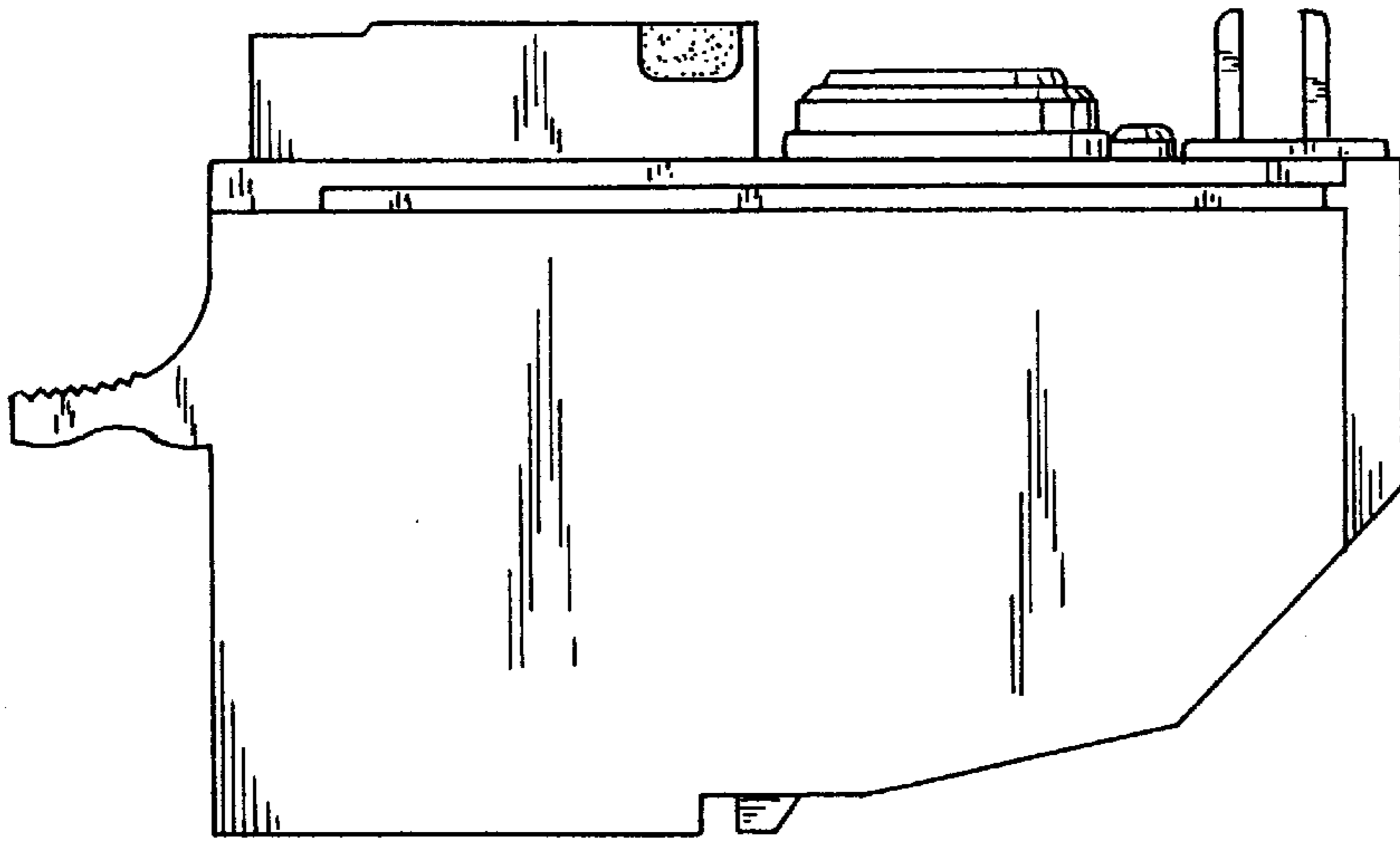

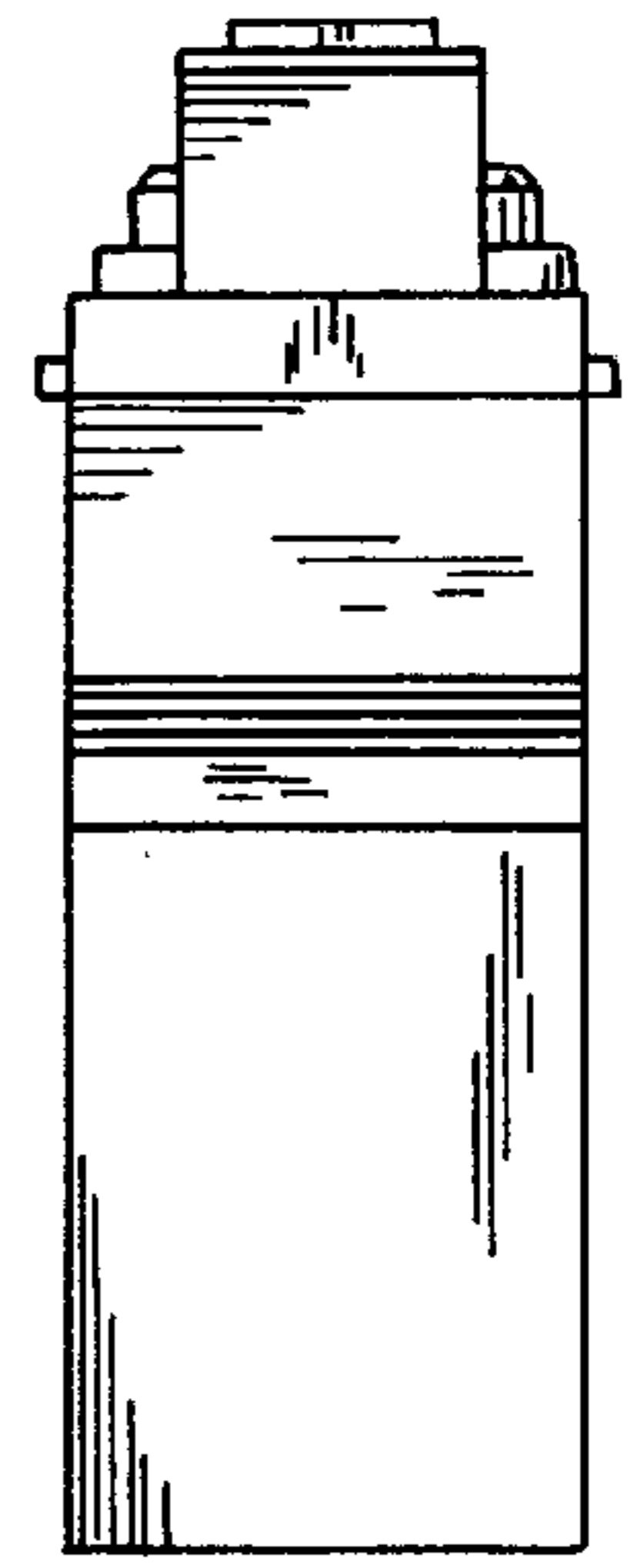

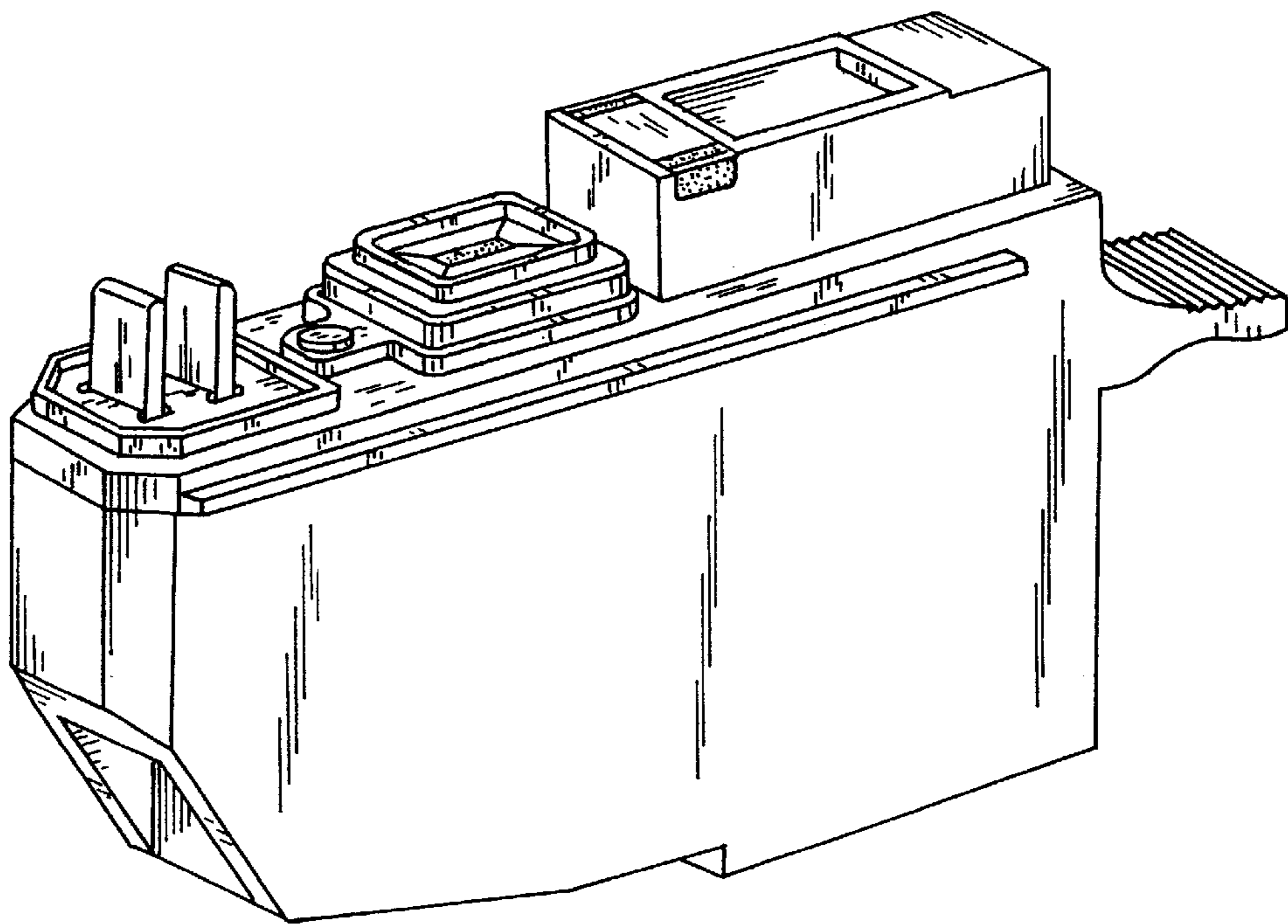
