[57] **CLAIM**

The ornamental design for a gusseted corner pocket for a binder or folio, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a gusseted corner pocket for a binder or folio, in an open position, embodying my design;

FIG. 2 is a bottom elevational view thereof;

FIG. 3 is a left elevational view thereof;

FIG. 4 represents a top perspective view taken along lines 4—4 on FIG. 1;

FIG. 5 is a front elevational view of a gusseted corner pocket for a binder or folio, in an open position, showing another embodiment of my design;

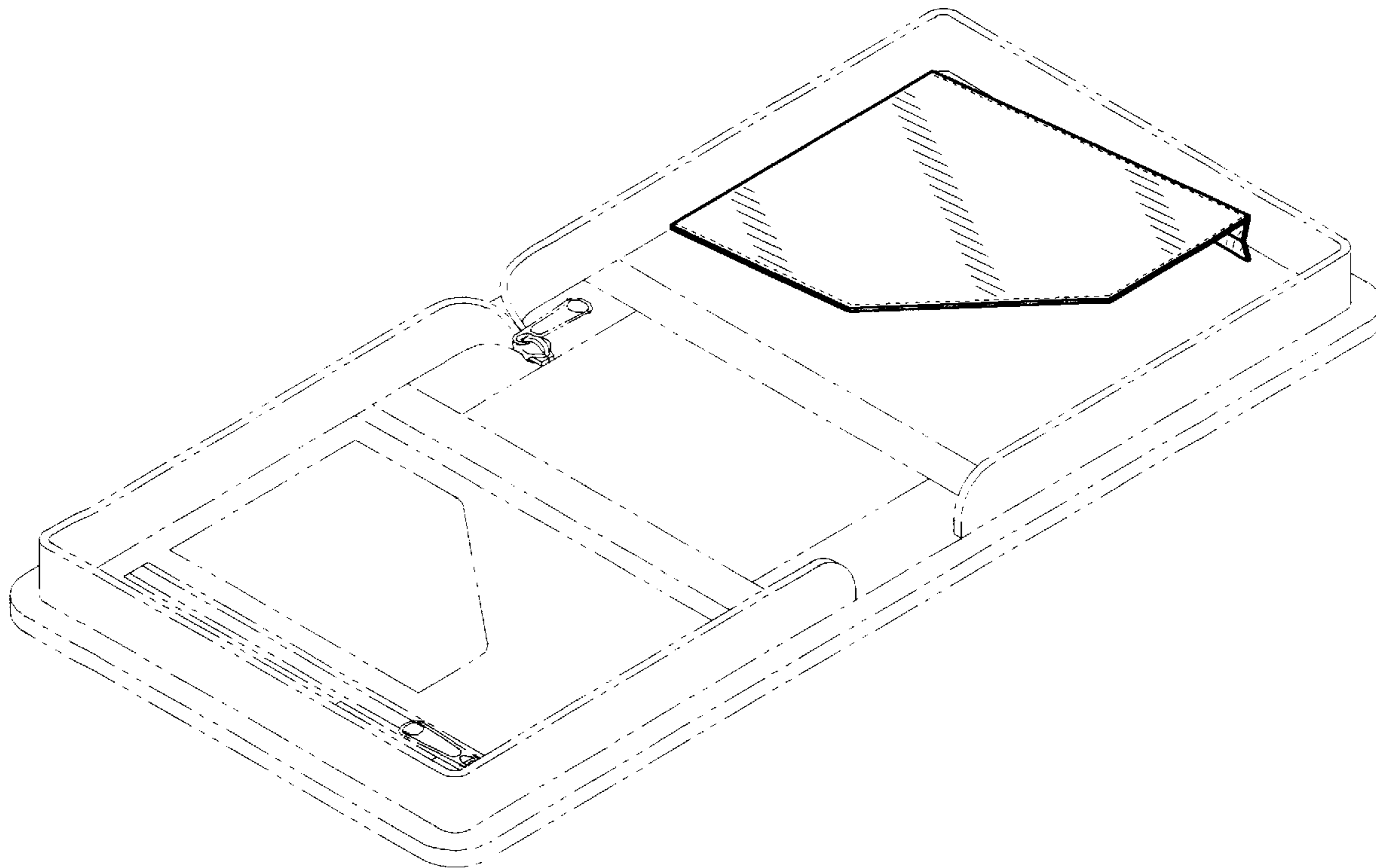
FIG. 6 is a bottom elevational view of FIG. 5;

FIG. 7 is a left elevational view of FIG. 5; and,

FIG. 8 represents a top perspective view taken along lines 8—8 on FIG. 5.

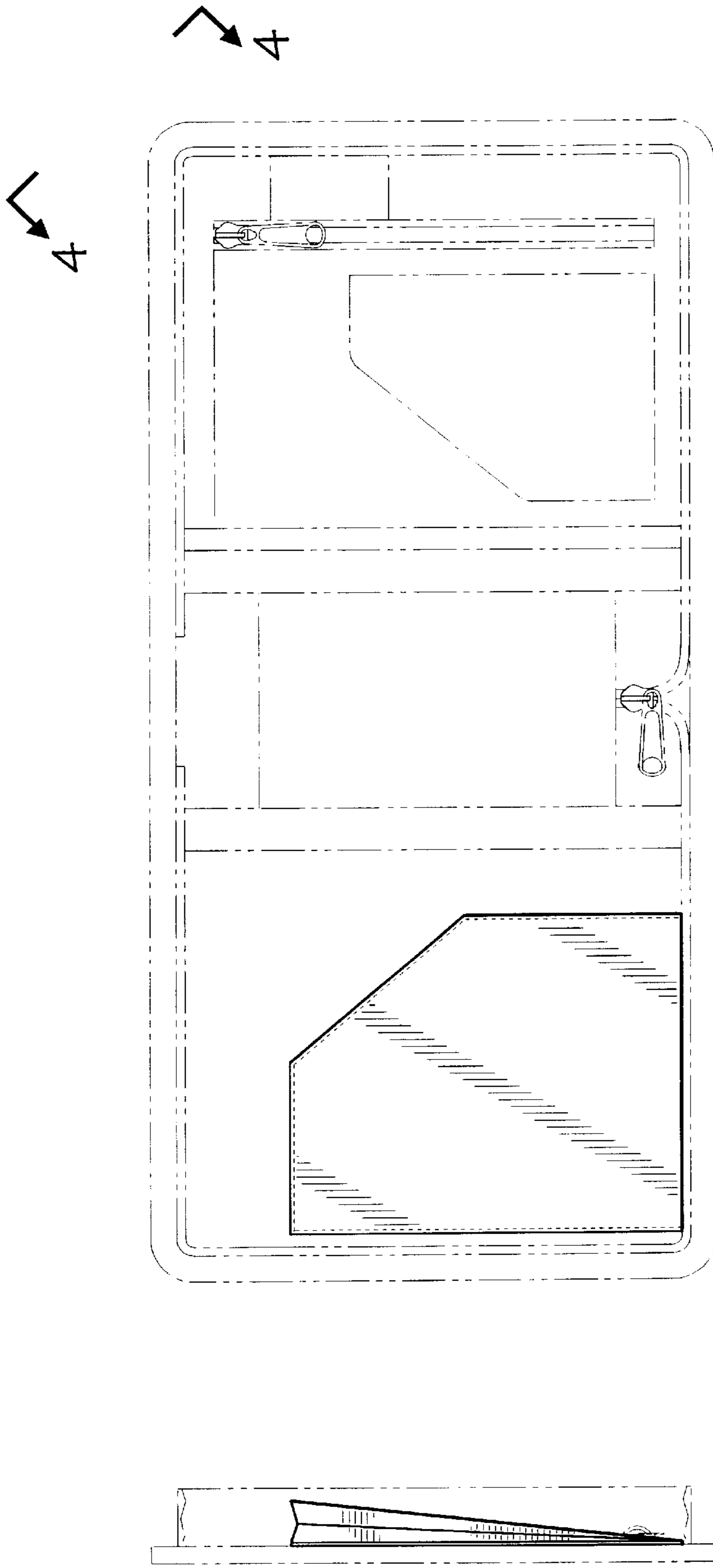

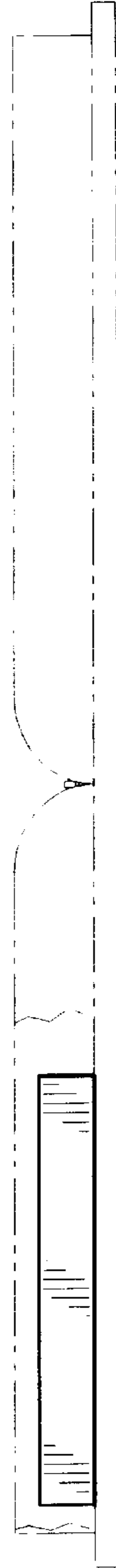

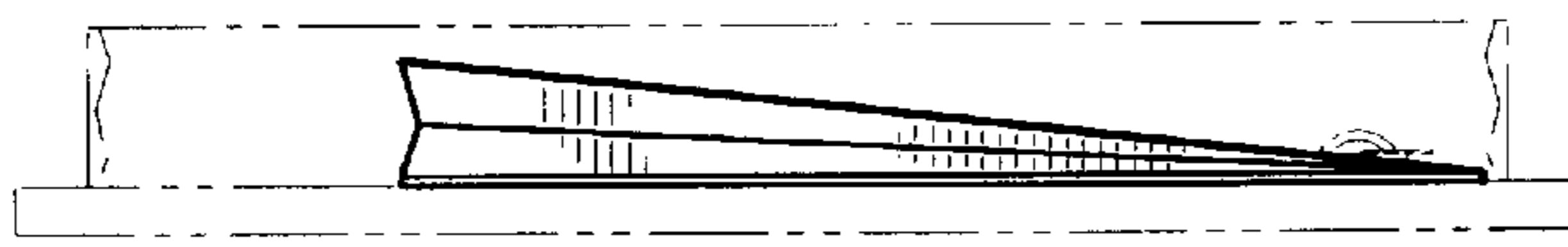

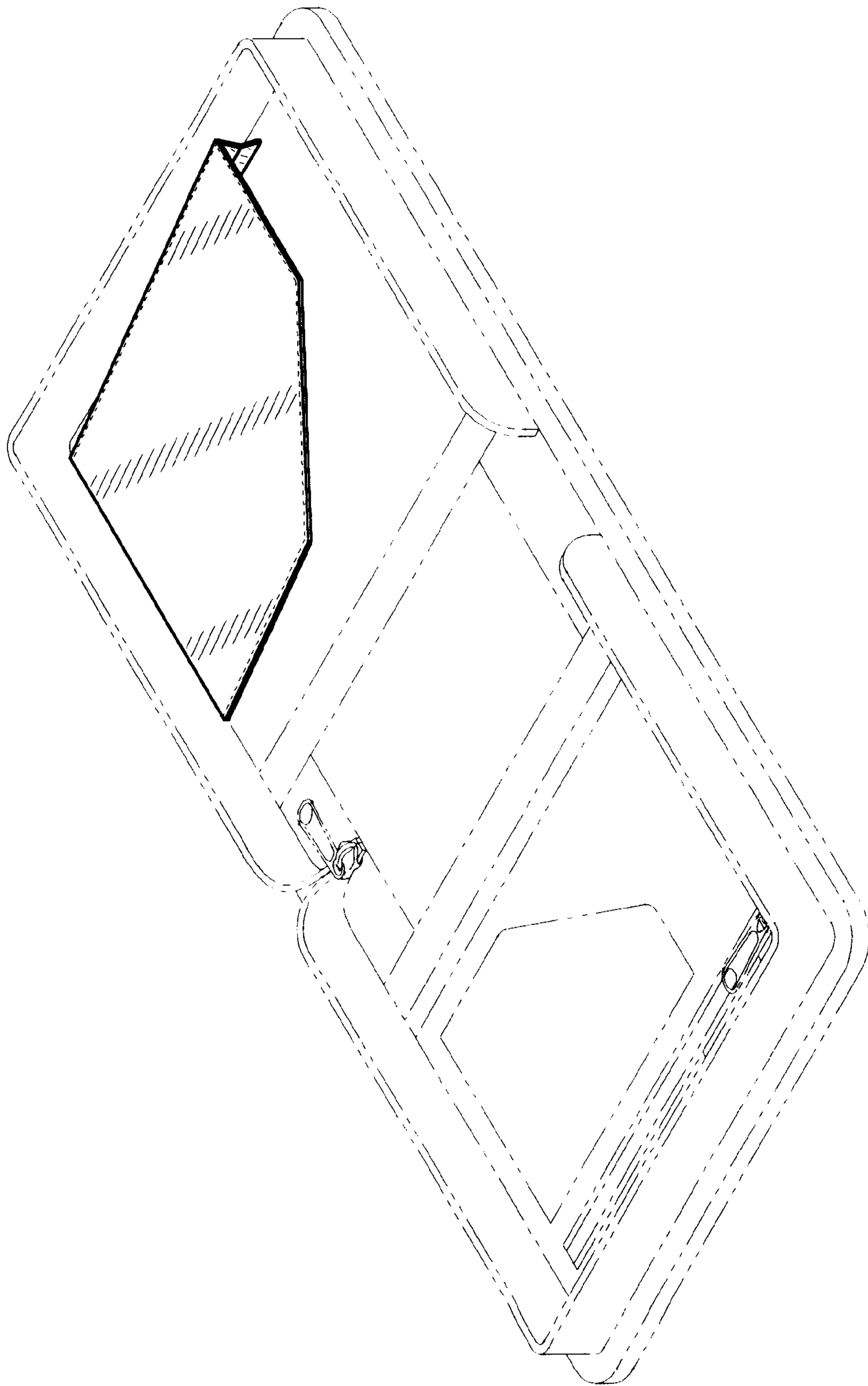

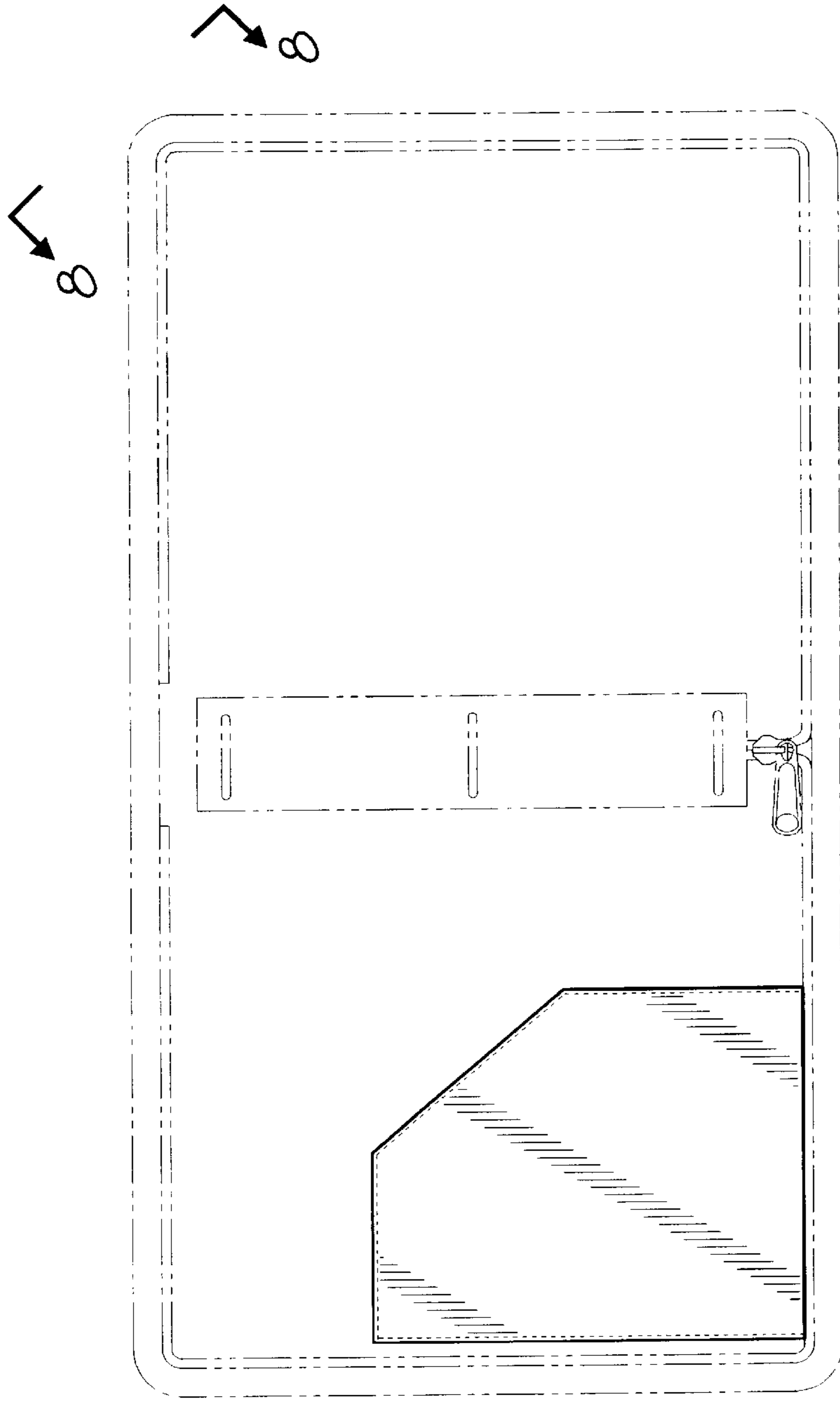

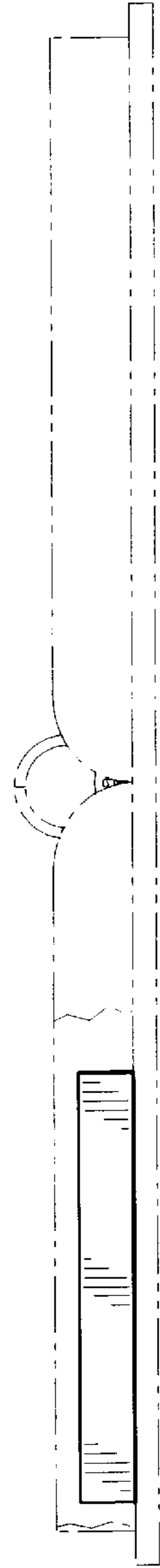

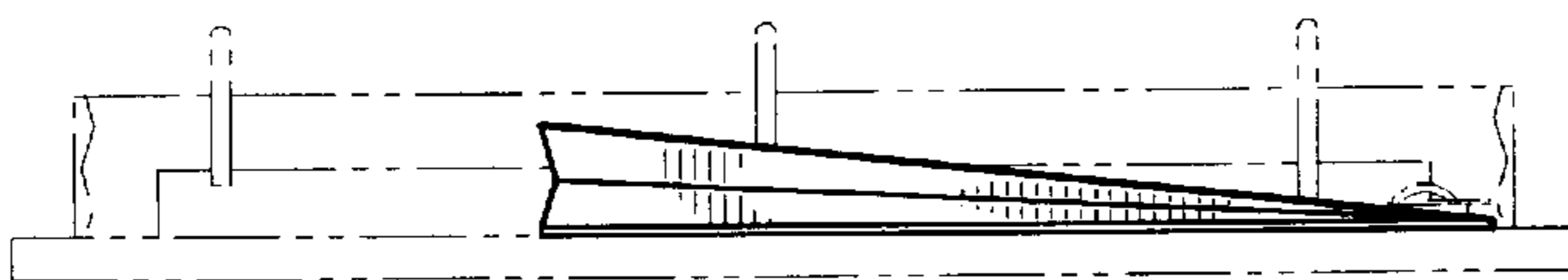

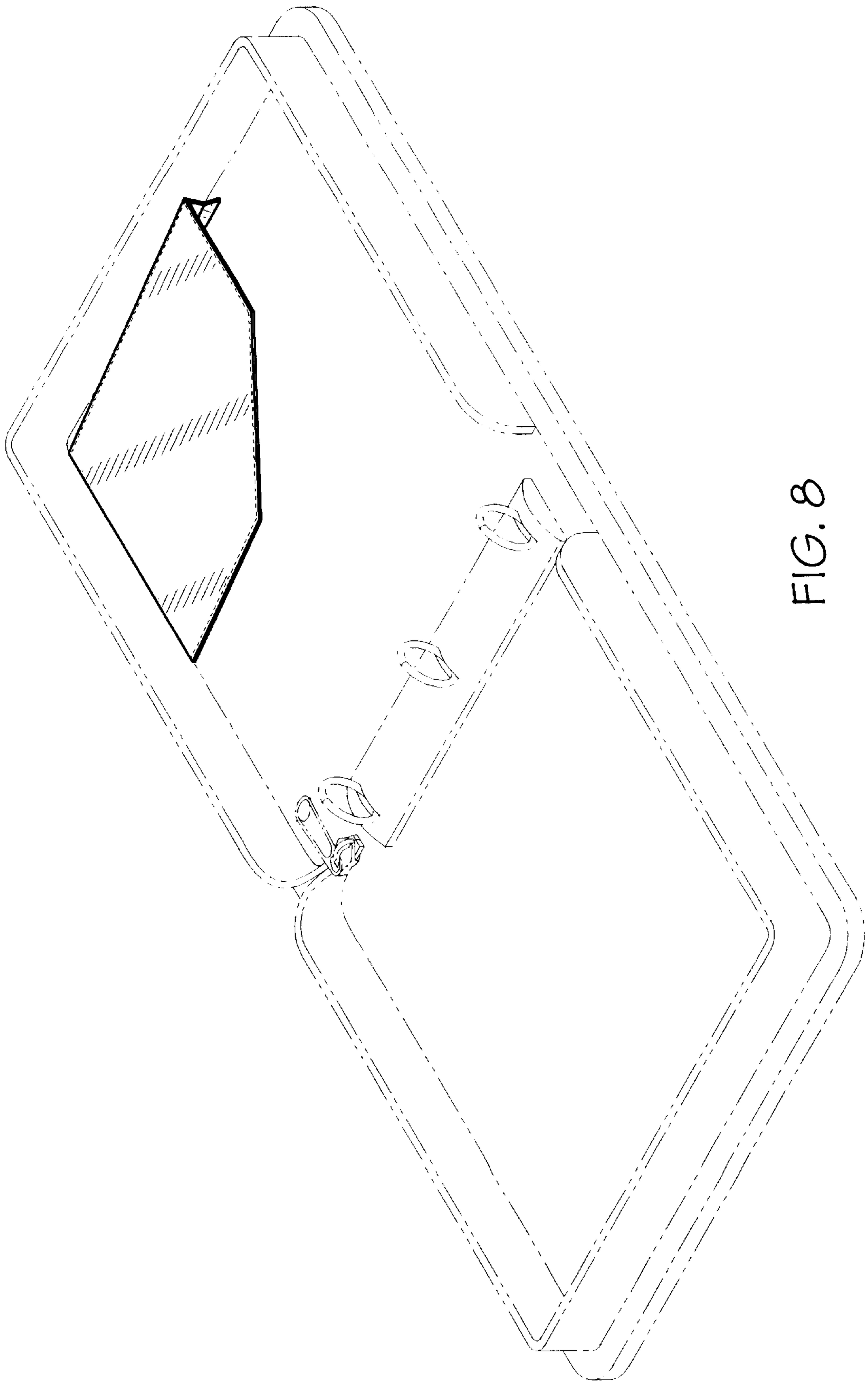
