DESCRIPTION

FIG. 1 is a perspective view of a basketball backboard cover showing the new design, the basketball hoop shown in broken lines is for illustrative purposes only and forms no part of the claimed design.

FIG. 2 is a top plan view thereof;

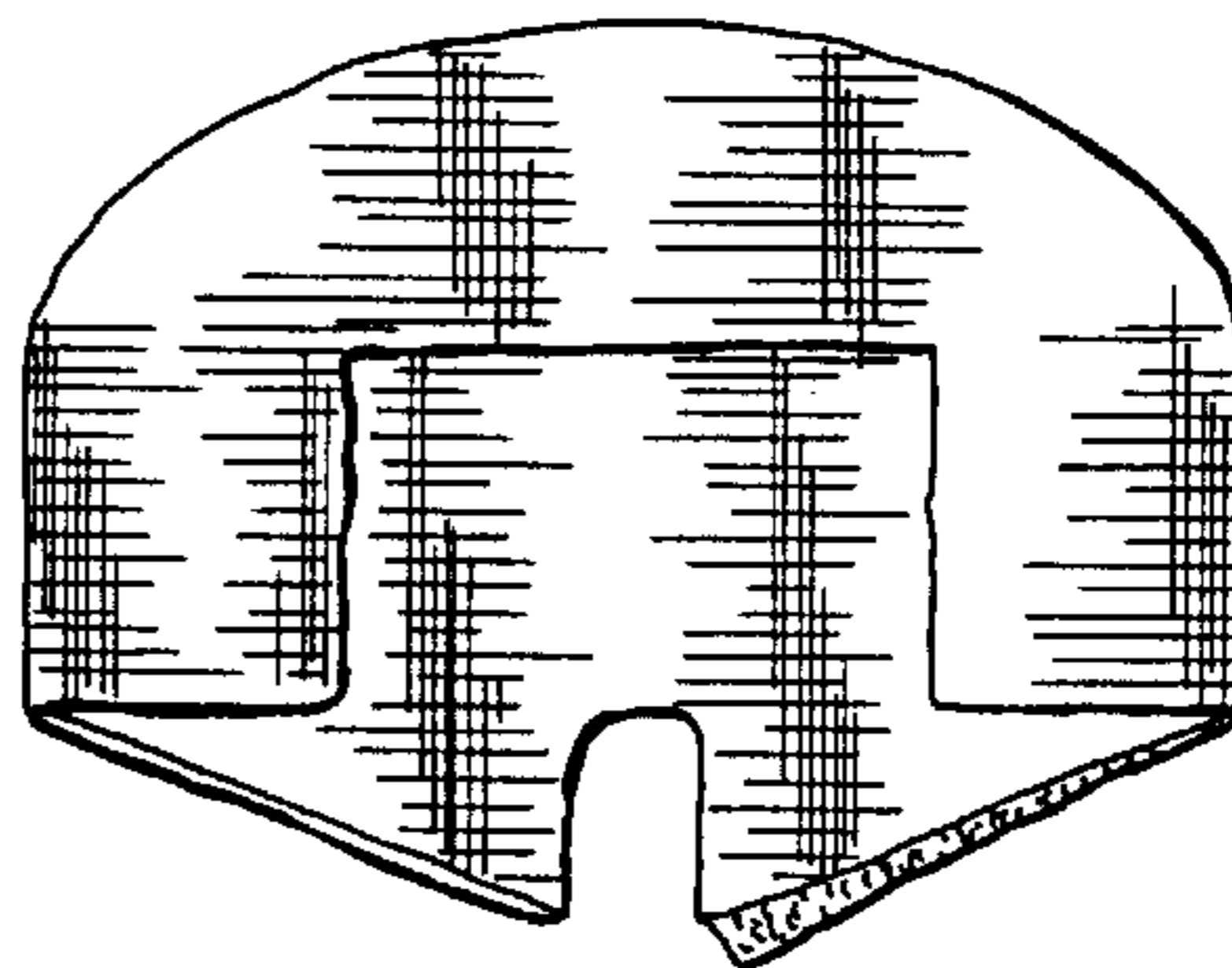
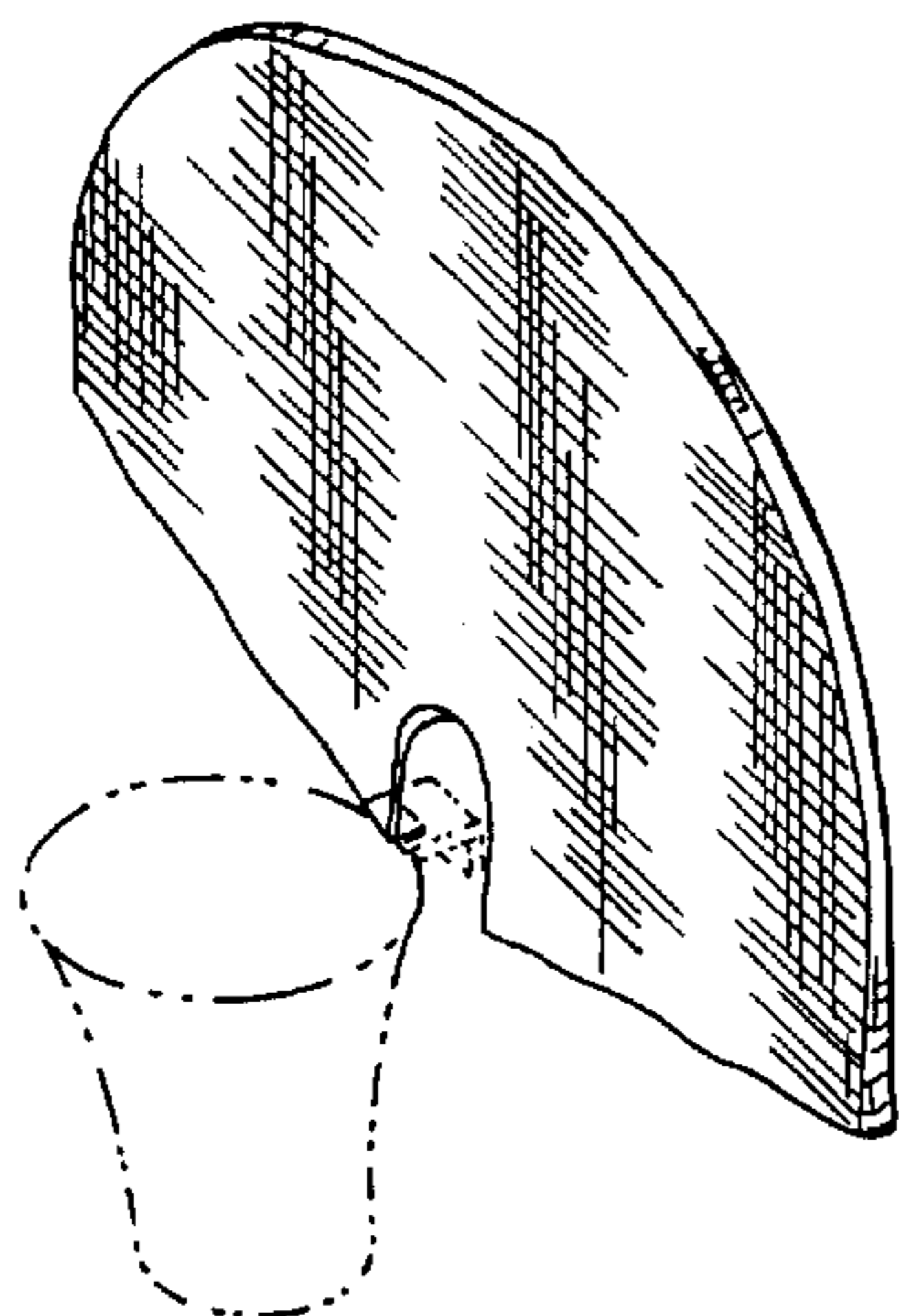
FIG. 3 is a bottom plan view thereof, with the rear, left, bottom in an alternate position;

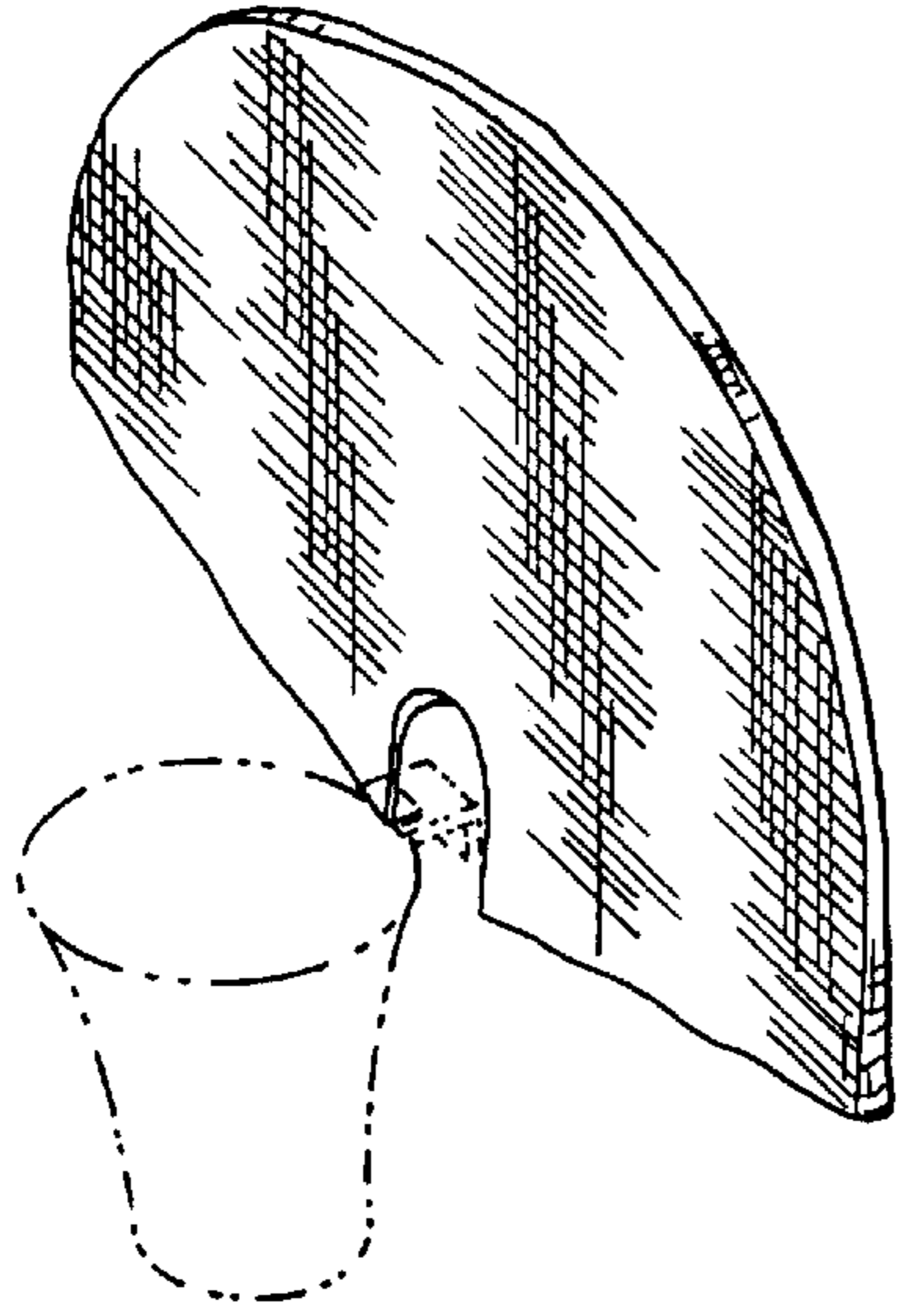

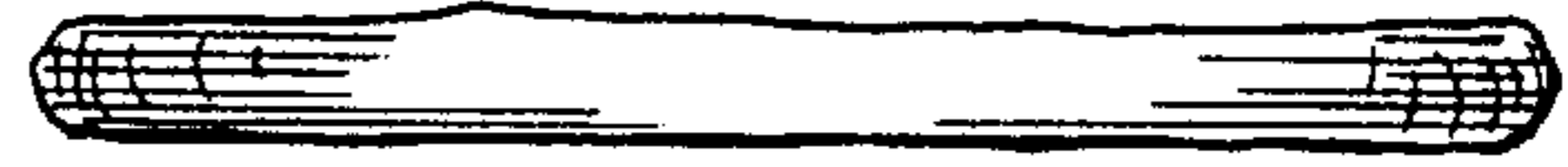

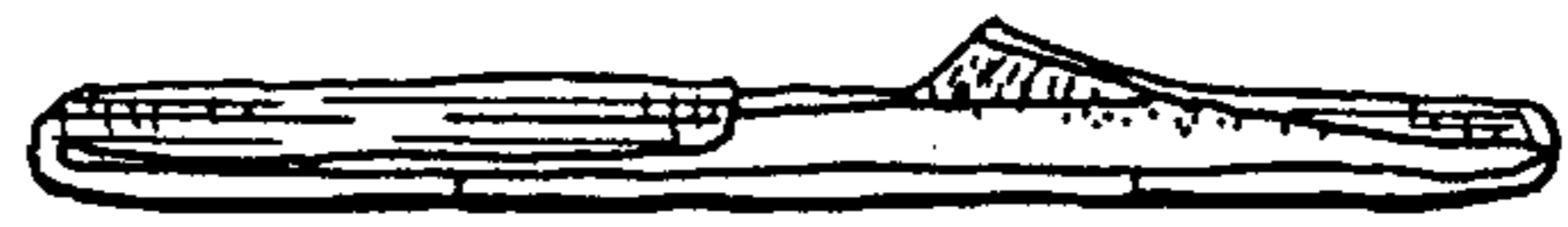

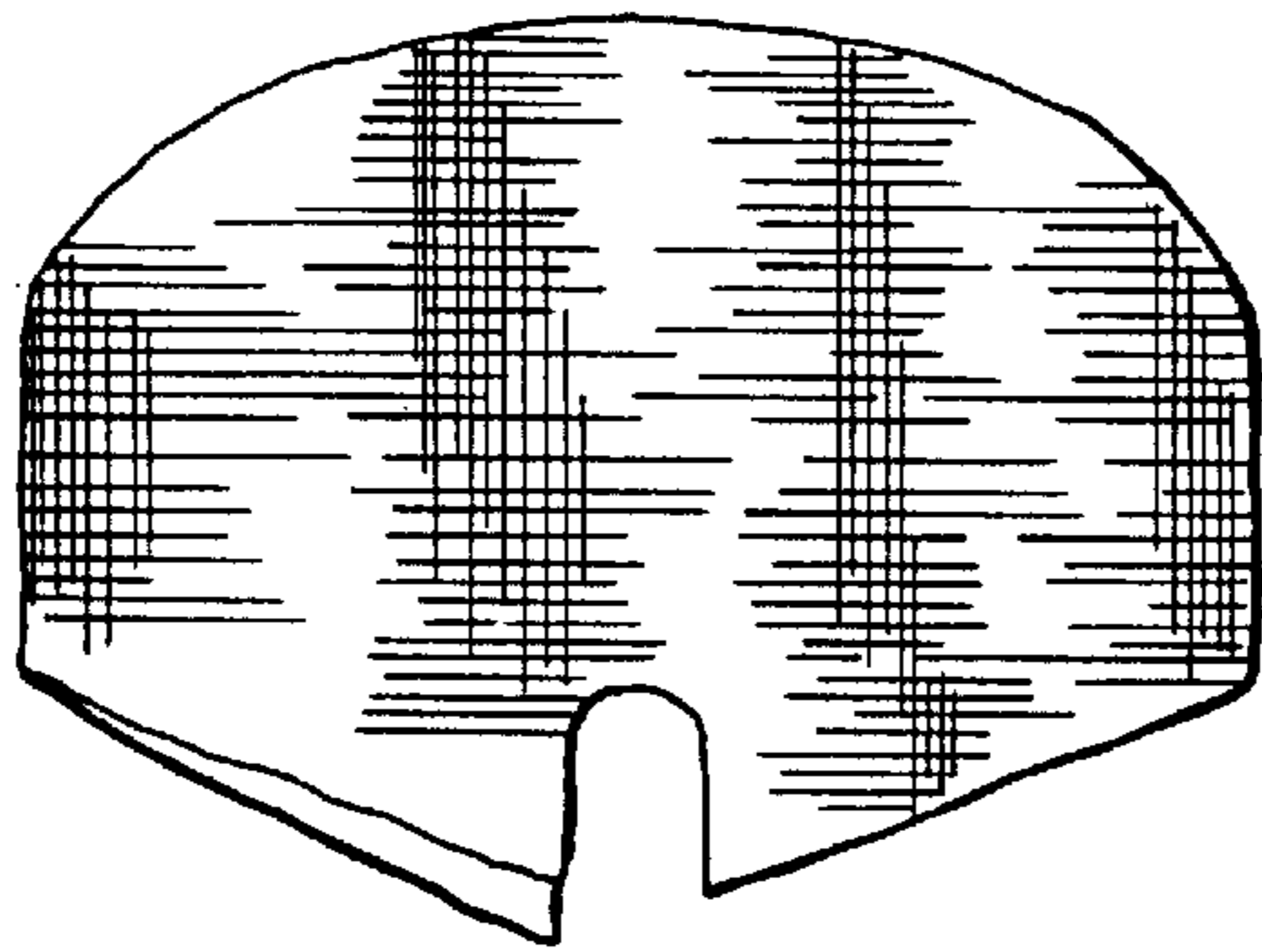

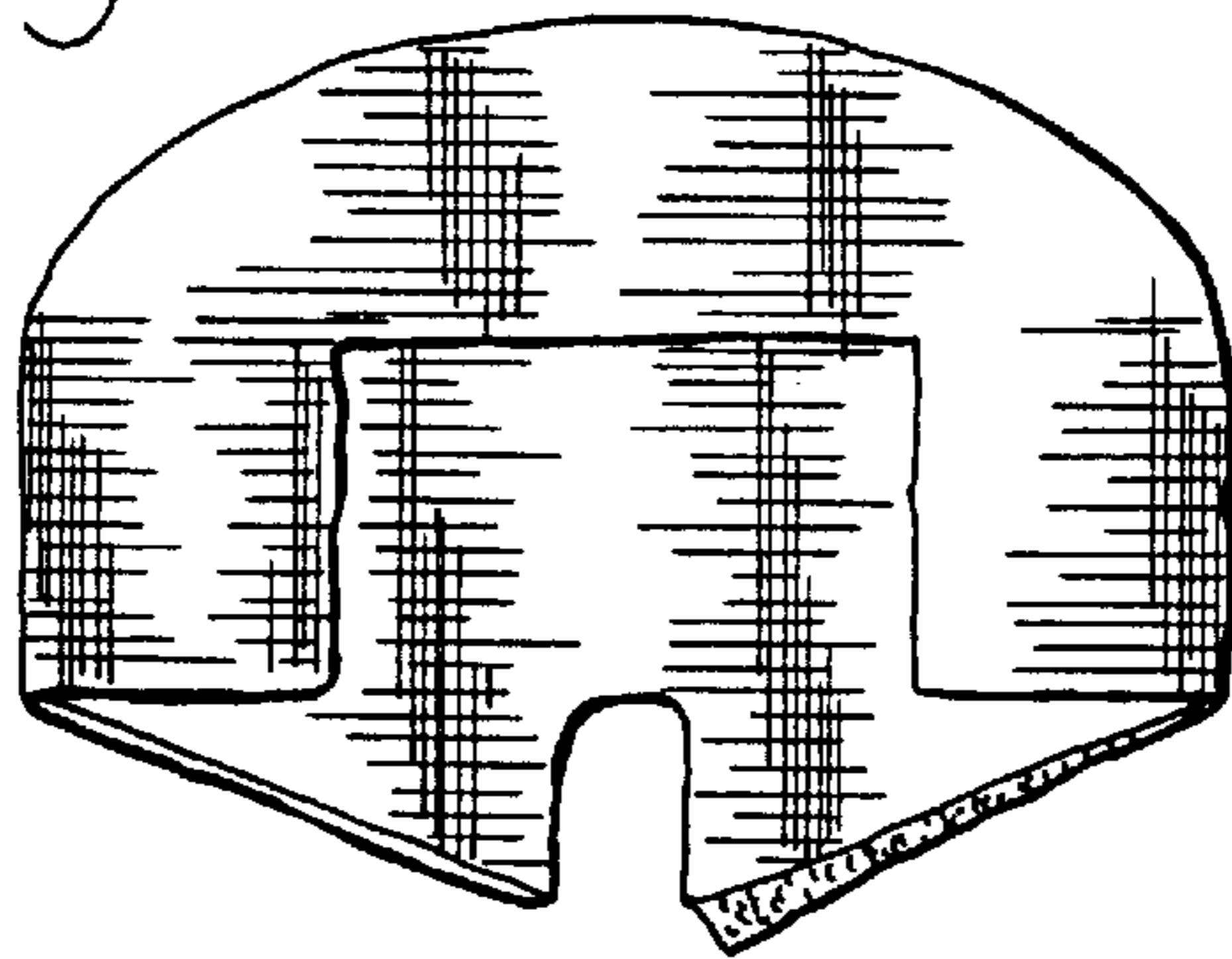
