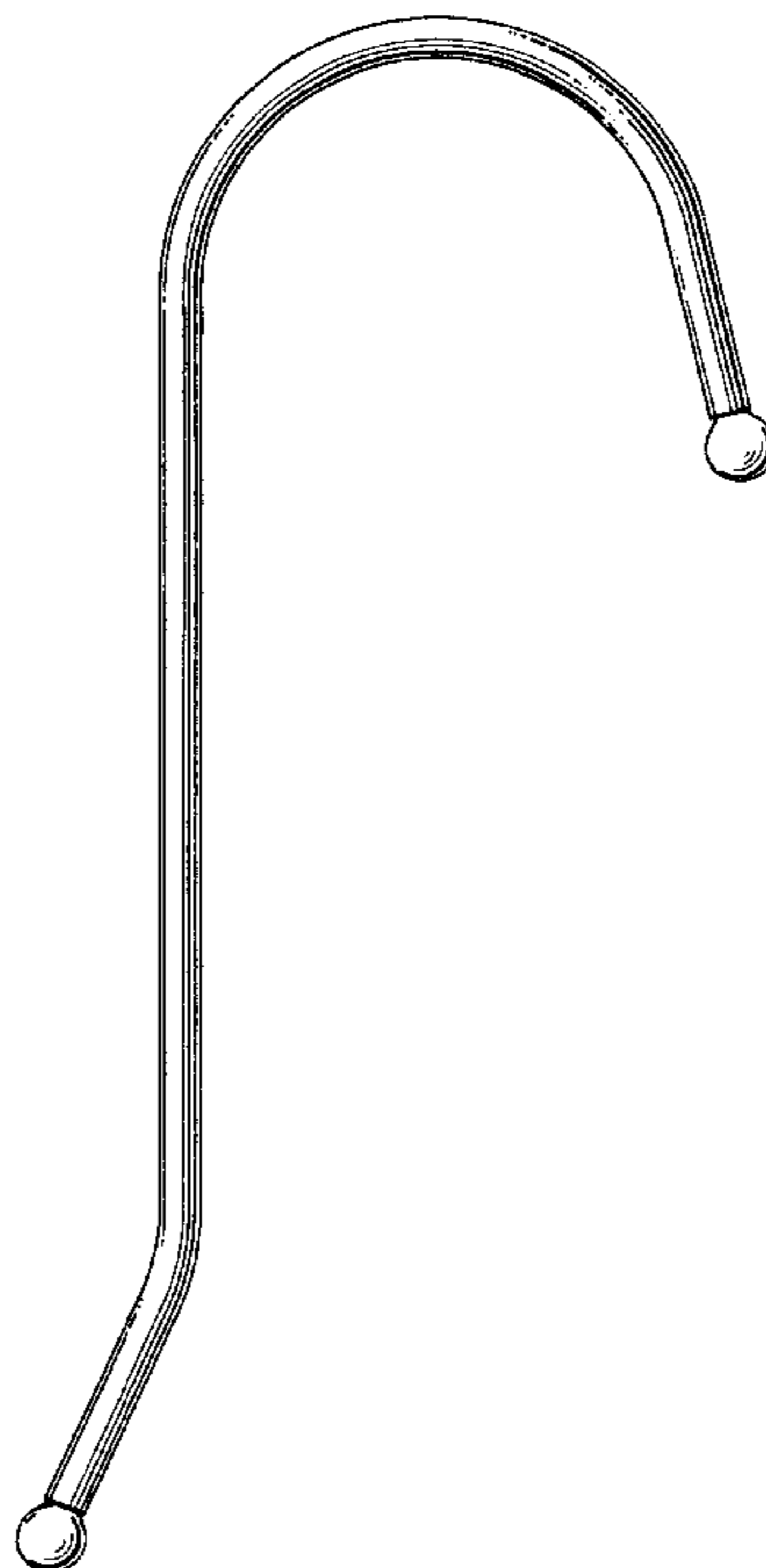
[57] **CLAIM**

The ornamental design for a combined acupressure and massage device, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevation of a first embodiment of a combined acupressure and massage device of this invention; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a right side elevation view thereof; FIG. 5 is a rear view thereof; FIG. 6 is a front view thereof; FIG. 7 is a left side elevation of a second embodiment of the acupressure and massage device of this invention; FIG. 8 is a top plan view thereof; FIG. 9 is a bottom plan view thereof; FIG. 10 is a right side elevation view thereof; FIG. 11 is a rear view thereof; and, FIG. 12 is a front view thereof.

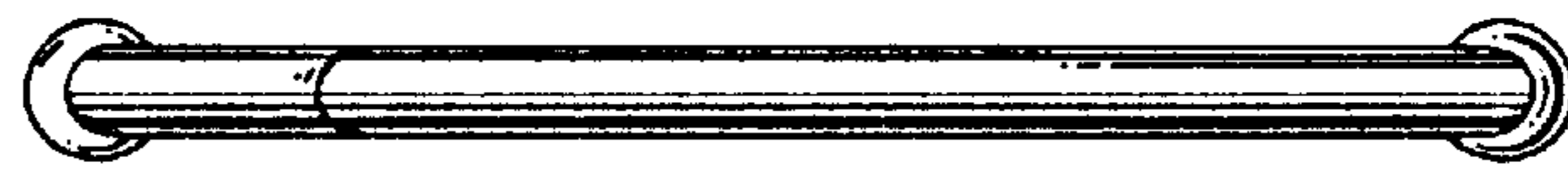

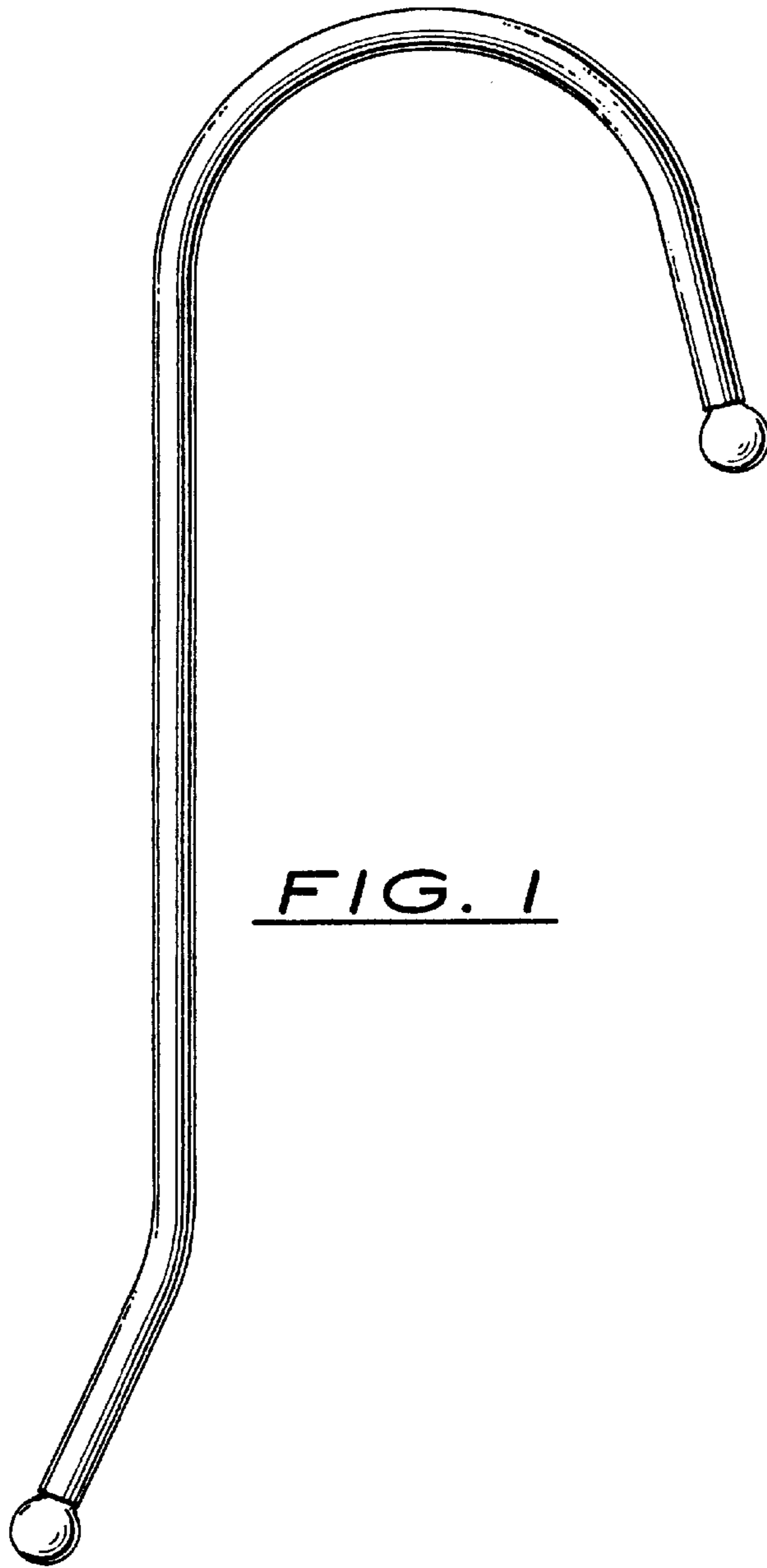

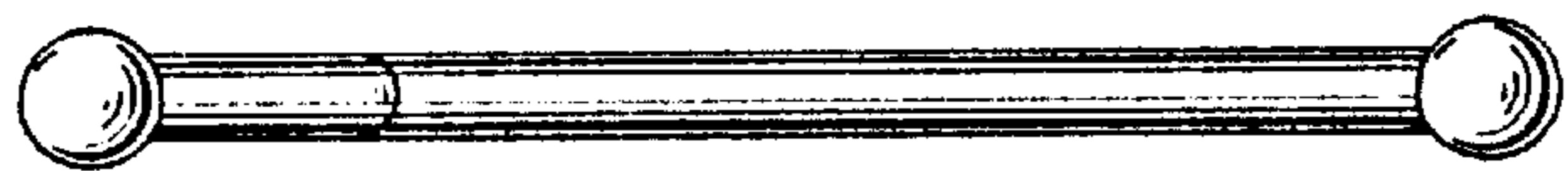

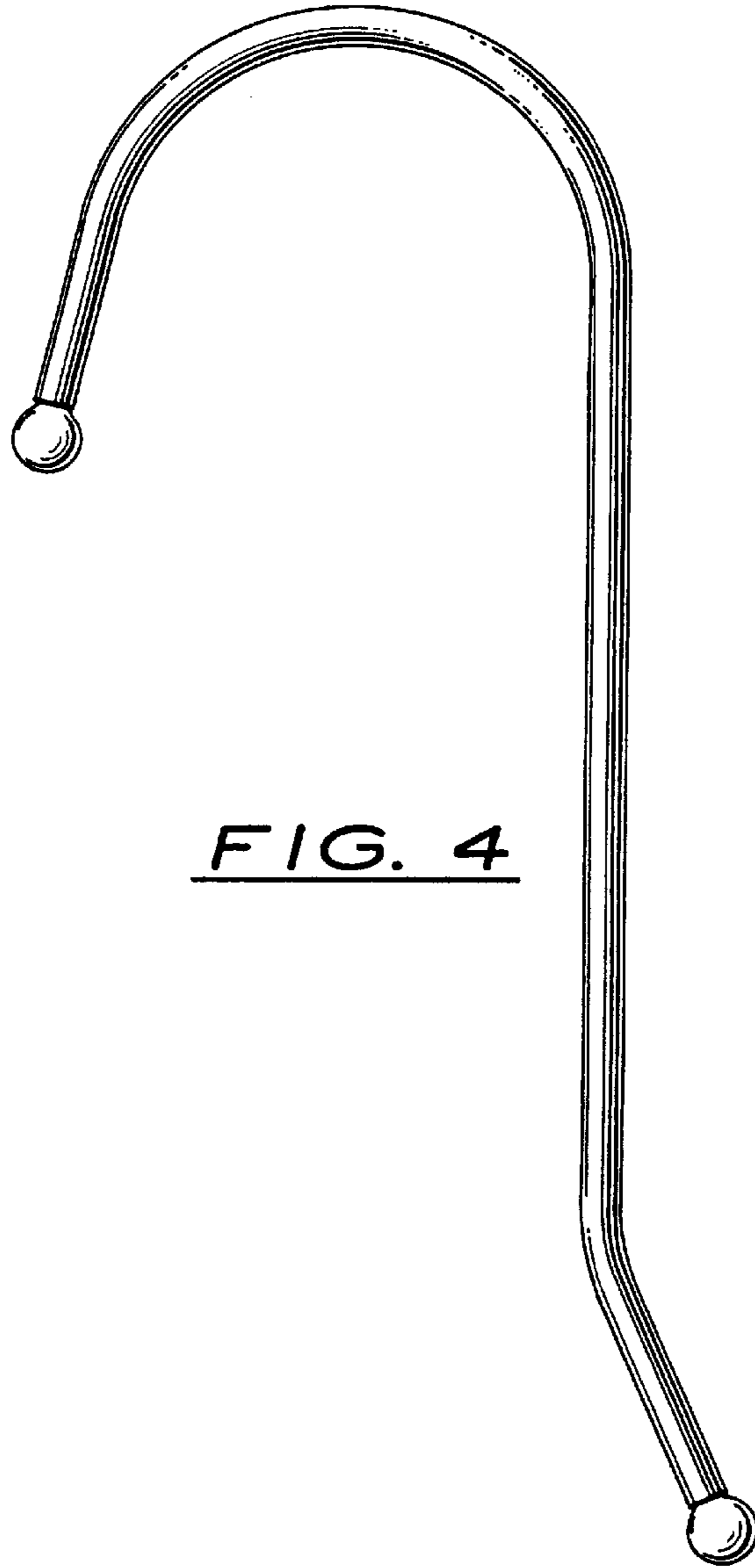

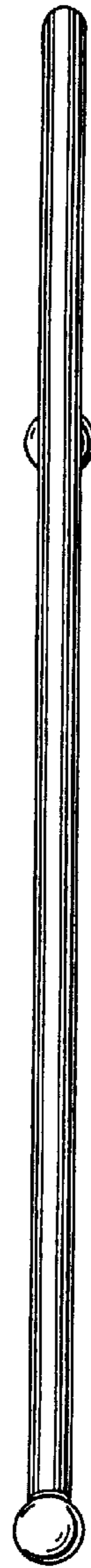

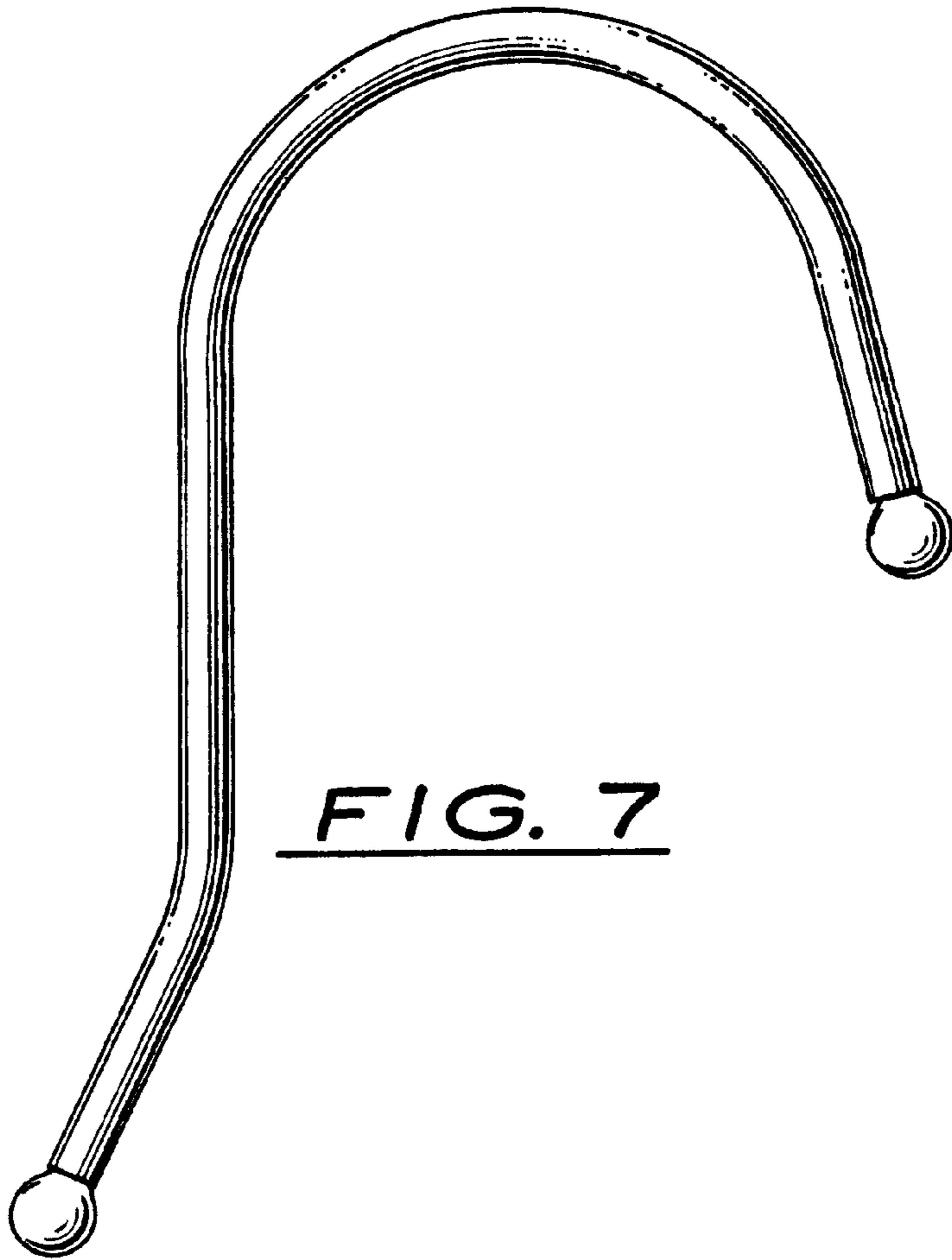

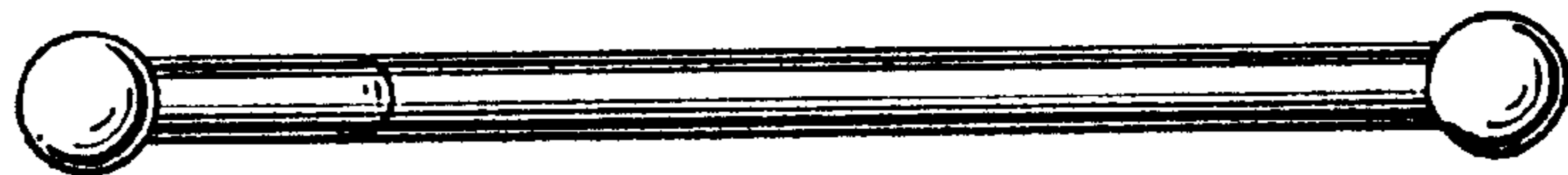

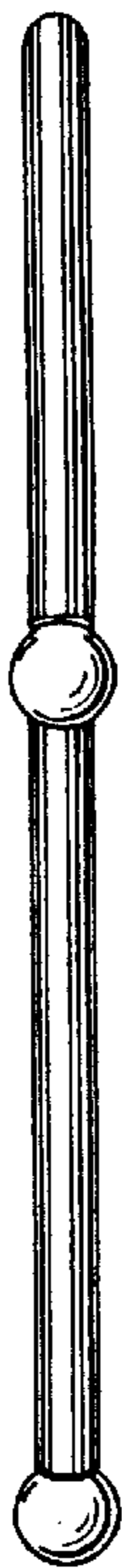

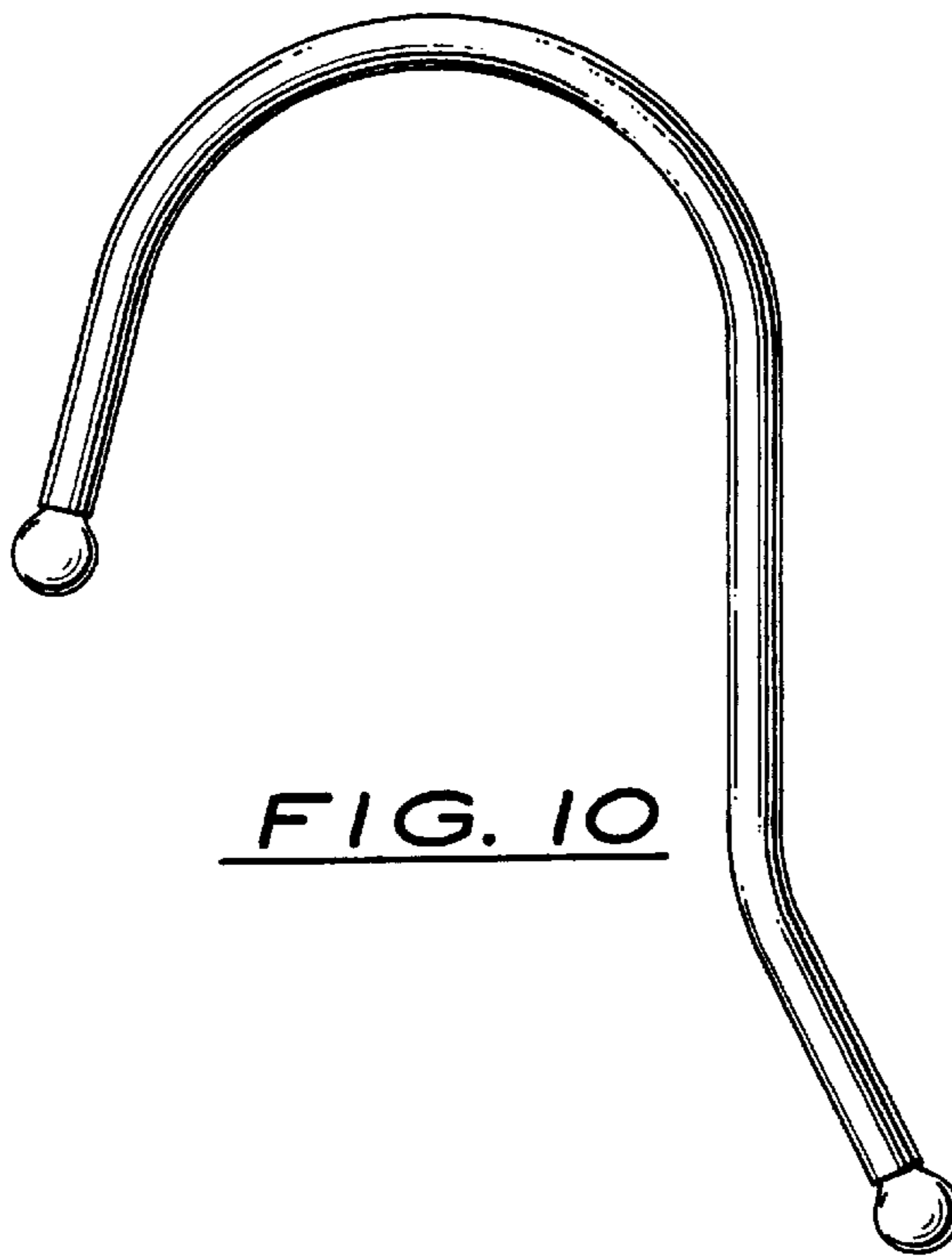
