FIG. 2 is a front elevational view of the Solomon's temple of FIG. 1;

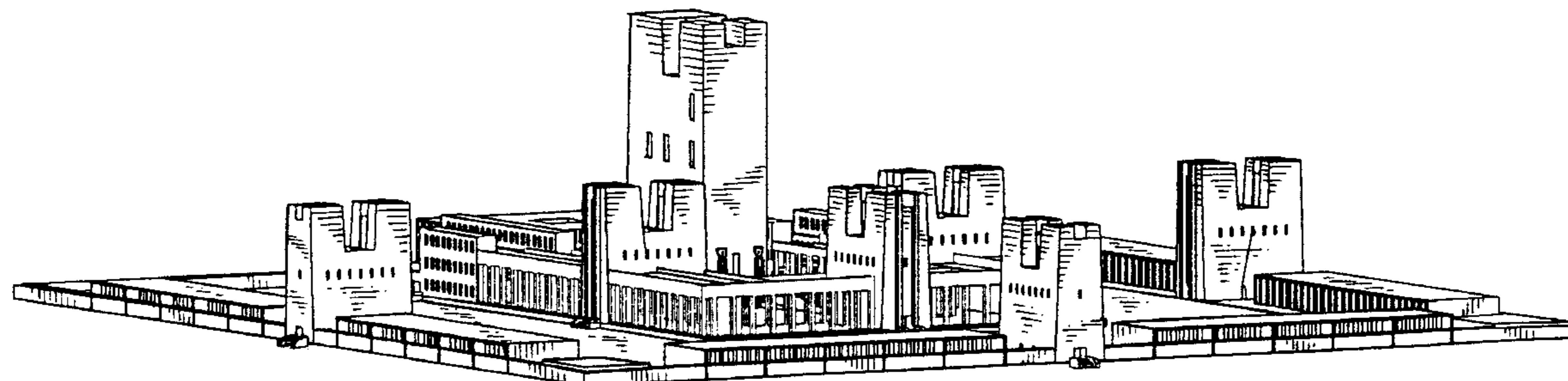
FIG. 3 is a rear elevational view of the Solomon's temple of FIG. 1;

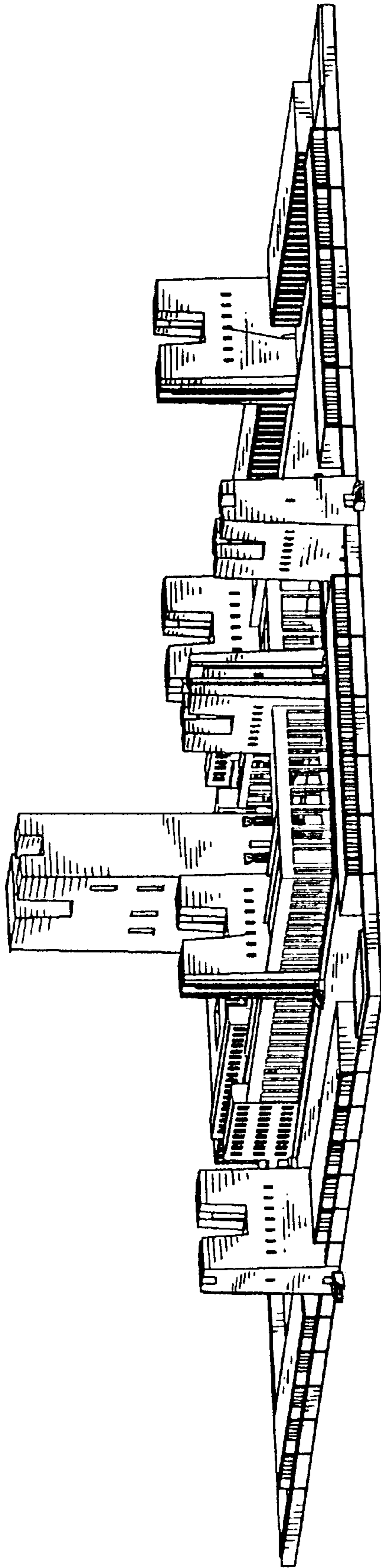
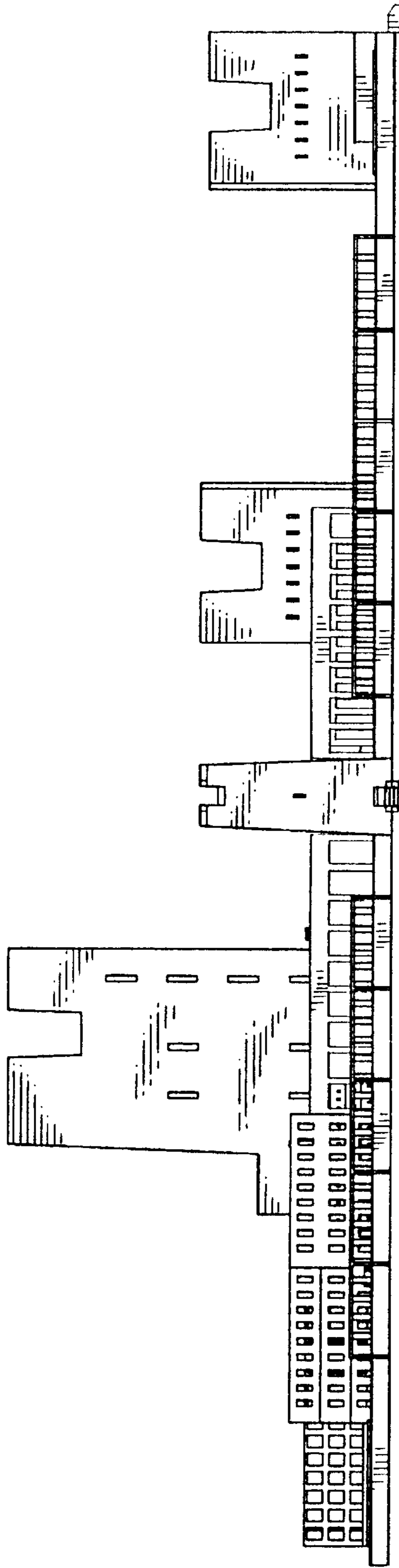

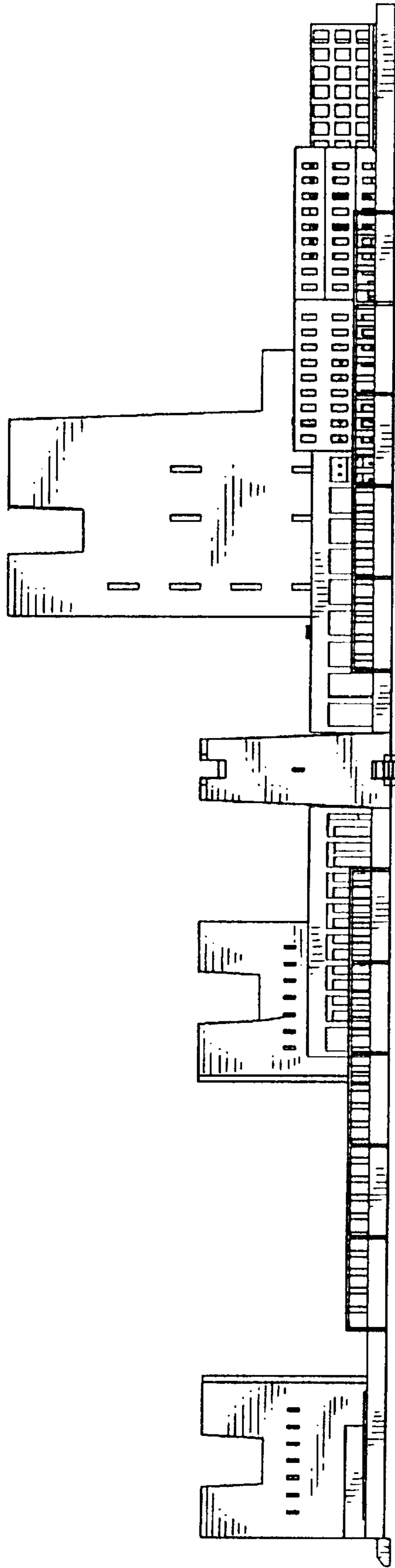

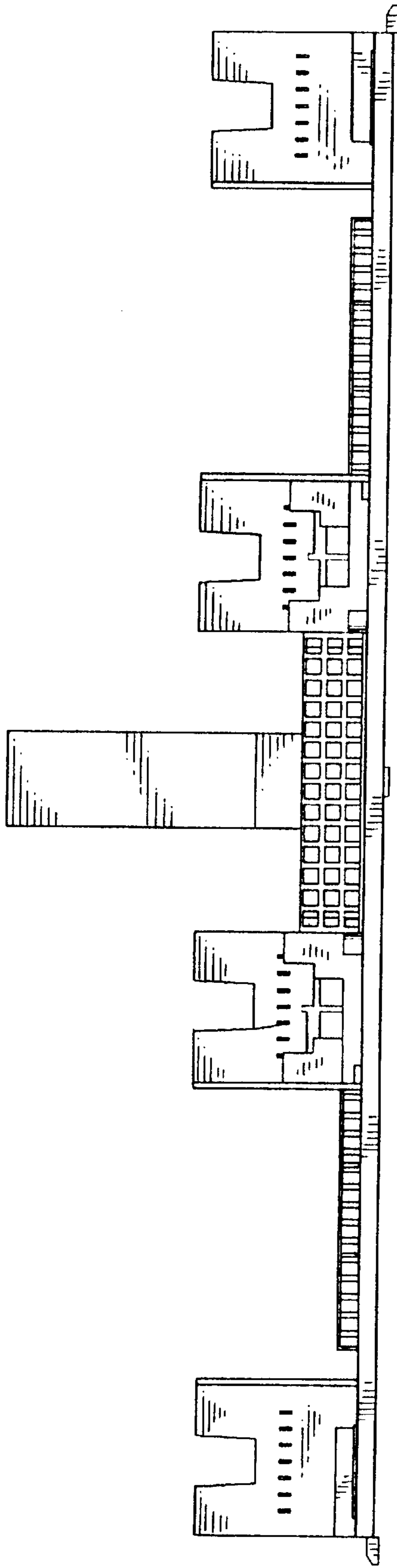
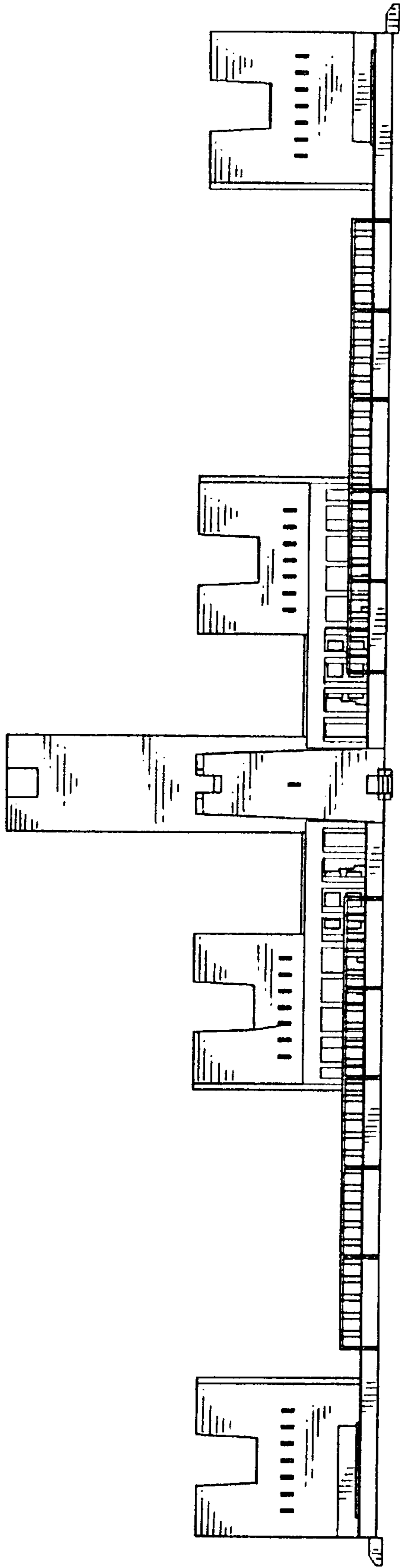

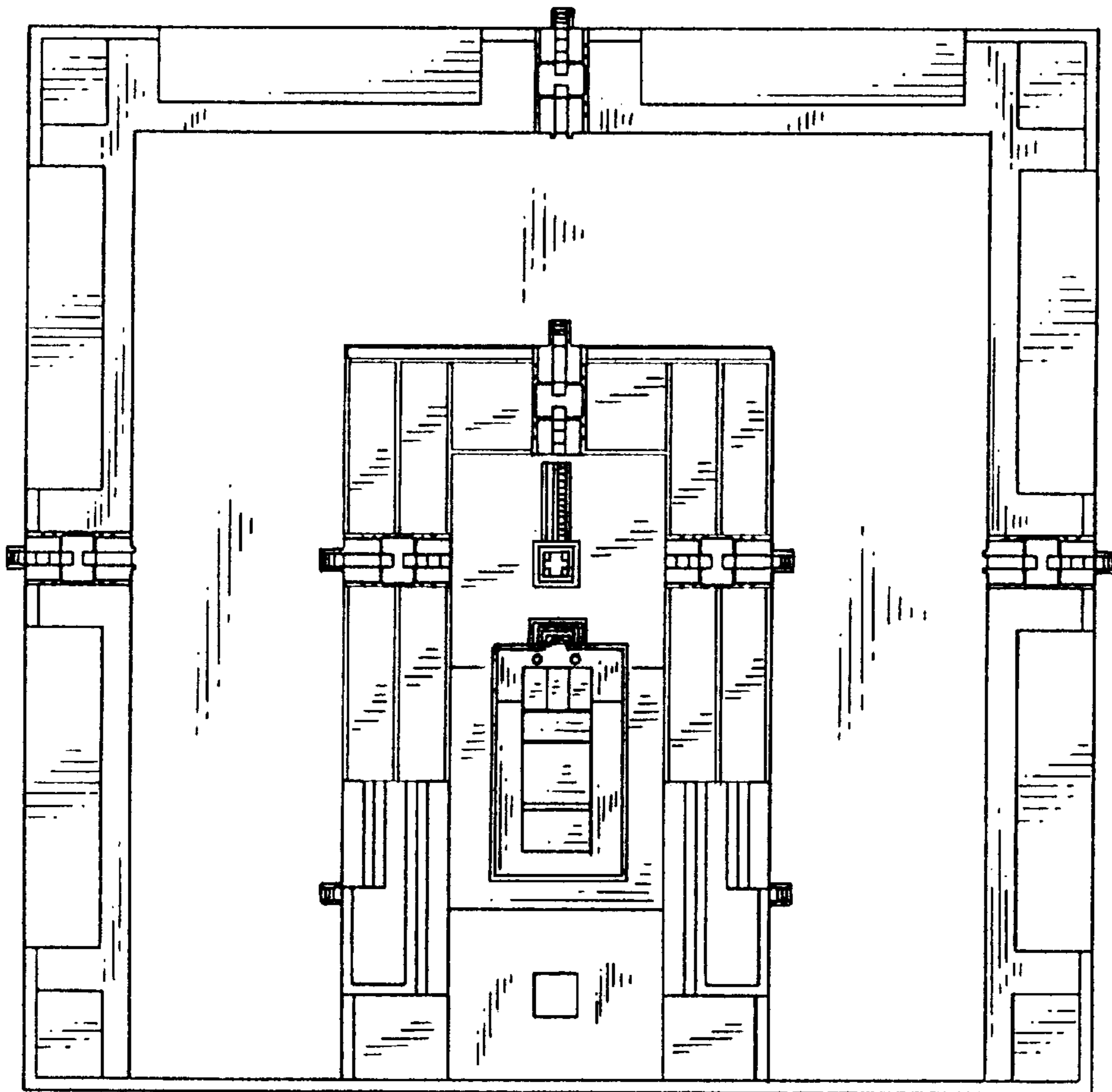
