FIG. 14 is a side elevational view of FIG. 13;

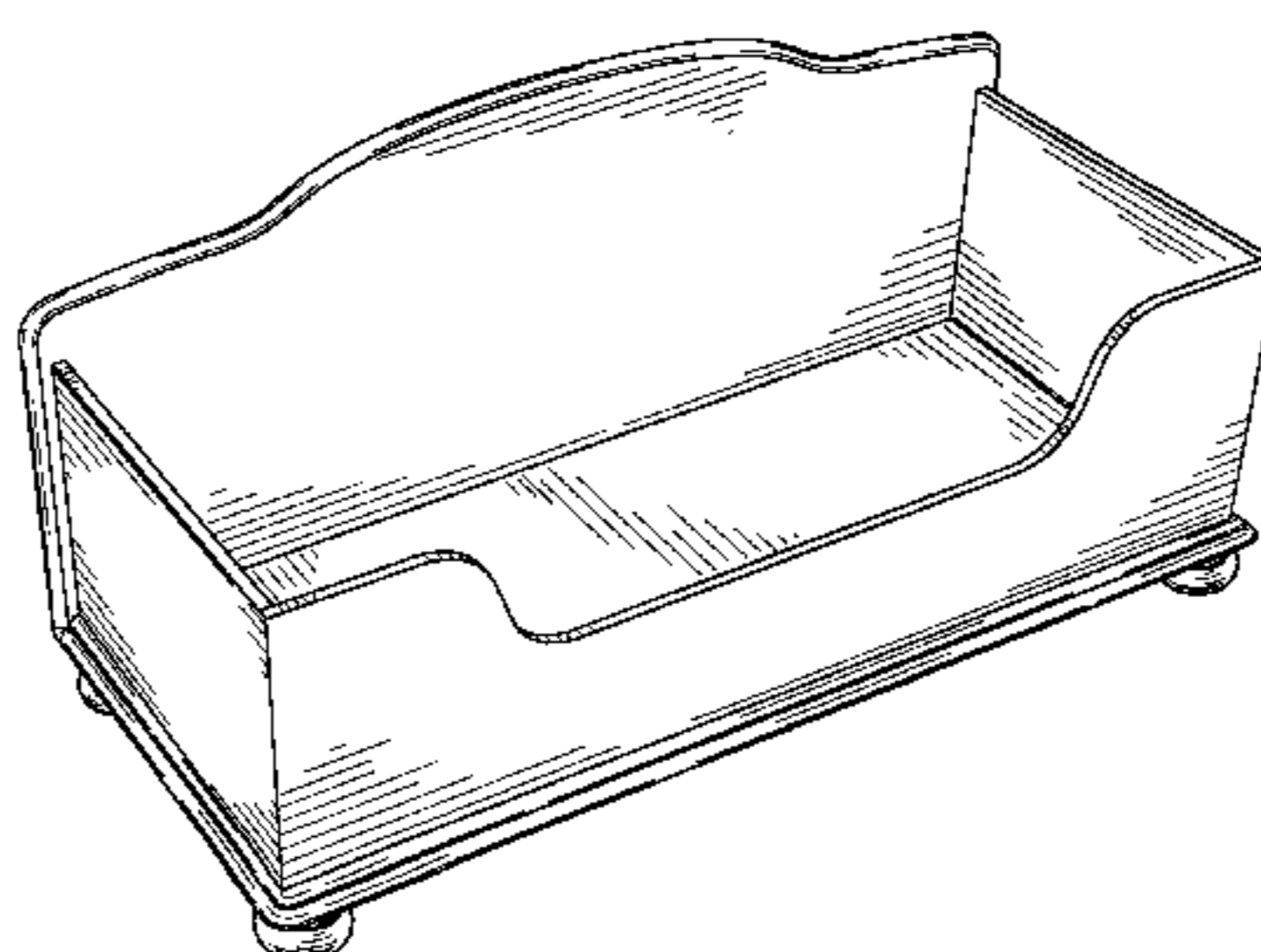
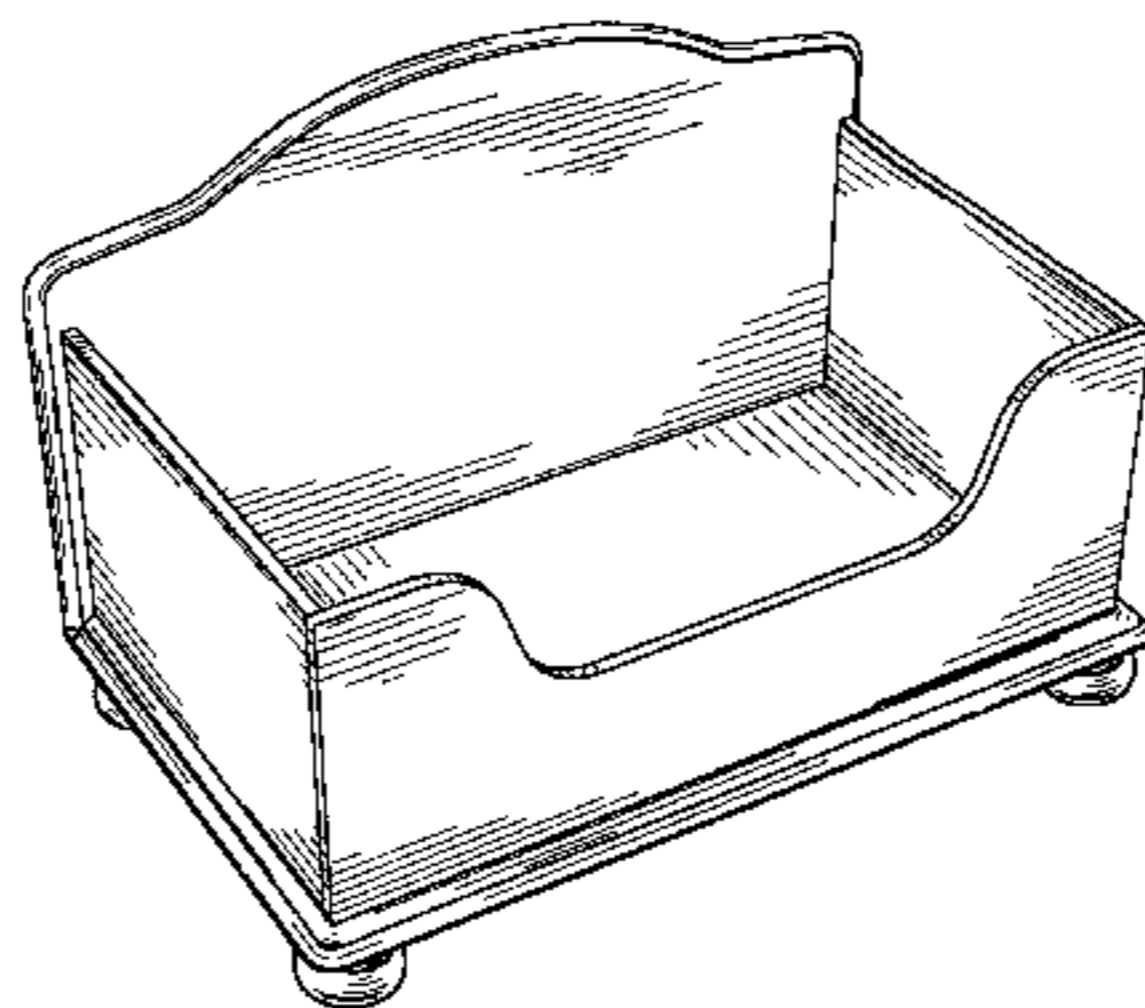
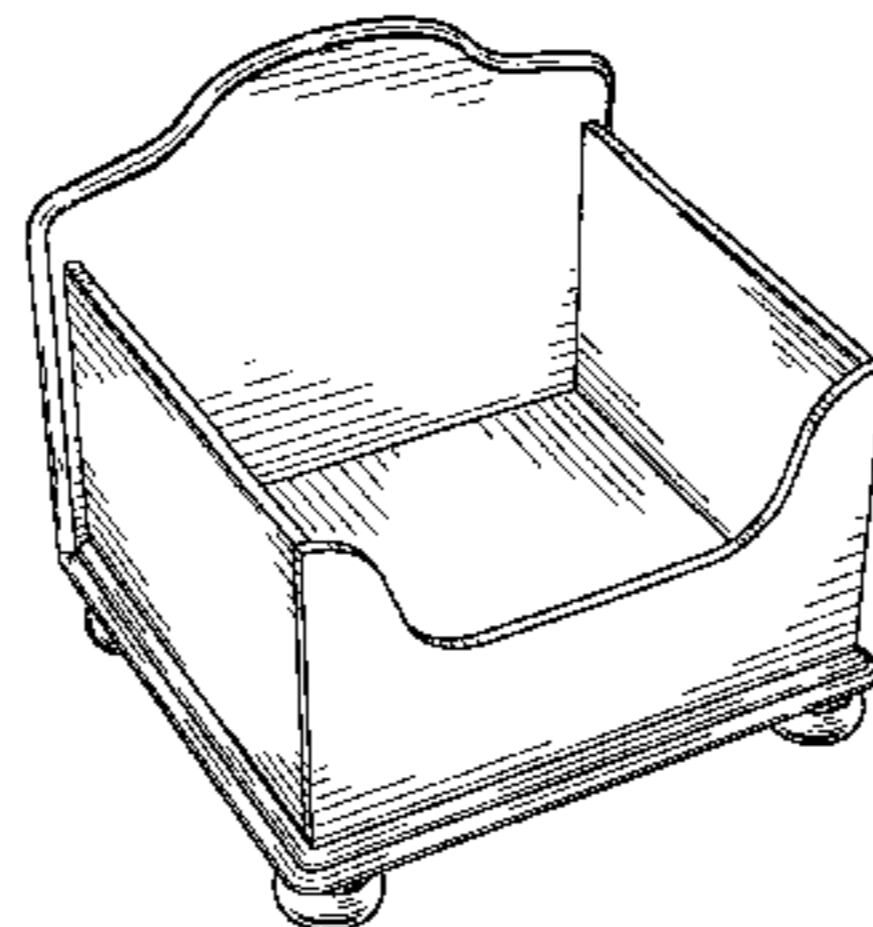
FIG. 15 is a front elevational view of FIG. 13; and,

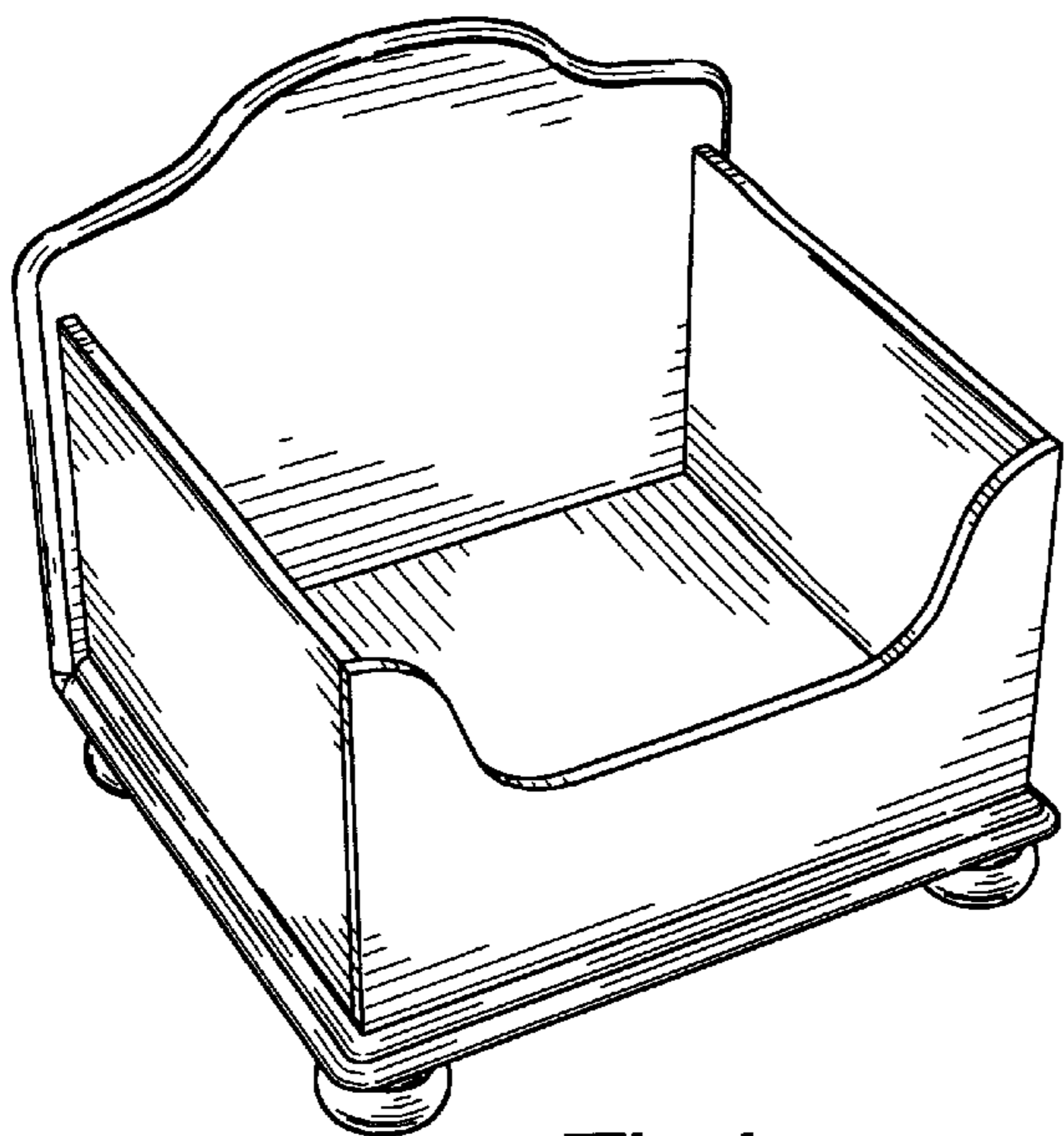

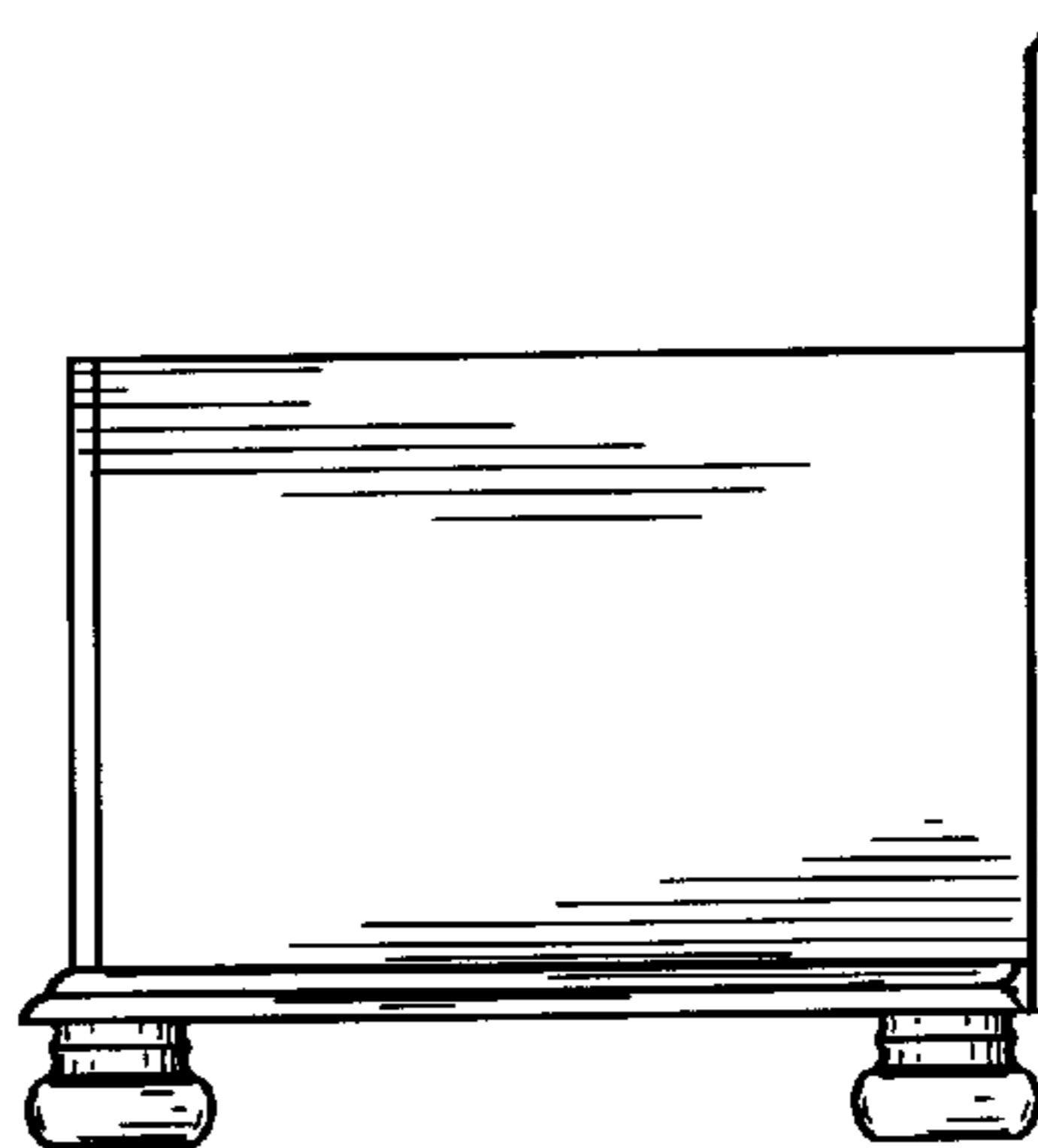

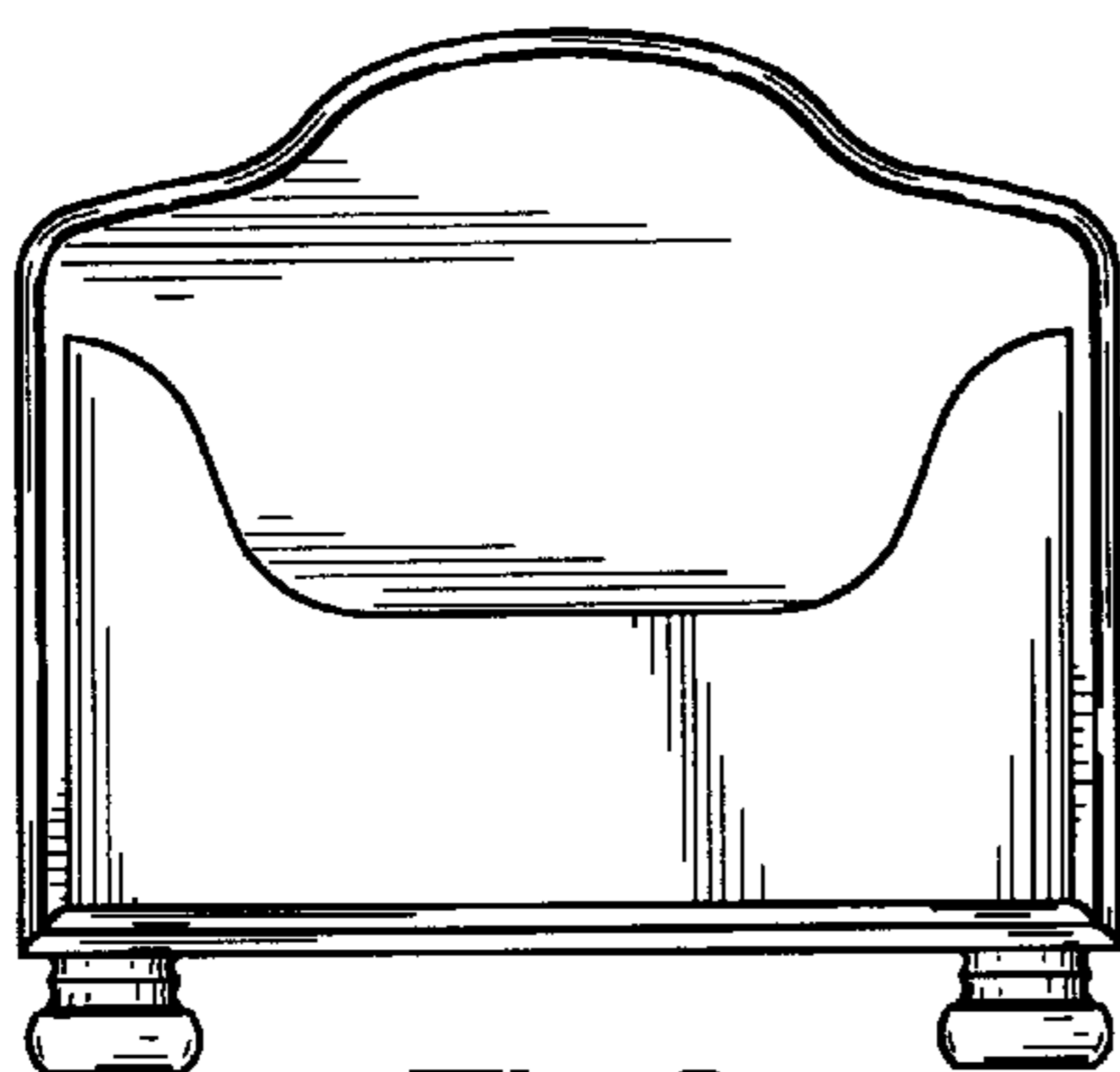

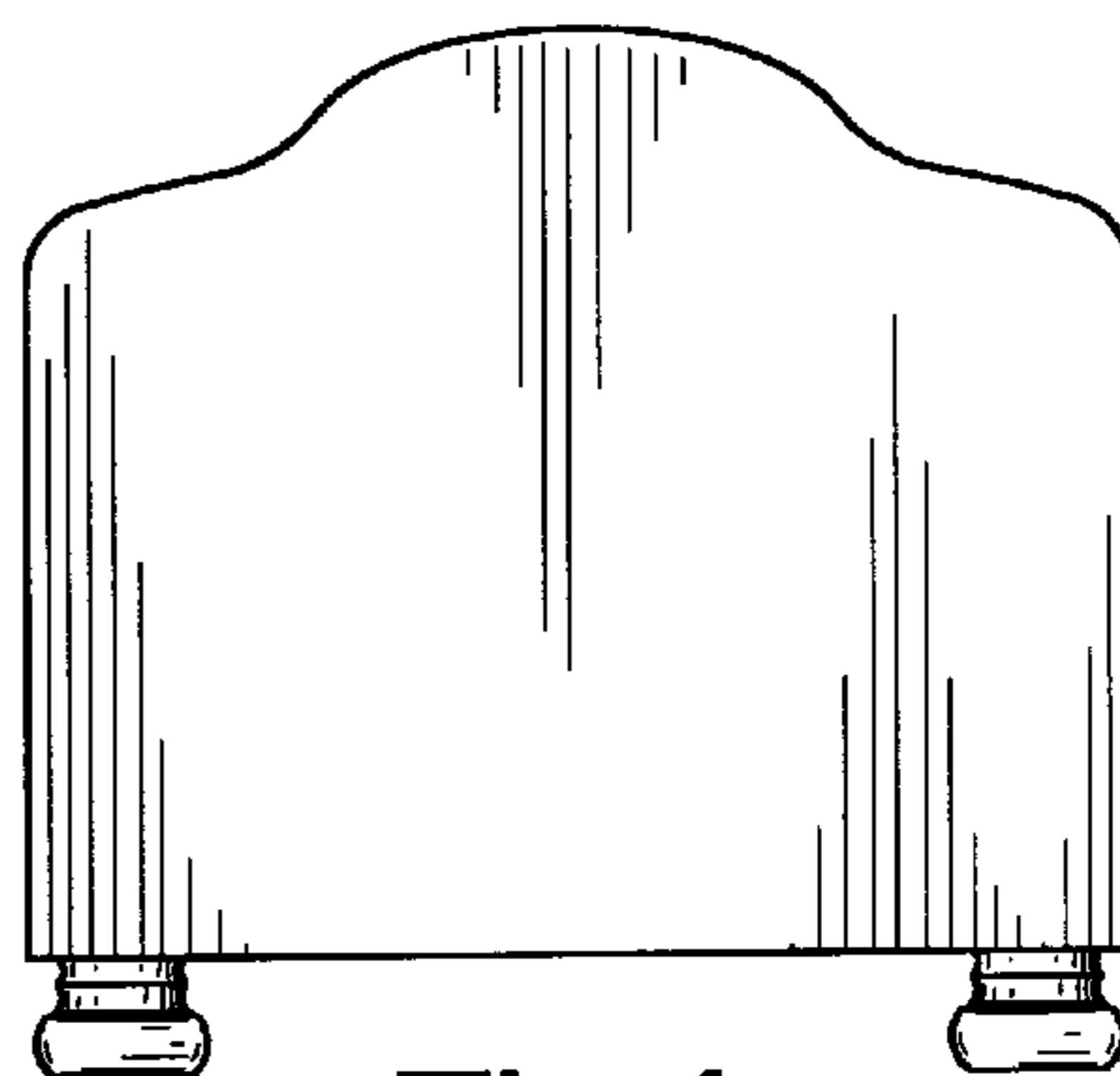

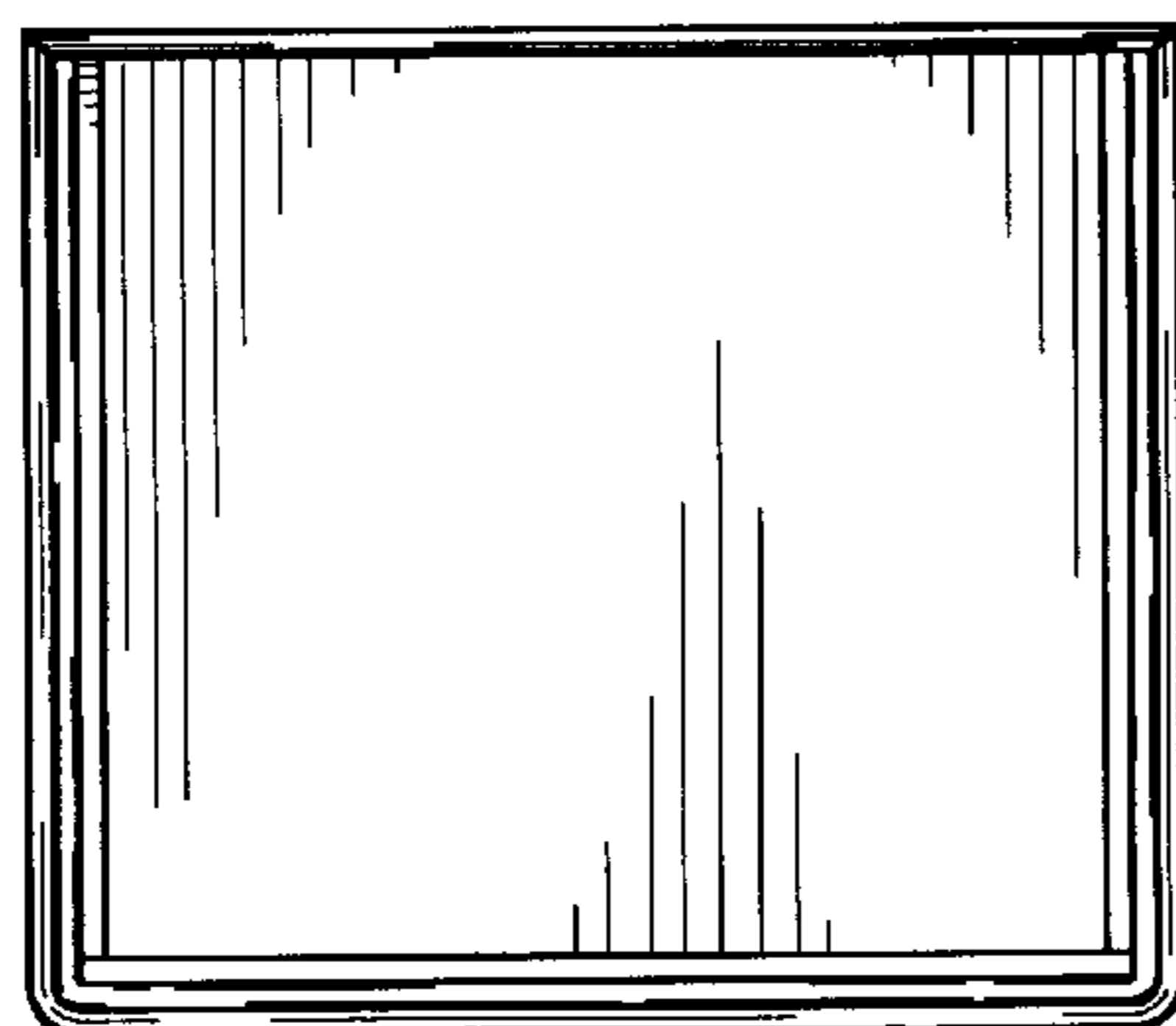

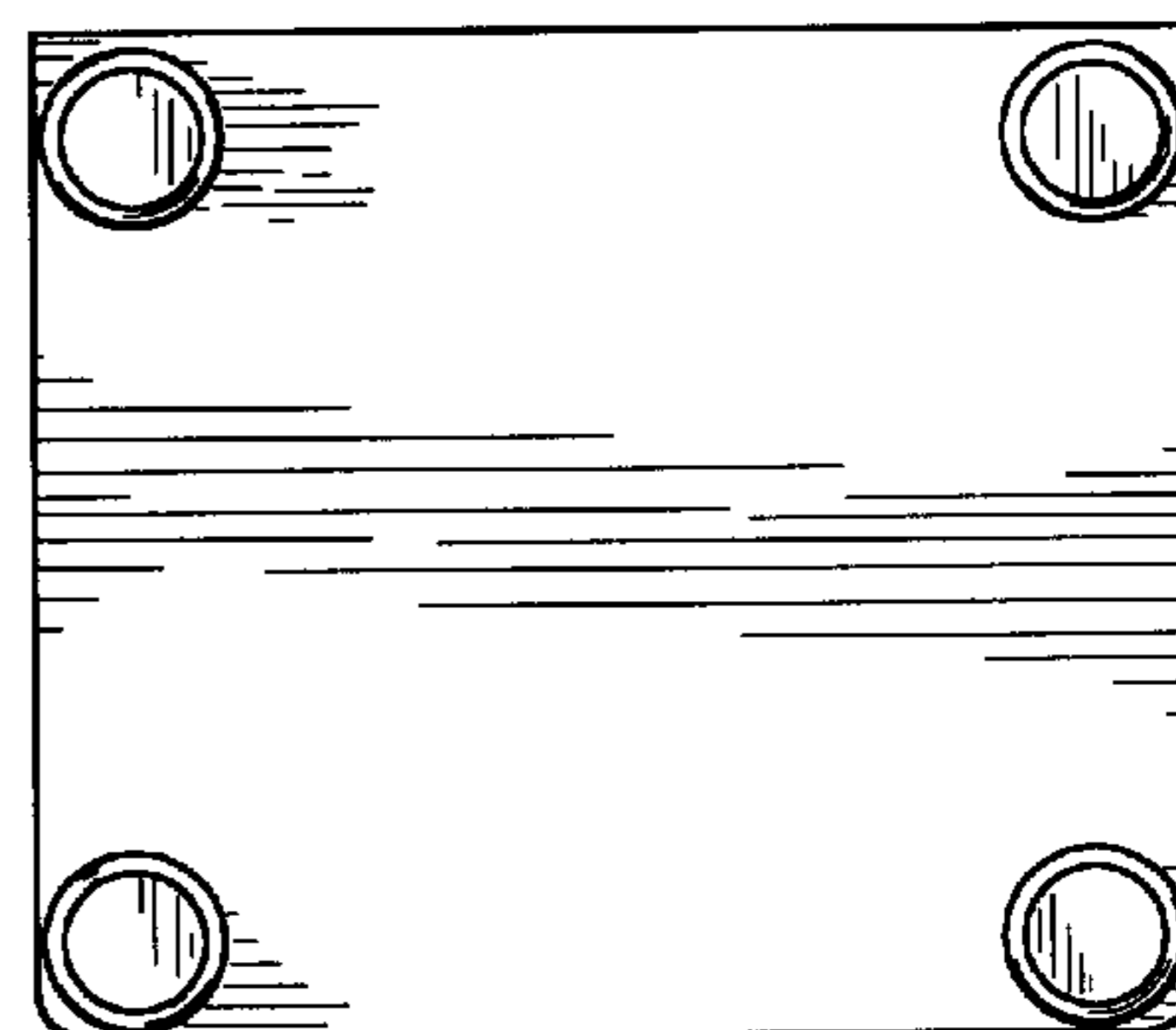

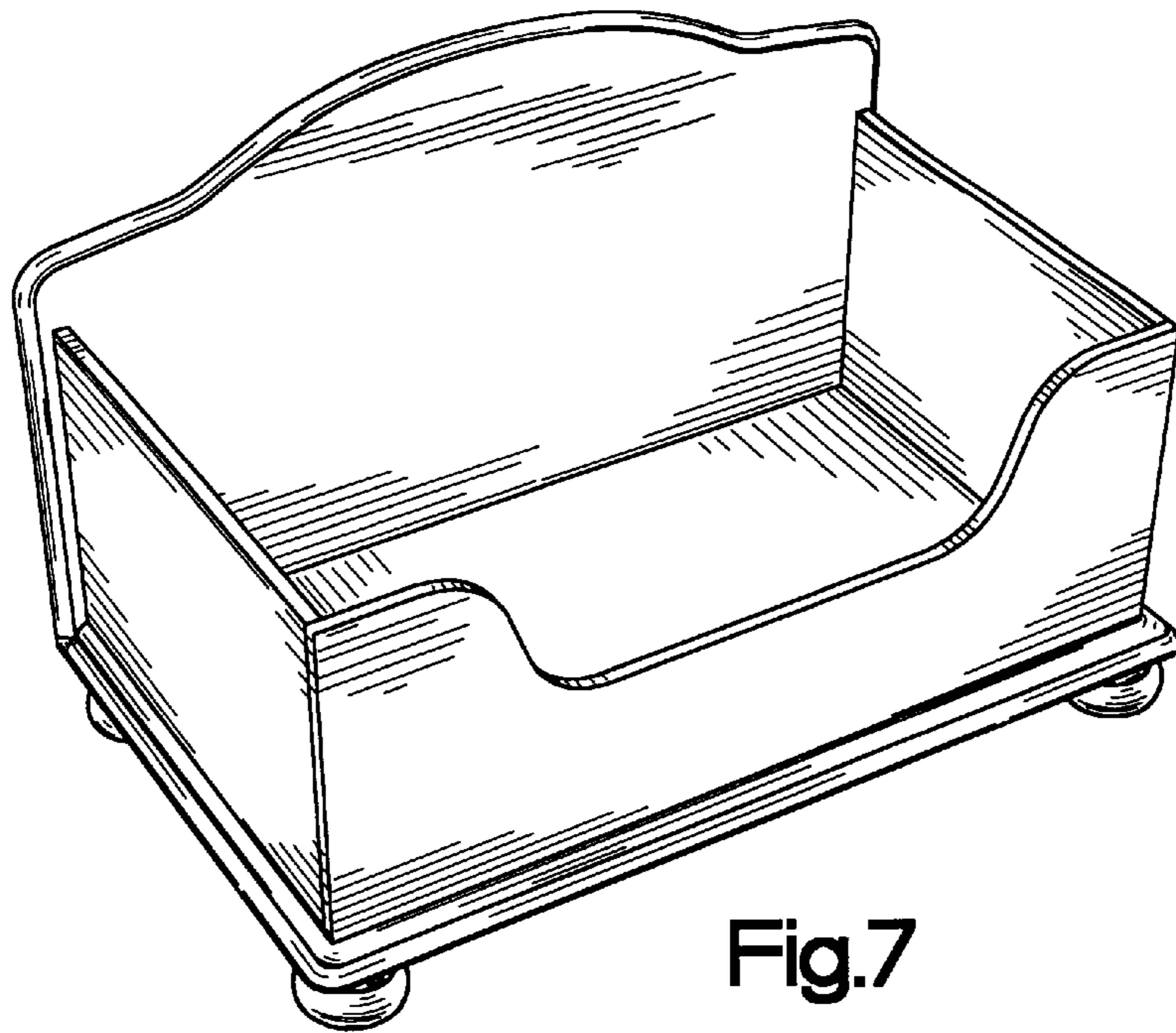

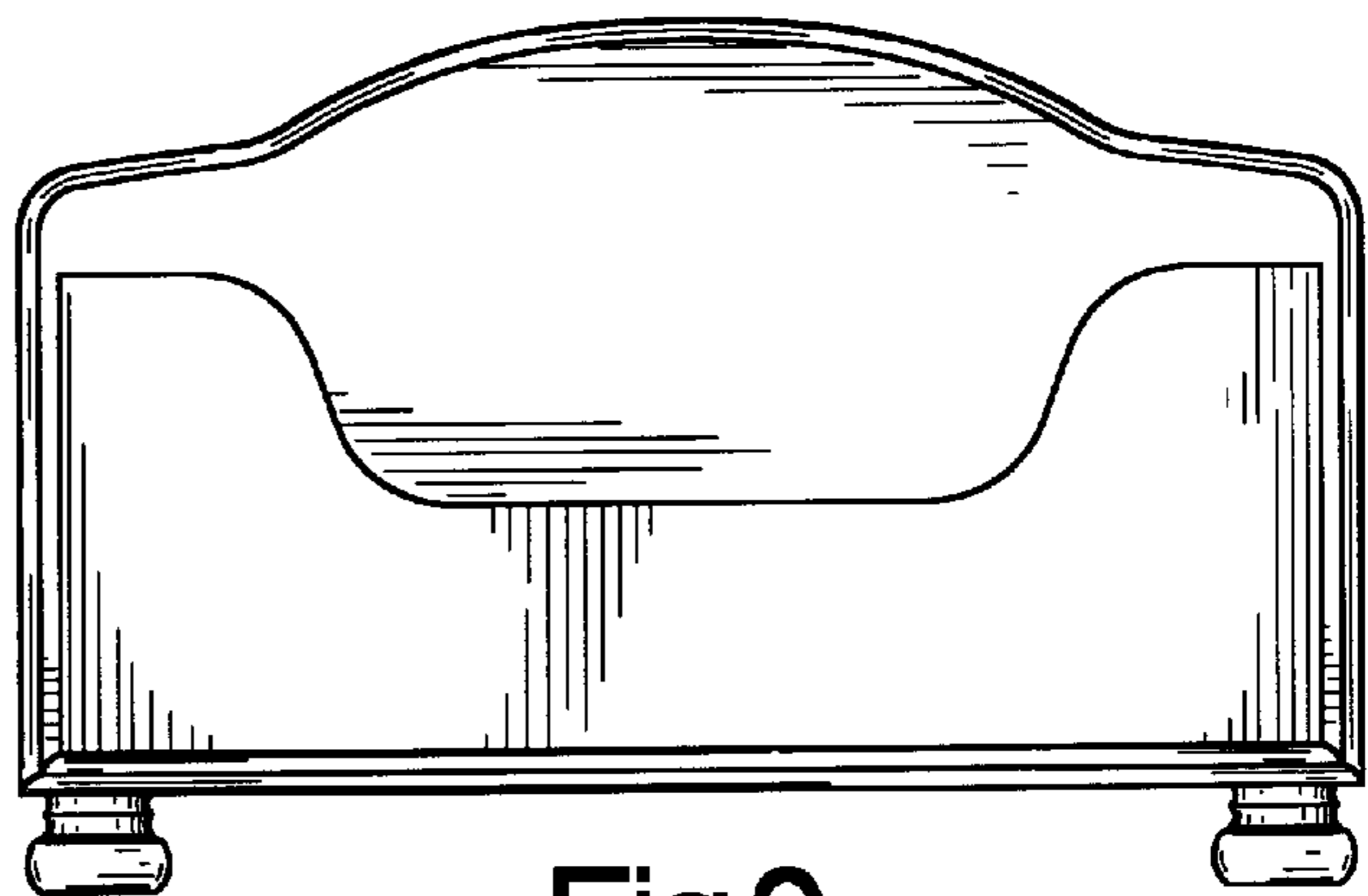

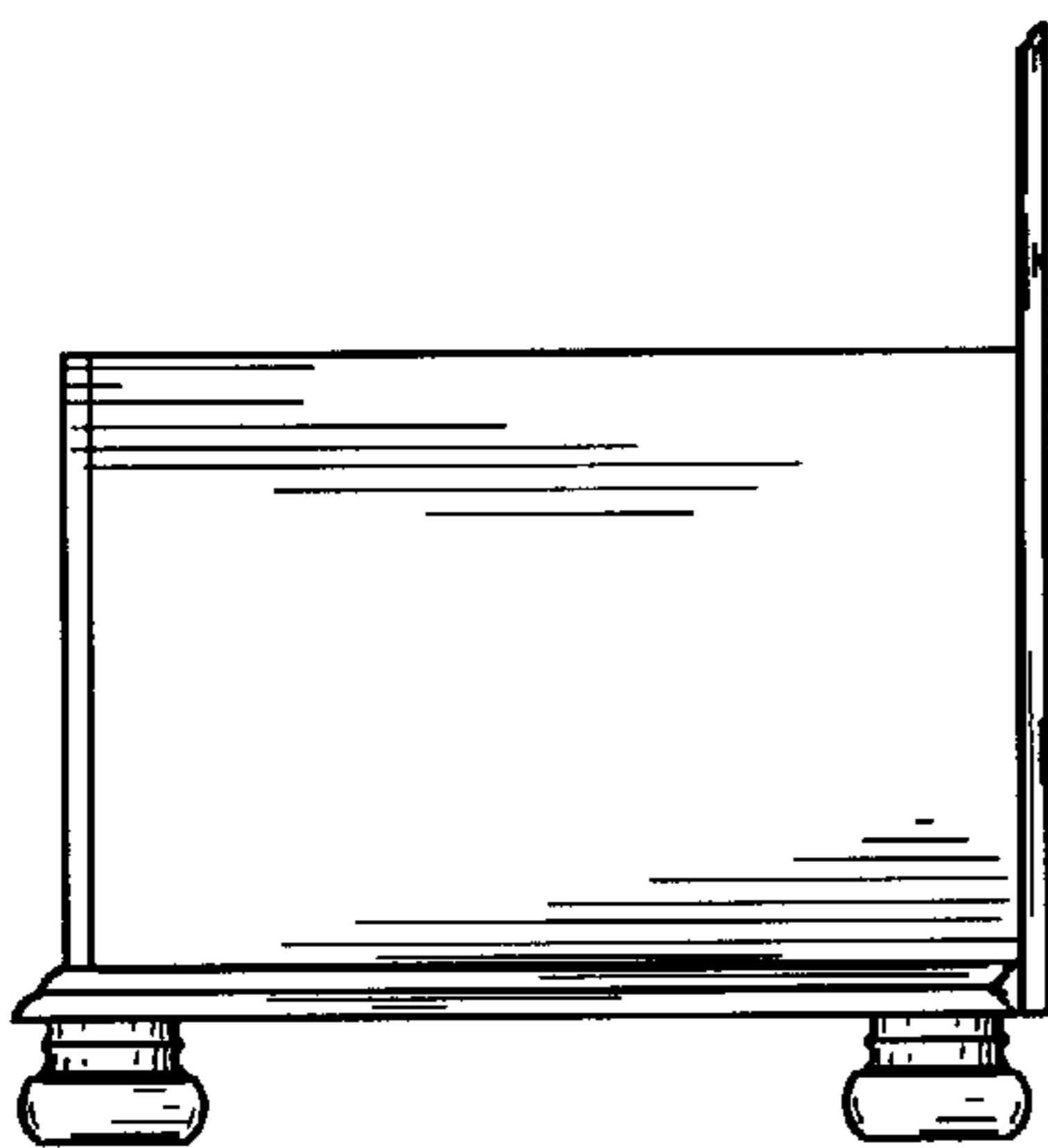

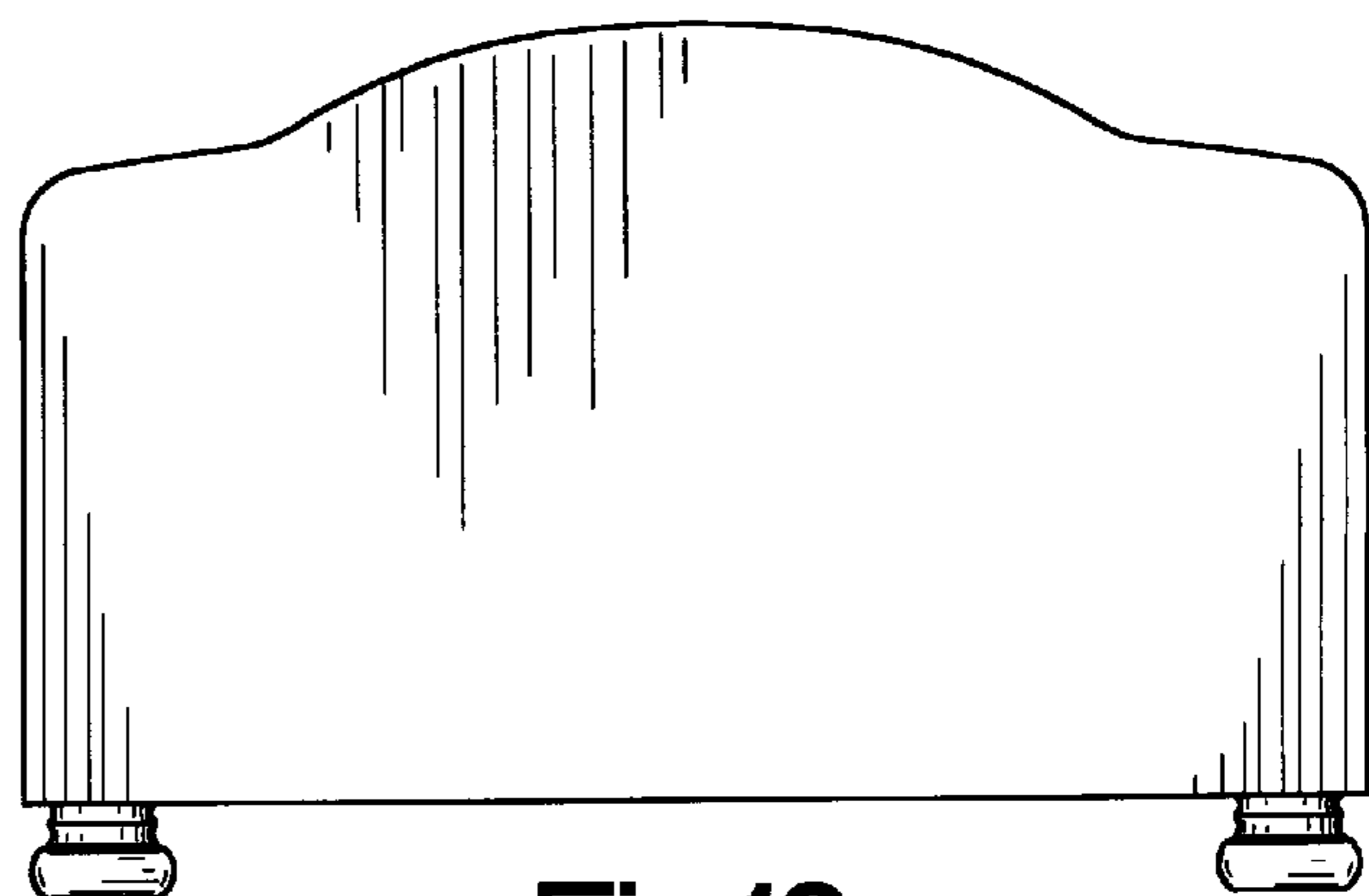

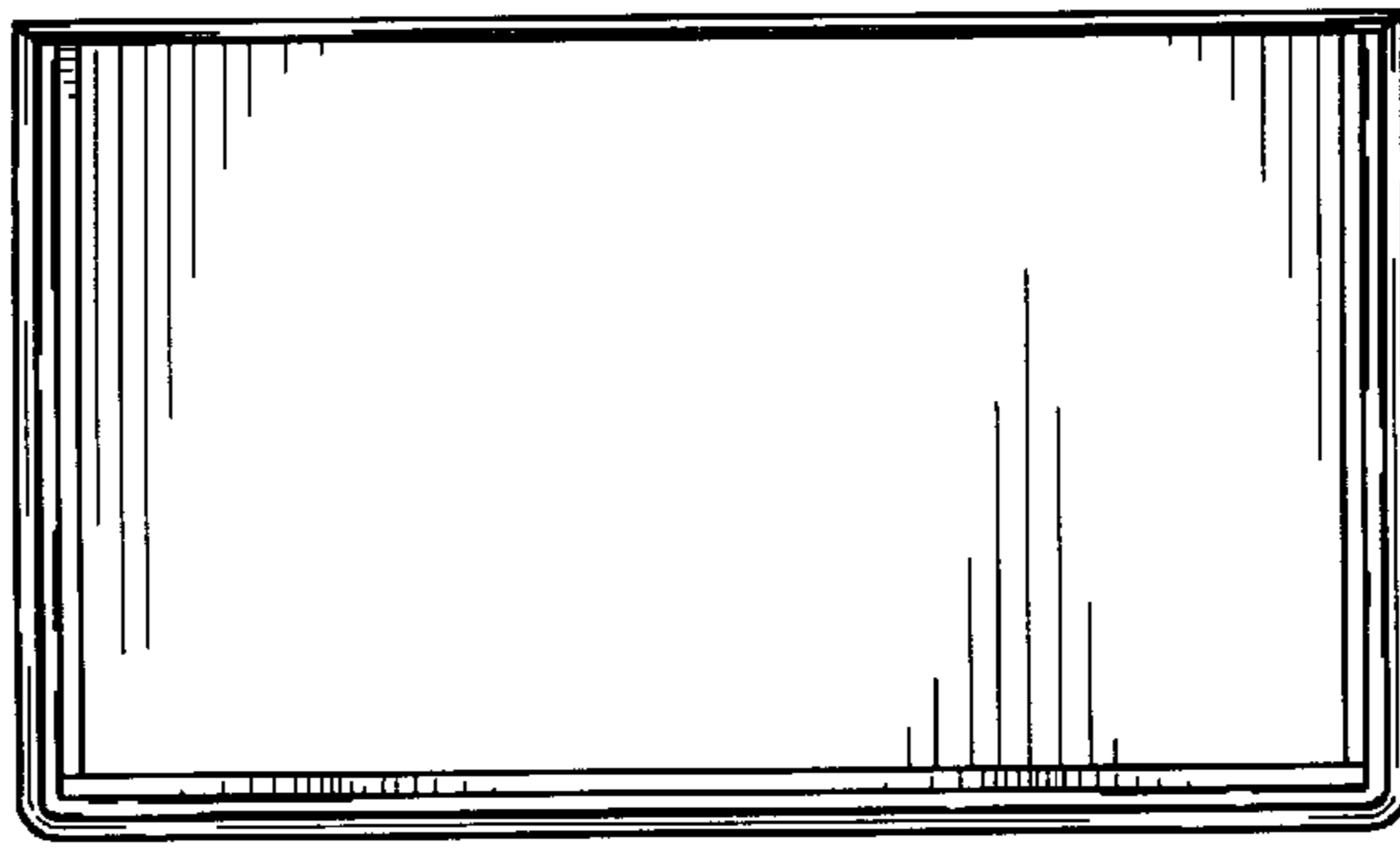

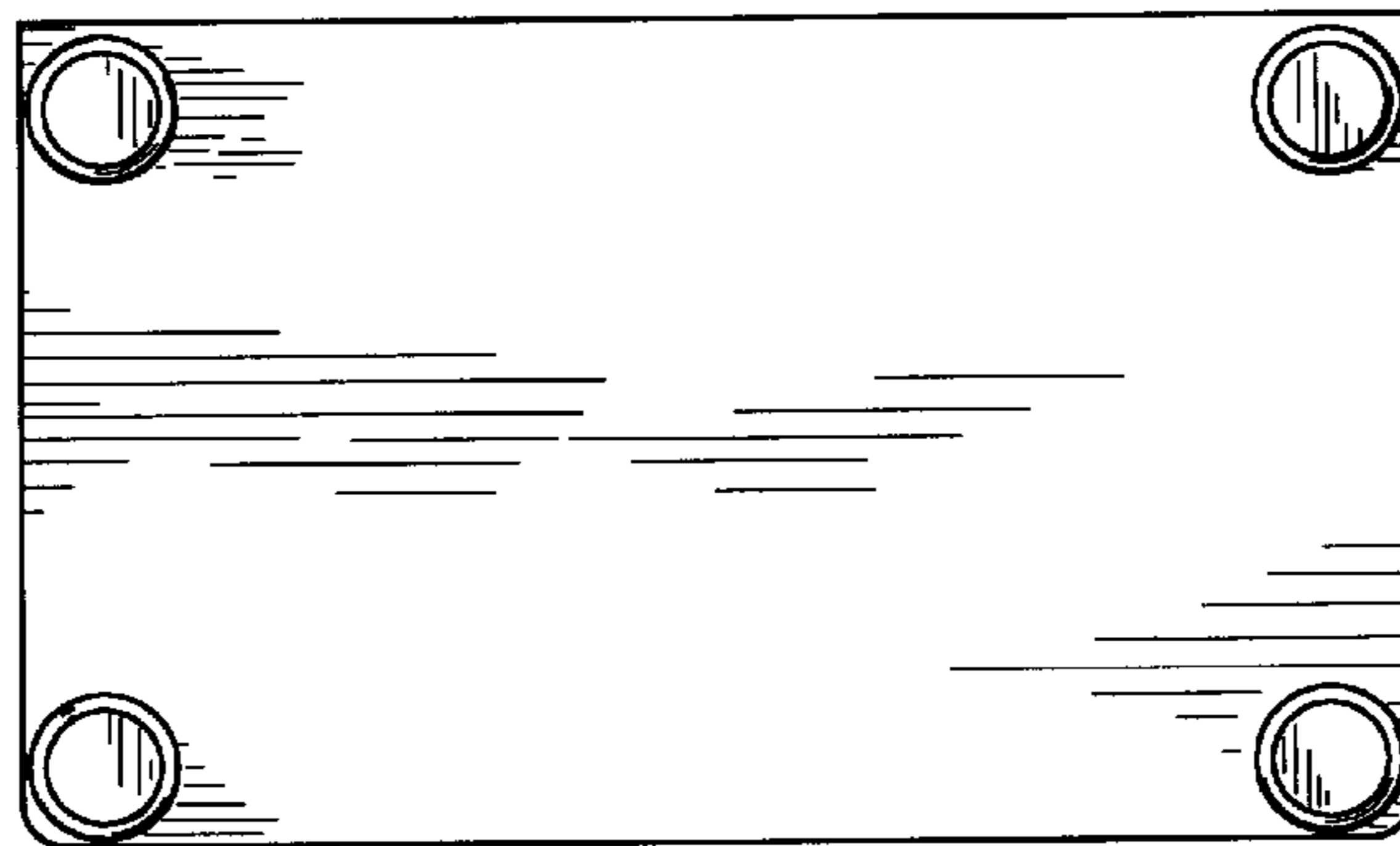

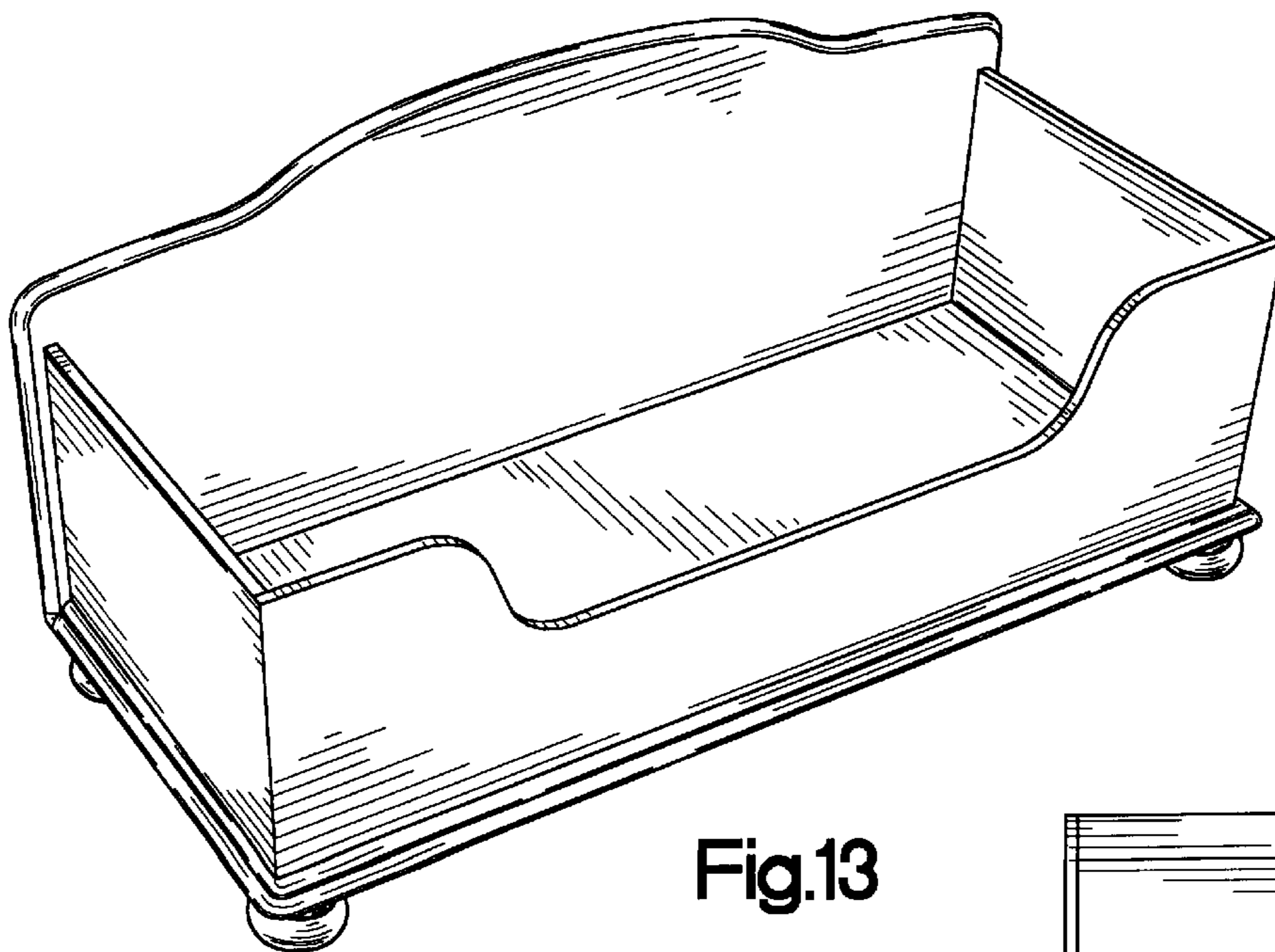

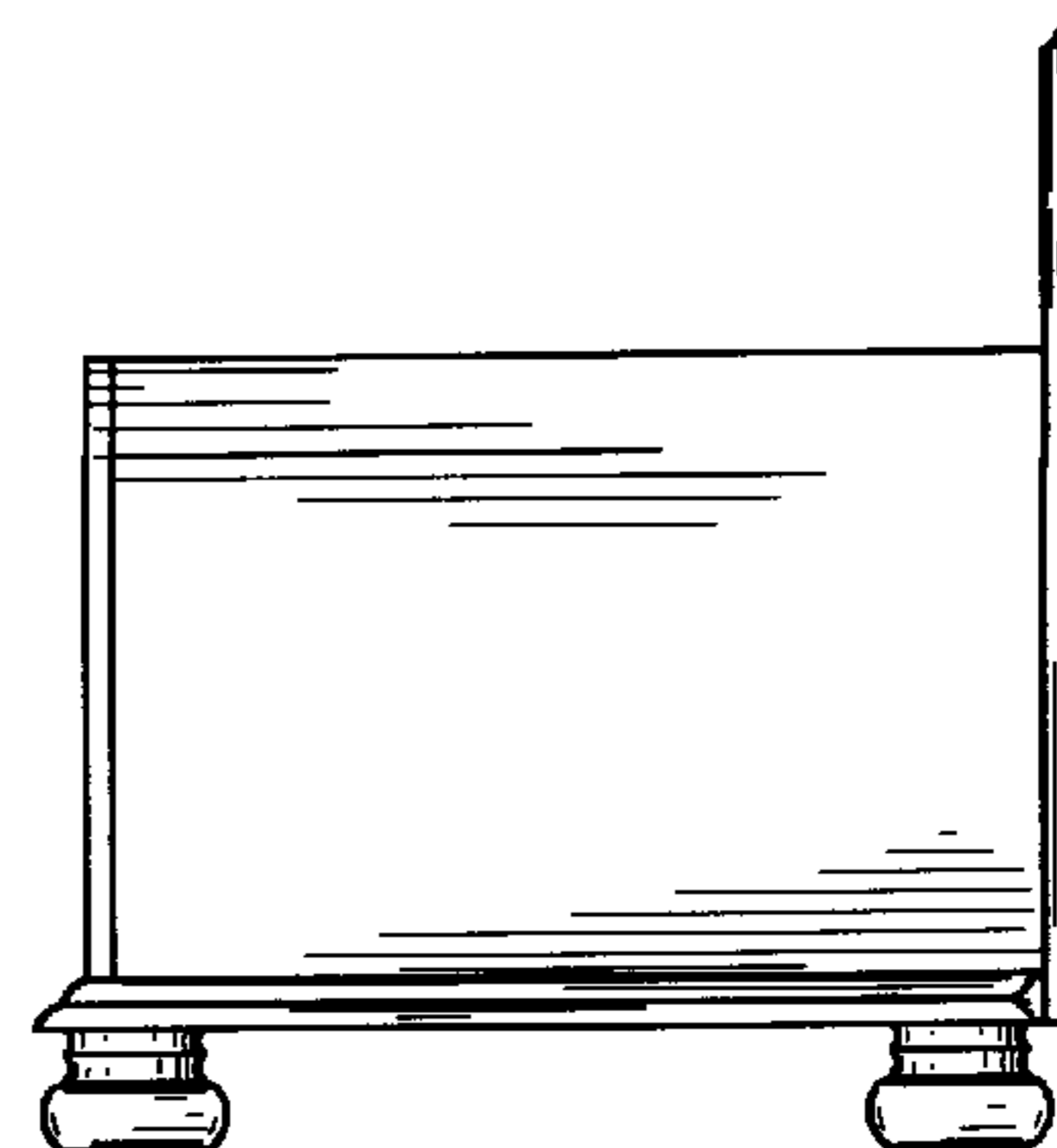

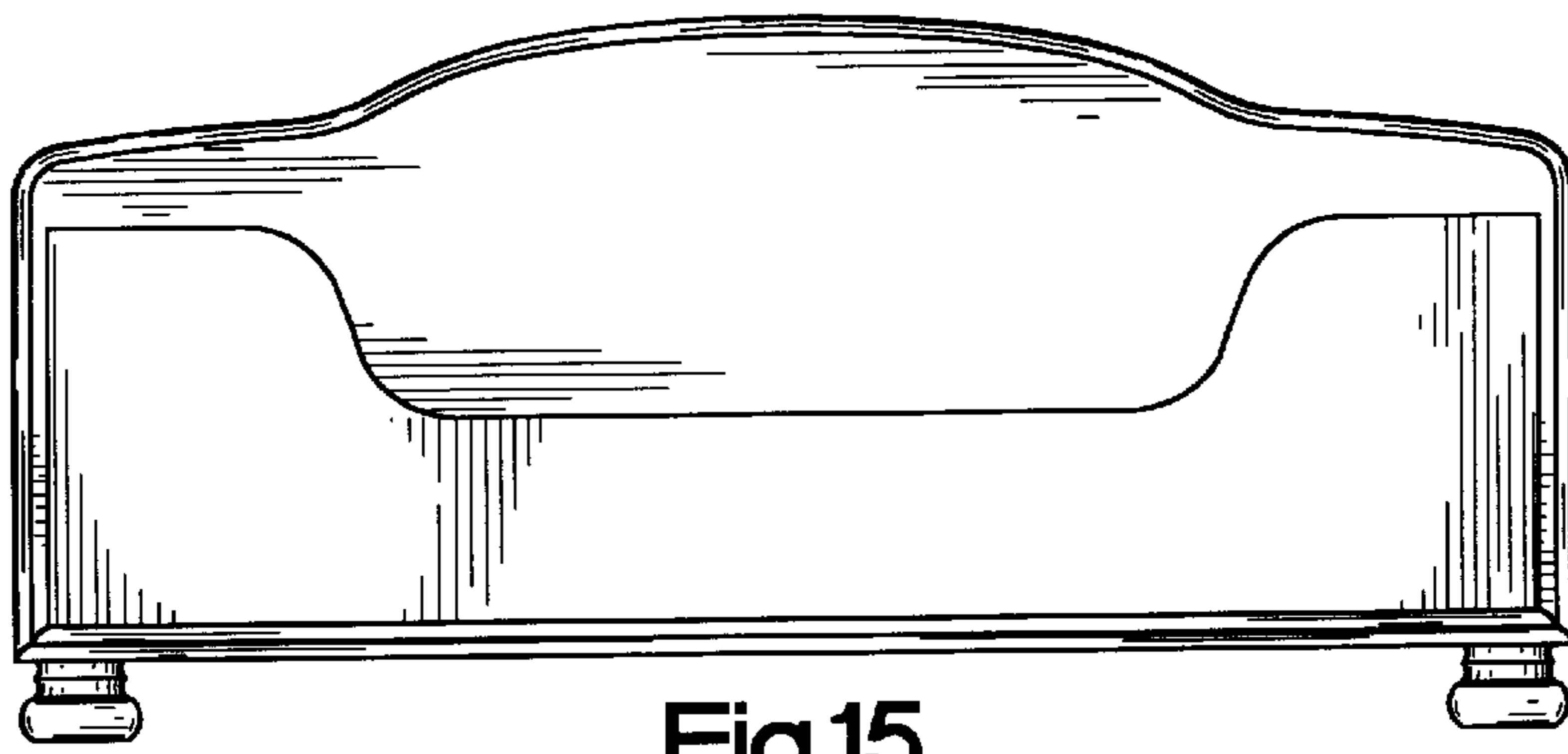

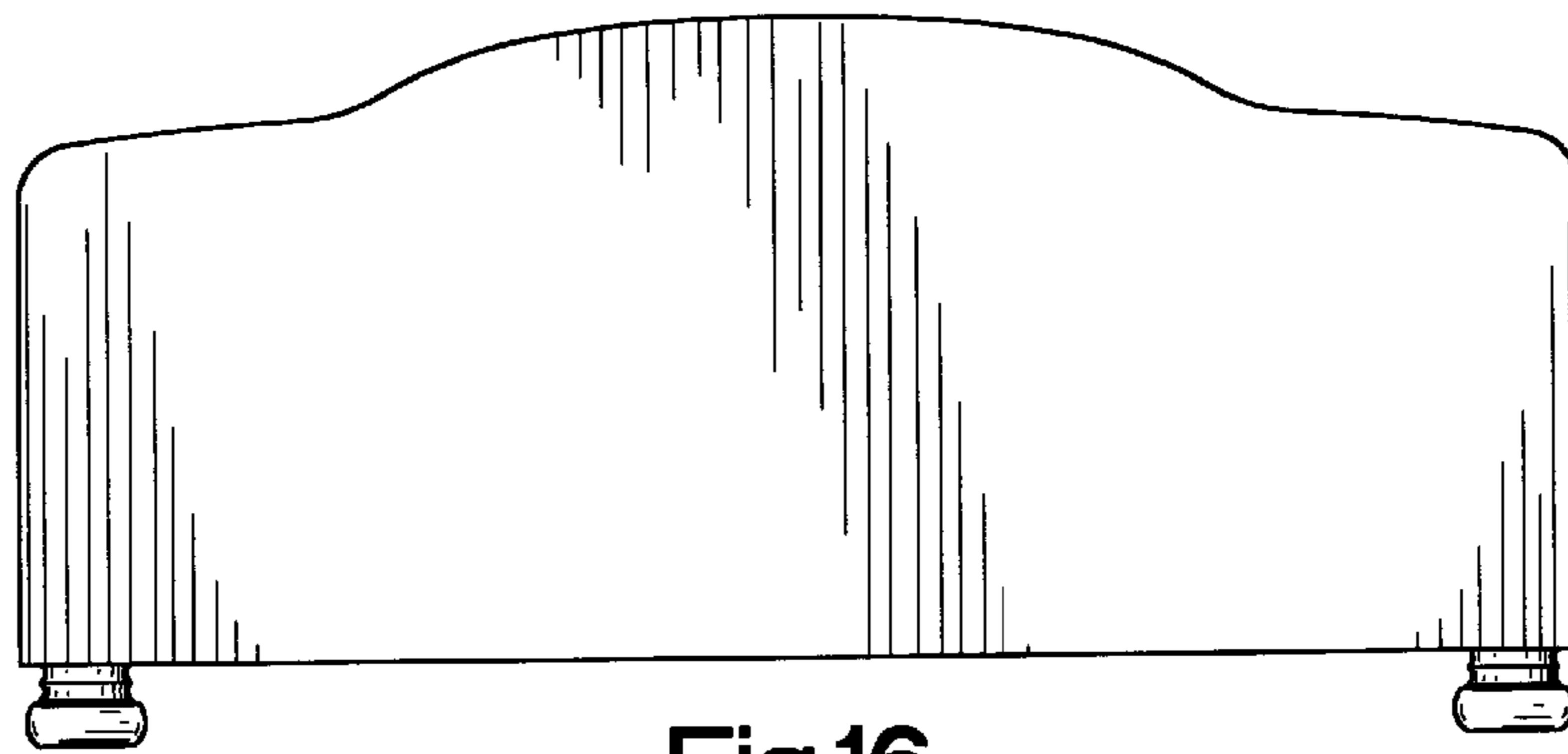

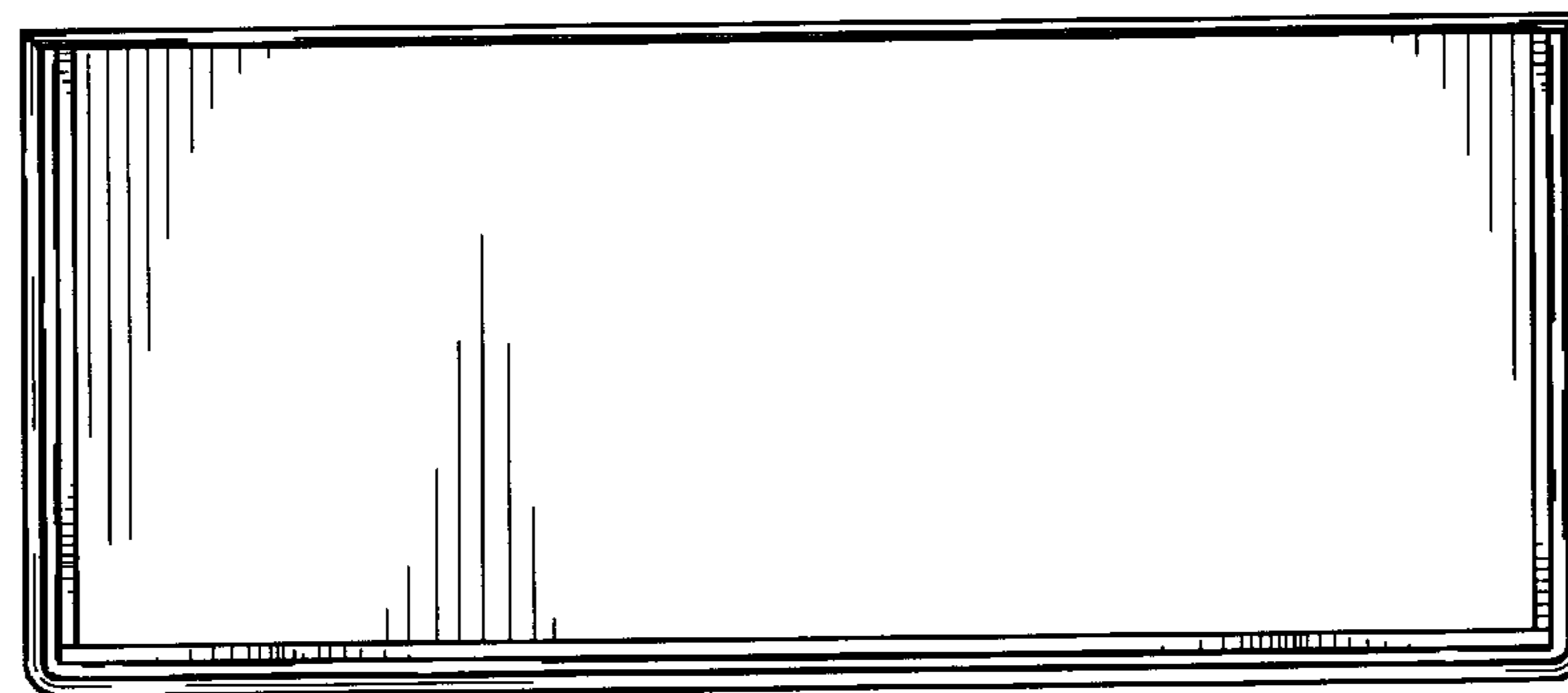

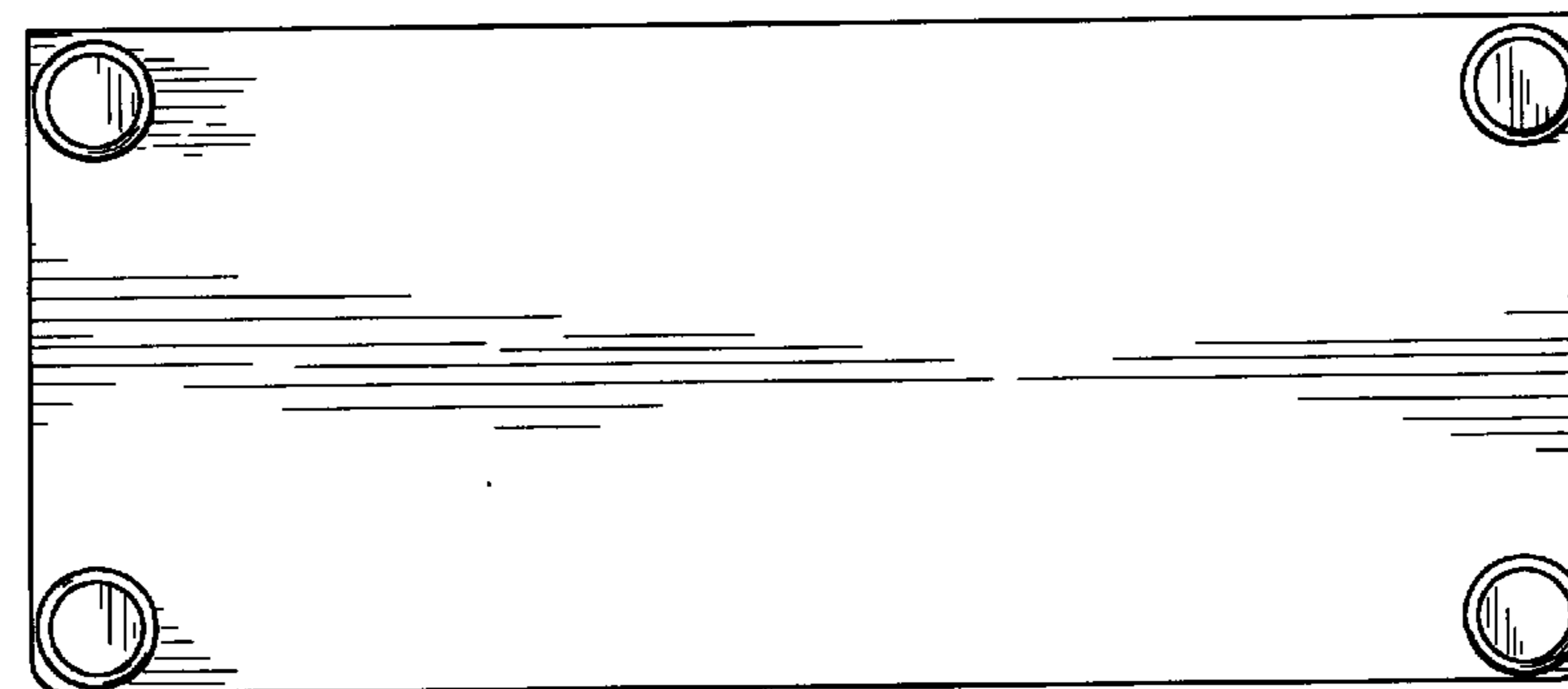
