FIG. 5 is a sectional view taken along section lines 5—5 of FIG. 2, showing the two piece construction of the insole; and,

FIG. 6 is an exploded view of the two piece insole.

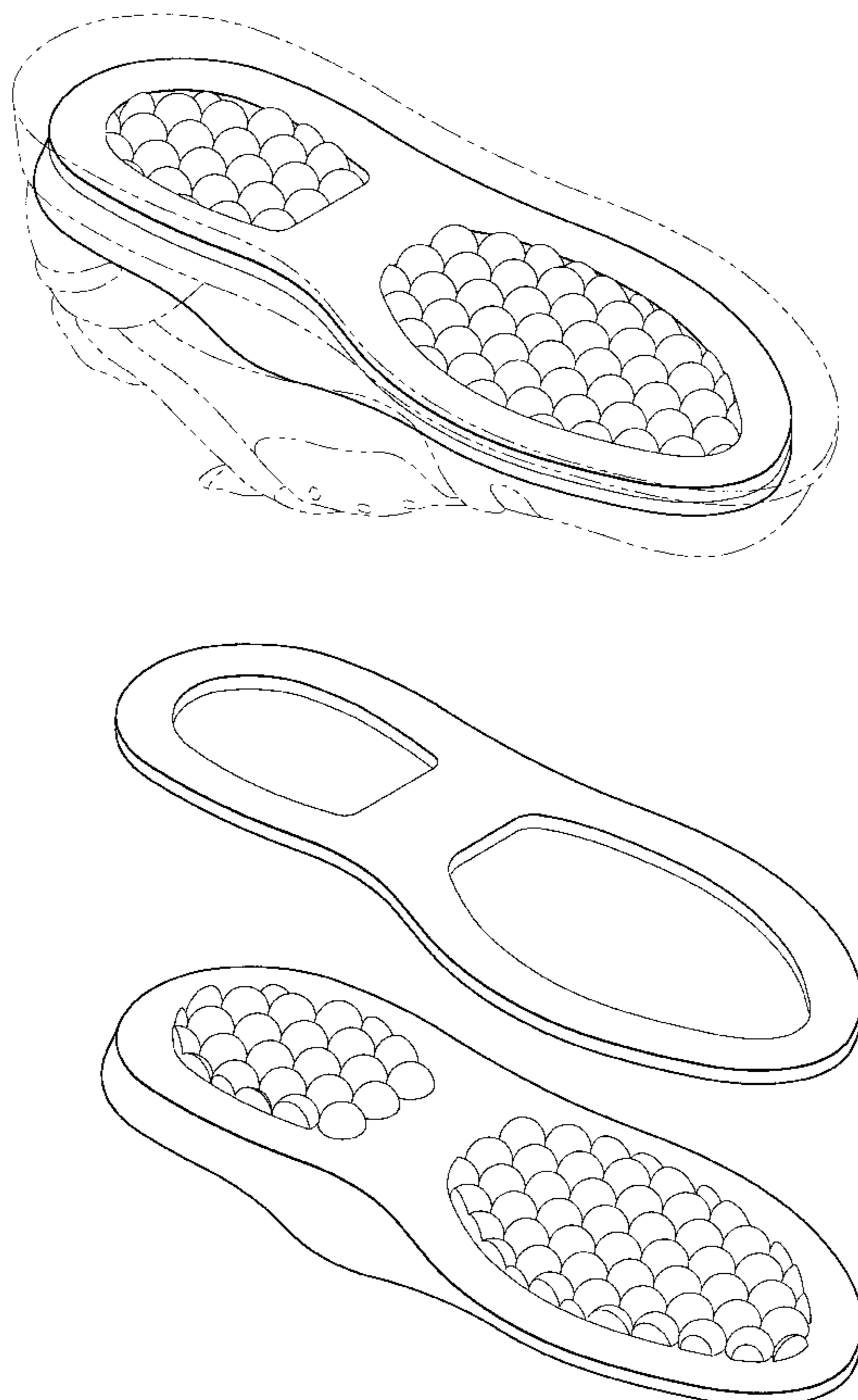
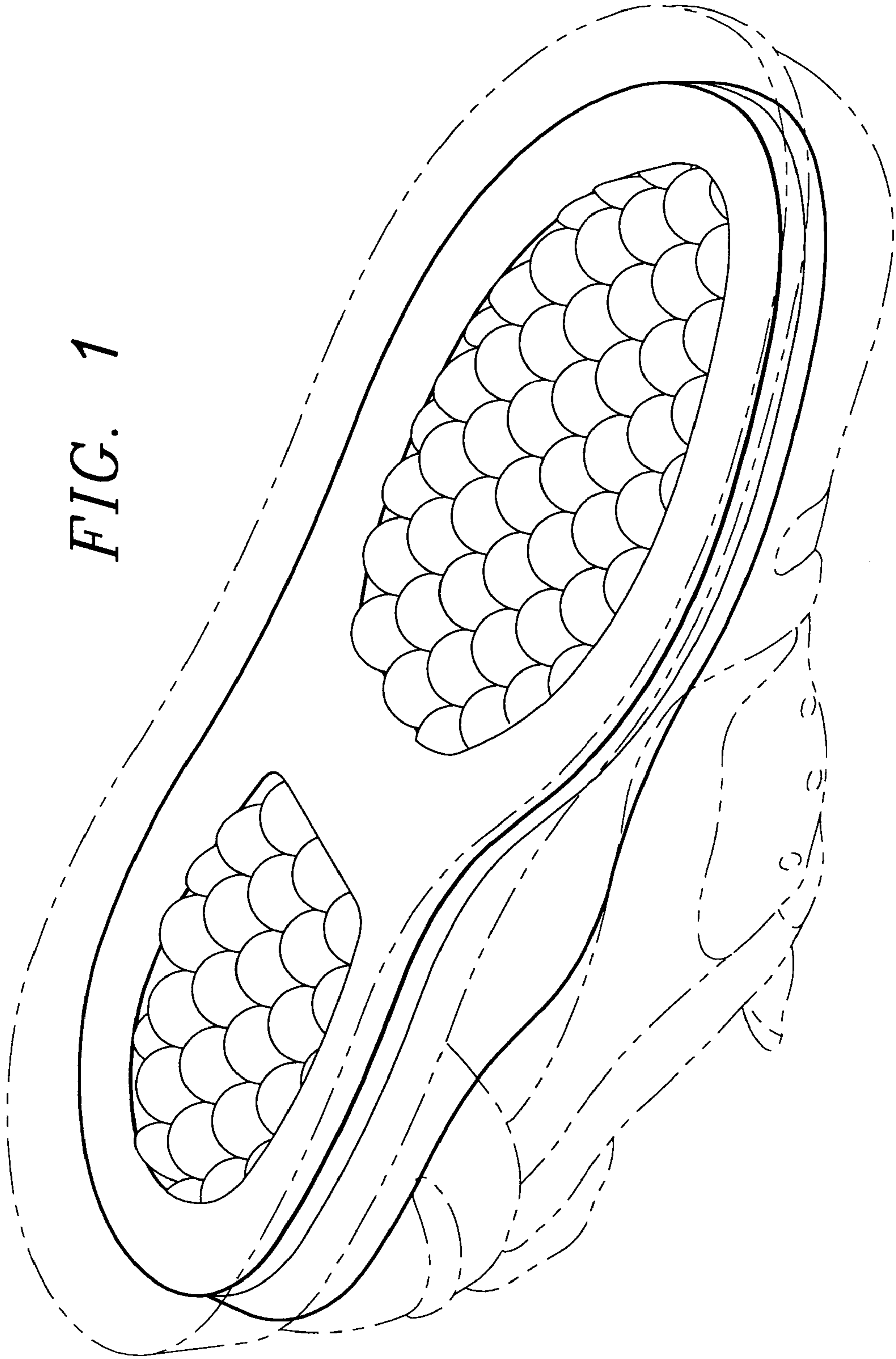

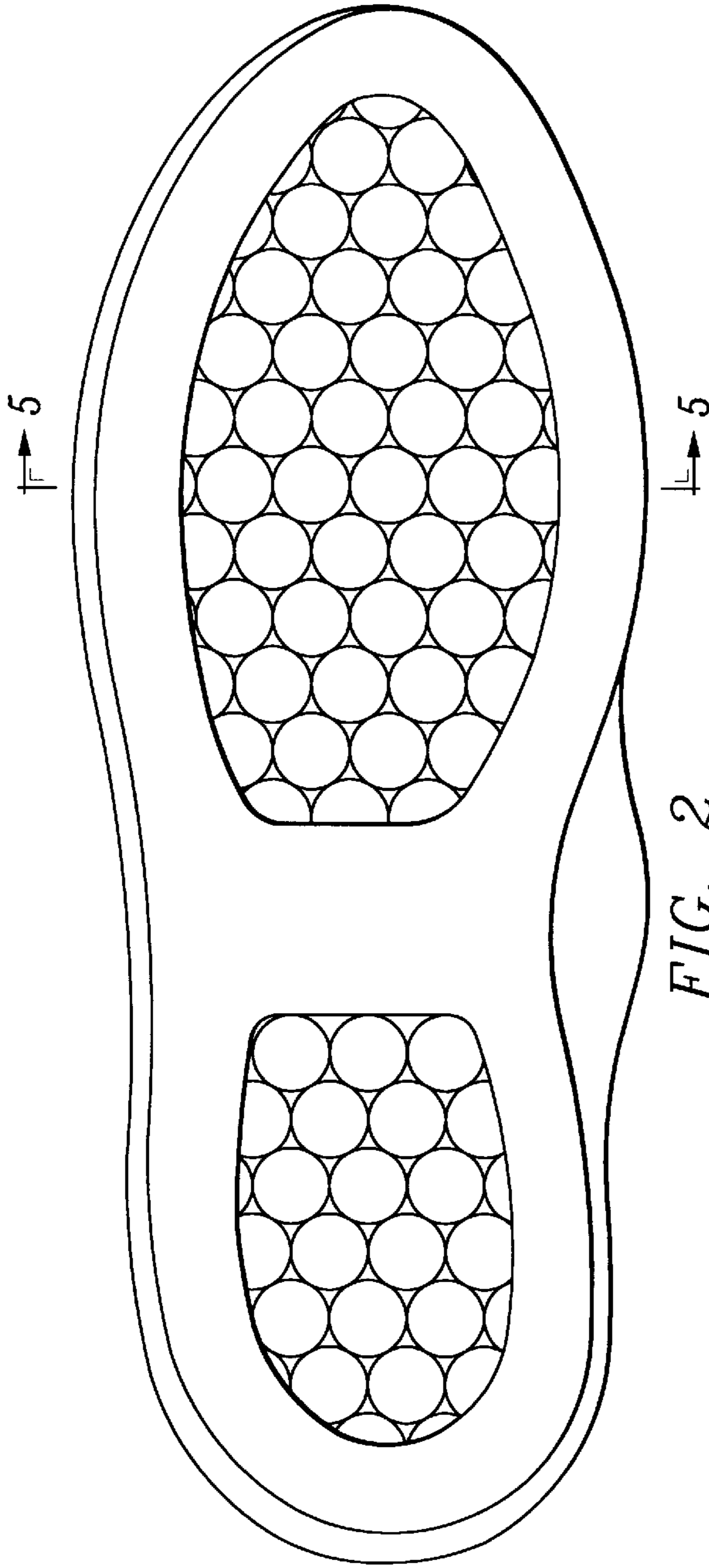

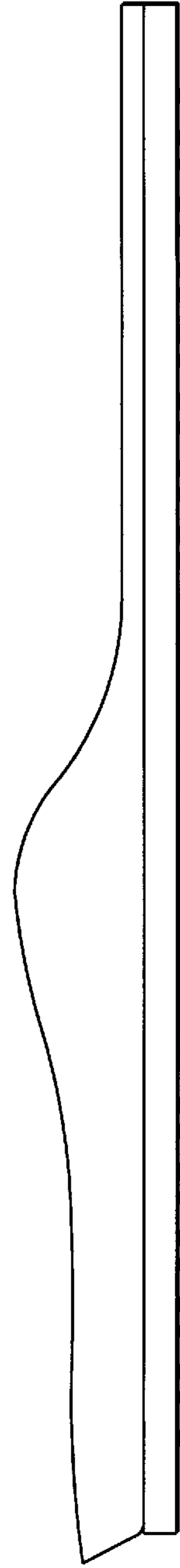

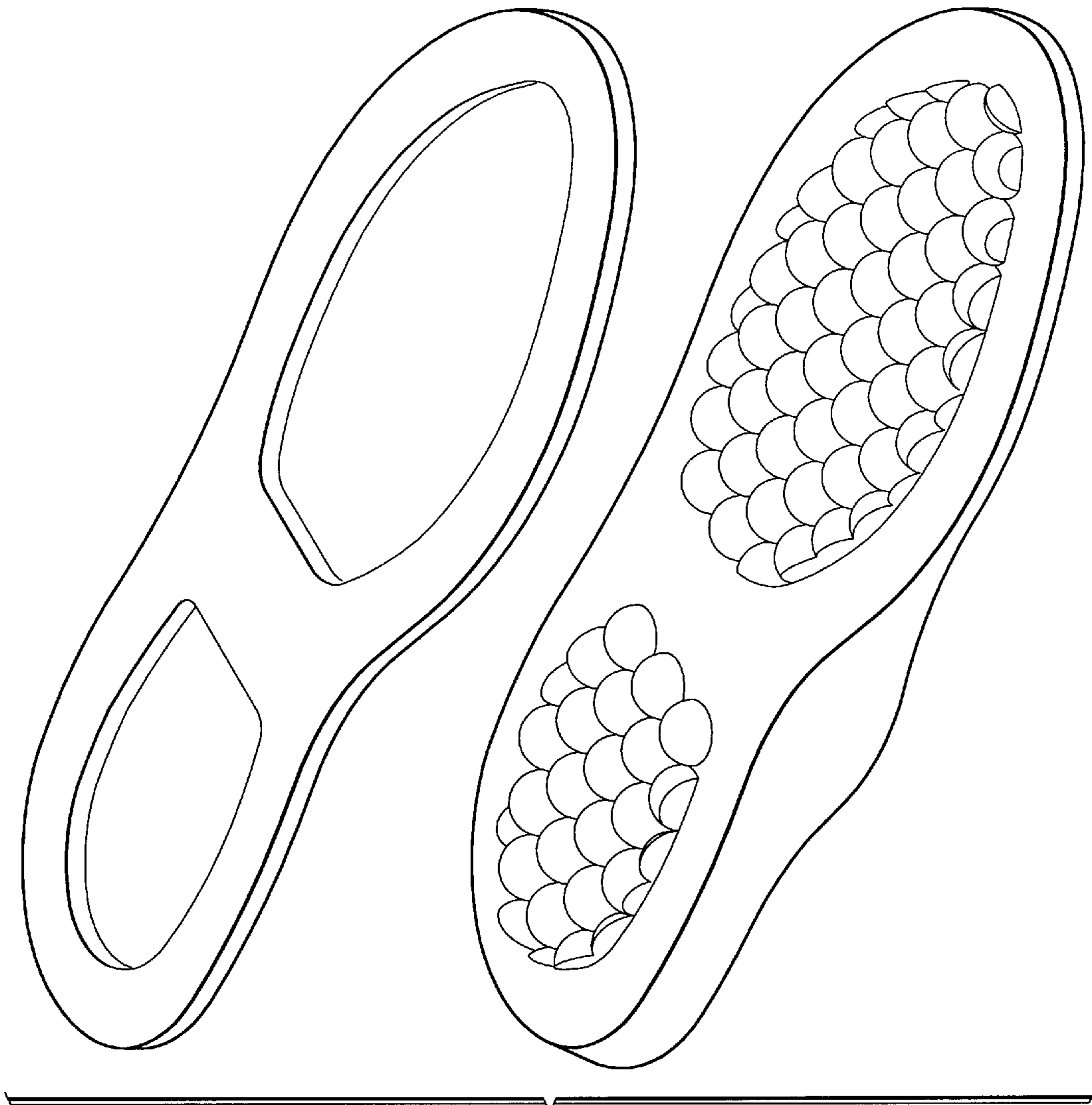
