FIG. 9 is a front elevational view thereof; and,

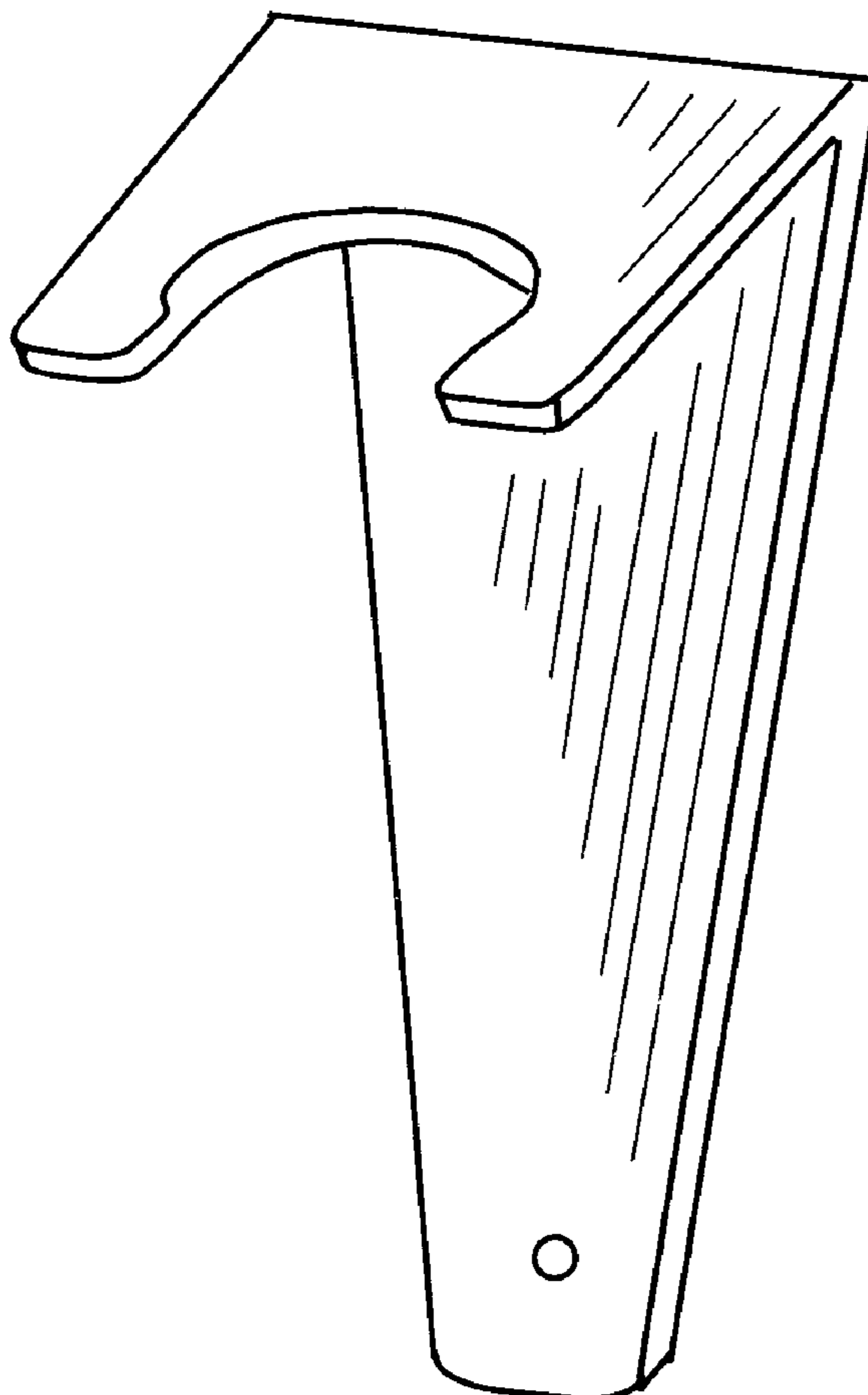
FIG. 10 is a perspective view thereof.

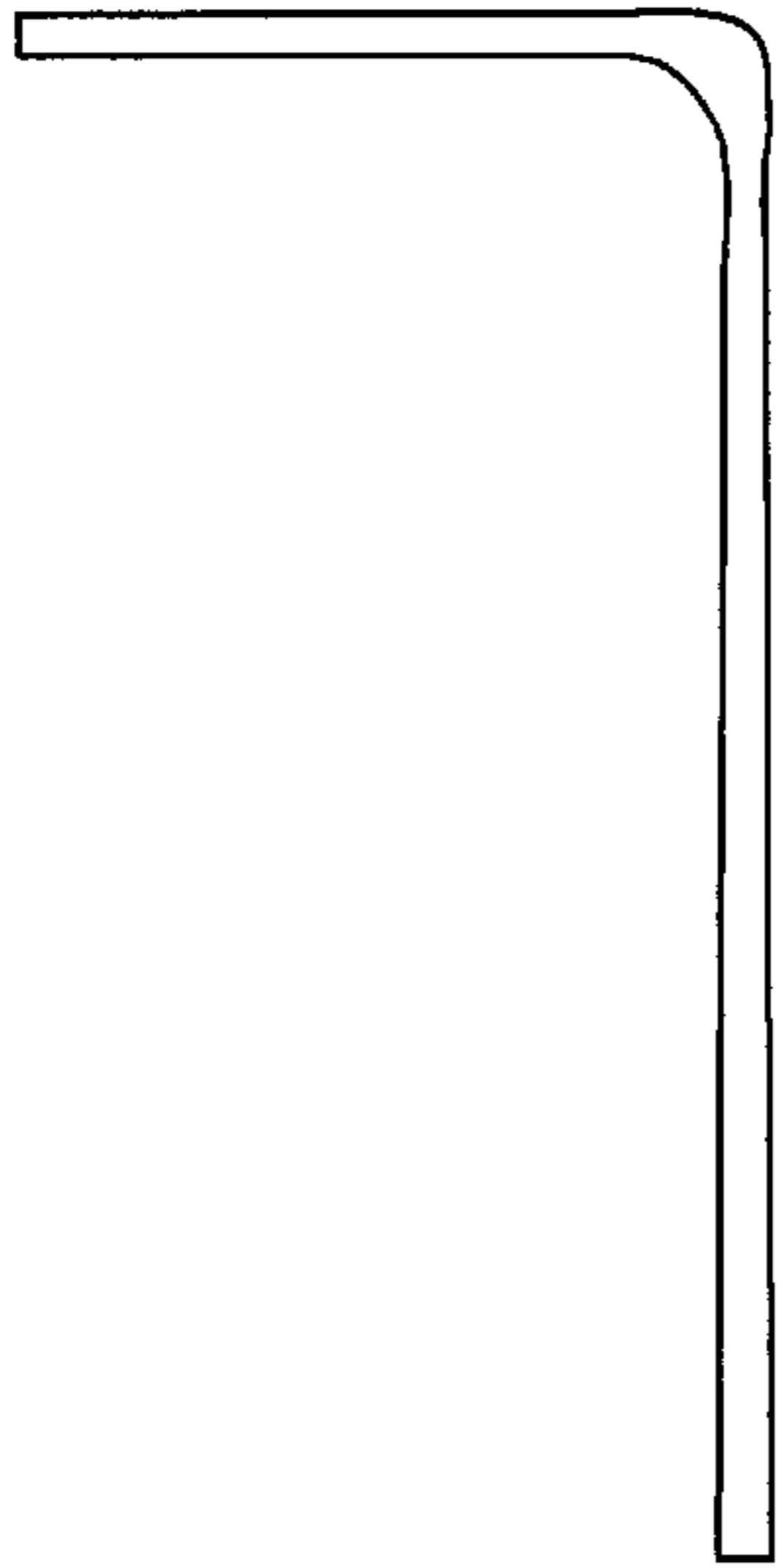

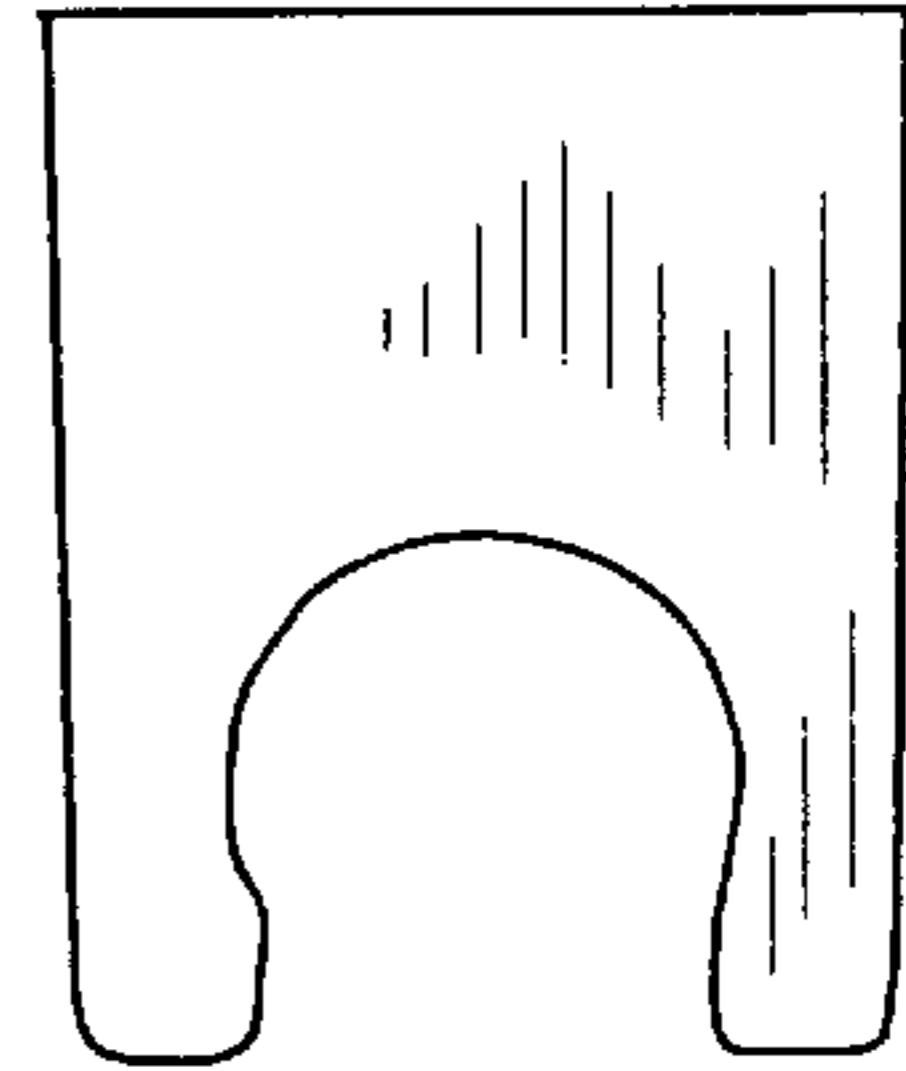

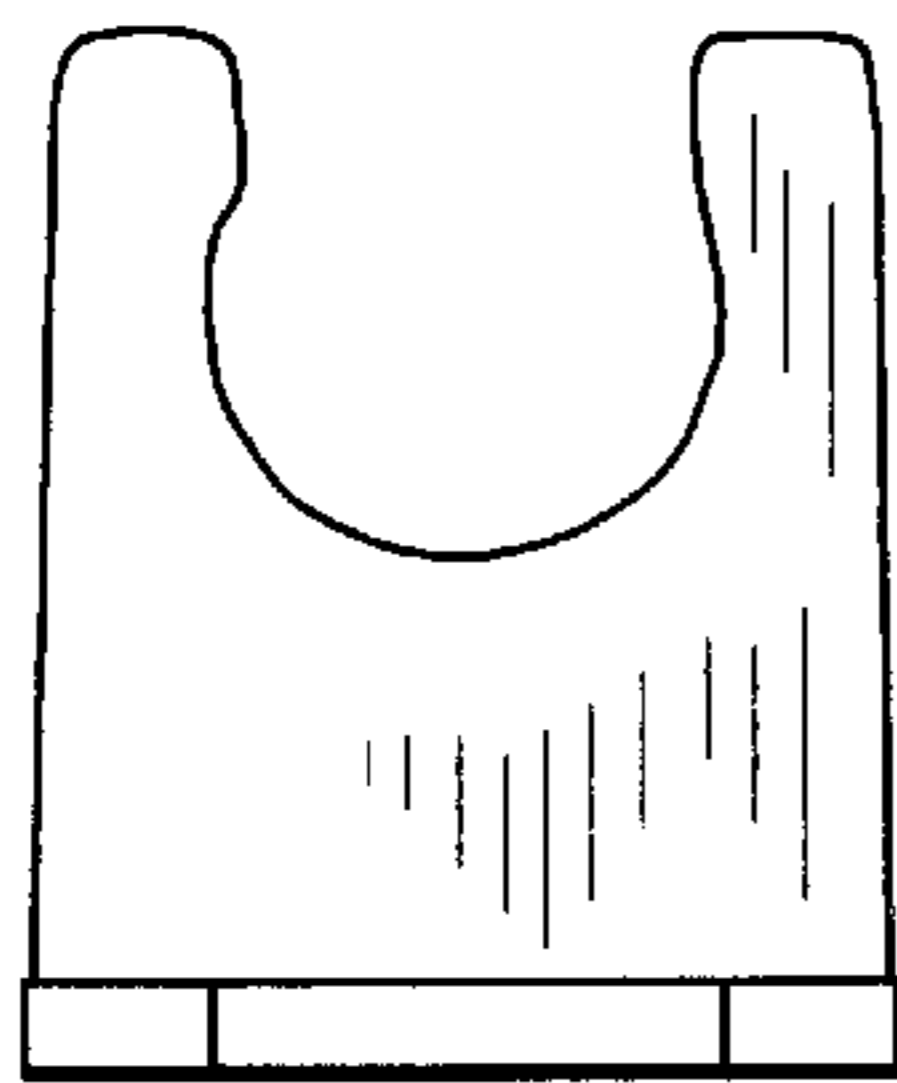

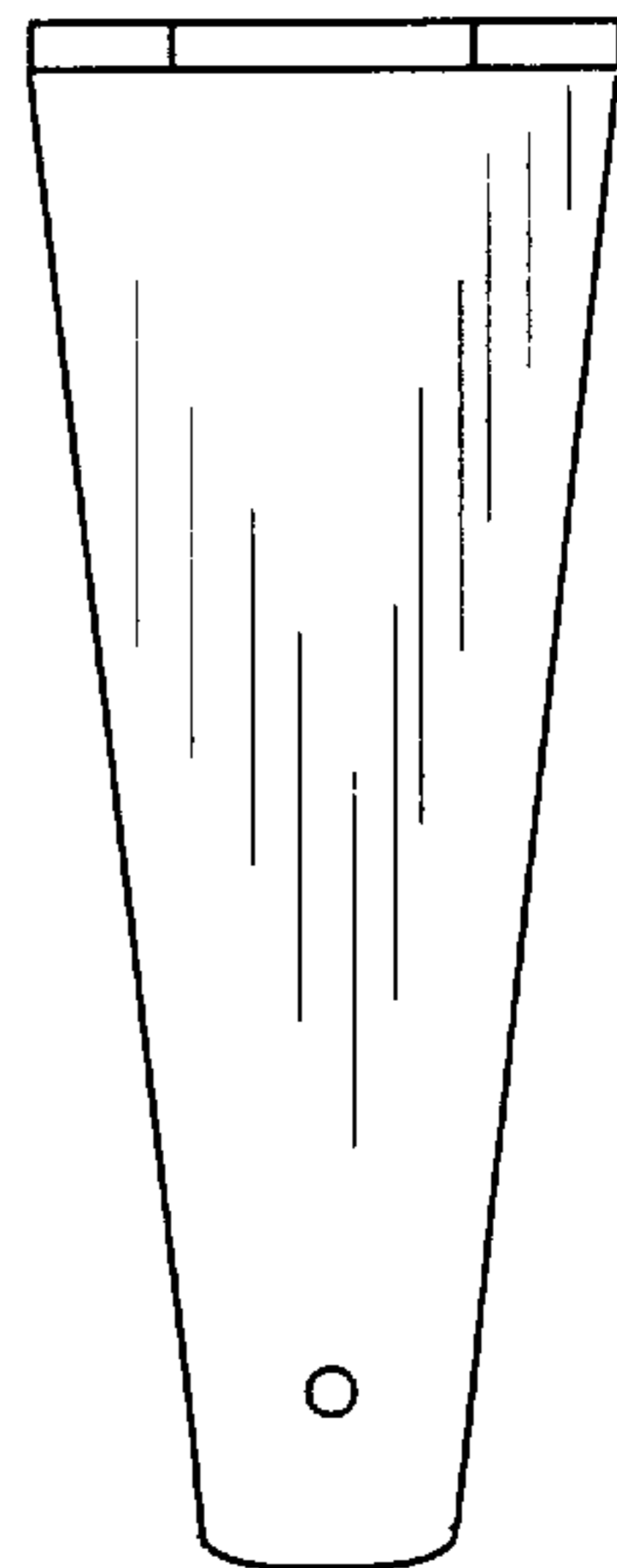
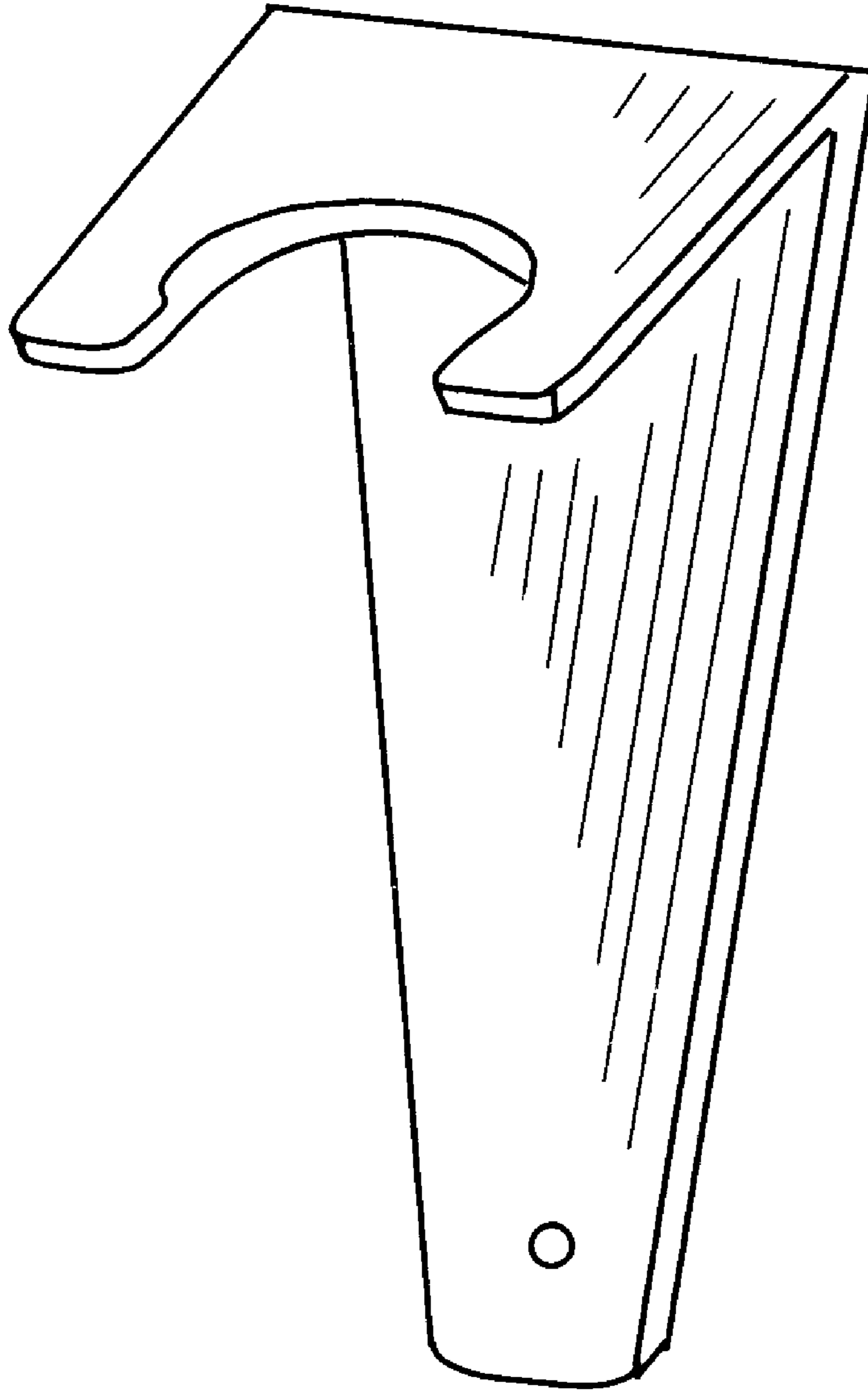

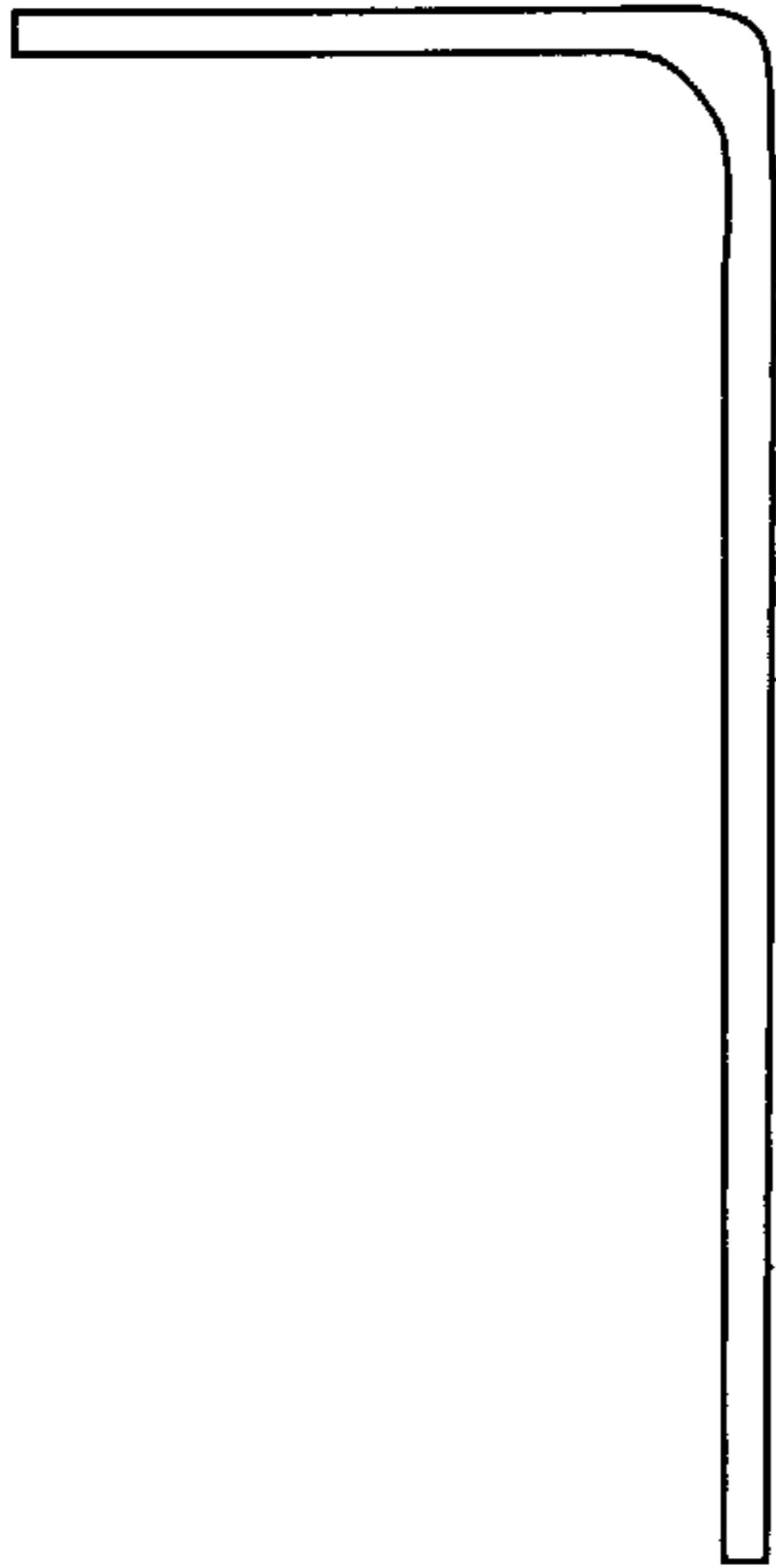

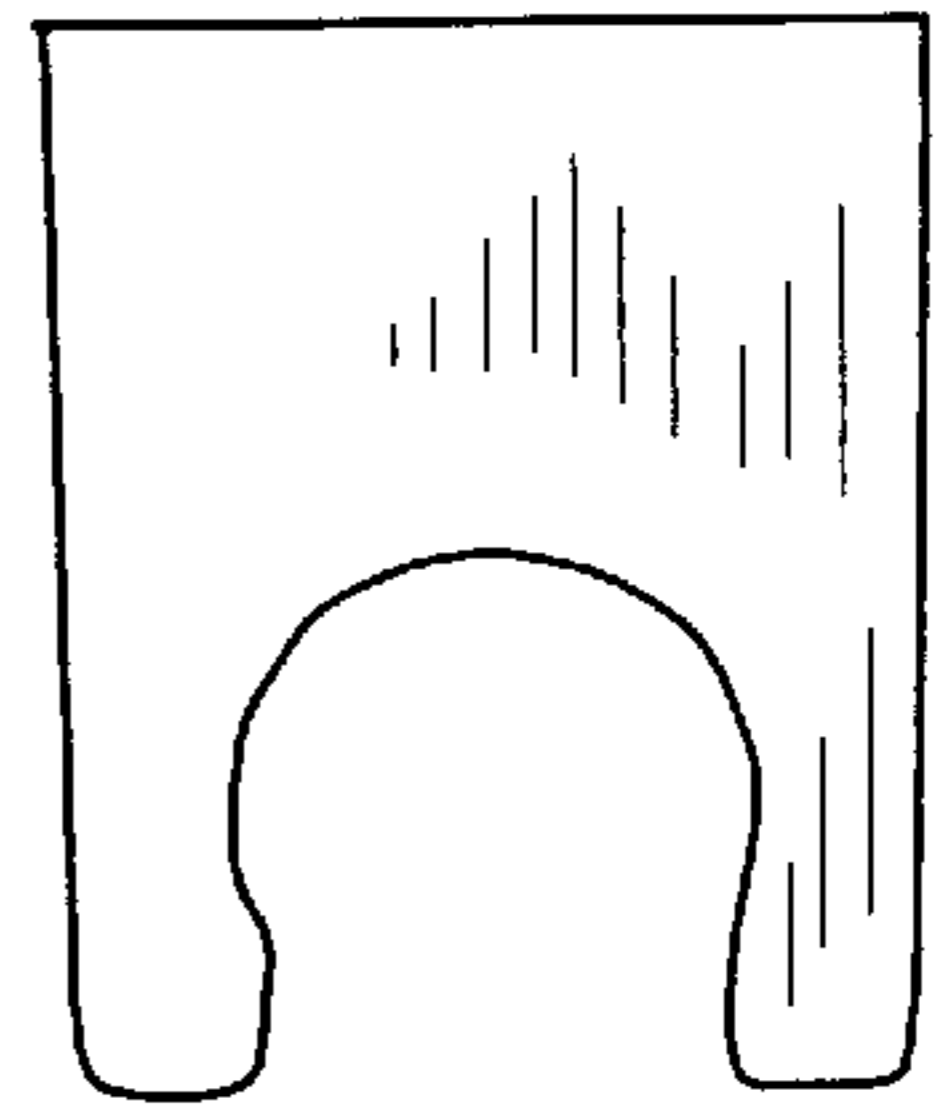

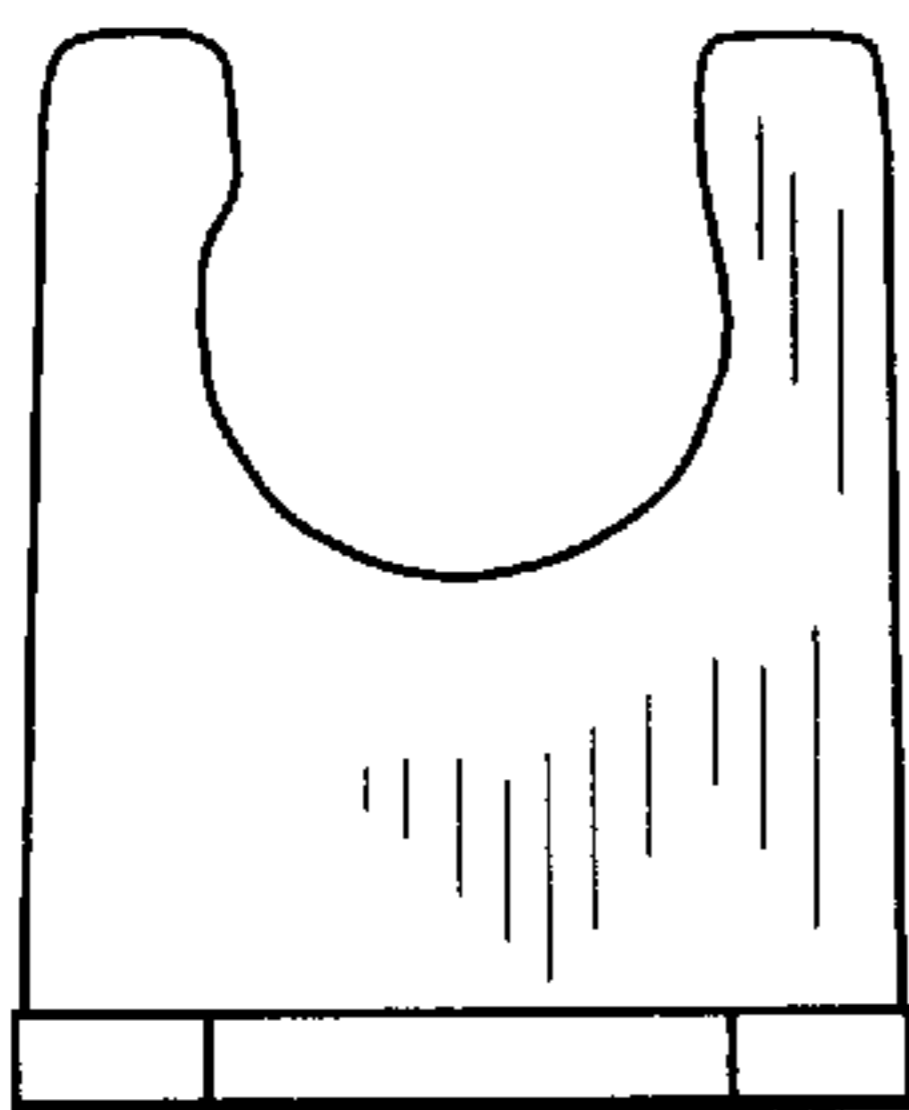

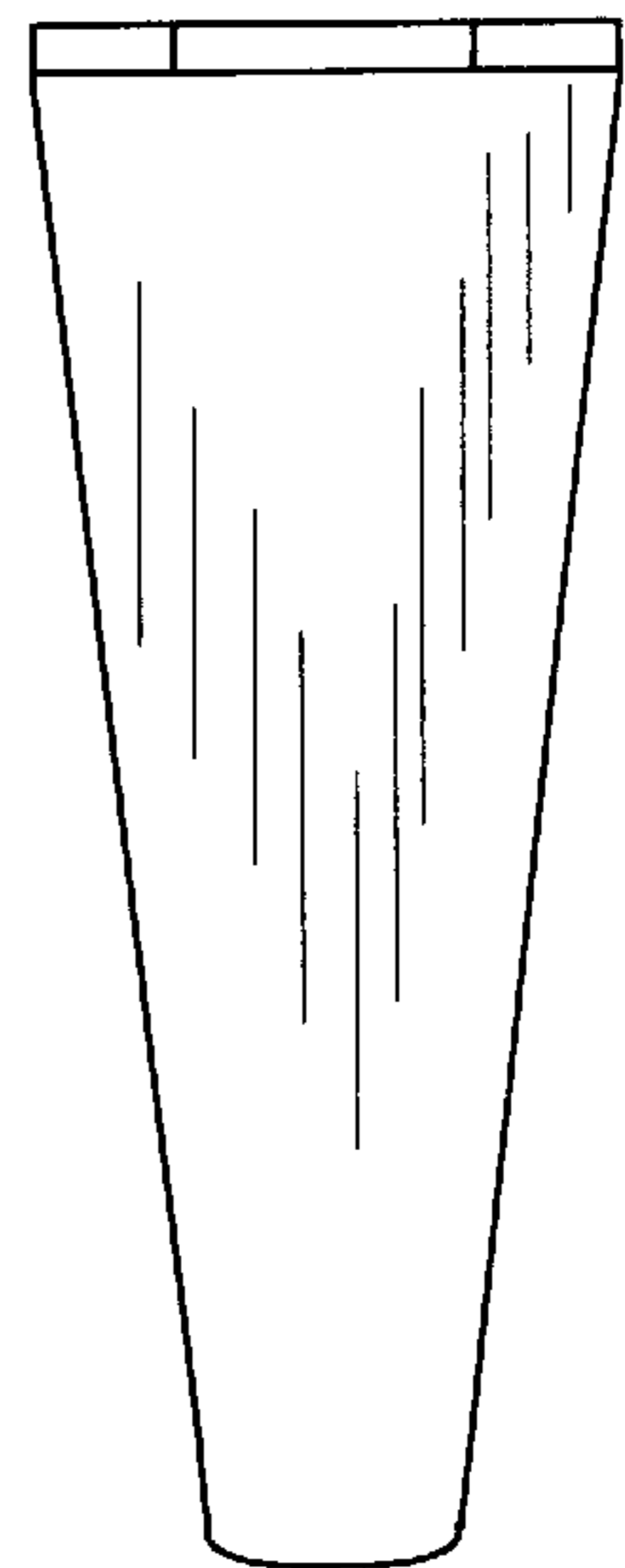
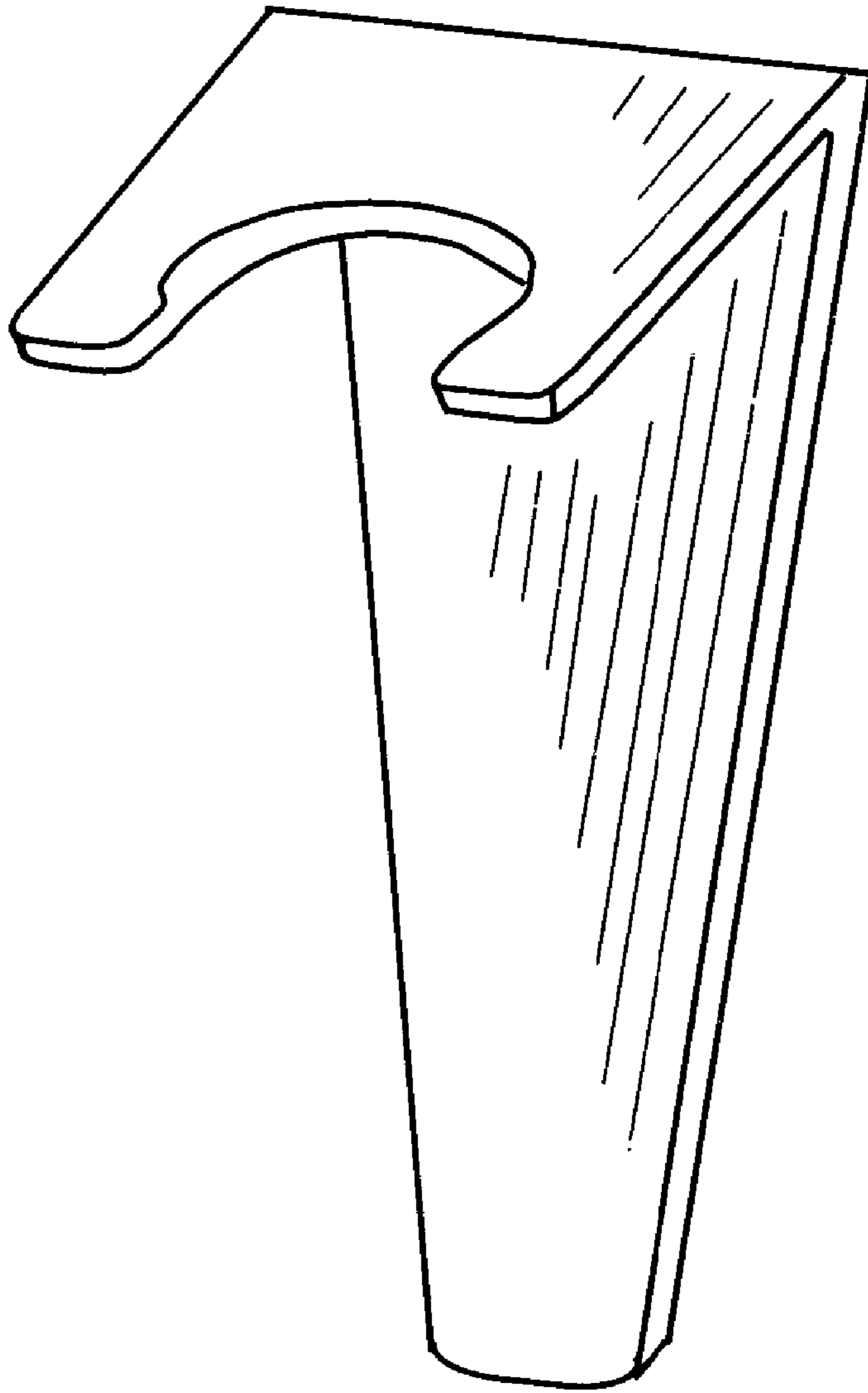
