DESCRIPTION

FIG. 1 is a perspective view of a garment divider according to the present design.

FIG. 2 is a top plan view of the garment divider of FIG. 1.

FIG. 3 is a front elevational view of the garment divider of FIG. 1.

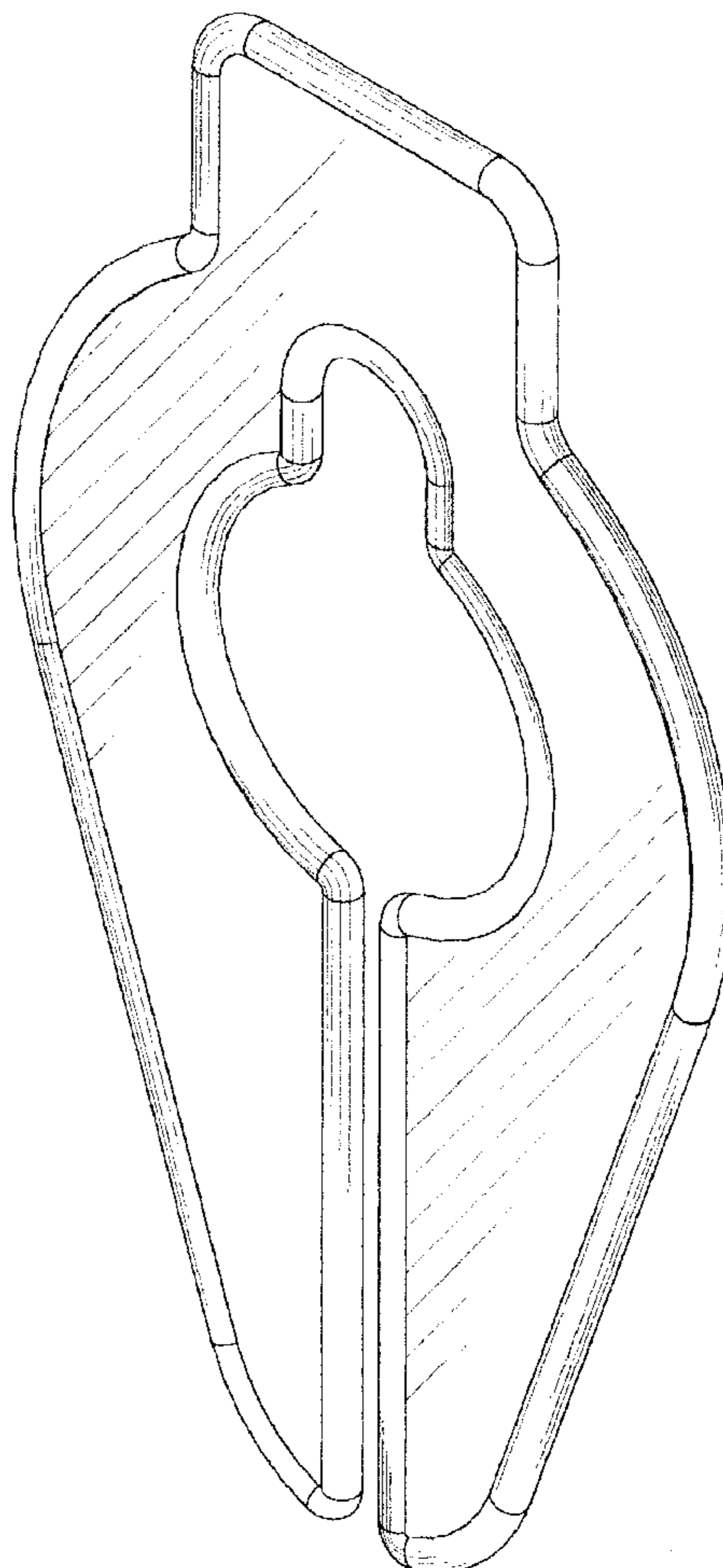
FIG. 4 is a bottom plan view of the garment divider of FIG. 1.

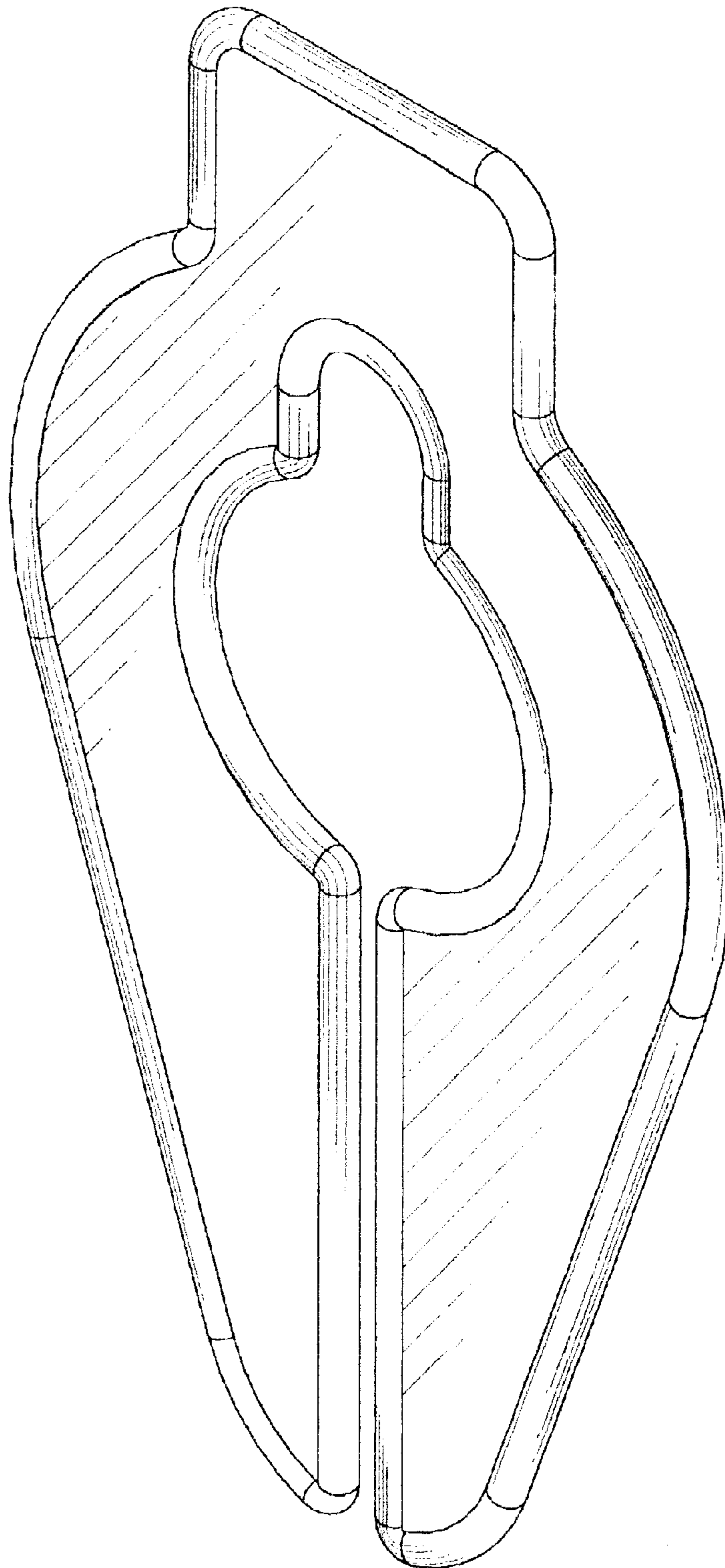

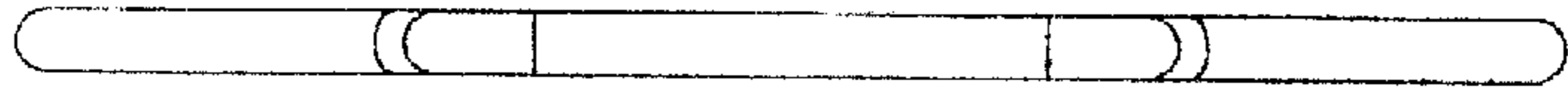

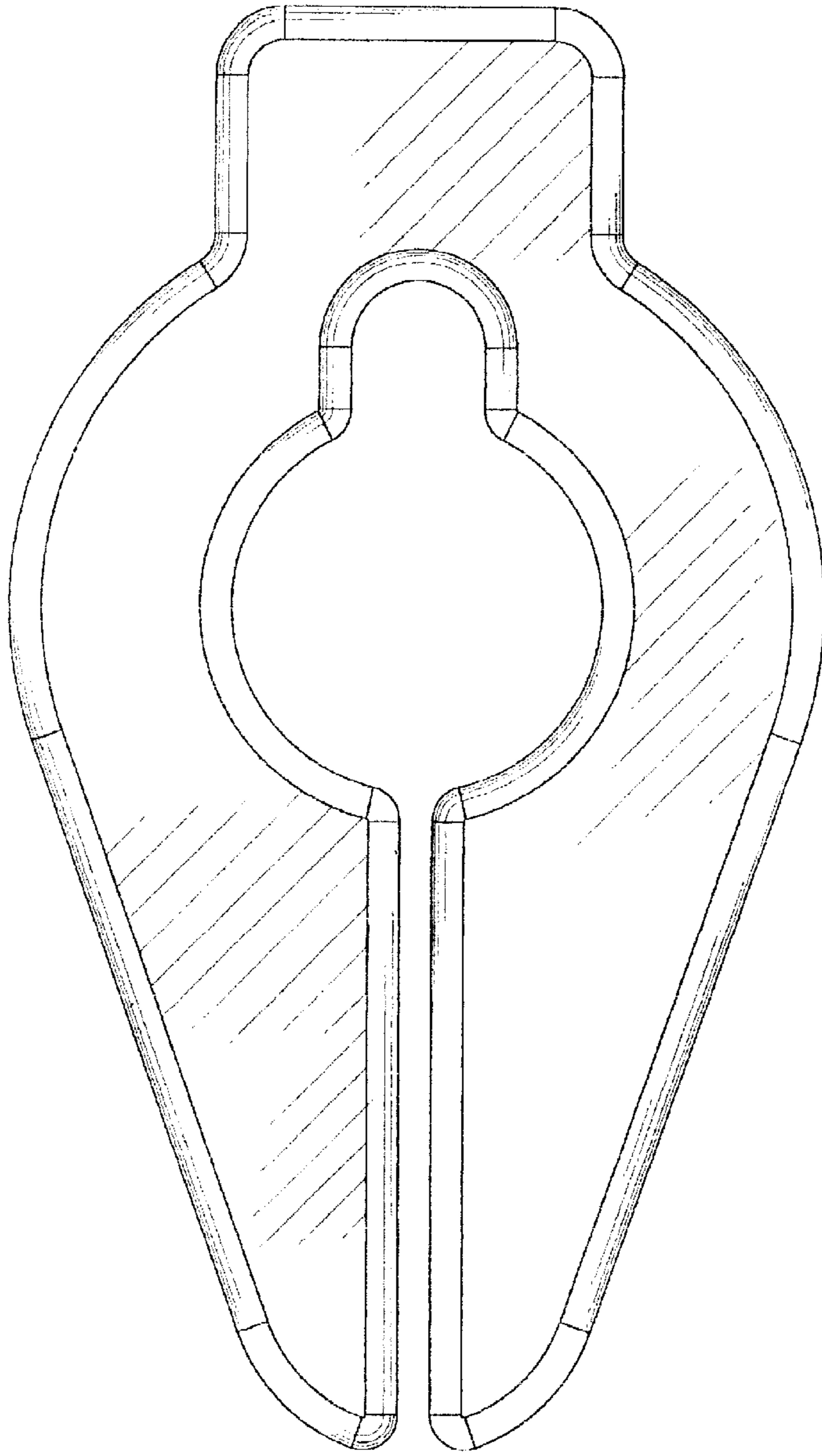

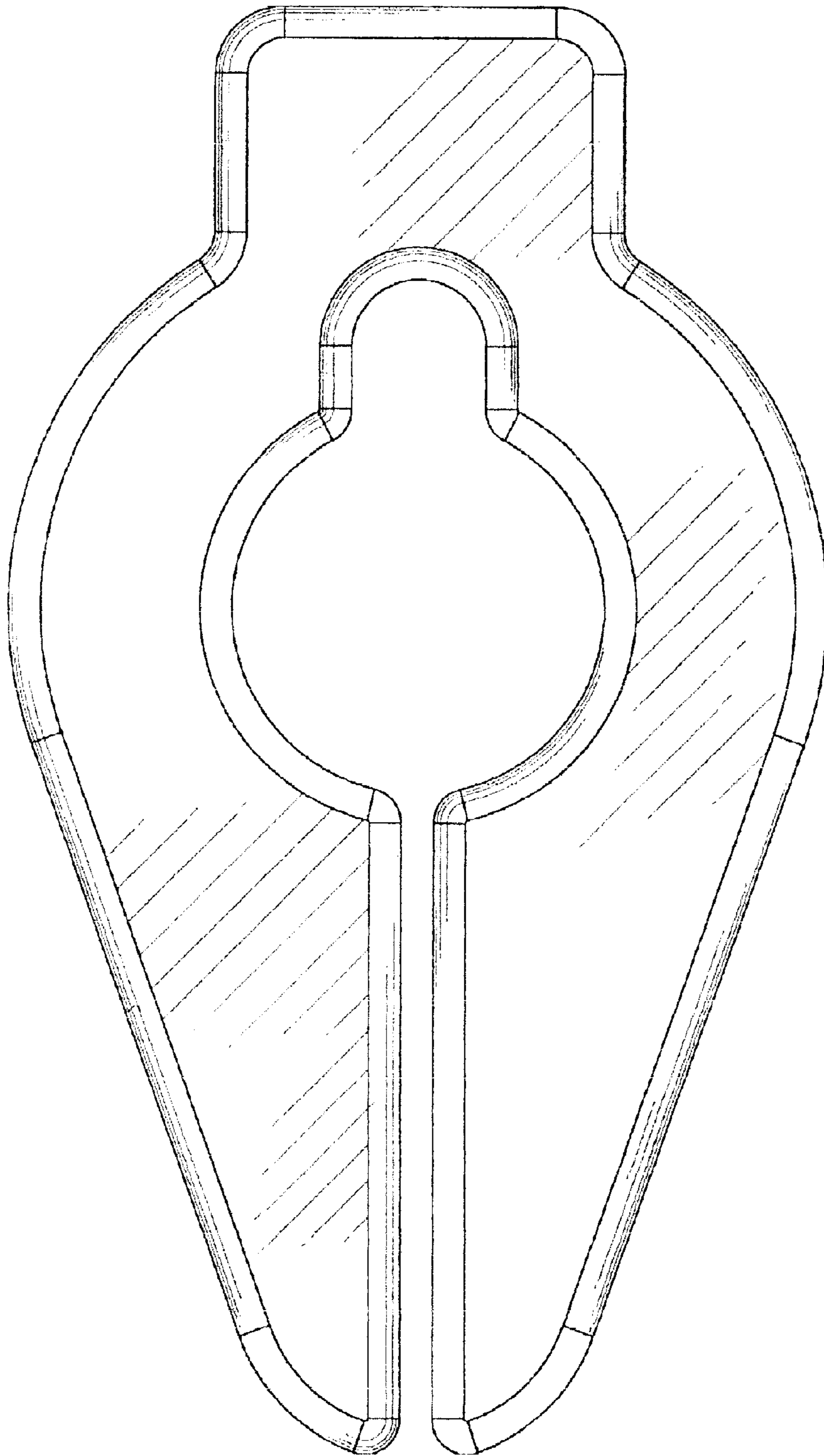
