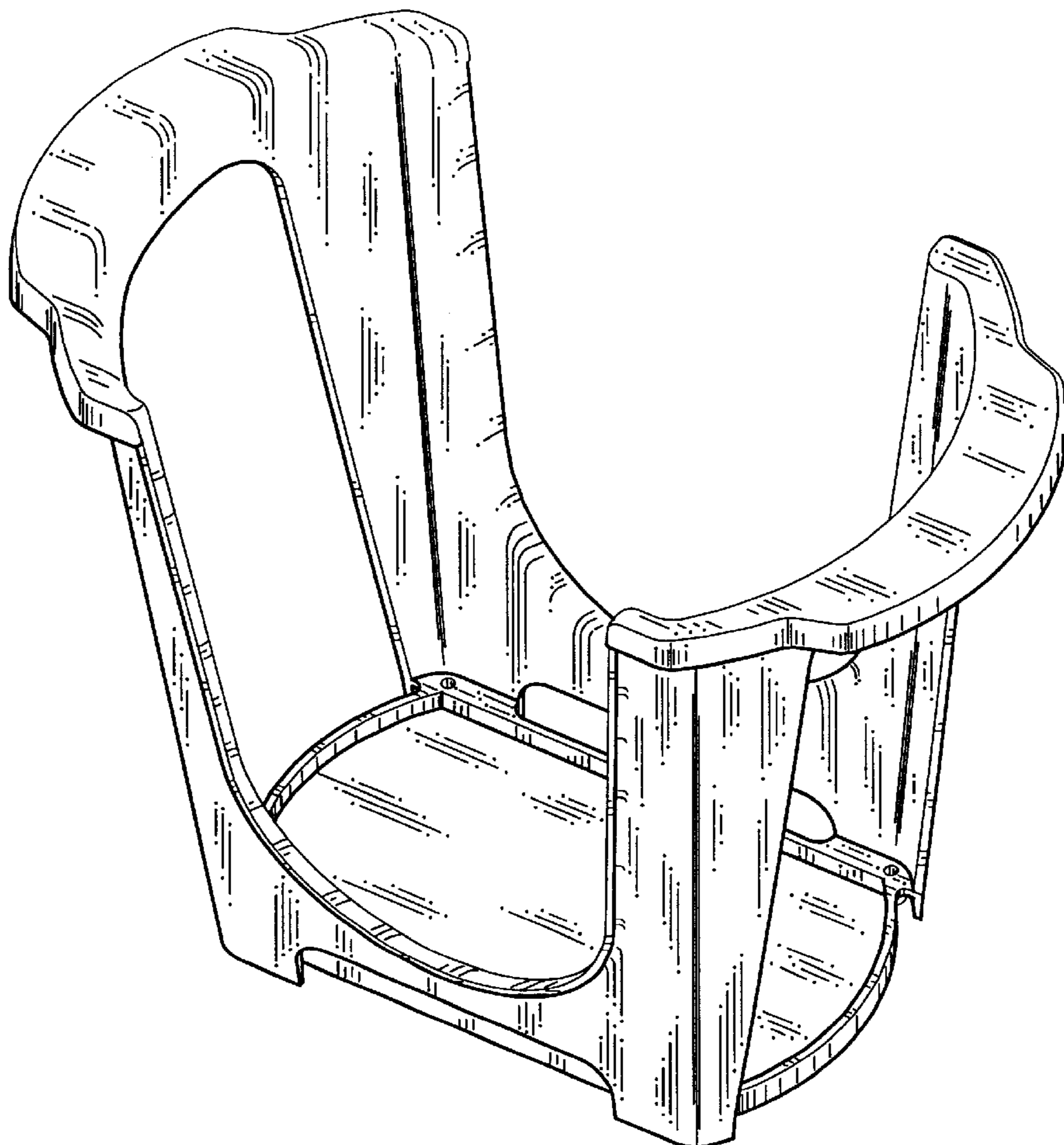

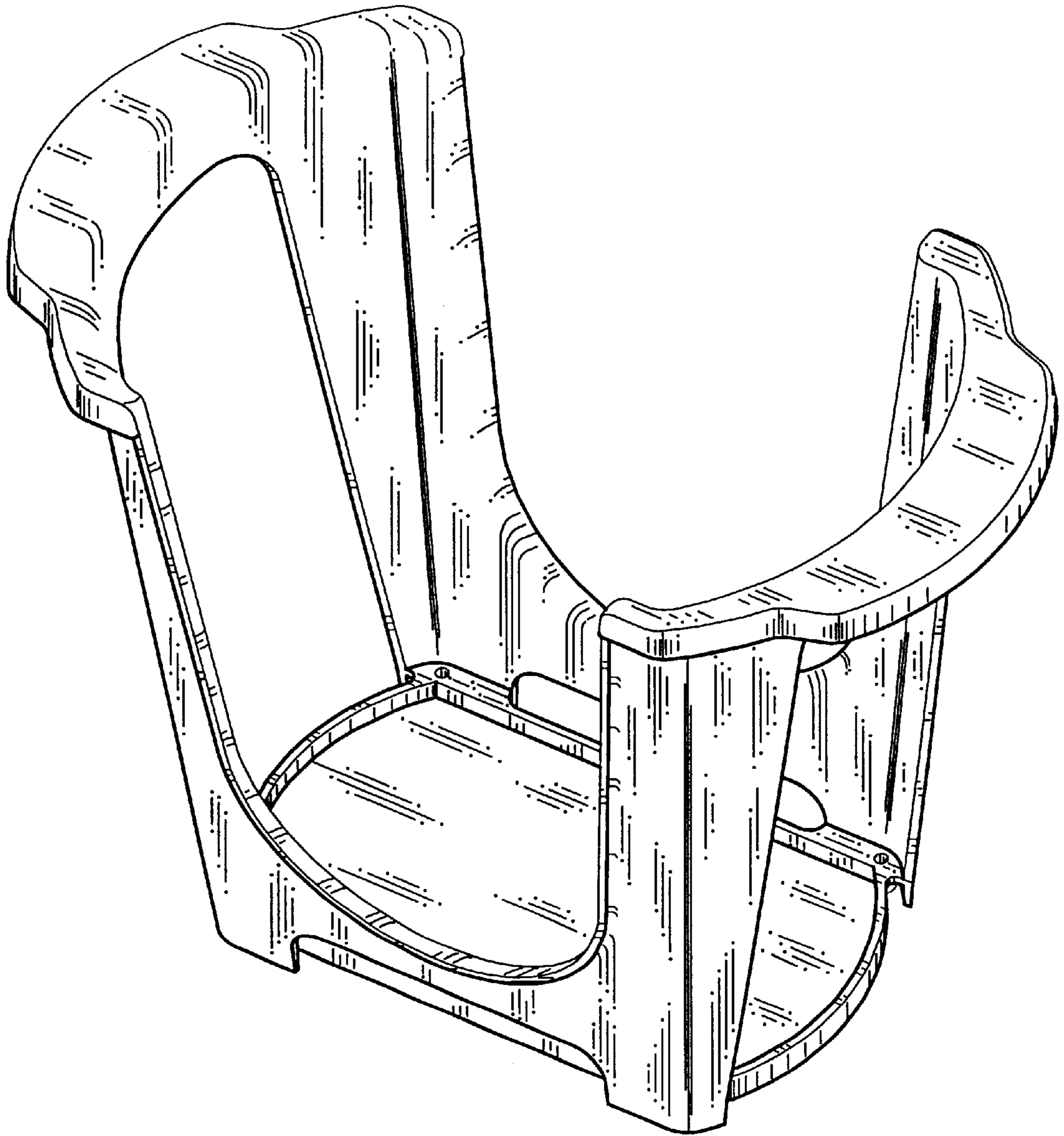
The ornamental design for an apparatus for holding a plastic bag, as shown and described.

**DESCRIPTION**

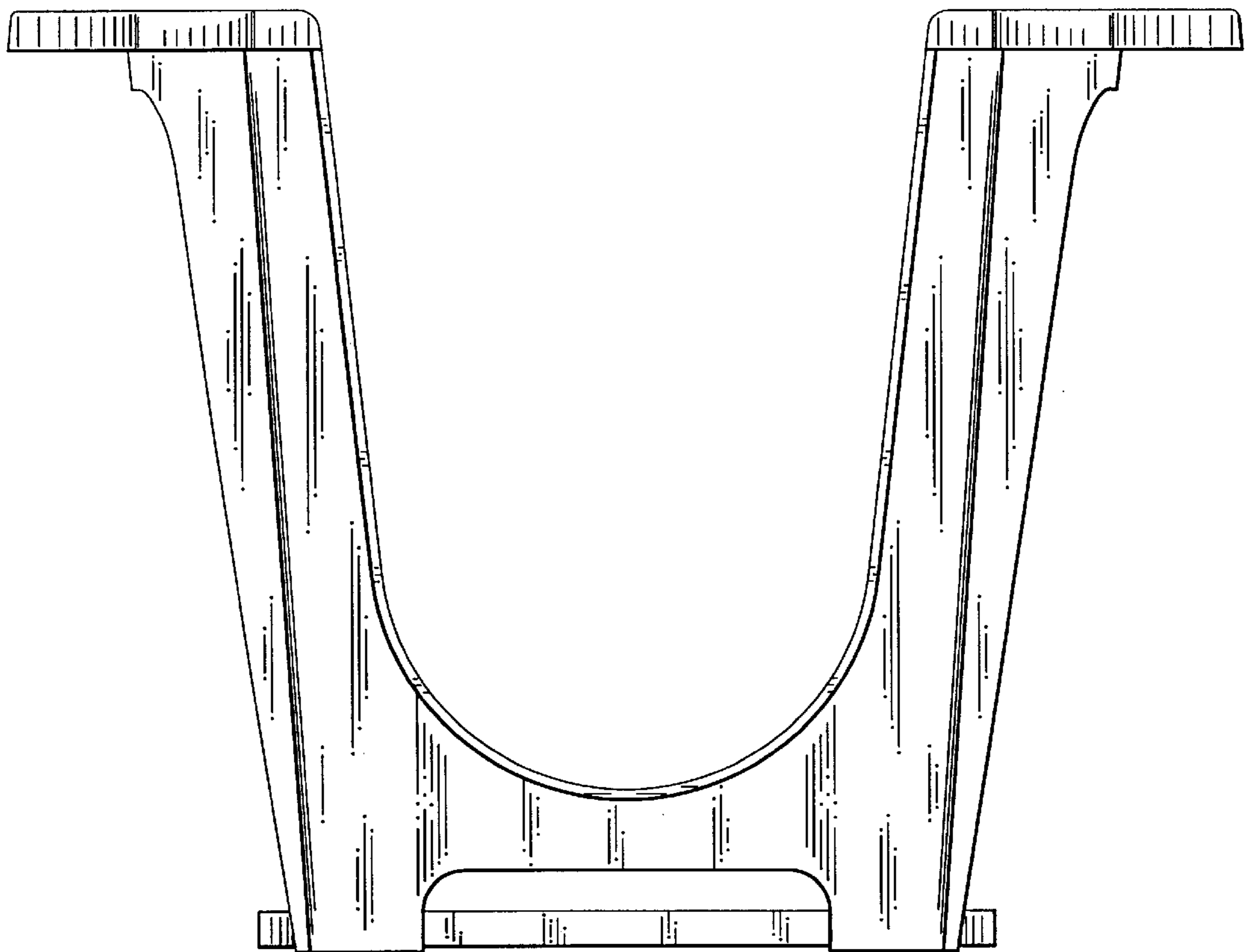

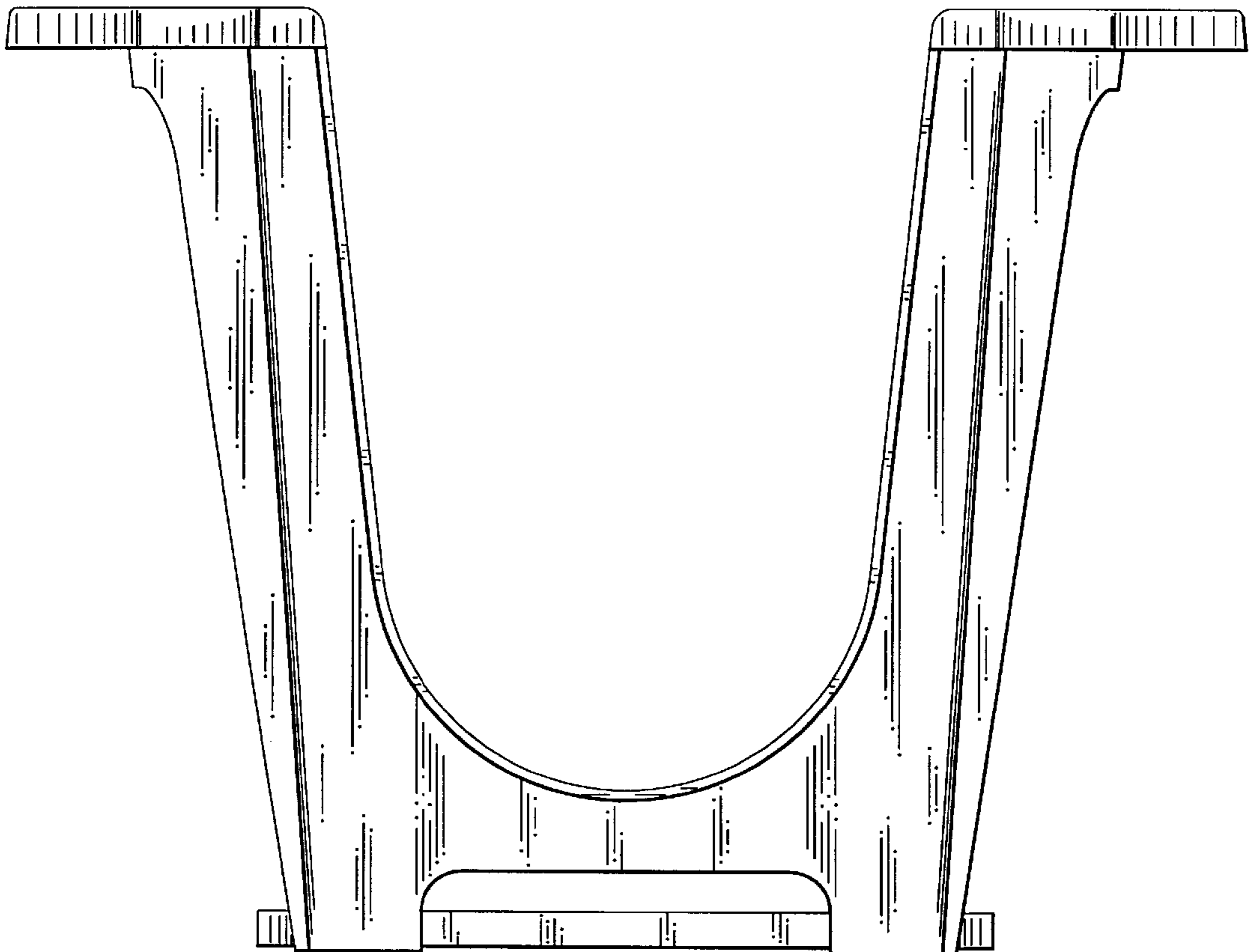

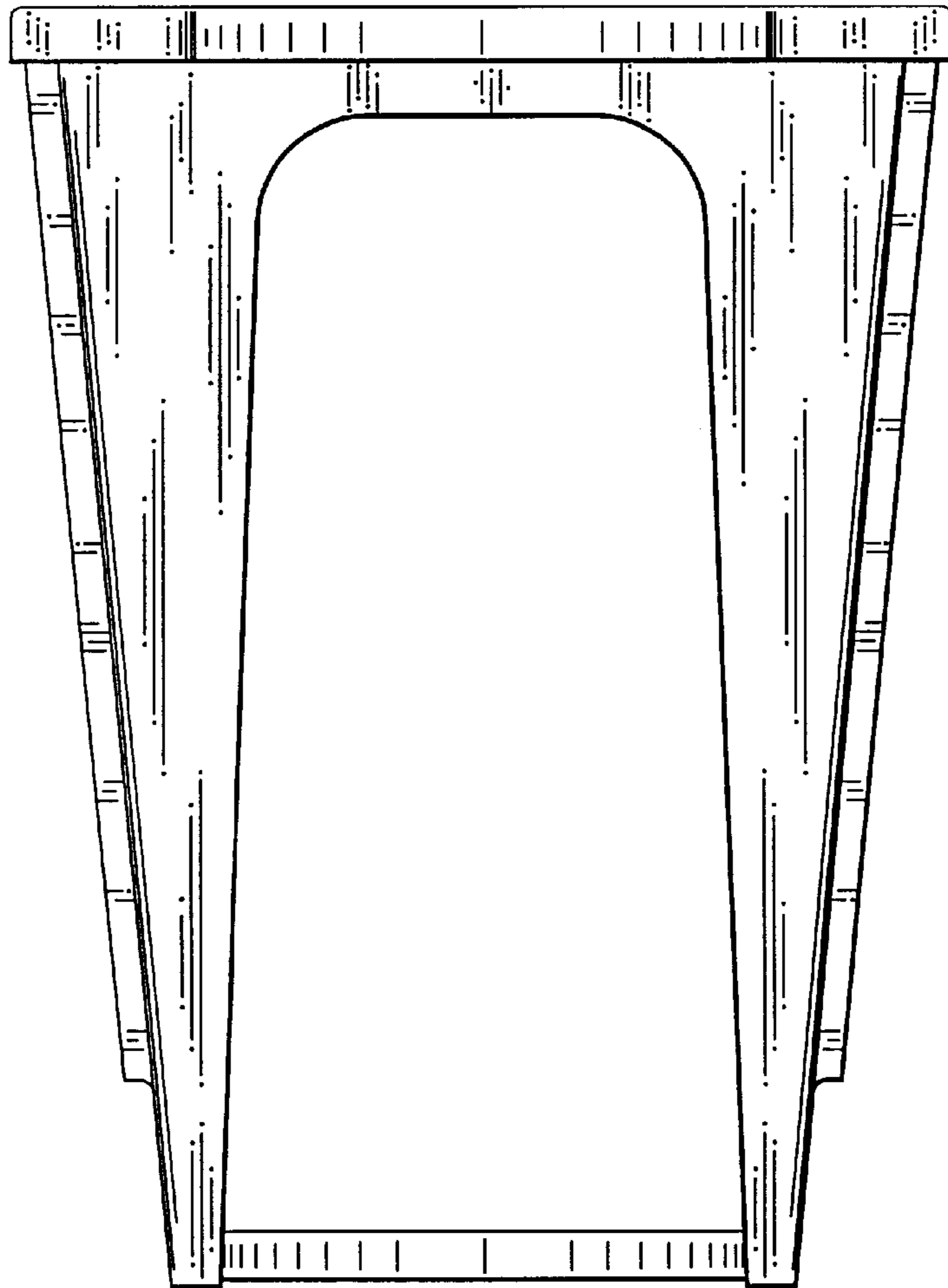

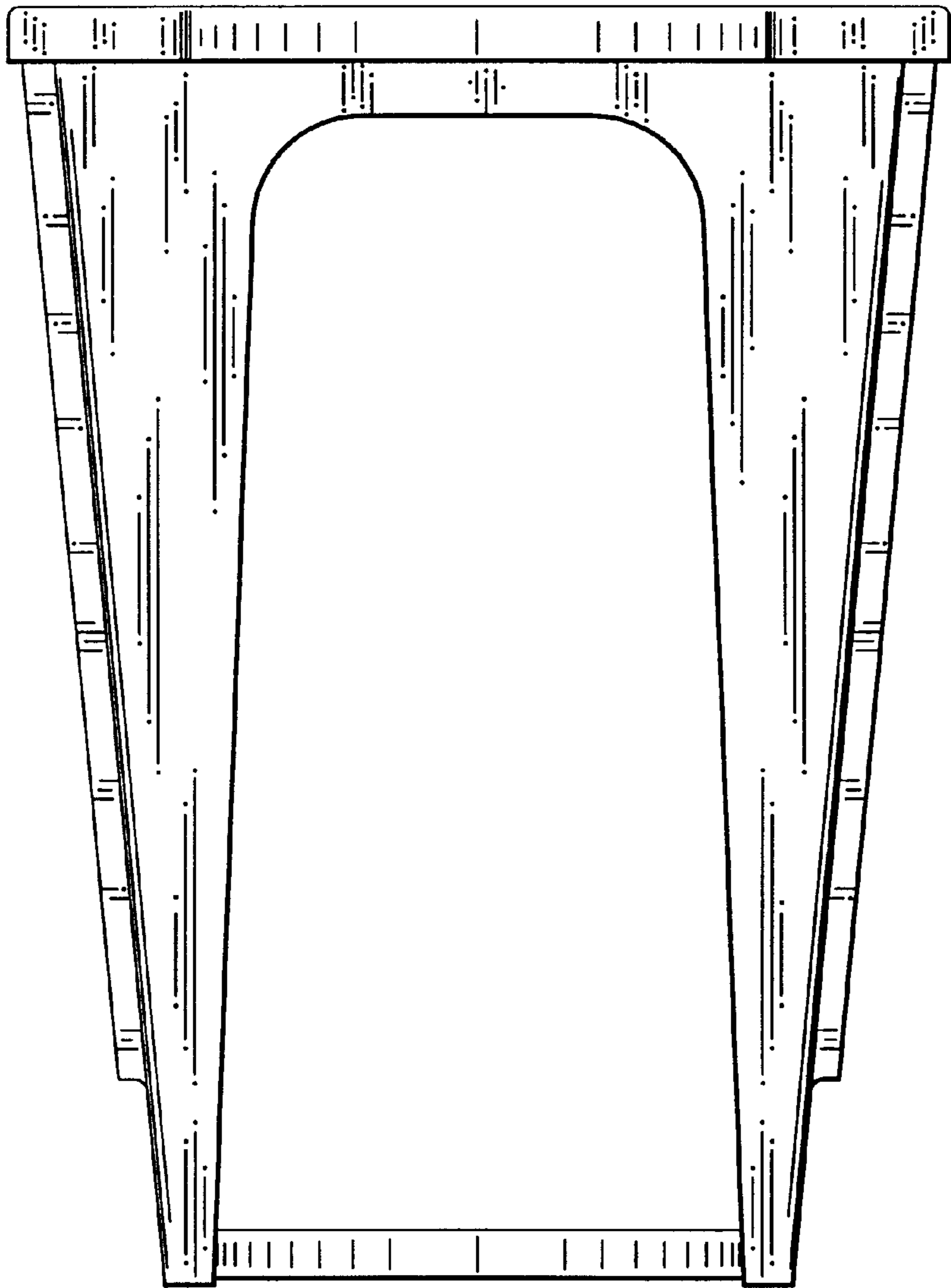

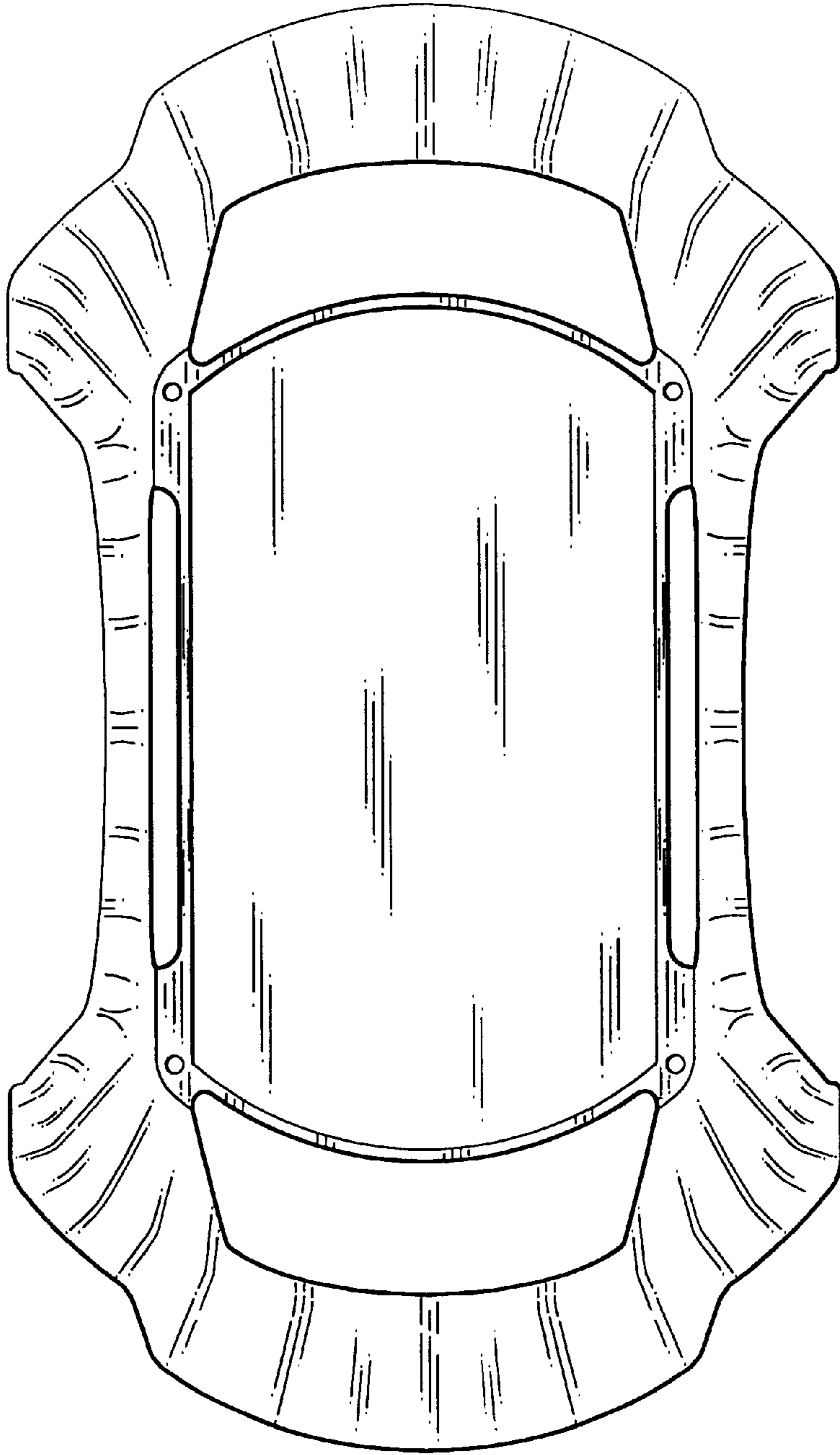

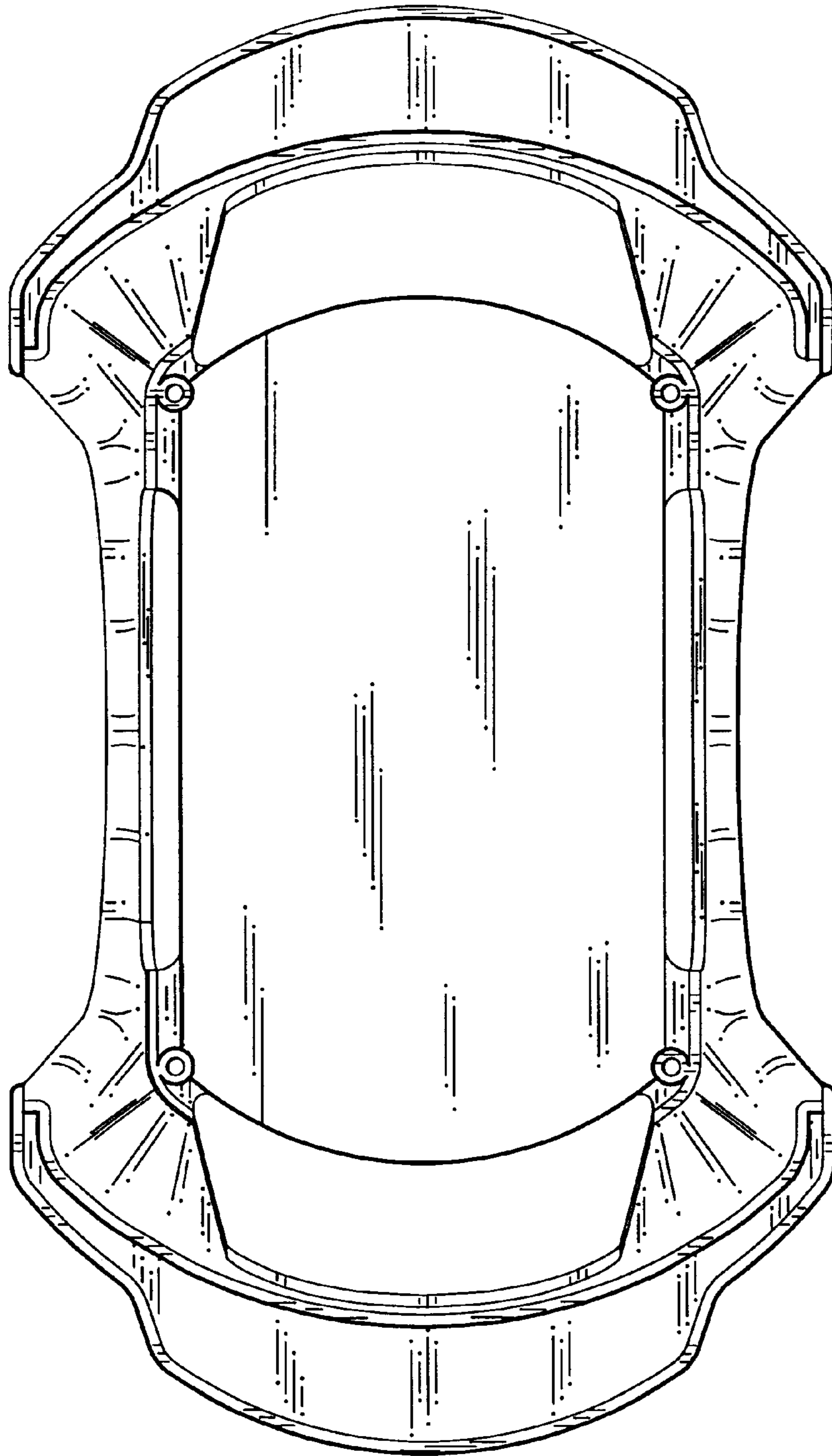
