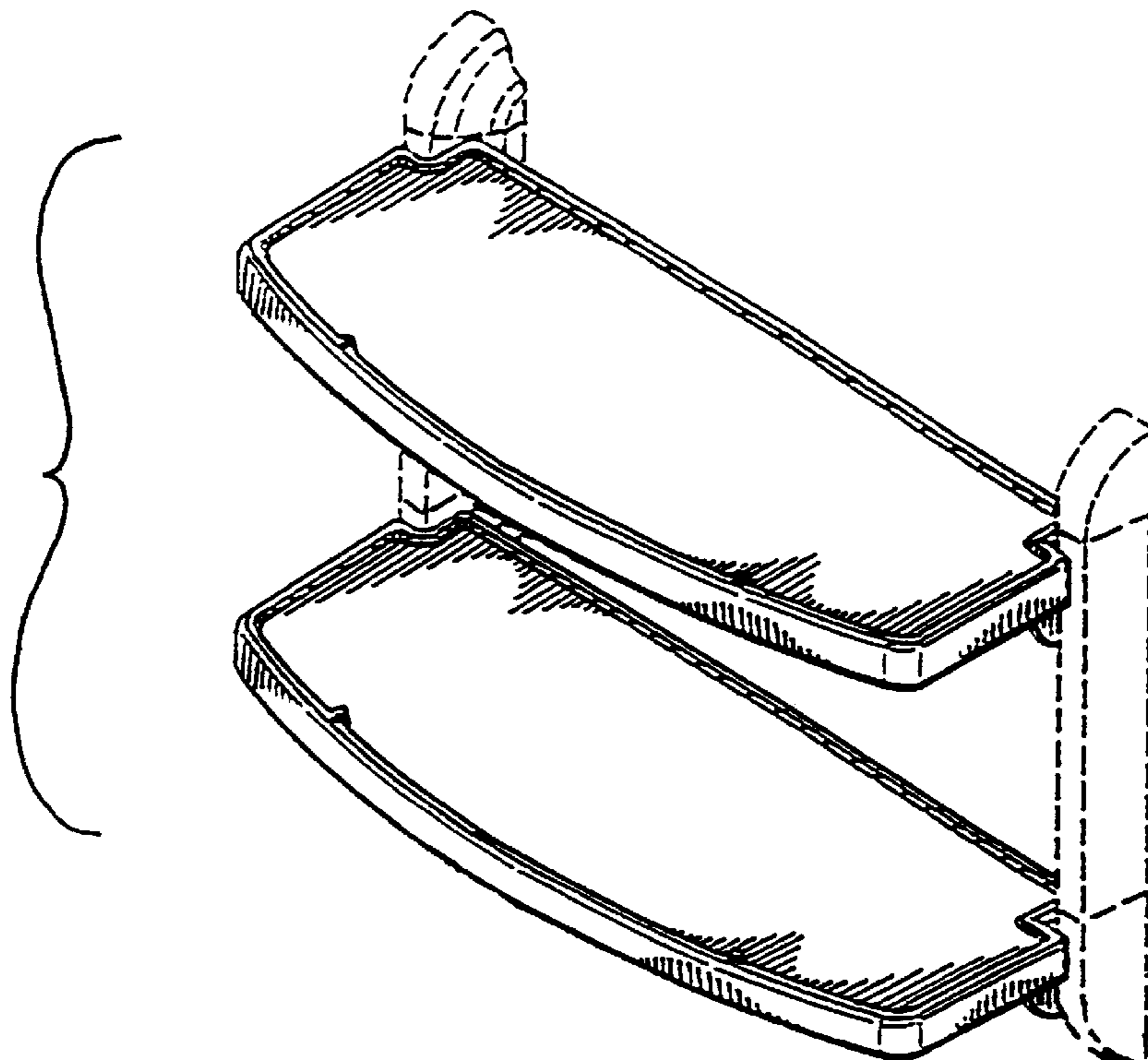

The ornamental design for a shelf unit, as shown and described.

**DESCRIPTION**  
FIG. 1 is a perspective view of a shelf system showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a right side elevational view thereof, the left side elevational view being a mirror image thereof;  
FIG. 4 is a rear elevational view thereof; and,  
FIG. 5 is an enlarged top plan view thereof.  
The bottom of the shelves form no part of the claimed design. The broken lines shown are for illustrative purposes only and form no part of the claimed design.

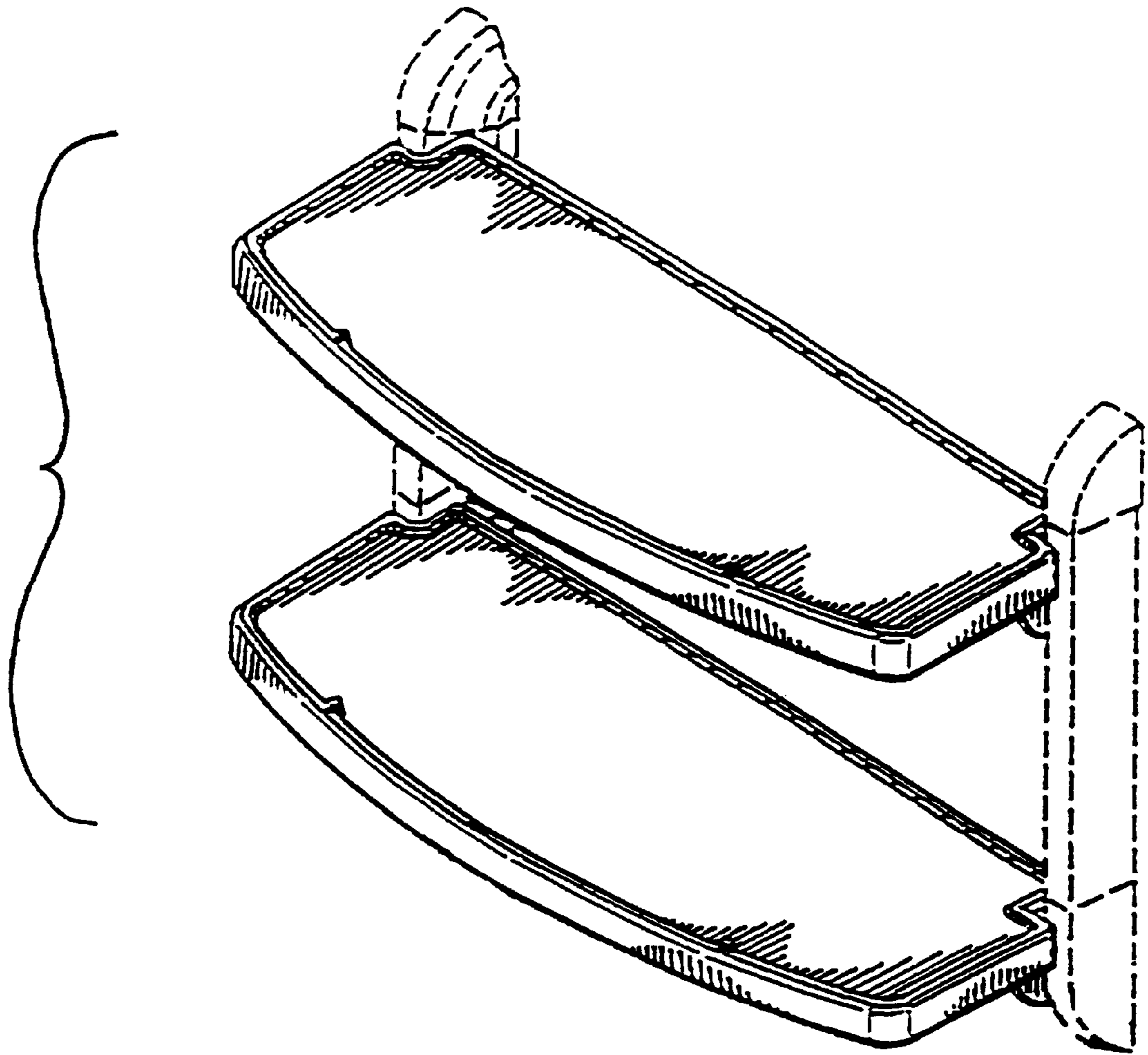

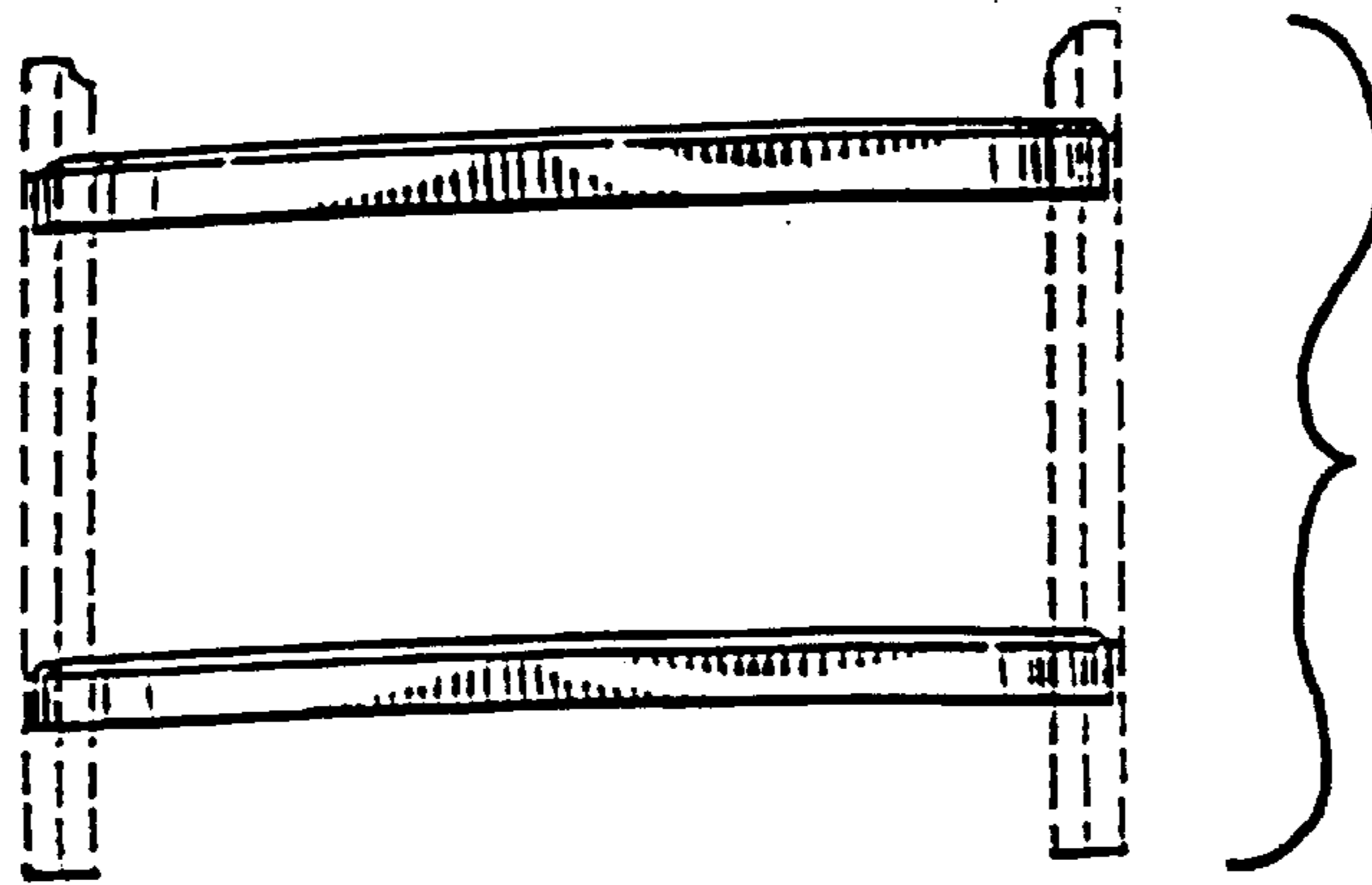

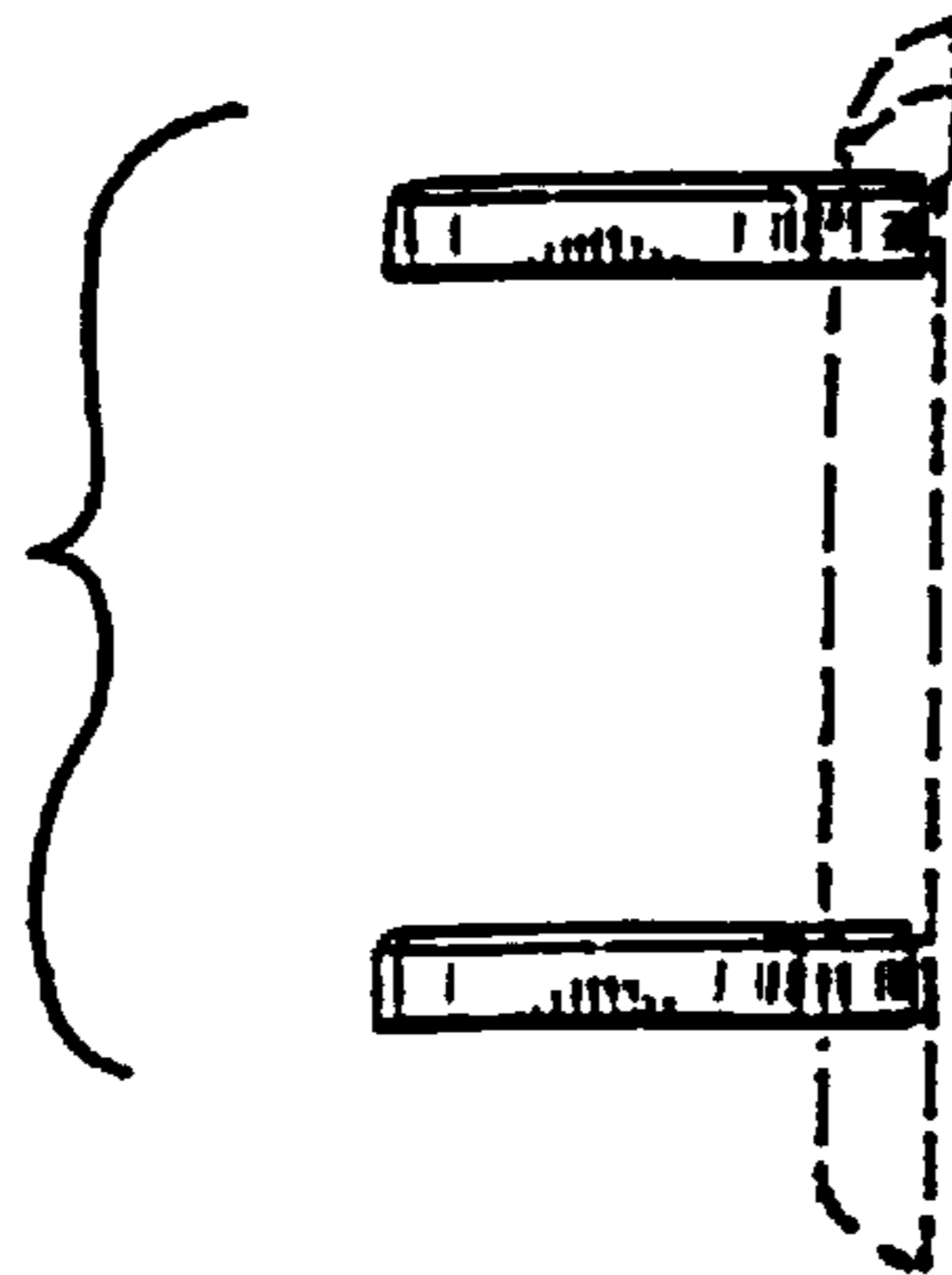

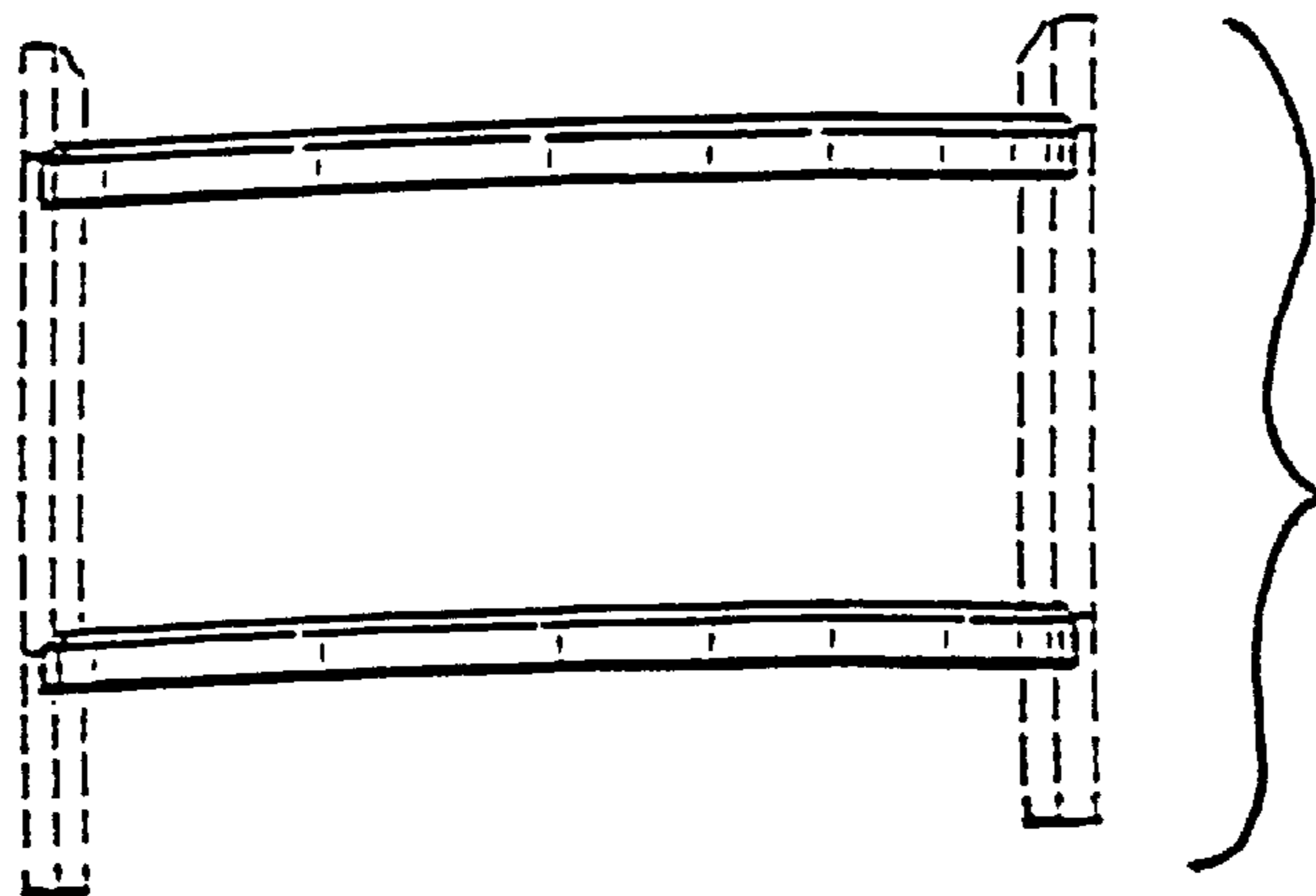

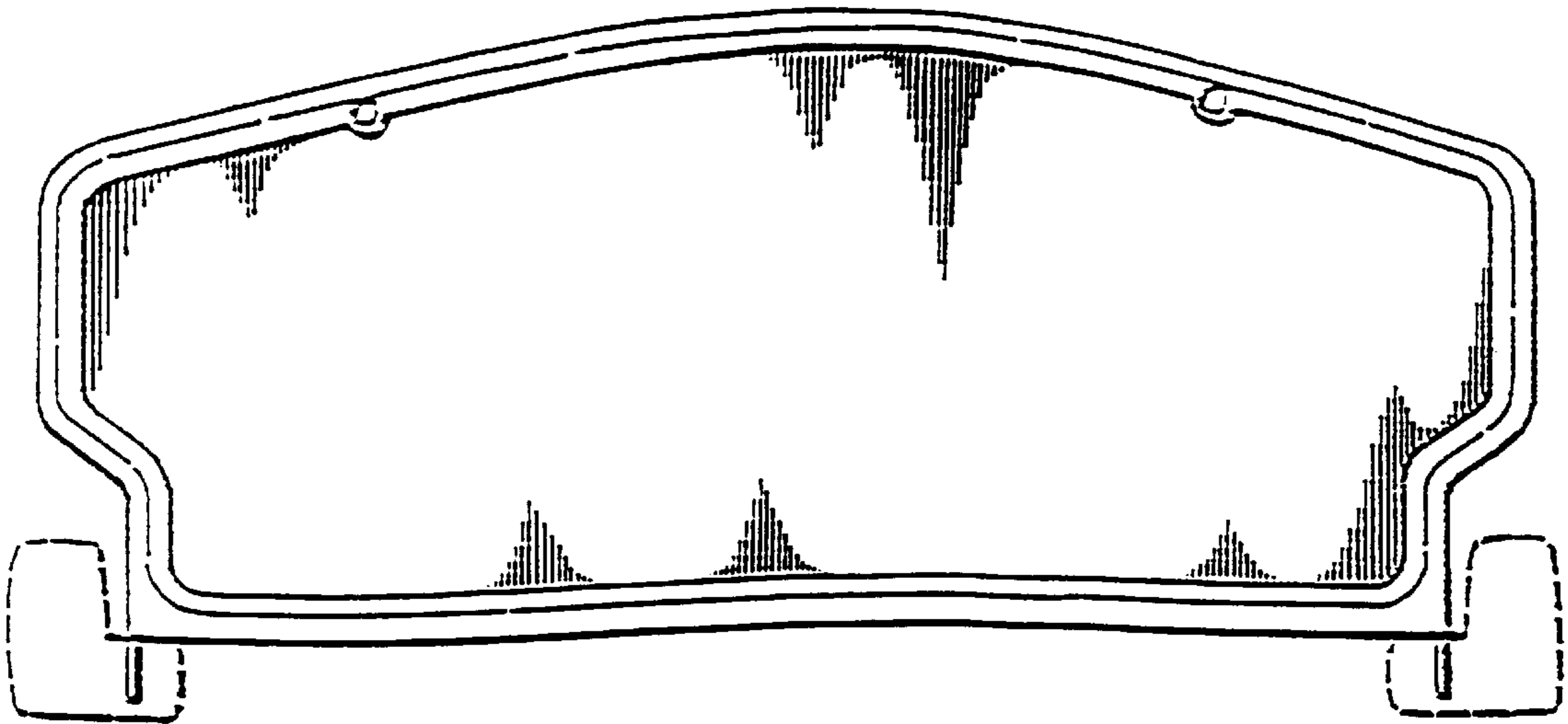
