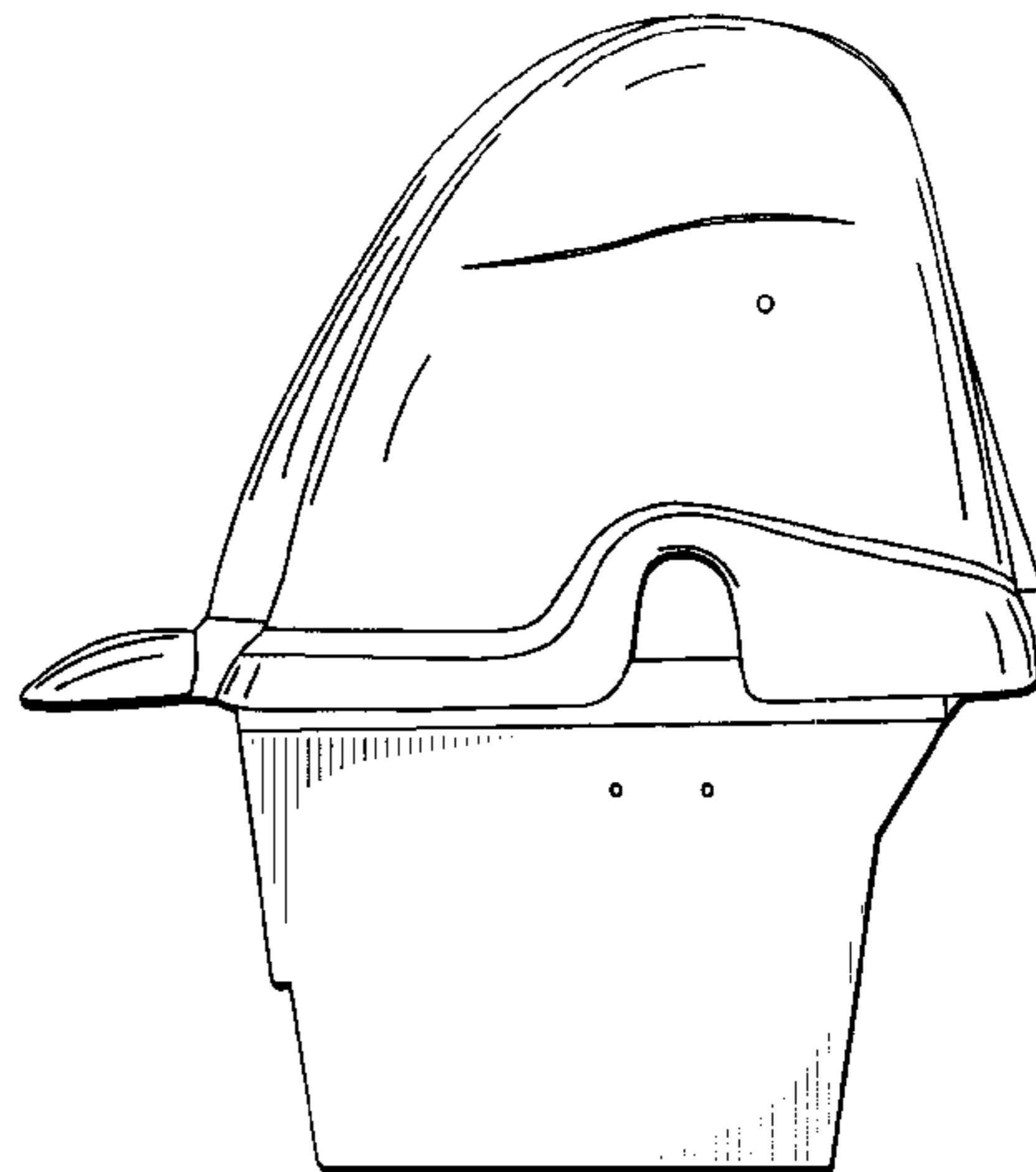
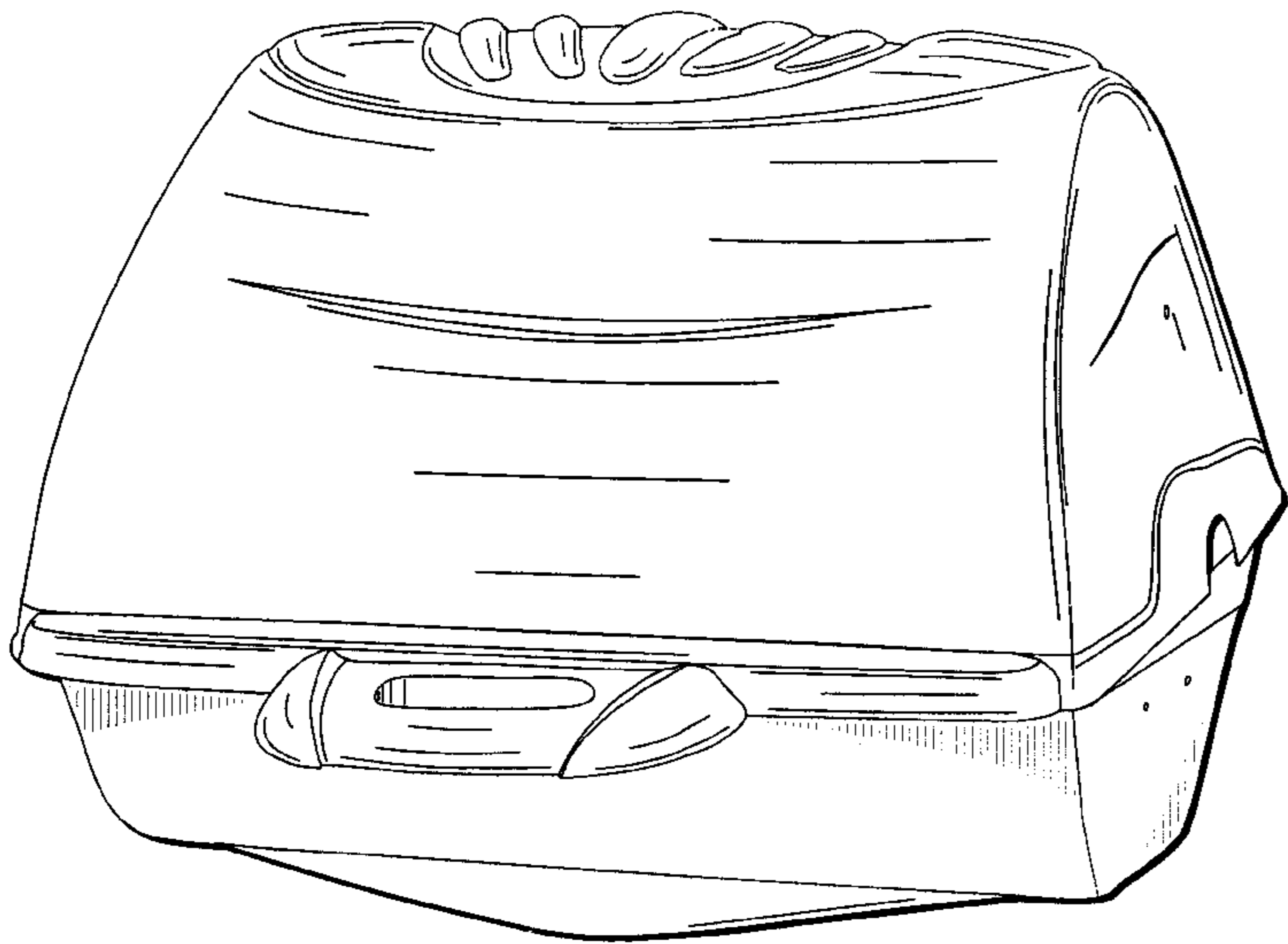

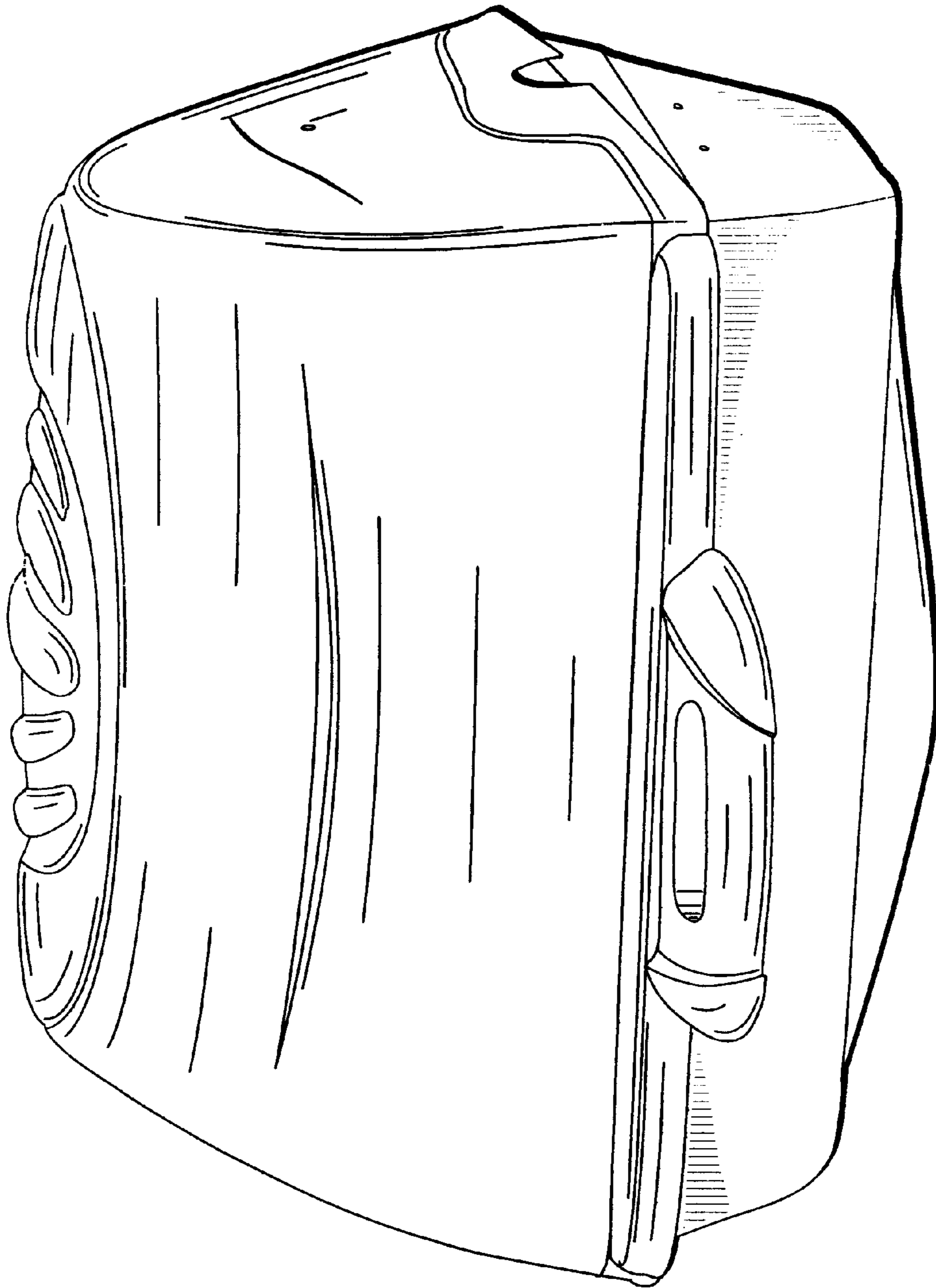
The ornamental design of a casting for barbecue grill, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a casting for a barbecue grill showing our new design;

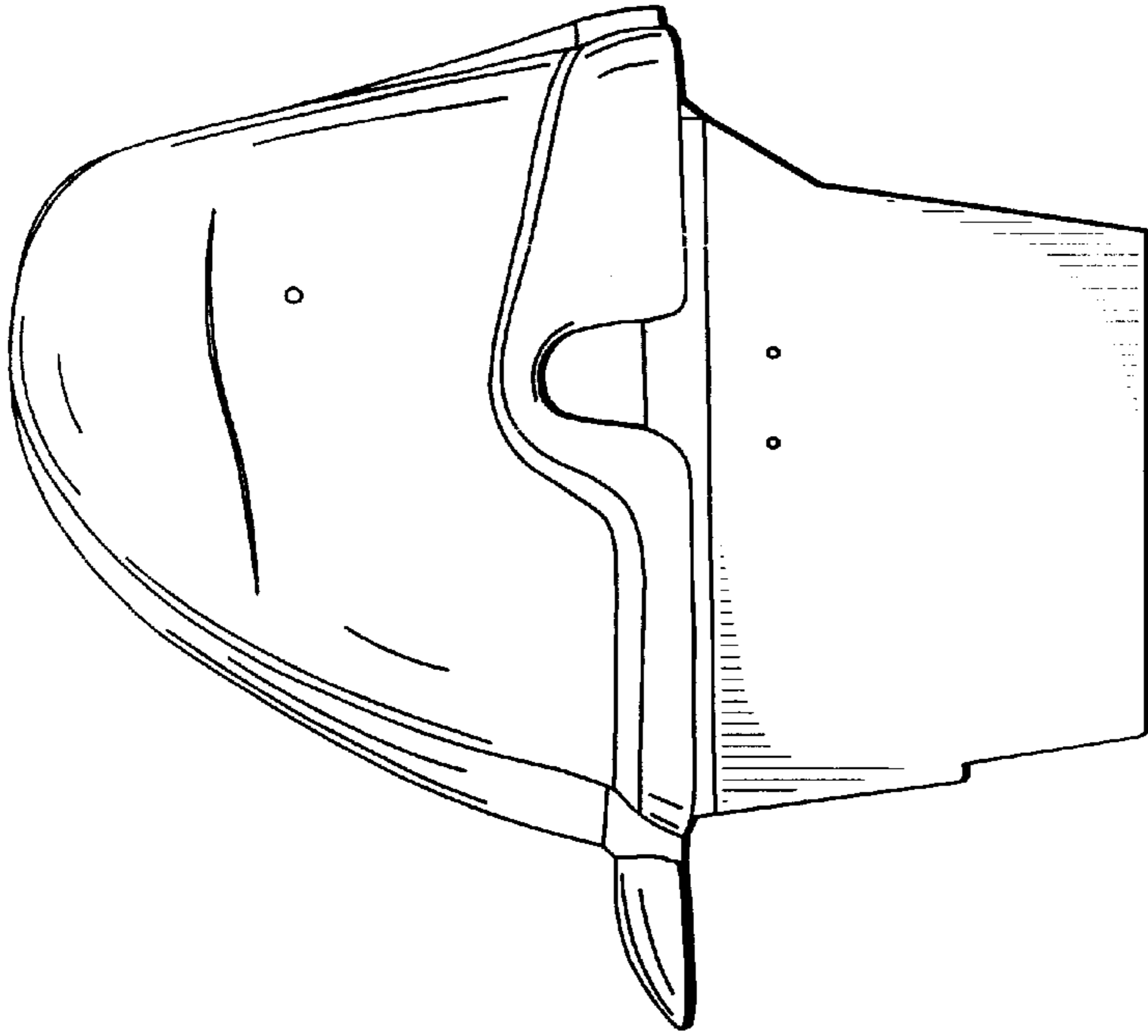

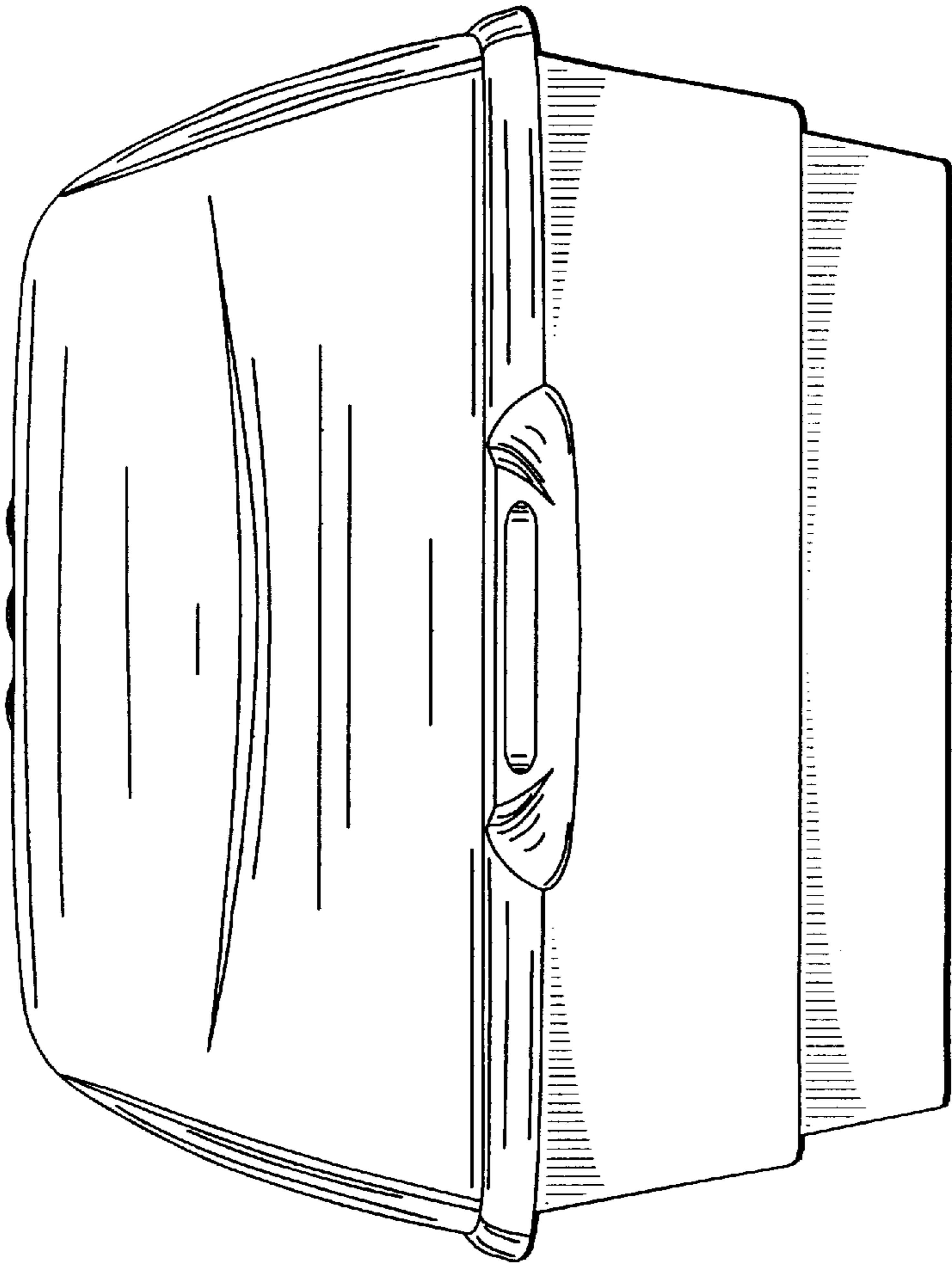
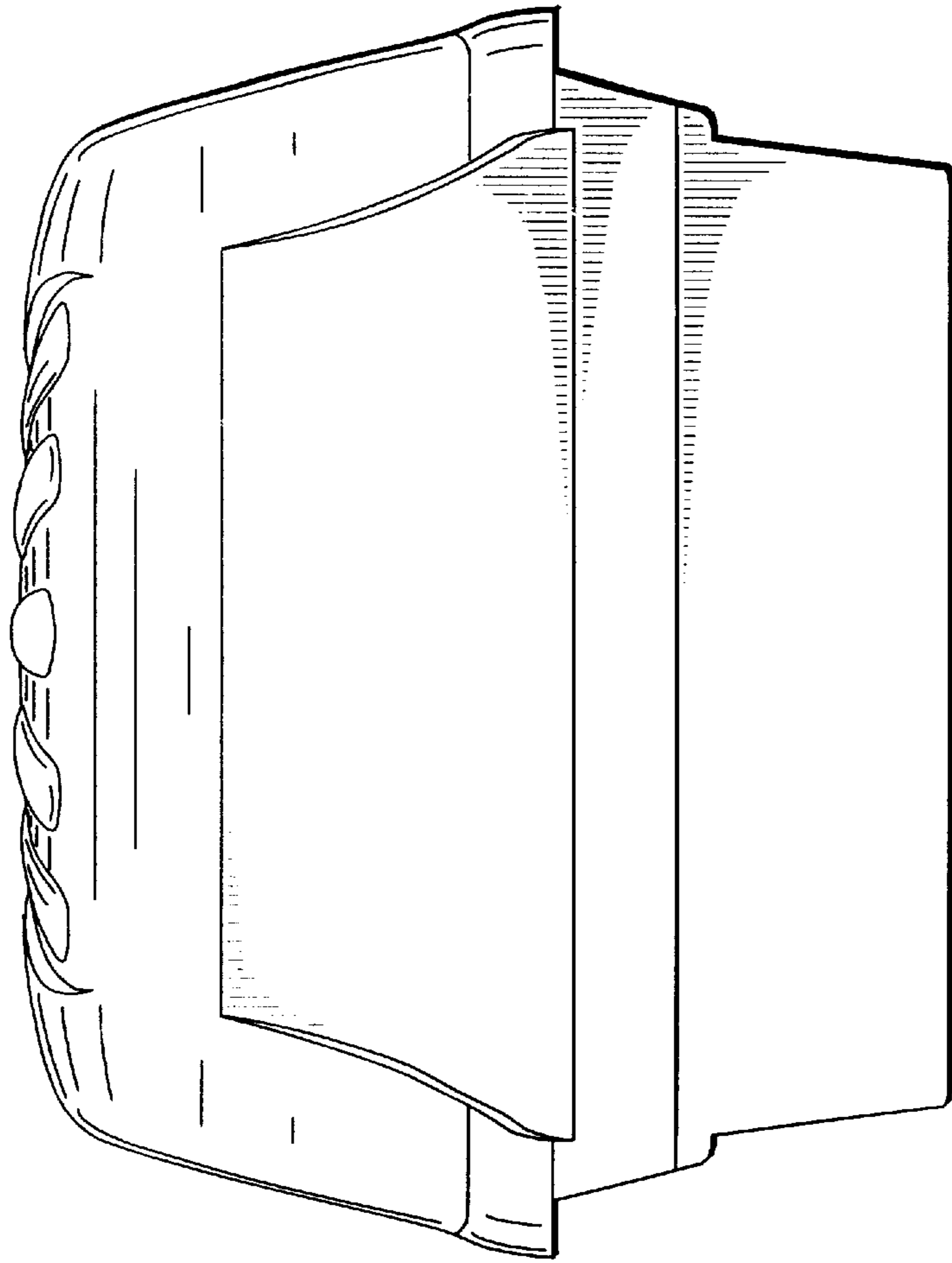
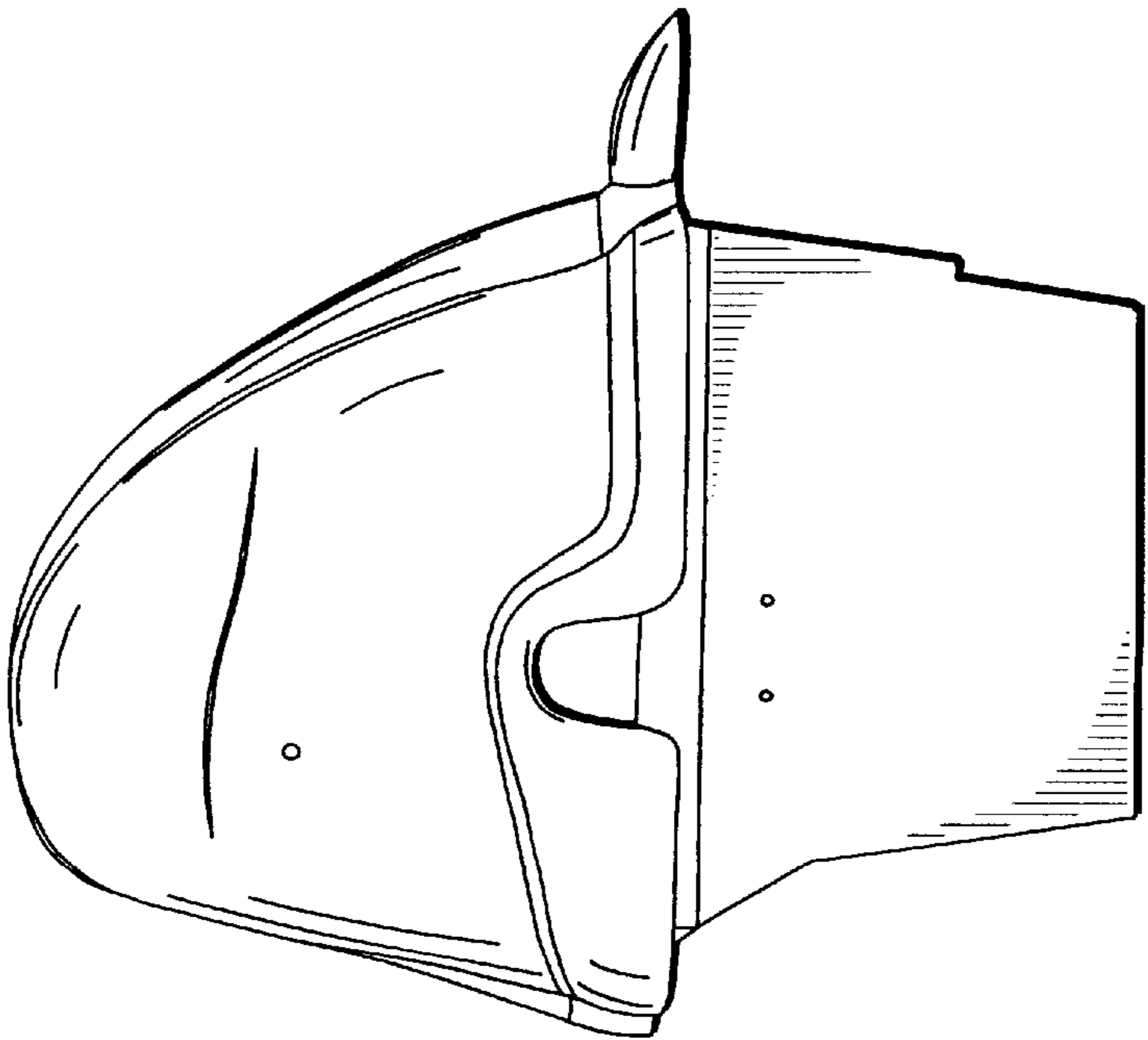


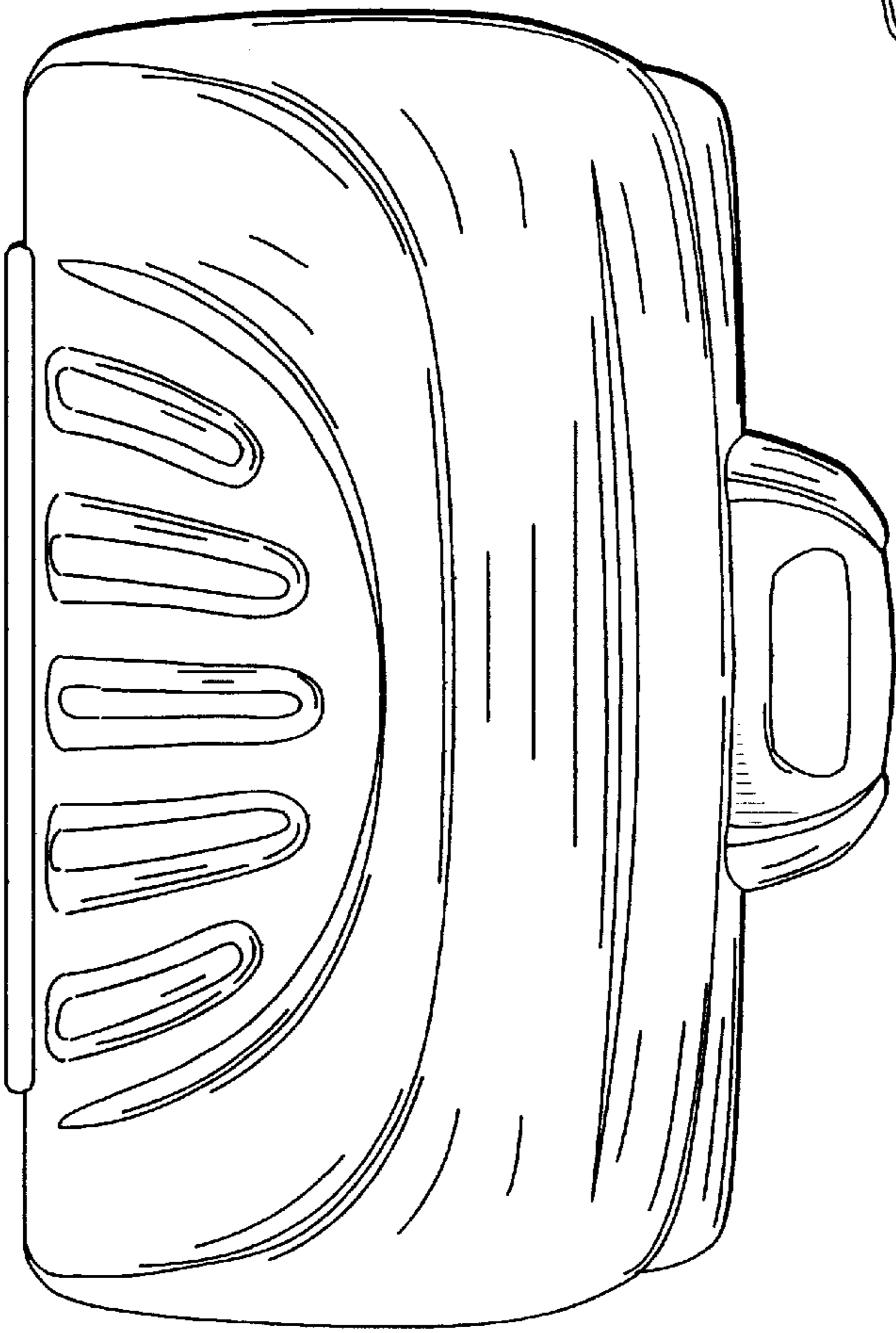

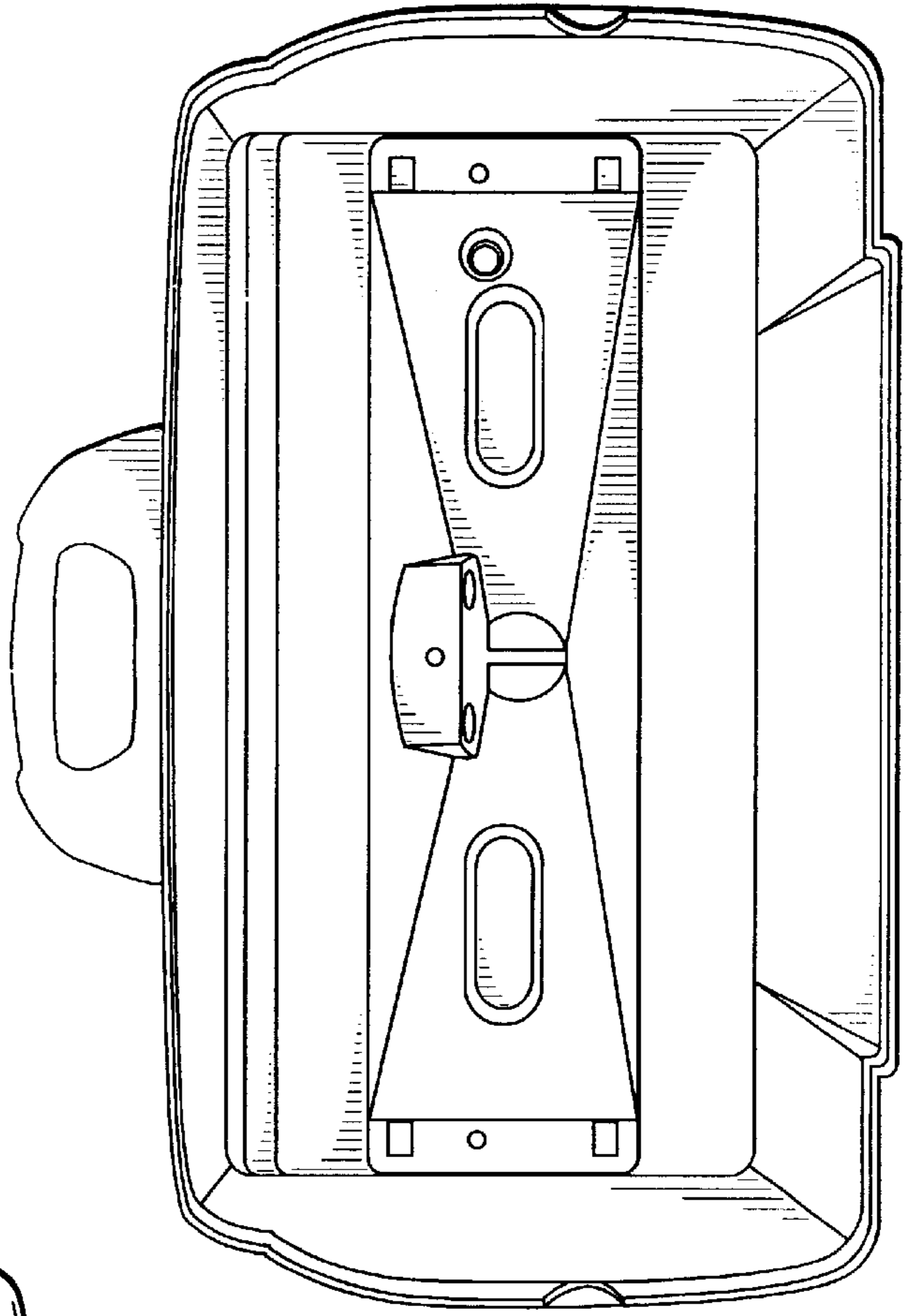
