[57] **CLAIM**

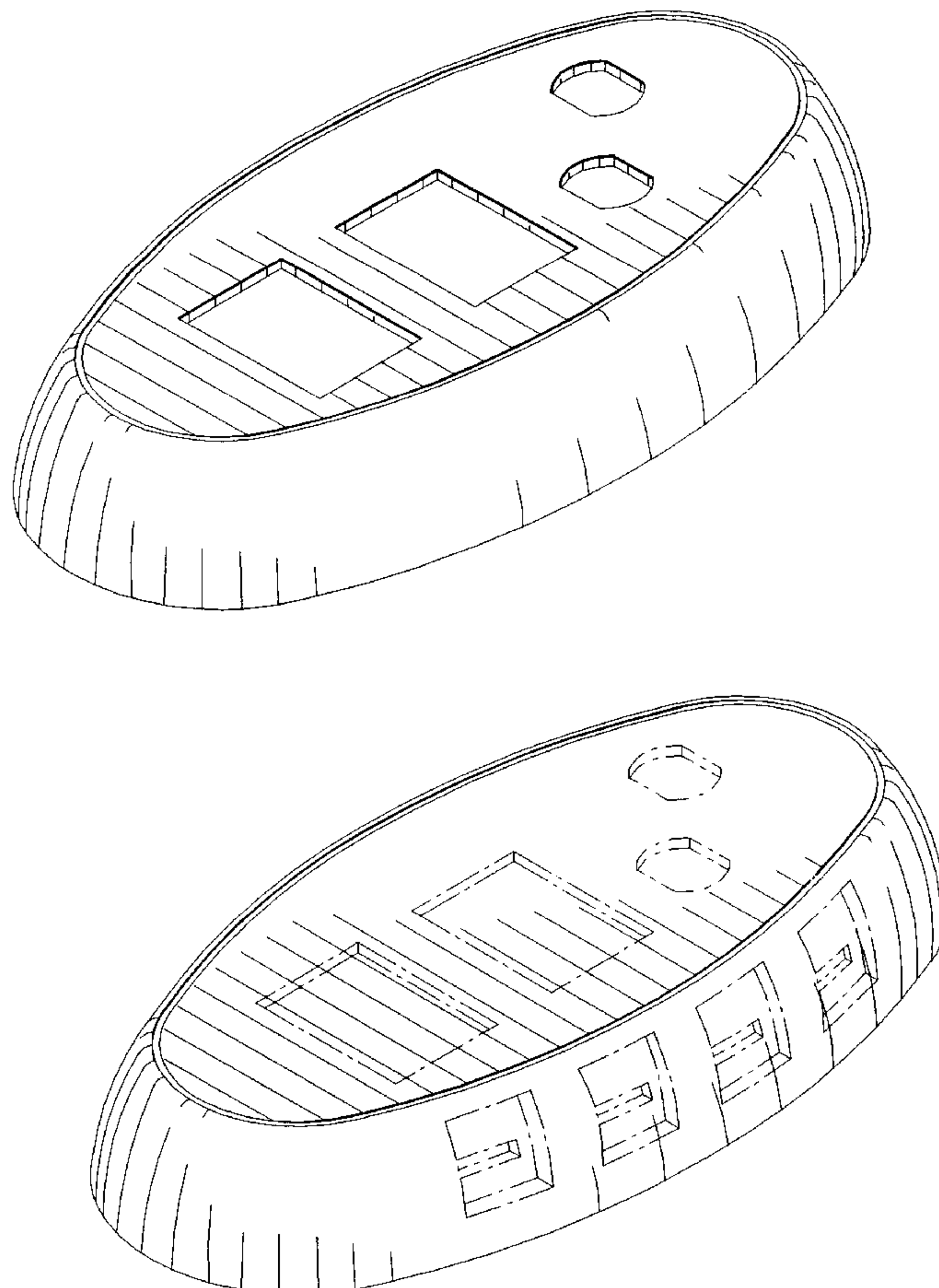
The ornamental design for a modular furniture wall plate, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a modular furniture wall plate showing my design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear view thereof;  
 FIG. 4 is a right side view thereof, the left side view being a mirror image;  
 FIG. 5 is a top view thereof, the bottom view being a mirror image;  
 FIG. 6 is a perspective view of a second embodiment of a modular furniture wall plate showing my design;  
 FIG. 7 is a front elevational view thereof;  
 FIG. 8 is a rear view thereof;  
 FIG. 9 is a right side view thereof, the left side view being a mirror image;  
 FIG. 10 is a top view thereof; and,  
 FIG. 11 is a bottom view thereof.

The broken lines showing the access ports, icon ports and attachment members in FIGS. 6–11 are for illustrative purposes only and form no part of the claimed design.

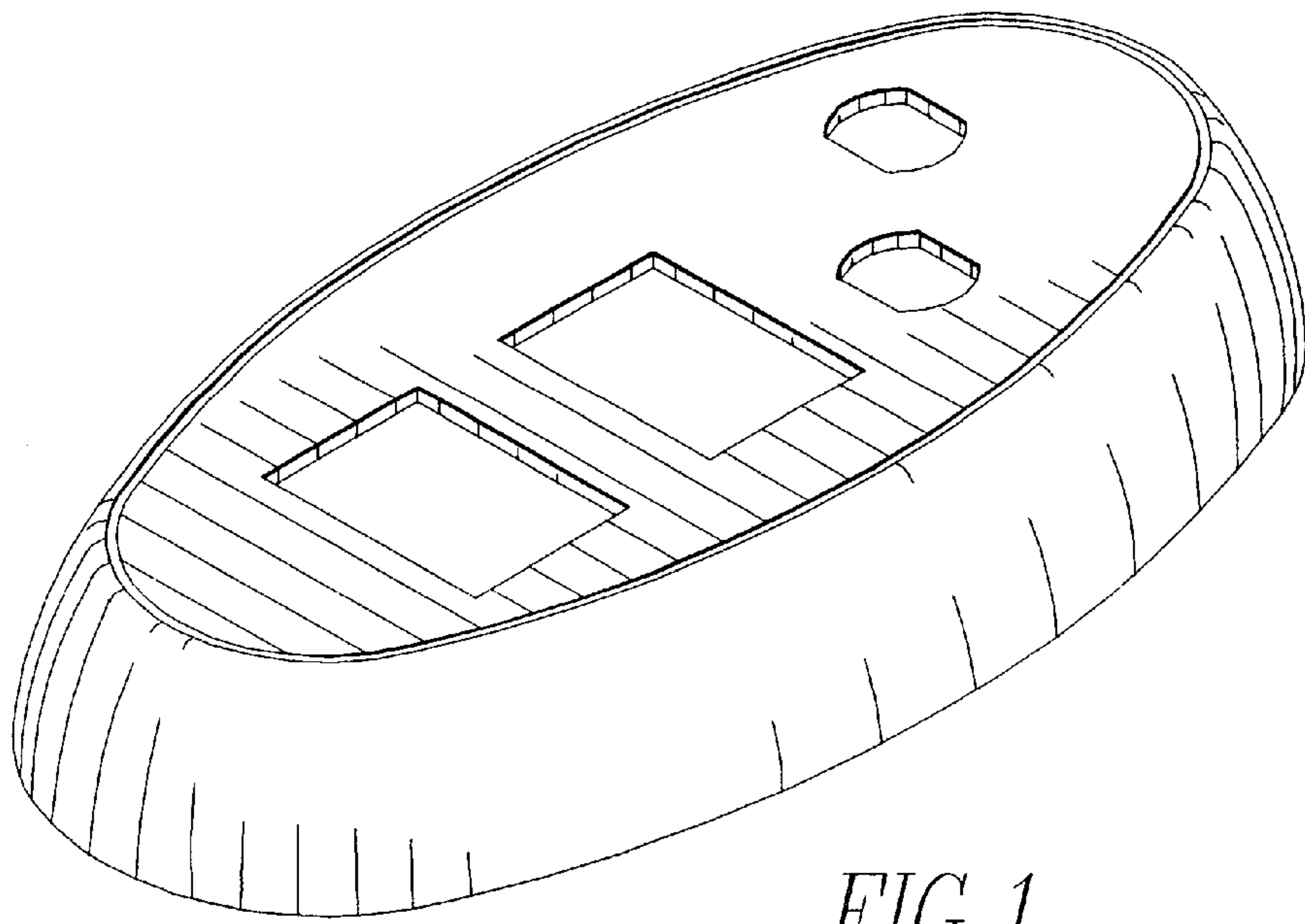

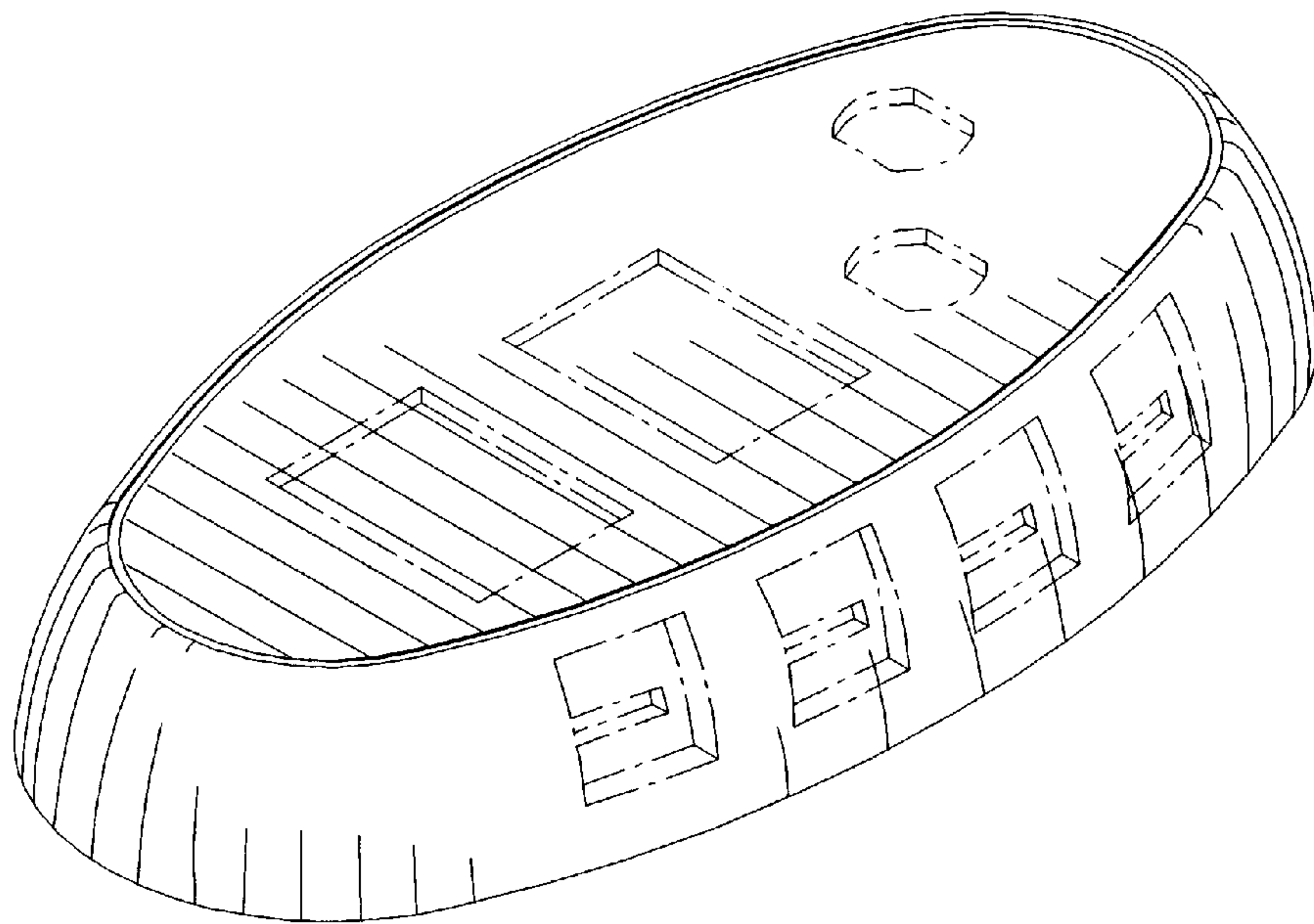

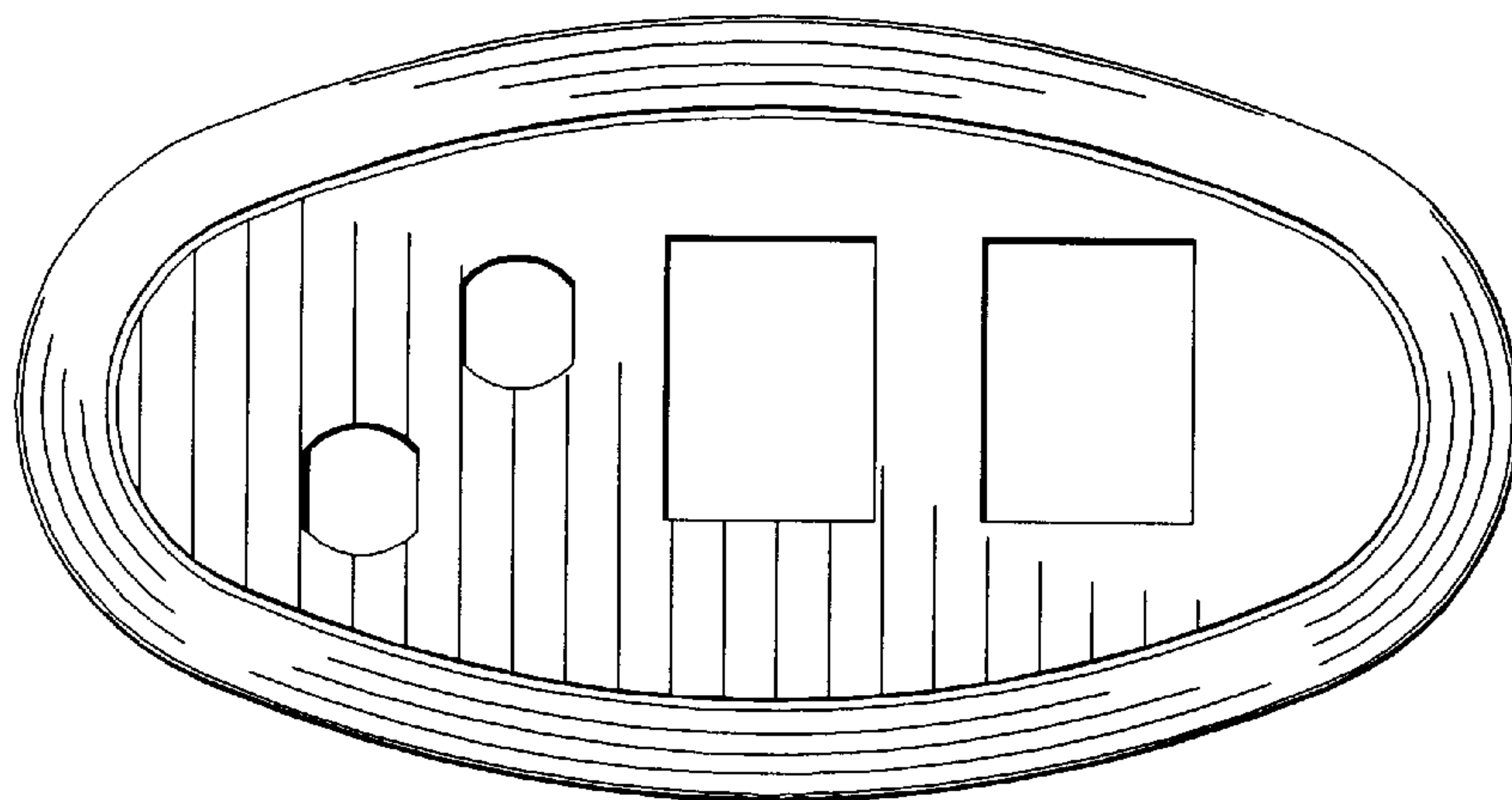

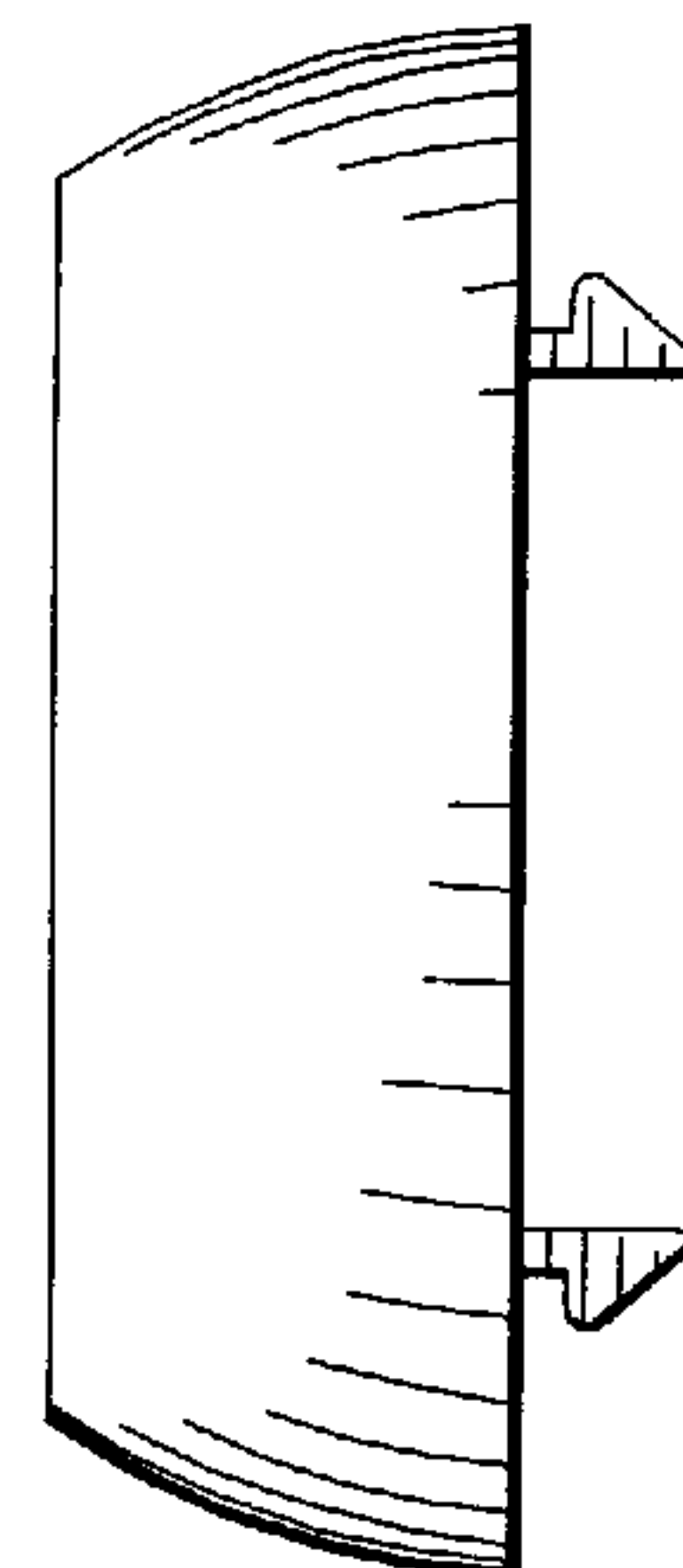

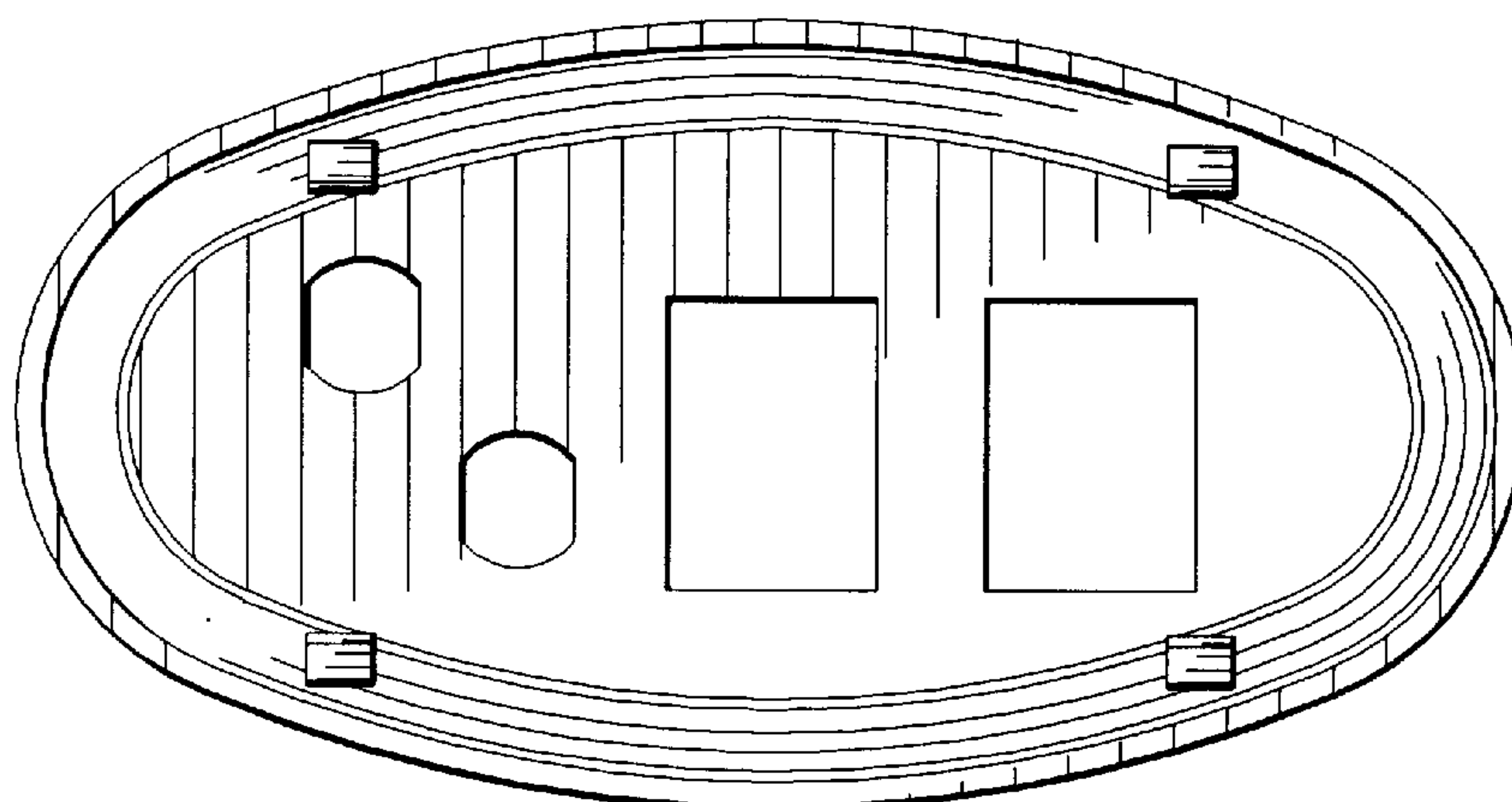

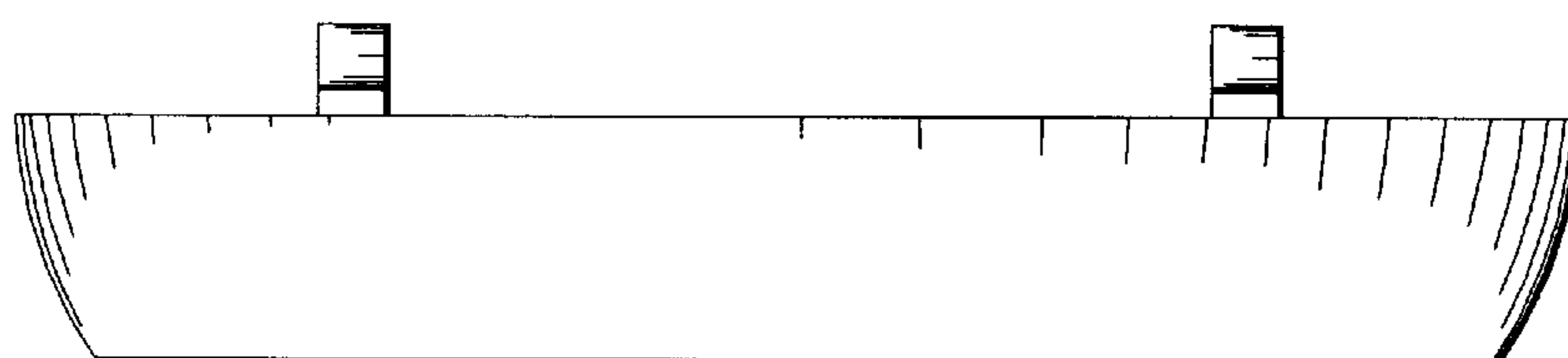

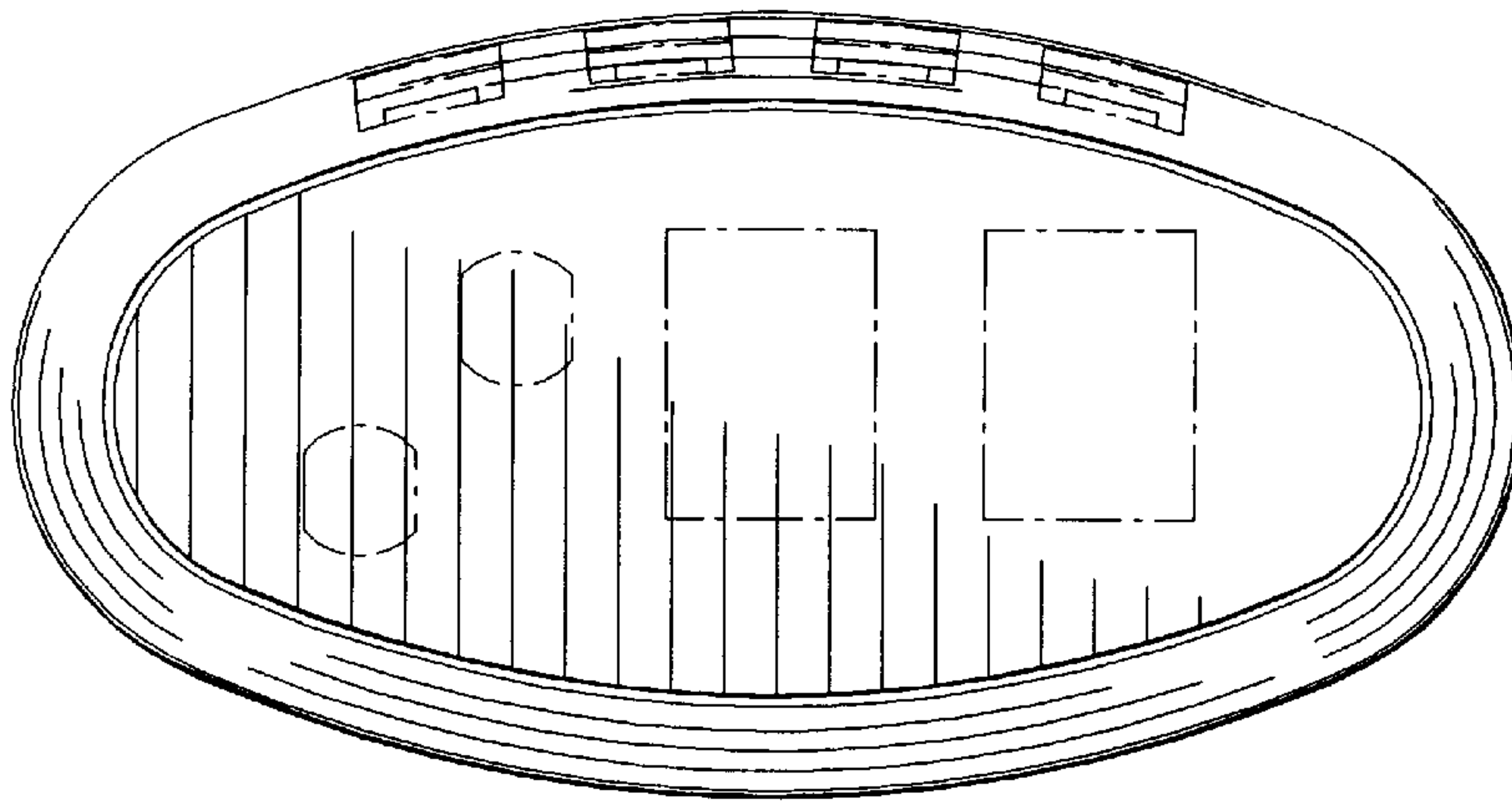

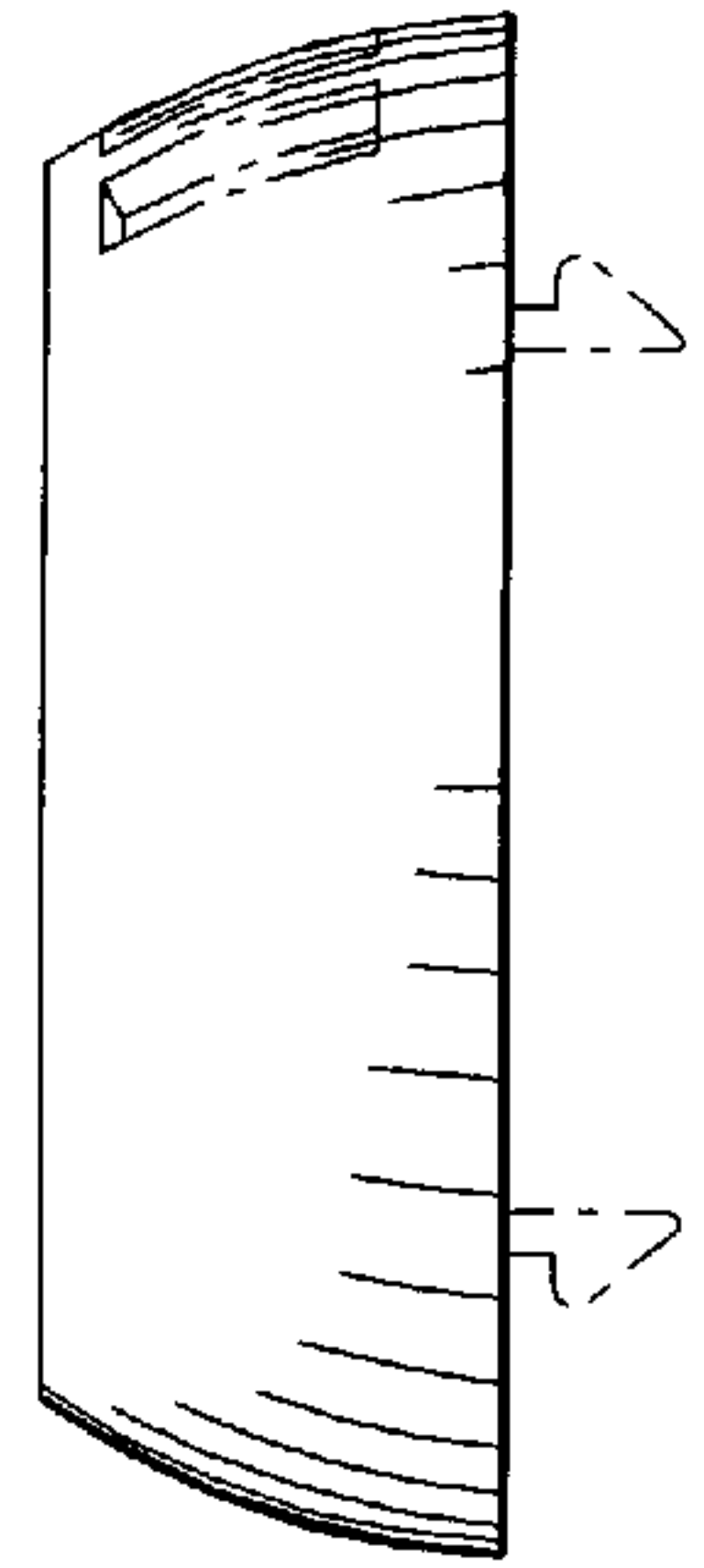

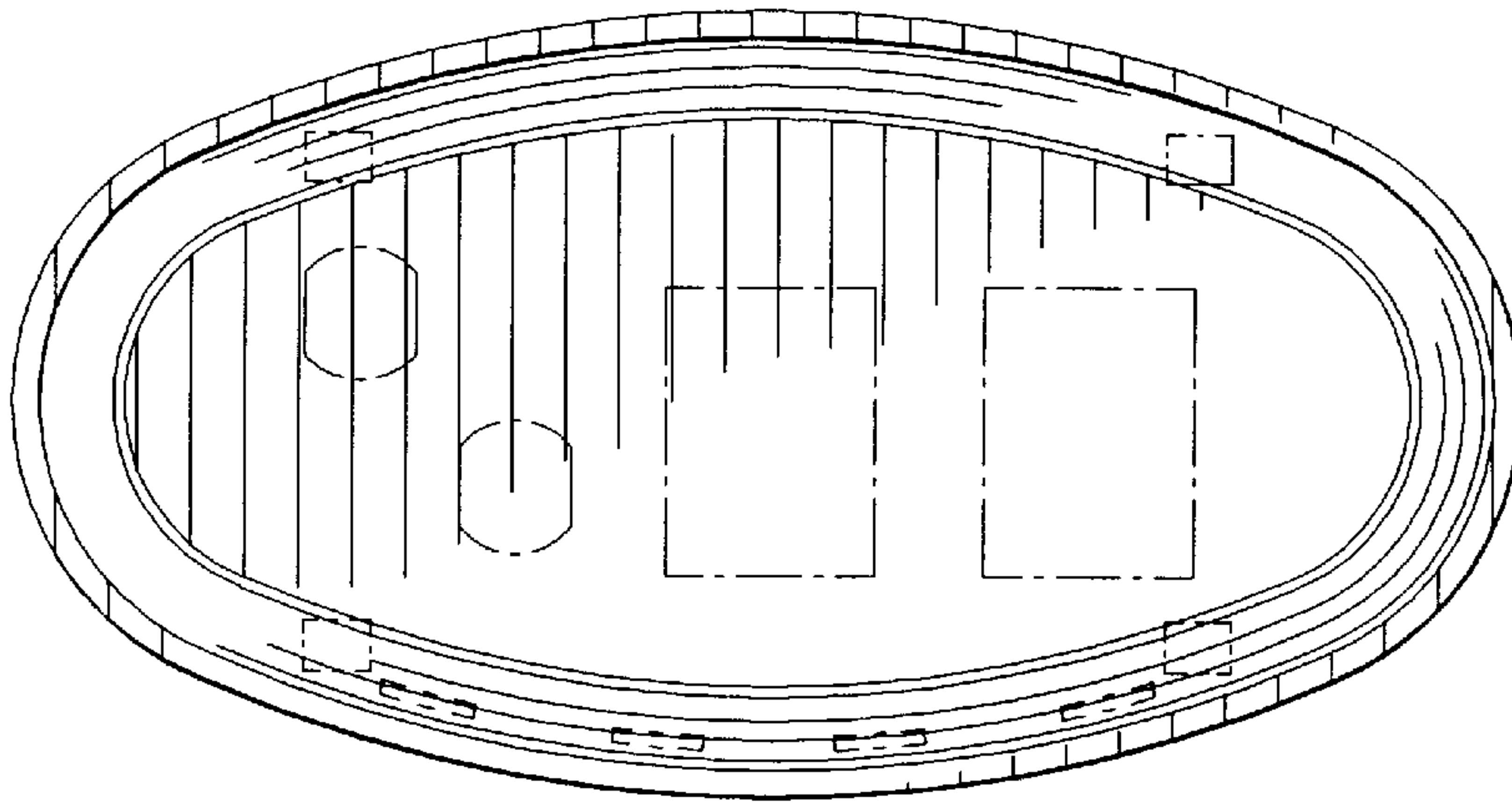

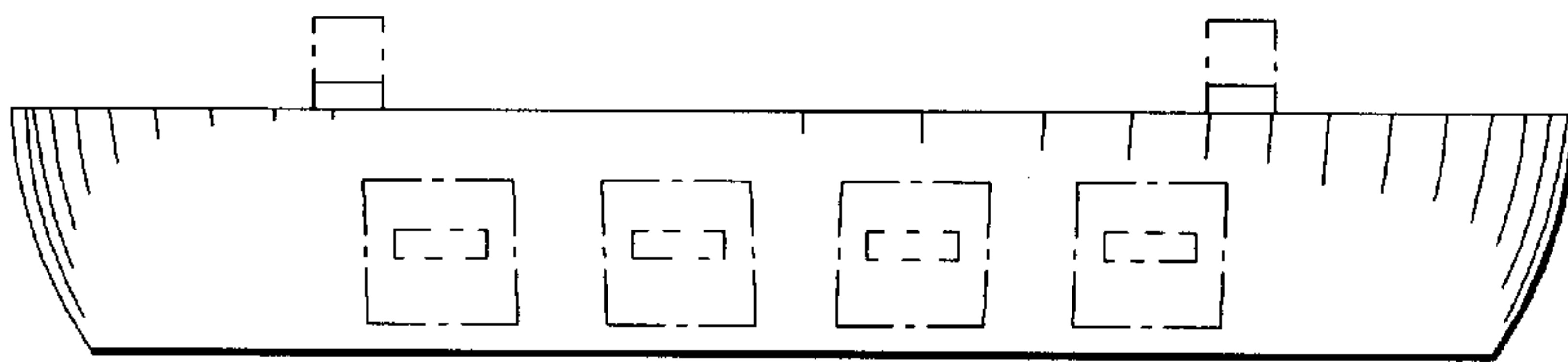

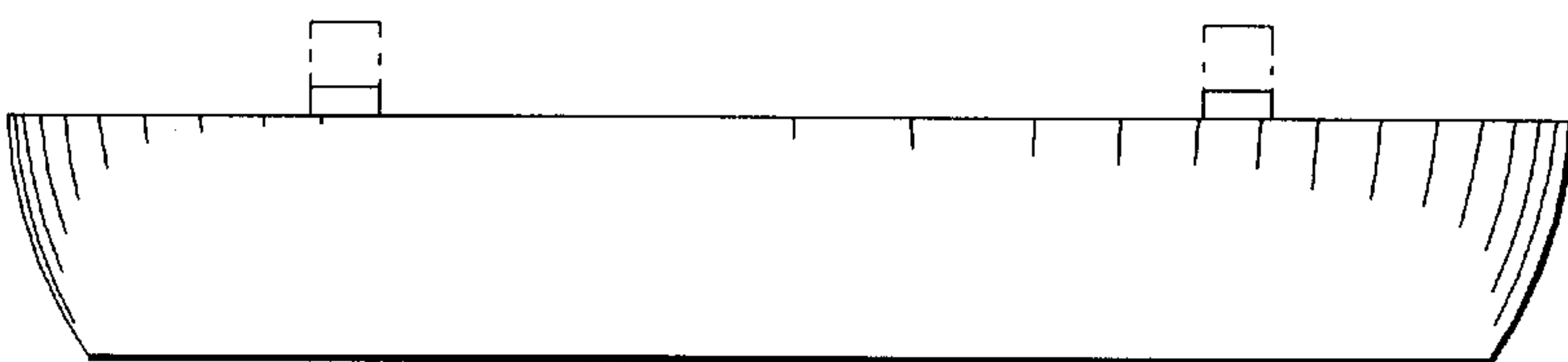
