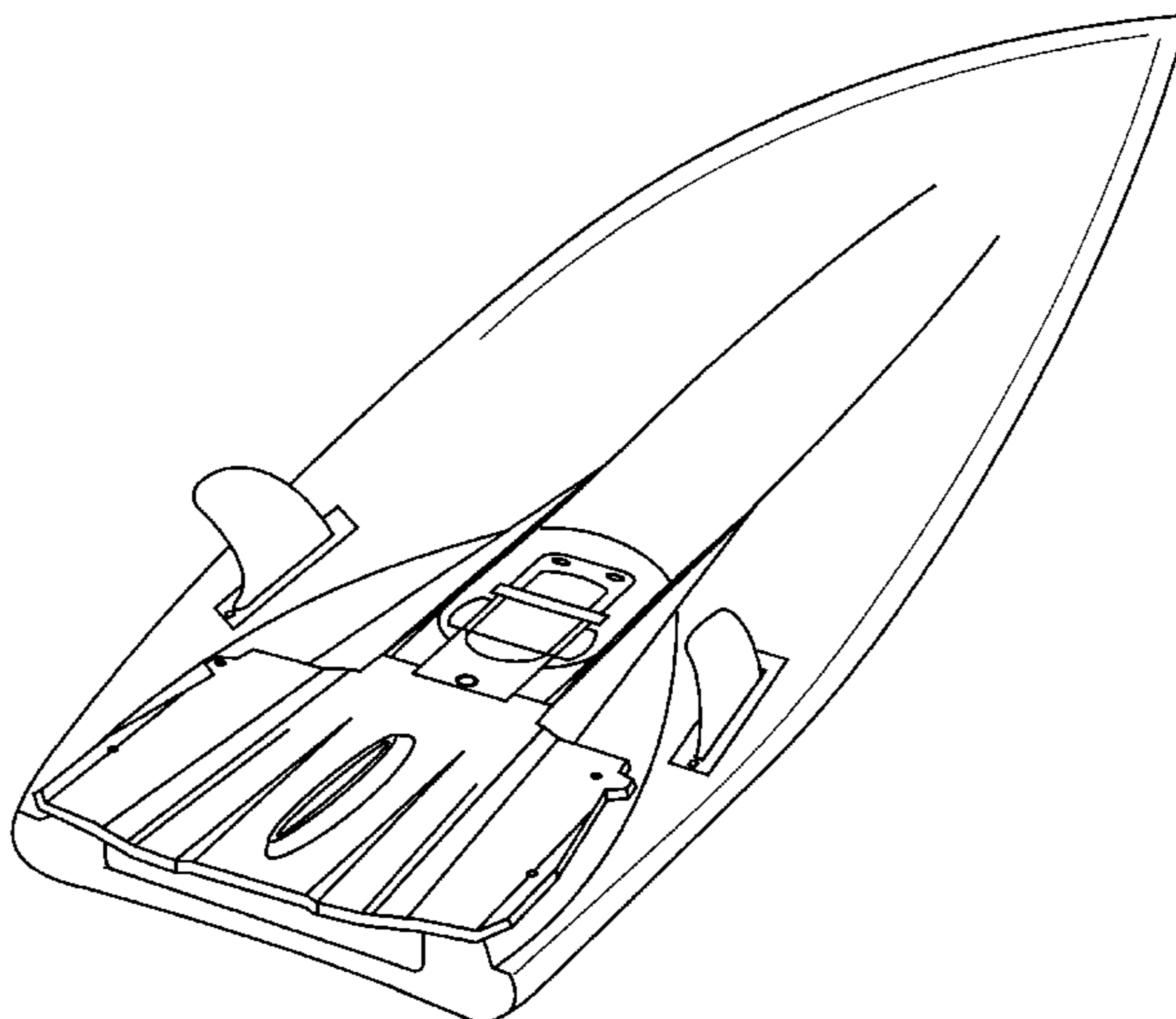
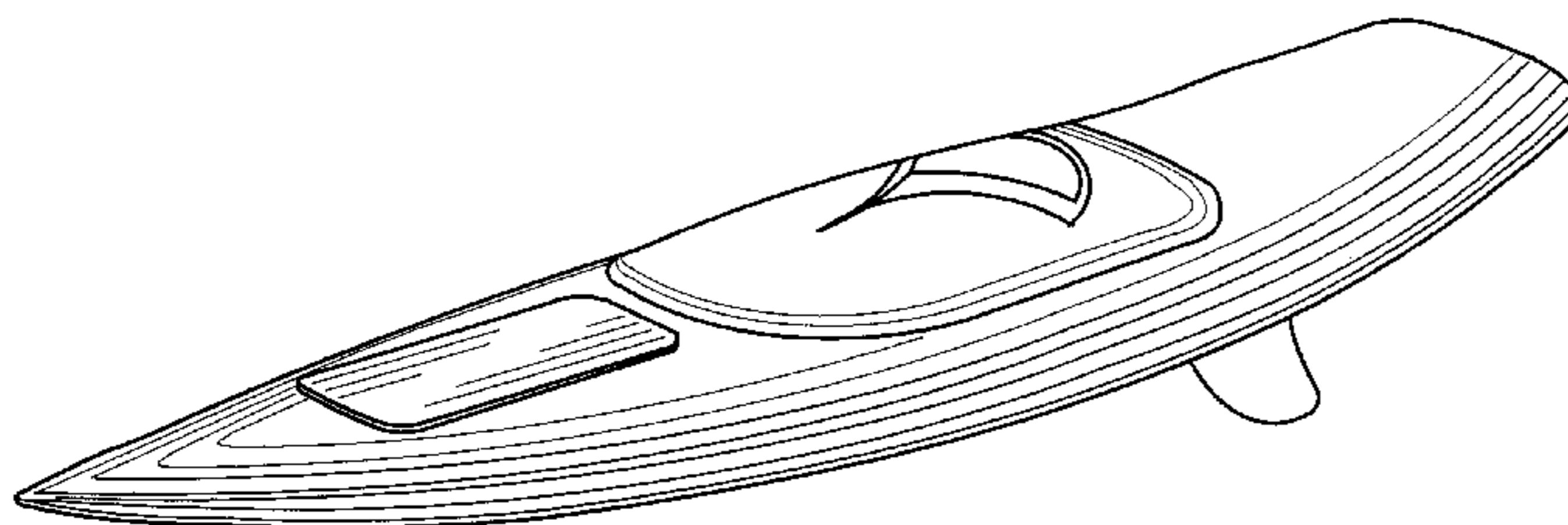
[57] **CLAIM**

I claim the ornamental design for a motorized water ski, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a motorized water ski showing my new design;  
FIG. 2 top plan view thereof;  
FIG. 3 is a front elevation view thereof  
FIG. 4 is a right side elevation view thereof;  
FIG. 5 is a rear perspective view thereof; and  
FIG. 6 is a bottom plan view thereof; and,

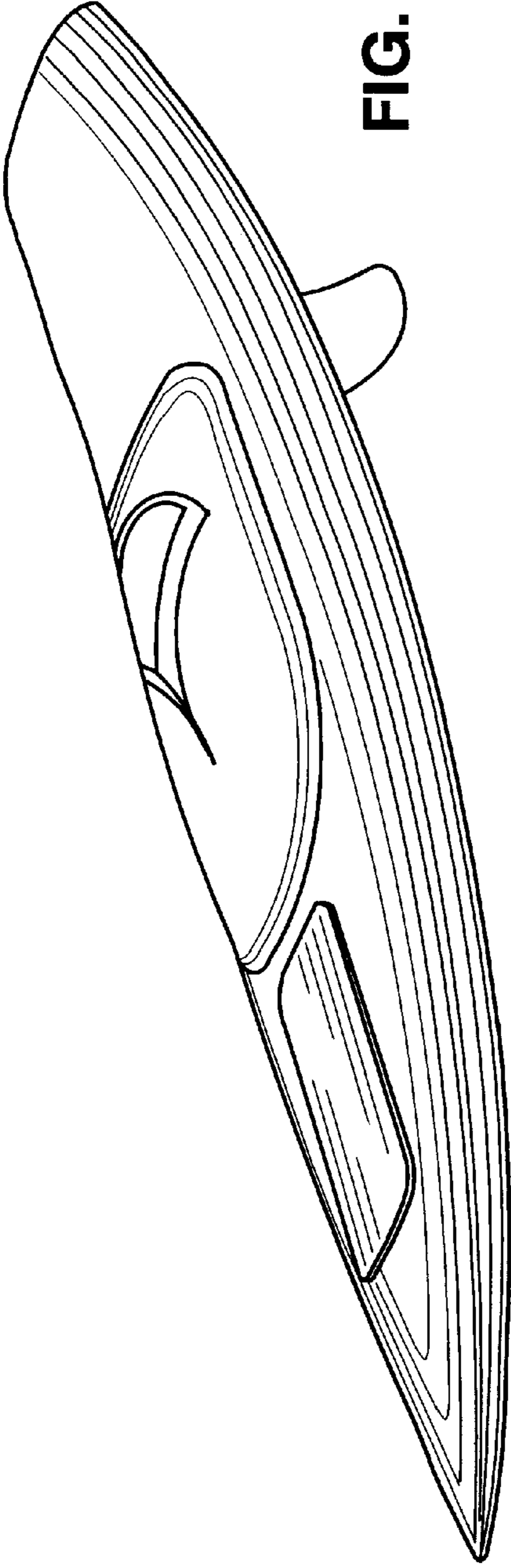

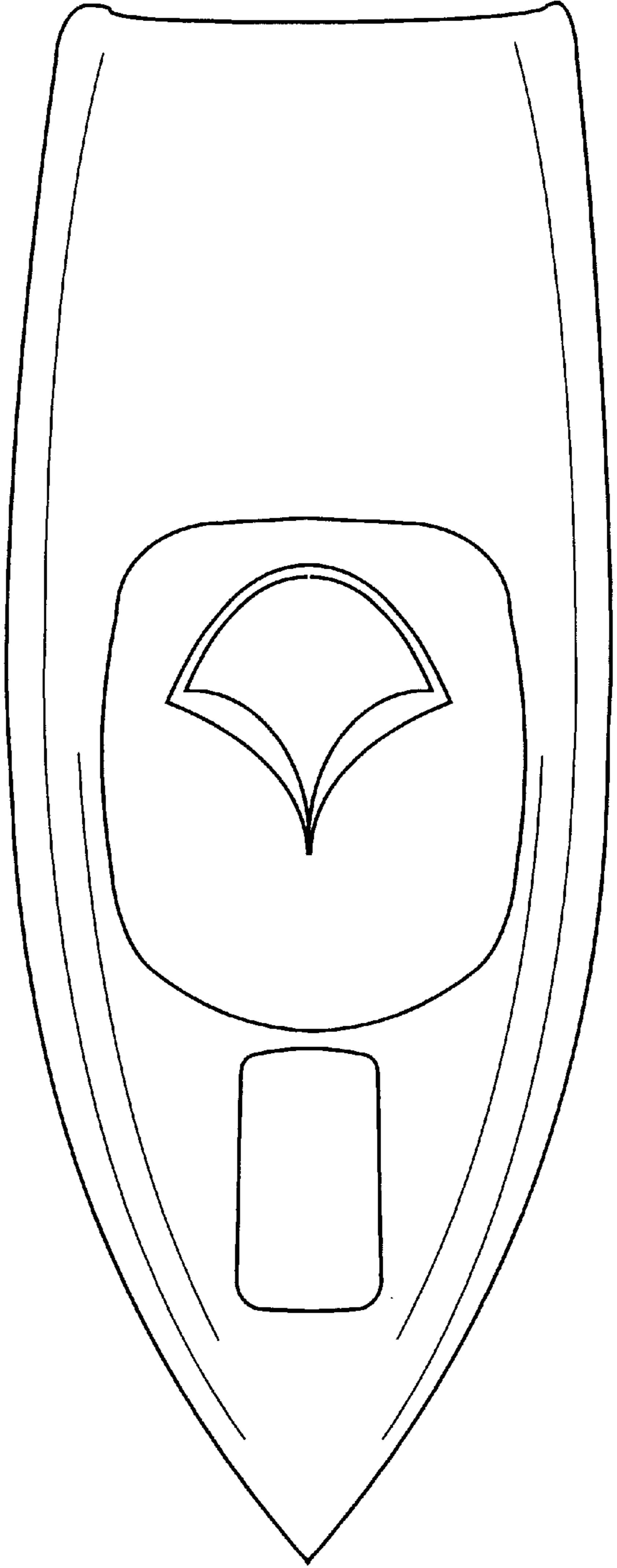
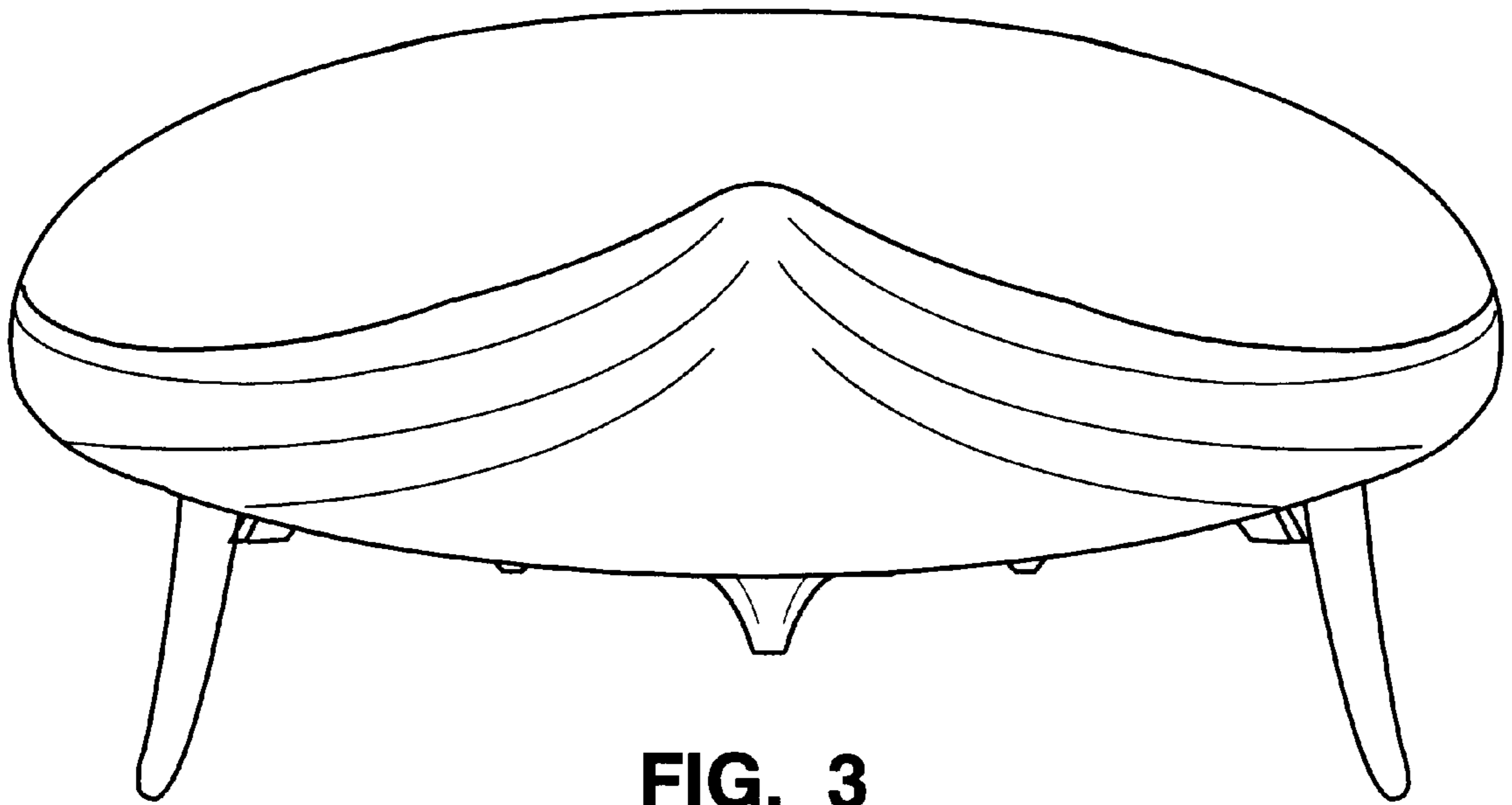
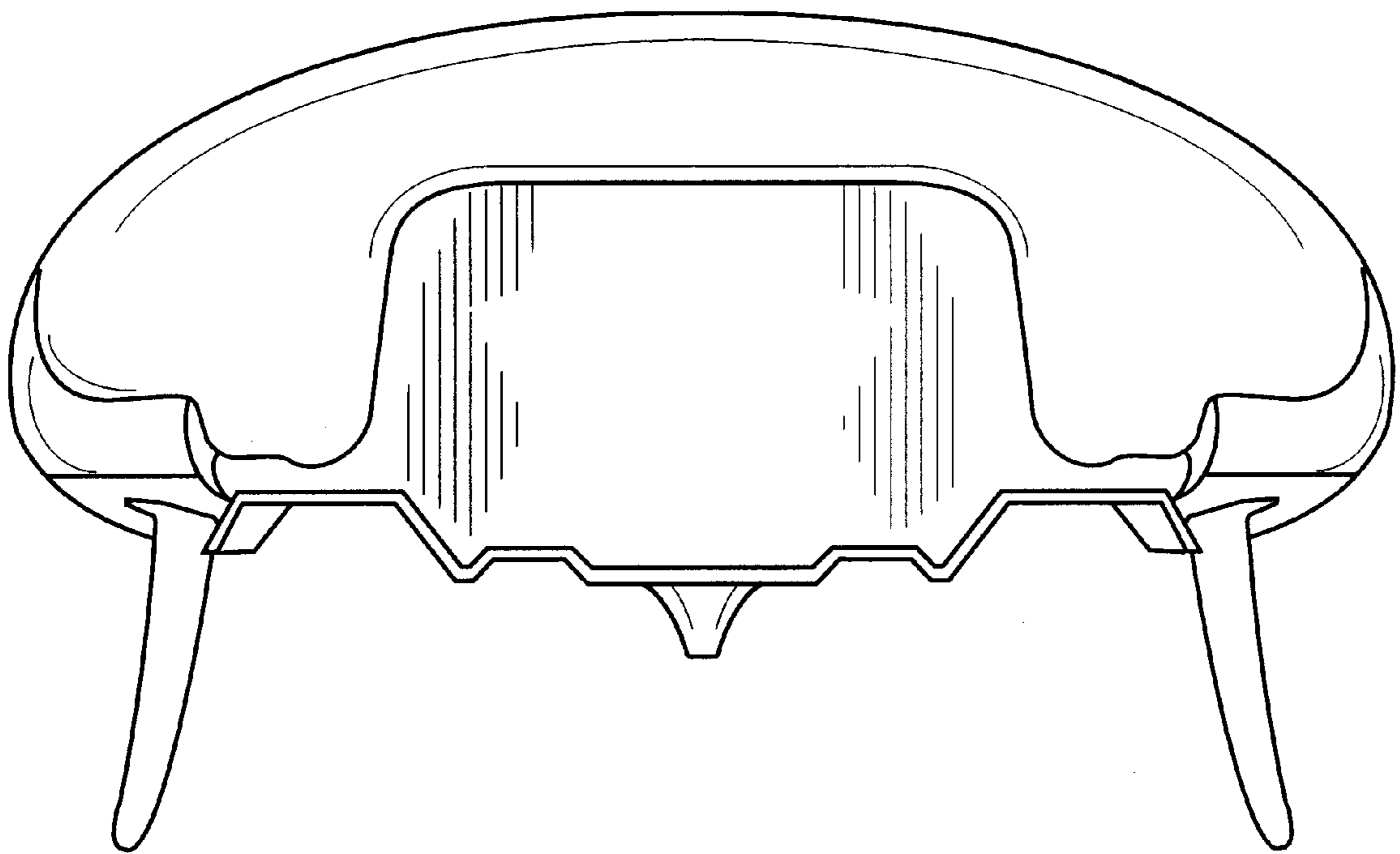

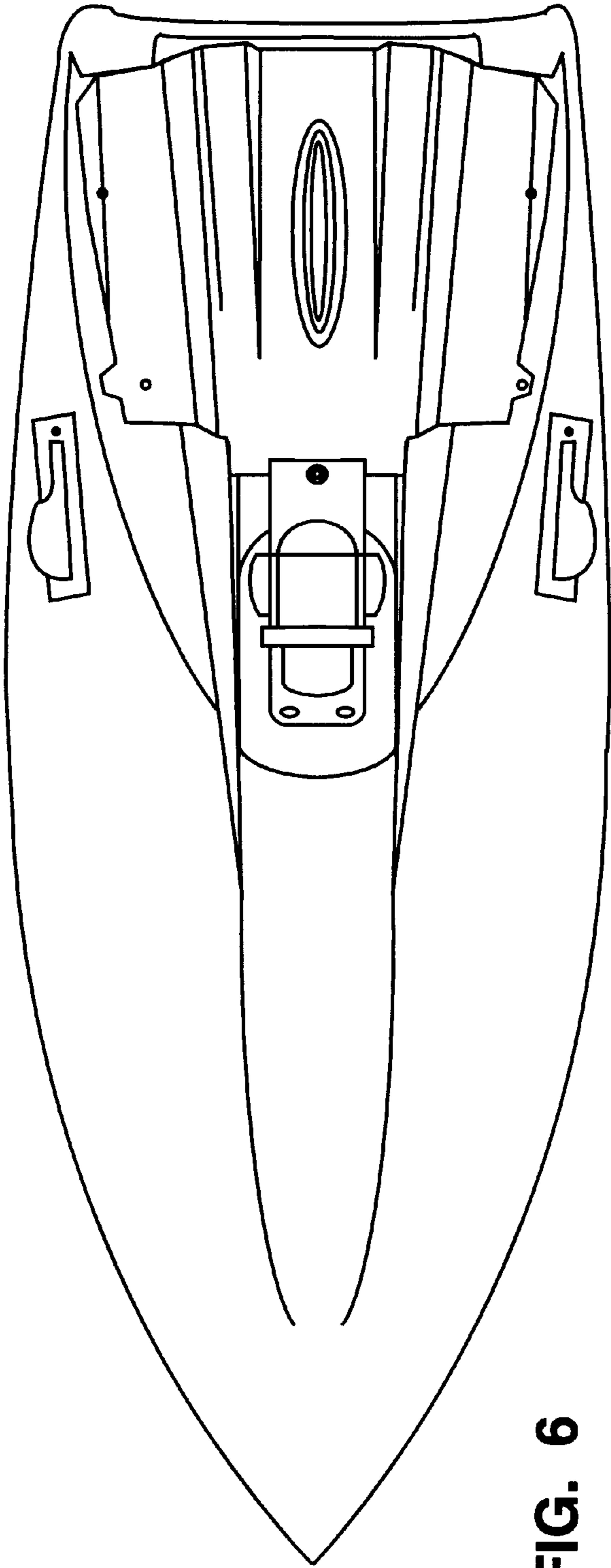

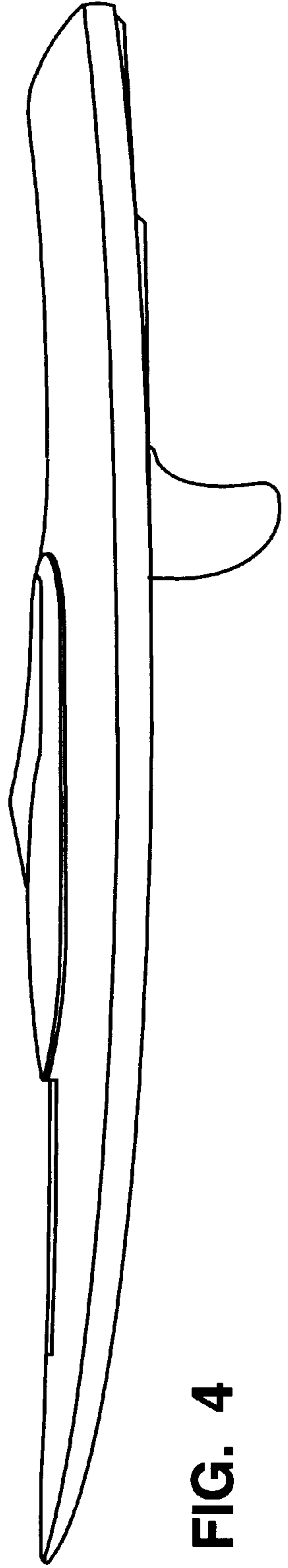

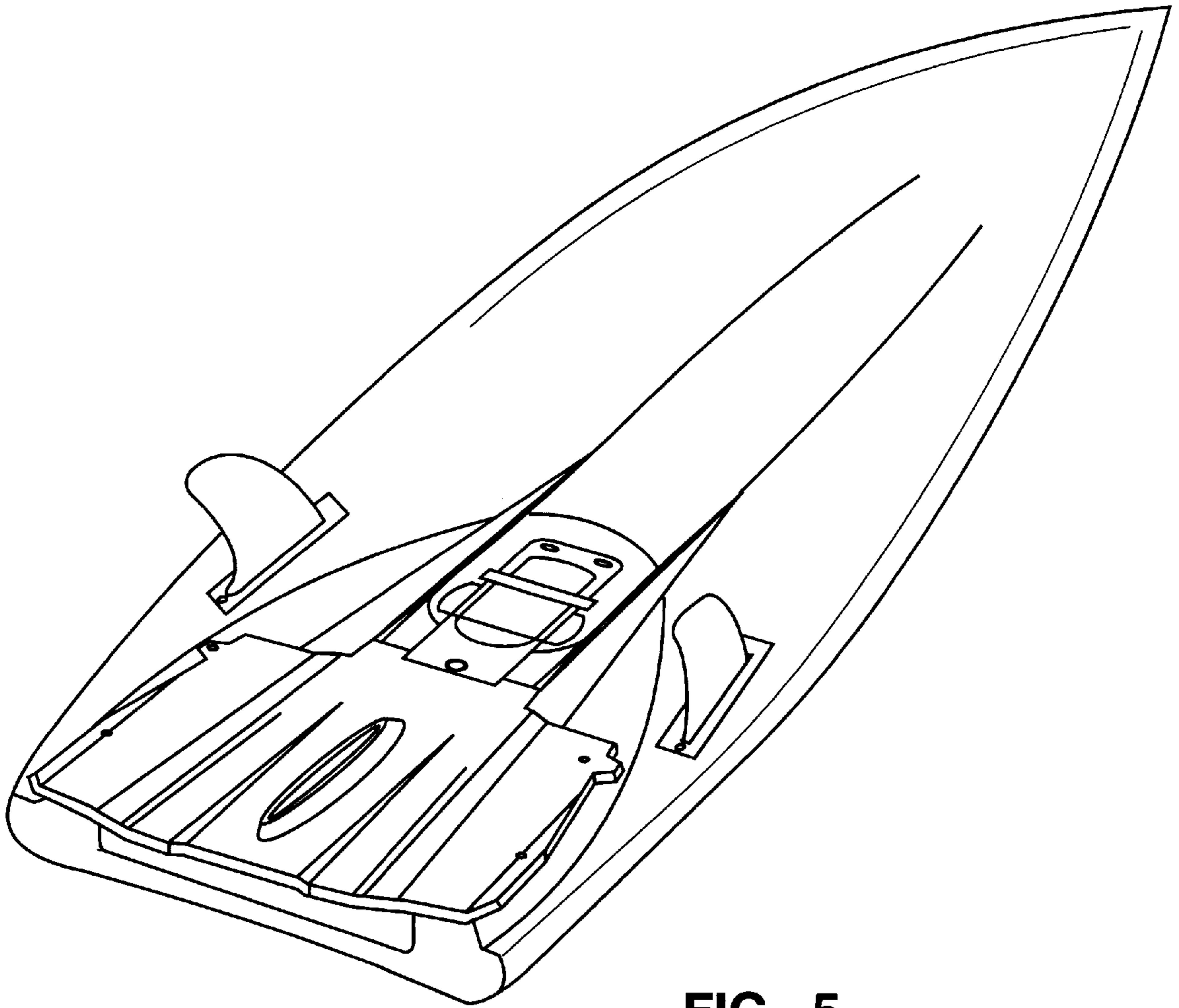
