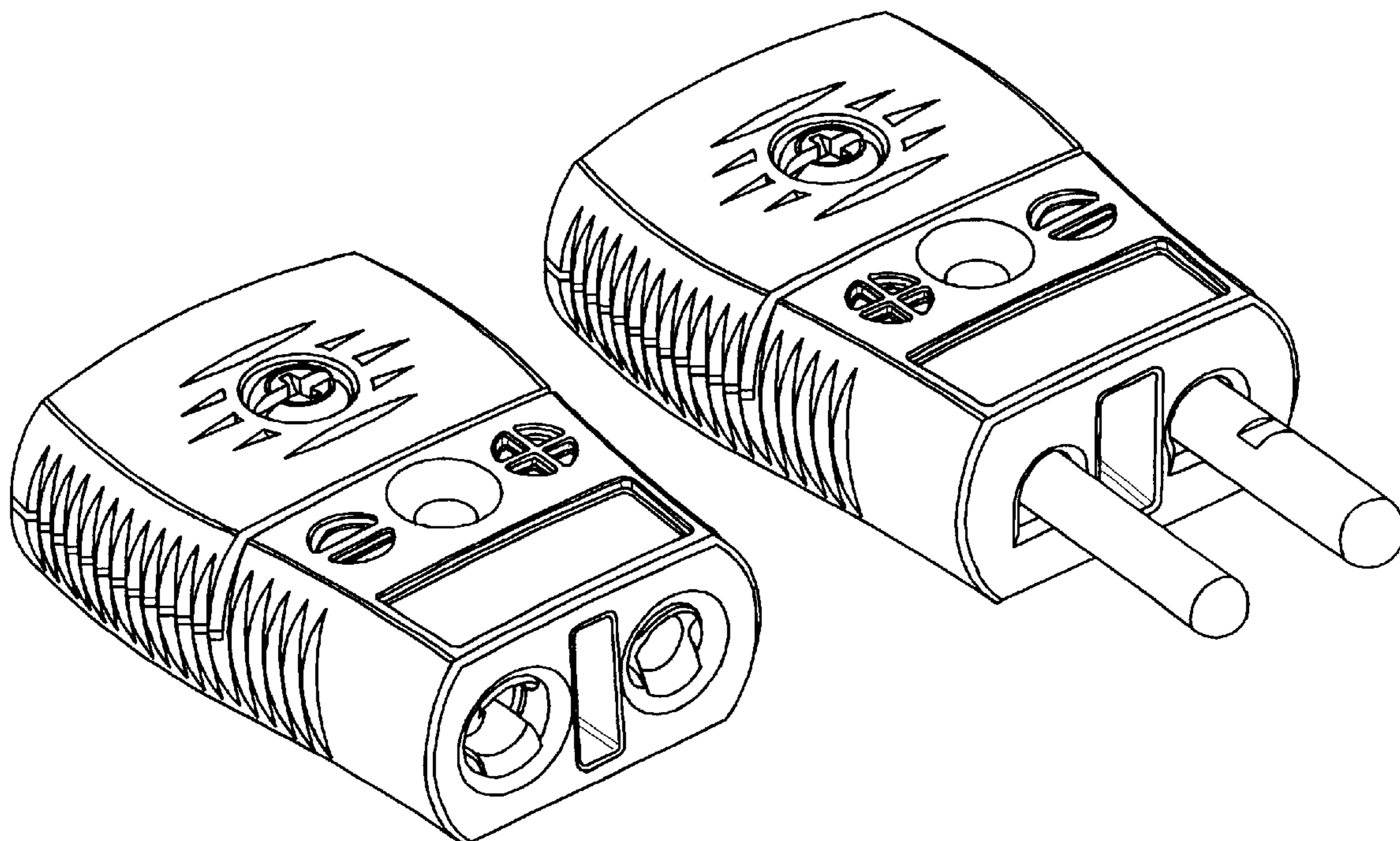
[57] CLAIM

The ornamental design of a thermocouple and RTD connector, as shown and described.

DESCRIPTION

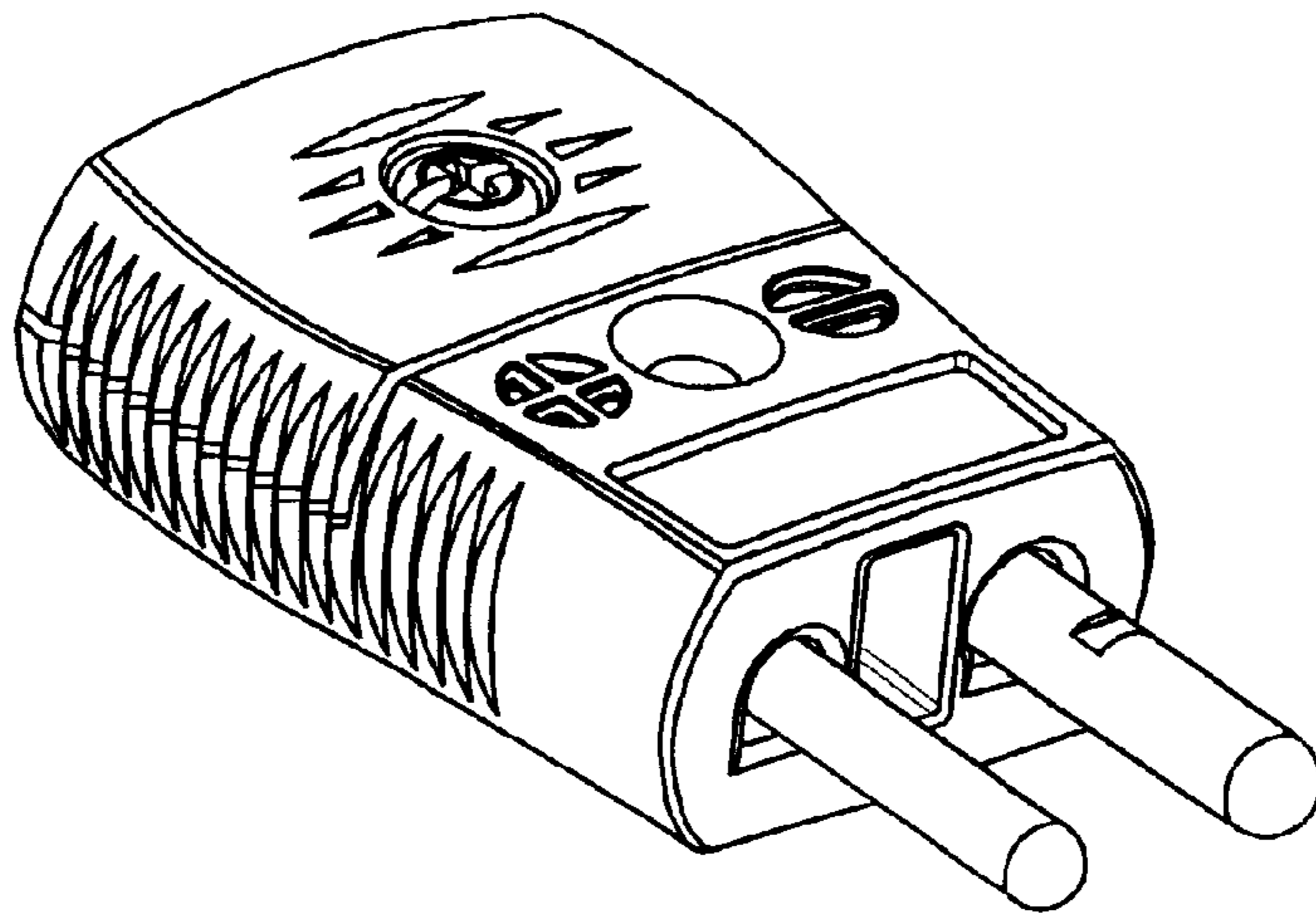

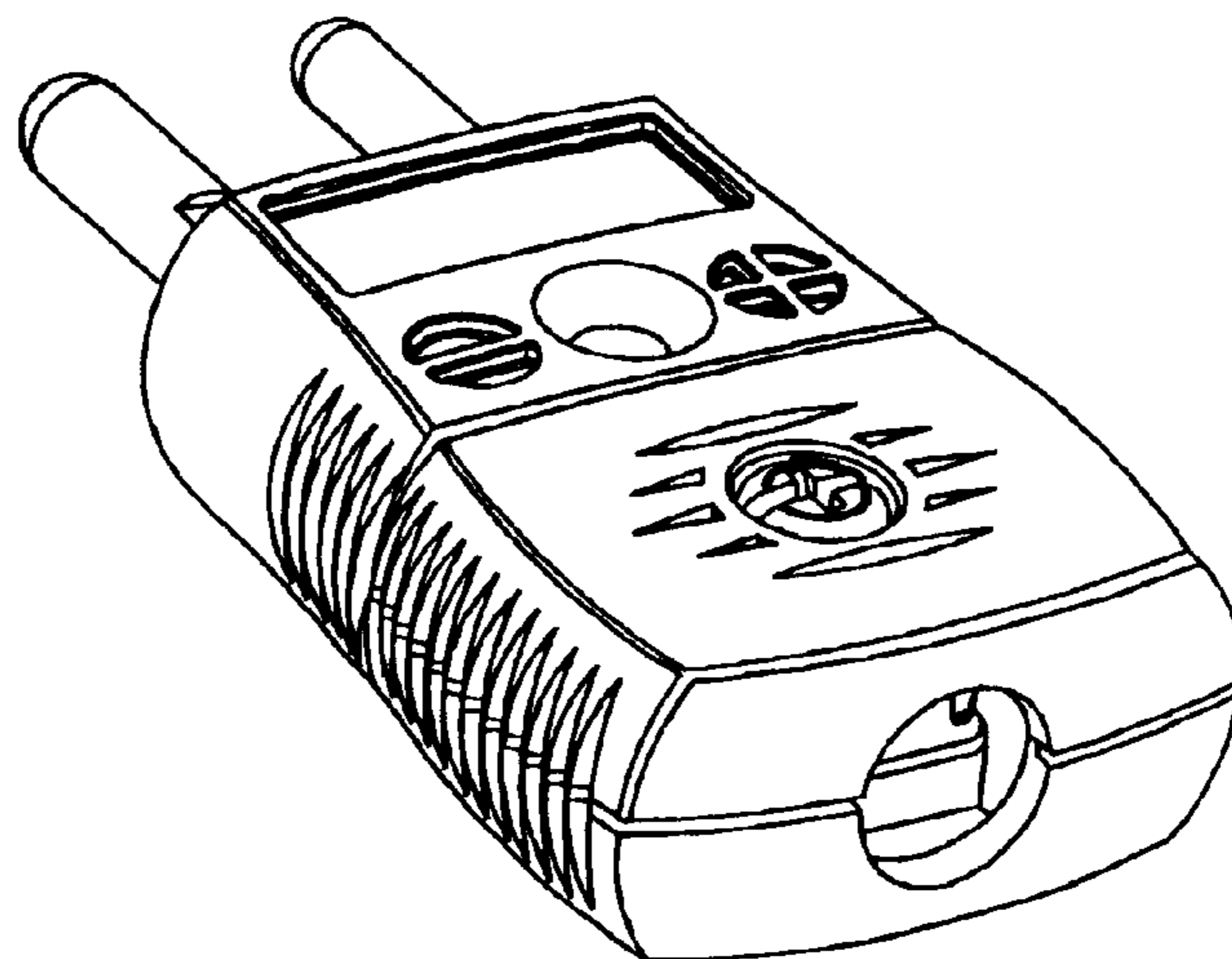

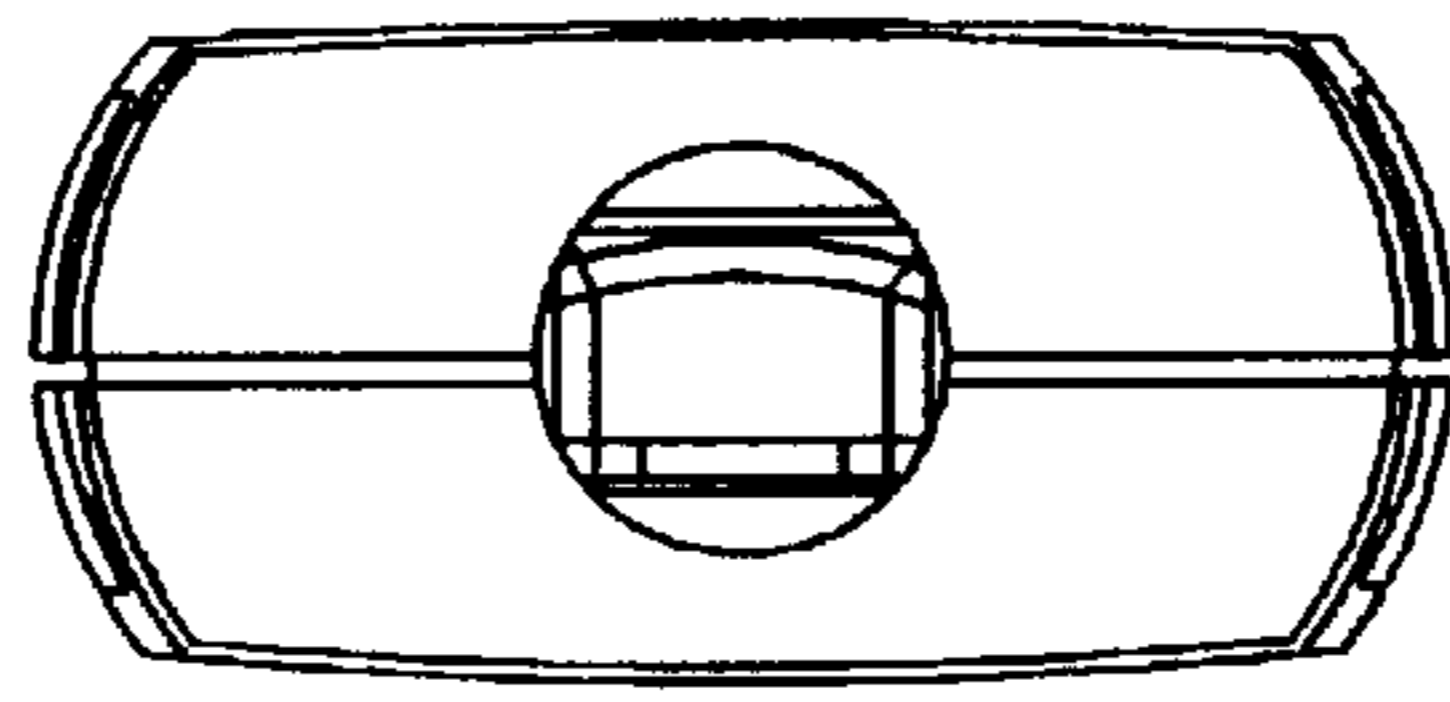

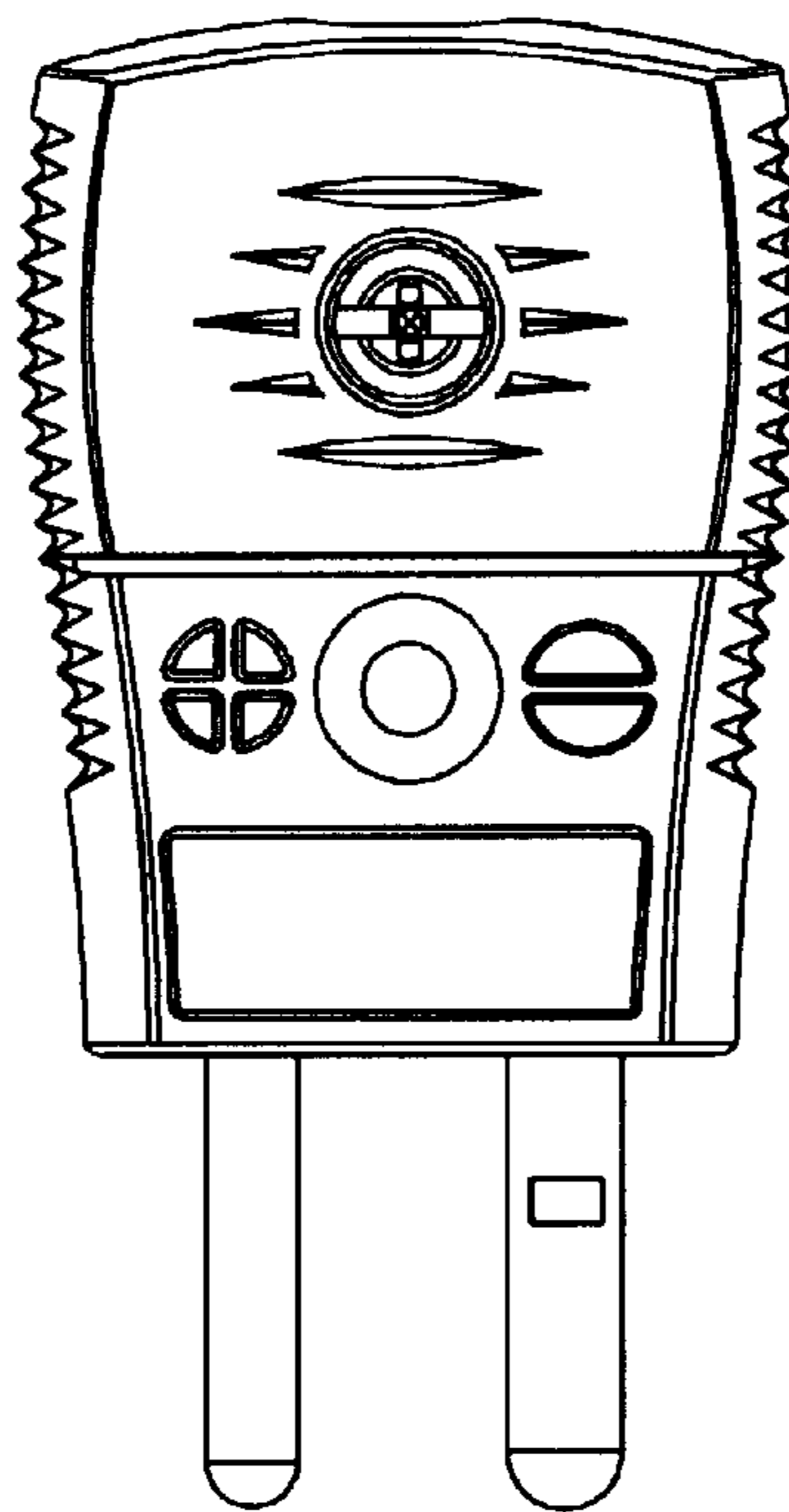

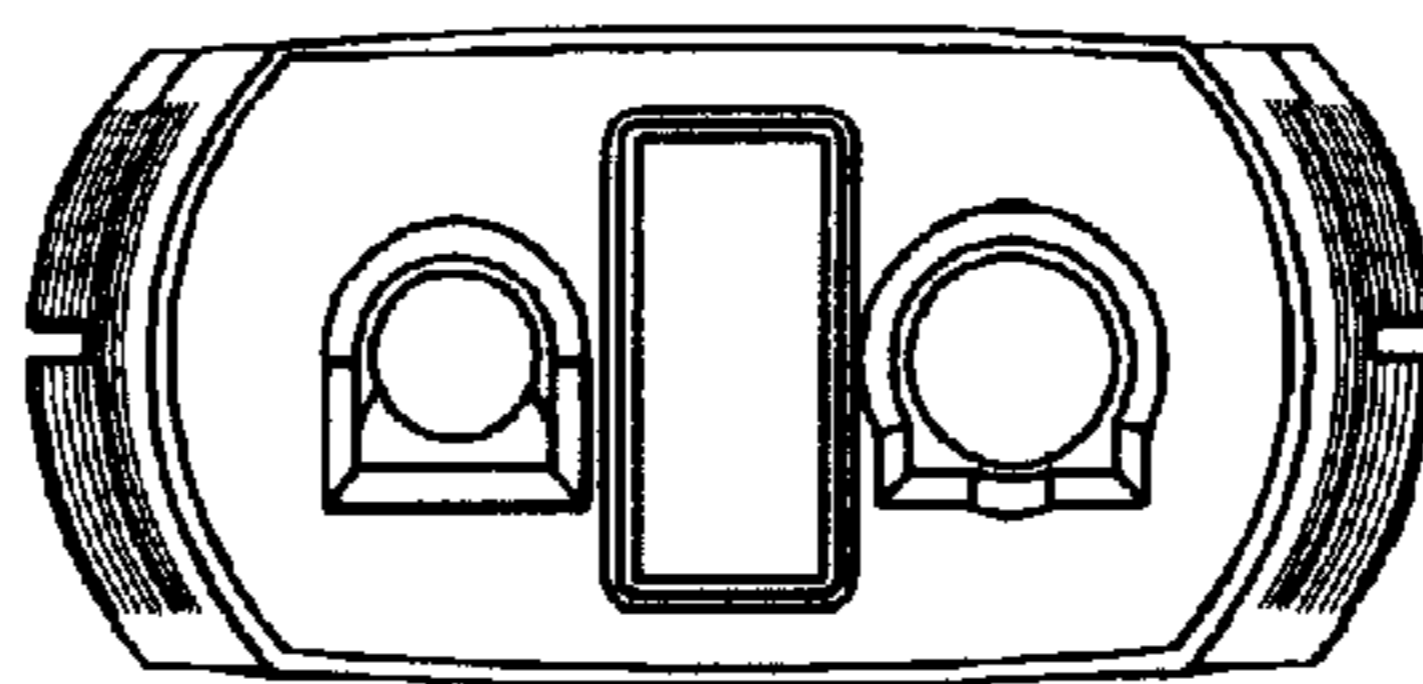

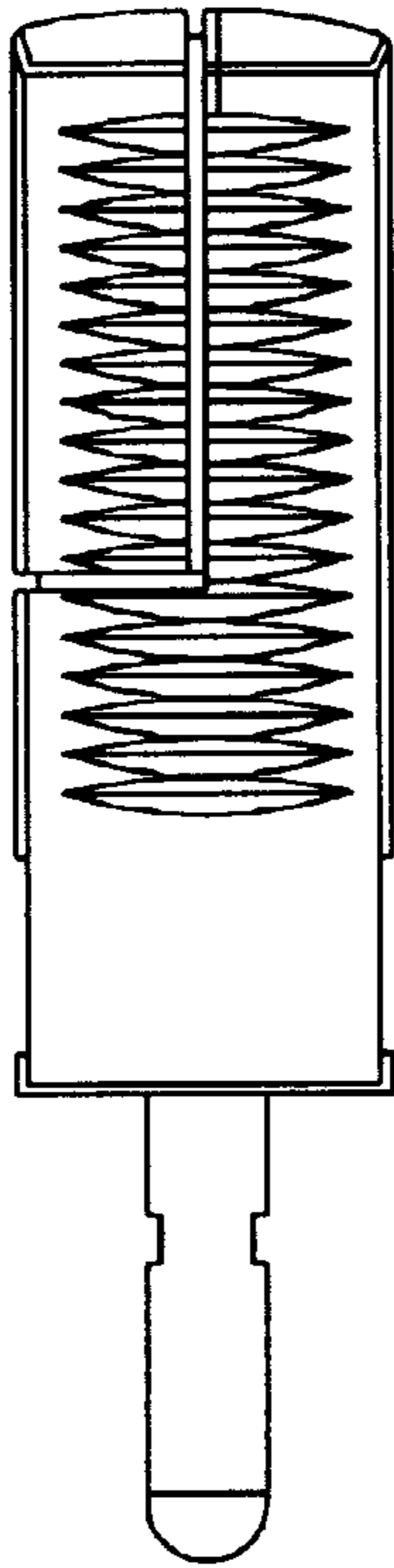

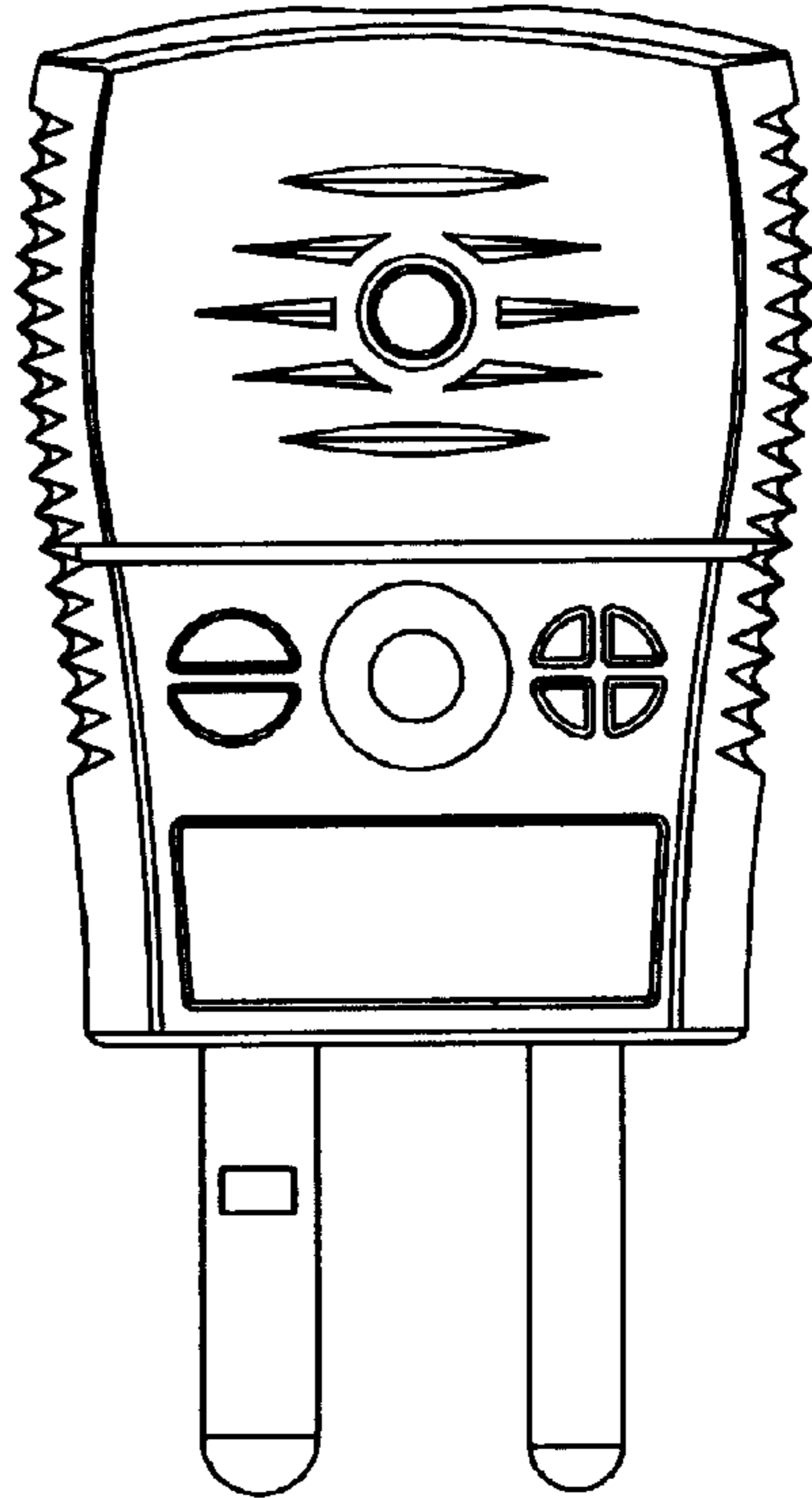

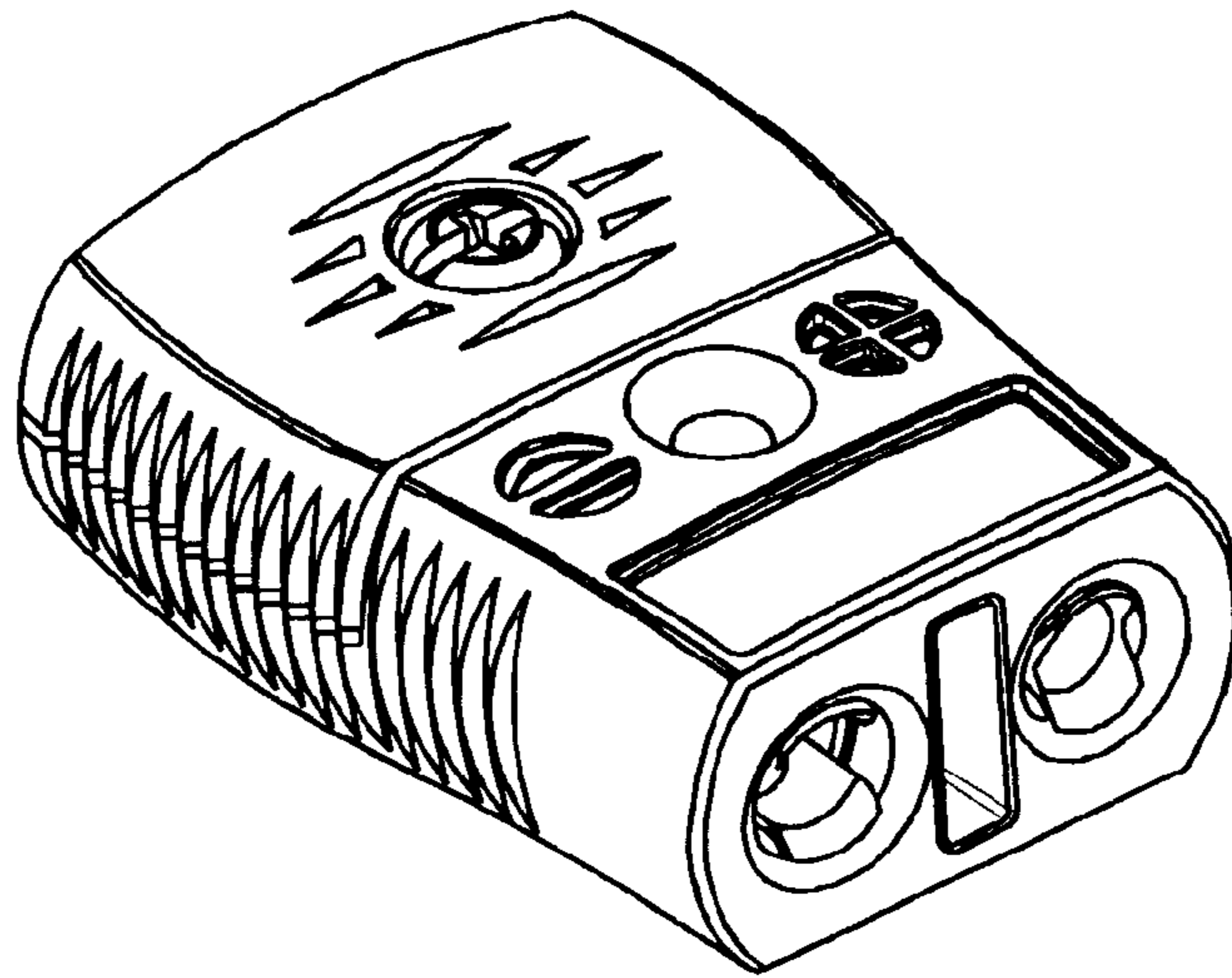

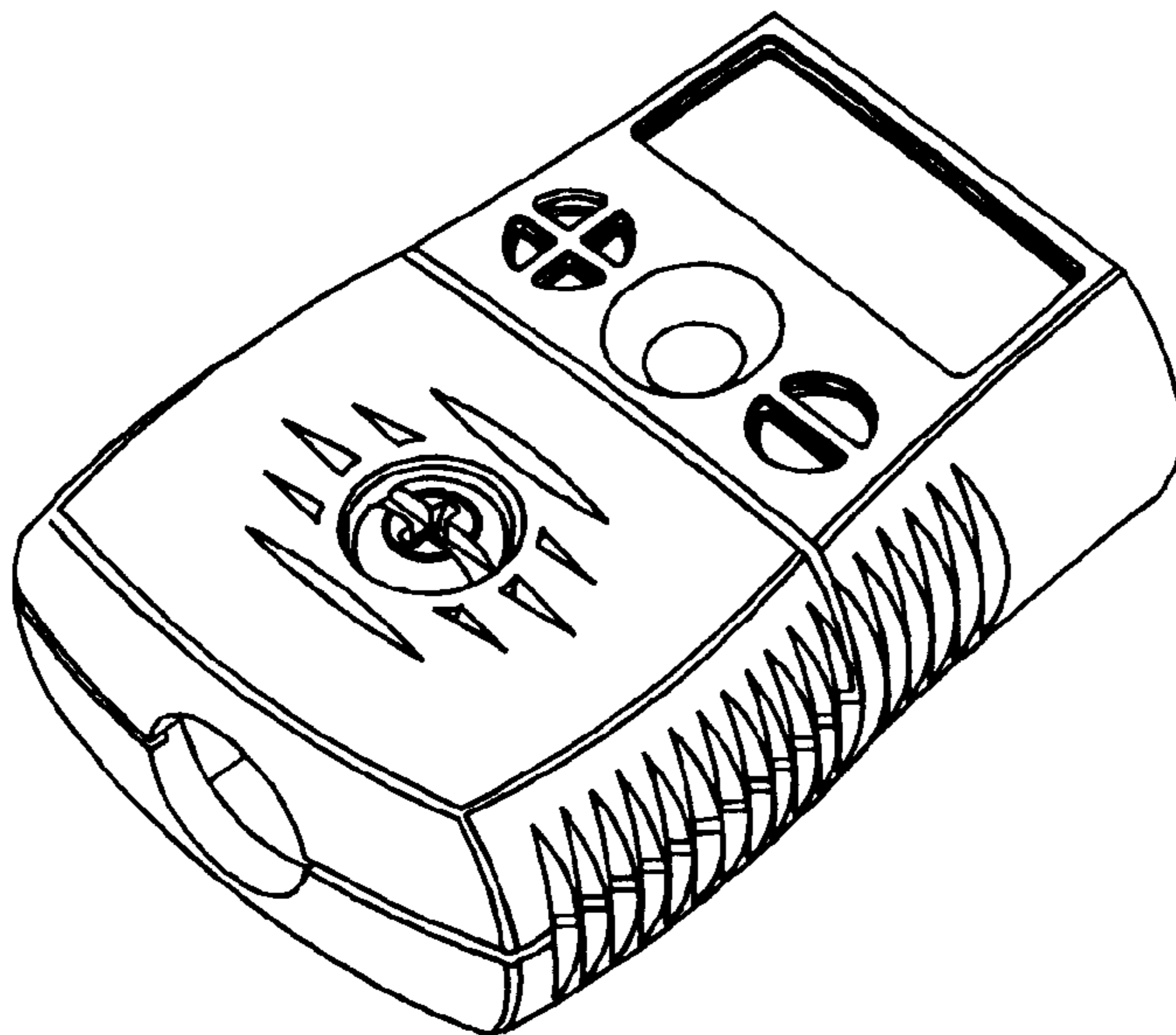

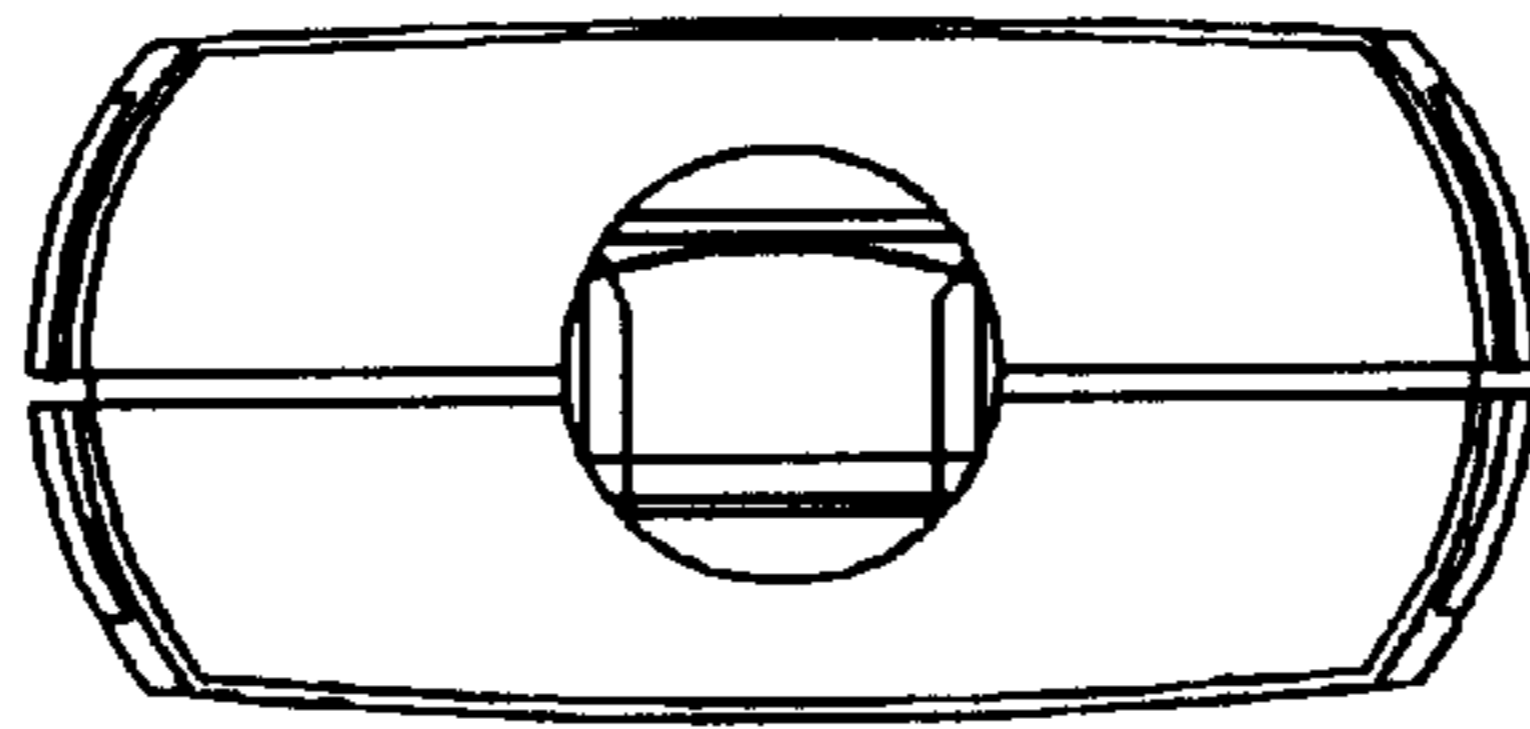

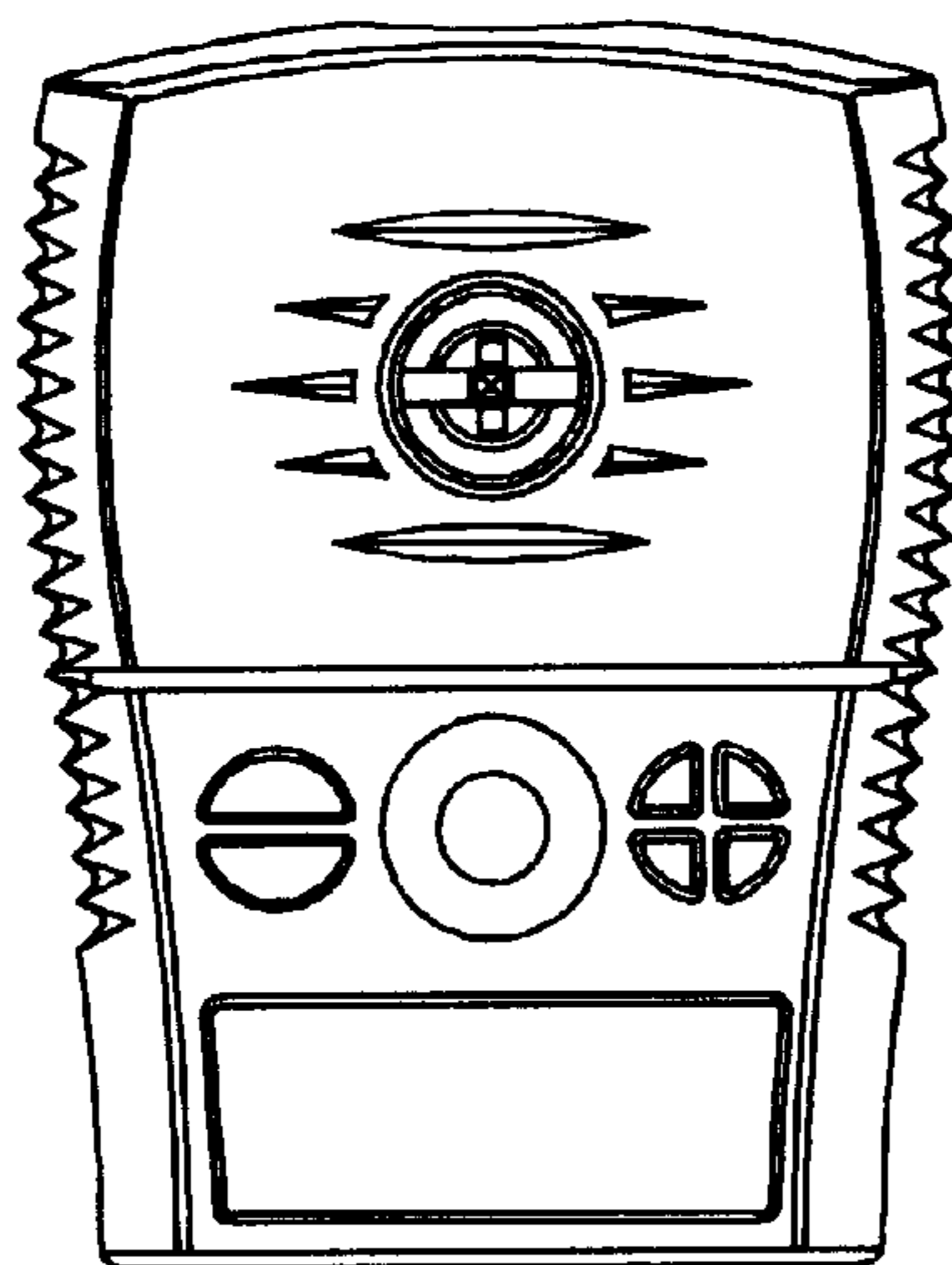

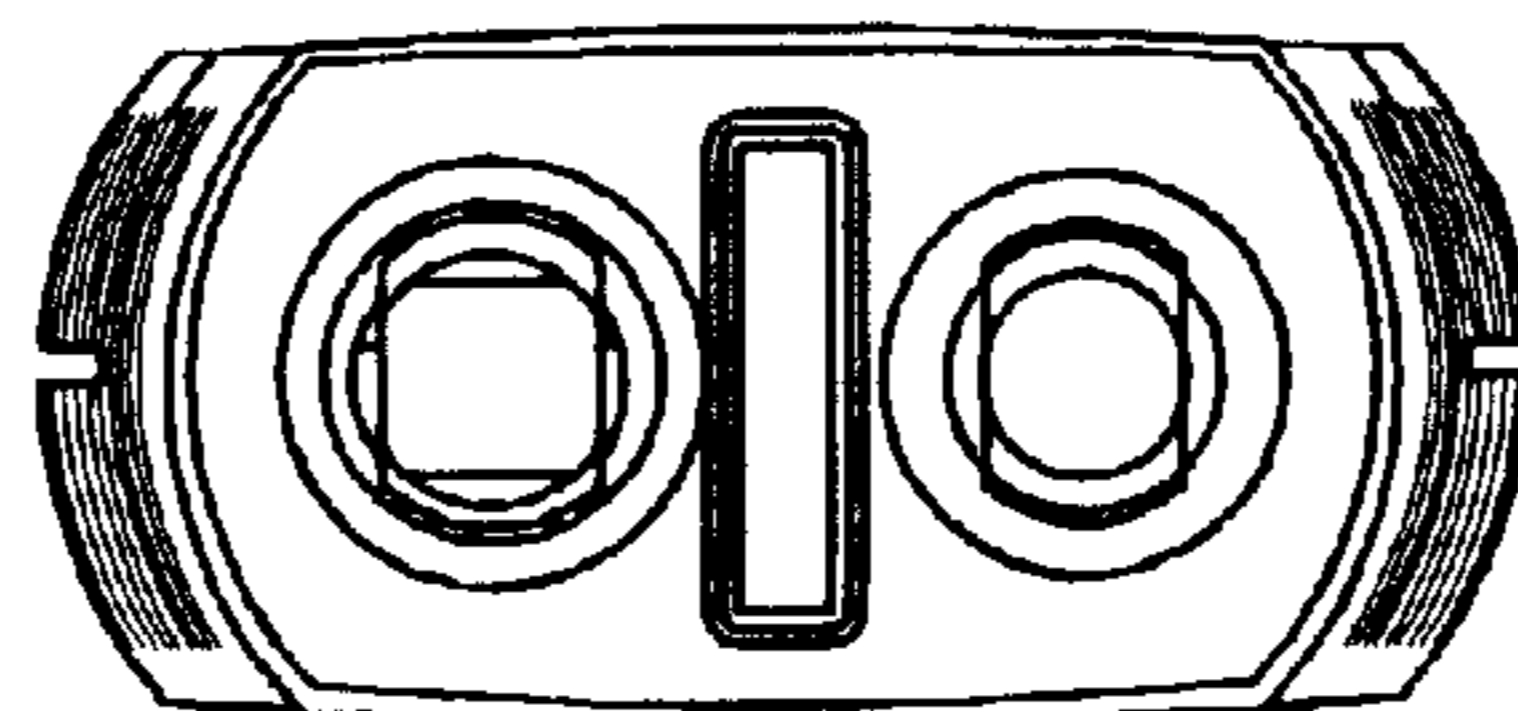

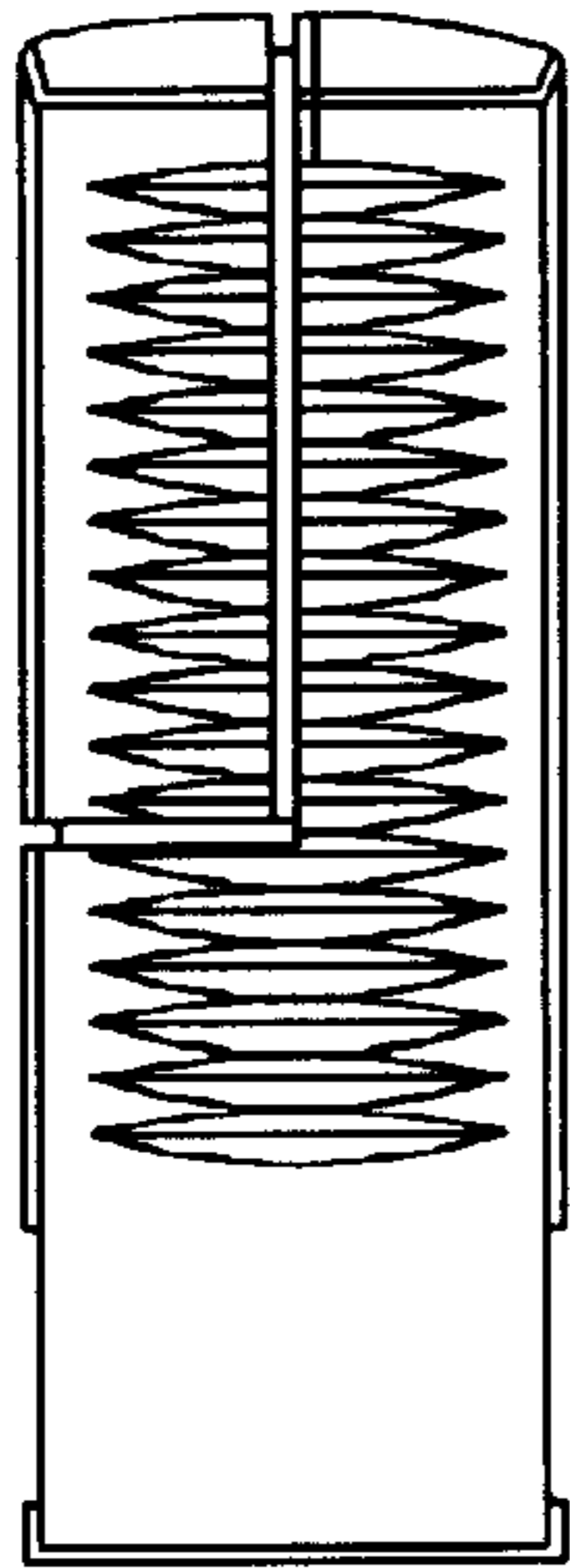

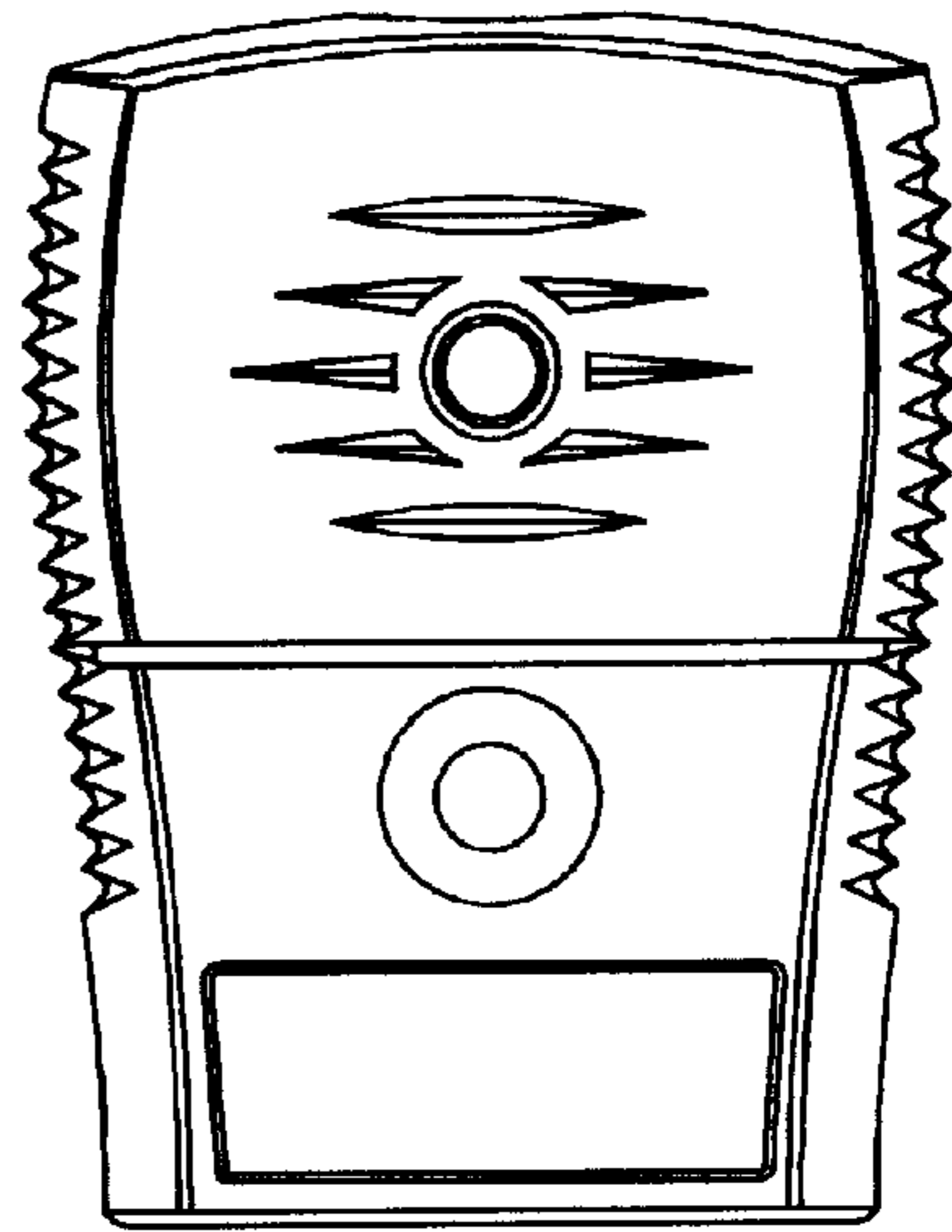

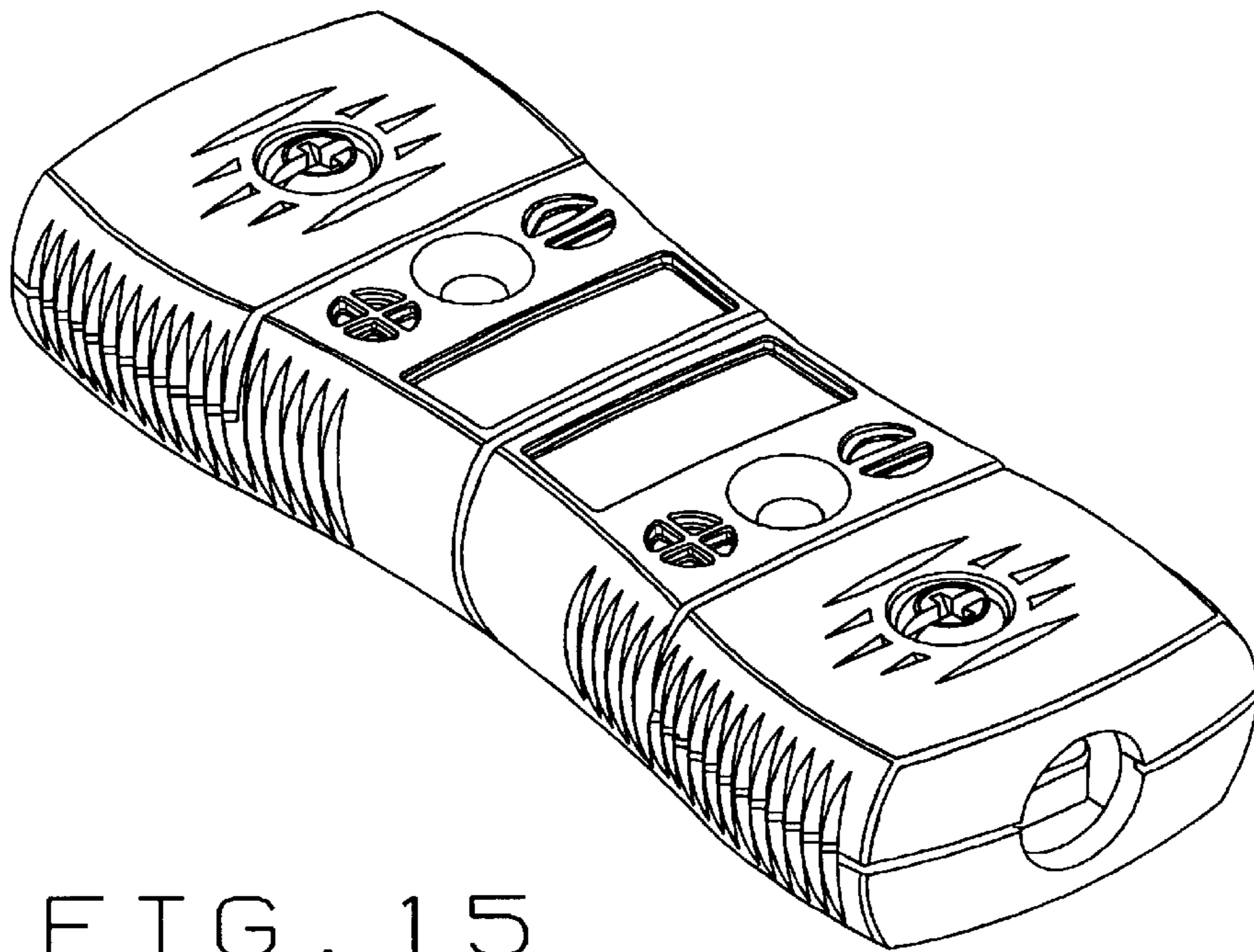

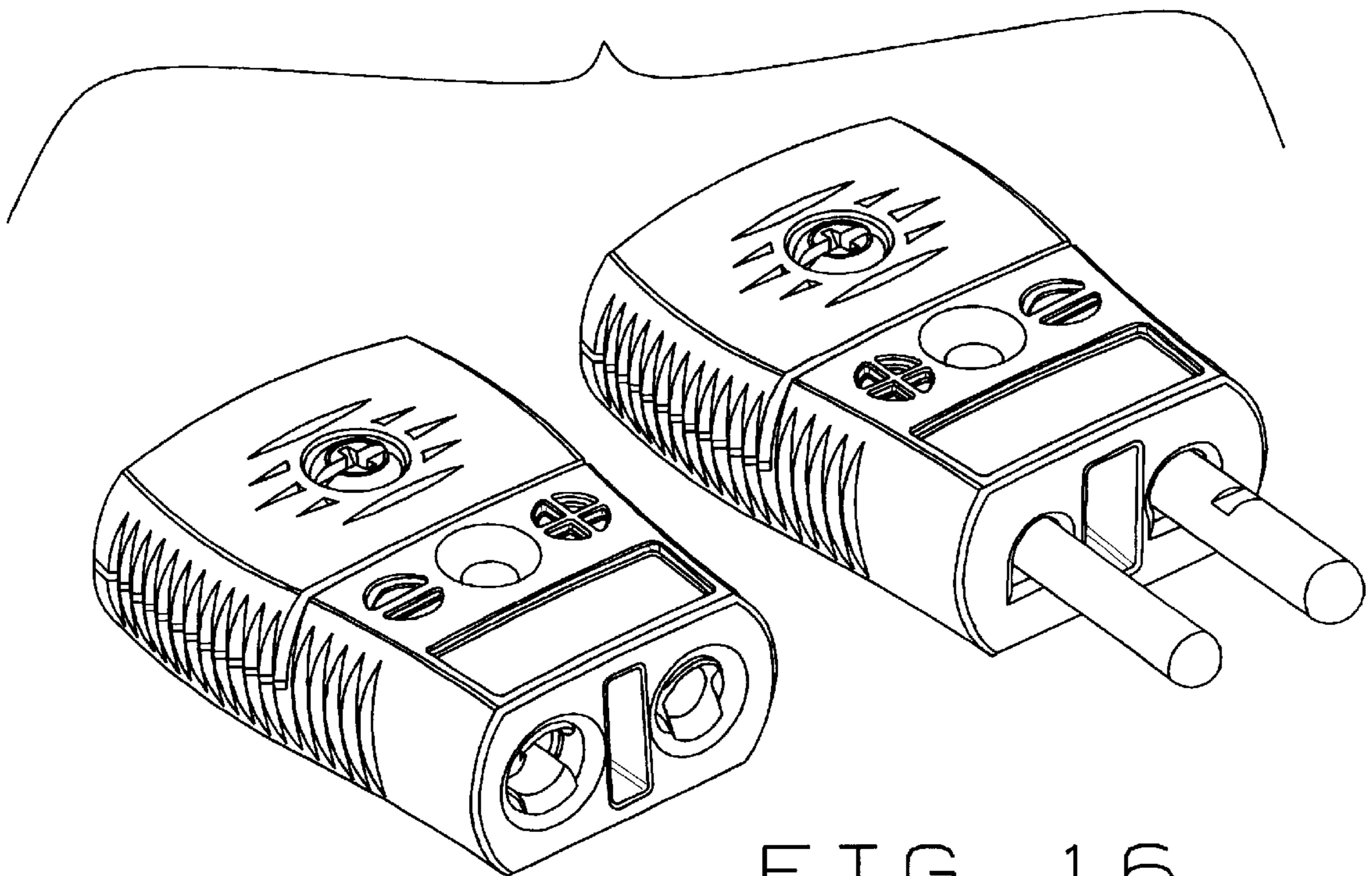
