**DESCRIPTION**

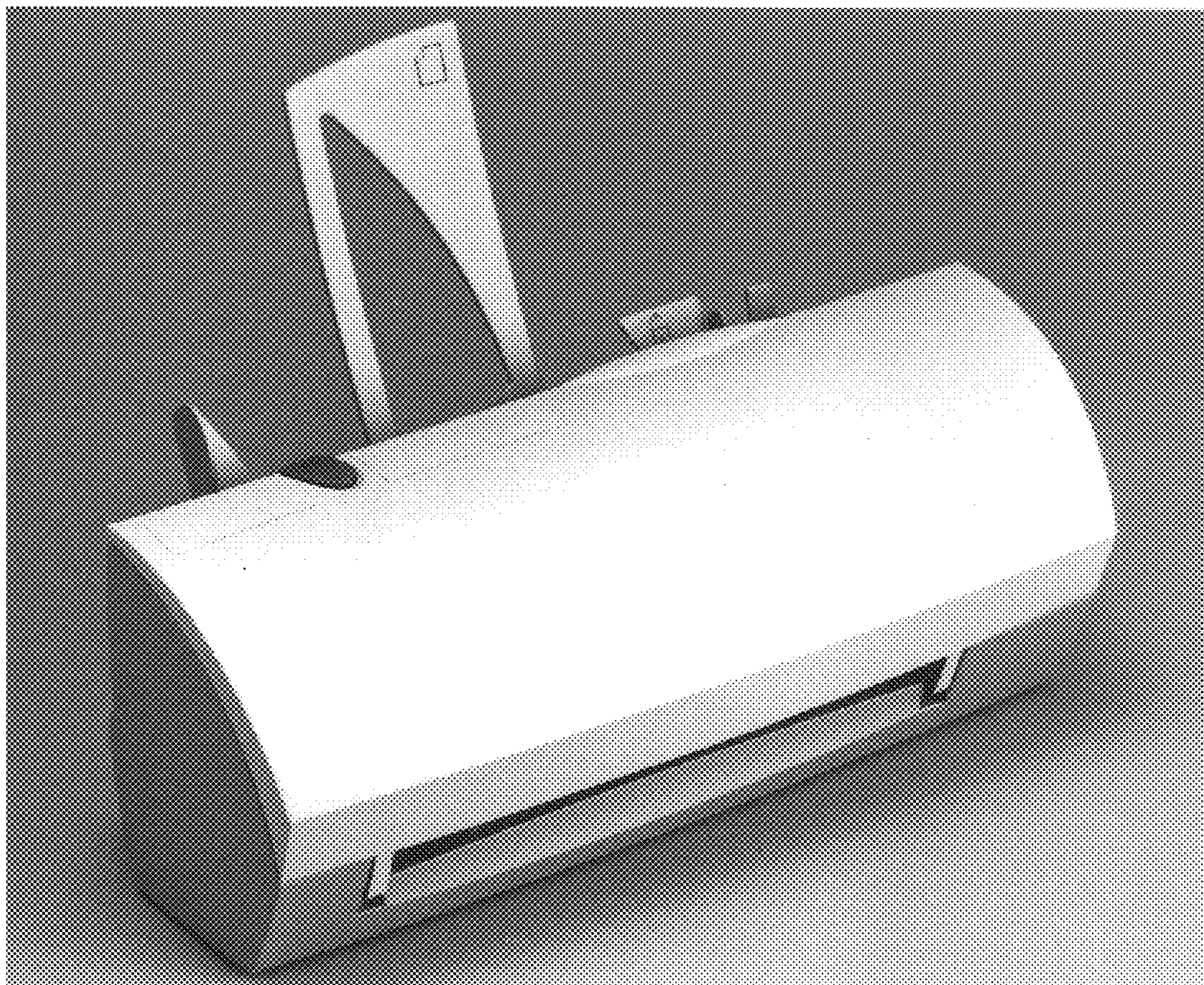
FIG. 1 is a top, front, left side perspective view of a printer showing my new design;

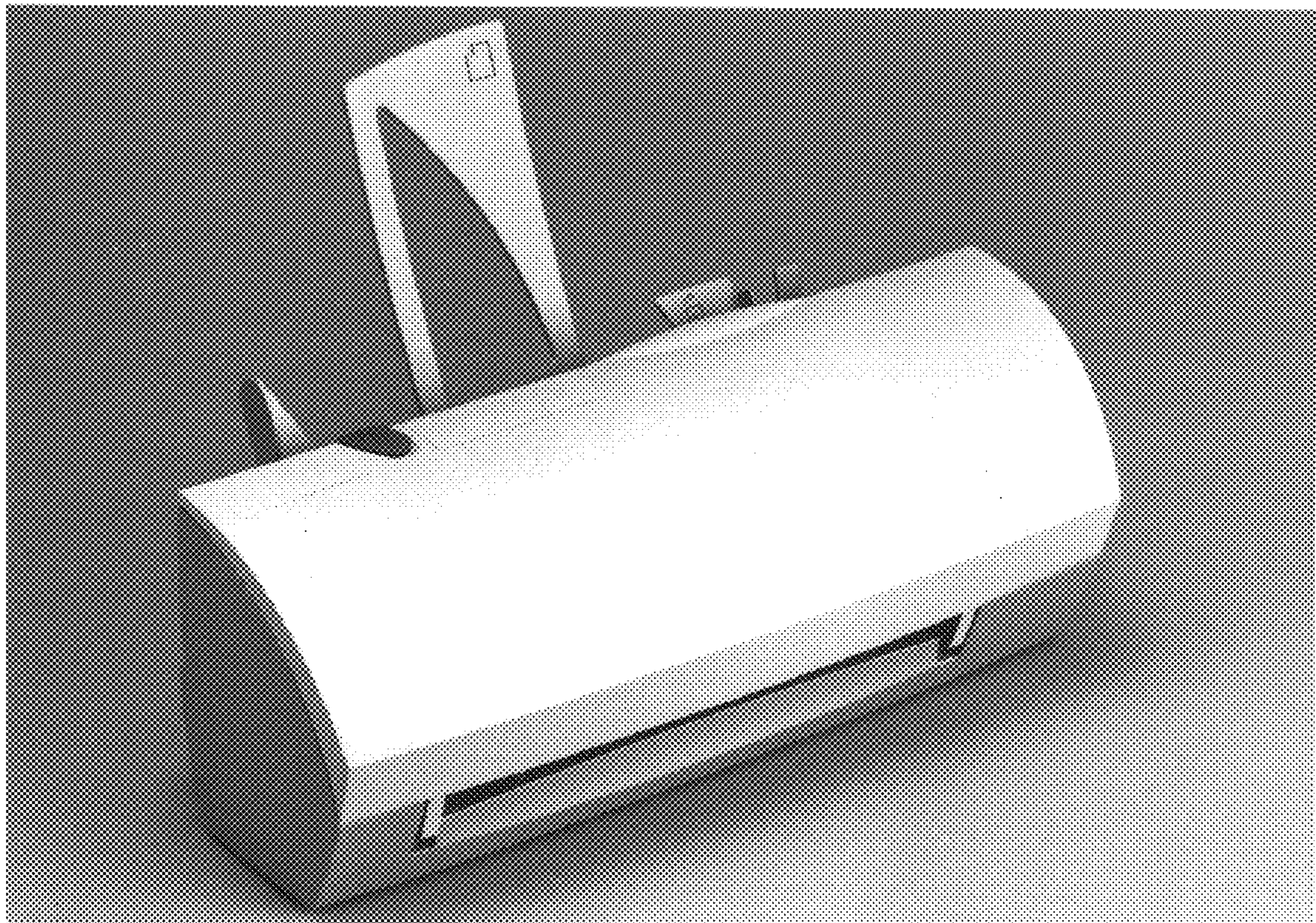

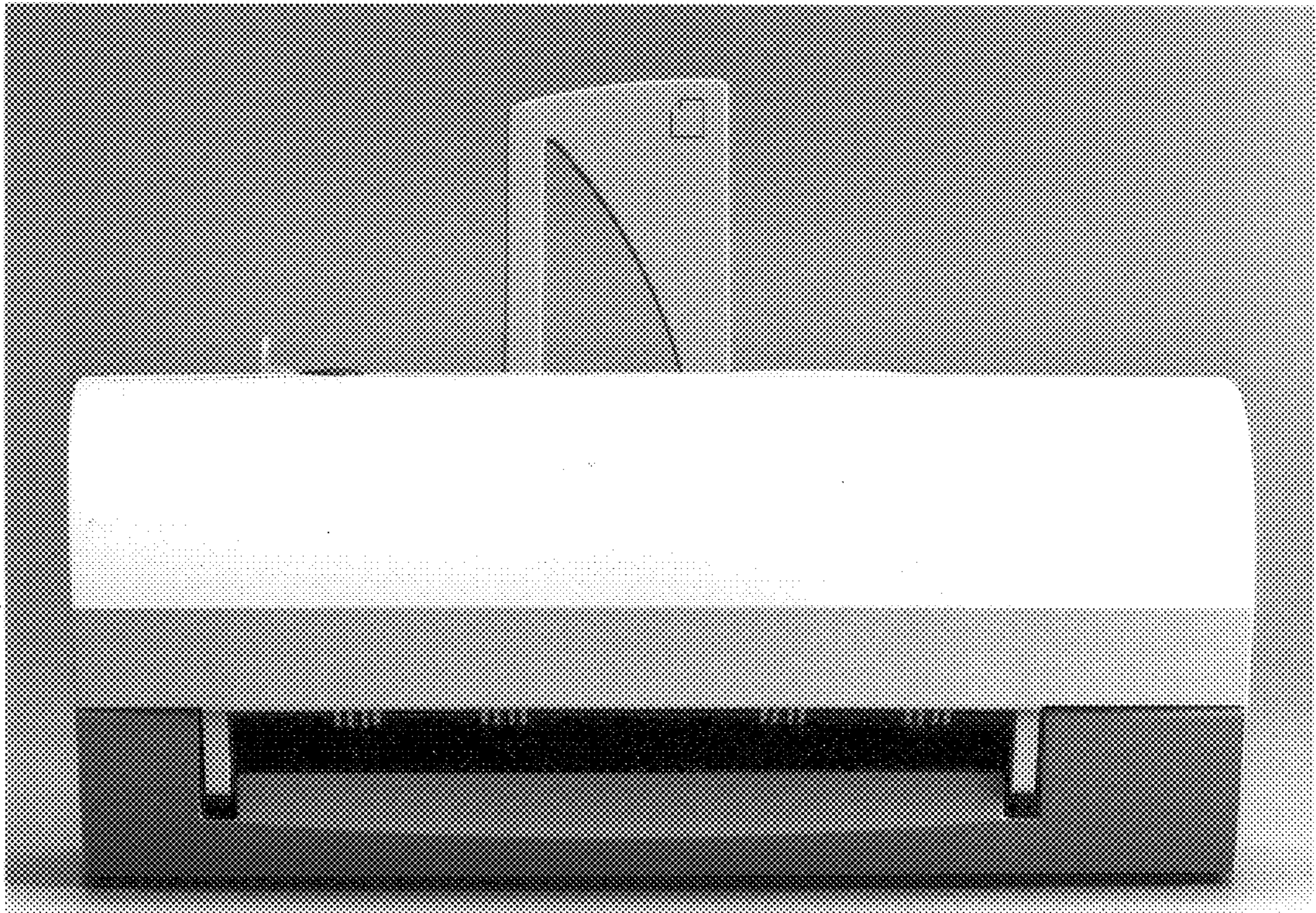

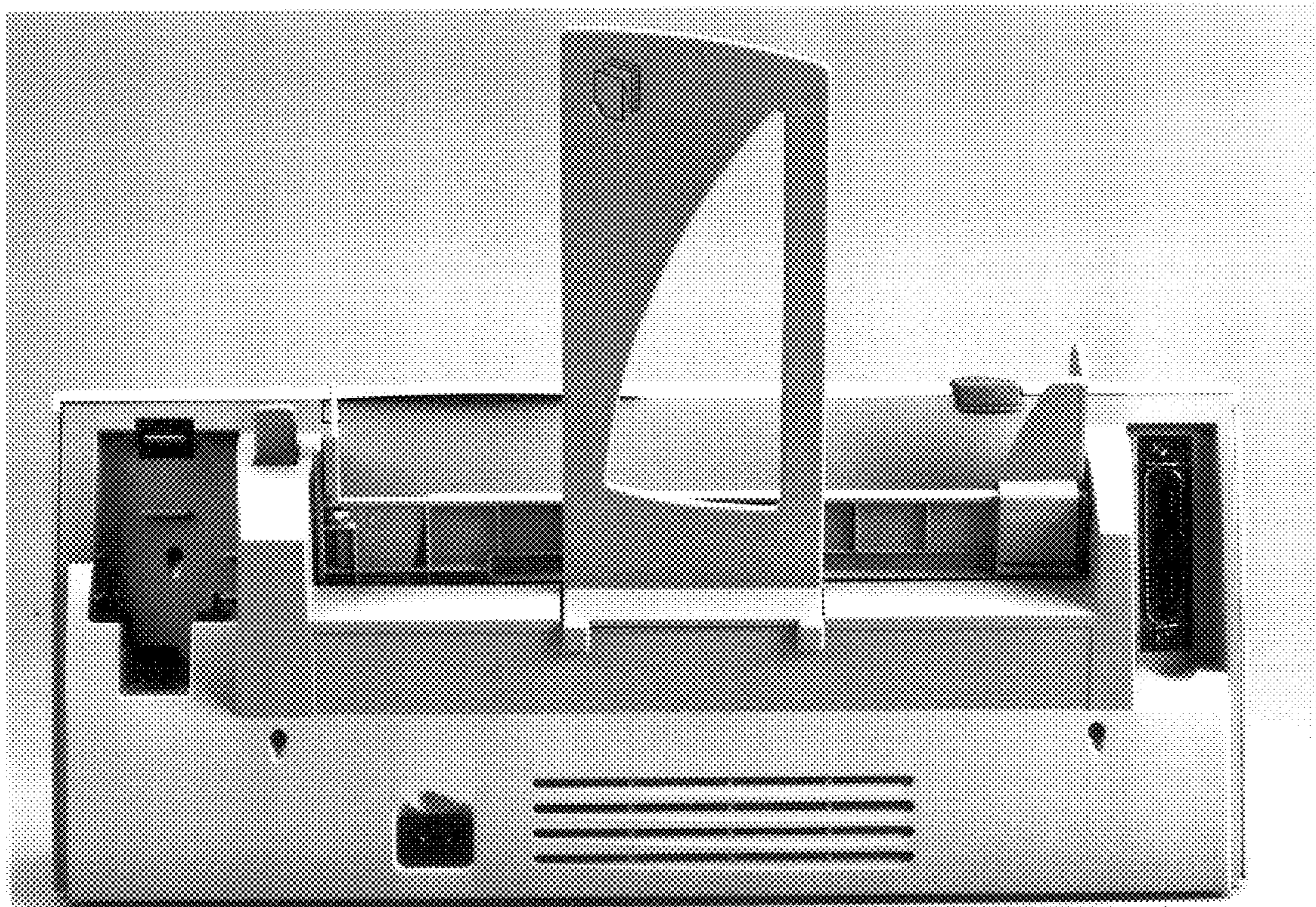

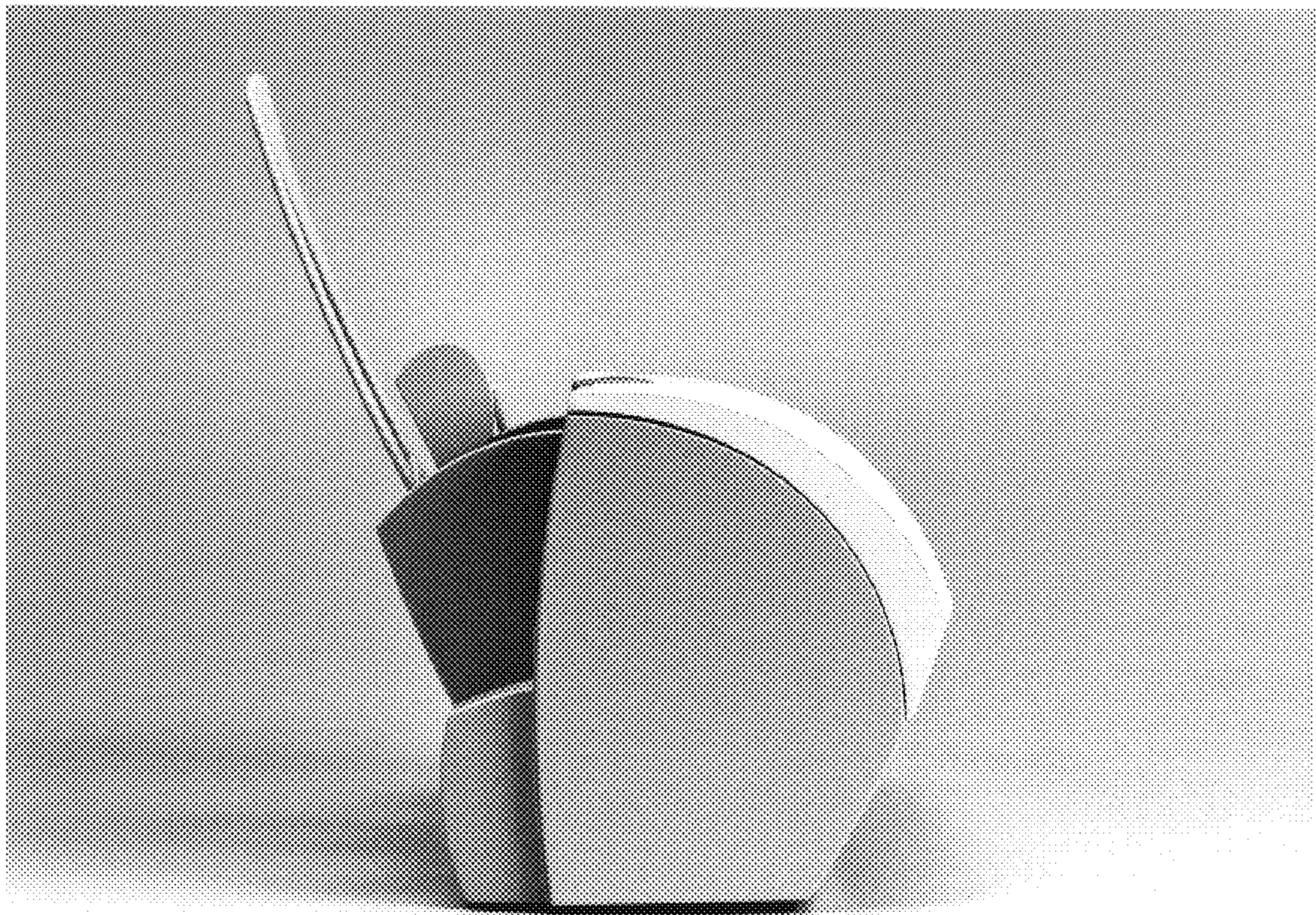

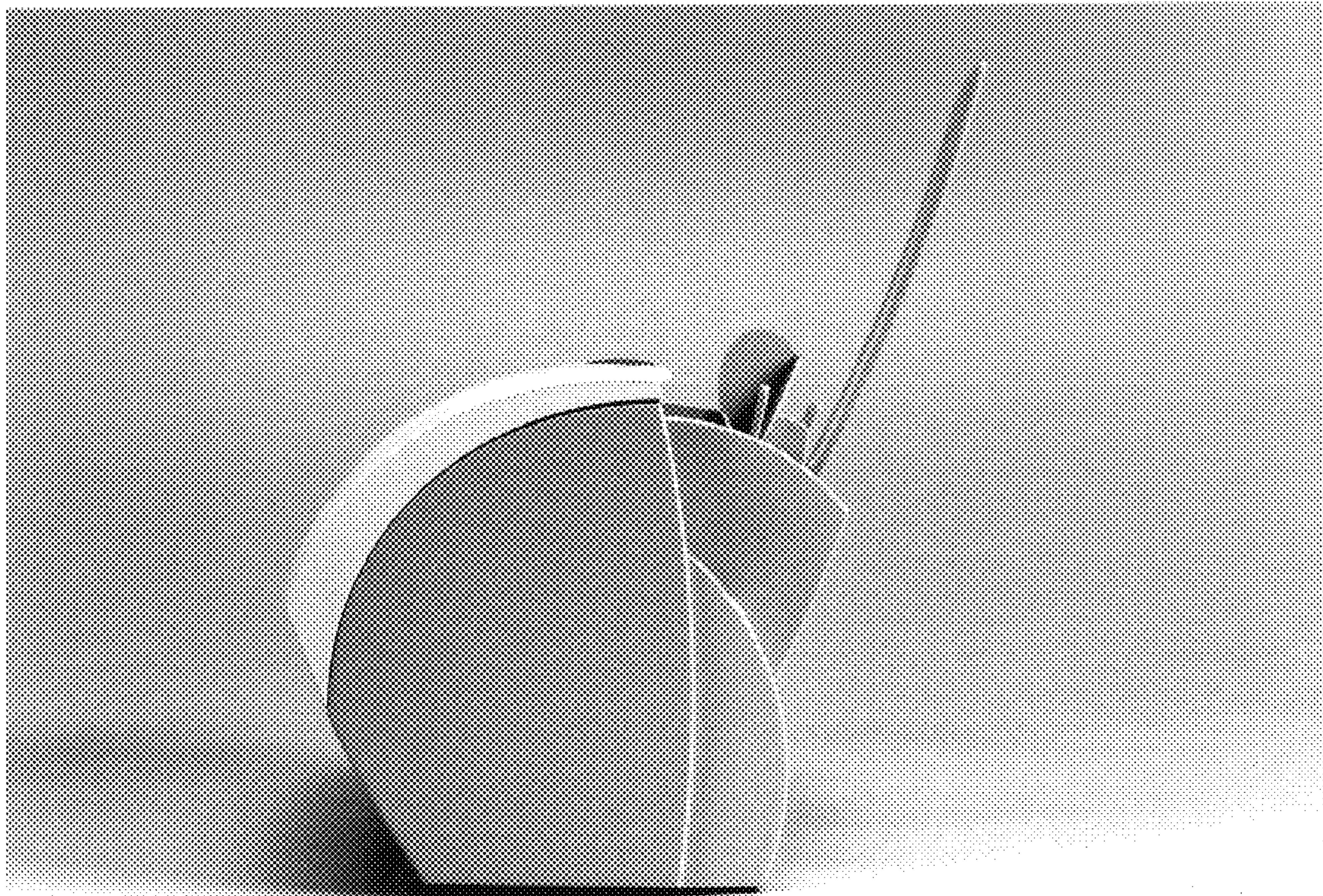

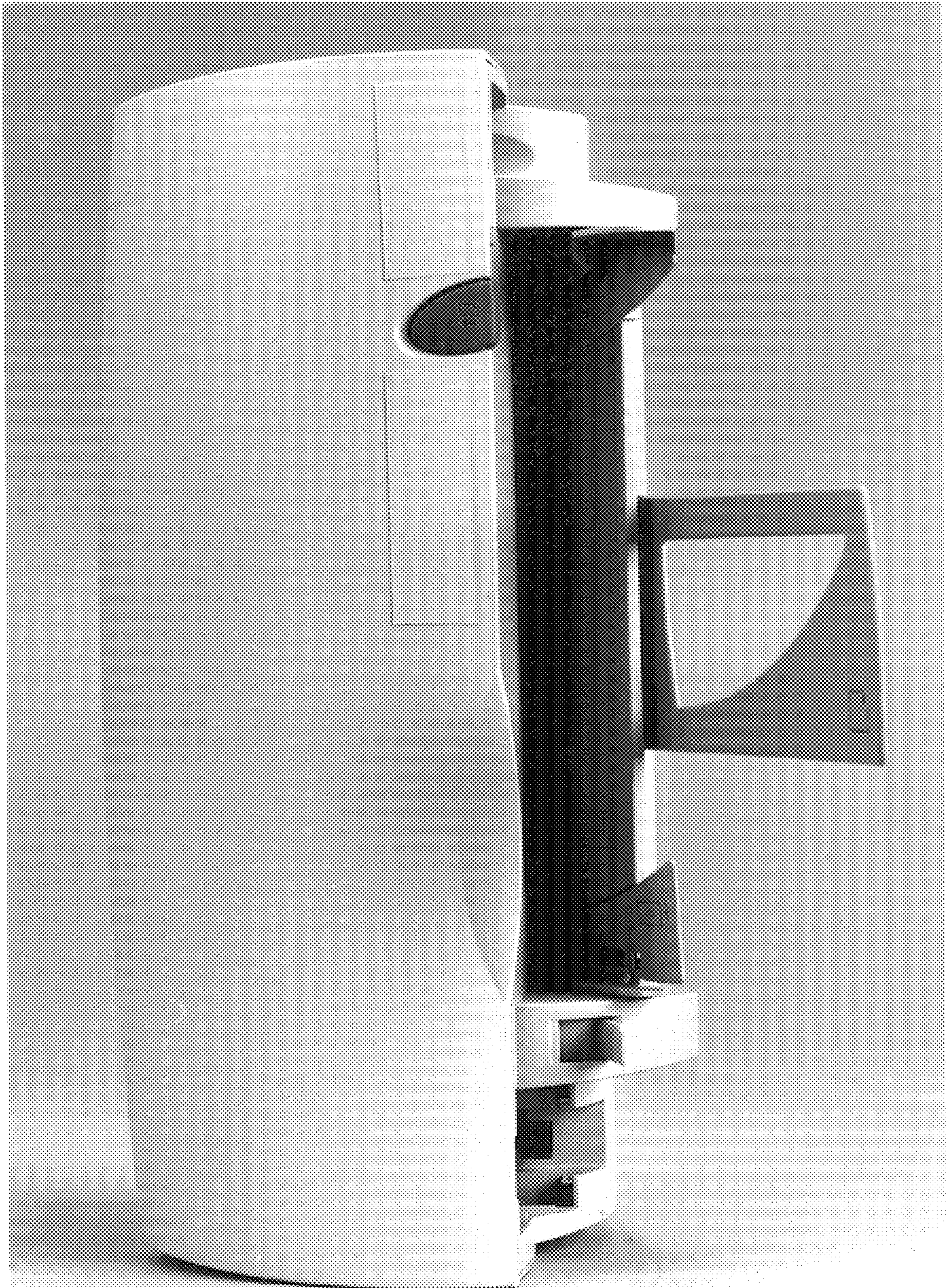
