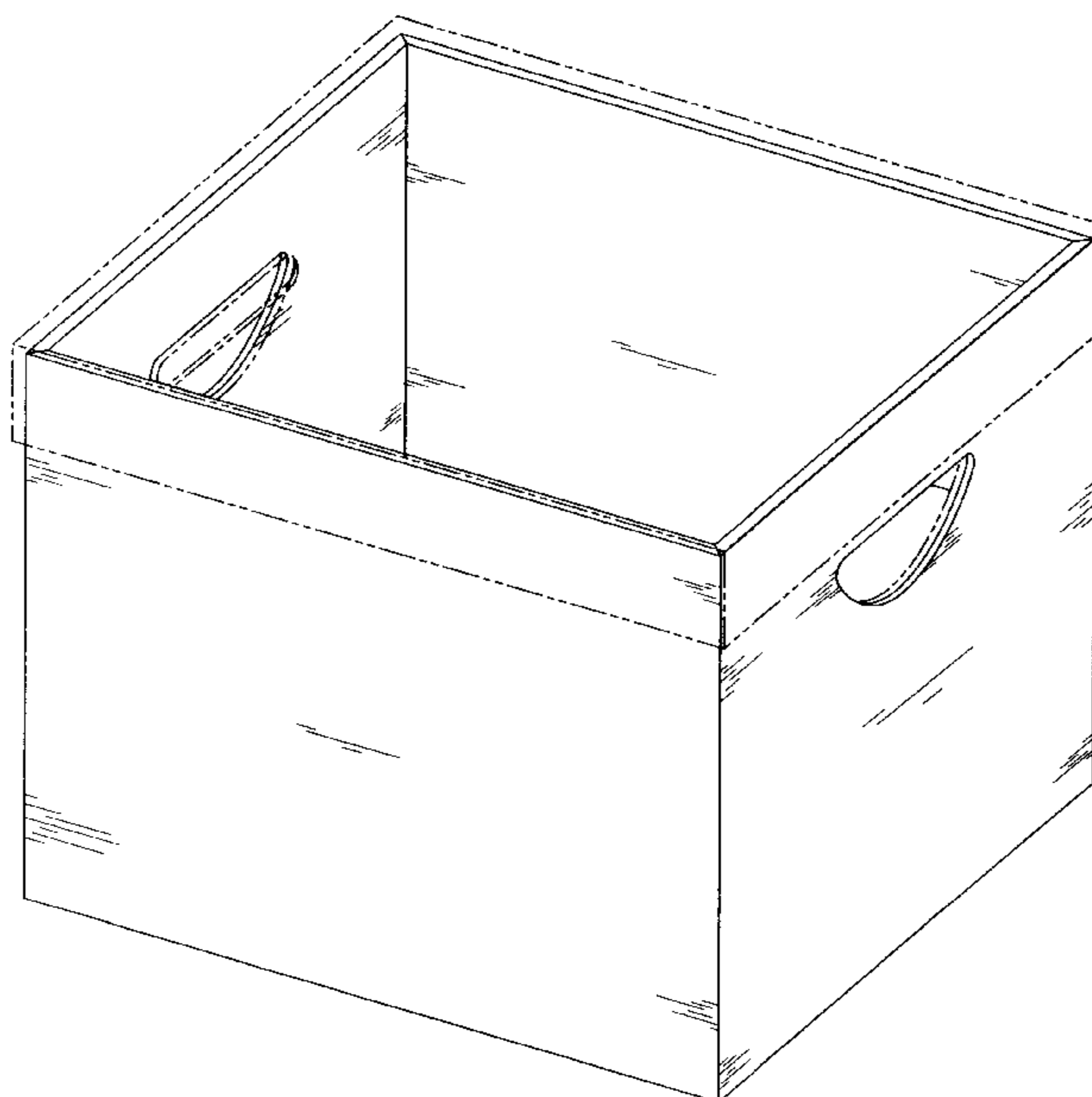
The ornamental design for a storage box, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a storage box illustrating our new design; FIG. 2 is a top view of the storage box shown in FIG. 1; FIG. 3 is a bottom view of the storage box shown in FIG. 1; FIG. 4 is a first side view of the storage box shown in FIG. 1; FIG. 5 is a second side view of the storage box shown in FIG. 1; FIG. 6 is a third side view of the storage box shown in FIG. 1; FIG. 7 is a fourth side view of the storage box shown in FIG. 1; FIG. 8 is a perspective view of a second embodiment of a storage box illustrating our new design; FIG. 9 is a top view of the storage box shown in FIG. 8; FIG. 10 is a bottom view of the storage box shown in FIG. 8; FIG. 11 is a first side view of the storage box shown in FIG. 8; FIG. 12 is a second side view of the storage box shown in FIG. 8; FIG. 13 is a third side view of the storage box shown in FIG. 8; and, FIG. 14 is a fourth side view of the storage box shown in FIG. 8.

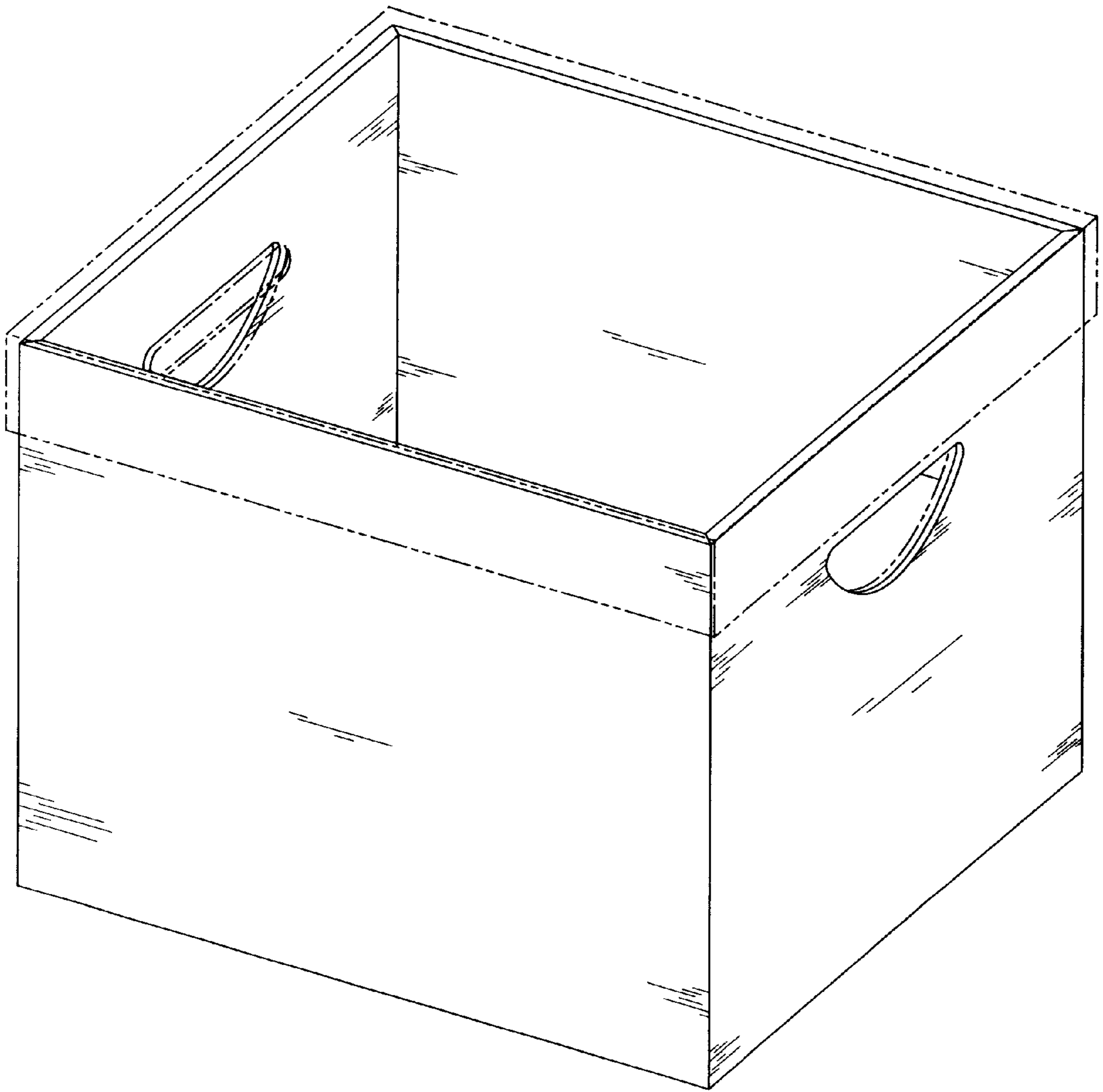

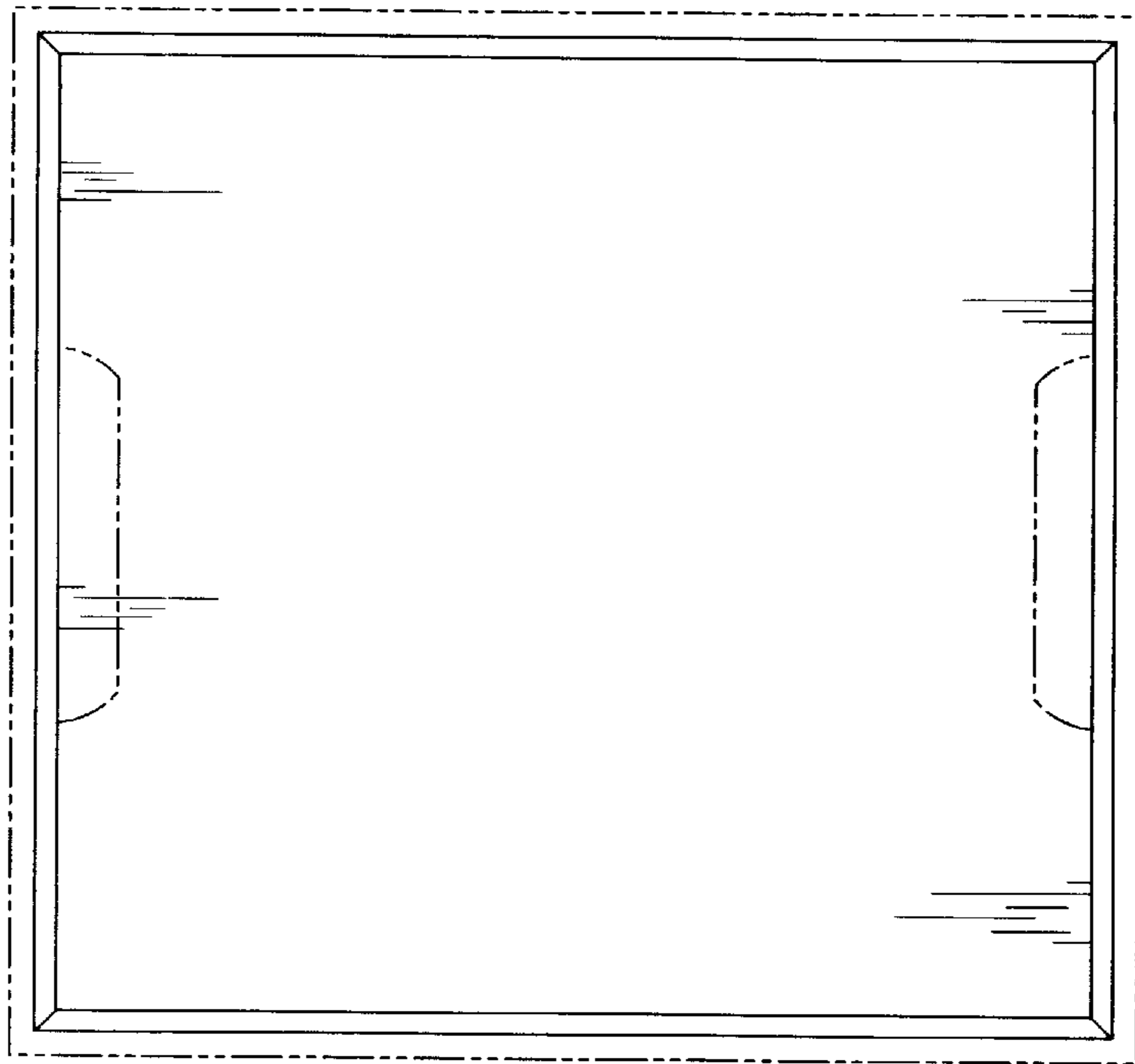

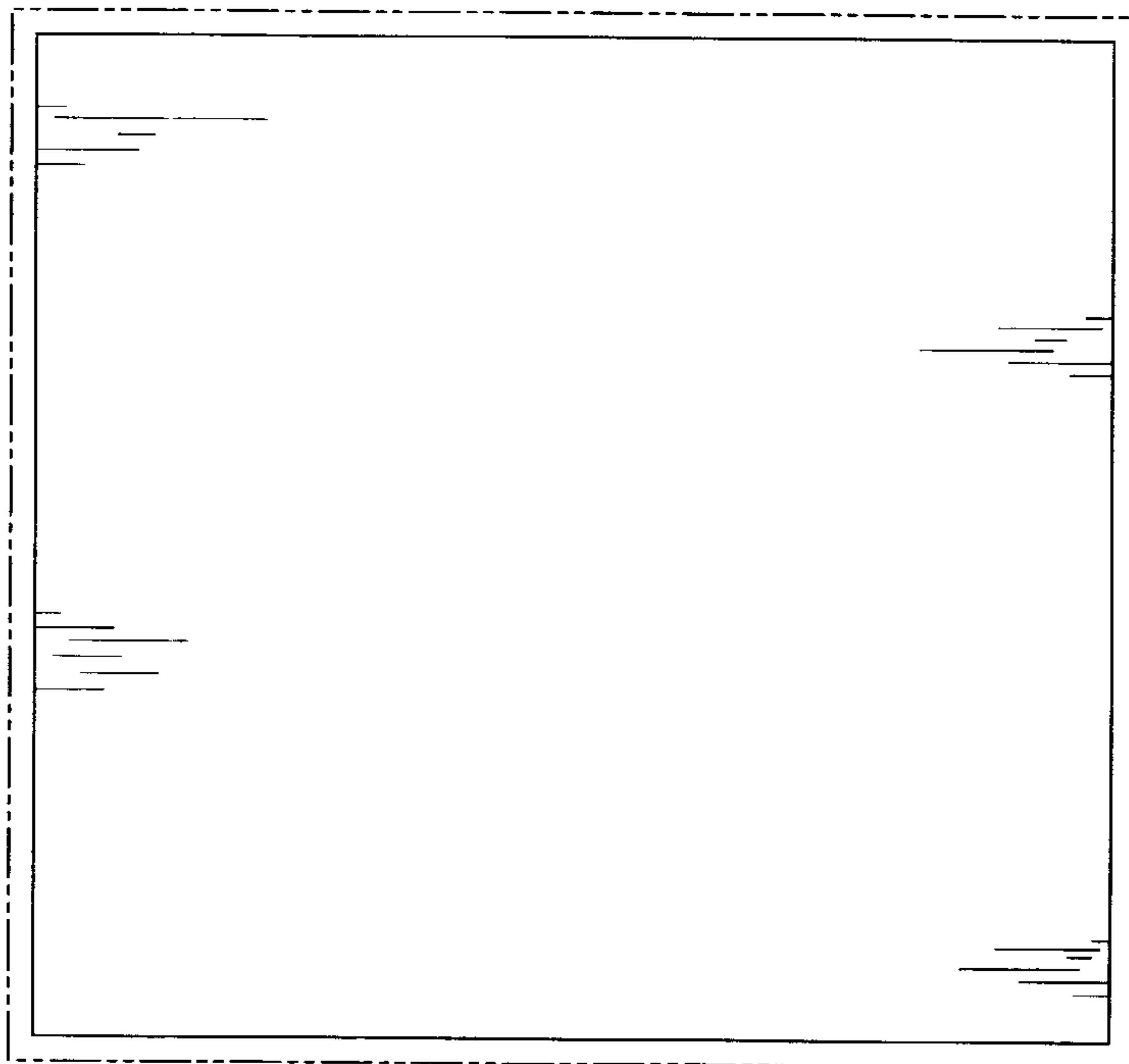

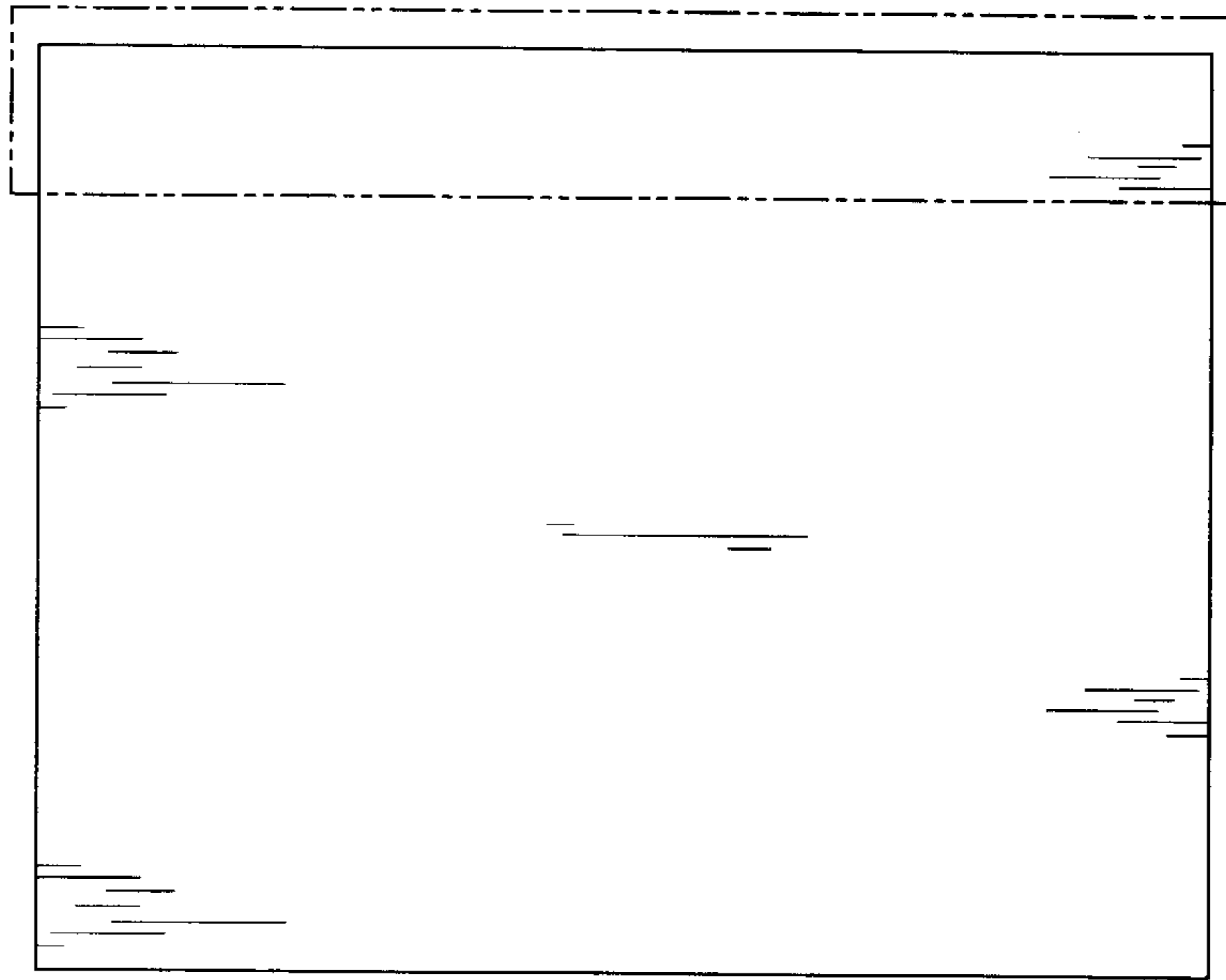

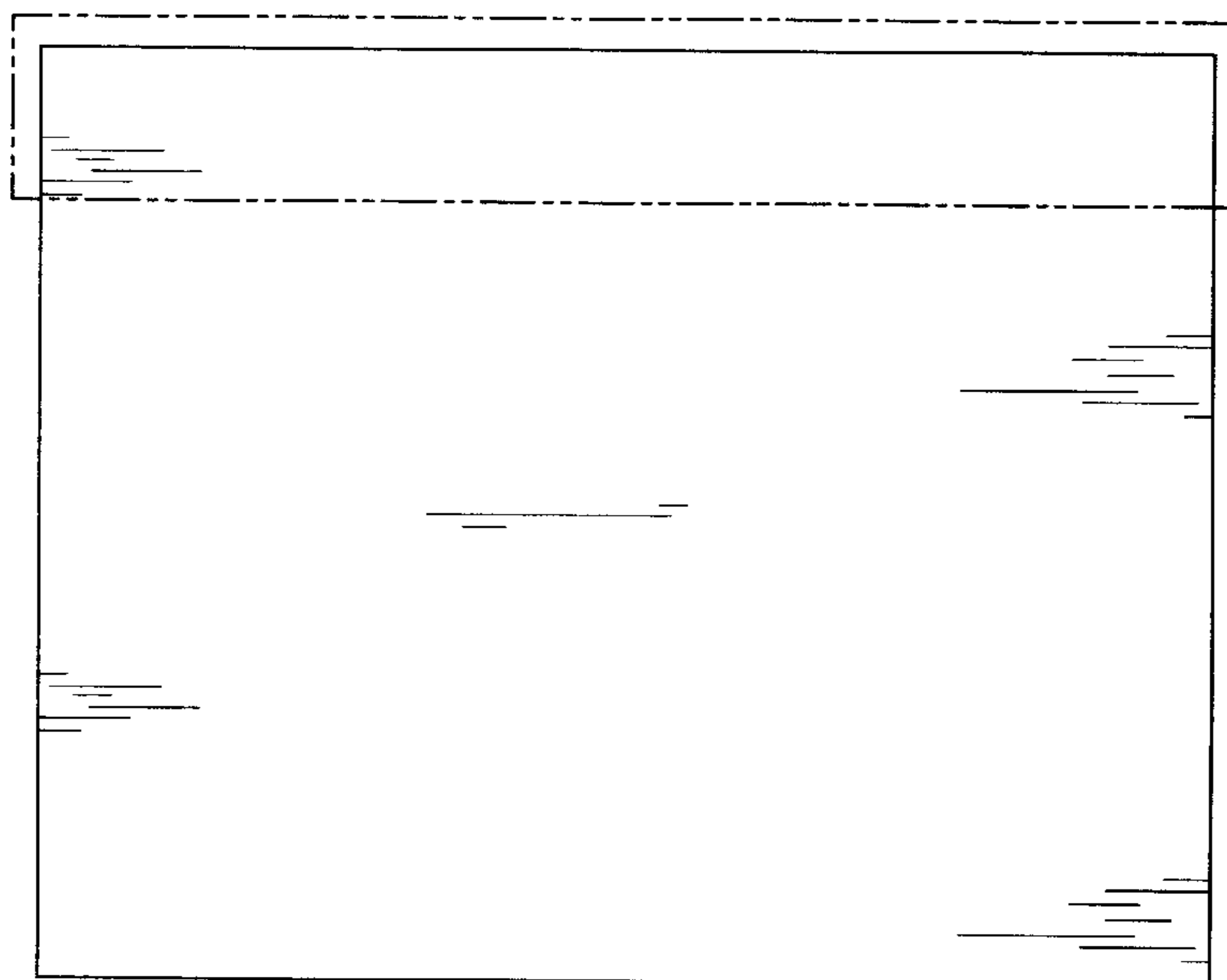

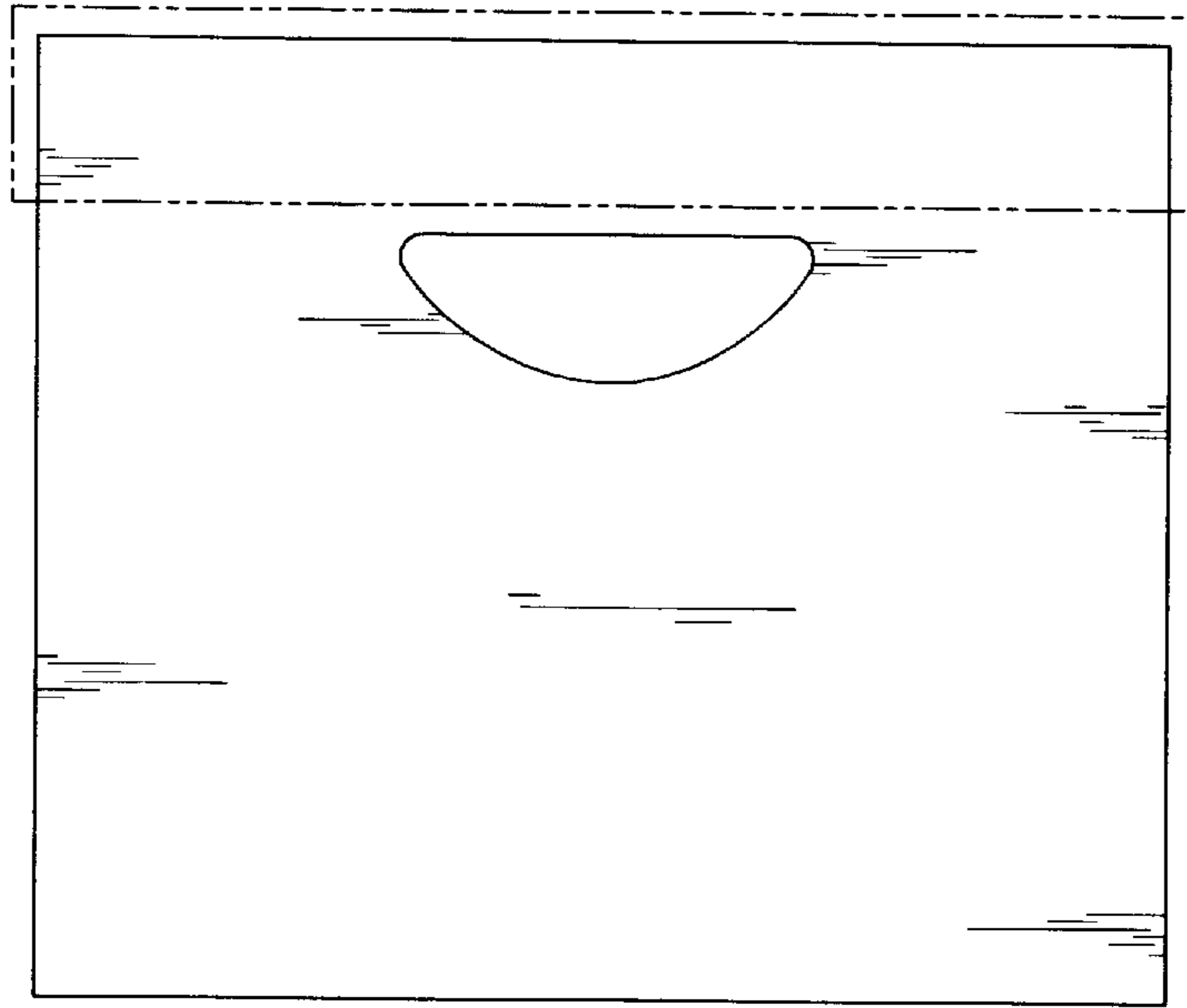

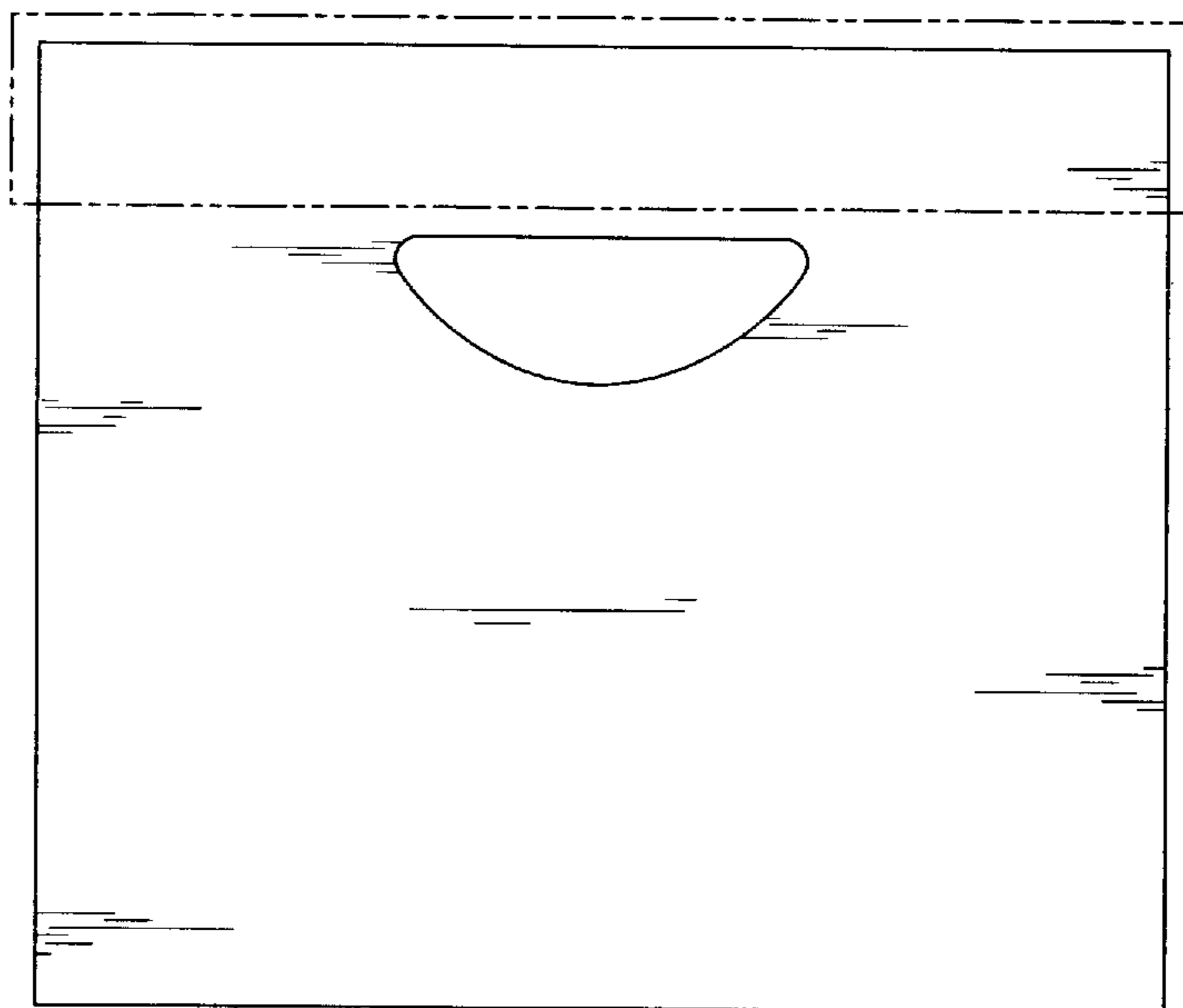

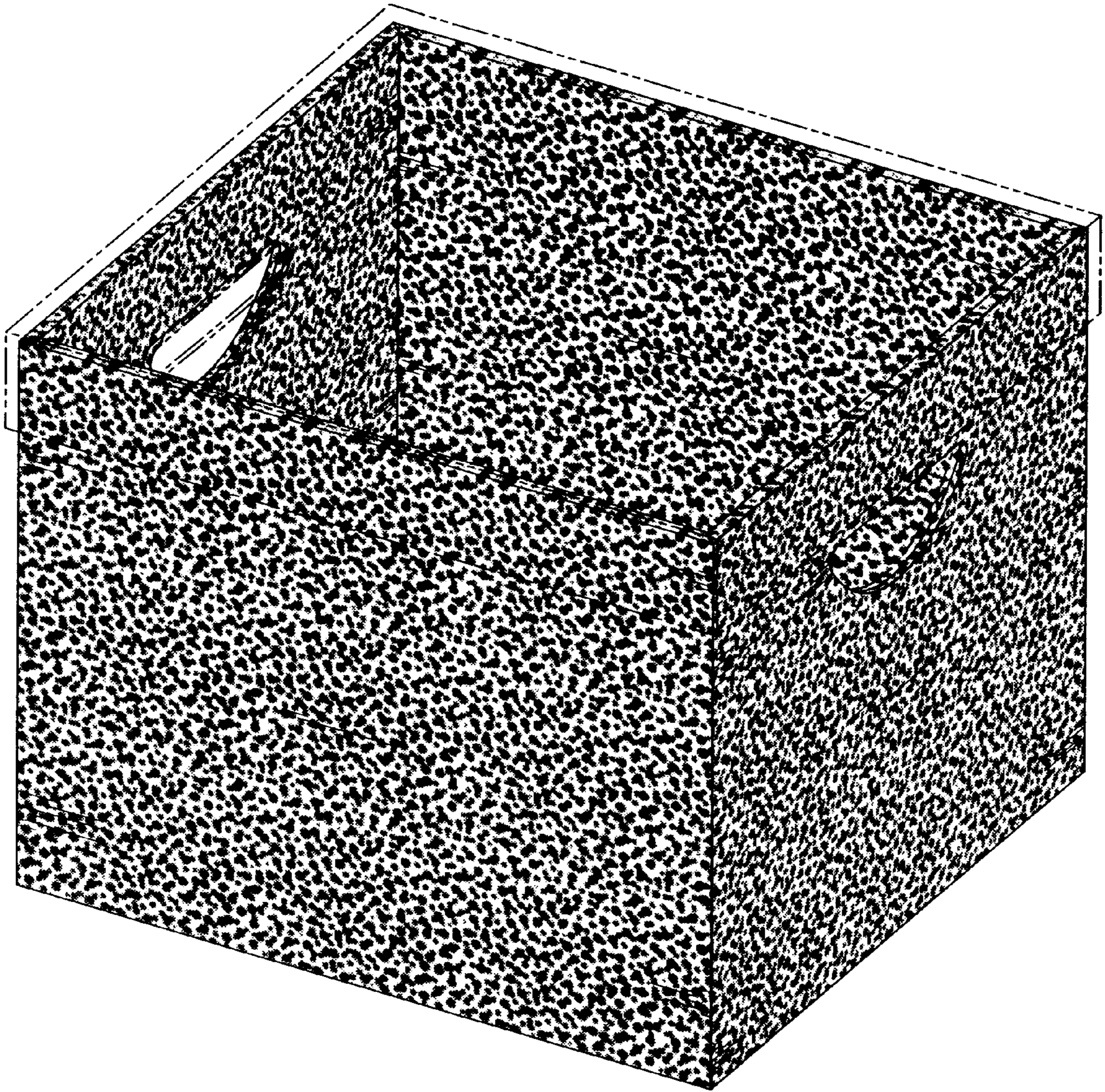

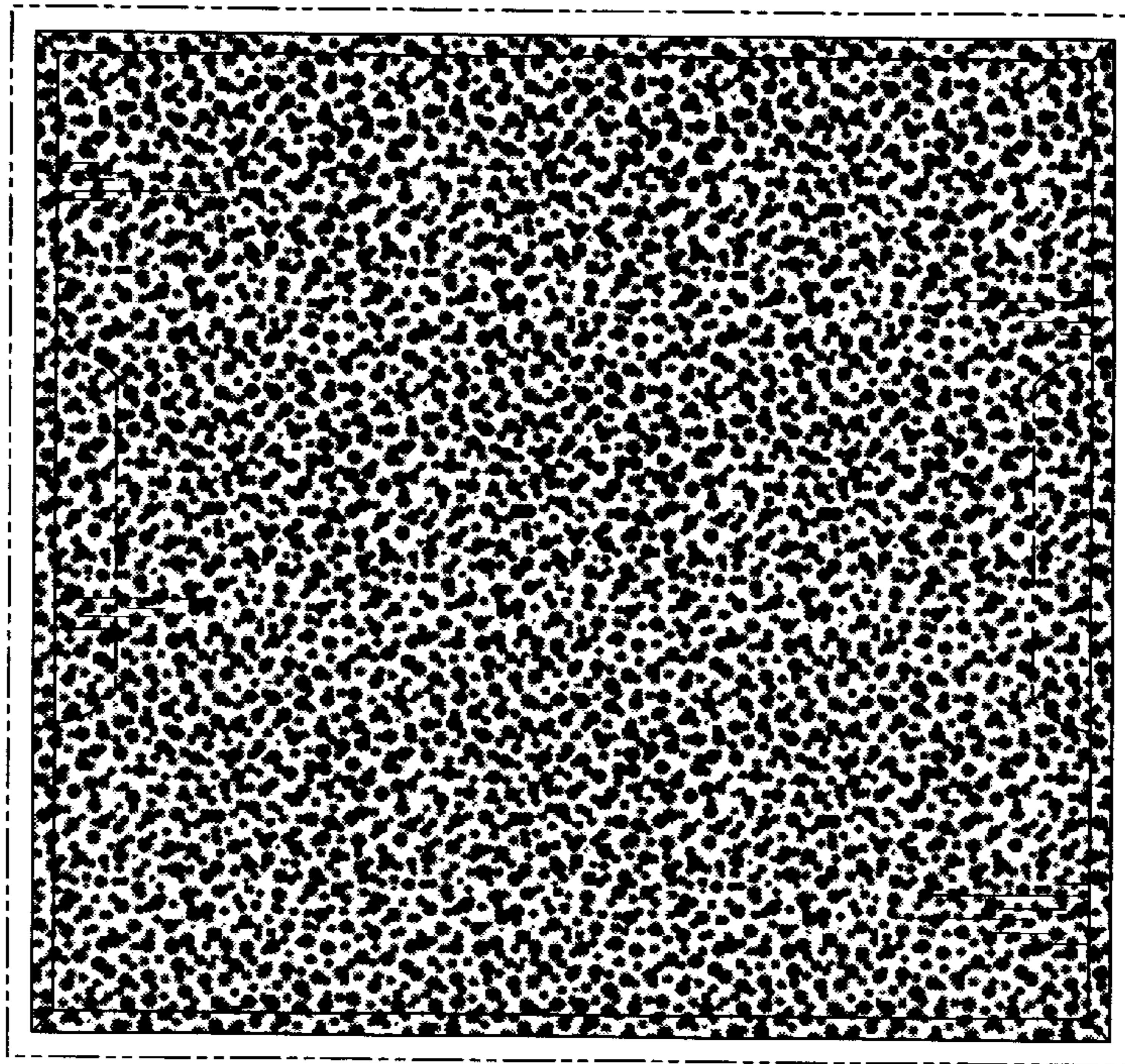

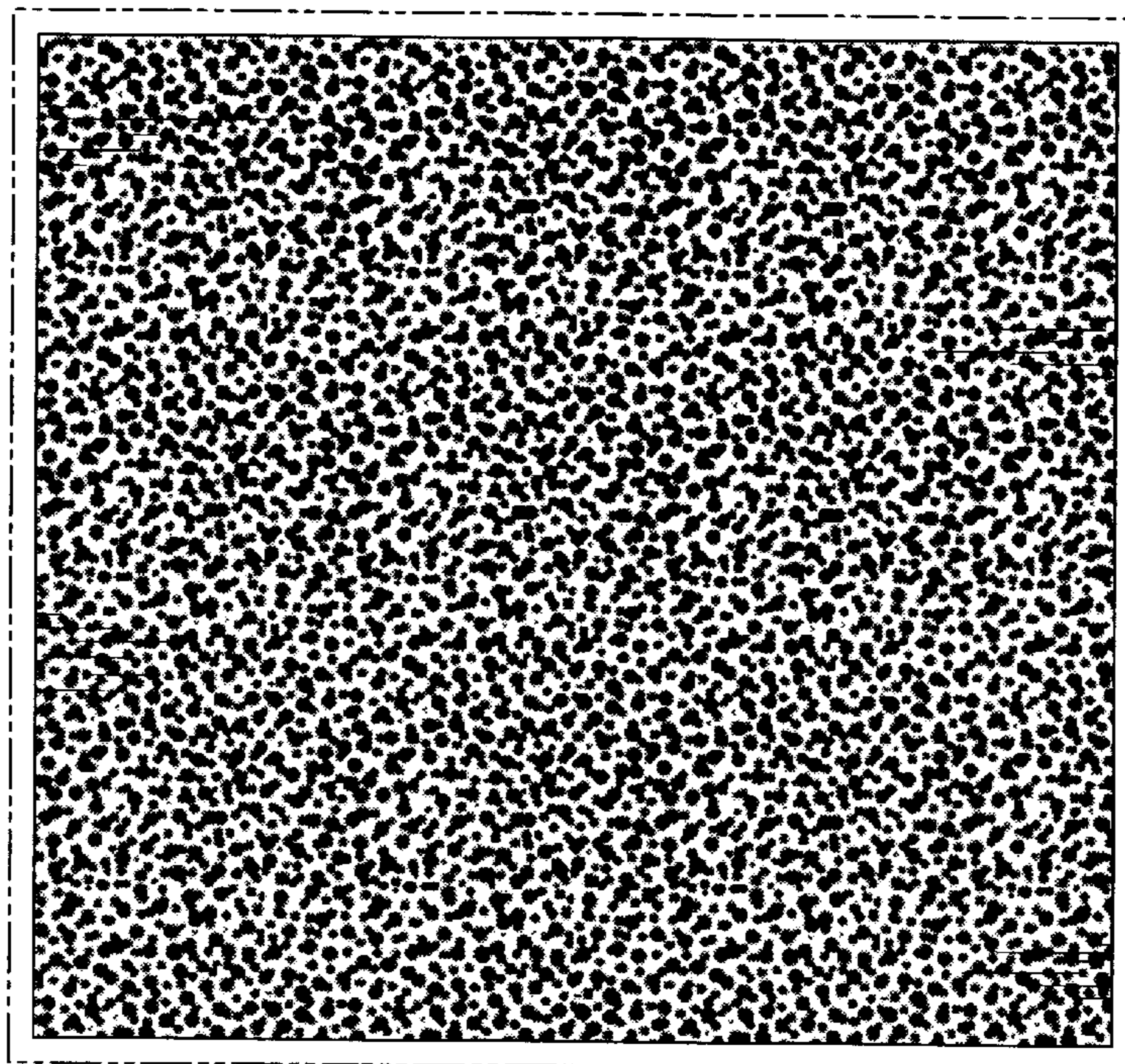

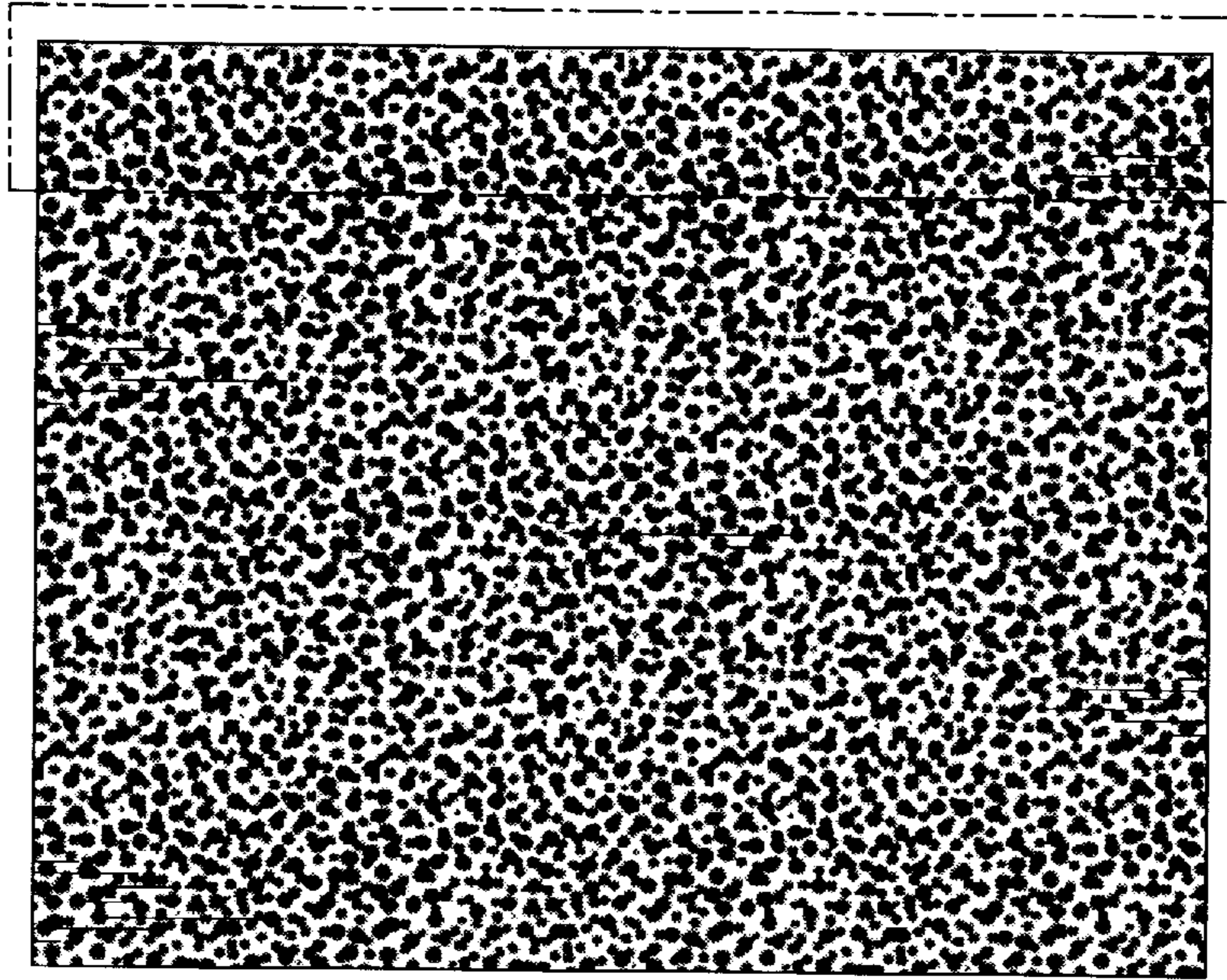

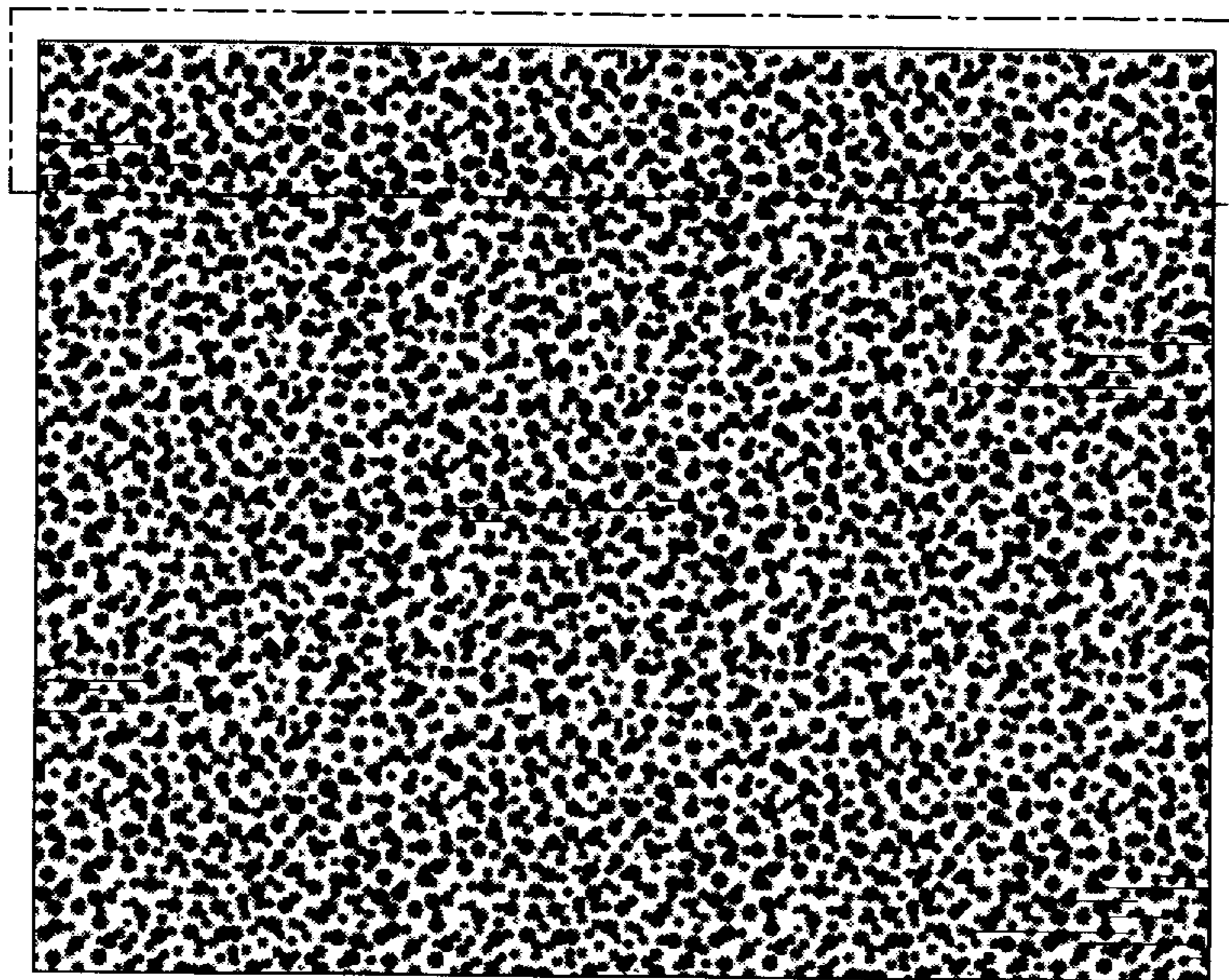

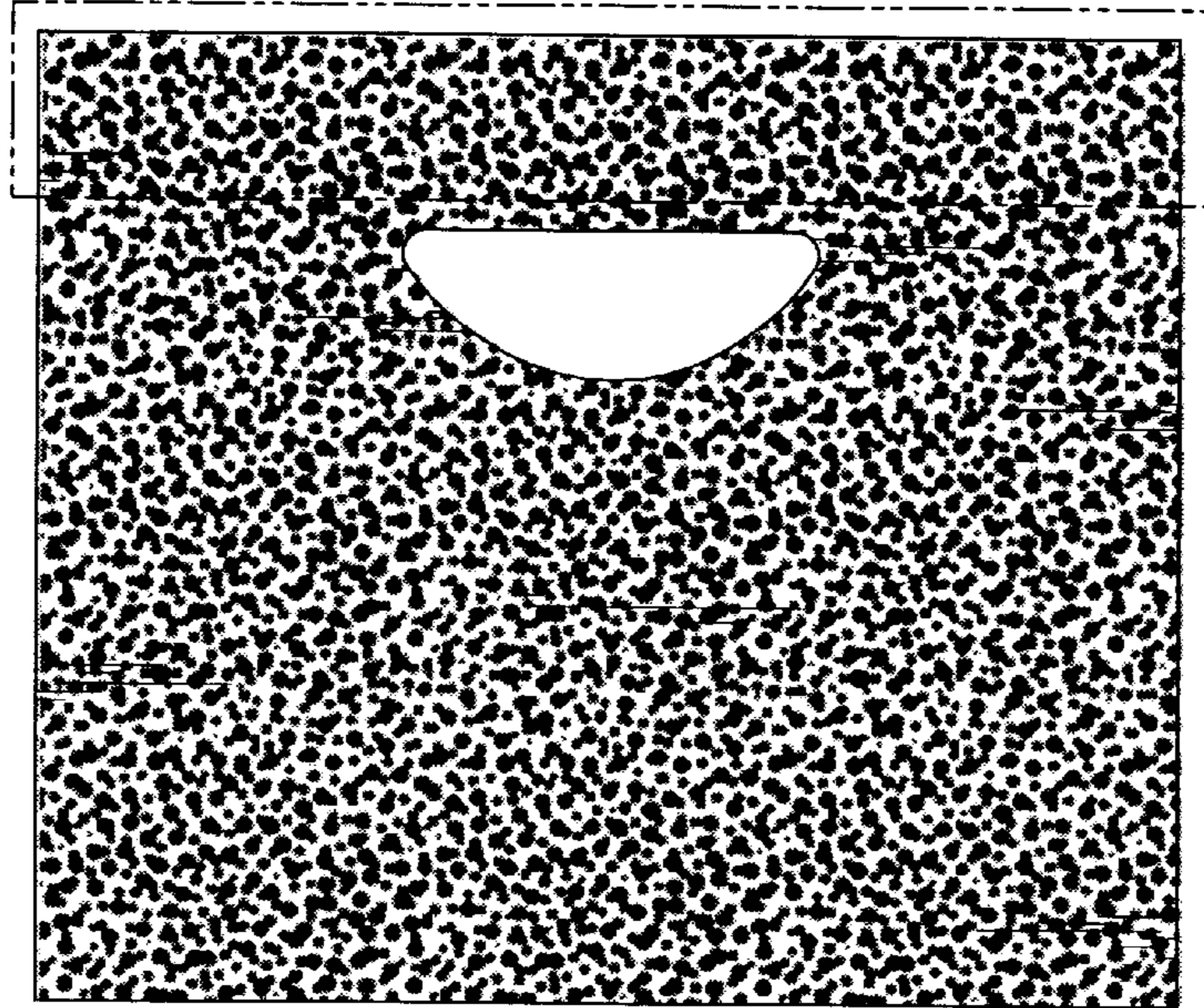

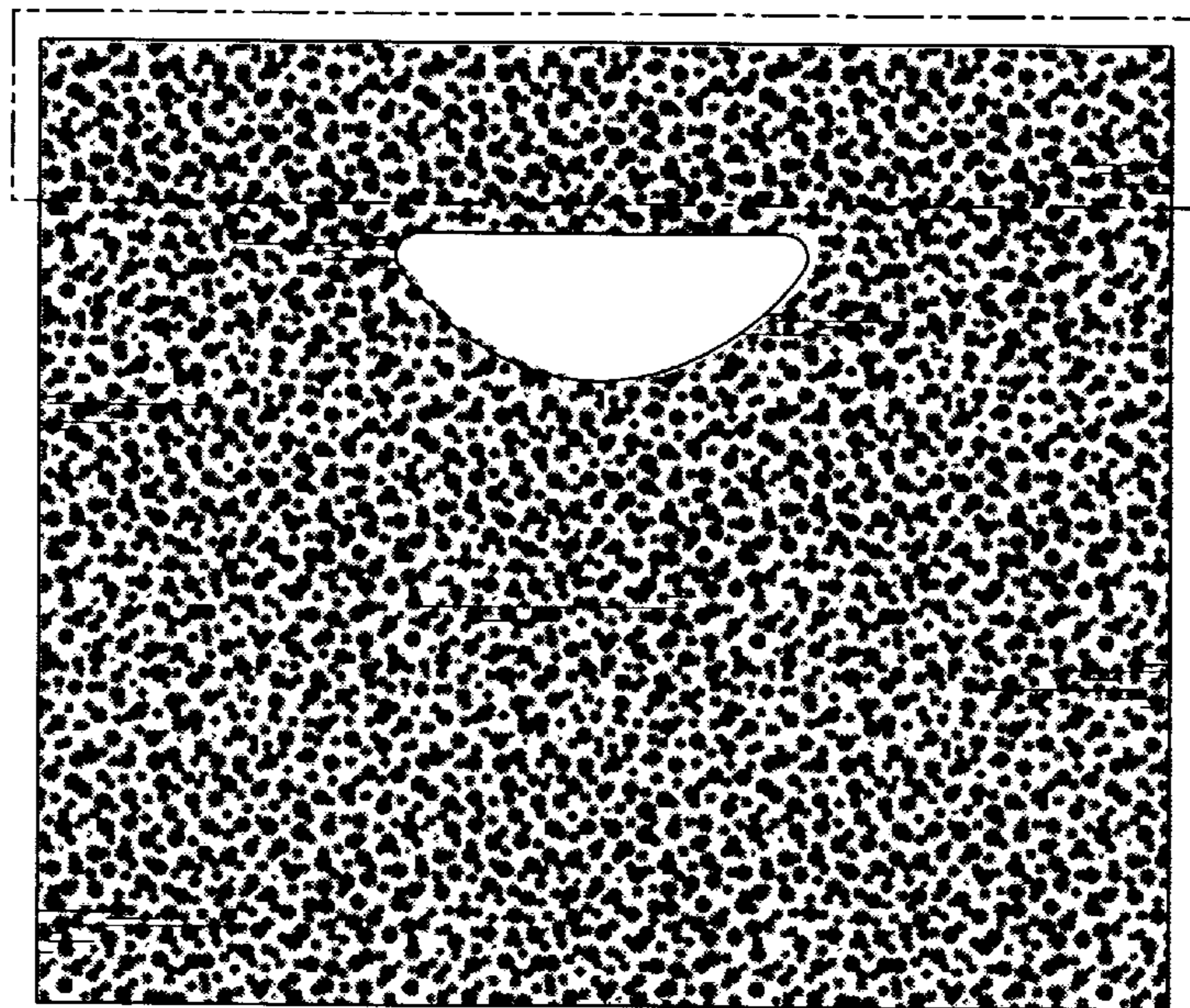
