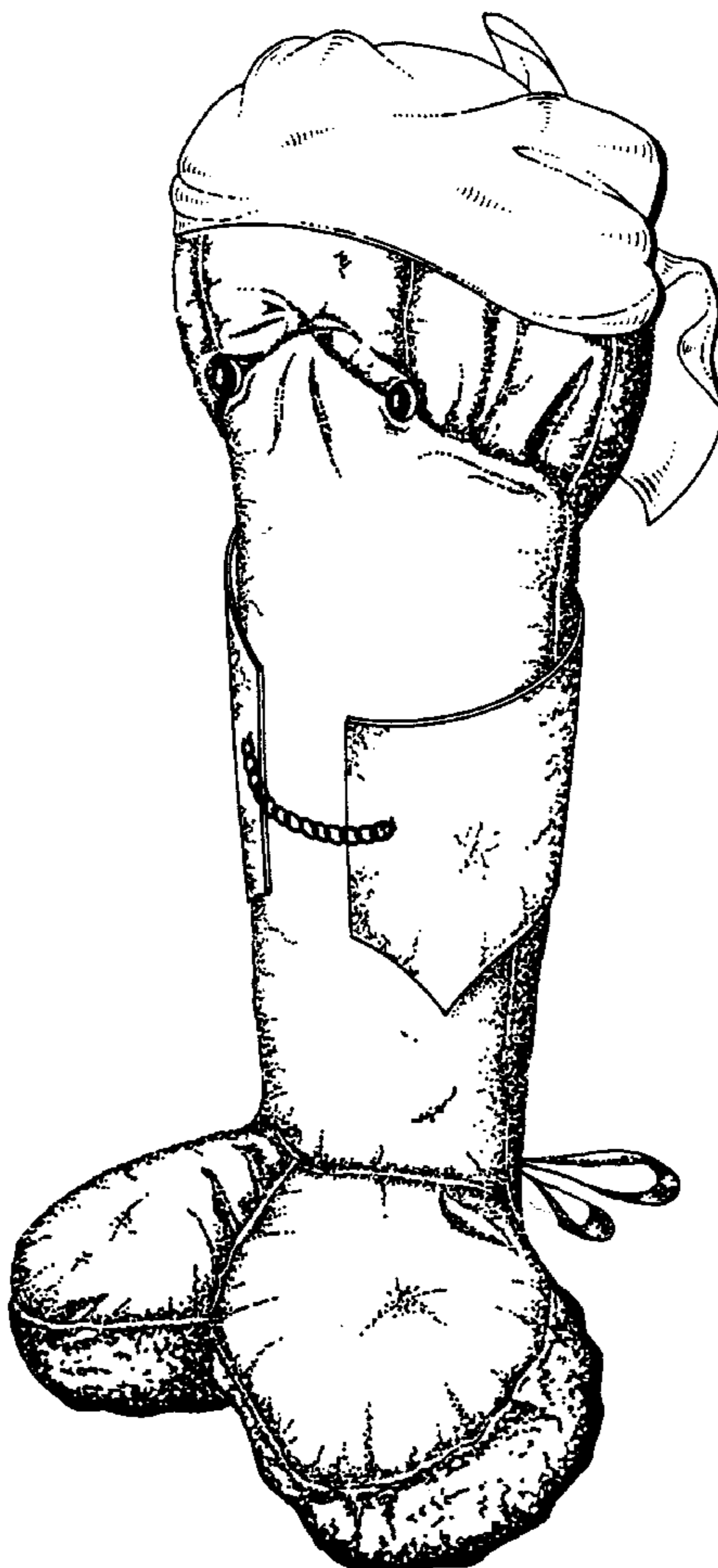

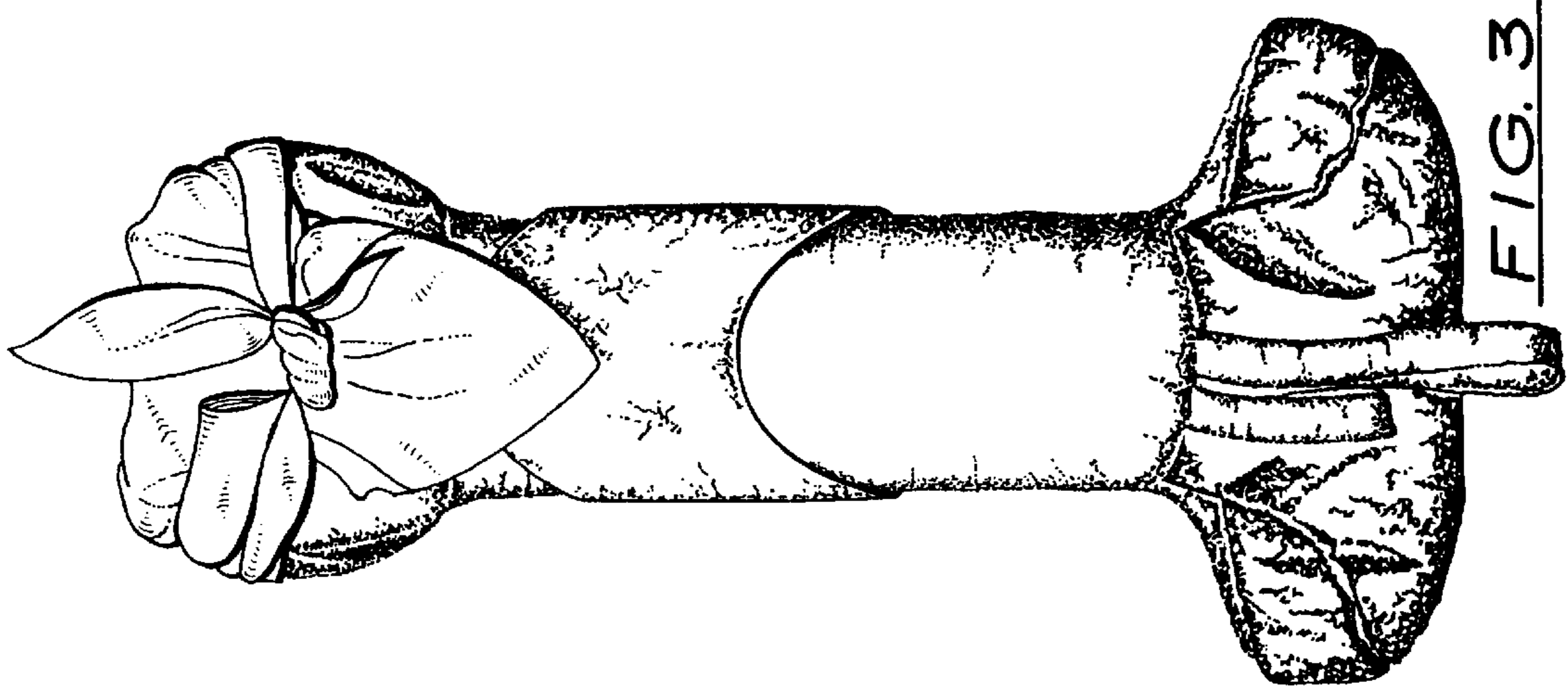
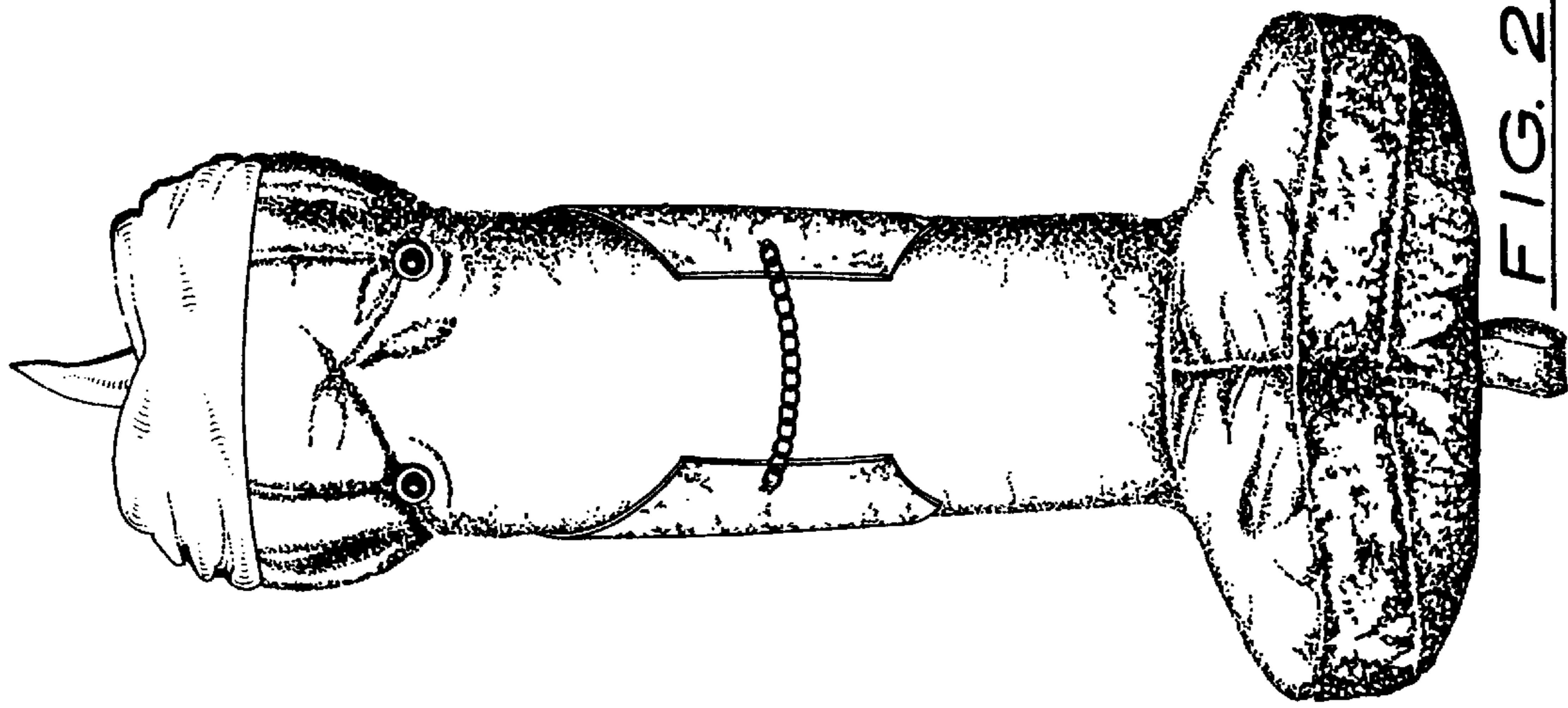
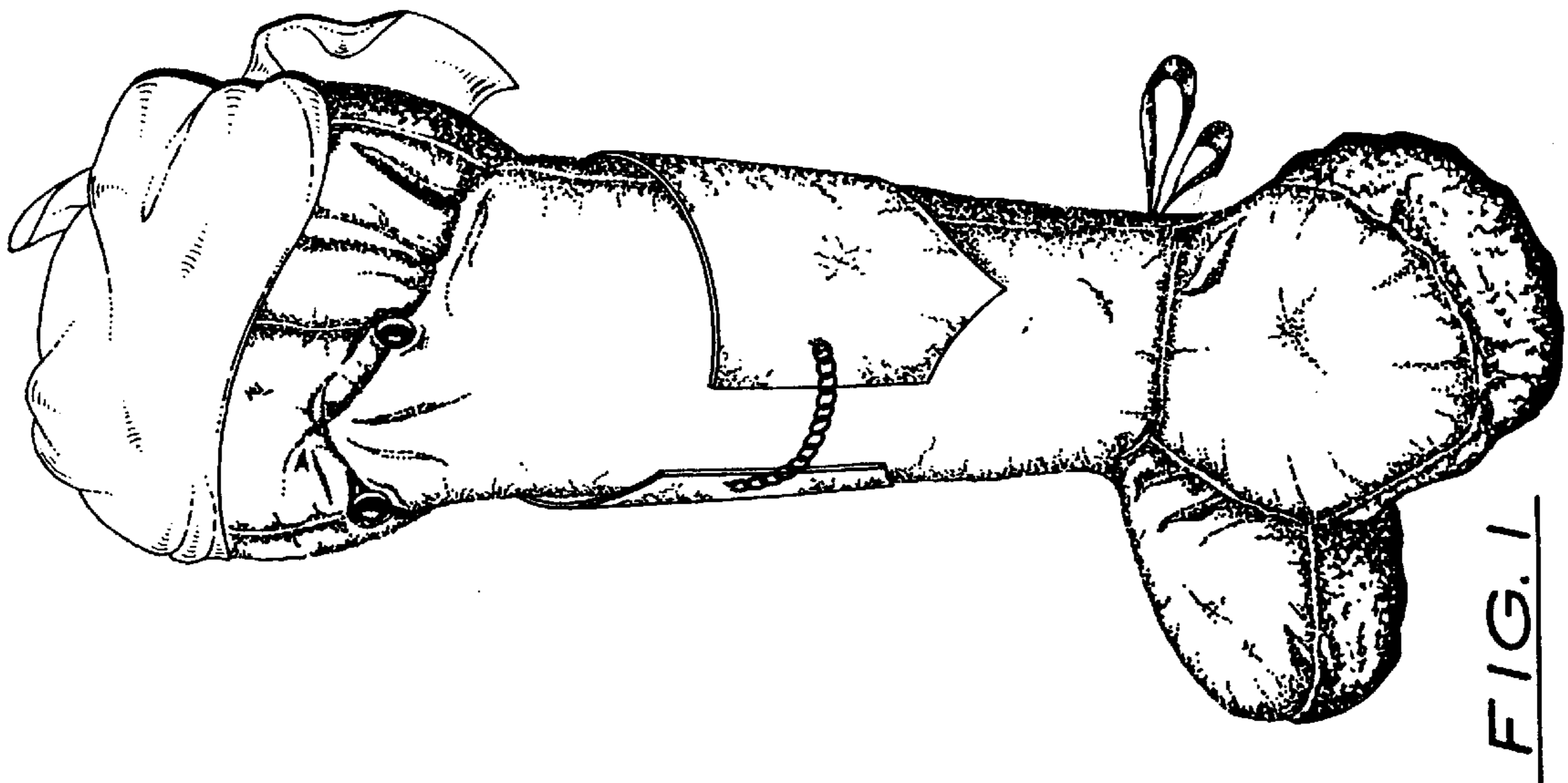
The ornamental design for a novelty doll with headgear and vest, as shown and described.

### DESCRIPTION

FIG. 1 is a perspective view of a doll showing our new design.

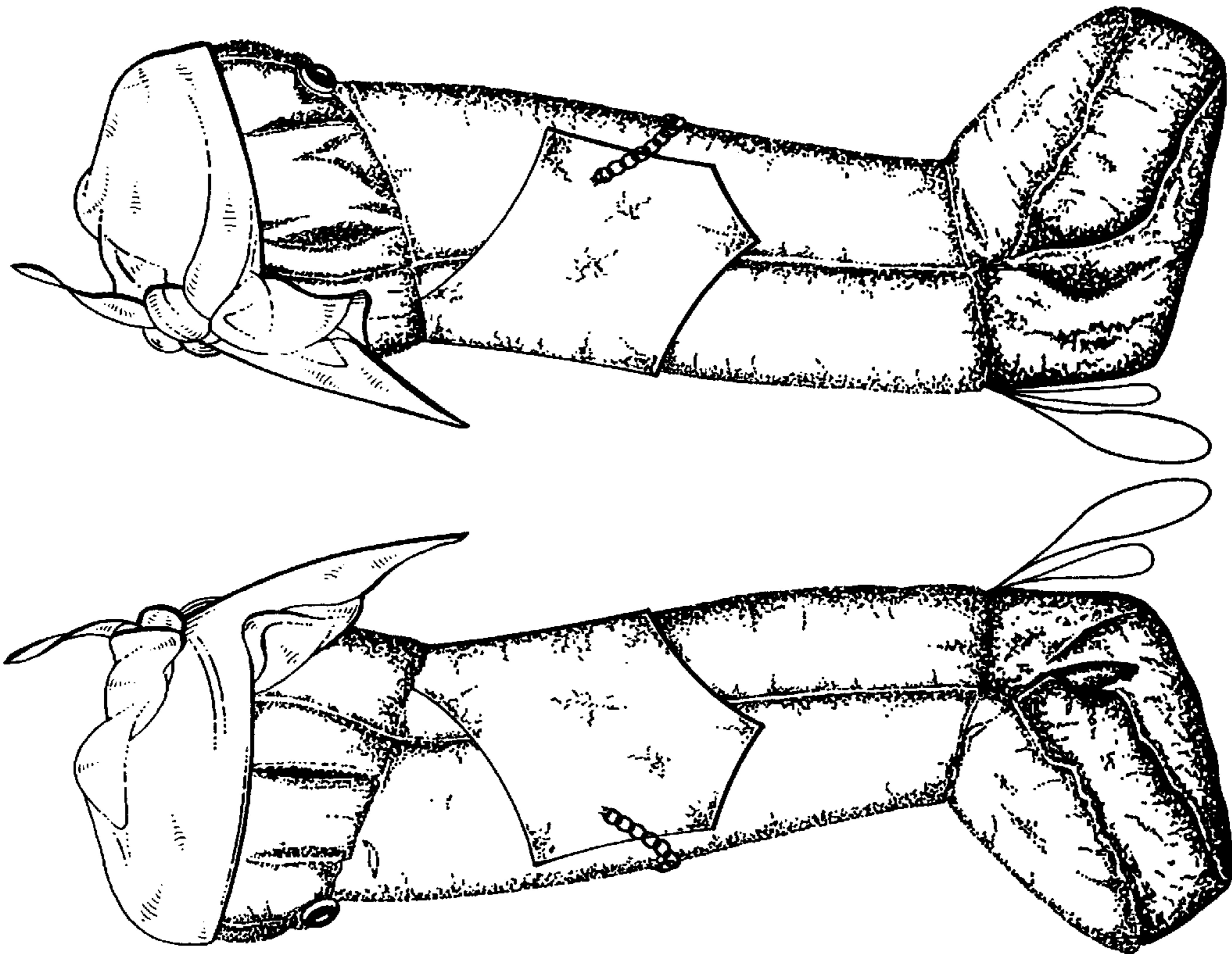

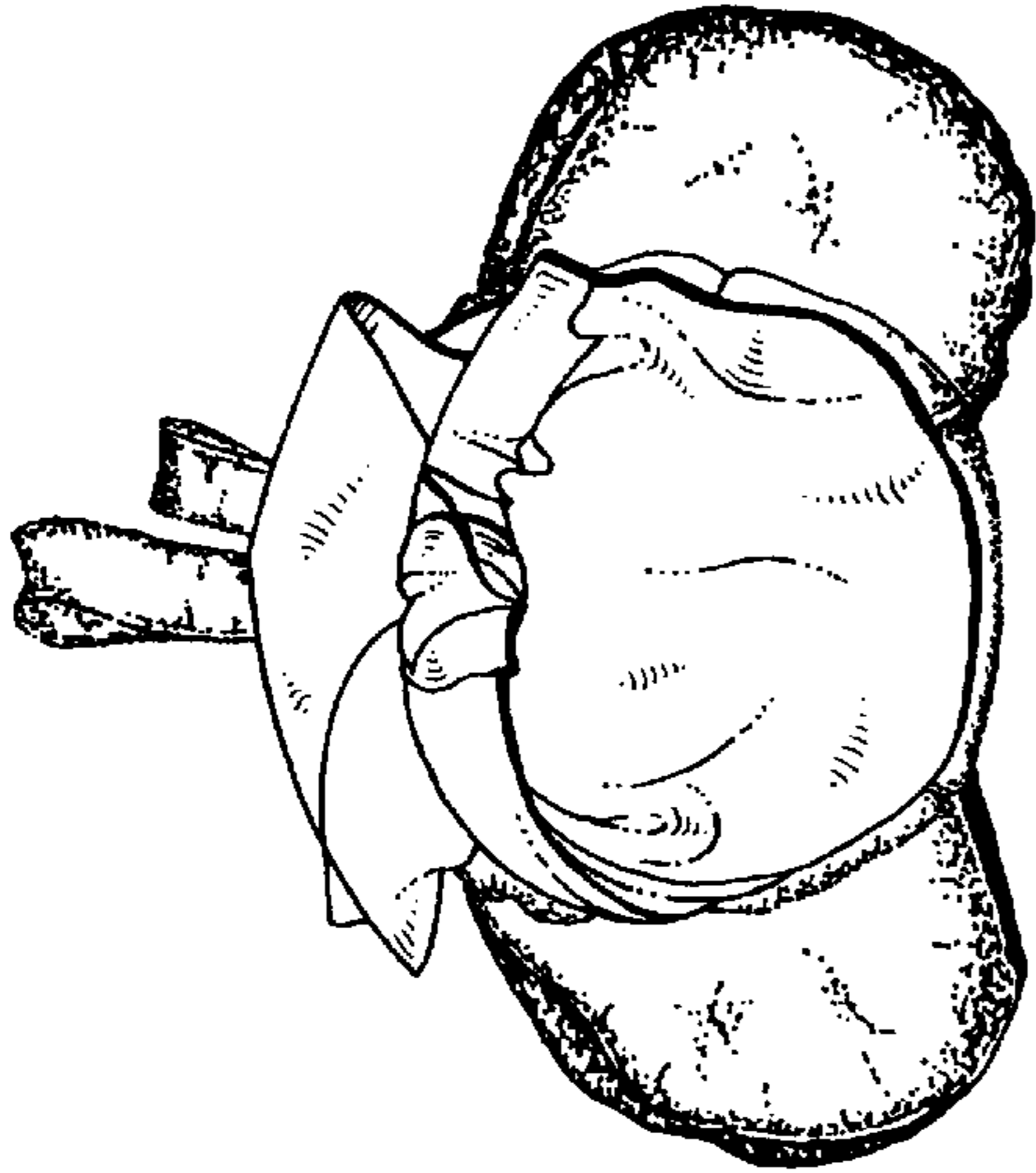

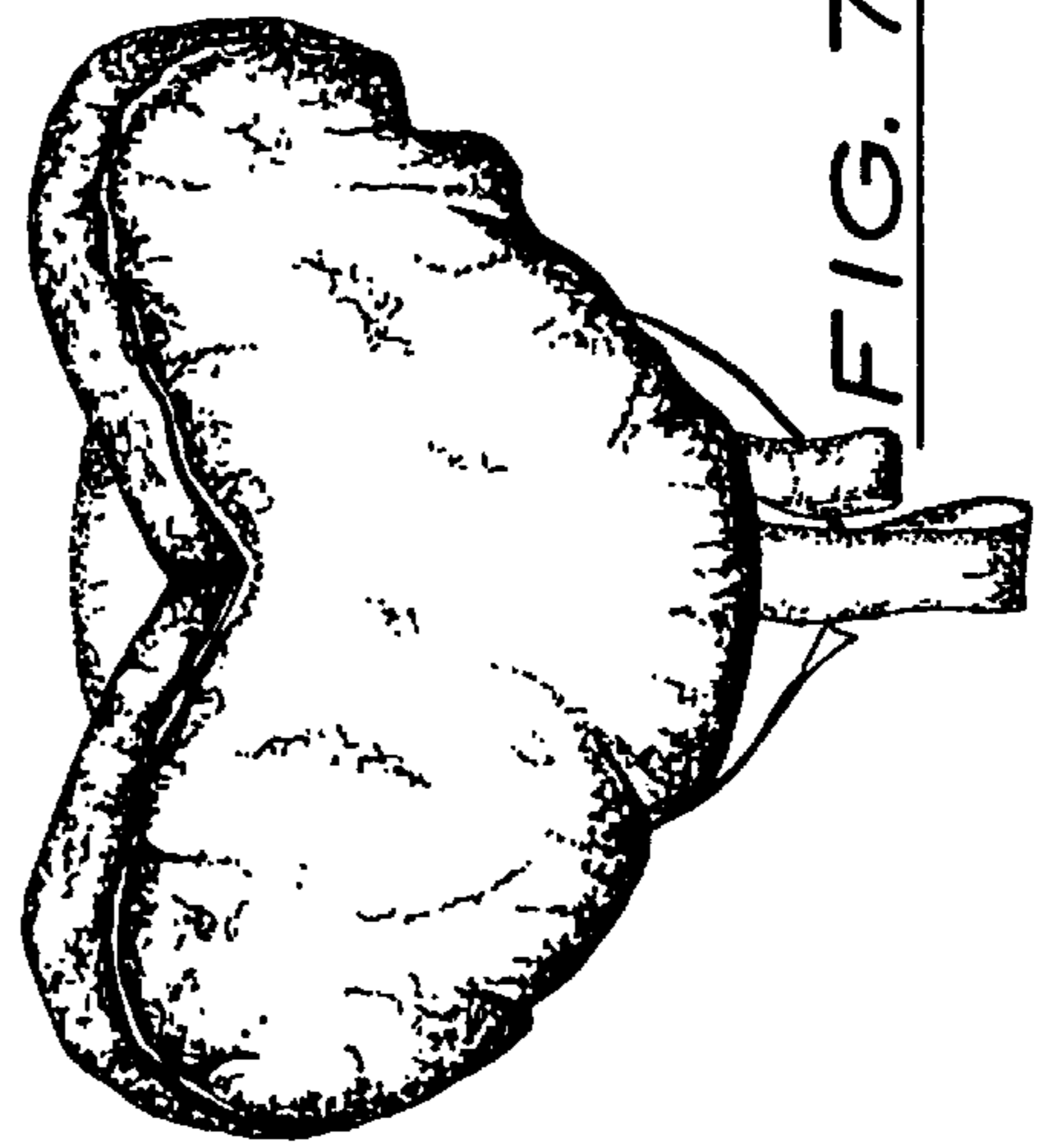
