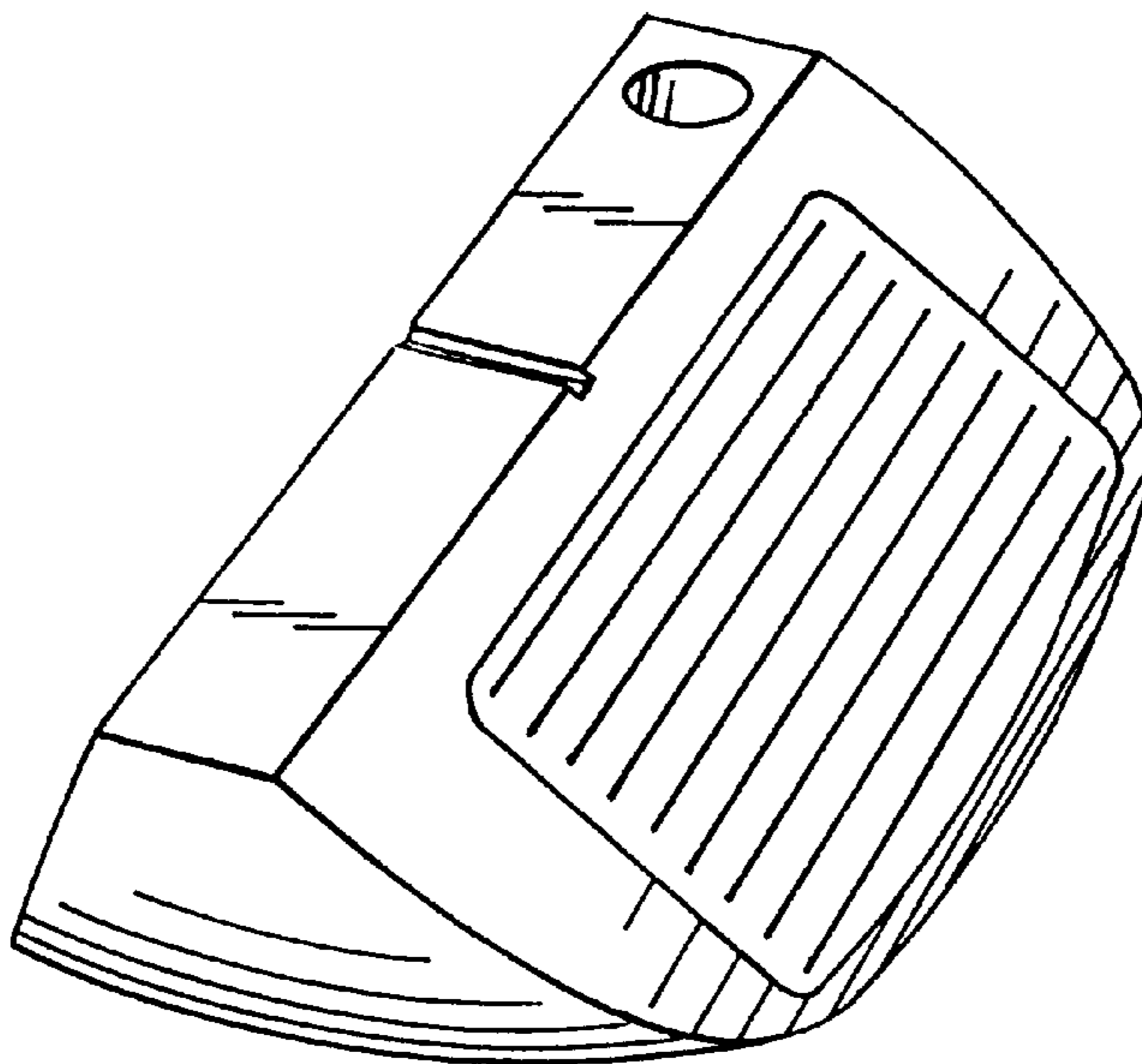

[57] **CLAIM**

The ornamental design for a golf club head, as shown and described.

FIG. 1 is a perspective view of a first embodiment of a golf club head illustrating my new design with the view taken from above the toe end of the head;
 FIG. 2 is a perspective view of the golf club head of FIG. 1 taken from the rear, heel corner of the head;
 FIG. 3 is a front view of the golf club head of FIG. 1 showing the face of the head;
 FIG. 4 is a rear view of the golf club head of FIG. 1 showing the back of the head;
 FIG. 5 is a left end view of the golf club head of FIG. 1 showing the toe end of the head;
 FIG. 6 is a right end view of the golf club head of FIG. 1 showing the heel end of the head;
 FIG. 7 is a top plan view of the of the golf club head of FIG. 1;
 FIG. 8 is a bottom plan view of the golf club head of FIG. 1;
 FIG. 9 is a perspective view of a second embodiment of a golf club head illustrating my new design with the view taken from above the toe end of the head;
 FIG. 10 is a perspective view of the golf club head of FIG. 9 taken from the rear, heel corner of the head;
 FIG. 11 is a front view of the golf club head of FIG. 9 showing the face of the head;
 FIG. 12 is a rear view of the golf club head of FIG. 9 showing the back of the head;
 FIG. 13 is a left end view of the golf club head of FIG. 9 showing the toe end of the head;
 FIG. 14 is a right end view of the golf club head of FIG. 9 showing the heel end of the head;
 FIG. 15 is a top plan view of the of the golf club head of FIG. 9; and,
 FIG. 16 is a bottom plan view of the golf club head of FIG. 9.

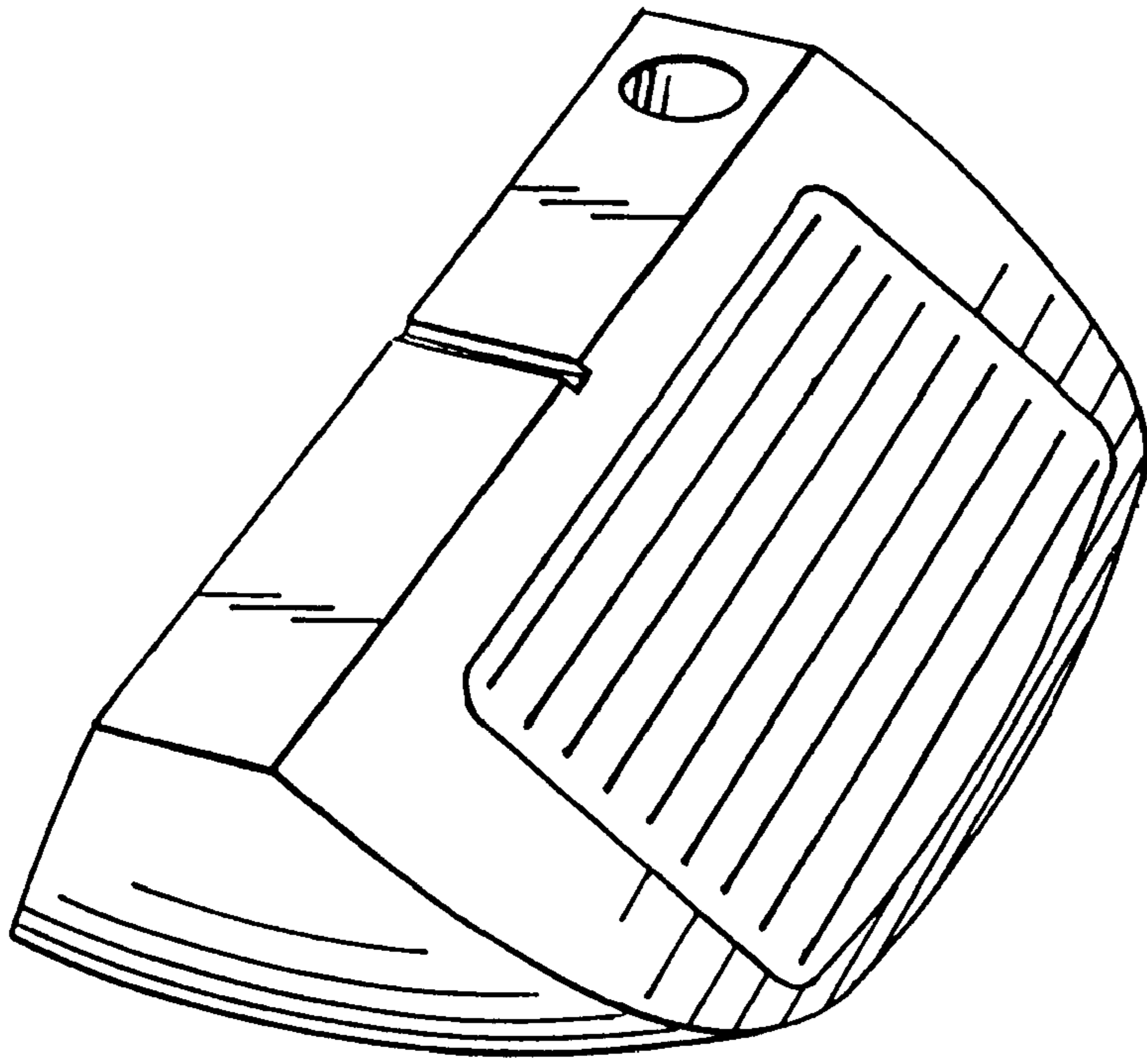

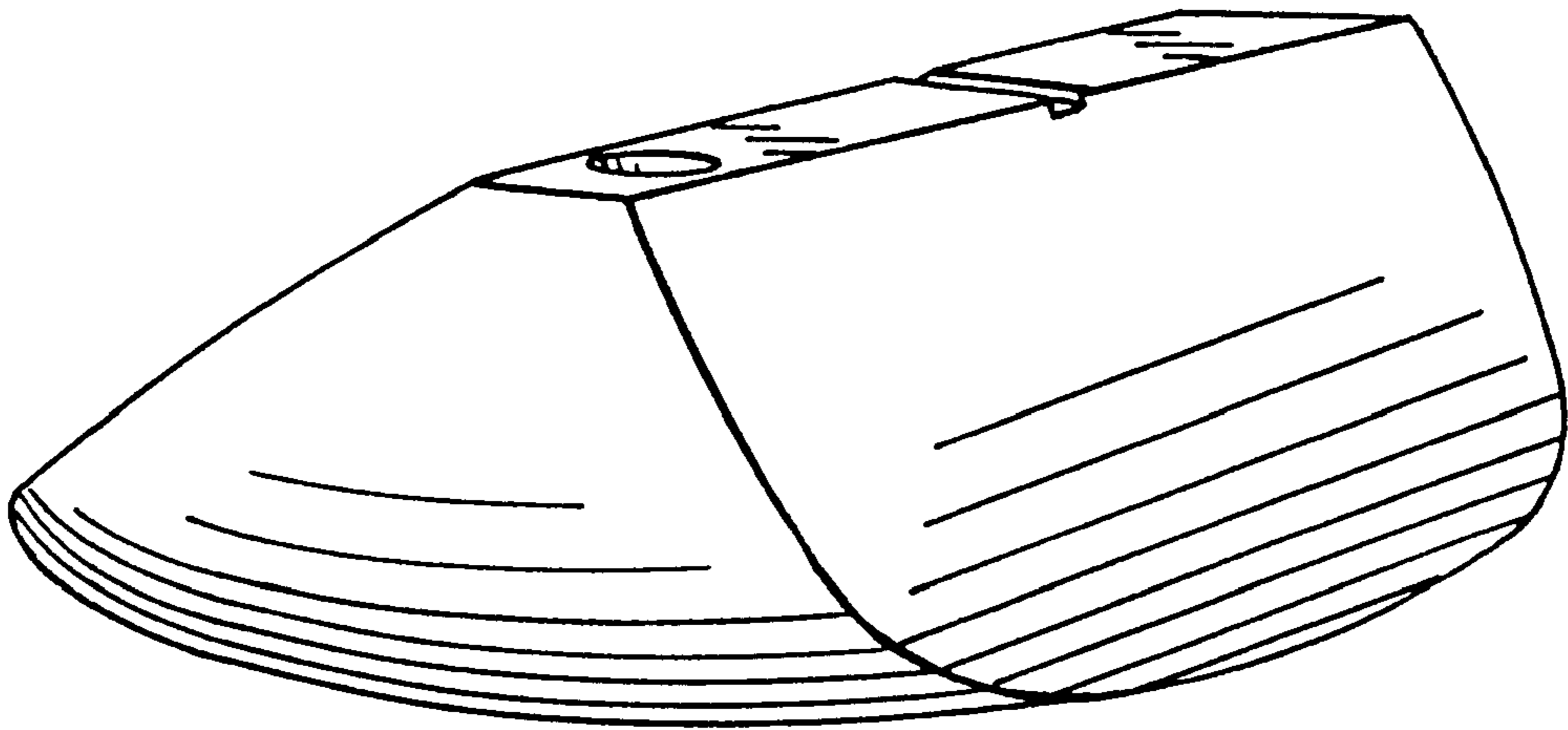

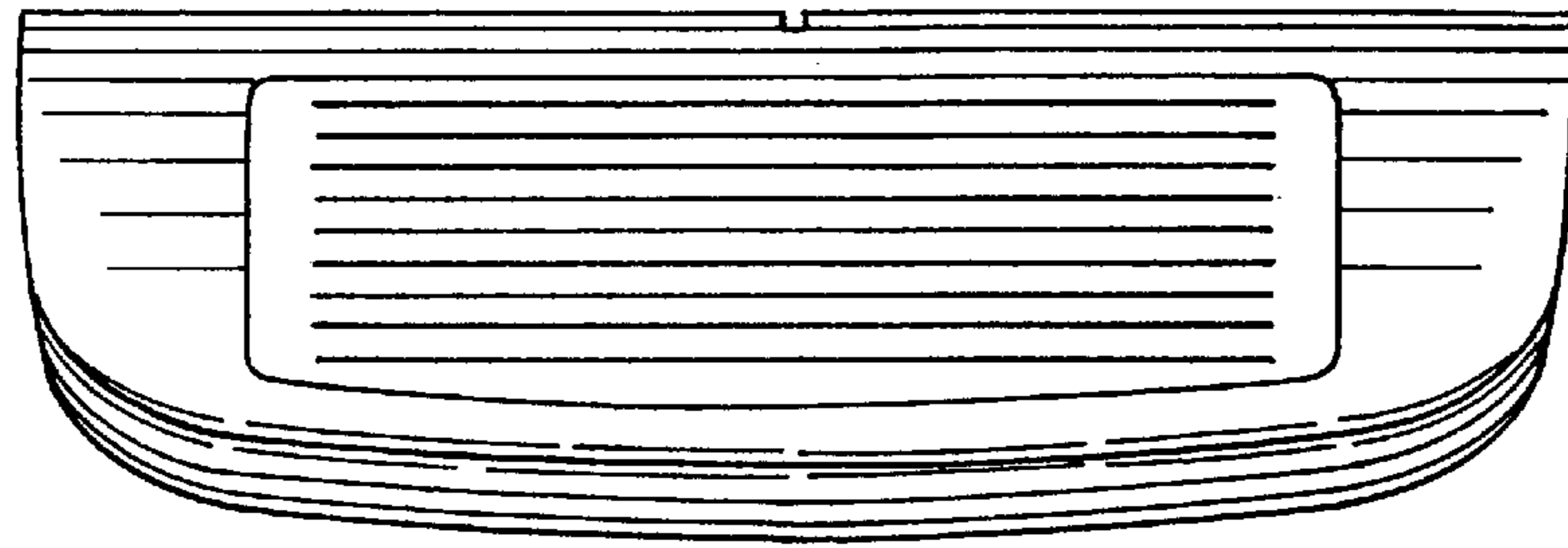

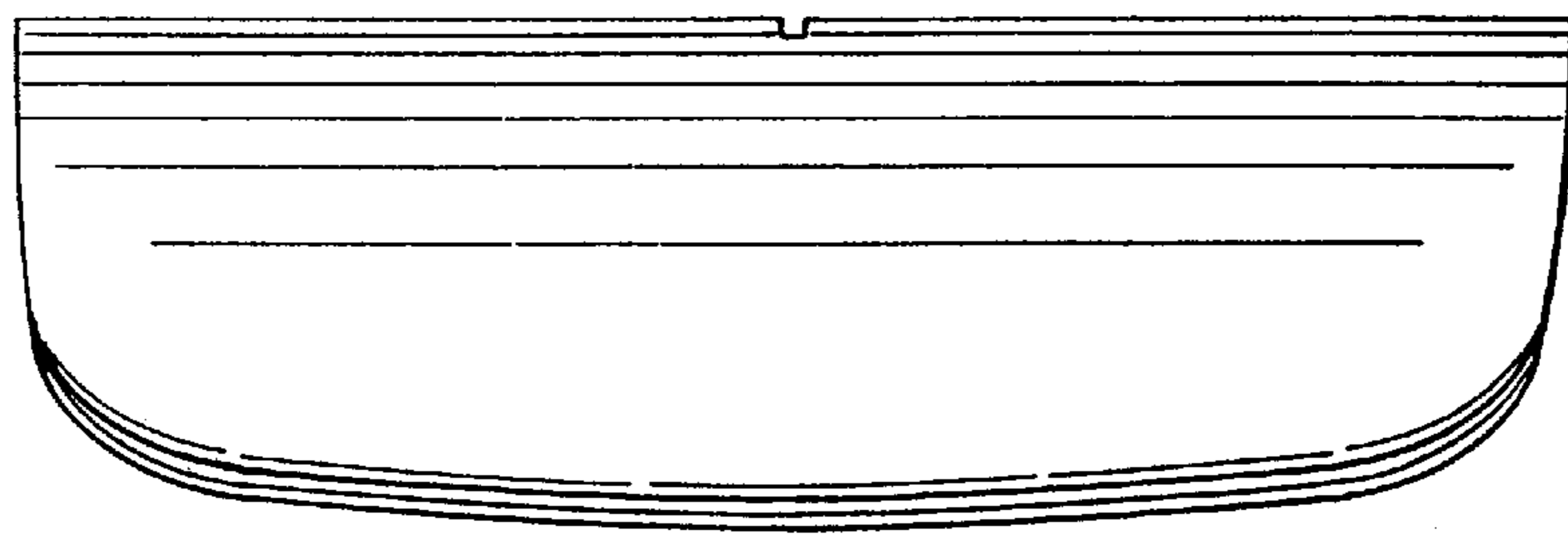

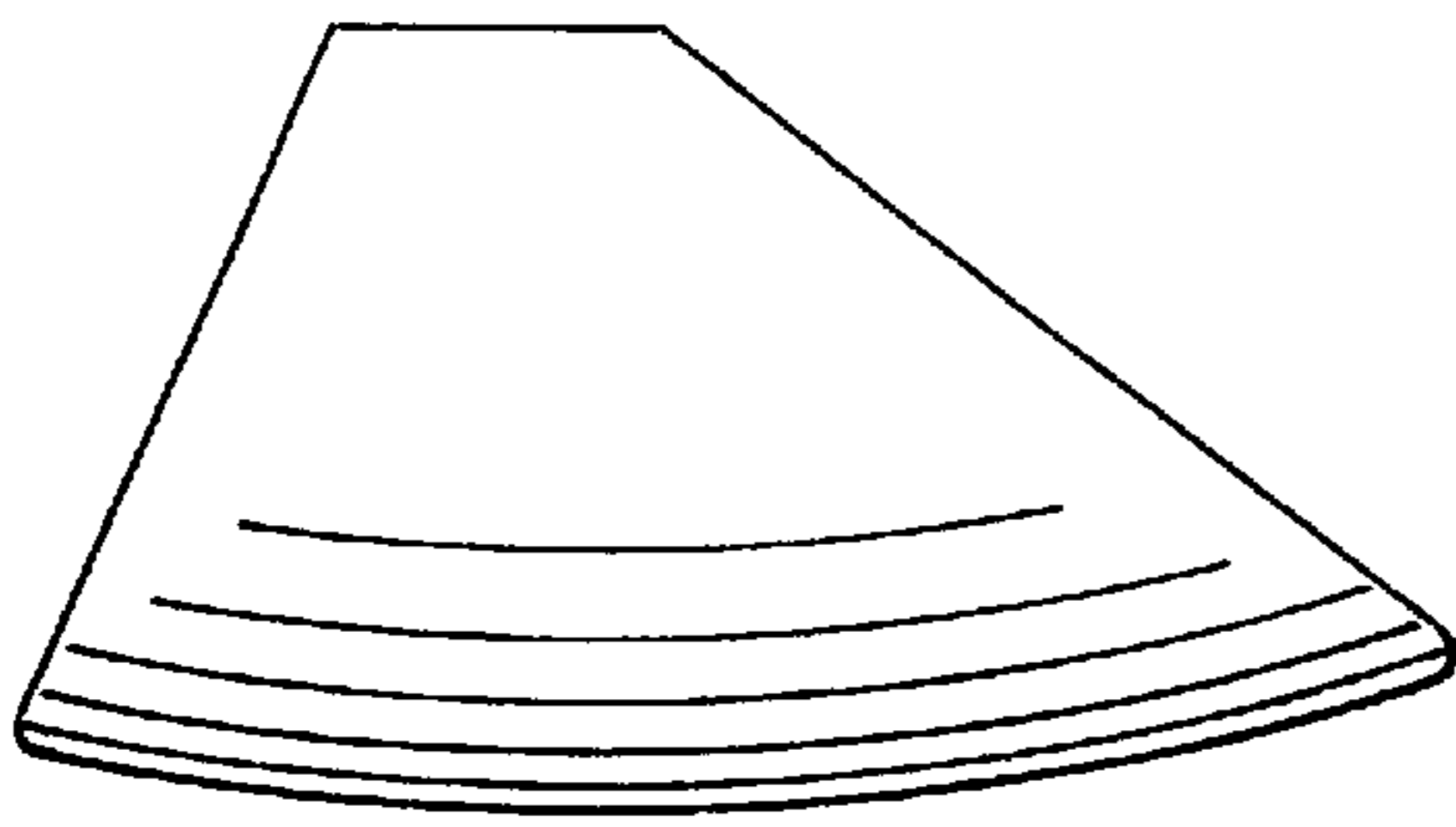

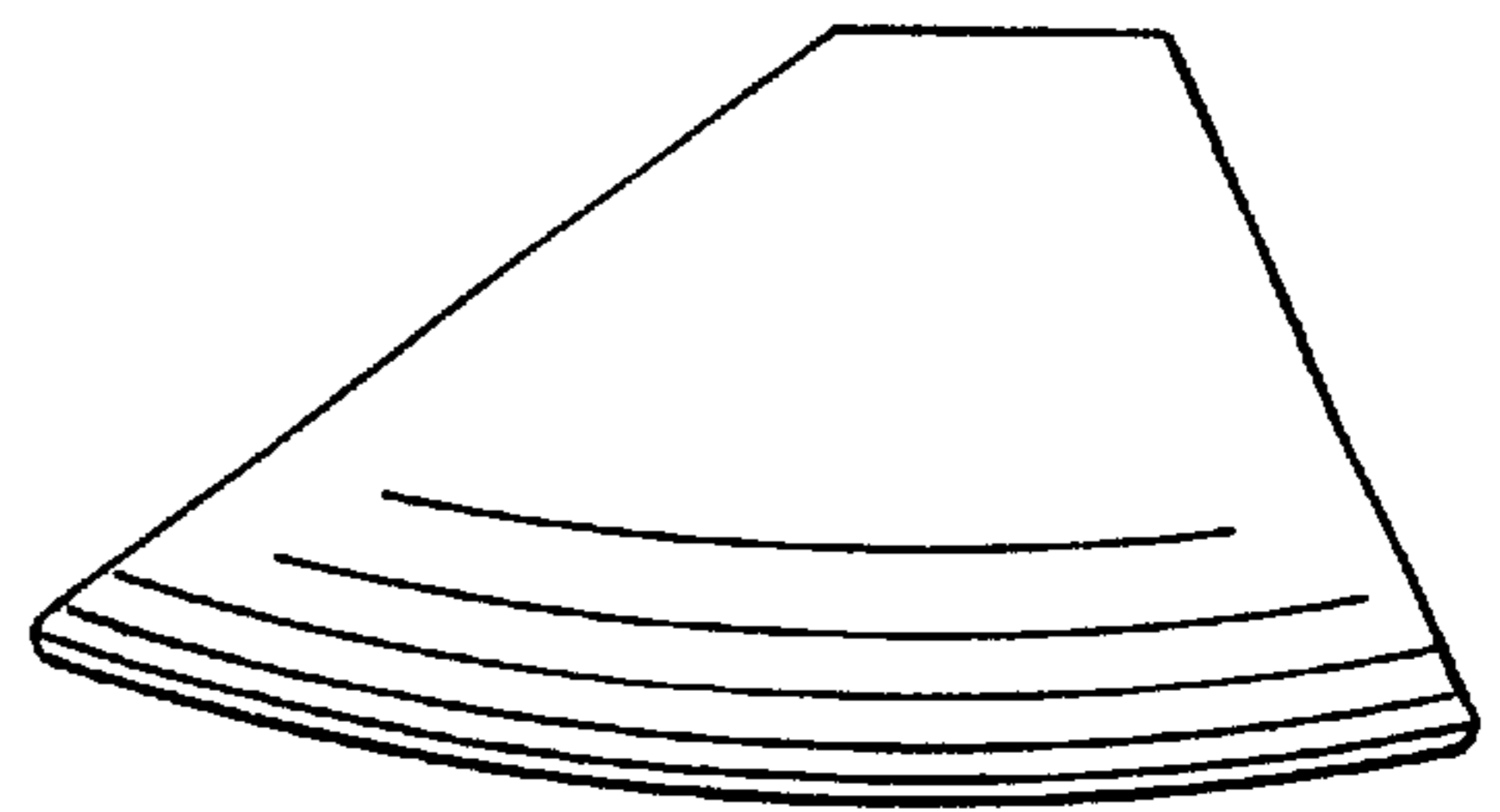

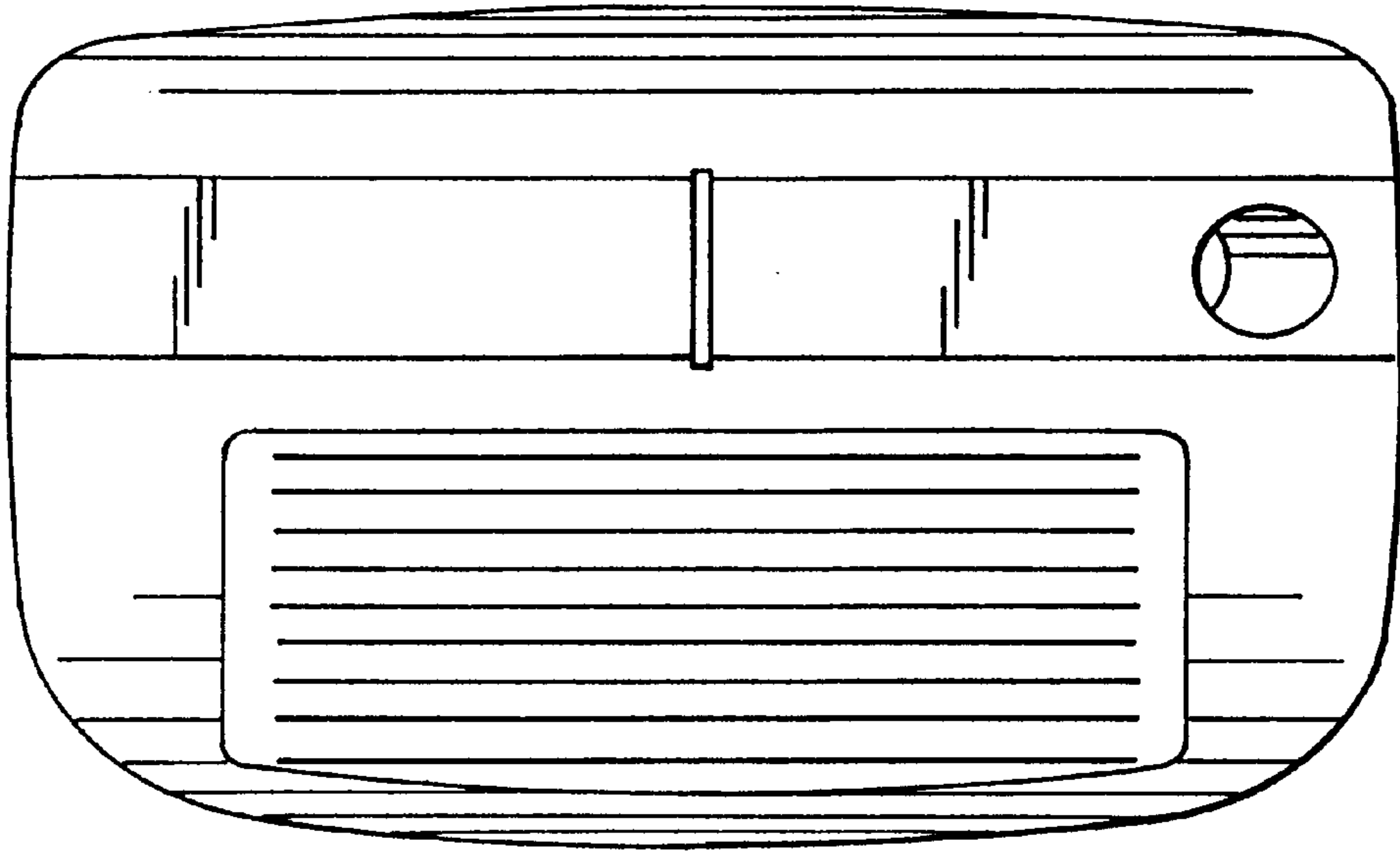

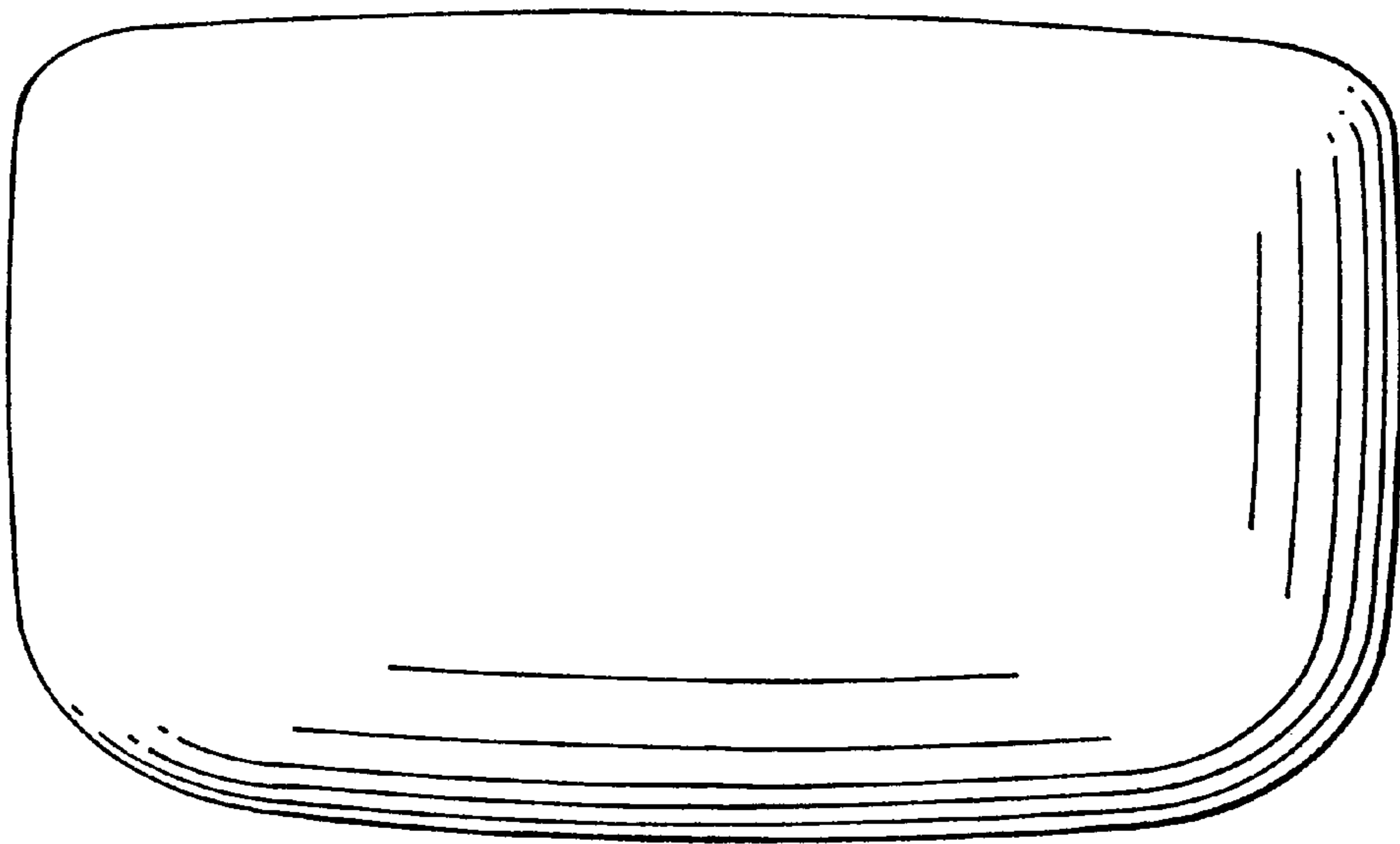

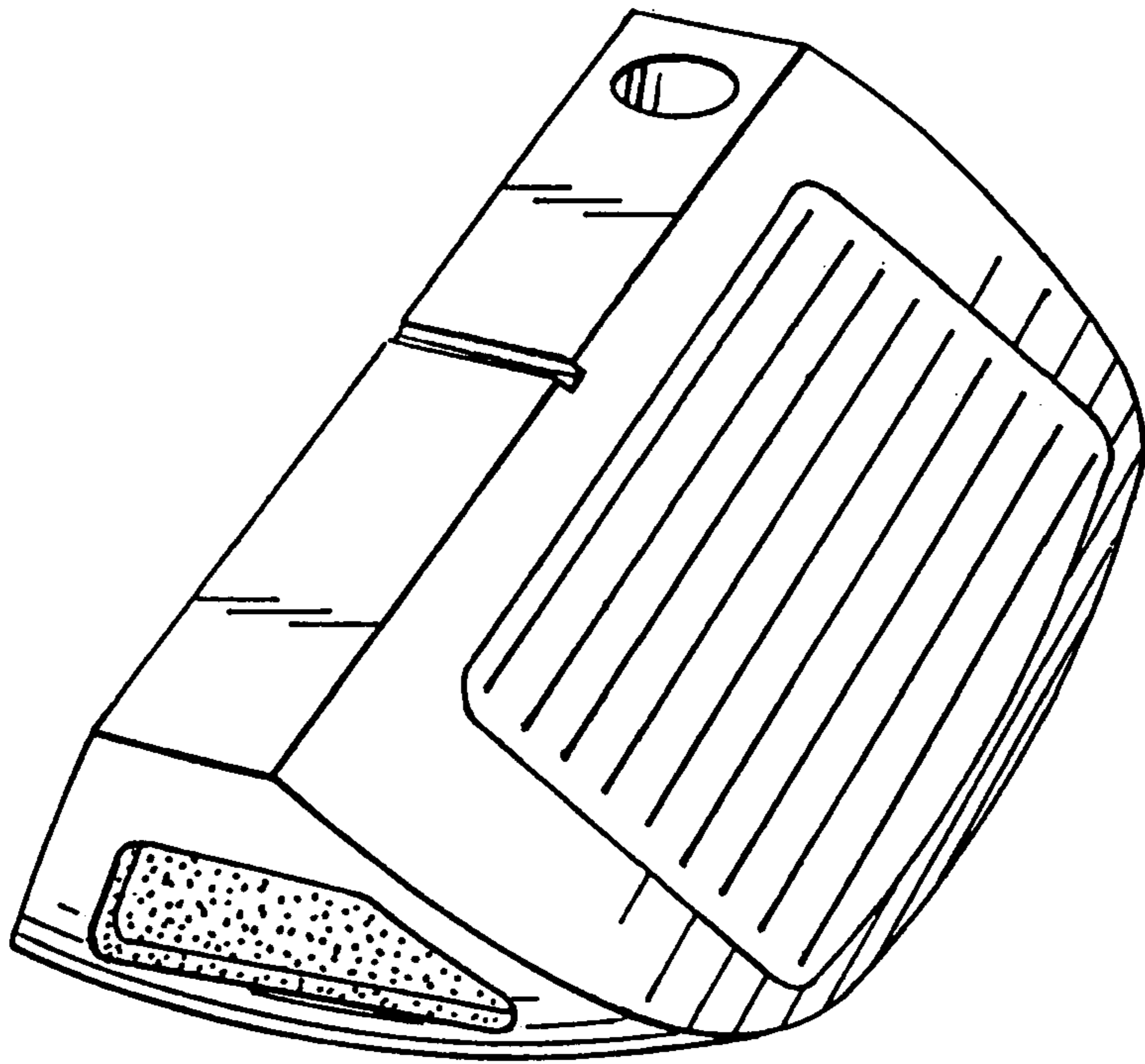

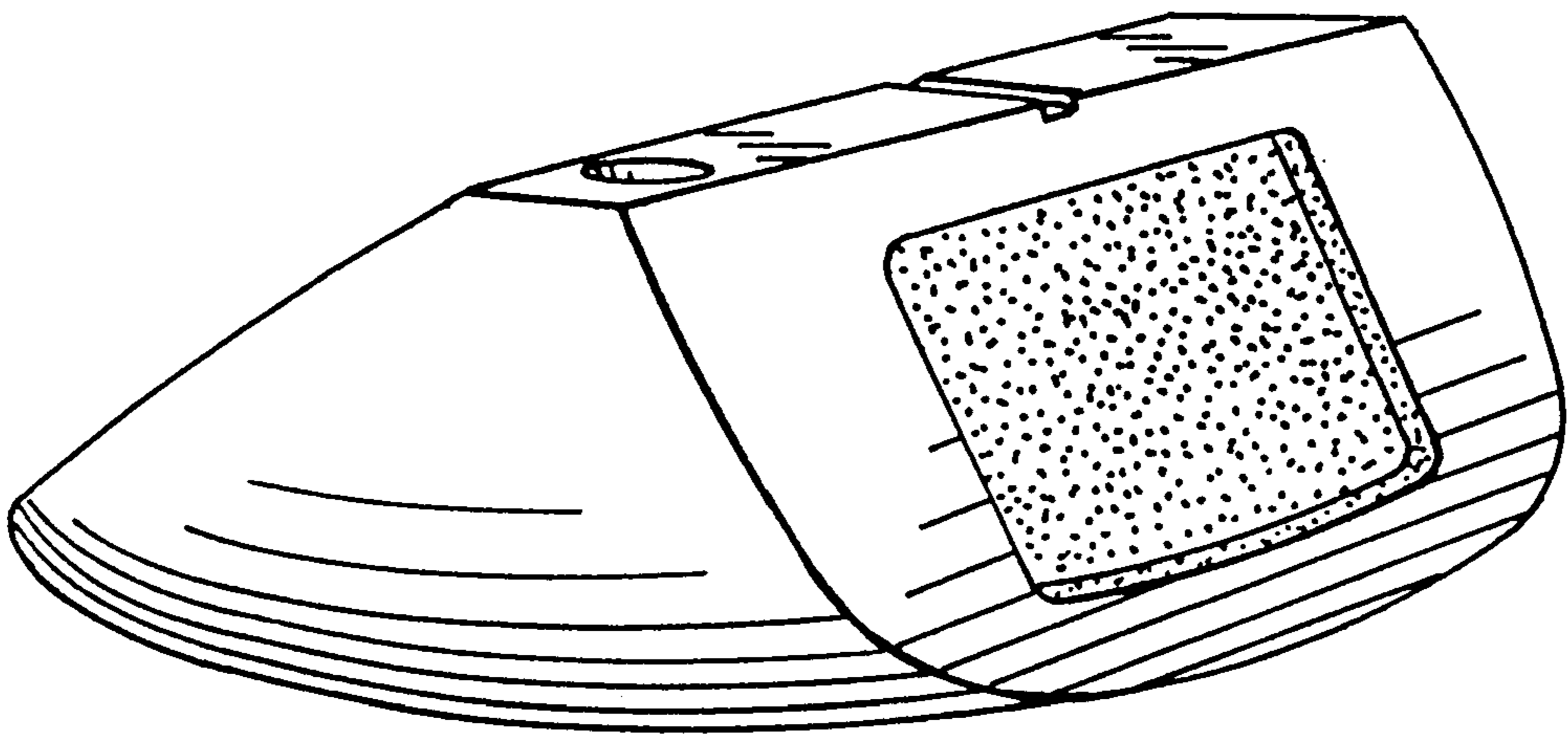

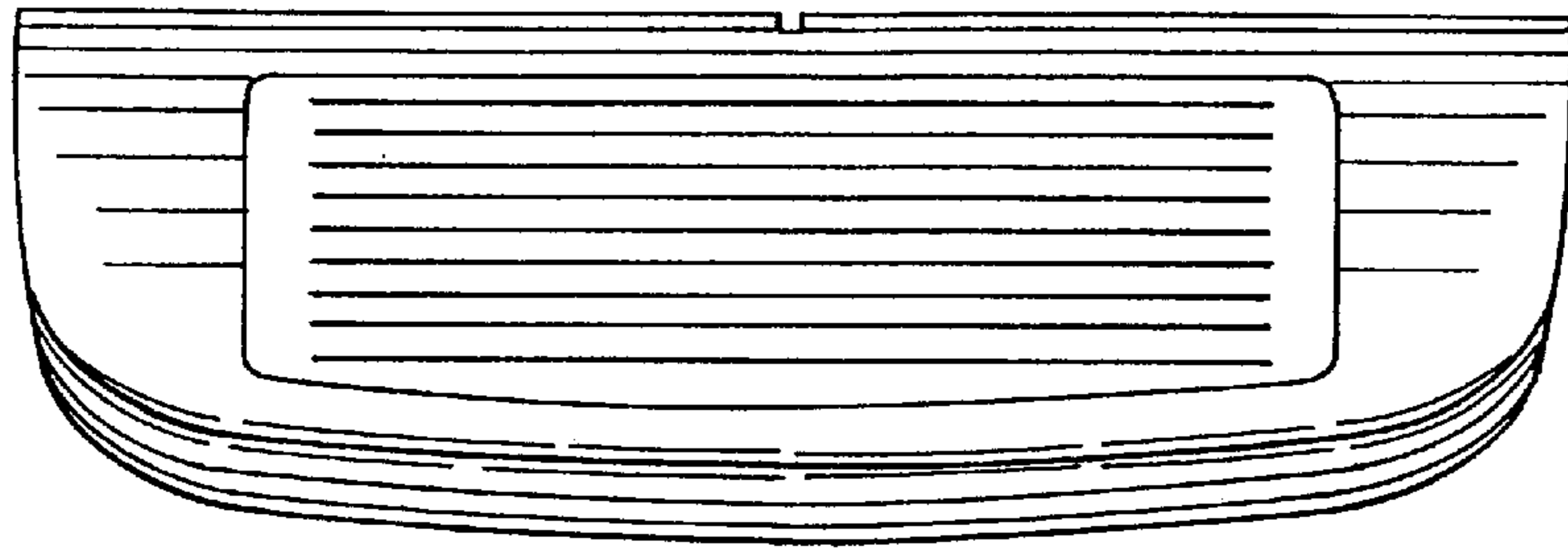

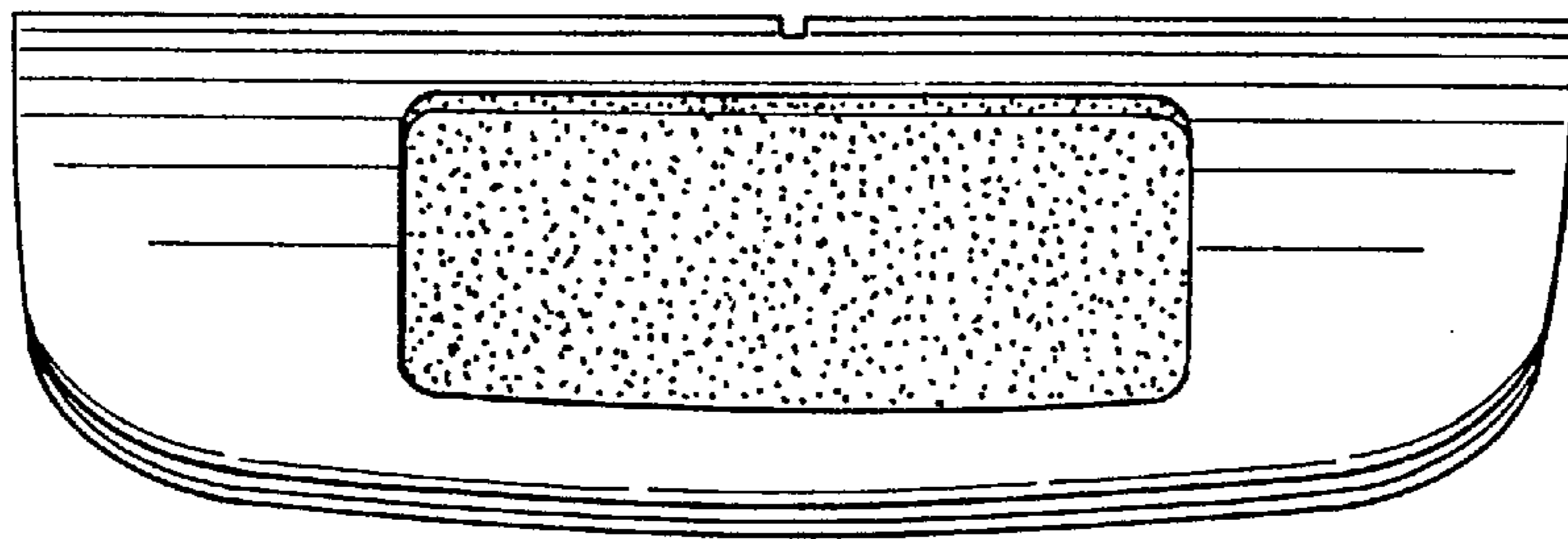

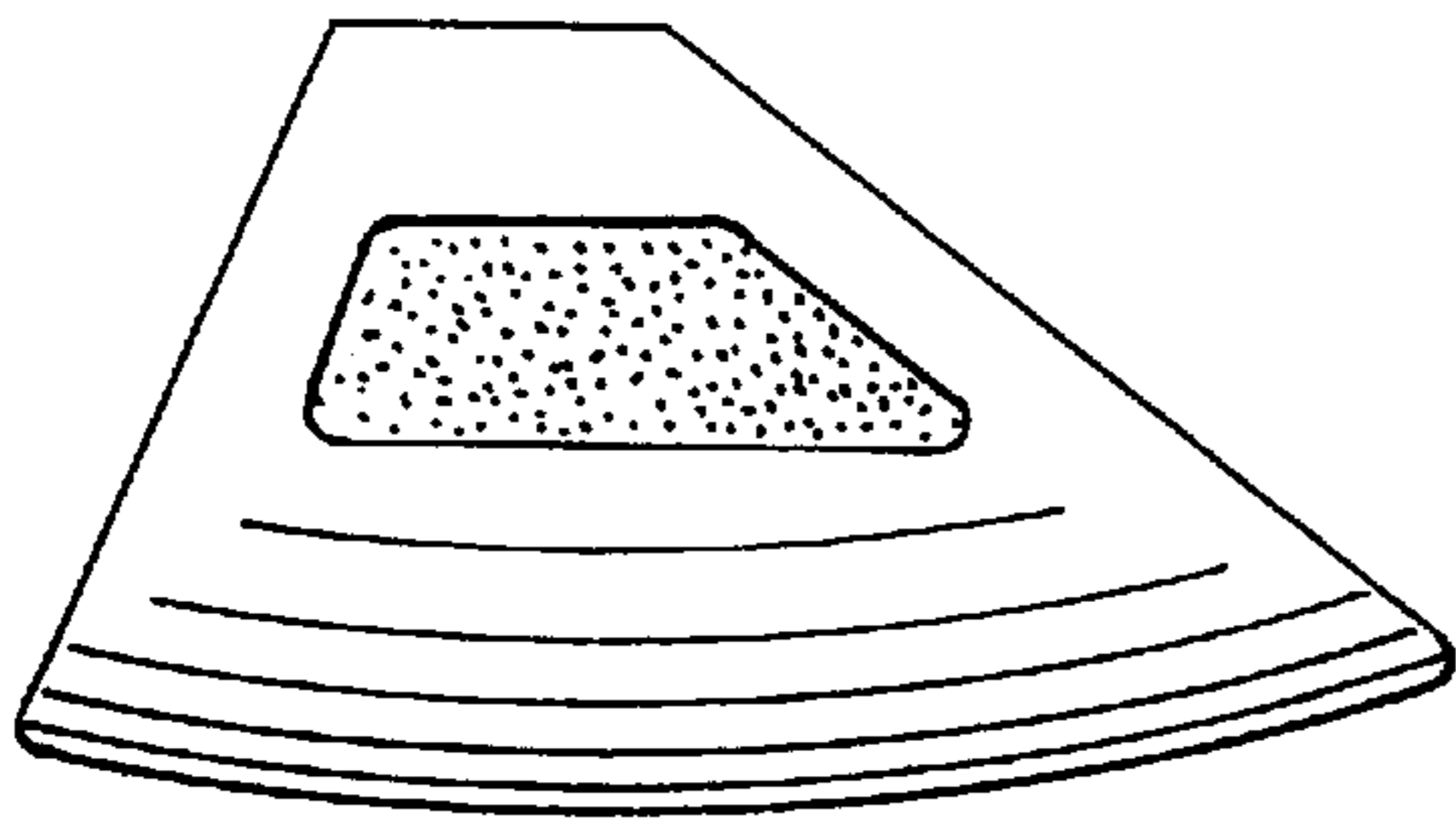

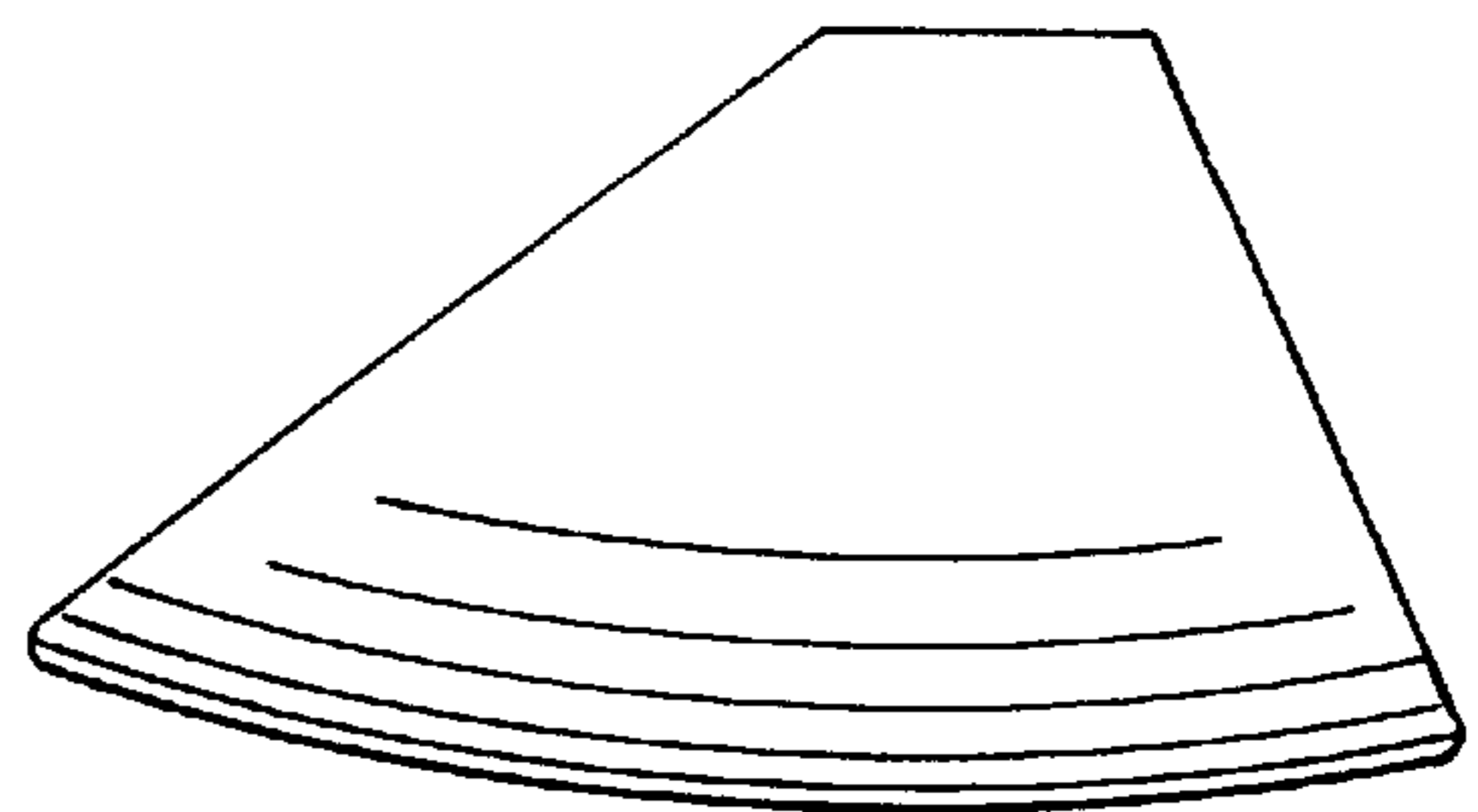

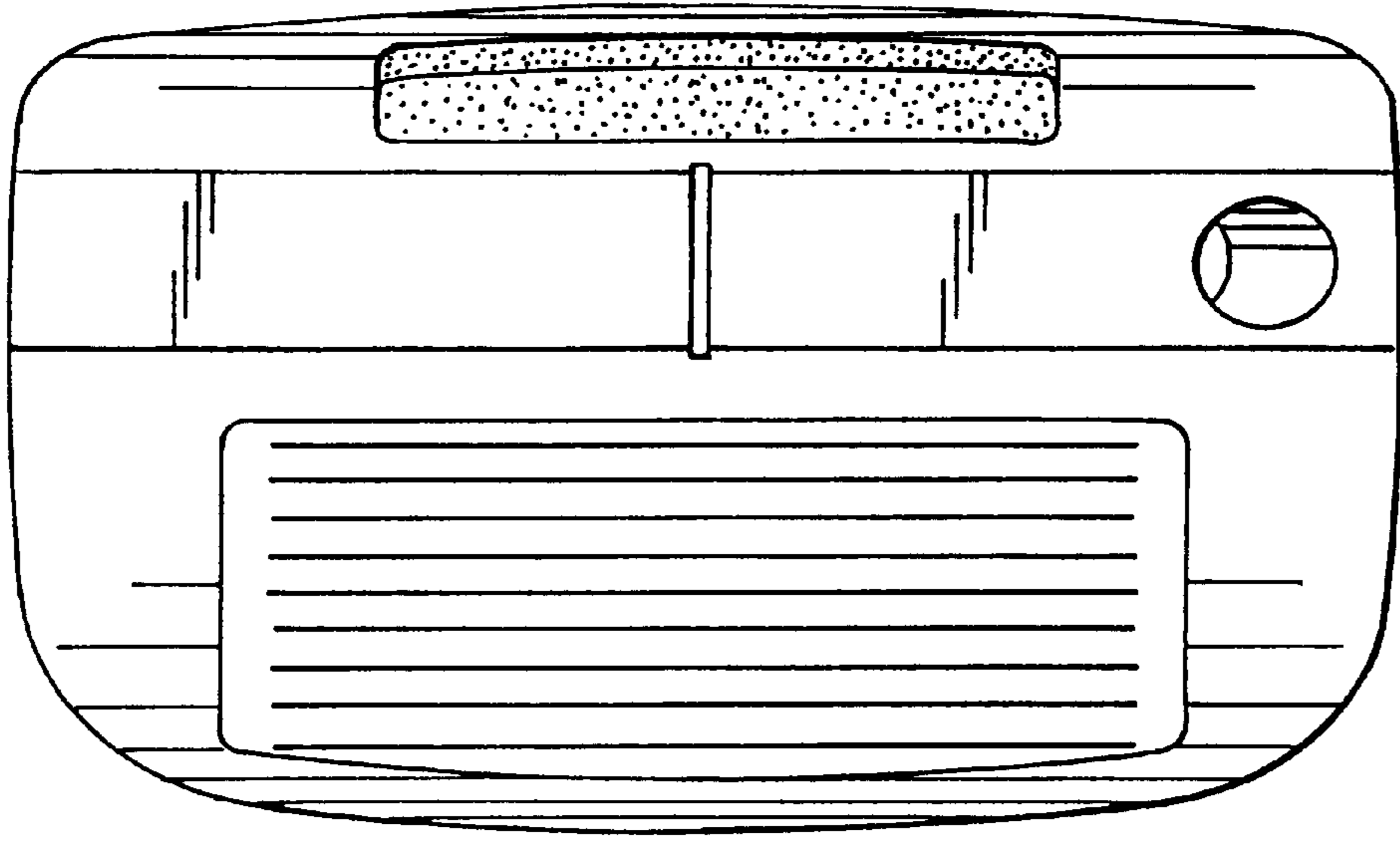

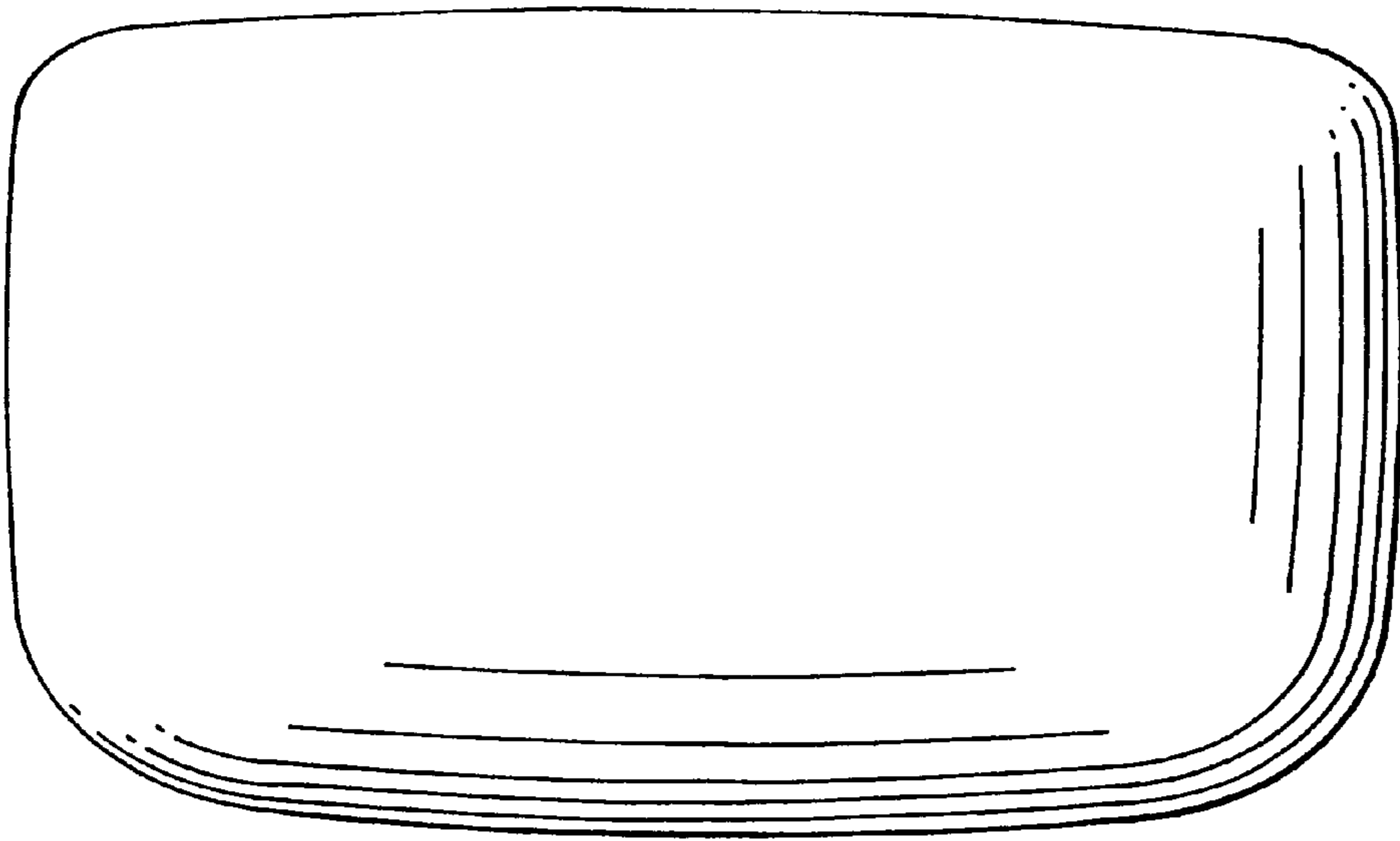
