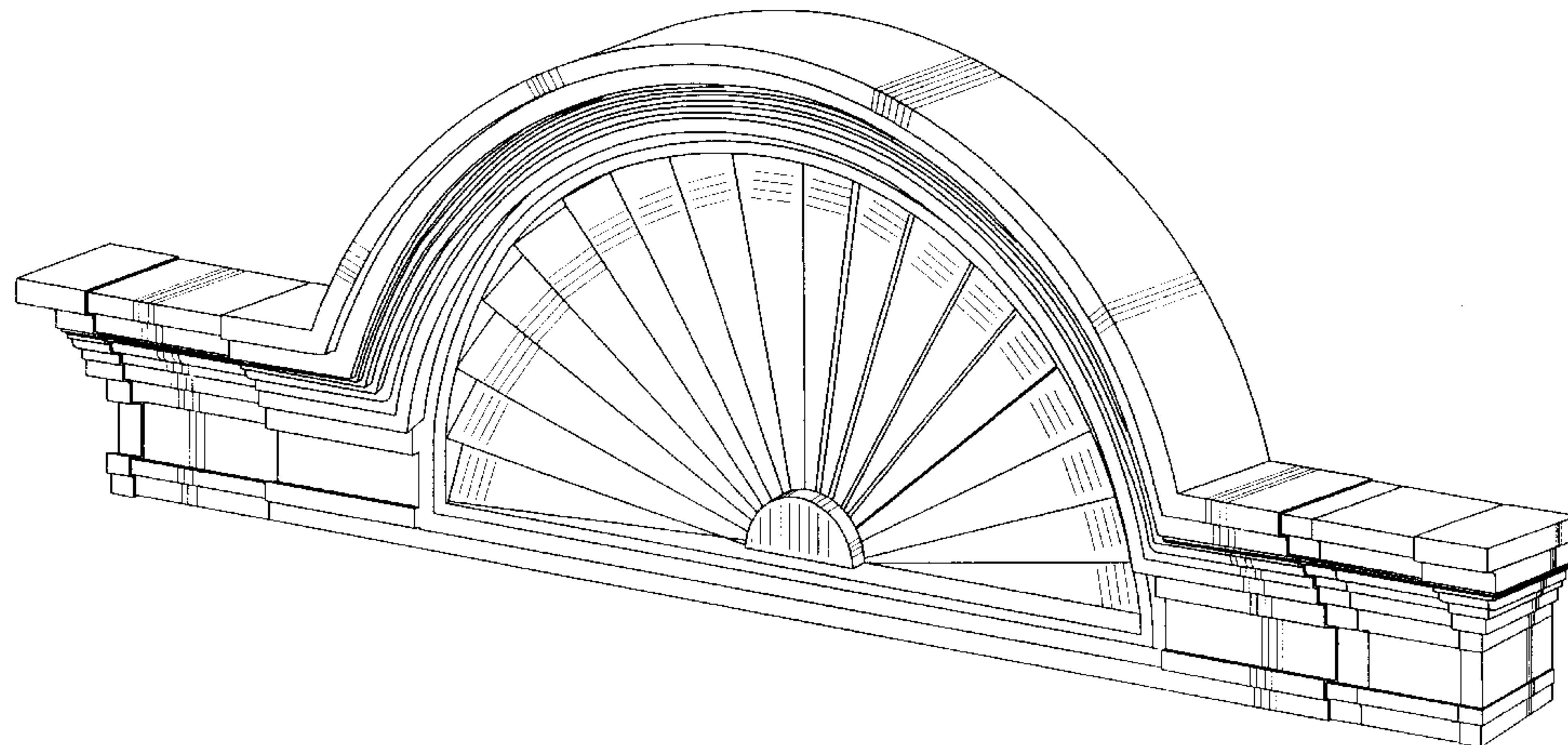
[57] CLAIM

We claim the ornamental design for a sunburst trim assembly, as shown and described.

DESCRIPTION

FIG. 1 is a top view of the sunburst trim assembly; FIG. 2 is a front view of the sunburst trim assembly; FIG. 3 is a bottom view of the sunburst trim assembly; FIG. 4 is a rear view of the sunburst trim assembly; FIG. 5 is a side view of the sunburst trim assembly as seen from the right side of FIG. 1; FIG. 6 is a side view of the sunburst trim assembly as seen from the left side of FIG. 1; and, FIG. 7 is a front perspective view of the sunburst trim assembly.

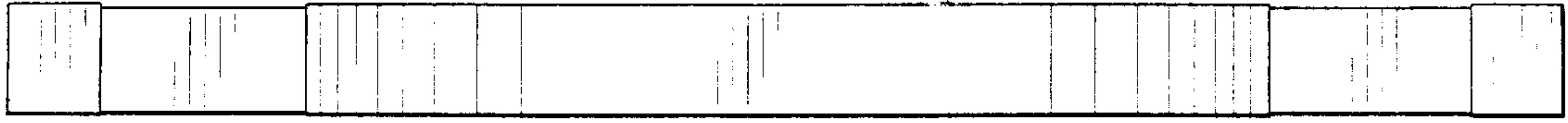

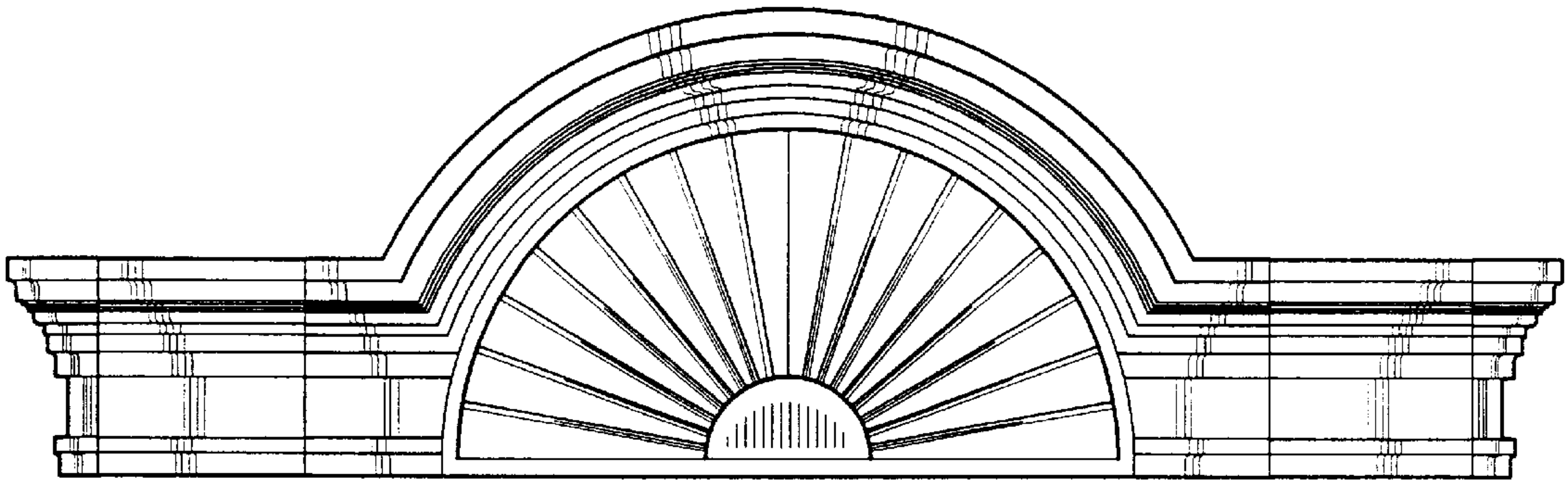

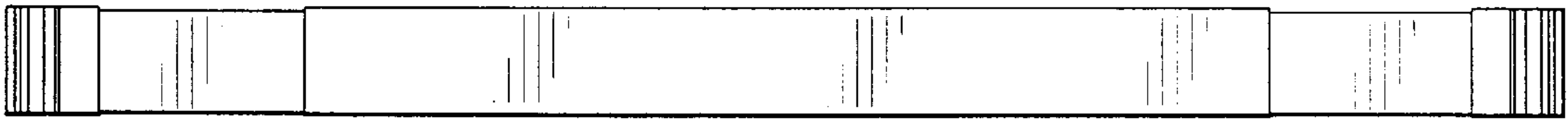

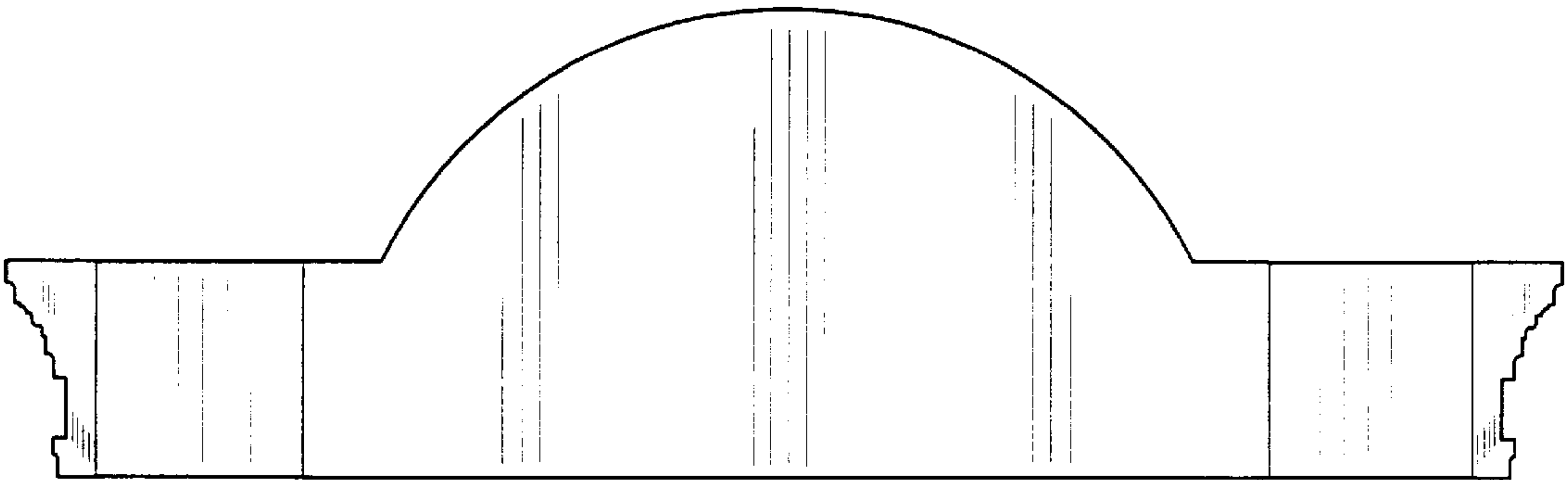

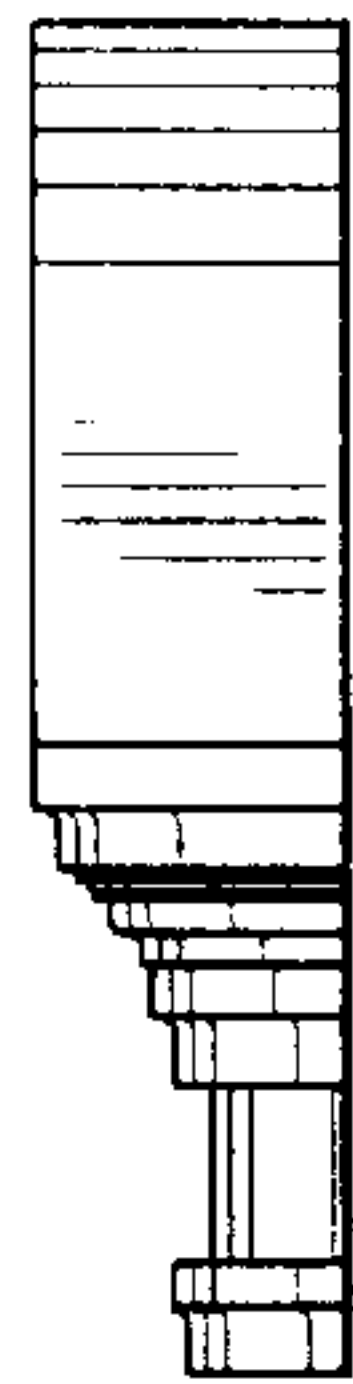
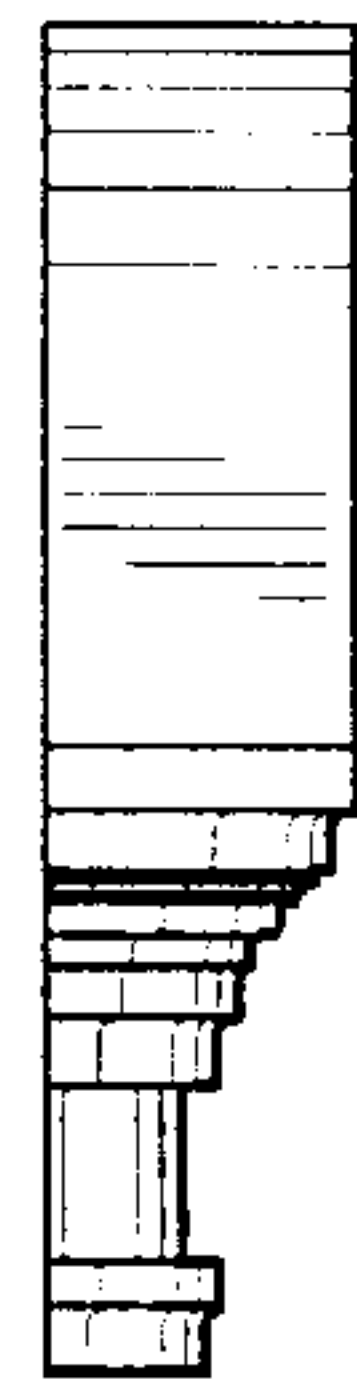

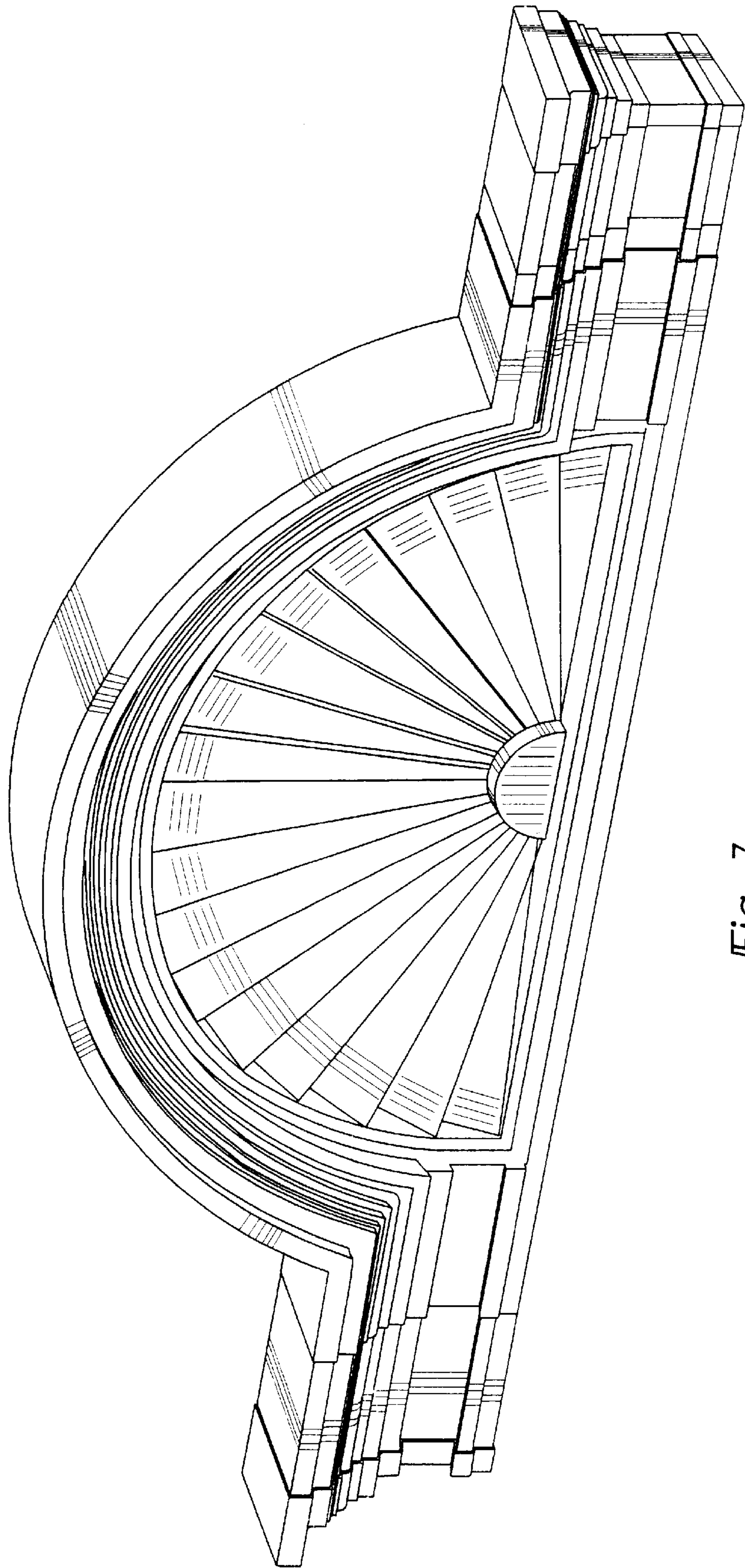
