DESCRIPTION

FIG. 1 is a perspective view of the paving brick according

to the first embodiment of the present invention;

FIG. 2 is a top elevational view of the paving brick shown in FIG. 1;

FIG. 3 is a front elevational view of the paving brick shown in FIG. 1;

FIG. 4 is a rear elevational view of the paving brick shown in FIG. 1;

FIG. 5 is a left side elevational view of the paving brick shown in FIG. 1;

FIG. 6 is a right side elevational view of the paving brick shown in FIG. 1;

FIG. 7 is a top plan view of a plurality of paving bricks shown in FIG. 1;

FIG. 8 is a perspective view of a paving brick according to the second embodiment of the present invention;

FIG. 9 is a front elevational view of the paving brick shown in FIG. 8;

FIG. 10 is a front elevational view of the paving brick shown in FIG. 8;

FIG. 11 is a rear elevational view of the paving brick shown in FIG. 8;

FIG. 12 is a left side elevational view of the paving brick shown in FIG. 8;

FIG. 13 is a right side elevational view of the paving brick shown in FIG. 8; and,

FIG. 14 is a top plan view of a plurality of paving bricks shown in FIG. 8.

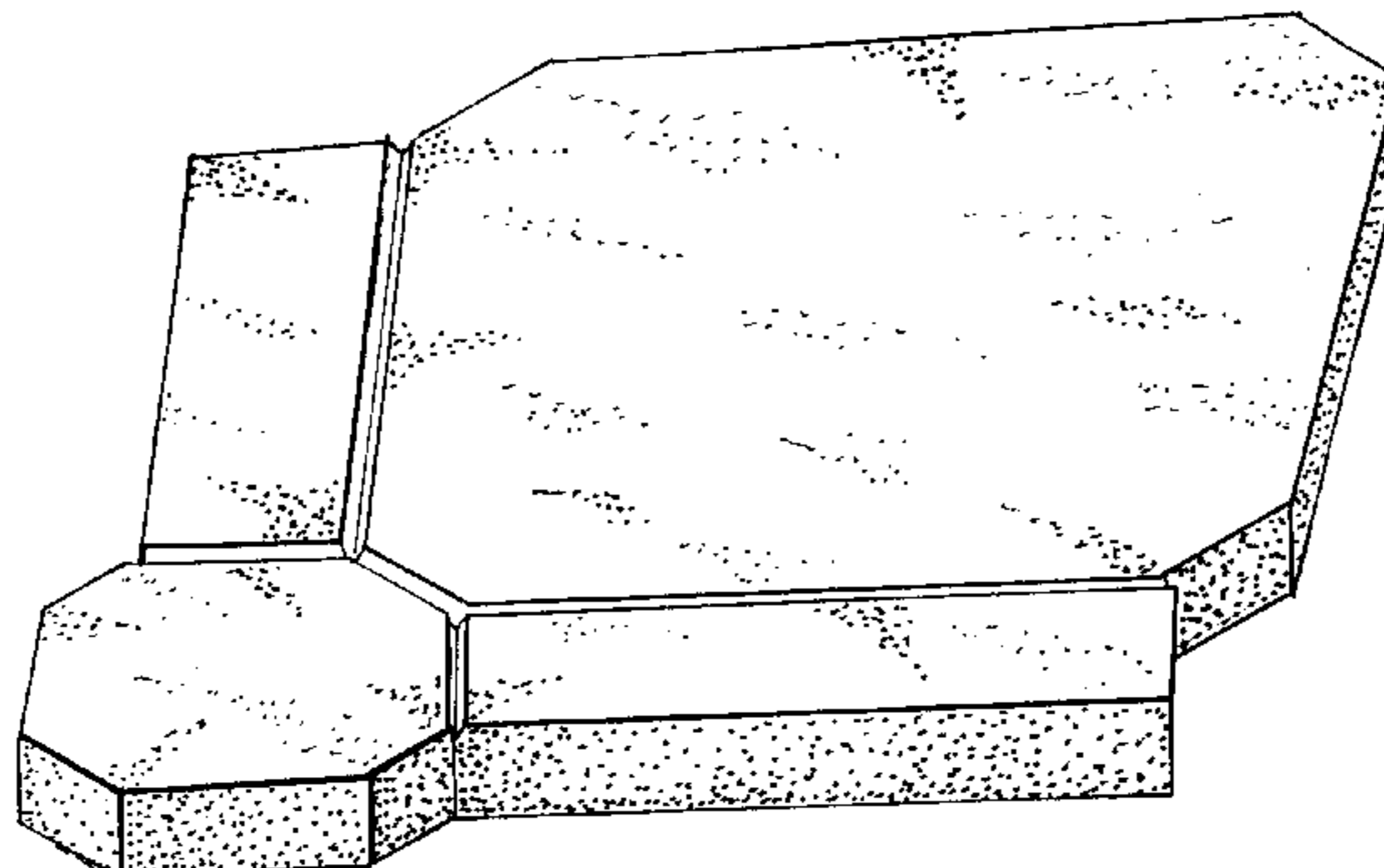
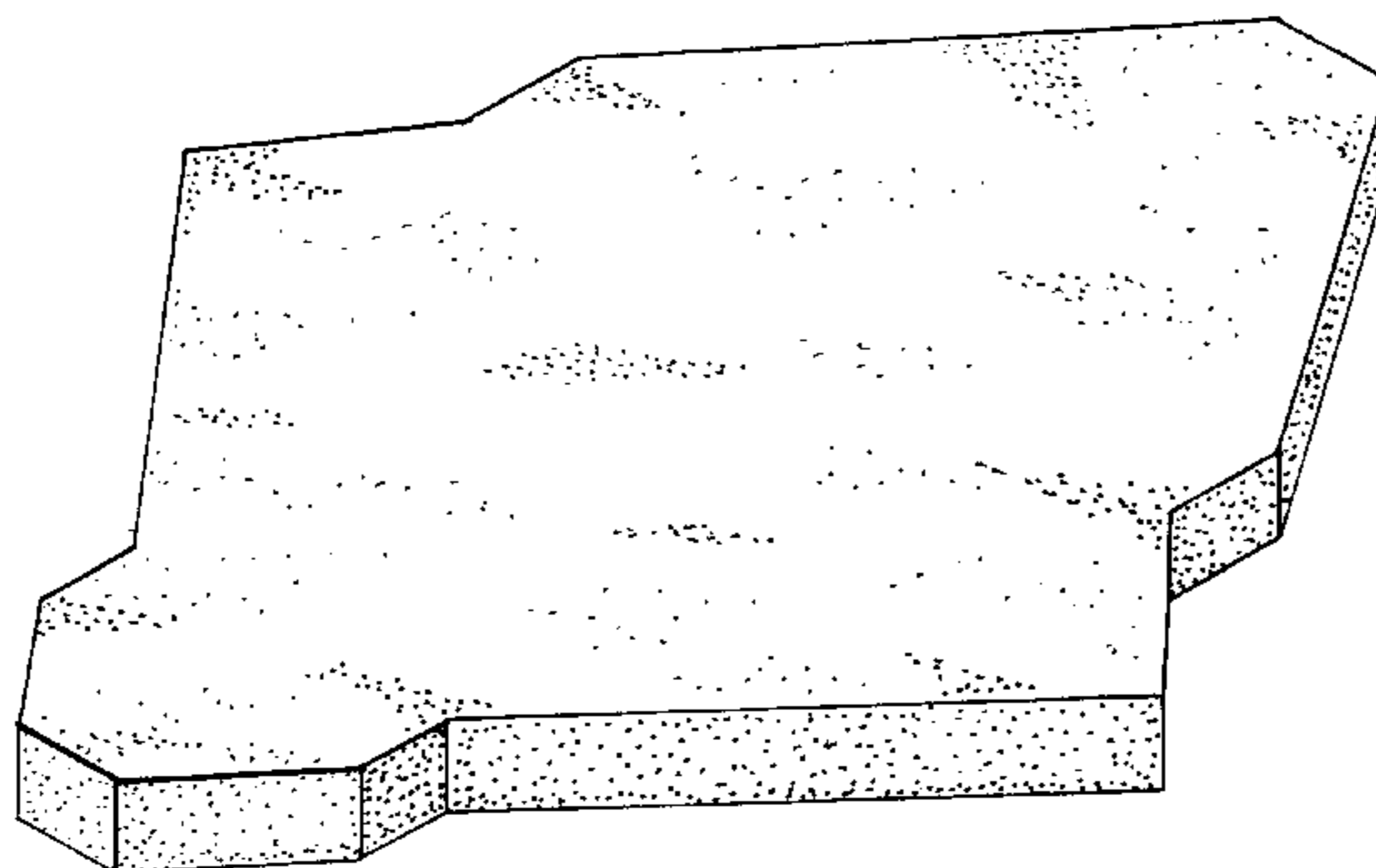

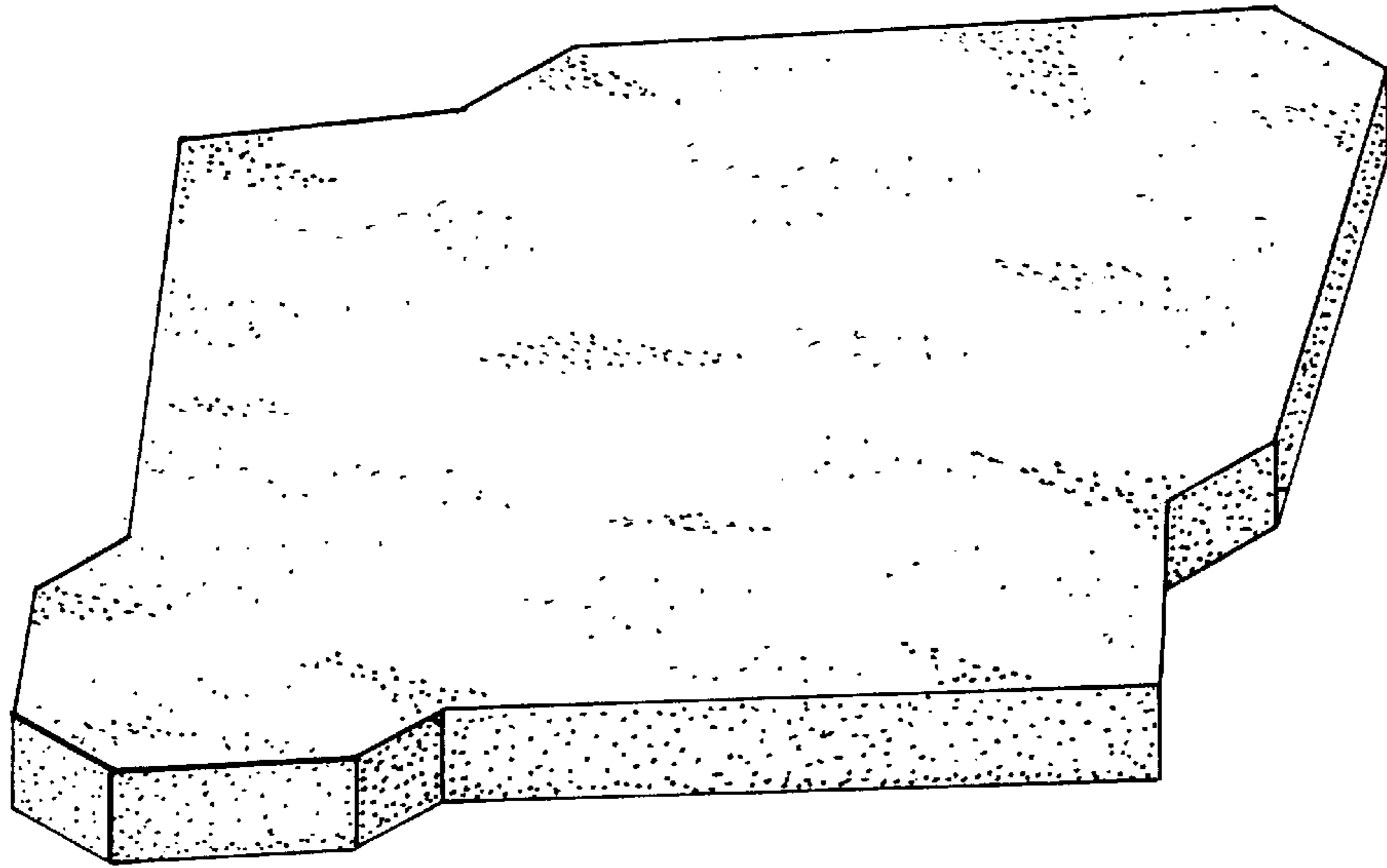
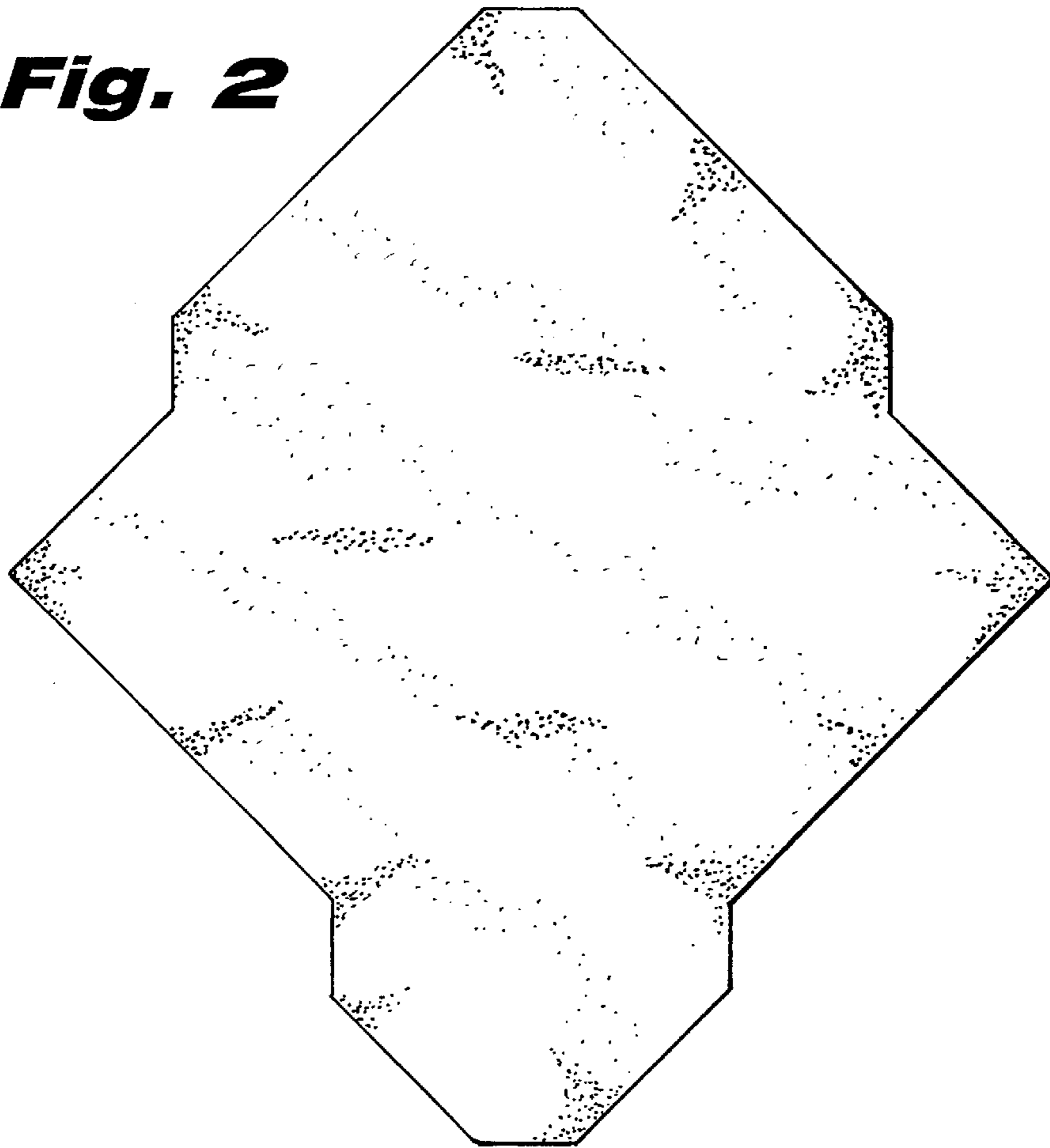

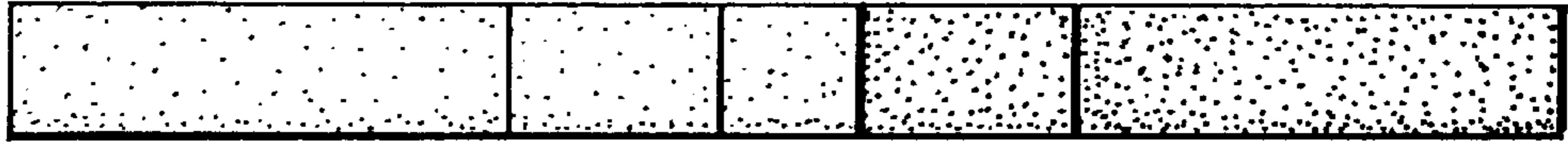

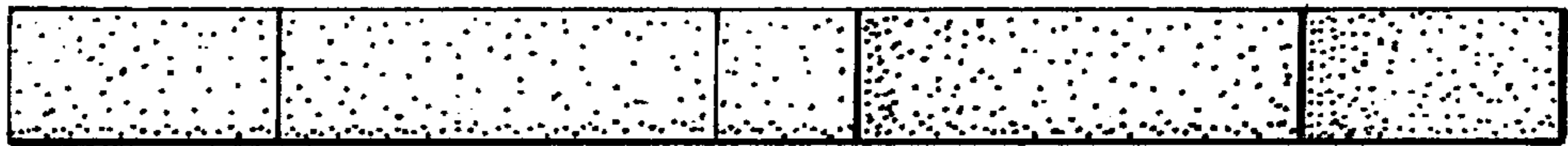

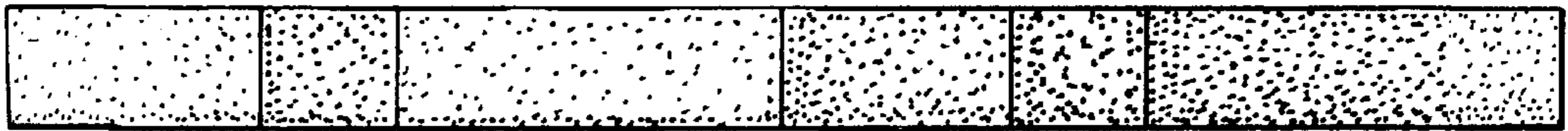

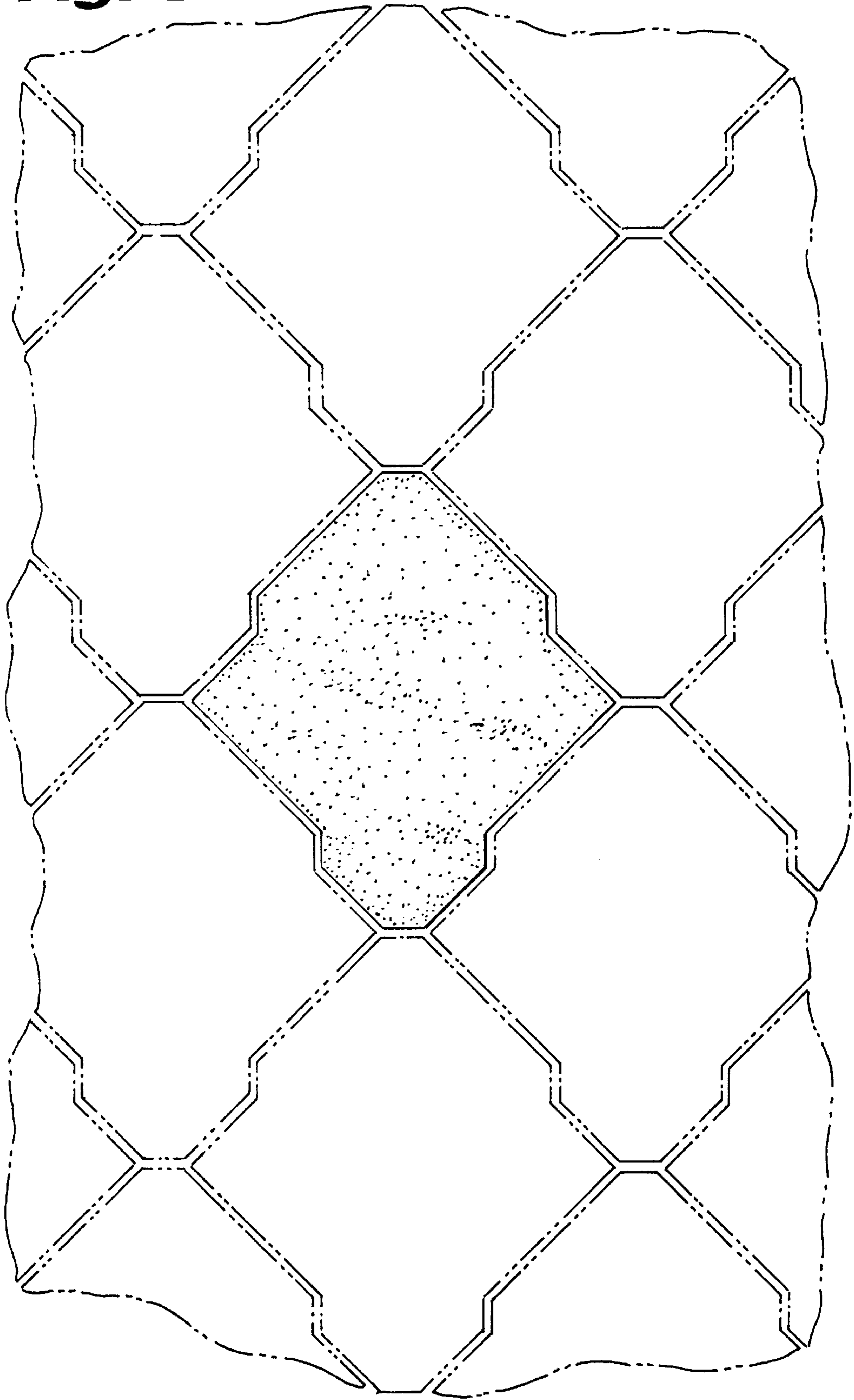

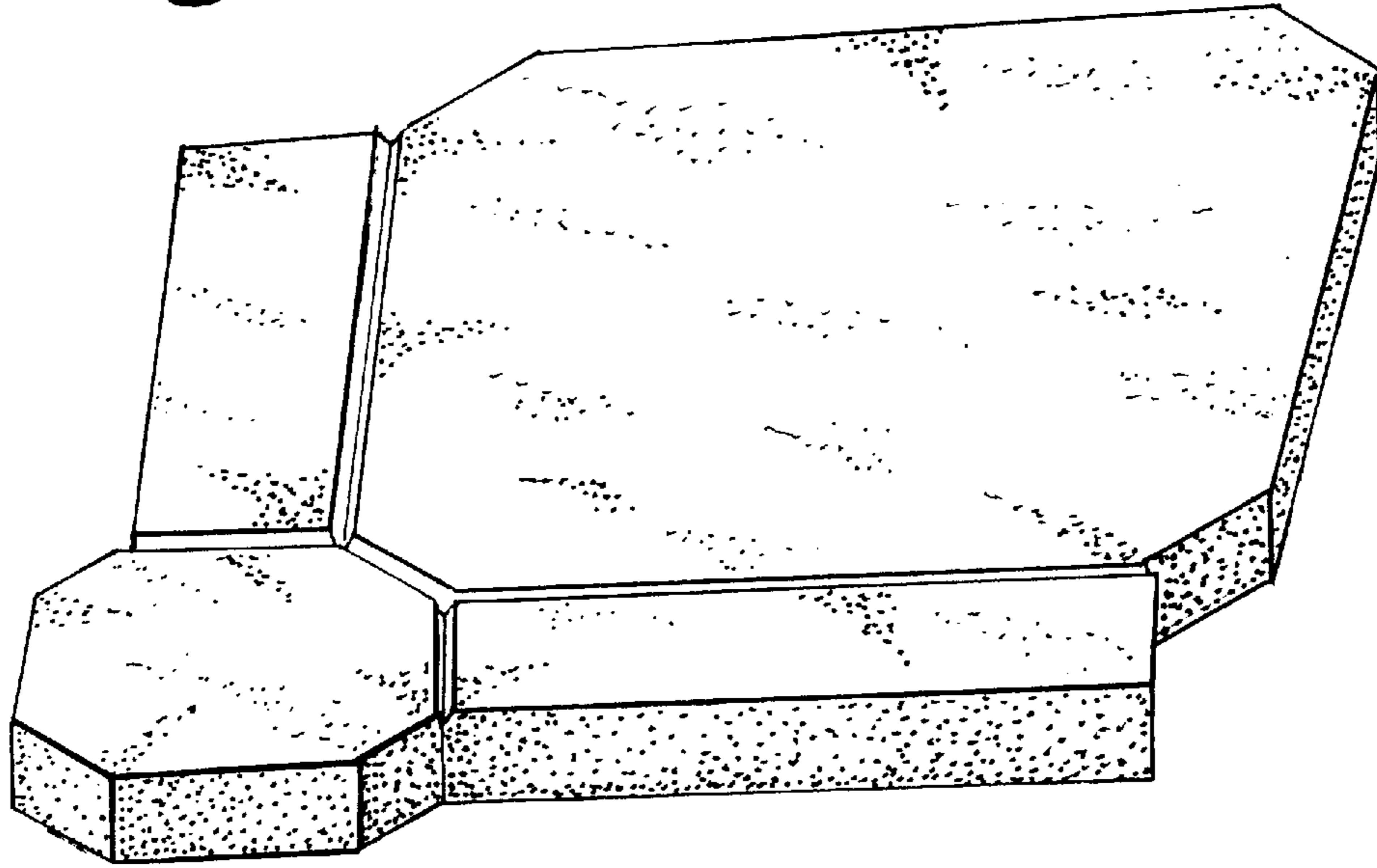

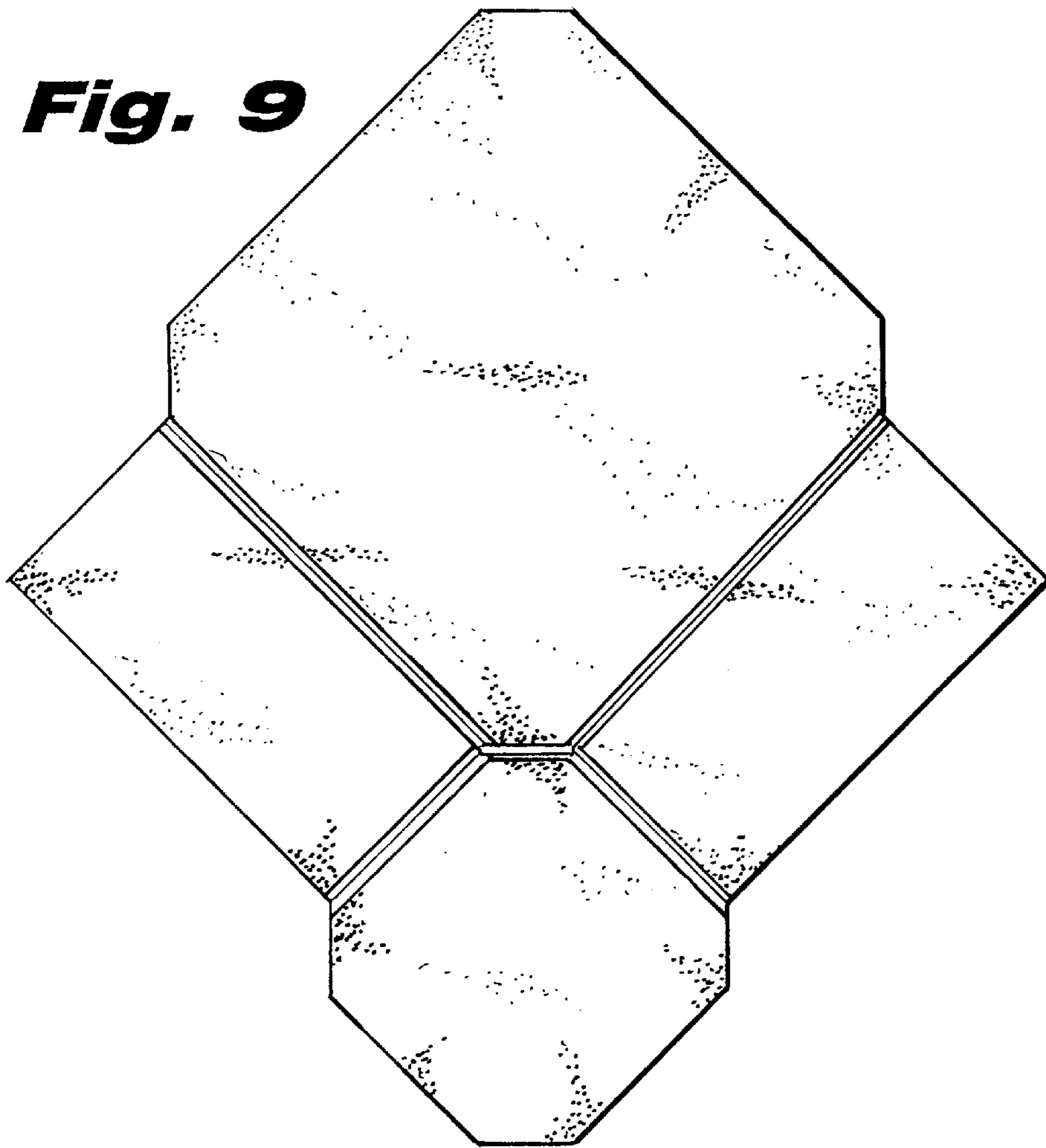

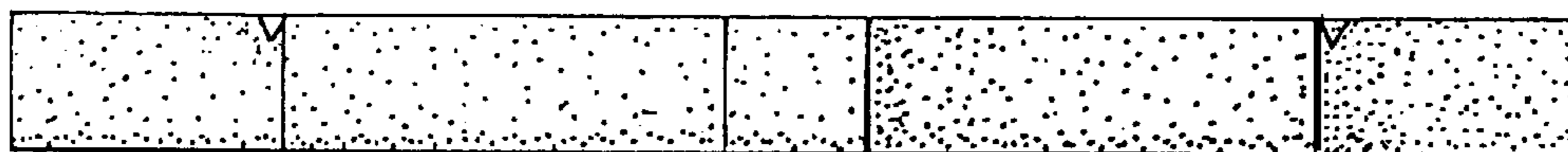
