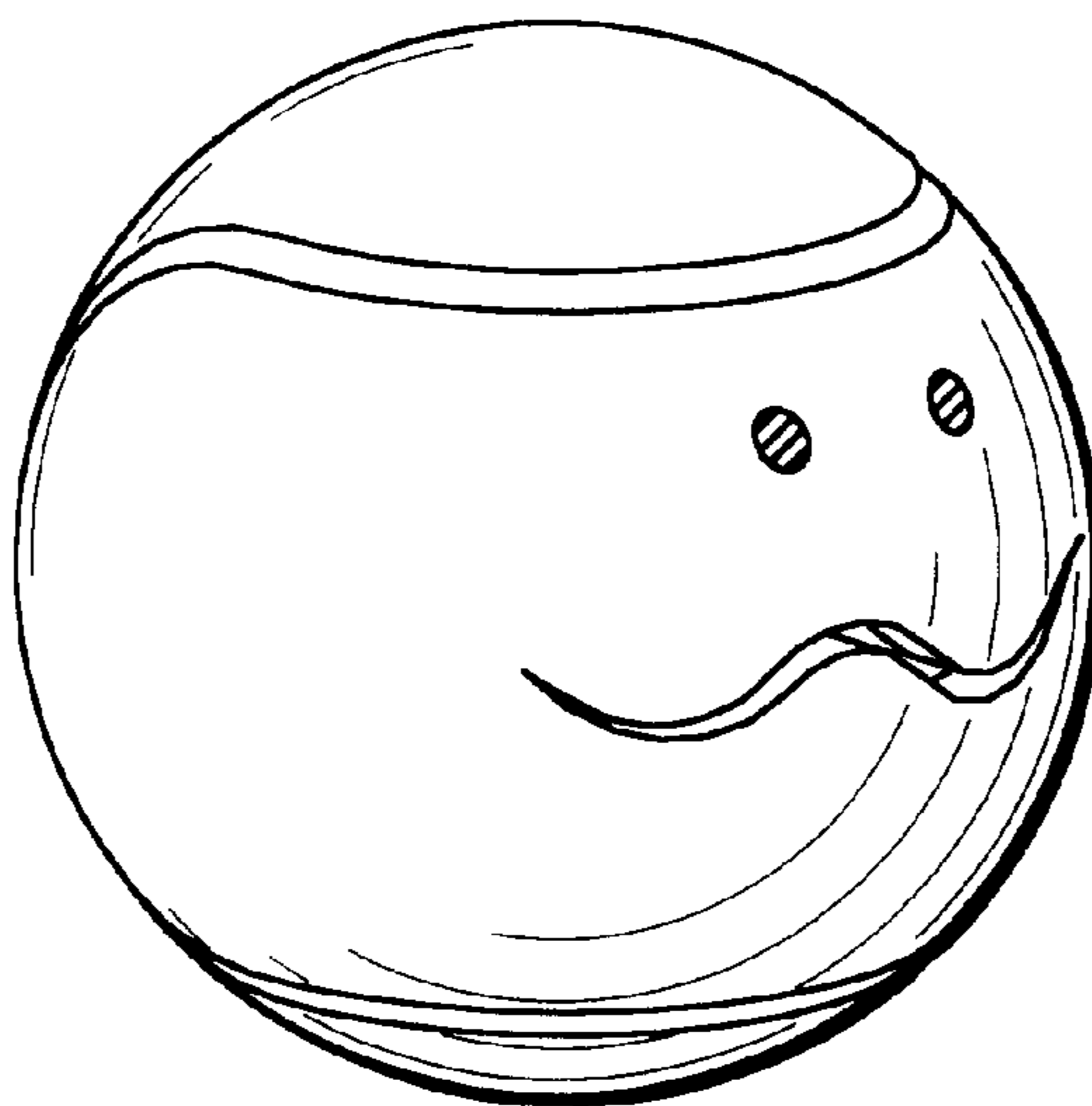

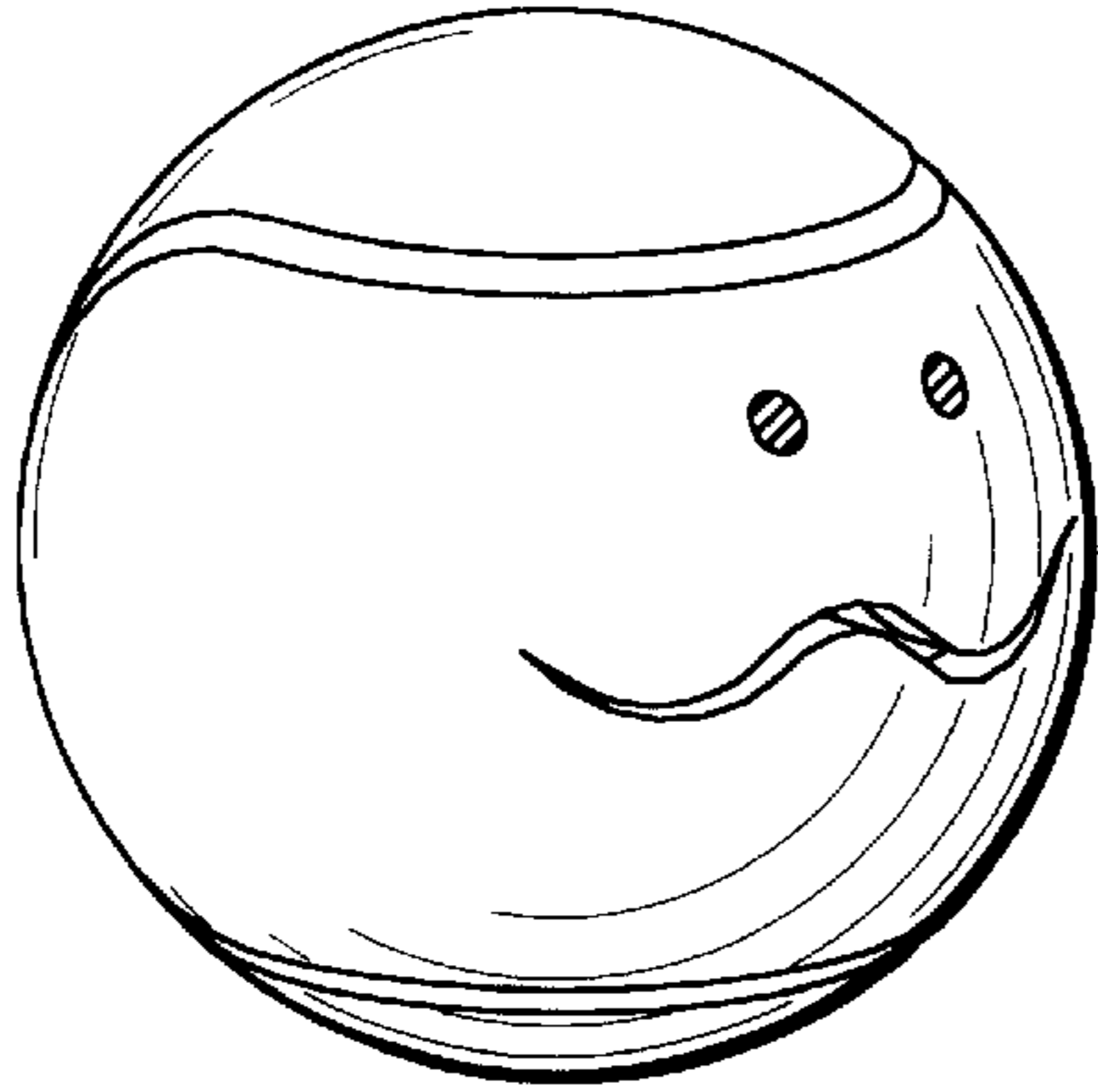

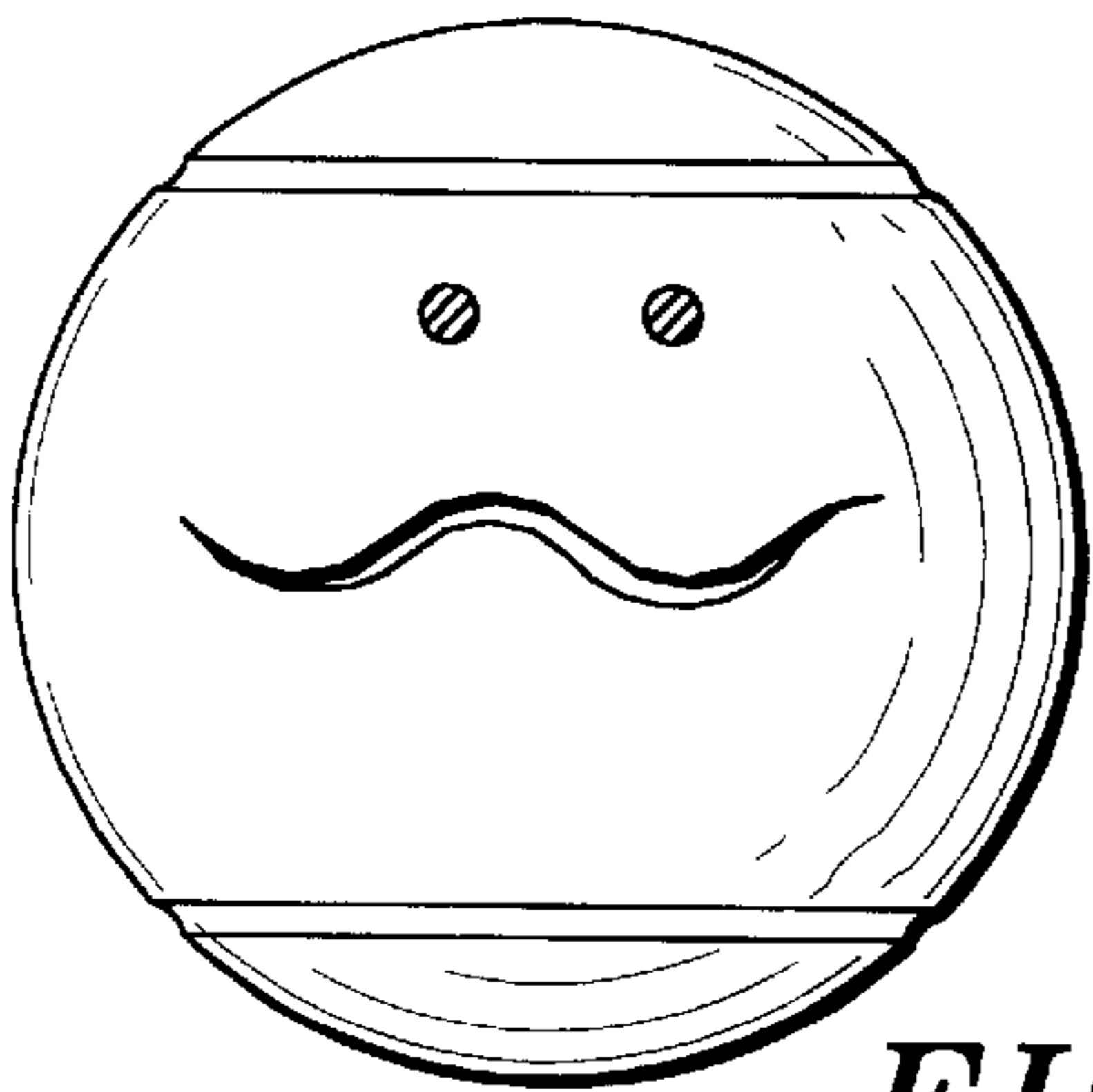
FIG. 1 is a front perspective view showing my new design;

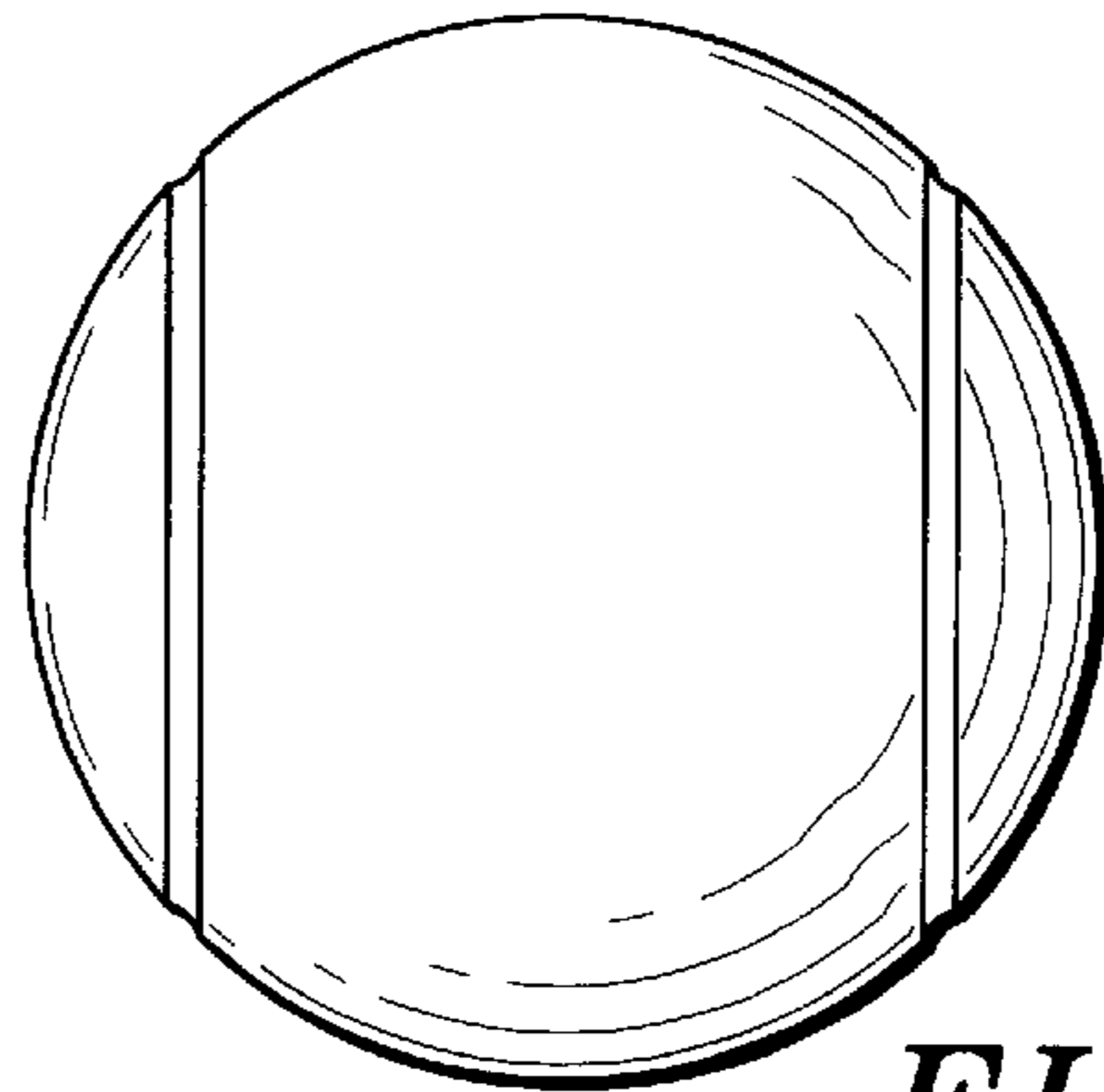




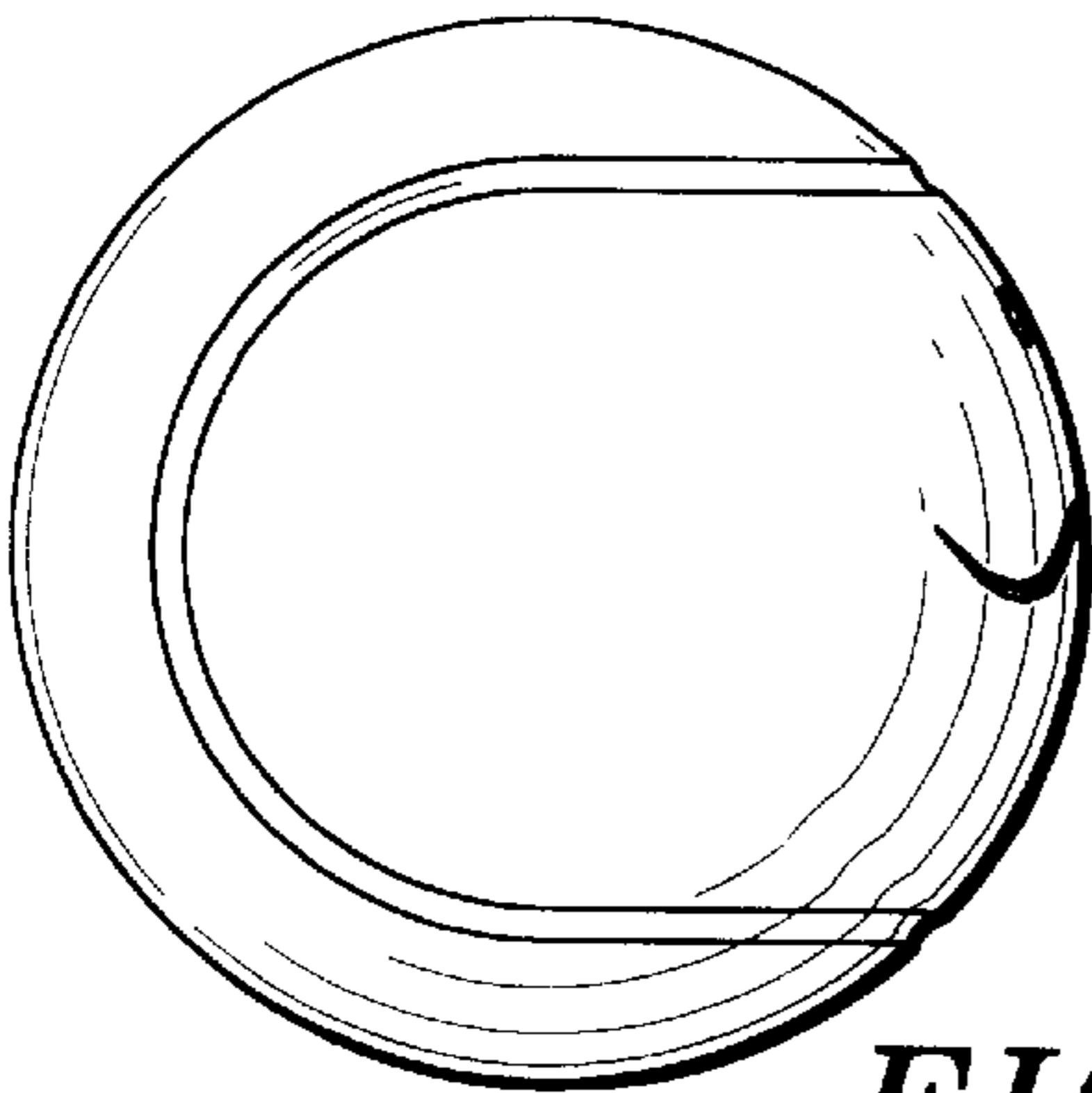

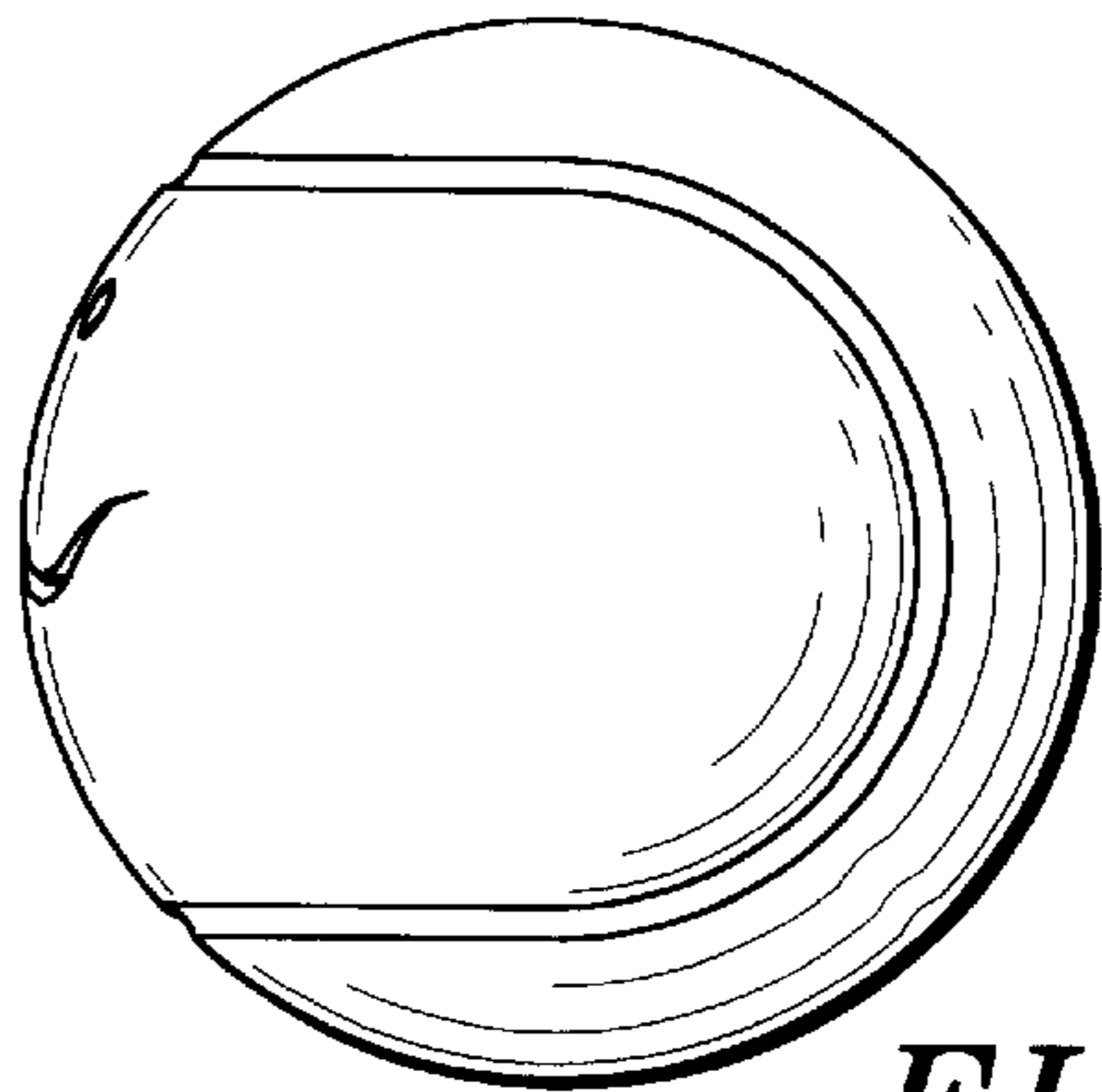

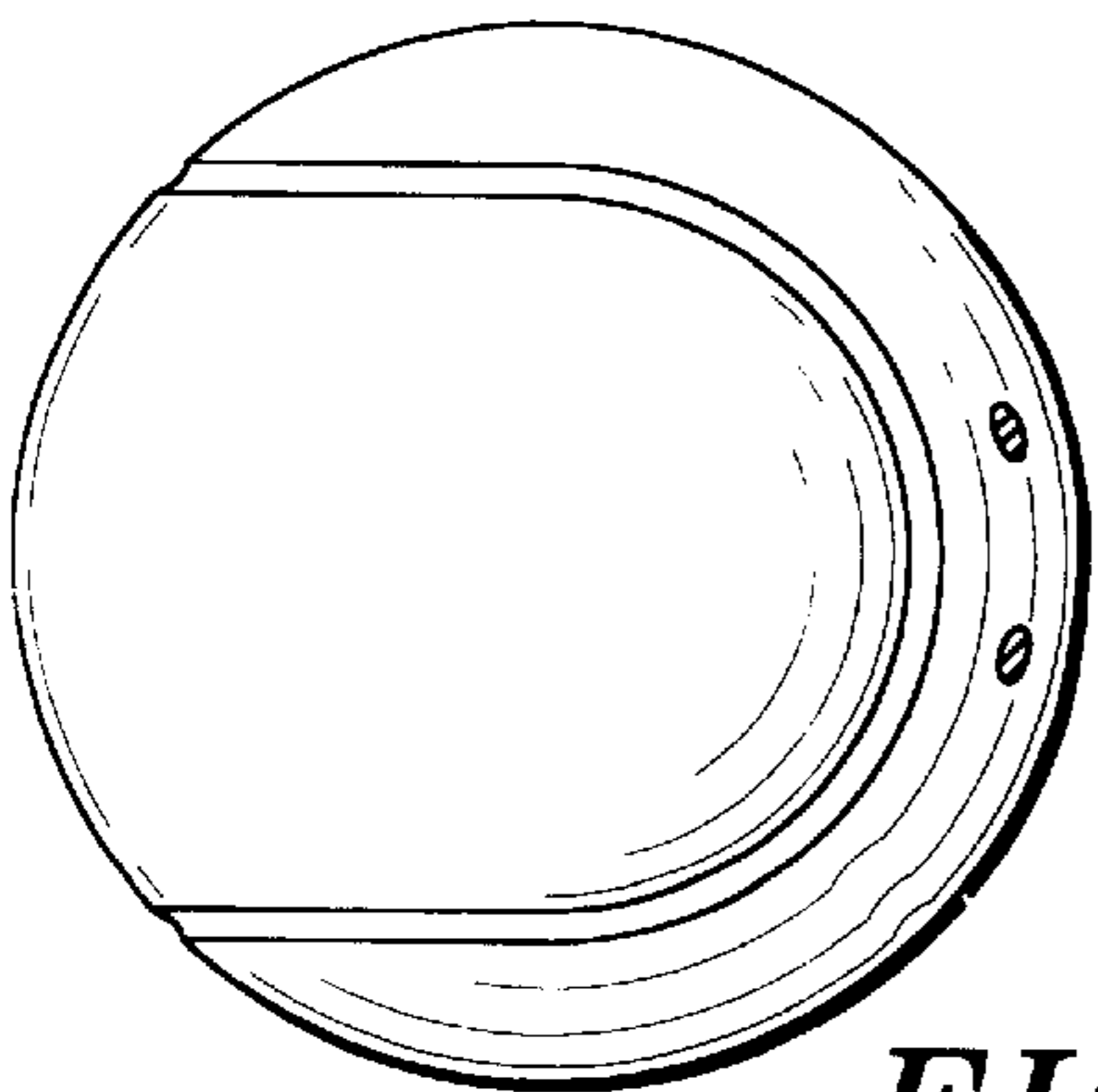

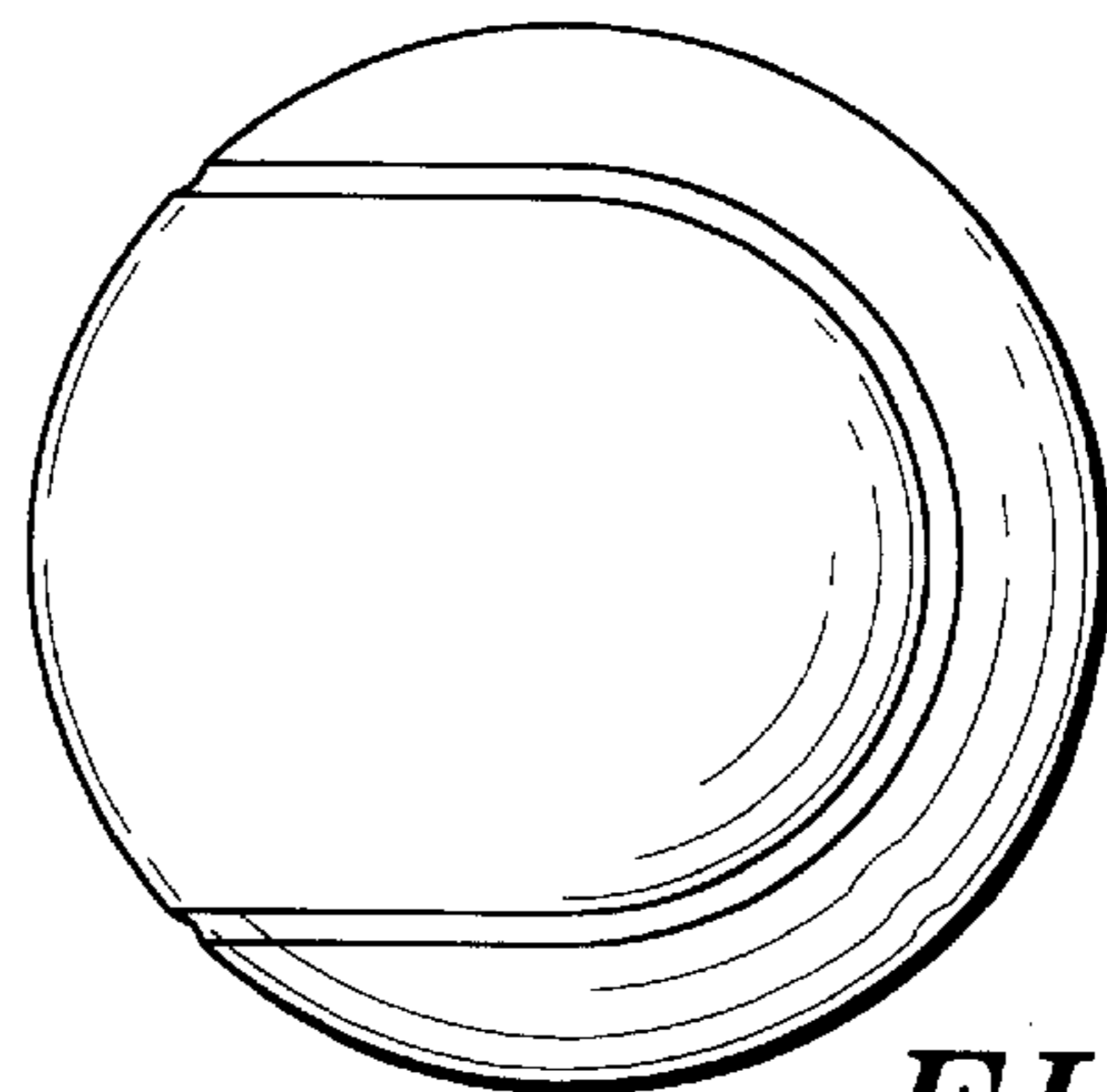
