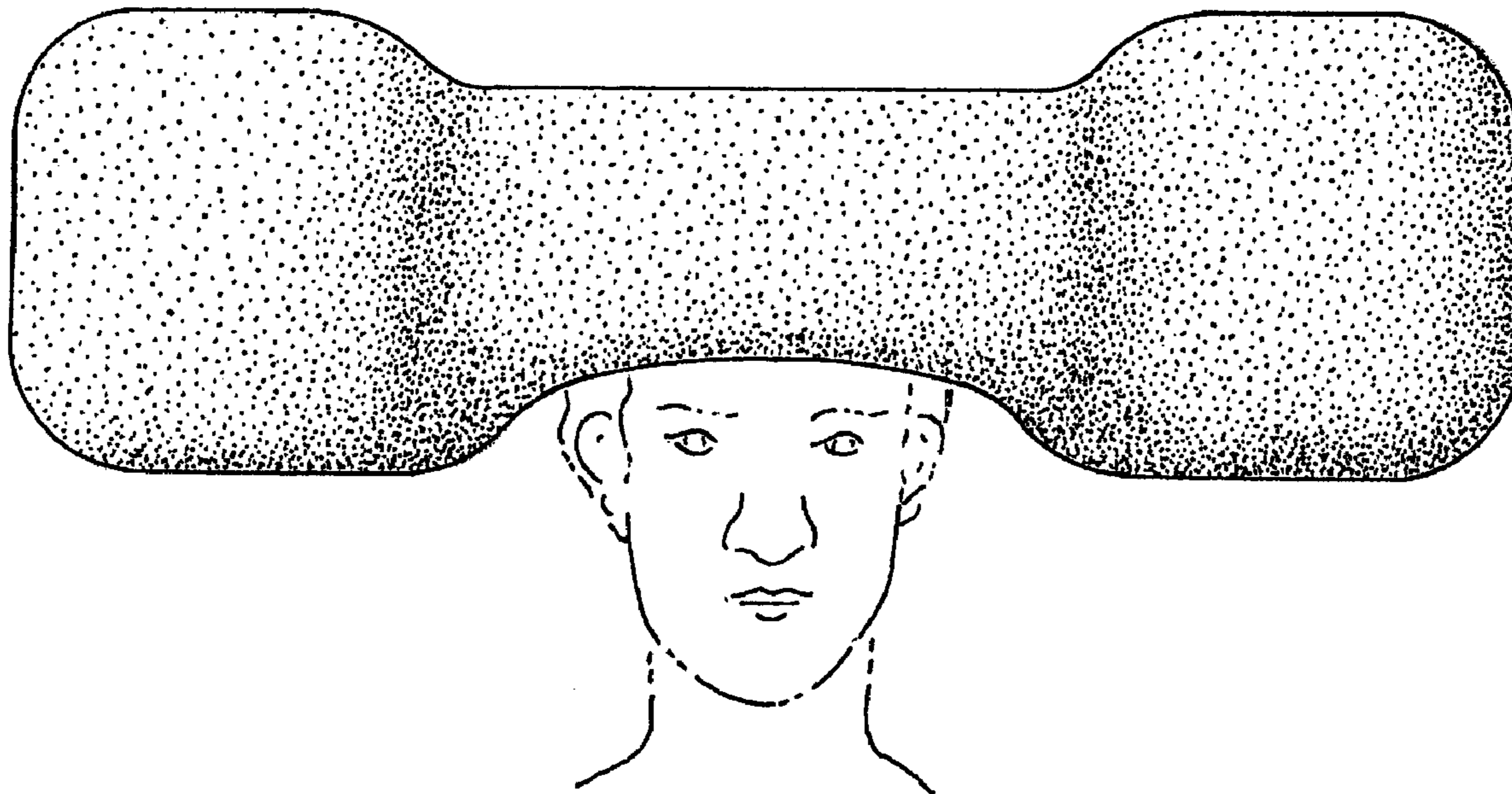
FIG. 1 is an end elevational view of bone configured headwear showing my new design, the opposite end is a mirror image;

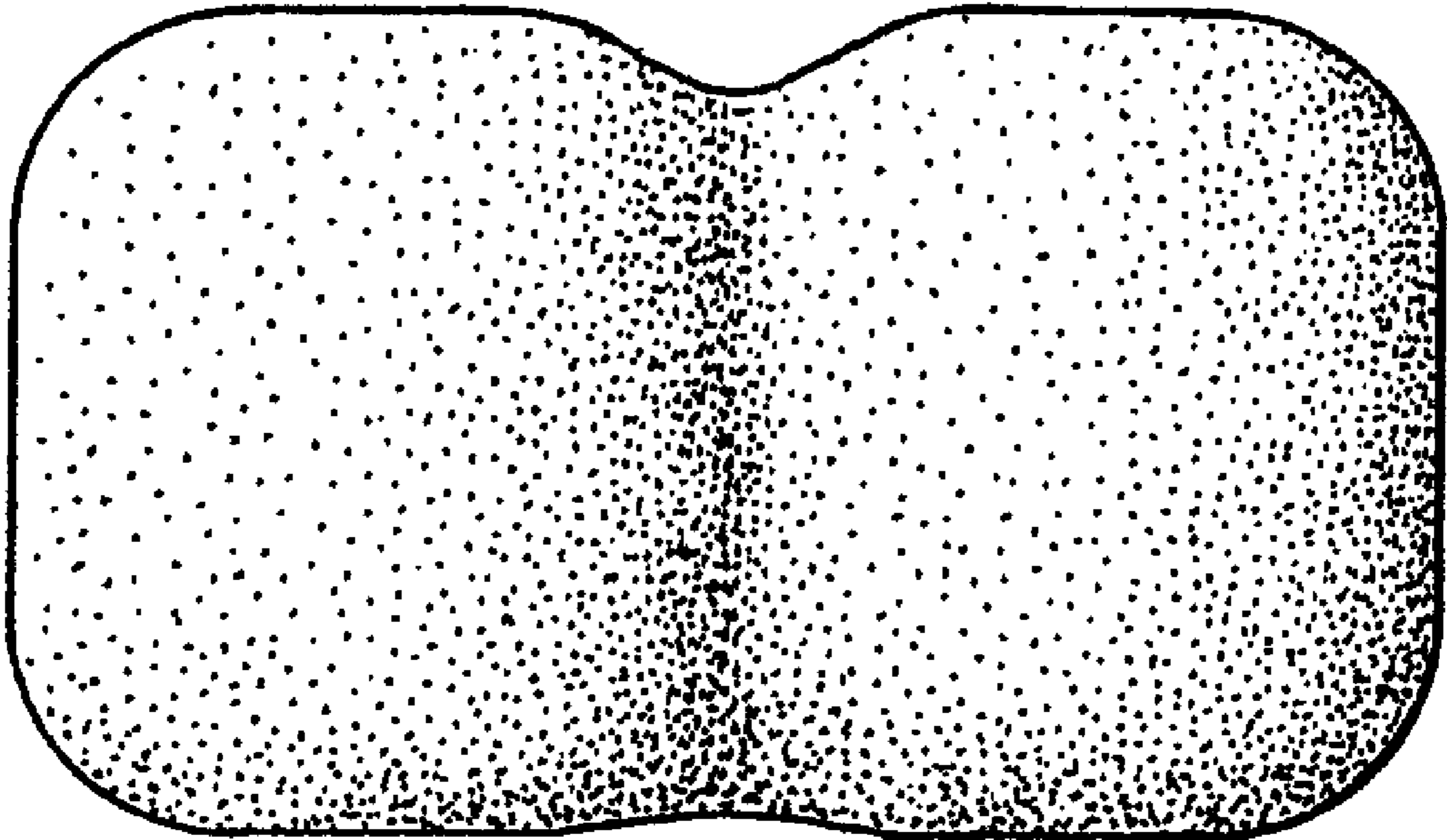

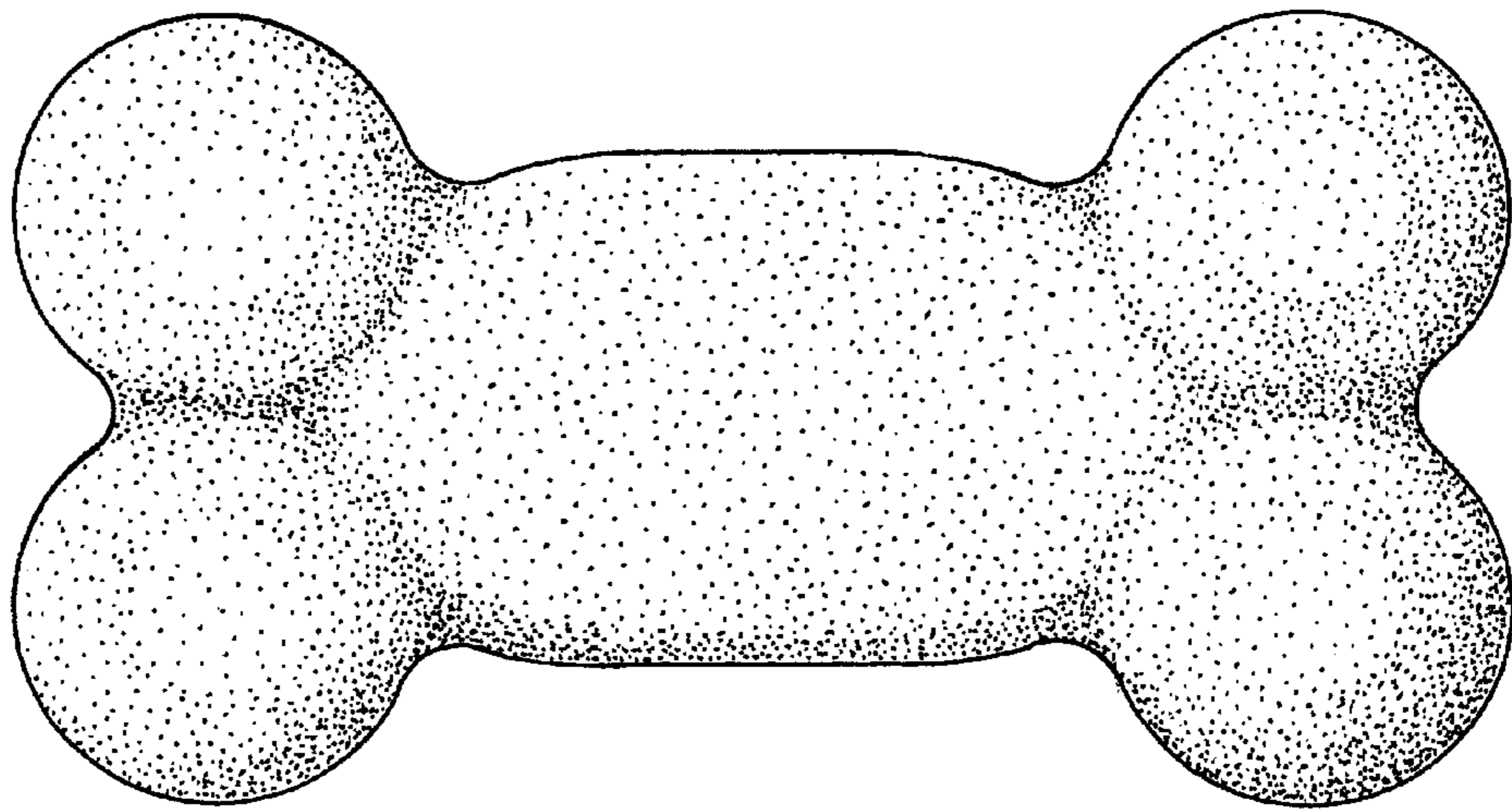

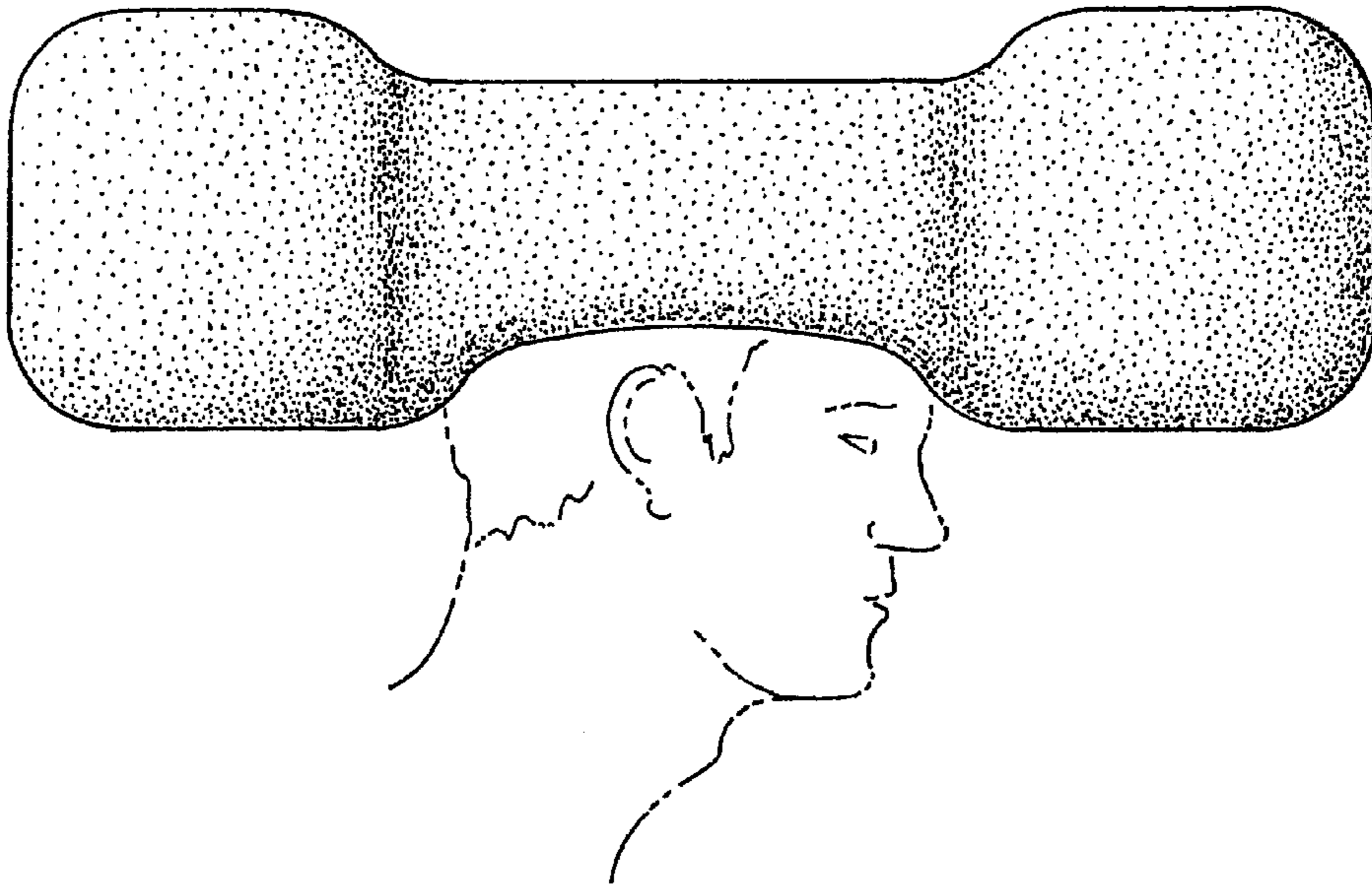

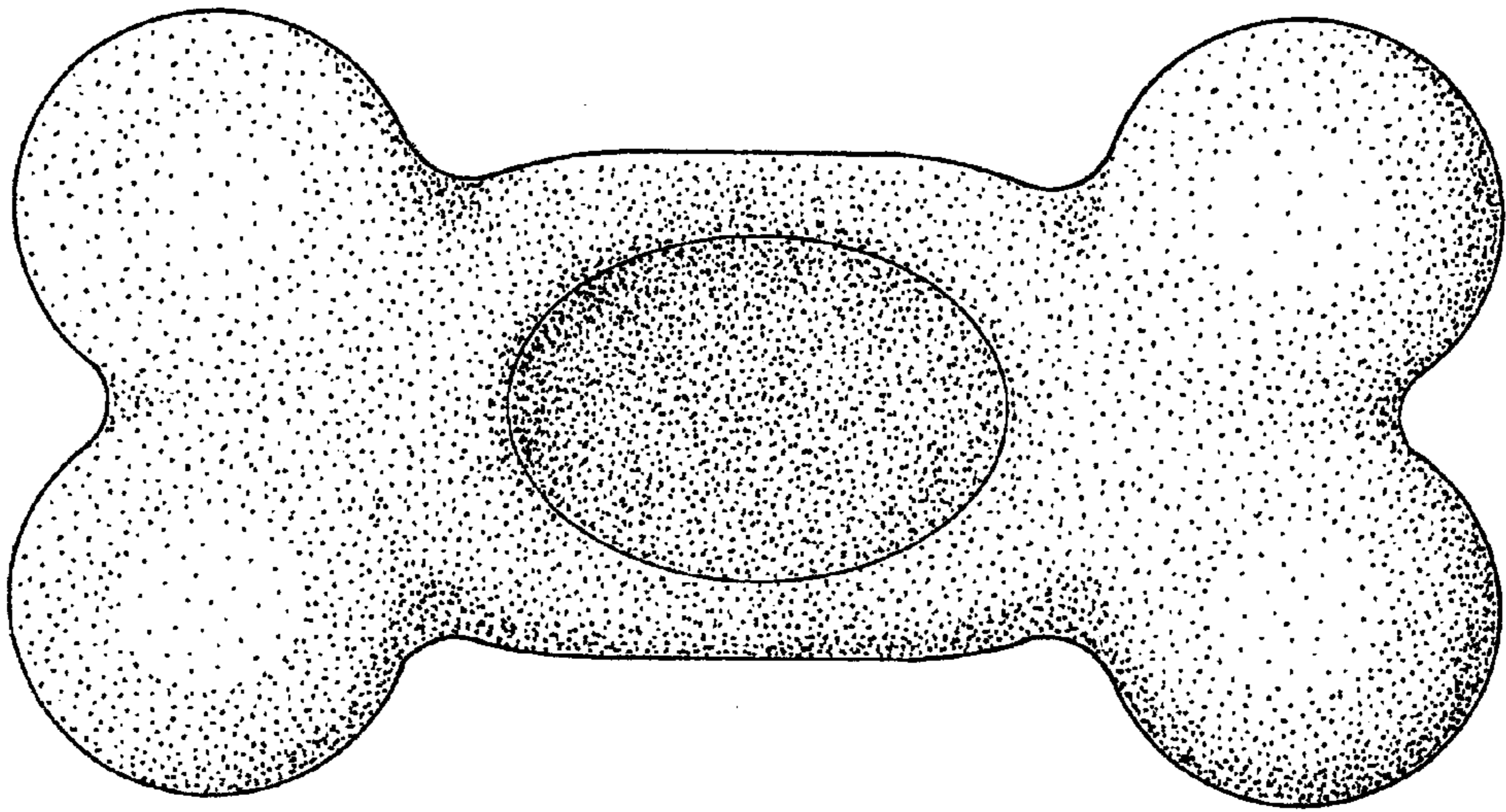

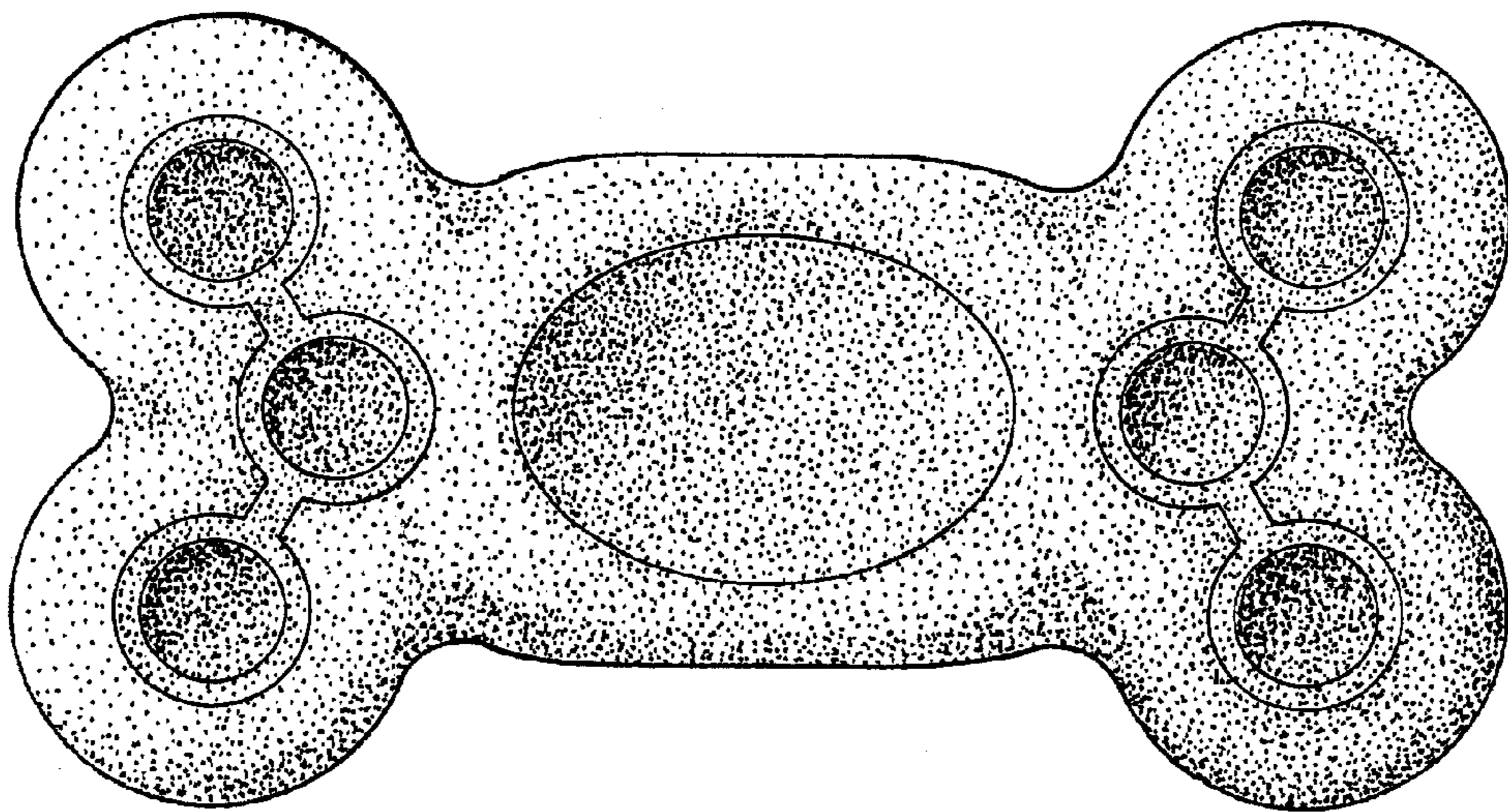

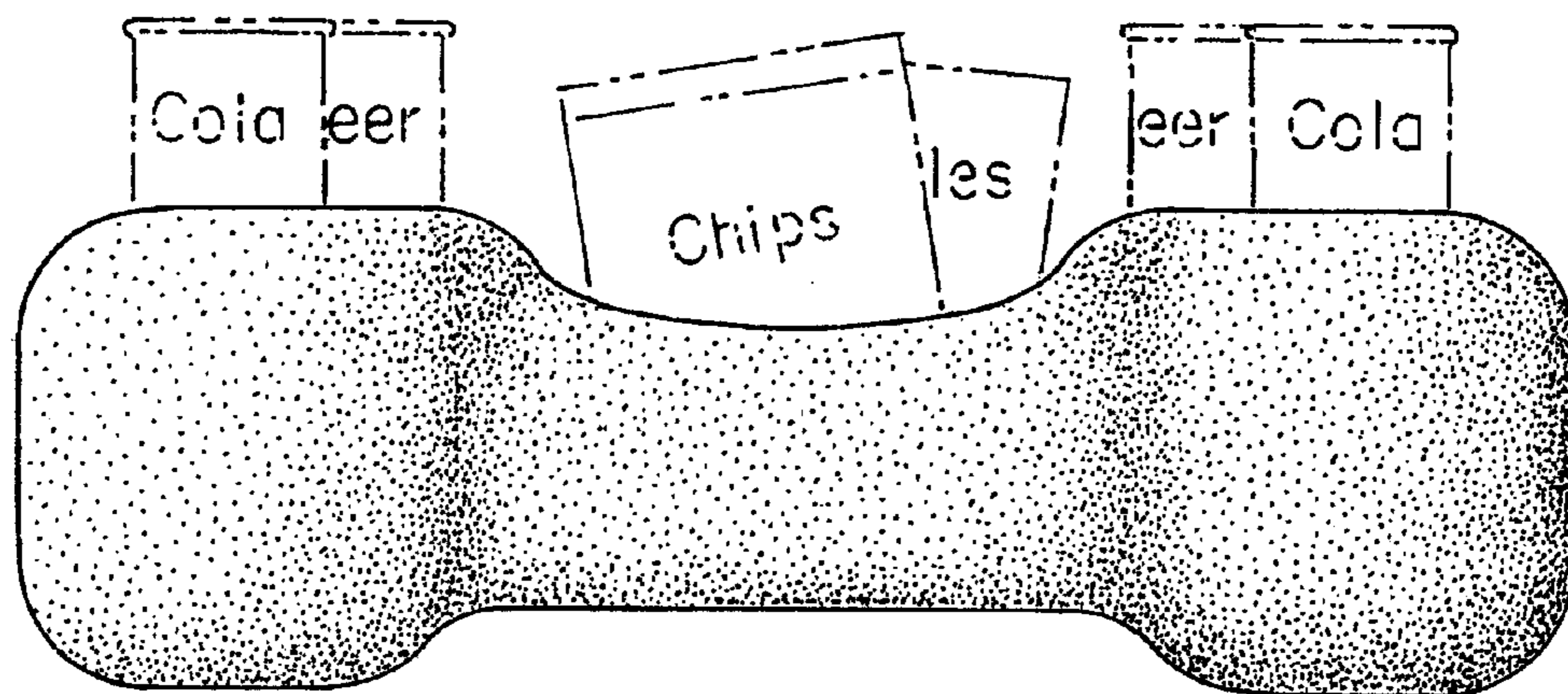

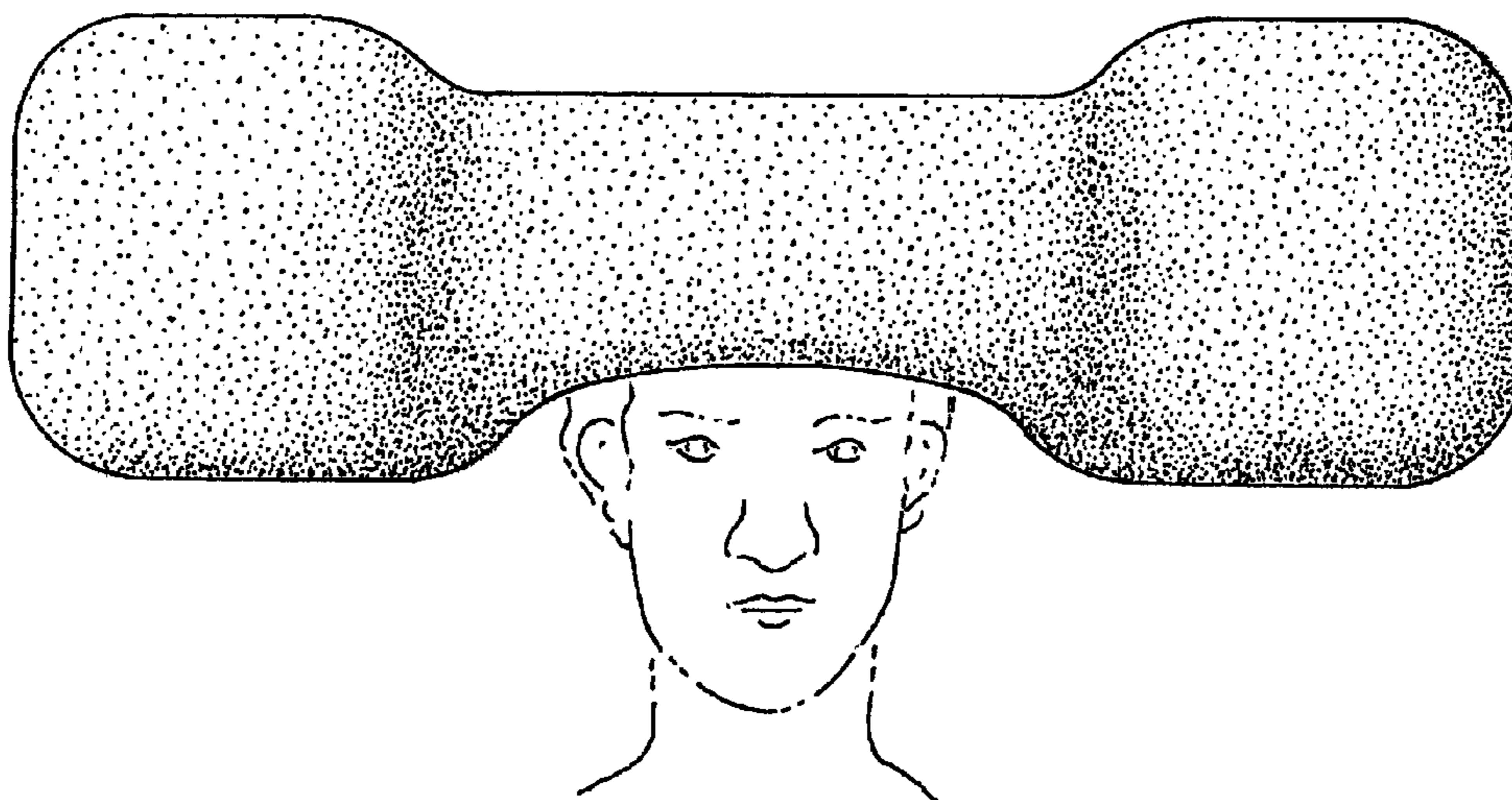
