FIG. 9 is a front elevational view of the embodiment of FIG. 4 in a modified position; and,

FIG. 10 is a rear elevational view of the embodiment of FIG. 5 in a modified position.

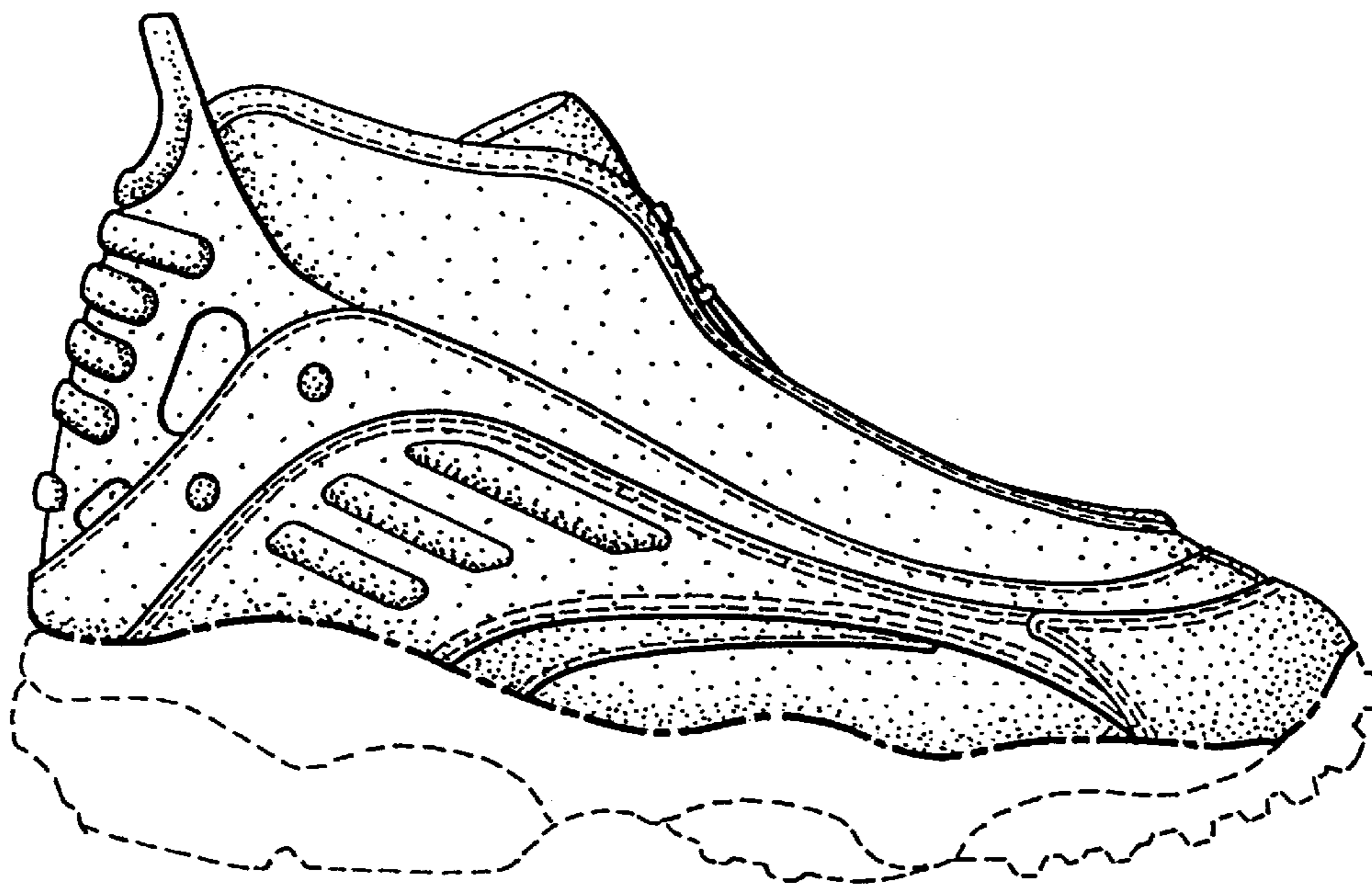

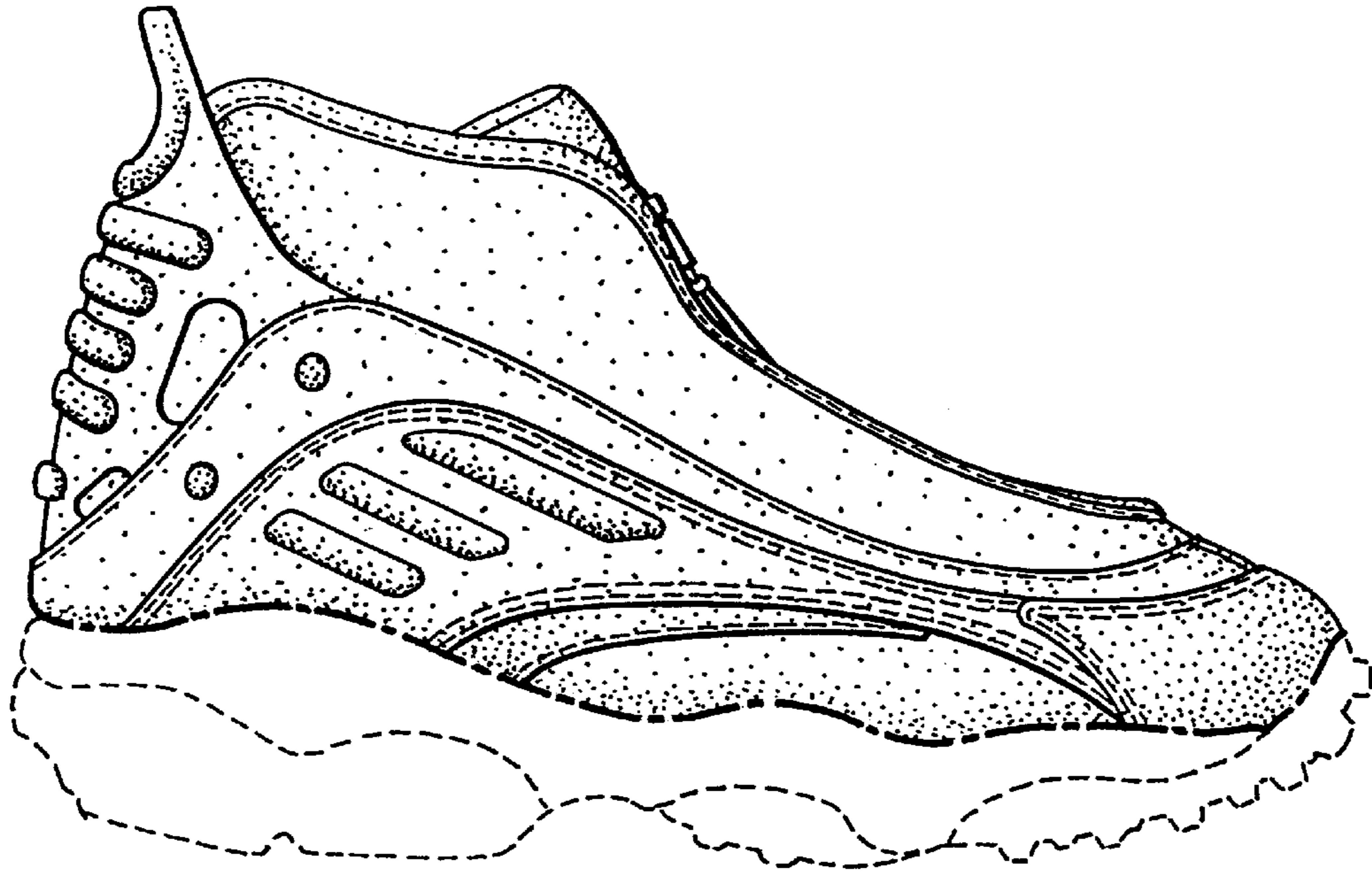

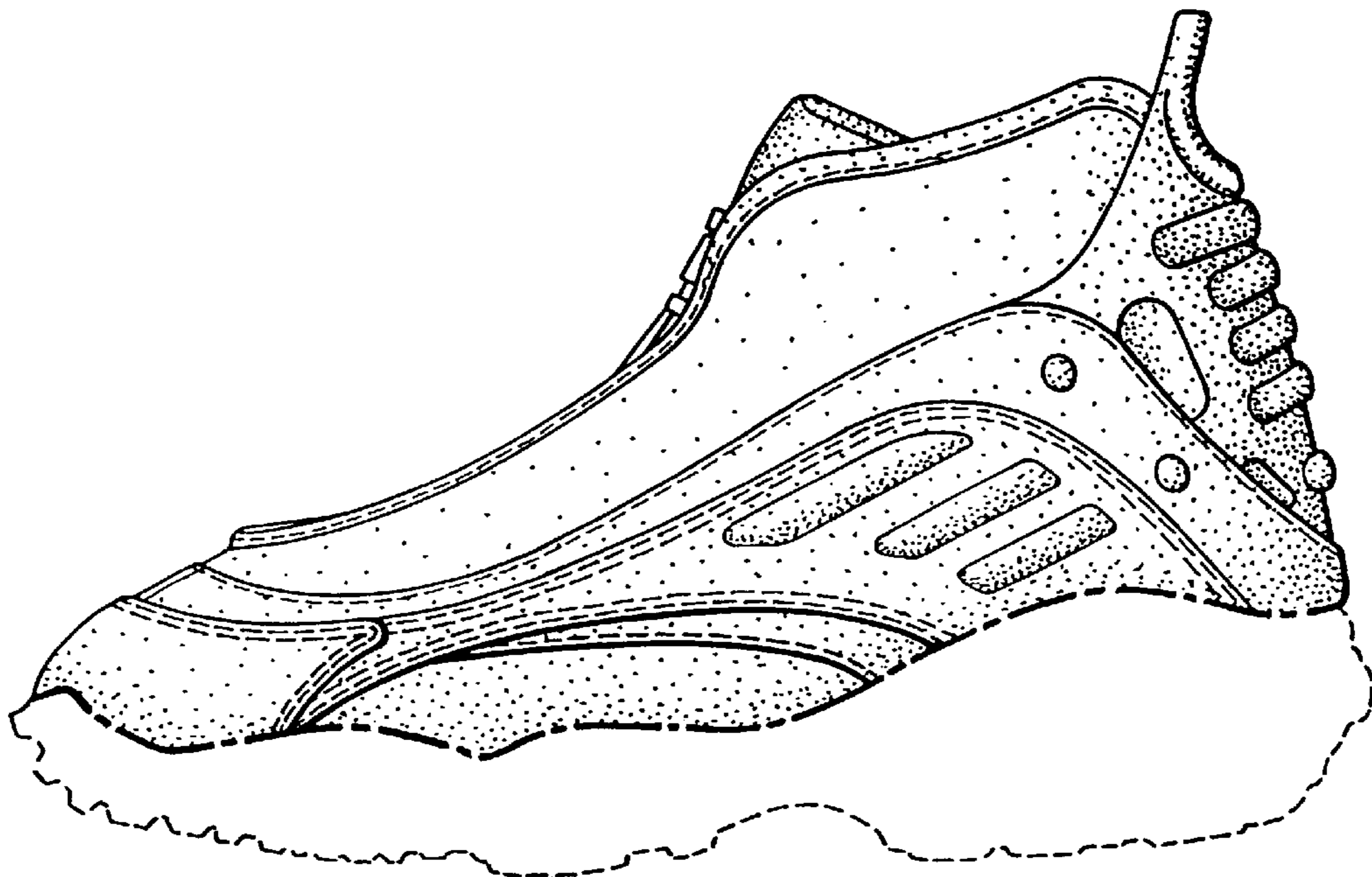

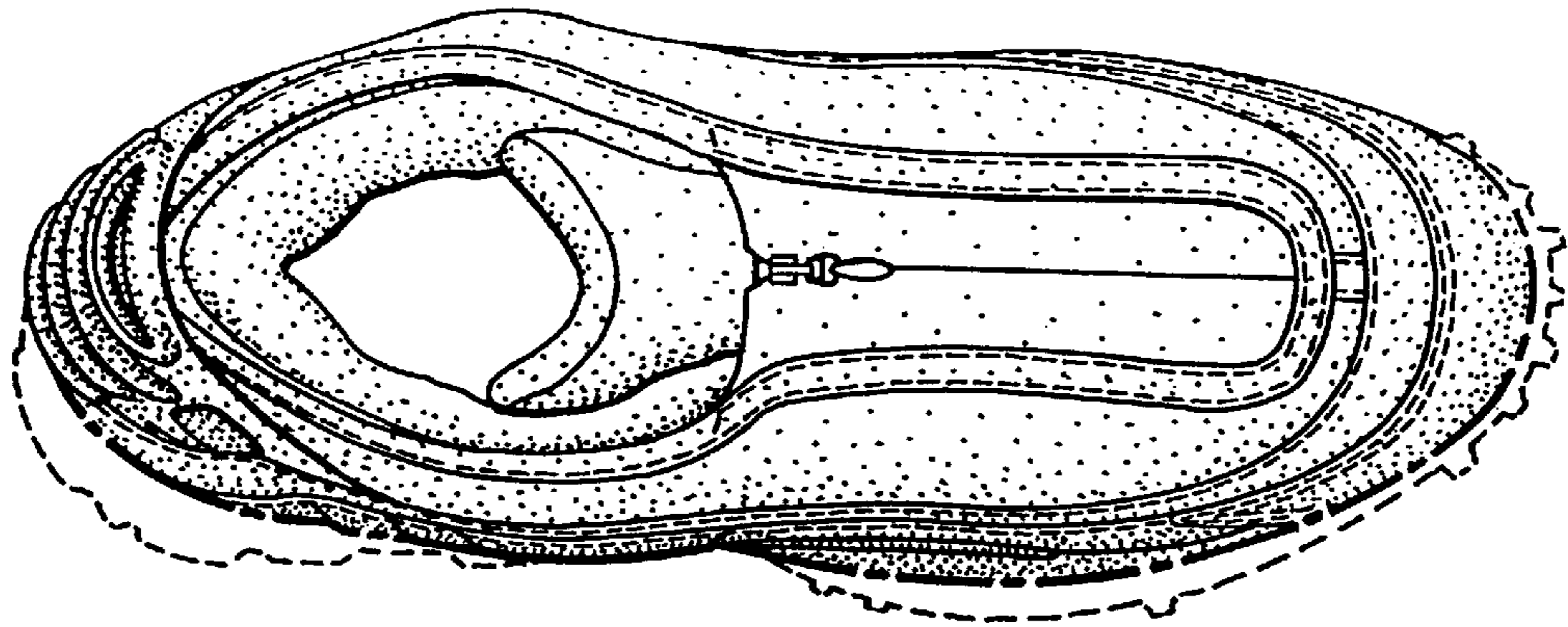

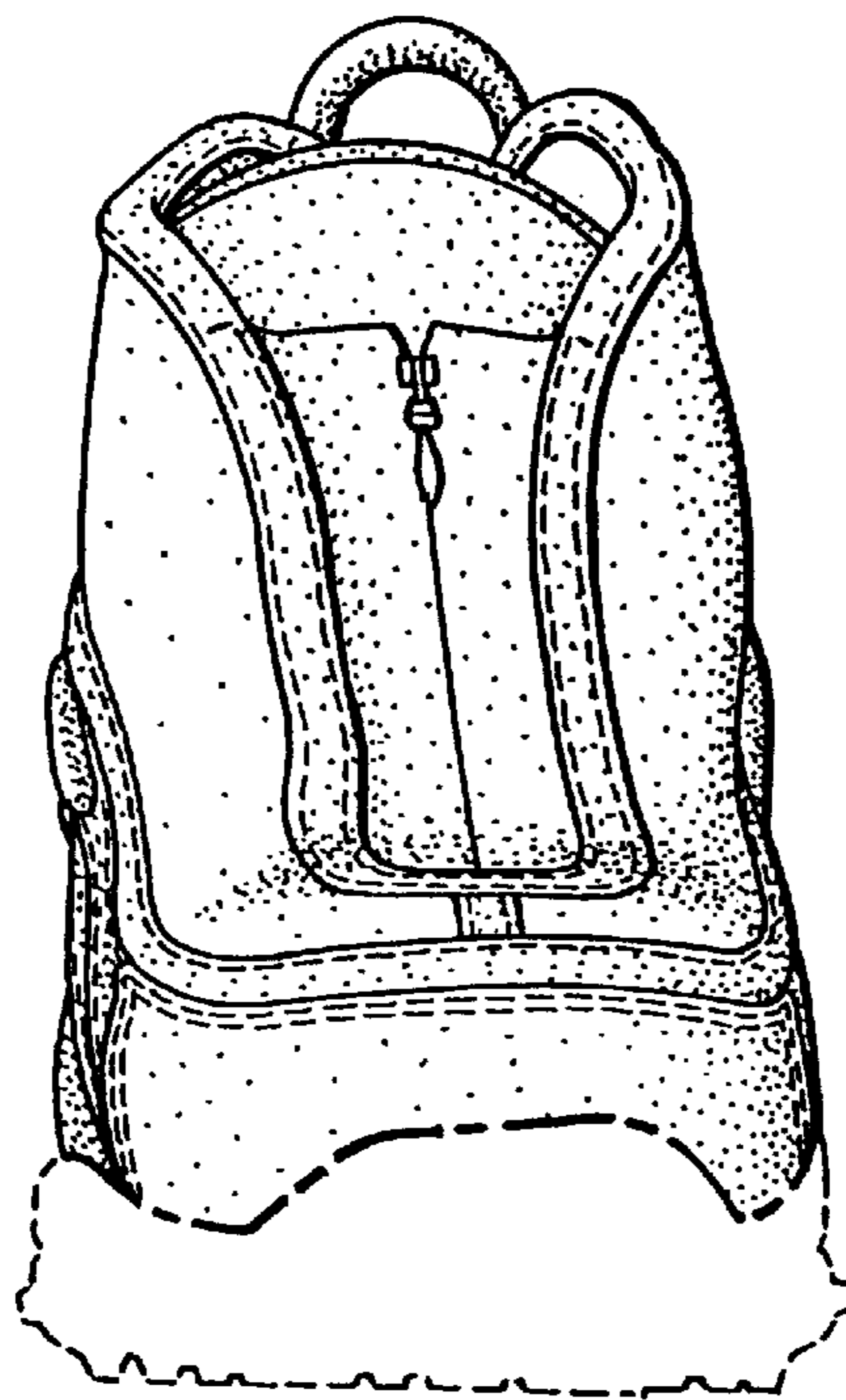

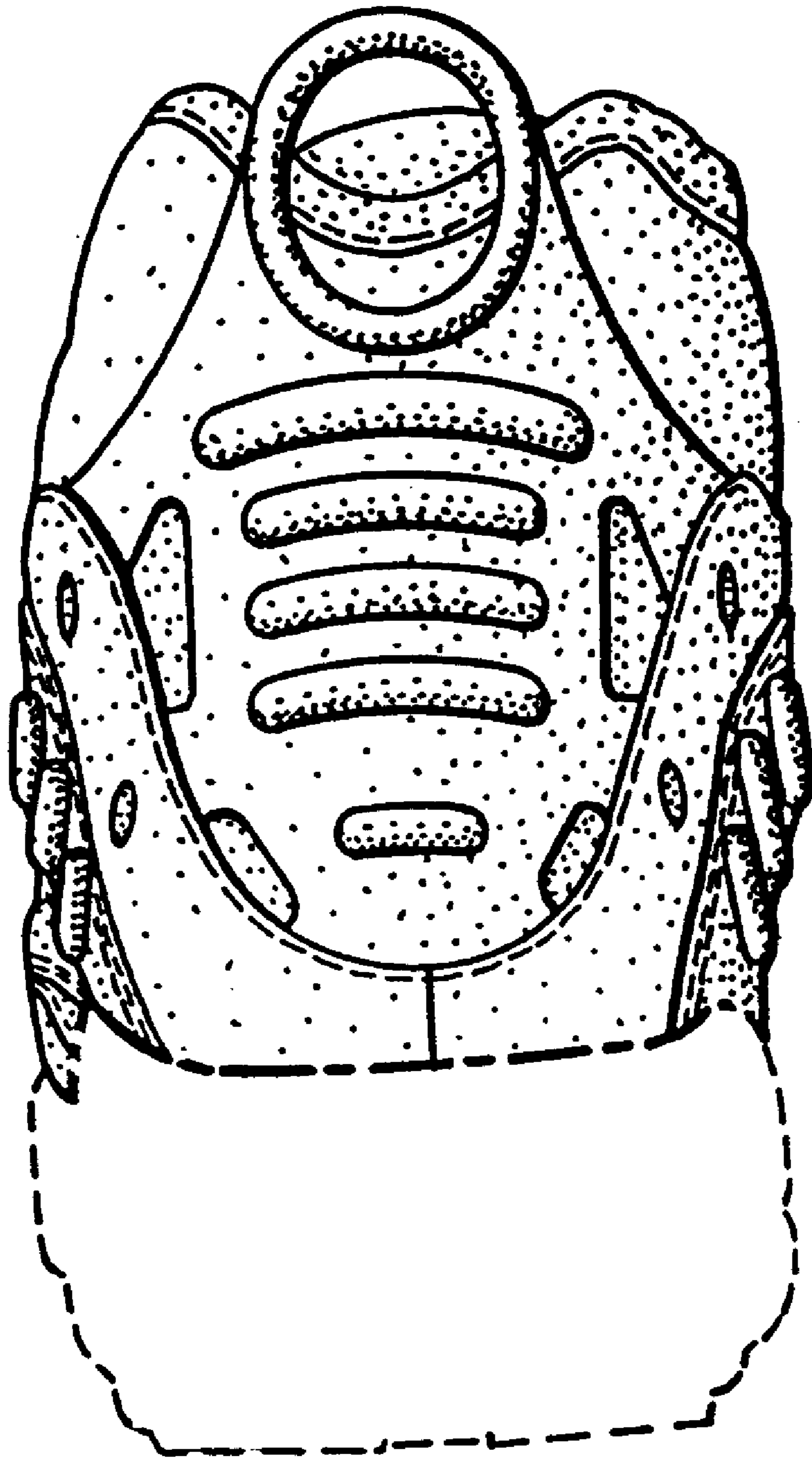

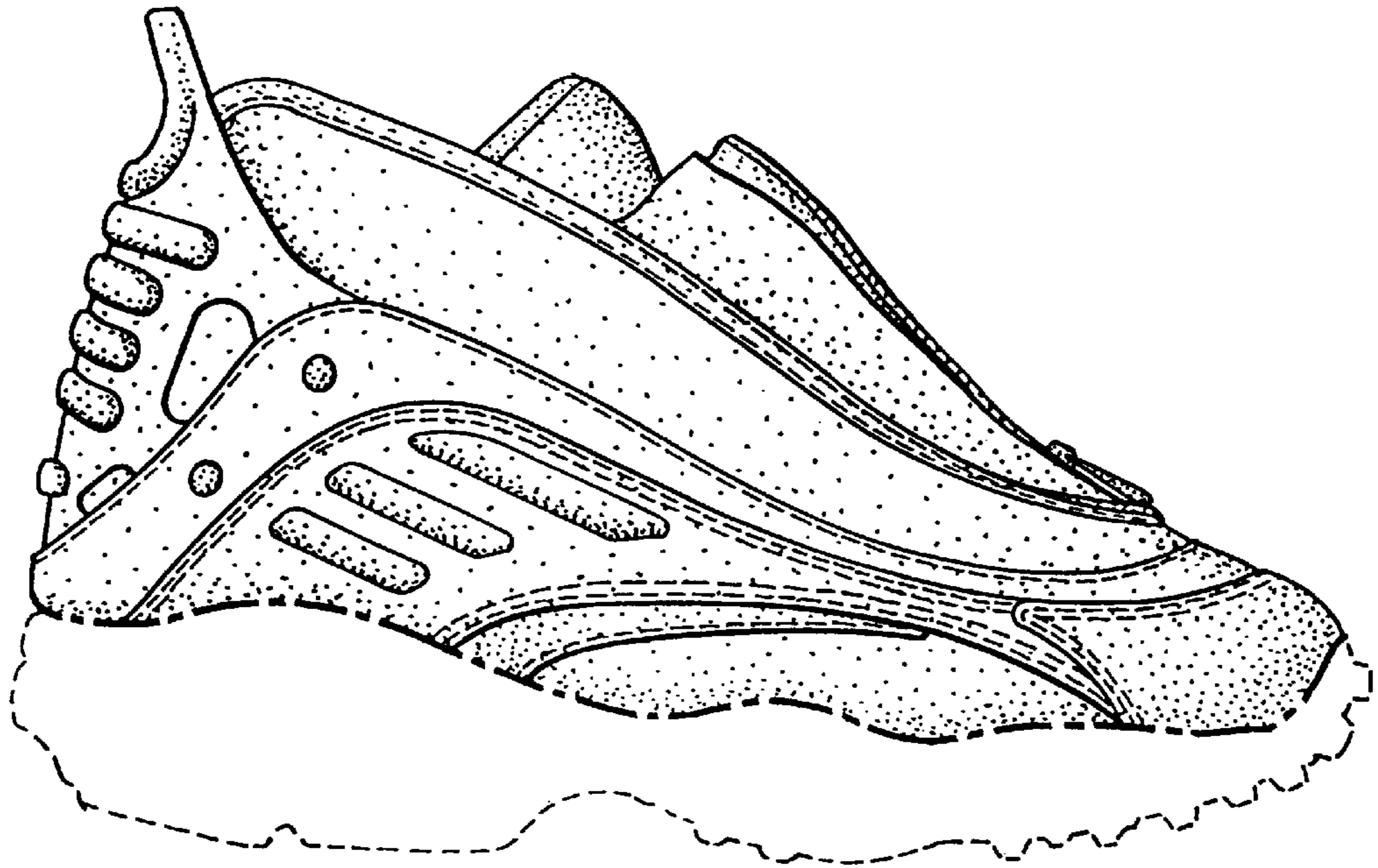

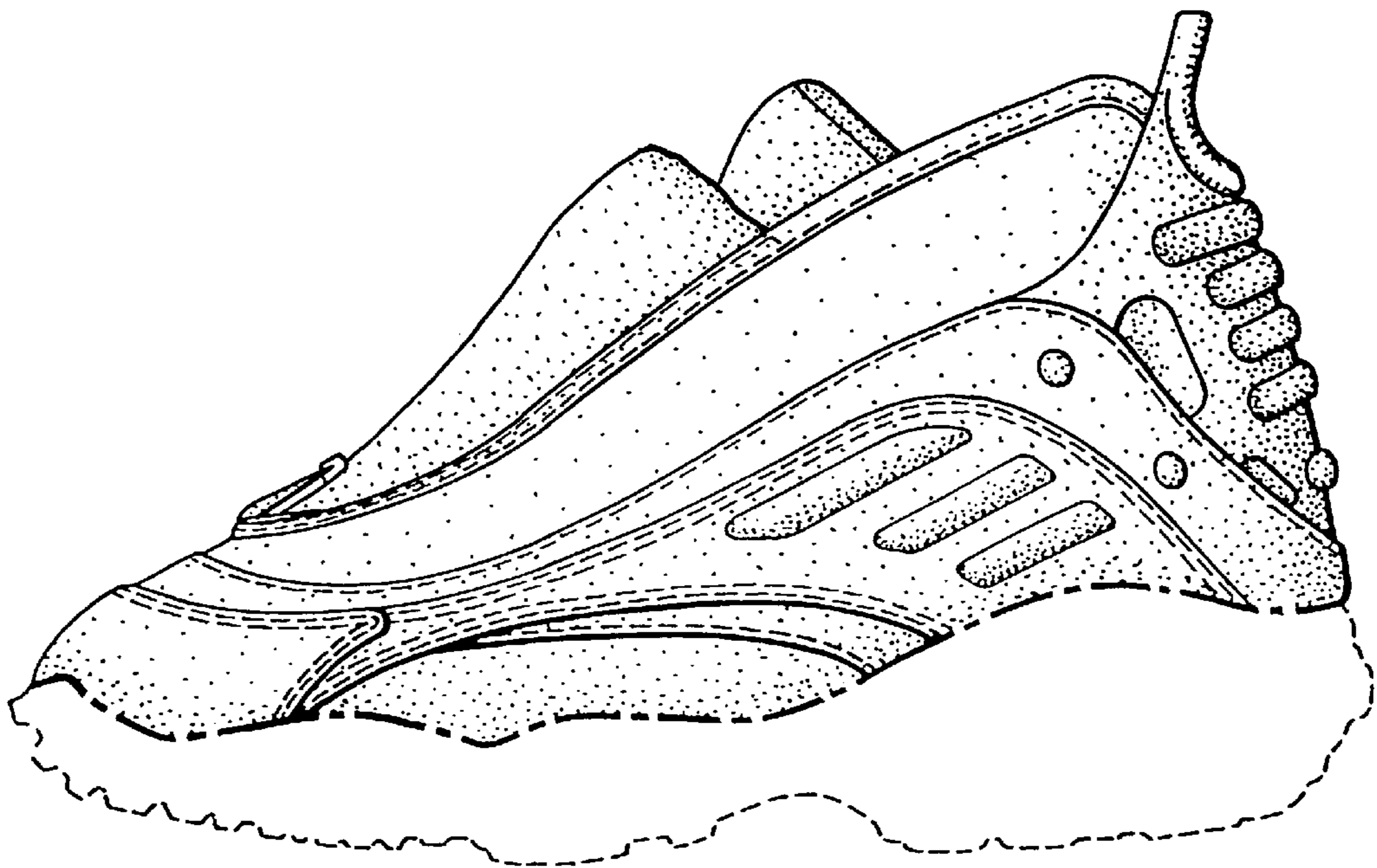

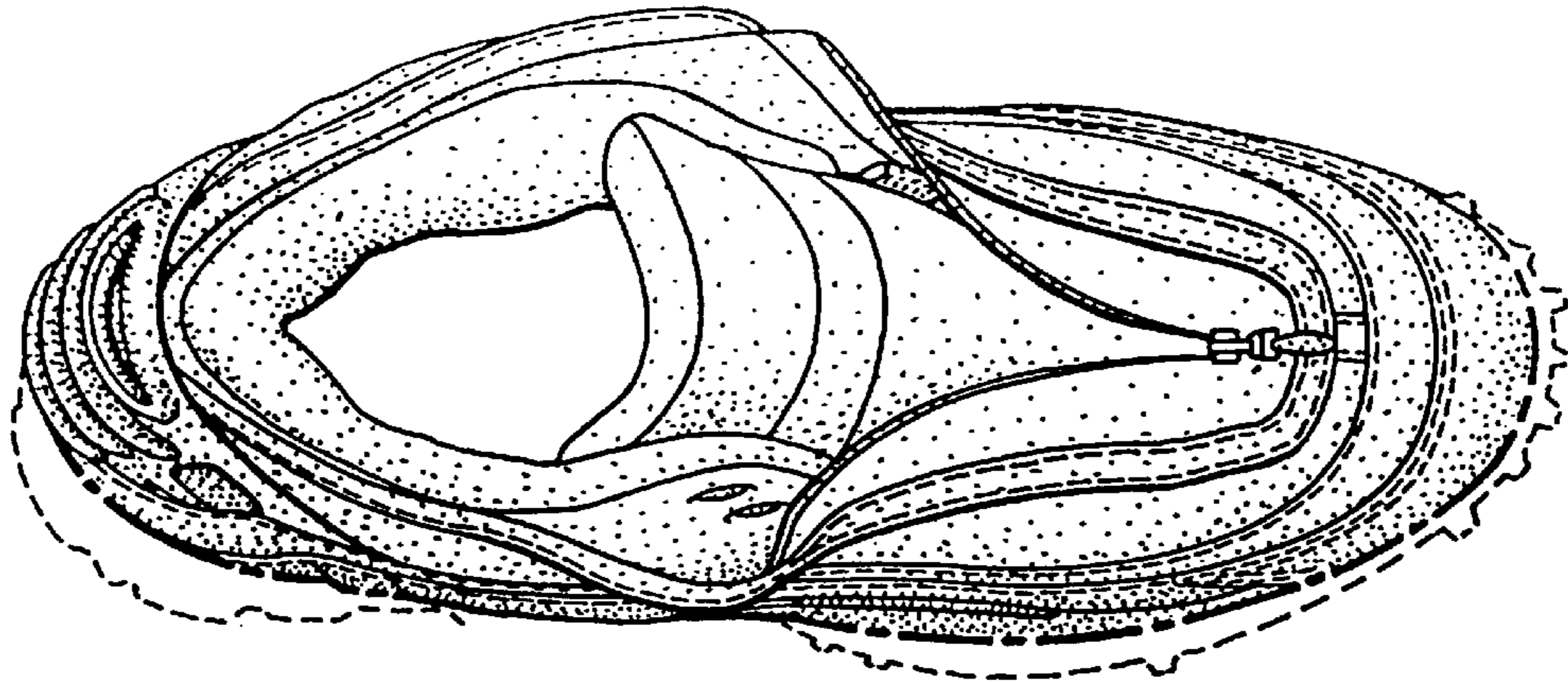

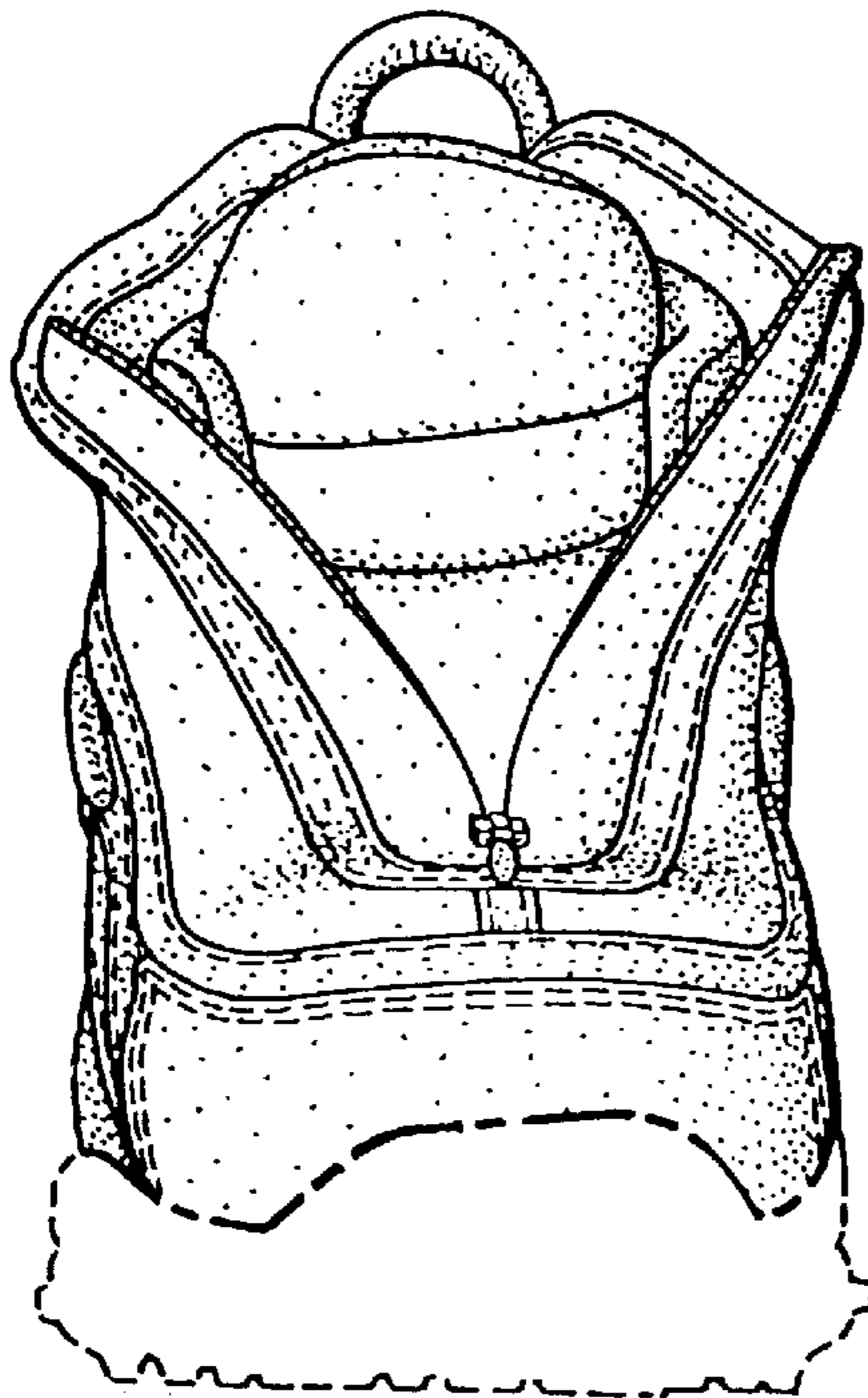

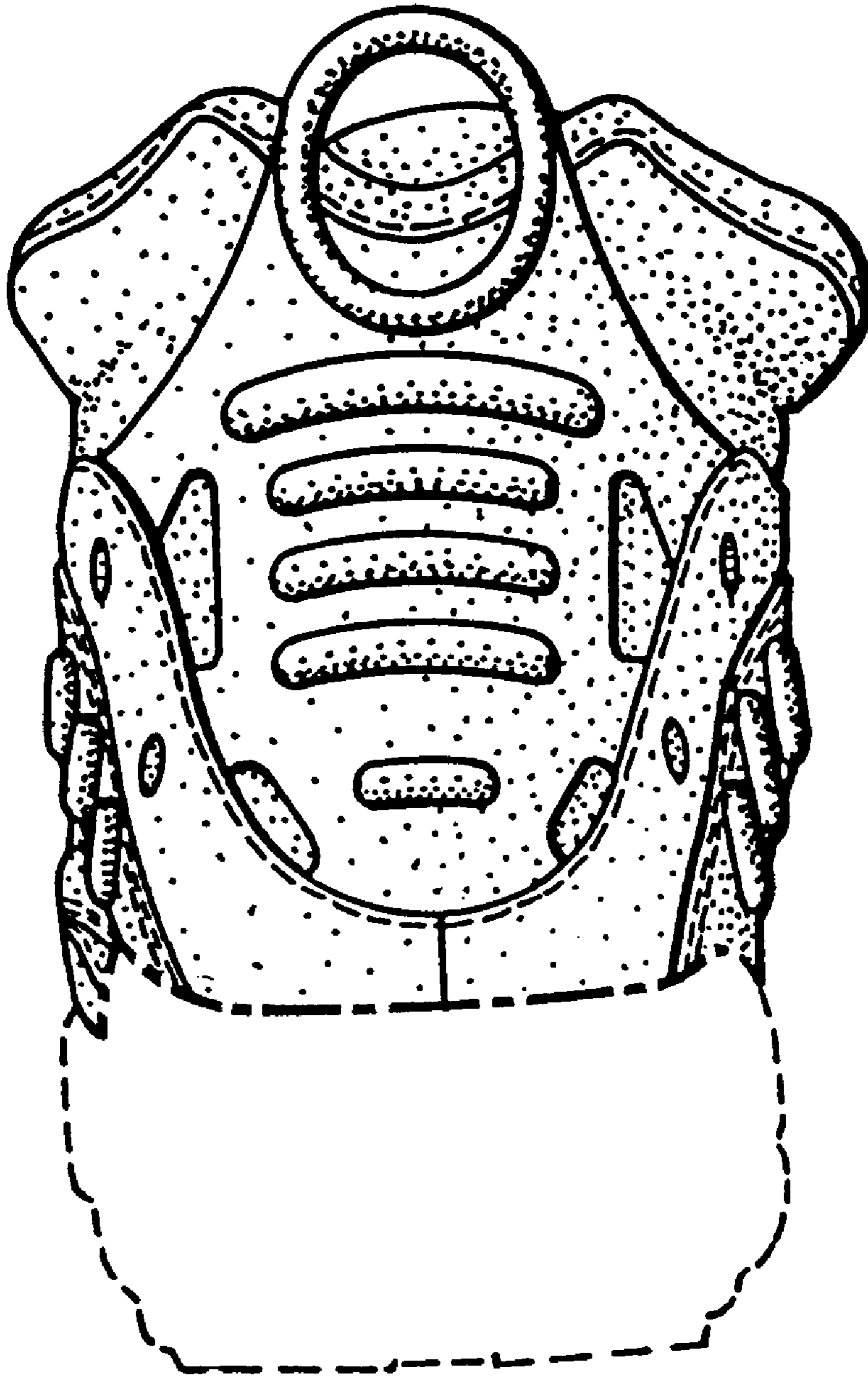
