[57] **CLAIM**

The ornamental design for a cutting tool for aiding removal of the wrapping of compact disc jewel cases, as shown.

DESCRIPTION

FIG. 1 is a perspective view of my design for a cutting tool for aiding removal of the wrapping of compact disc jewel cases showing my new design;

FIG. 2 is a left side elevational view of the design shown in FIG. 1;

FIG. 3 is a right side elevational view of the design shown in FIG. 1;

FIG. 4 is a front end elevational view of the design of FIG. 1;

FIG. 5 is a top plan view of the design of FIG. 1;

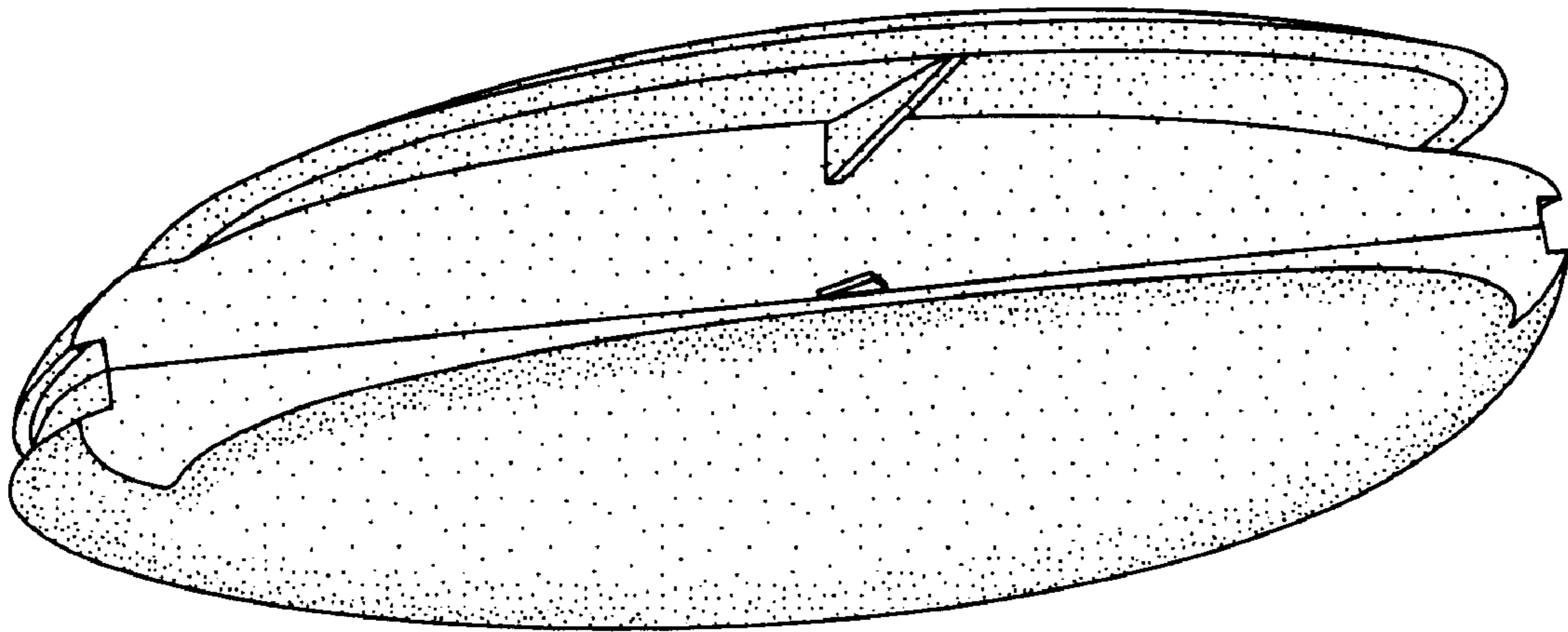
FIG. 6 is a left side elevational view of the design of FIG. 1, wherein the broken line showing of the jewel case is for illustrative purposes only and forms no part of the claimed design;

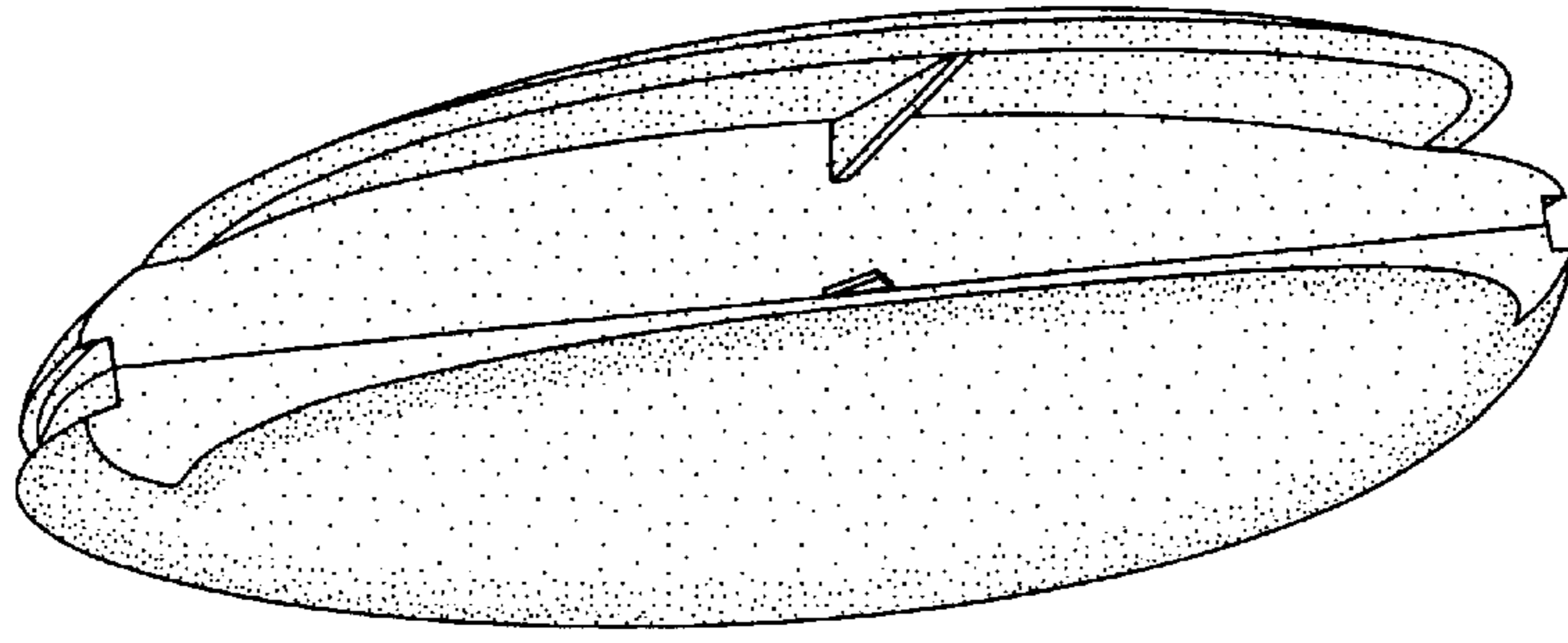

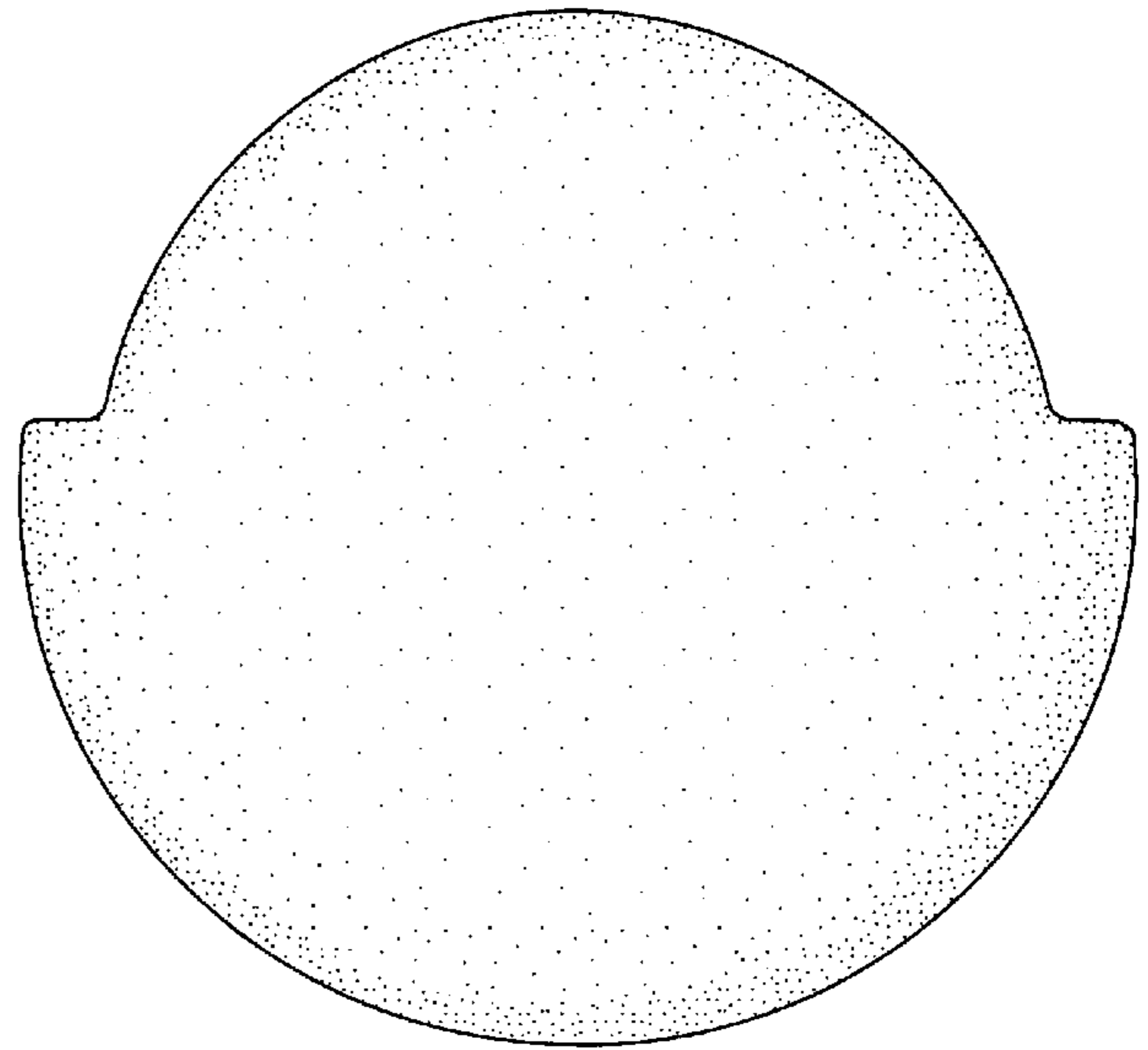

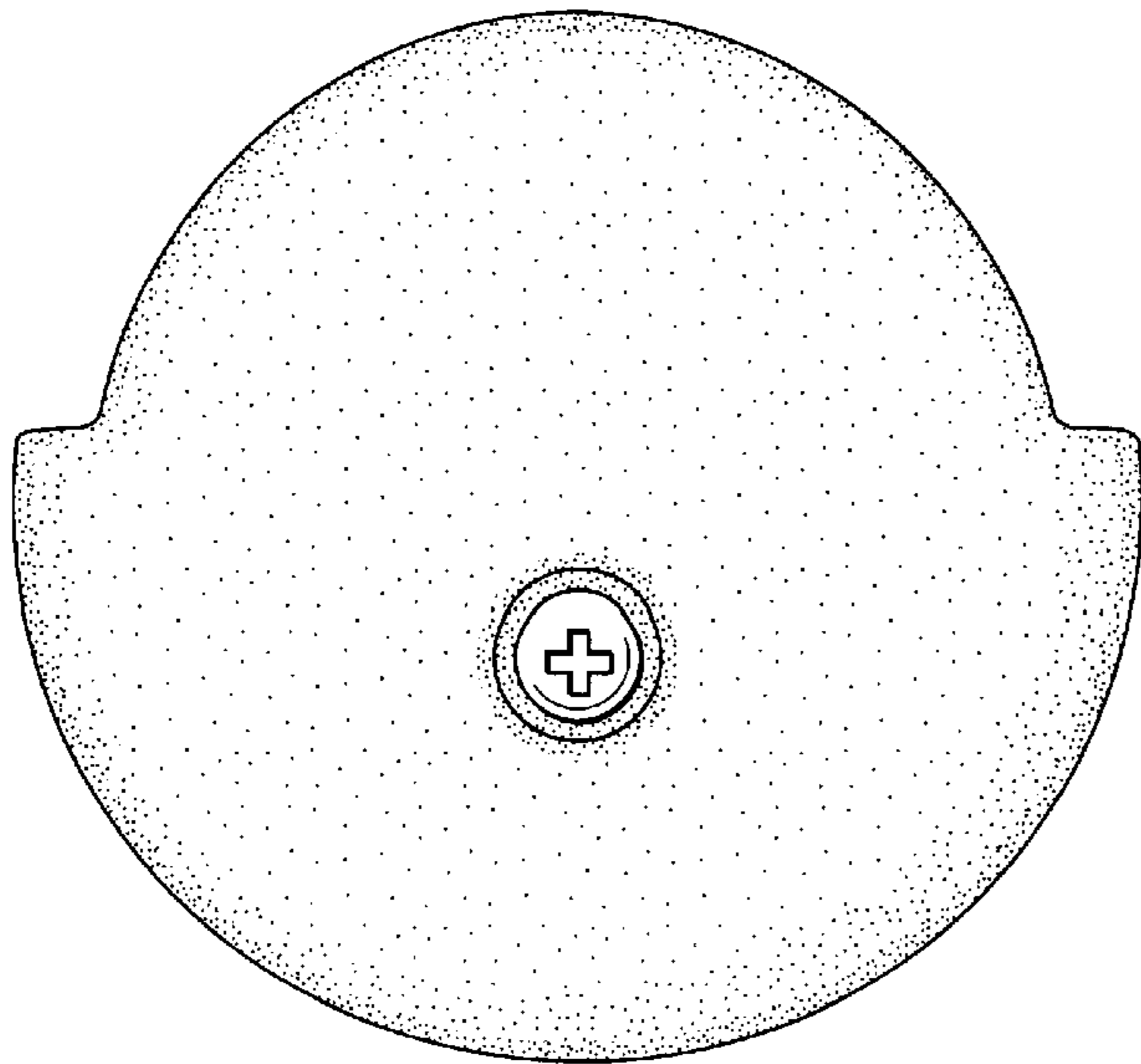

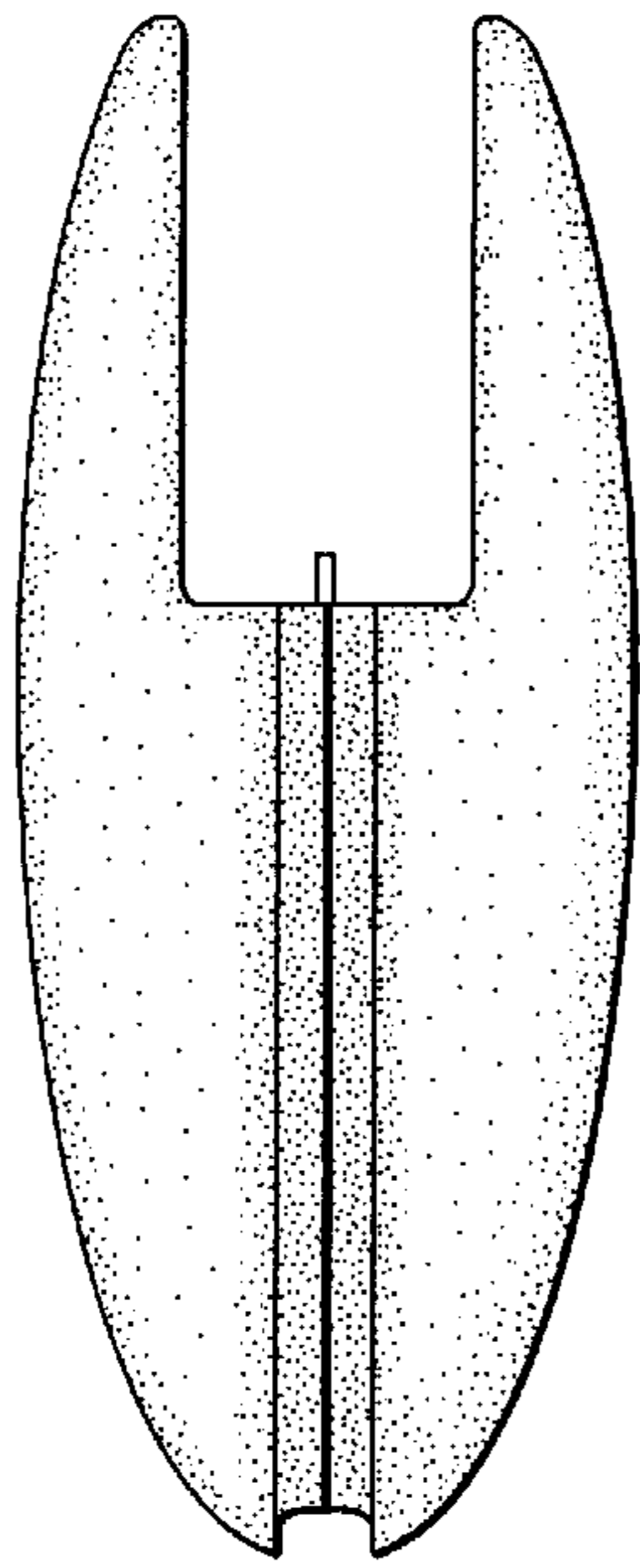

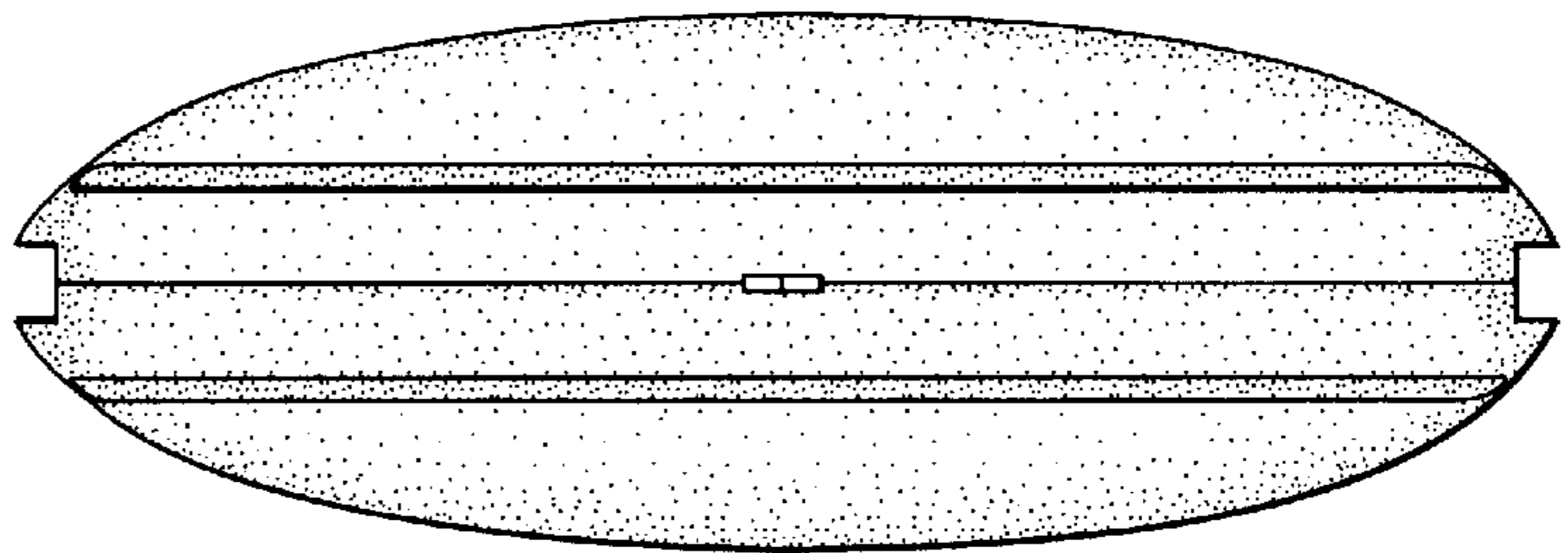

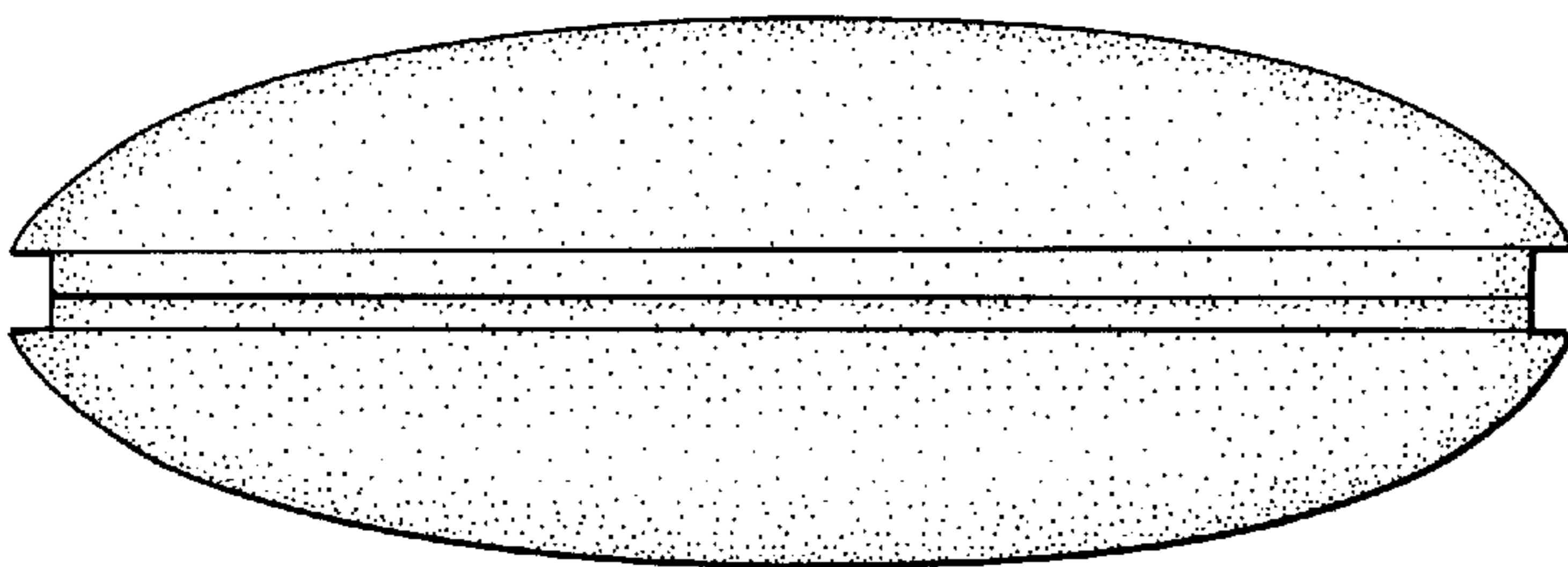

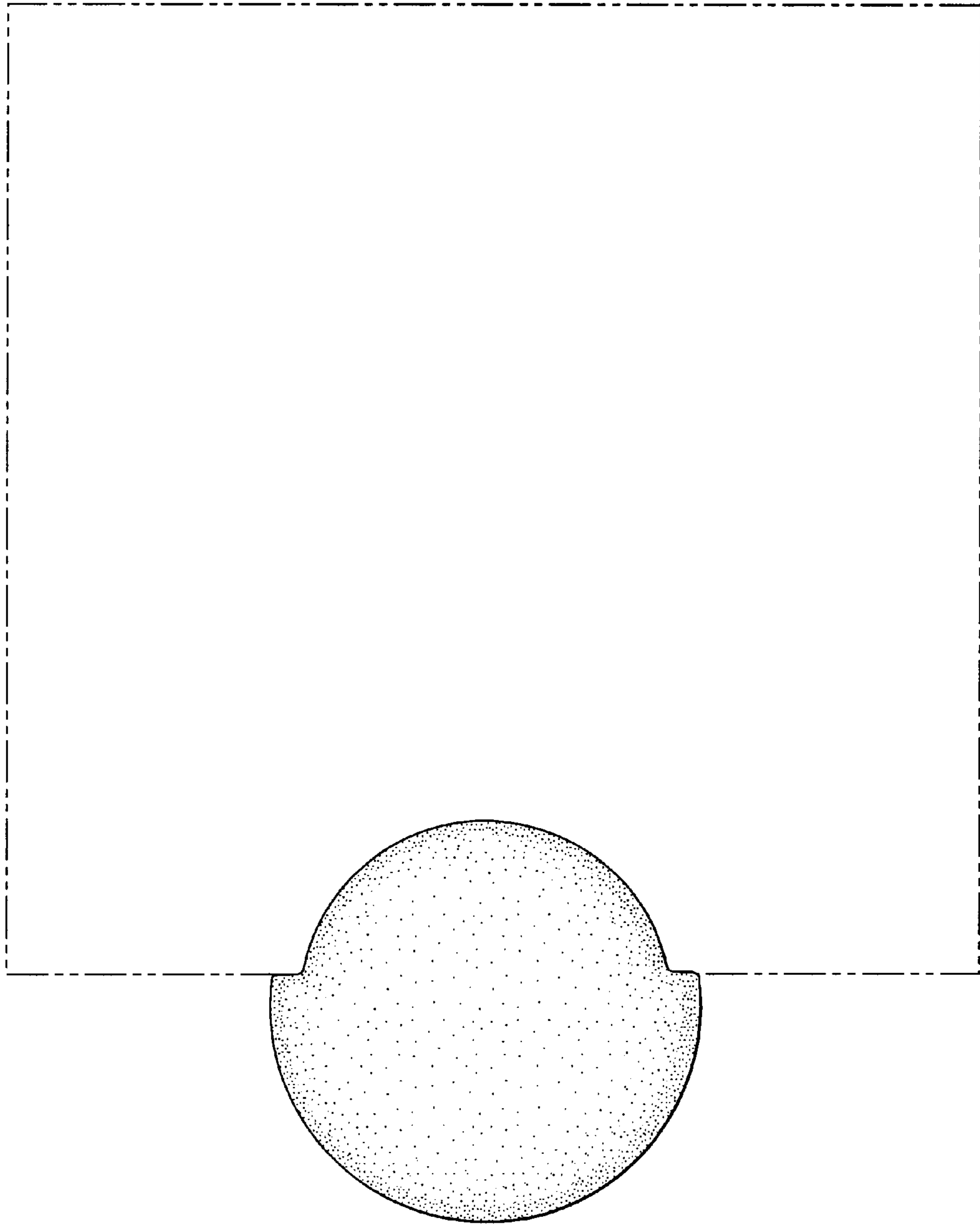

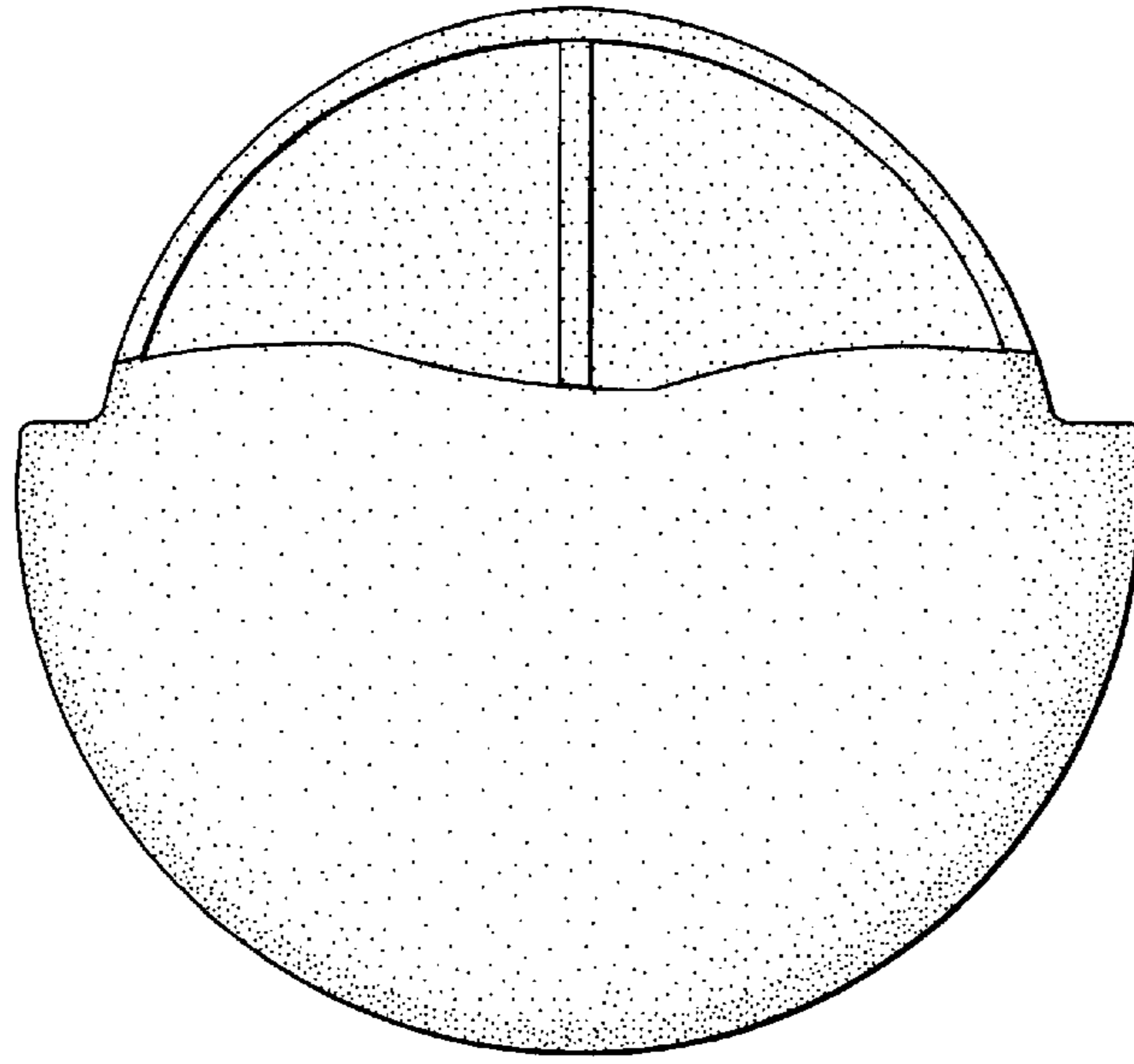

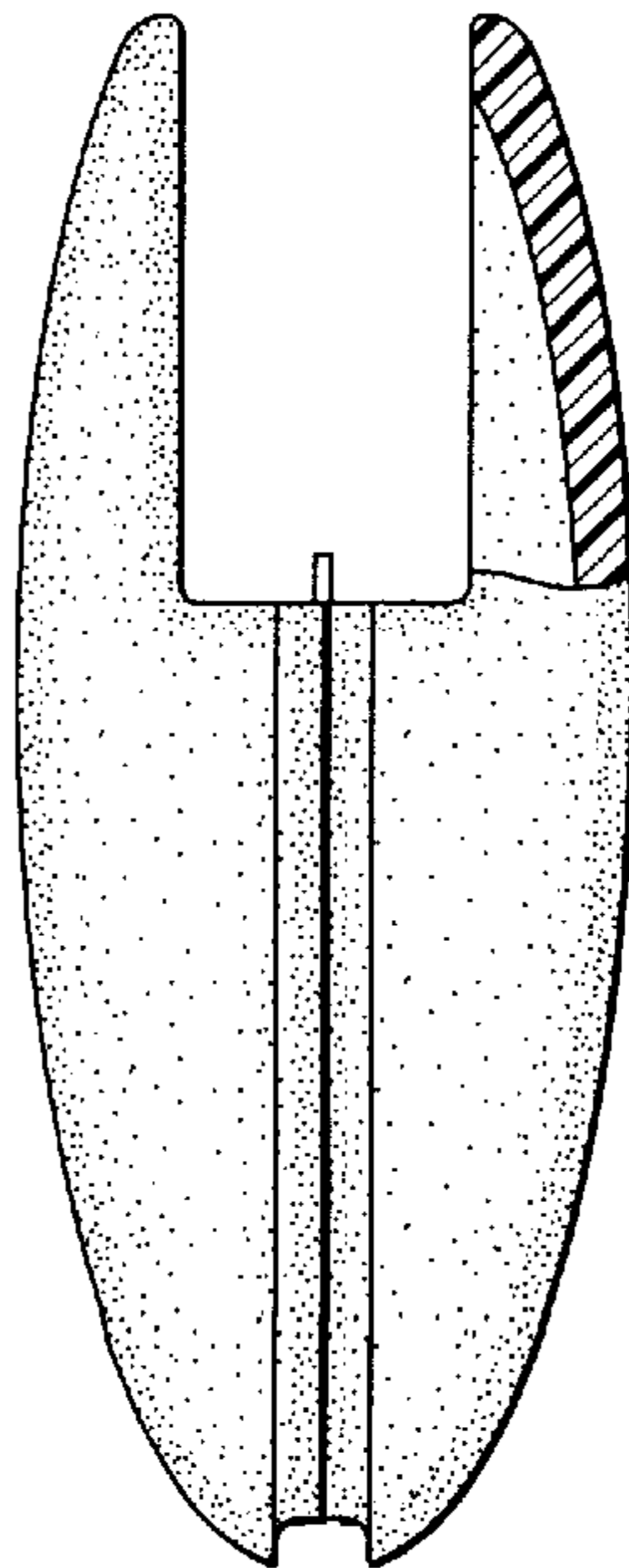
