[57] CLAIM

The ornamental design for a tube with hinged cover, as shown and described.

DESCRIPTION

FIG. 1 is a side, perspective view of a tube with hinged cover in accordance with the present invention, with the hinged cover in a closed configuration;

FIG. 2 is a side, perspective view of the tube with hinged cover shown in FIG. 1, shown from the opposite side compared with FIG. 1;

FIG. 3 is a side, perspective view of the tube with hinged cover shown in FIG. 1, with the hinged cover in an open configuration;

FIG. 4 is a front side, perspective view of the hinged cover used in the tube with hinged cover shown in FIG. 1;

FIG. 5 is a rear side, perspective view of the hinged cover of FIG. 4, shown without the tube for clarity of illustration;

FIG. 6 is a front side, perspective view of the hinged cover of FIG. 4, shown without the tube for clarity of illustration and shown with the hinged cover in an open configuration;

FIG. 7 is a bottom side, perspective view of the hinged cover shown in FIG. 4, with the hinged cover in an open configuration; and,

FIG. 8 is a top, elevational view of the hinged cover shown in FIG. 4.

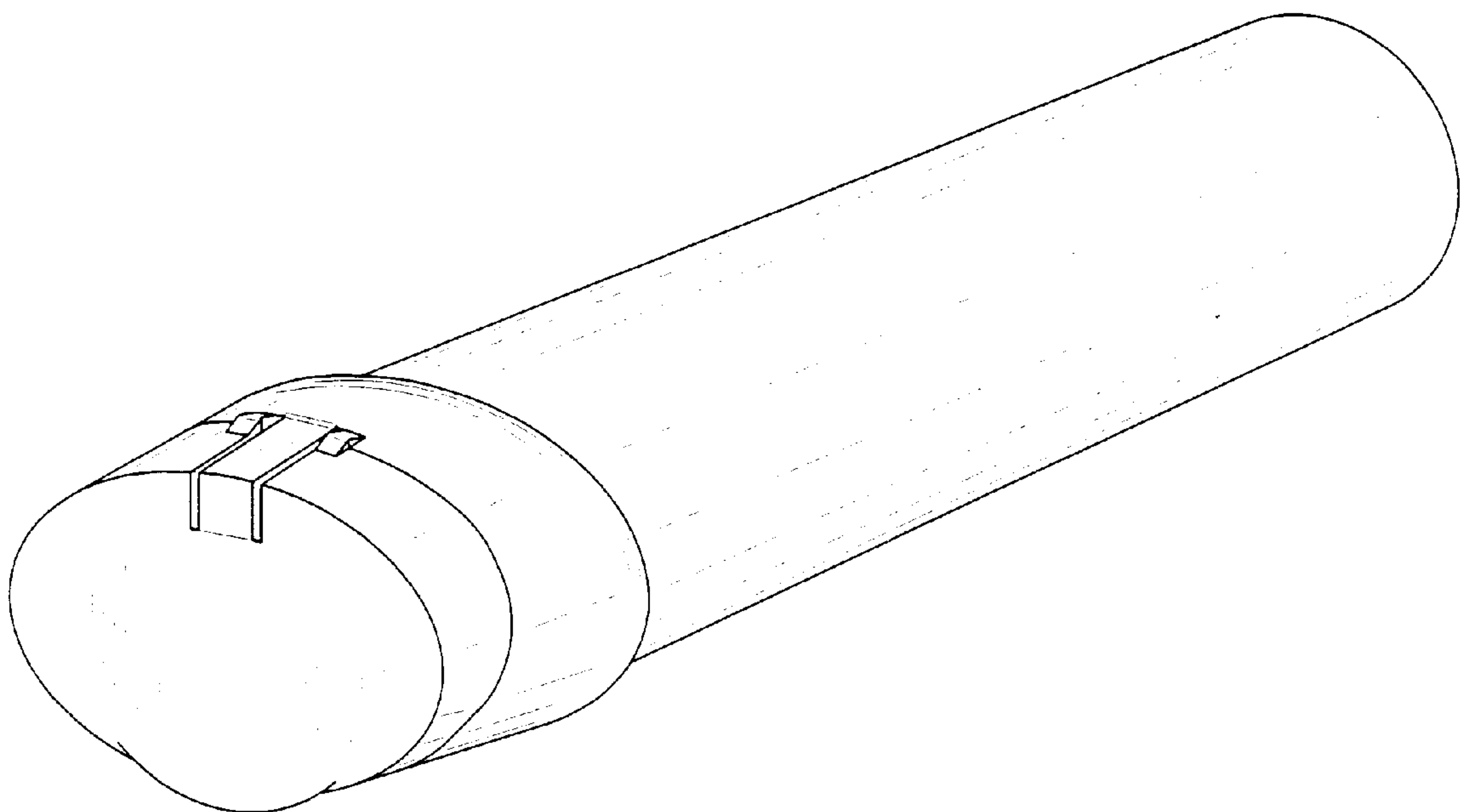

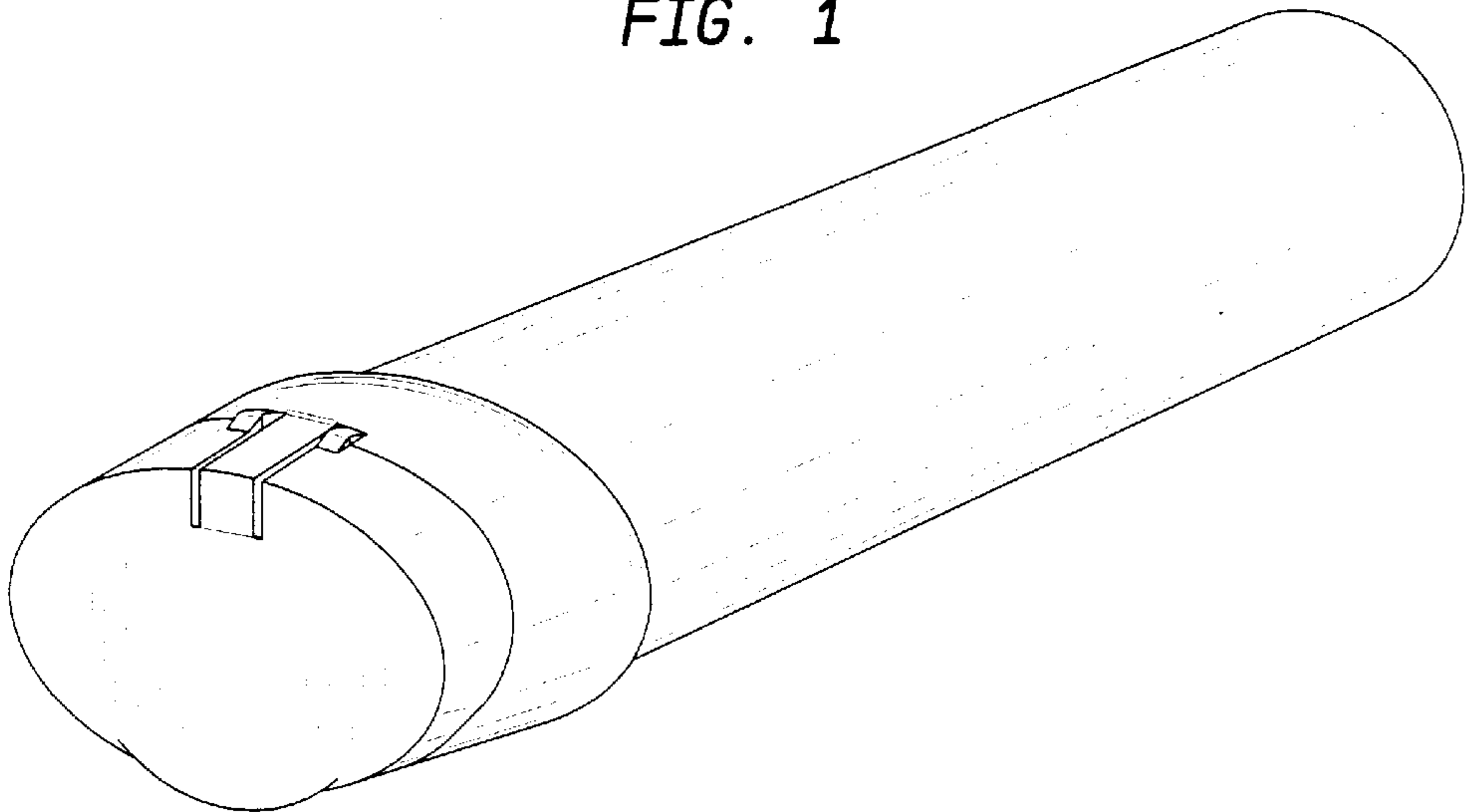

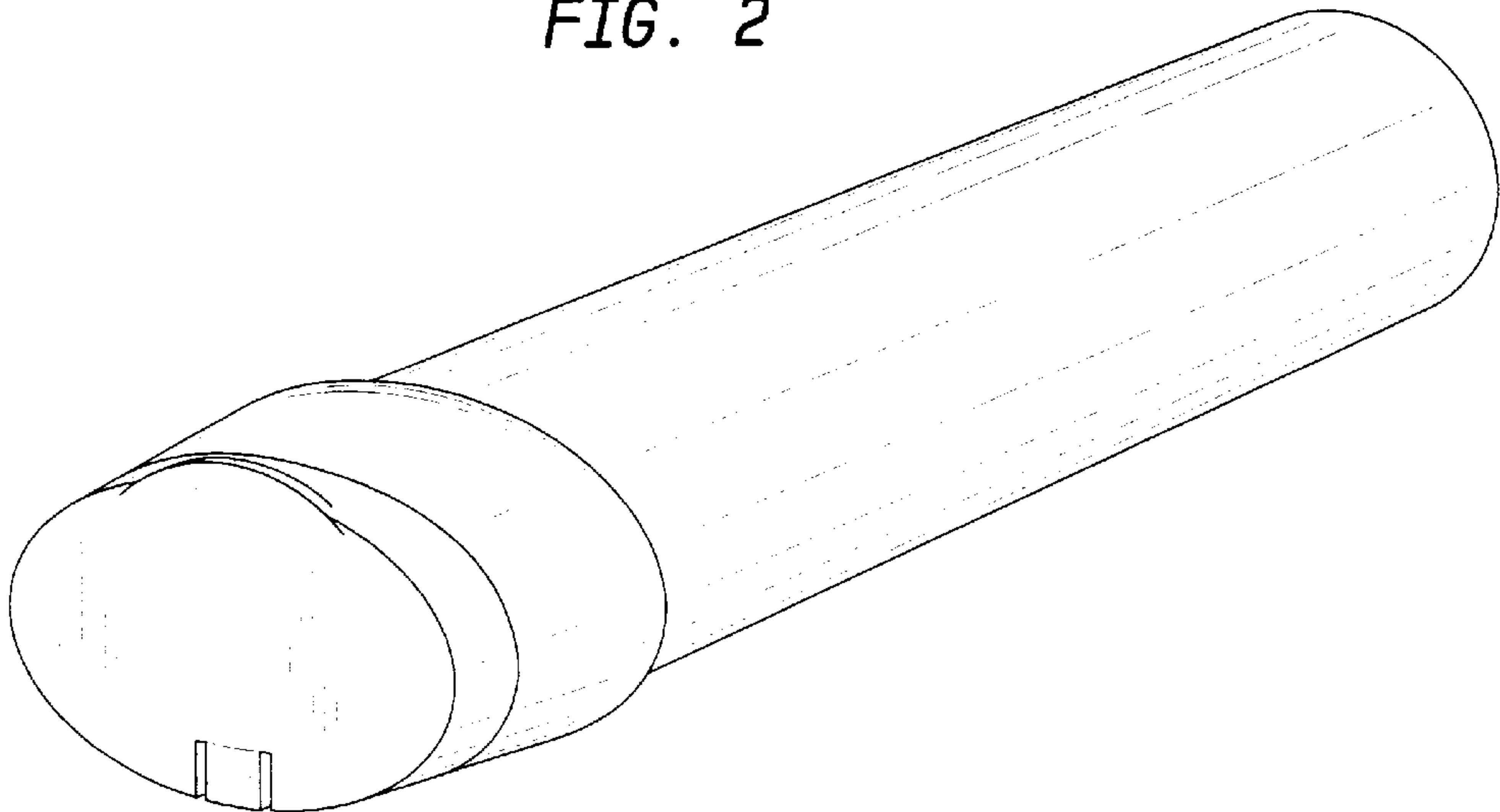

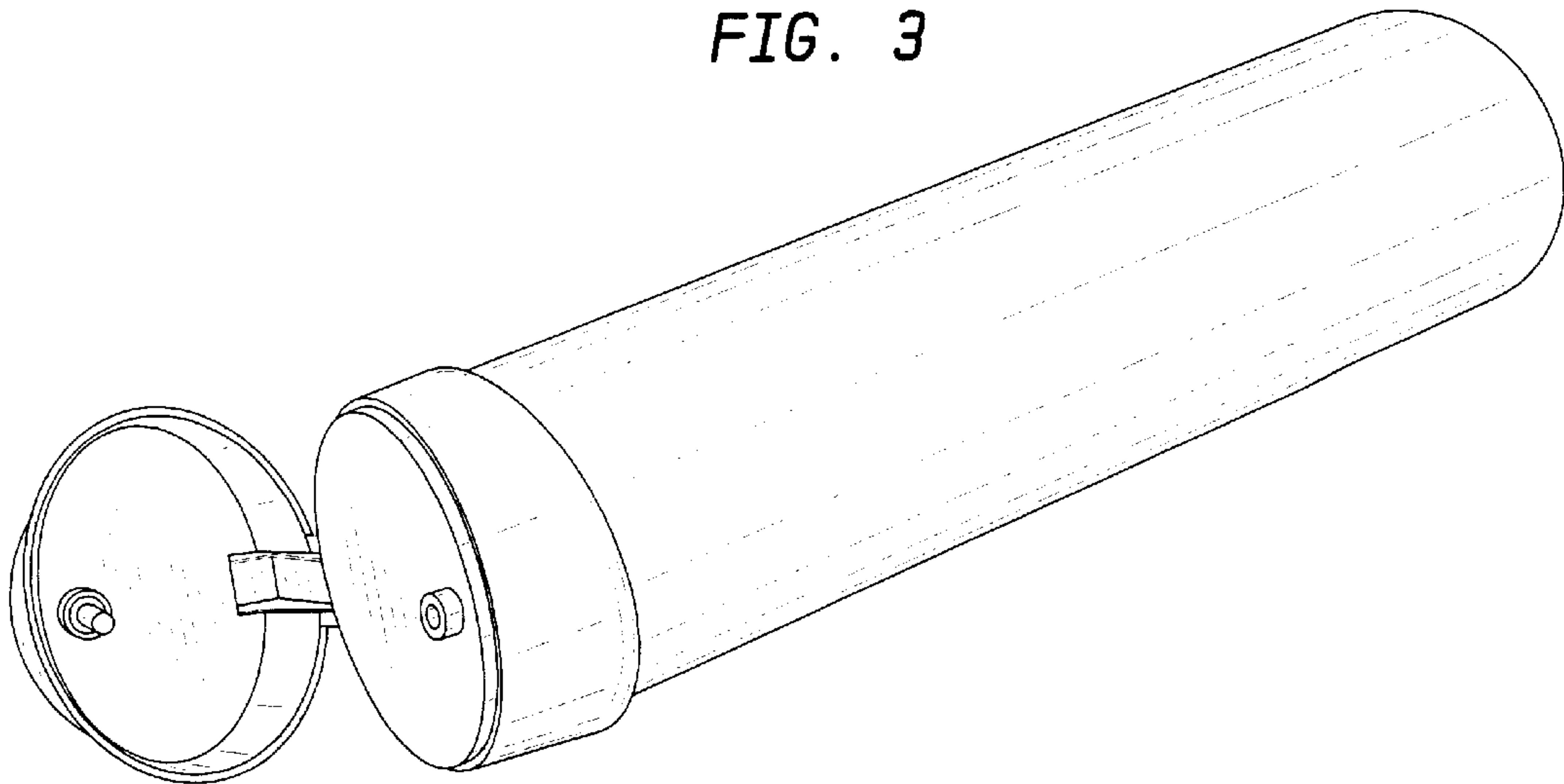

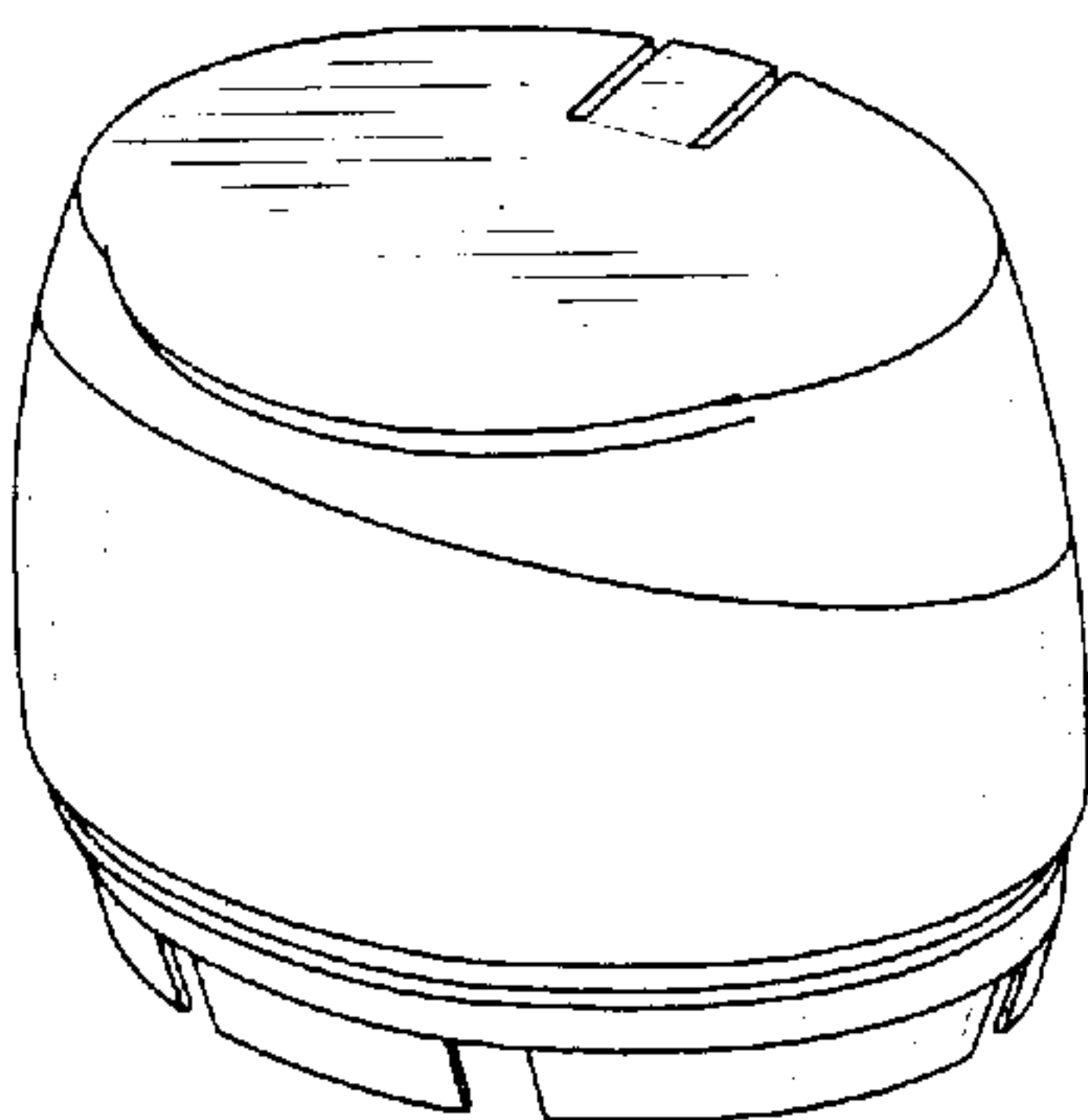

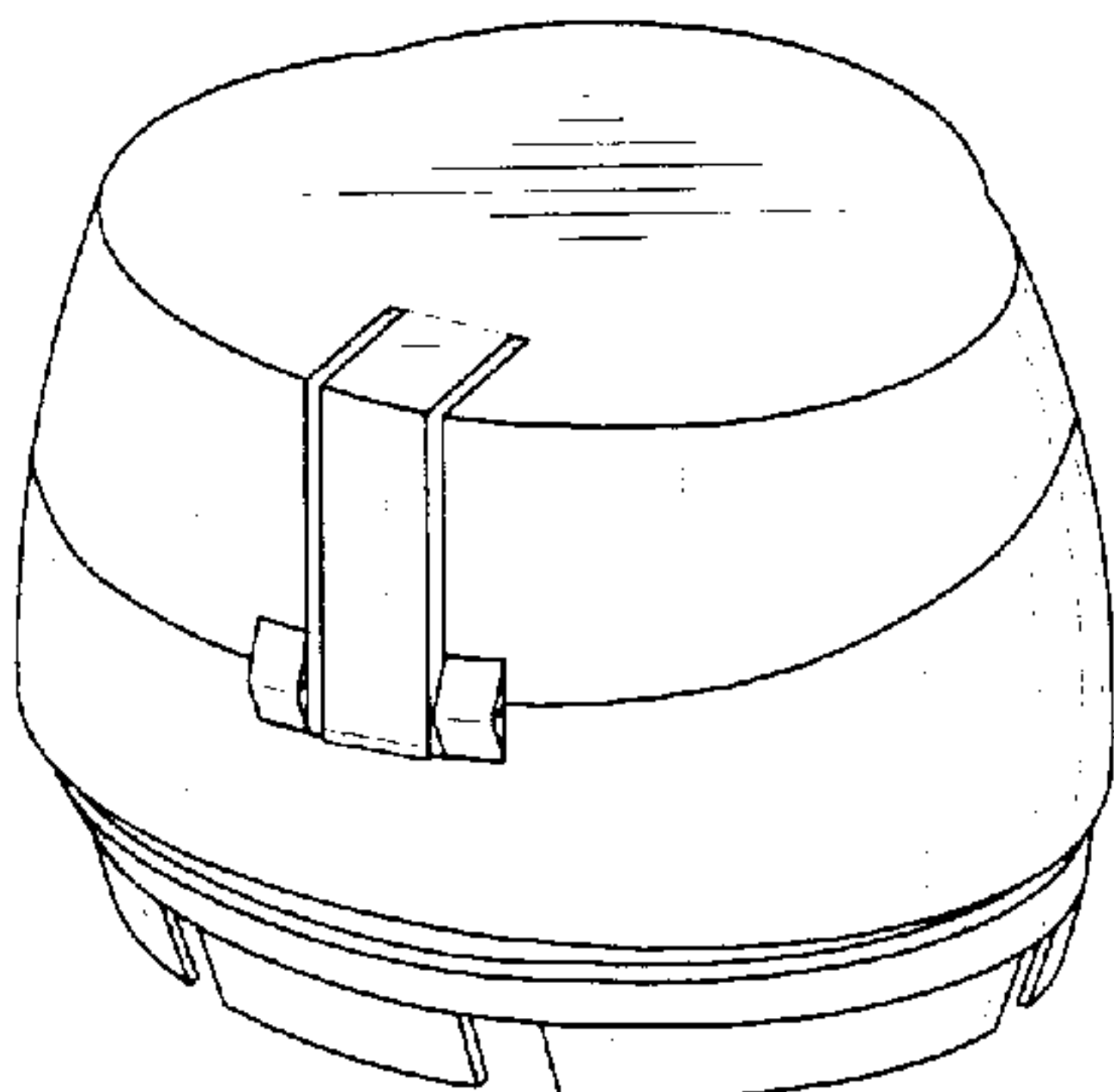

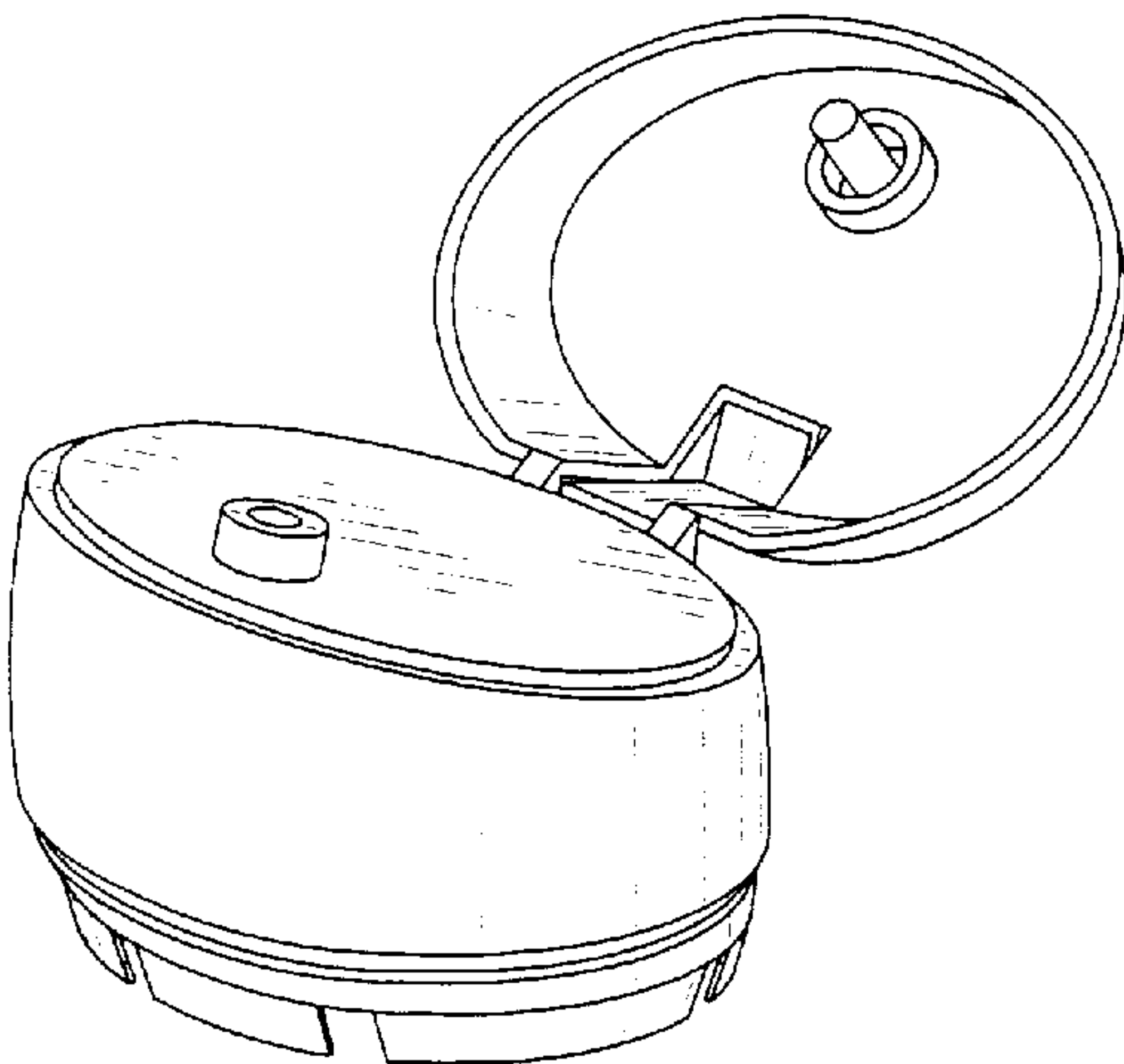

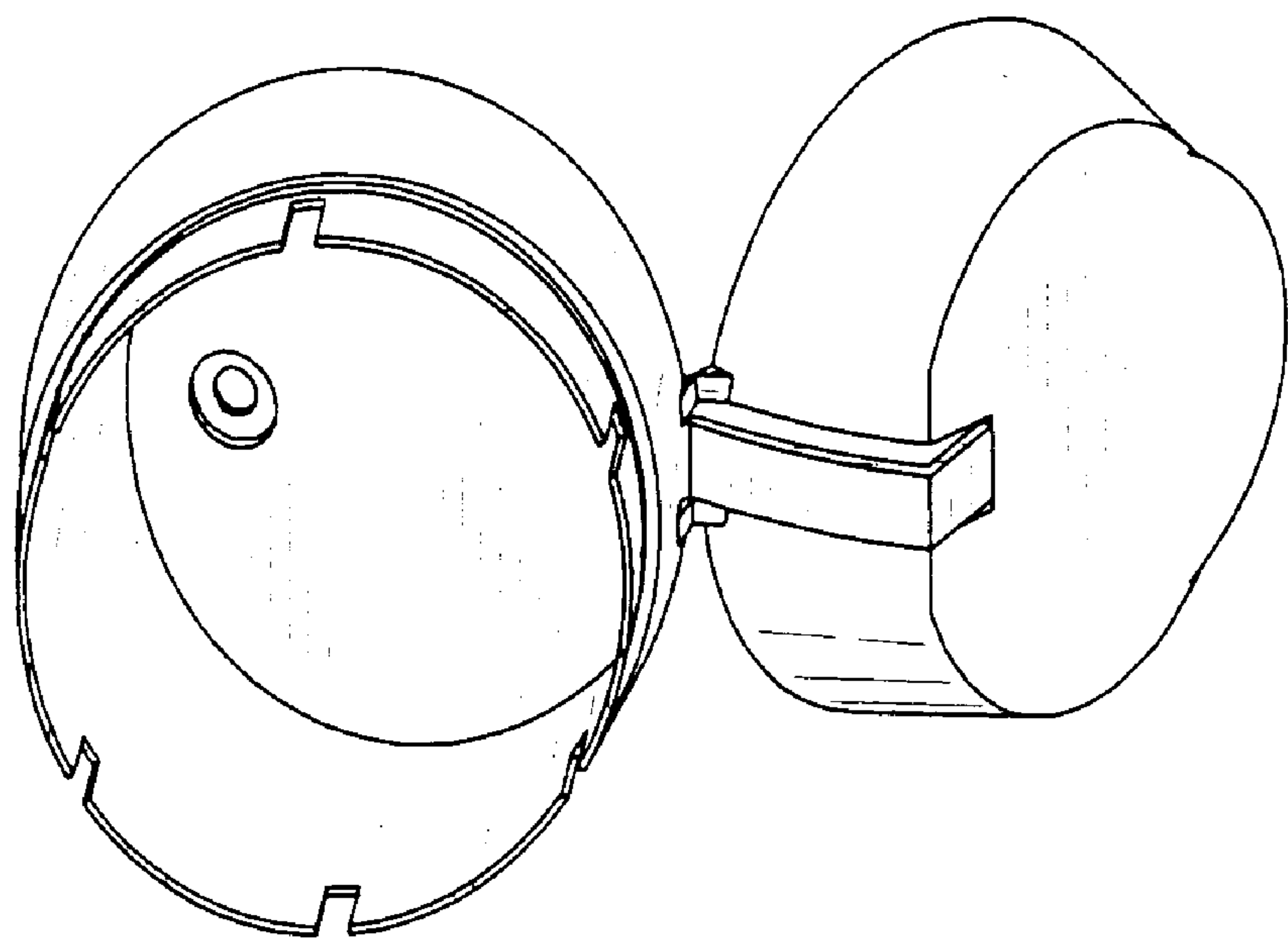
