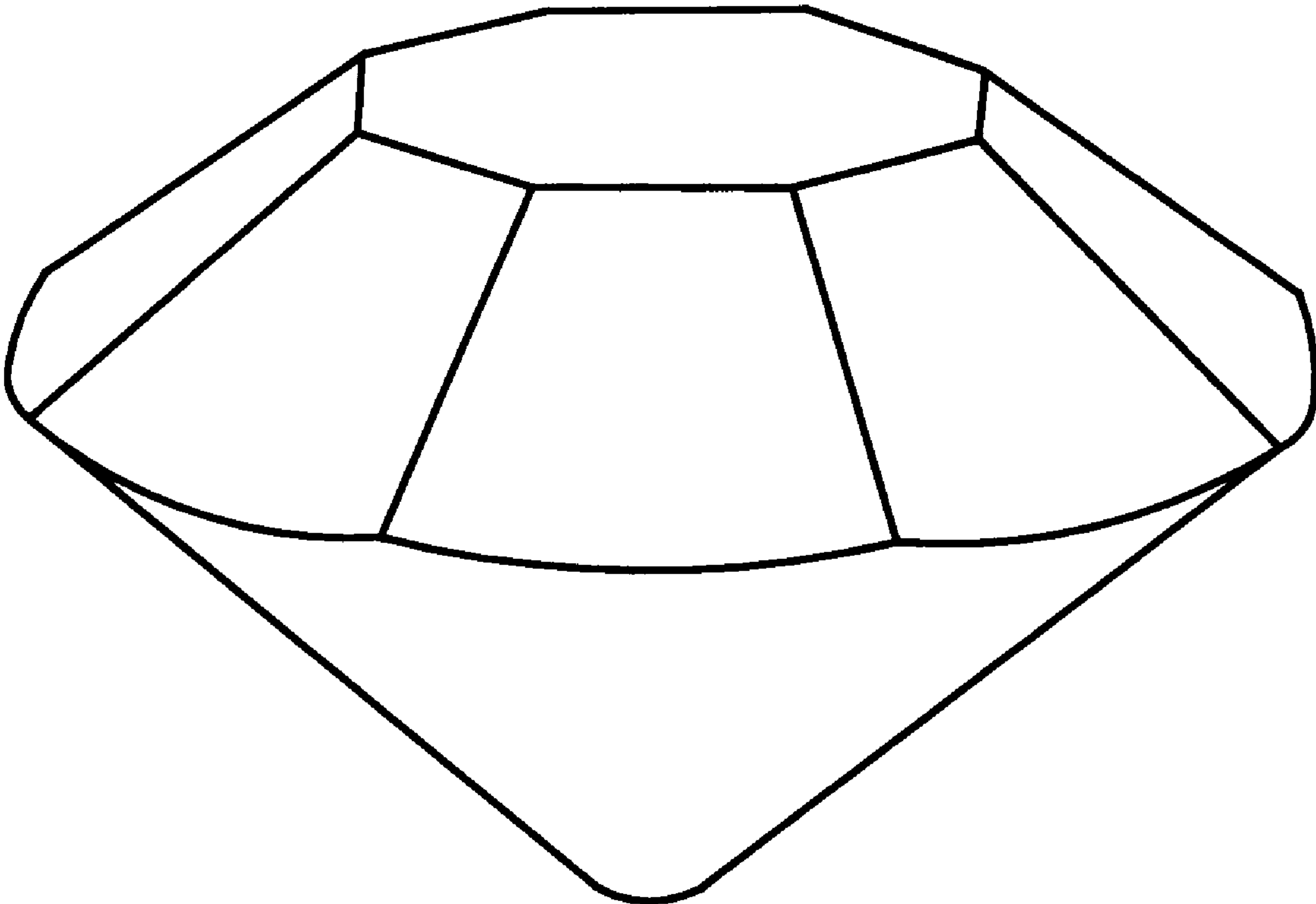

DESCRIPTION

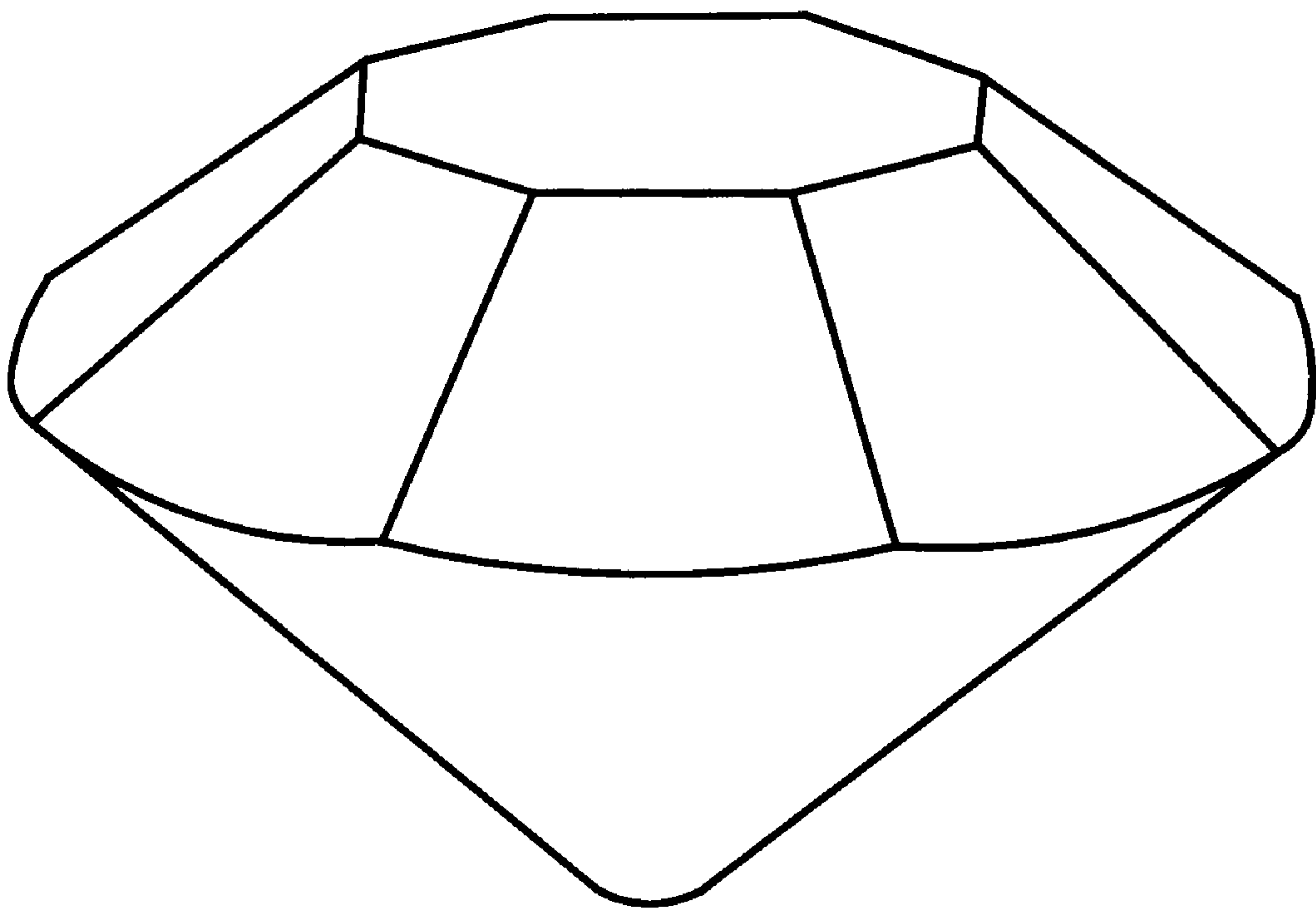

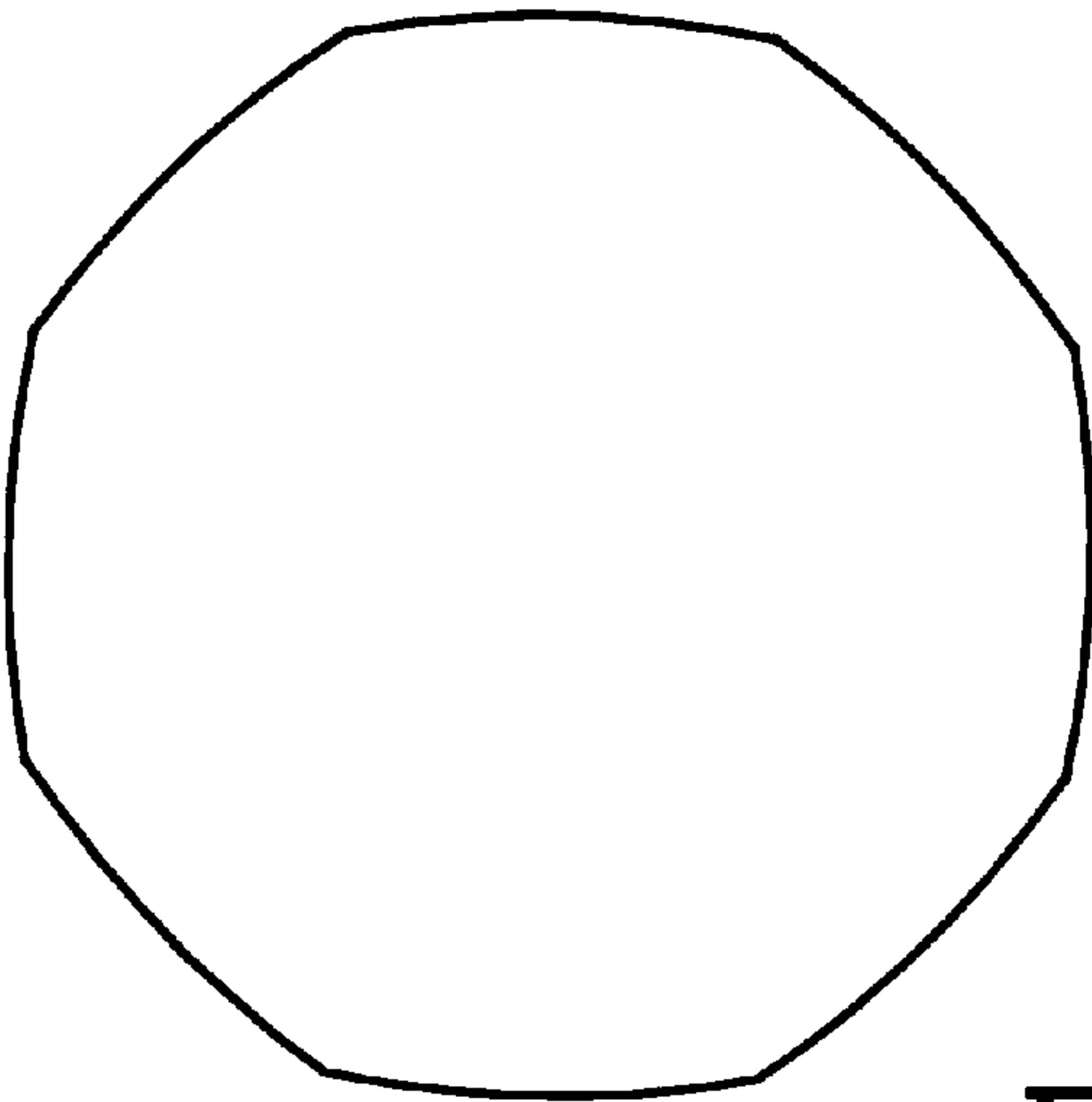

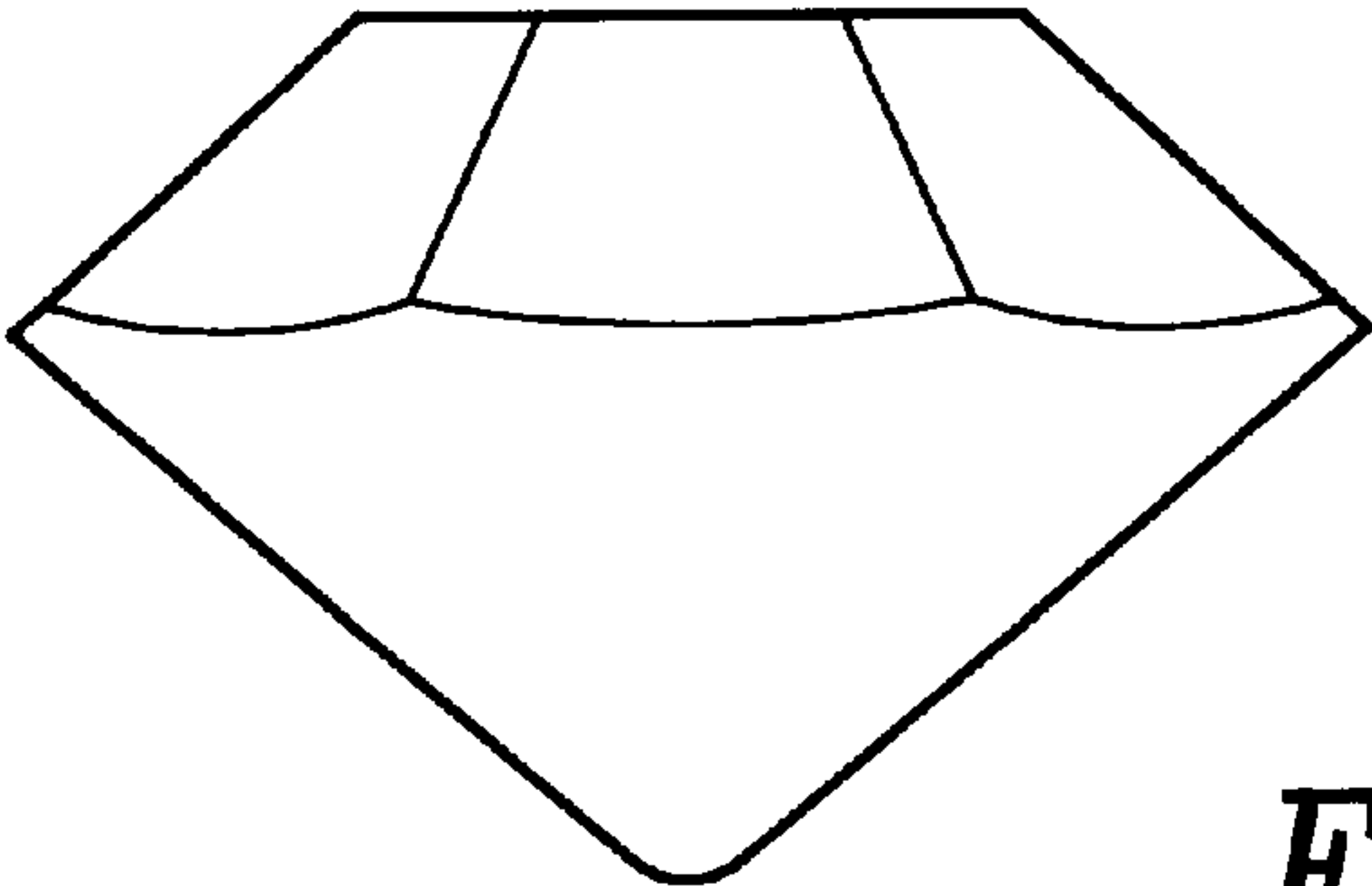

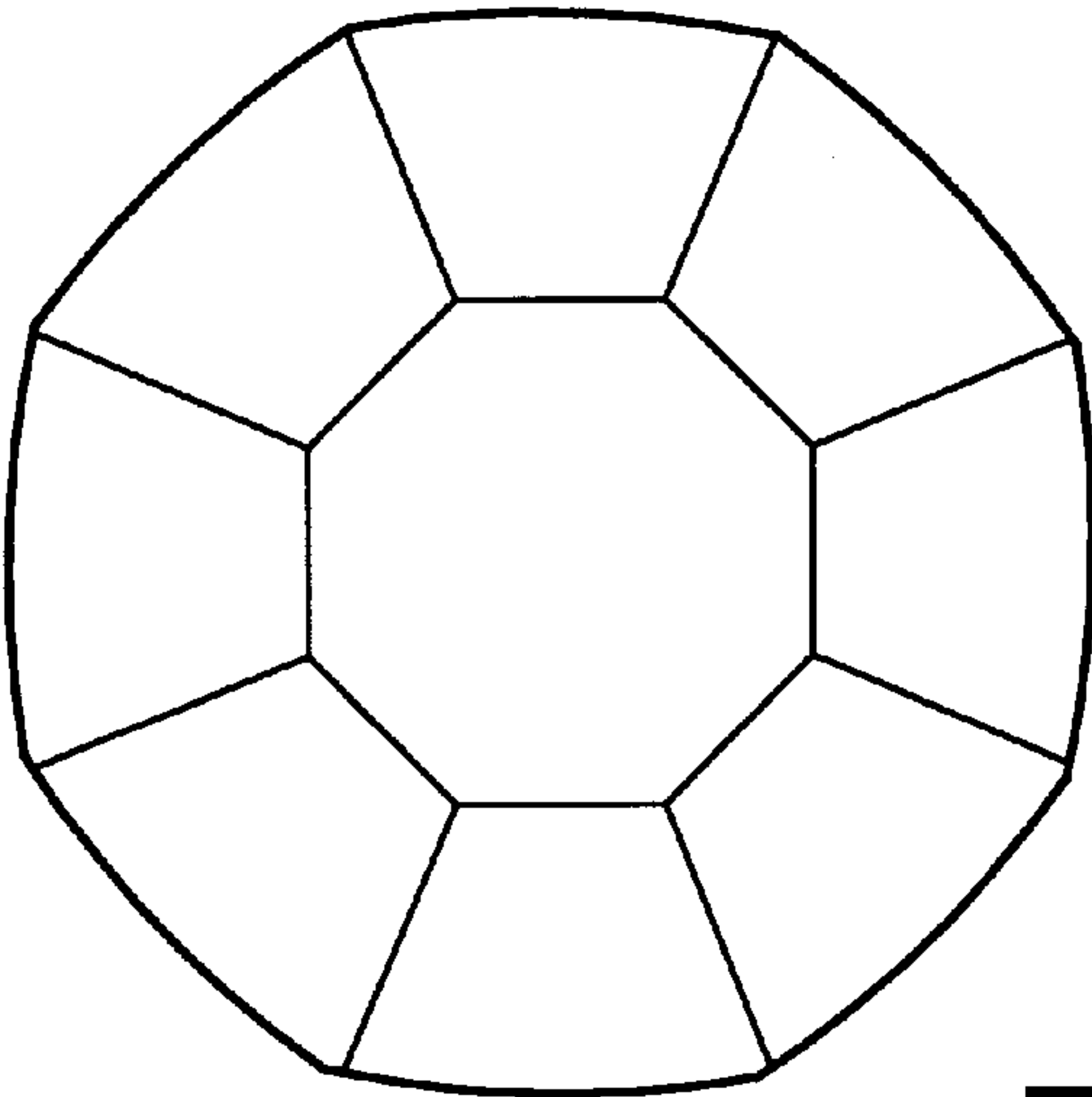

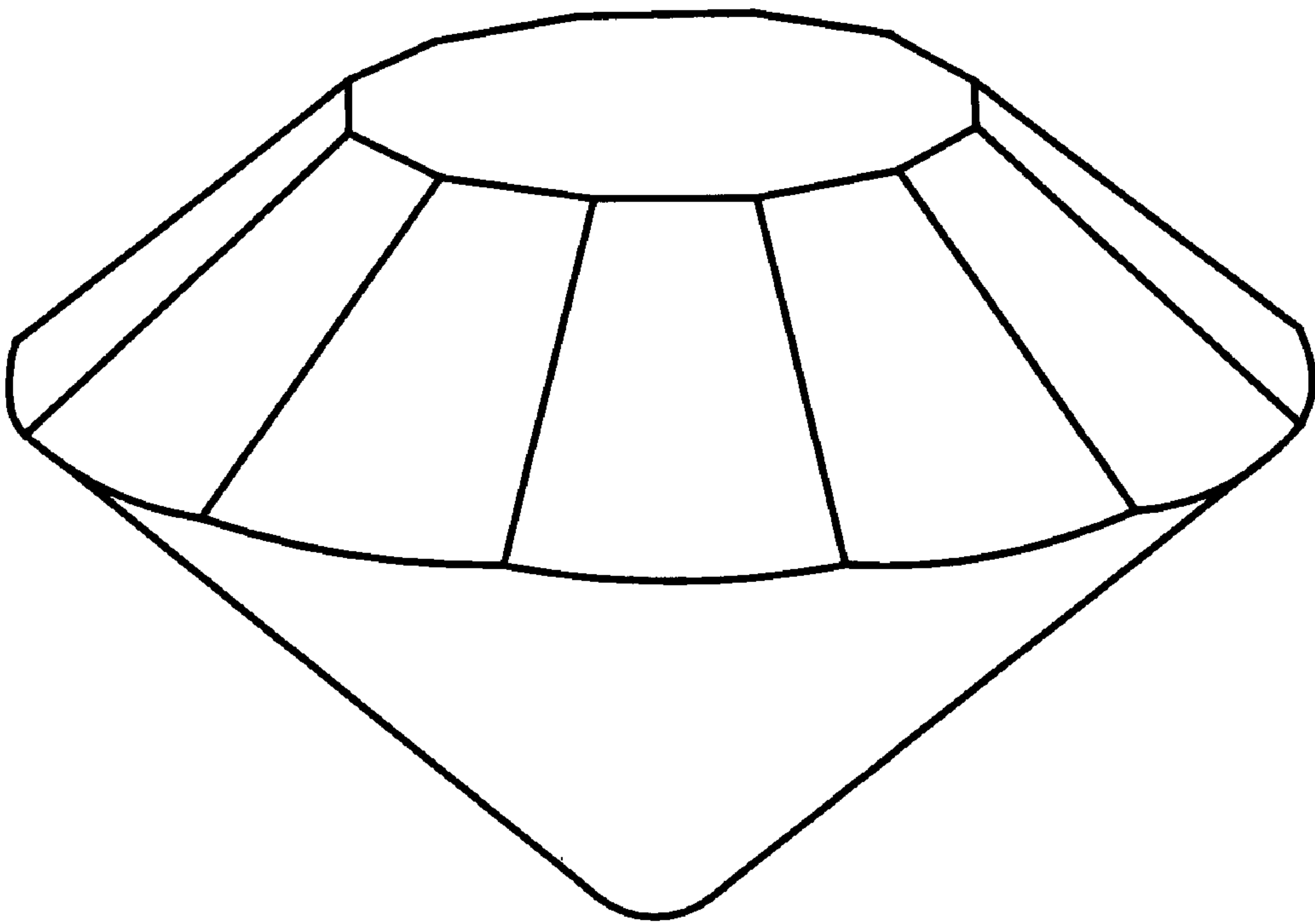

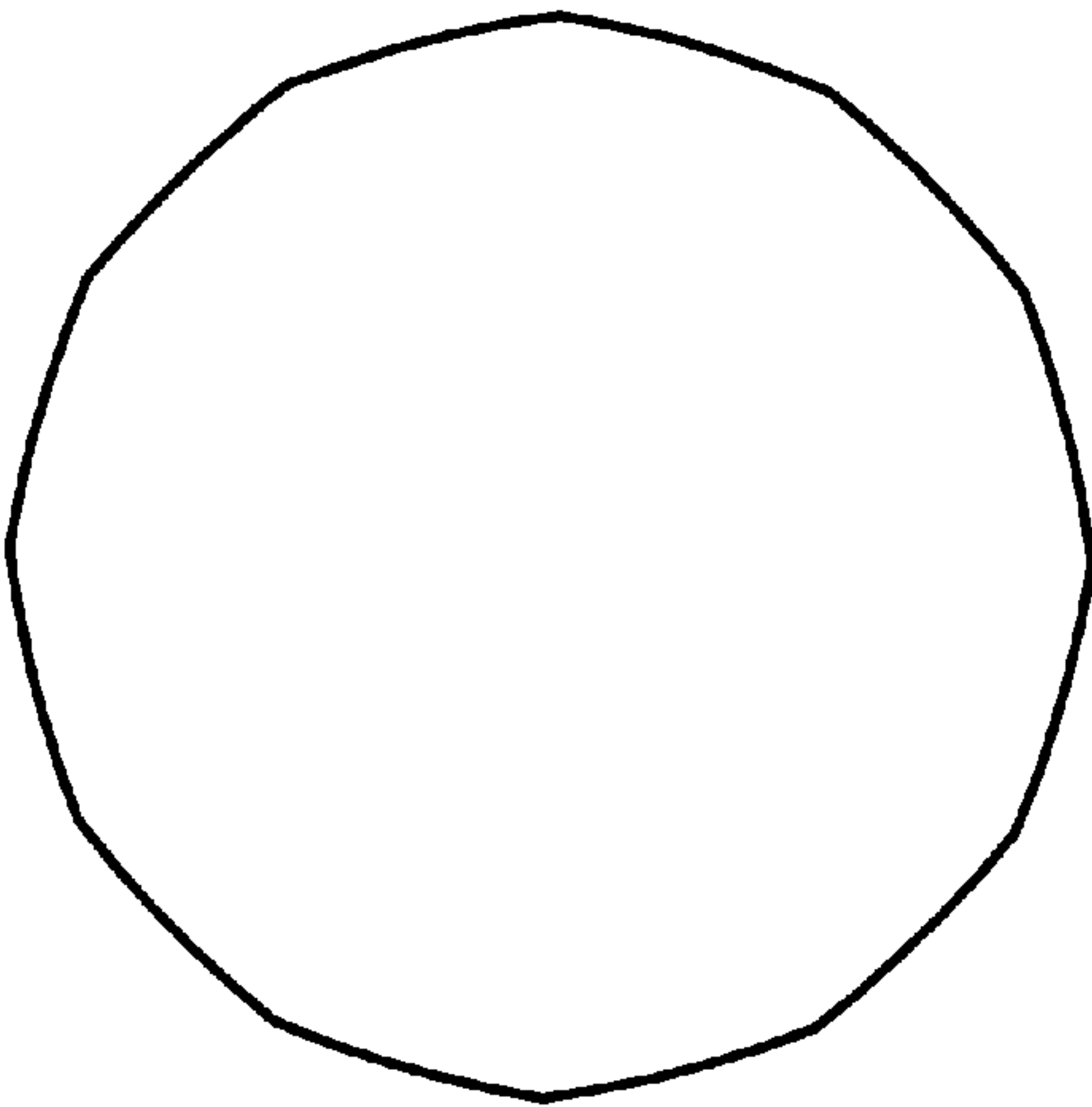

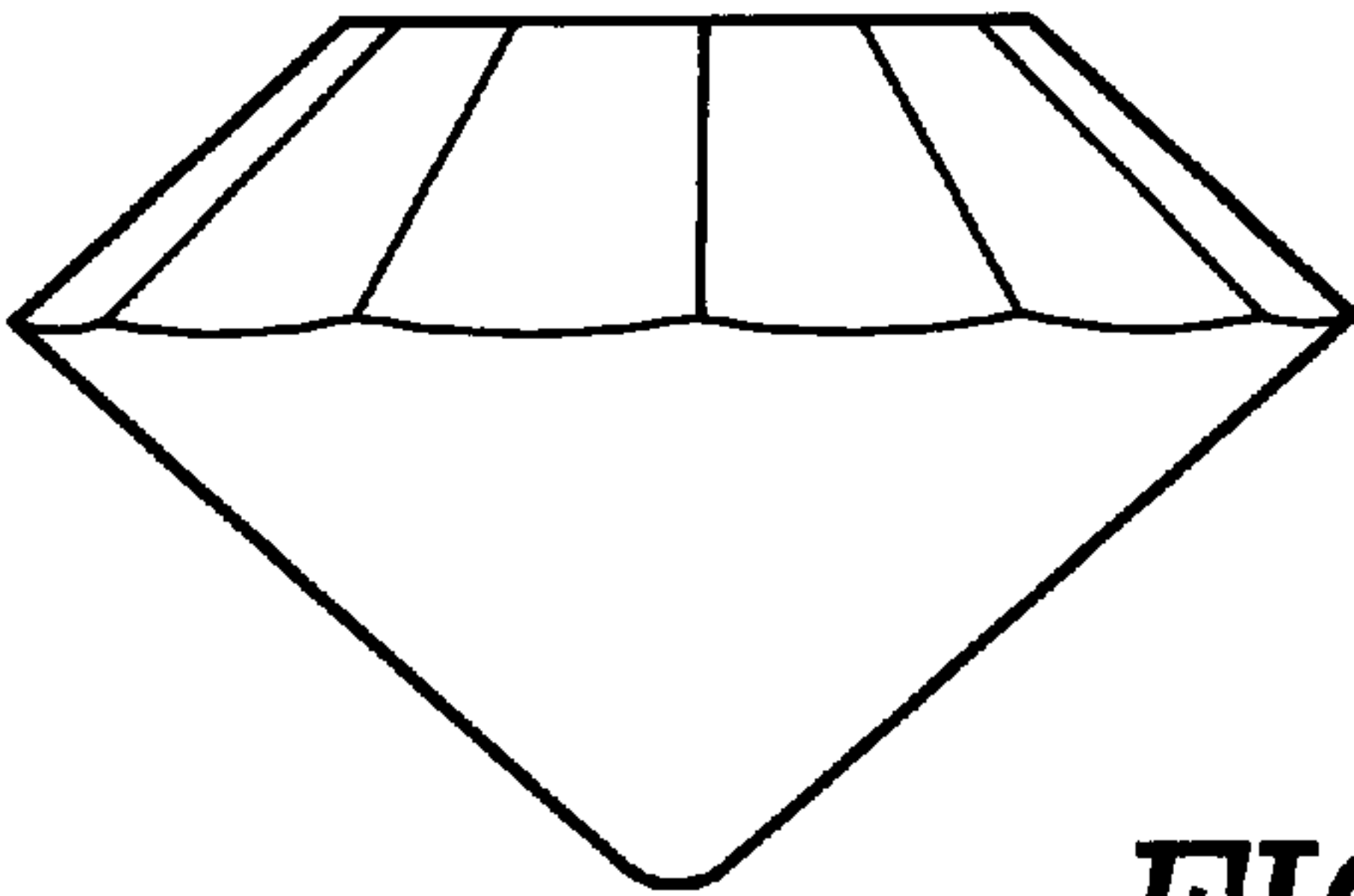

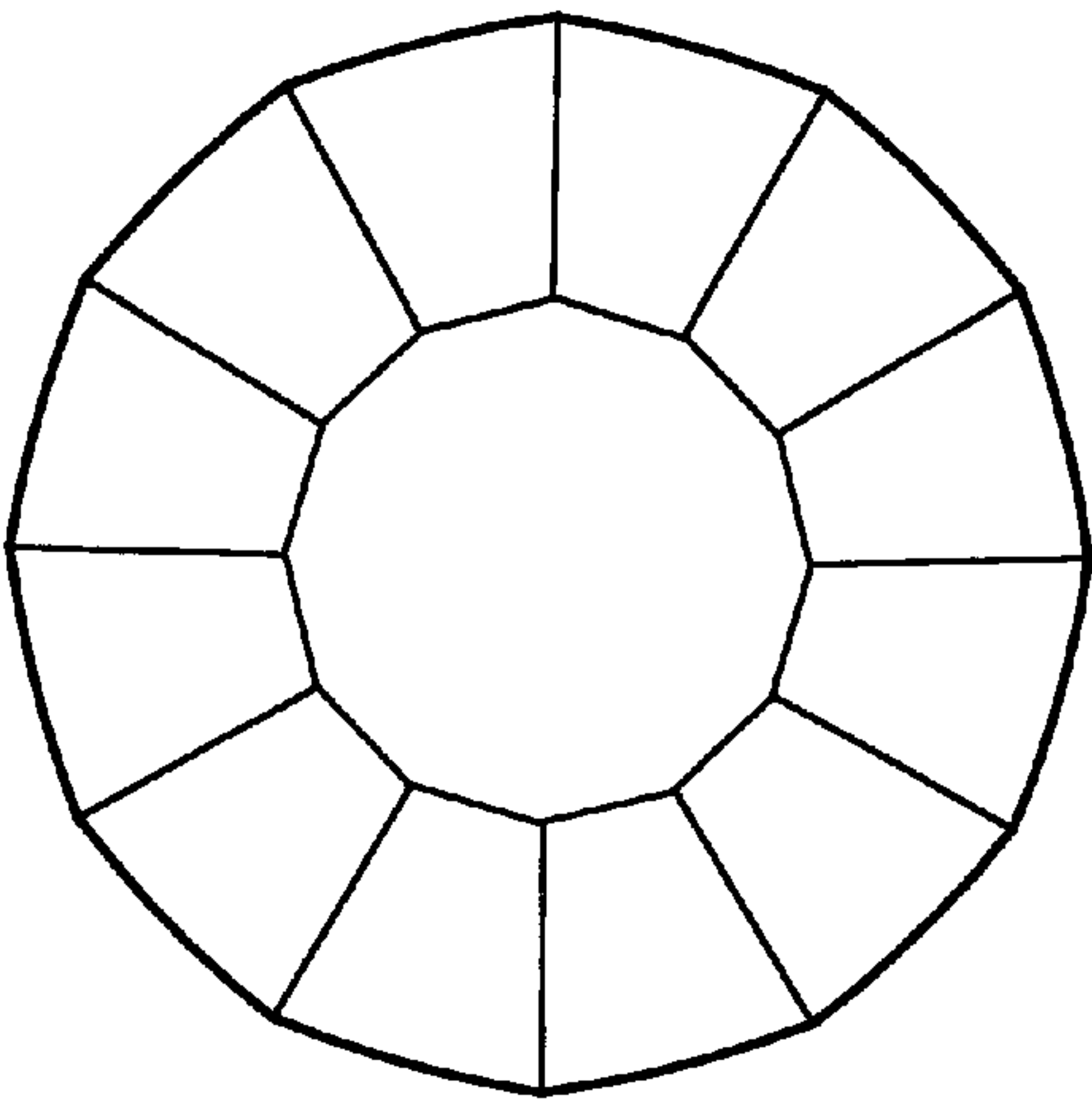

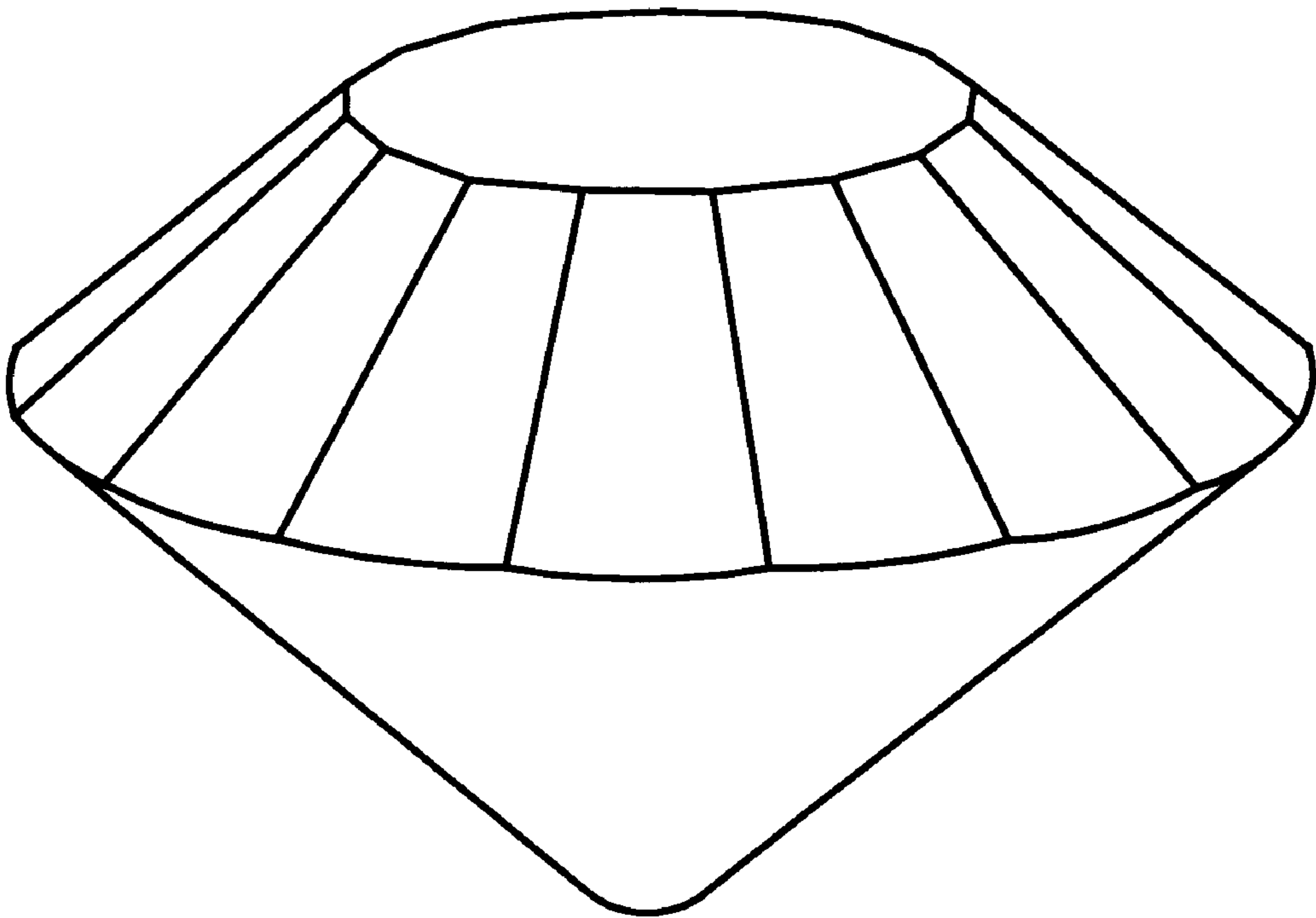

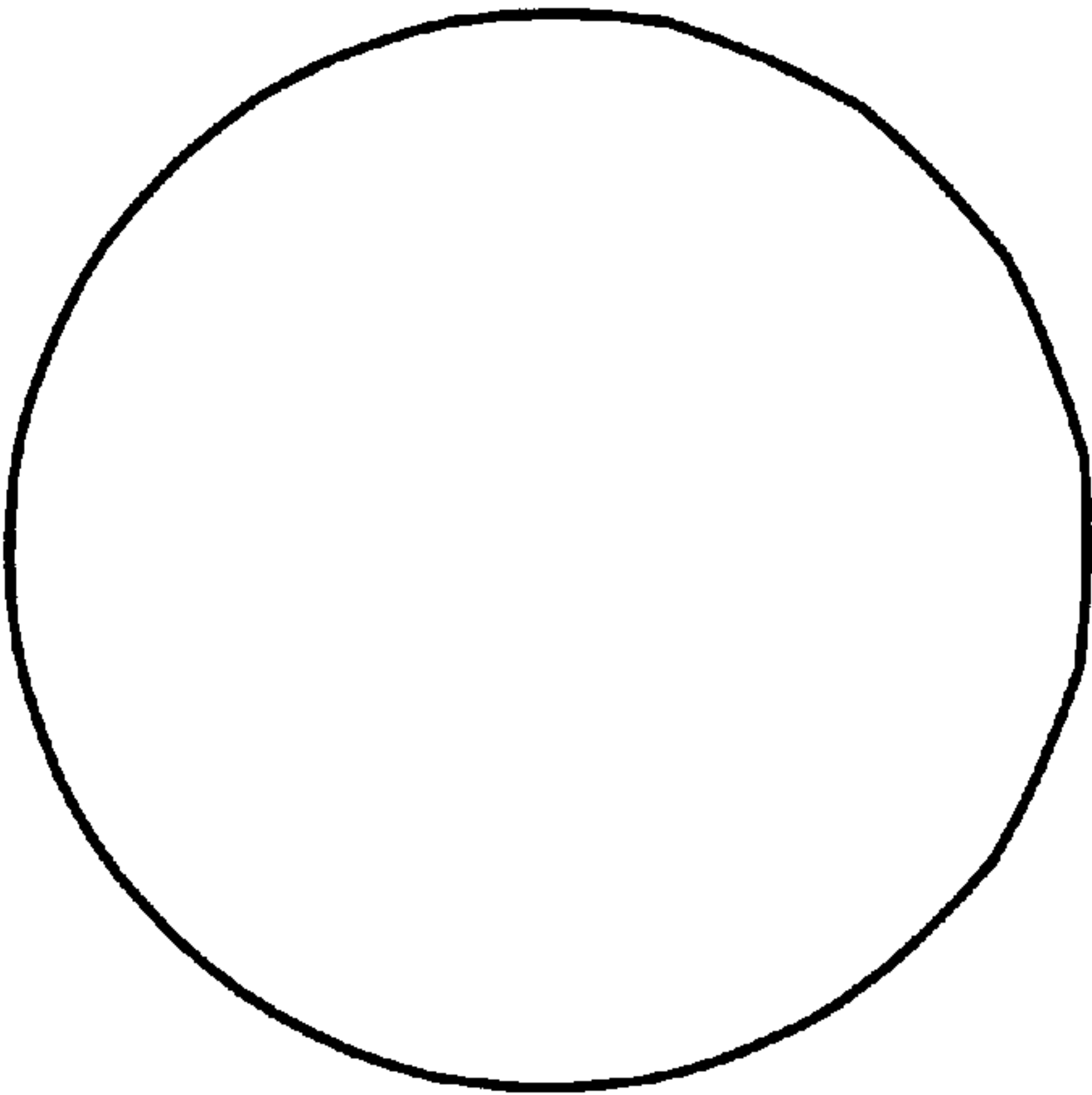

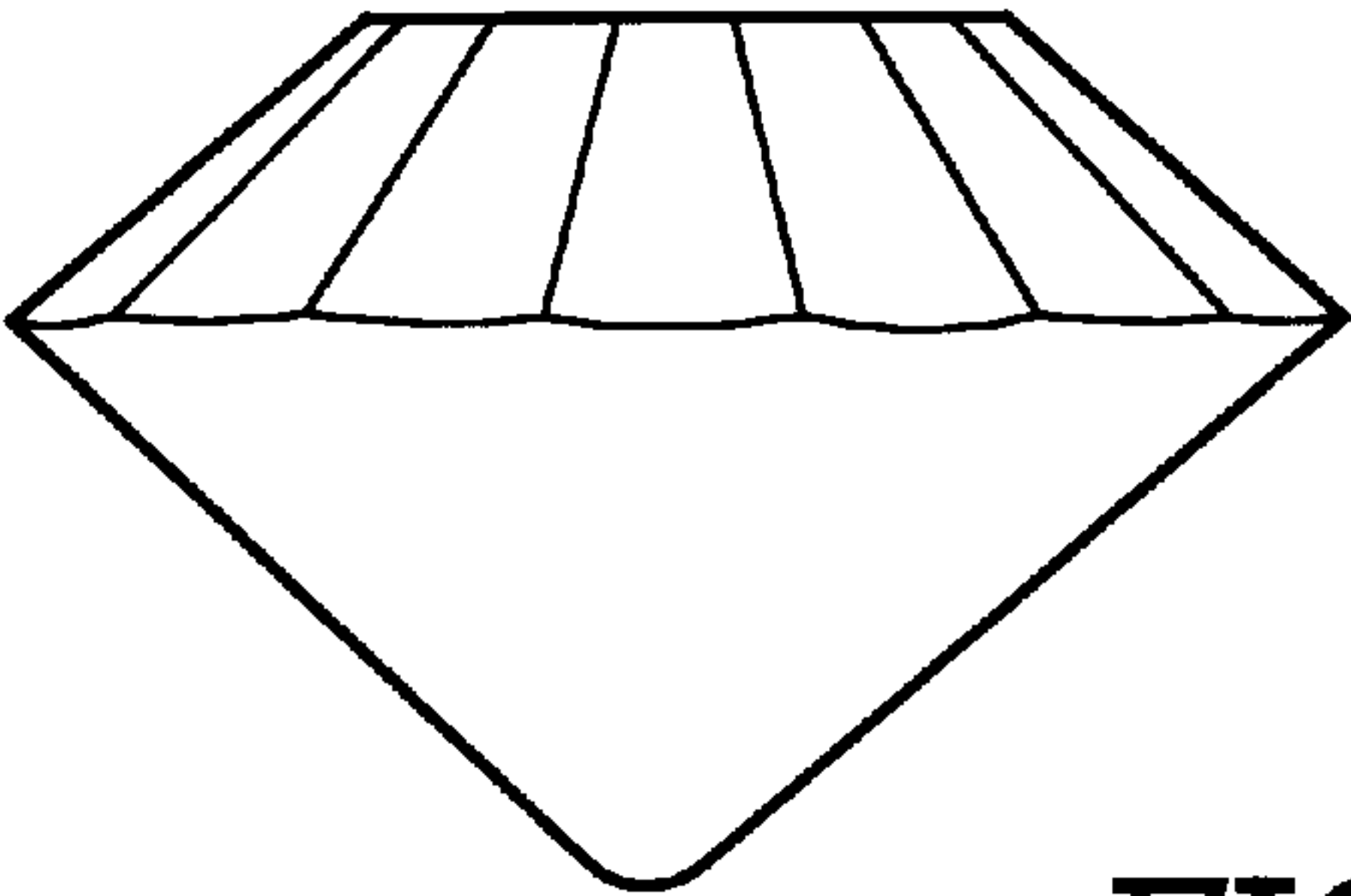

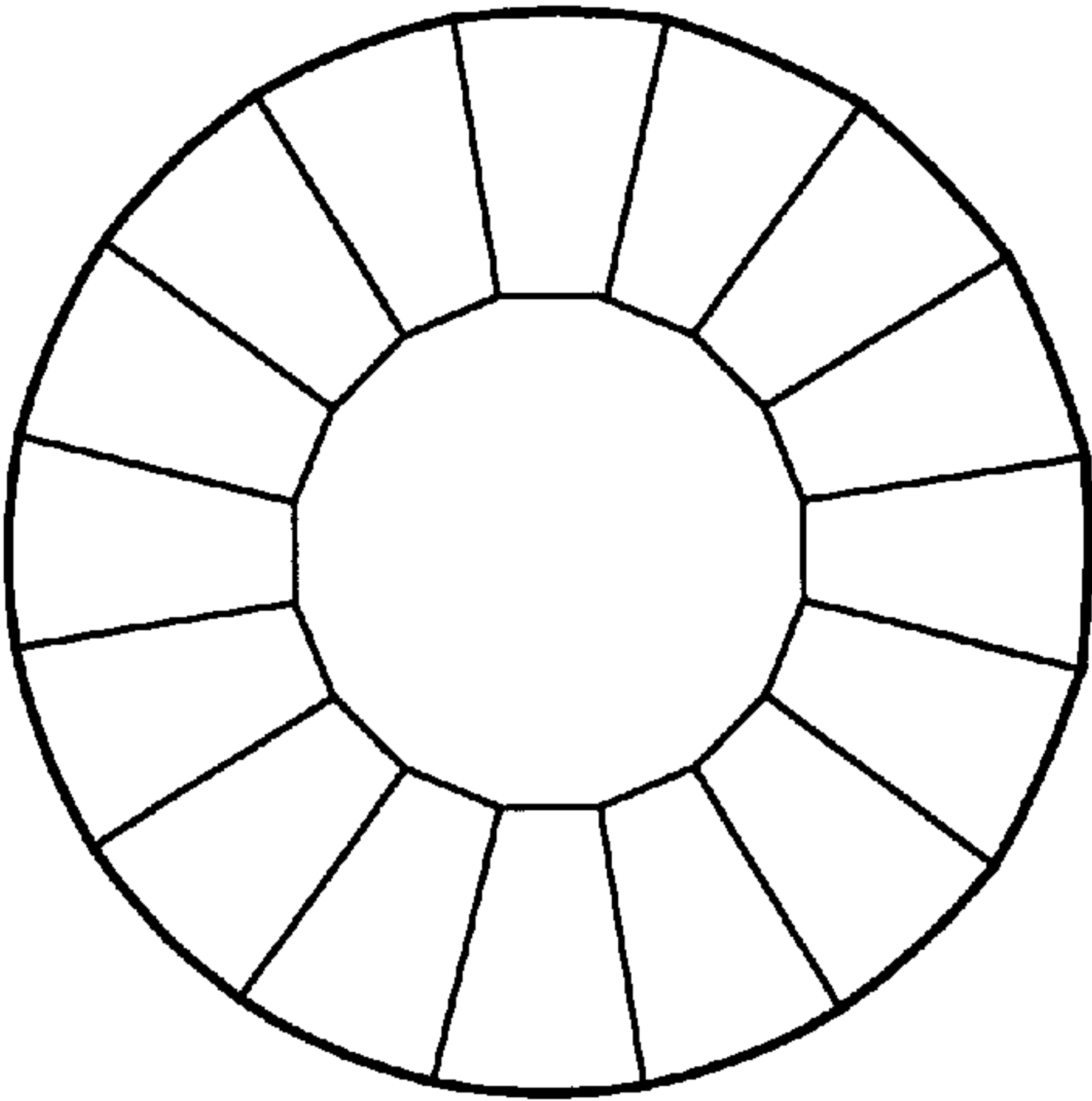
