[57] **CLAIM**

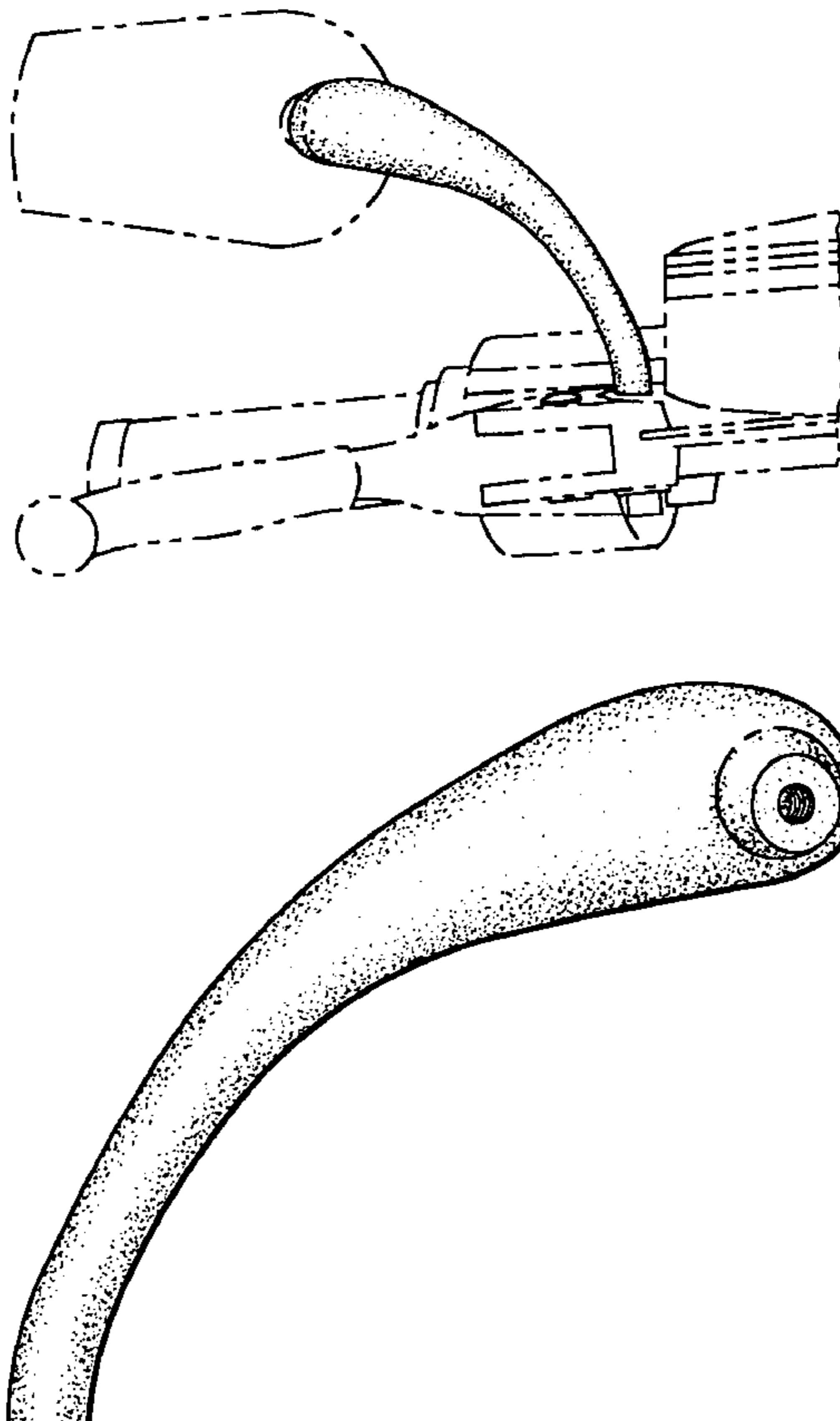
The ornamental design for a motorcycle mirror stem, as shown and described.

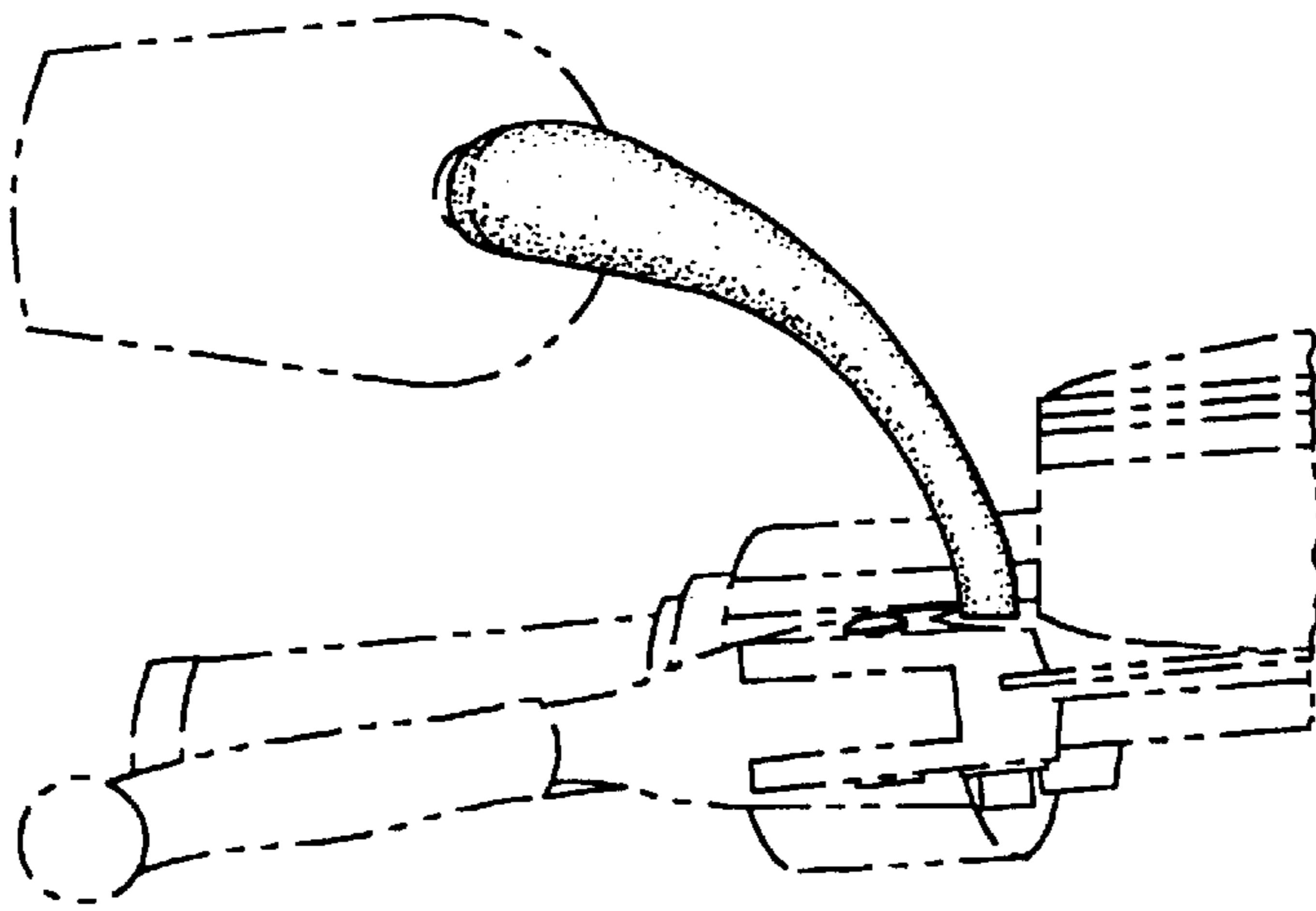
**DESCRIPTION**

- FIG. 1 is a perspective front view of the motorcycle mirror stem.
- FIG. 2 is an enlarged top view of the motorcycle mirror stem.
- FIG. 3 is an enlarged front view of the motorcycle mirror stem.
- FIG. 4 is an enlarged left side view of the motorcycle mirror stem.
- FIG. 5 is an enlarged back view of the motorcycle mirror stem.
- FIG. 6 is an enlarged right side view of the motorcycle mirror stem; and,
- FIG. 7 is an enlarged bottom view of the motorcycle mirror stem.

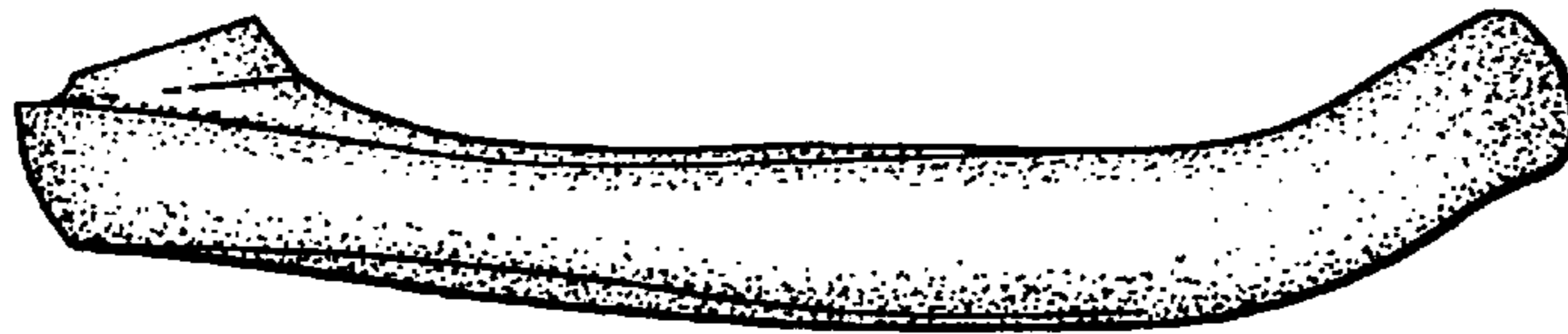

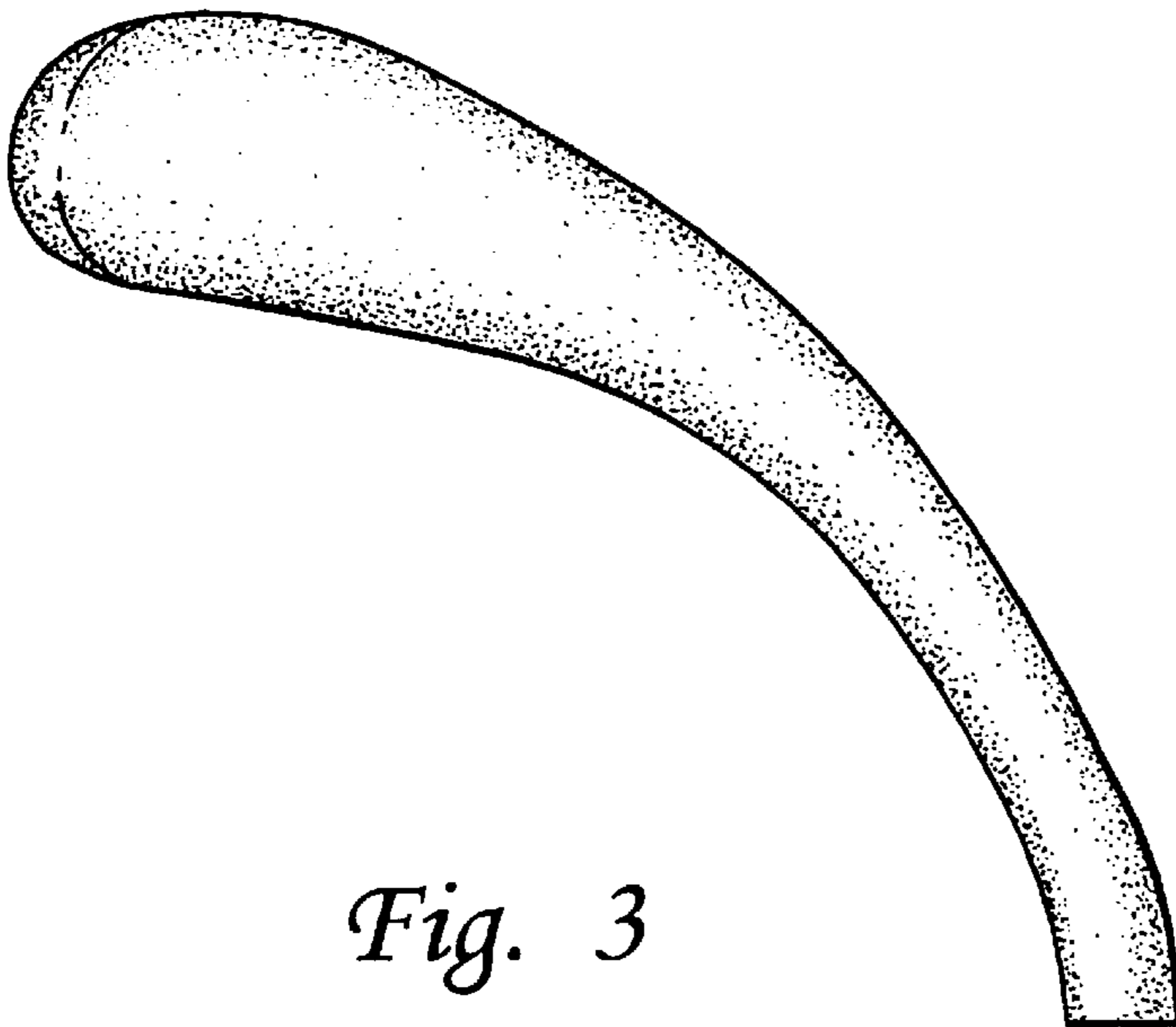

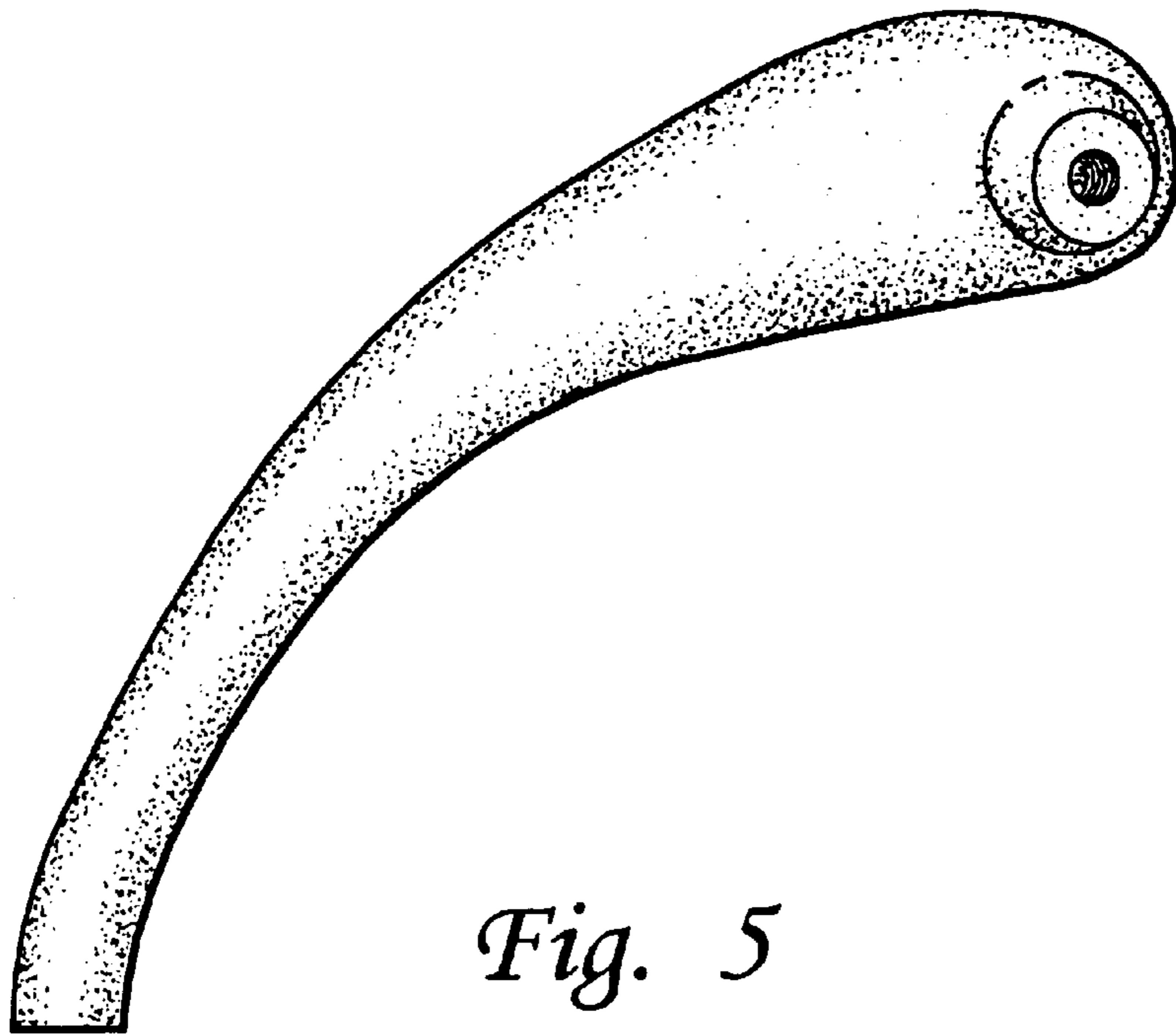

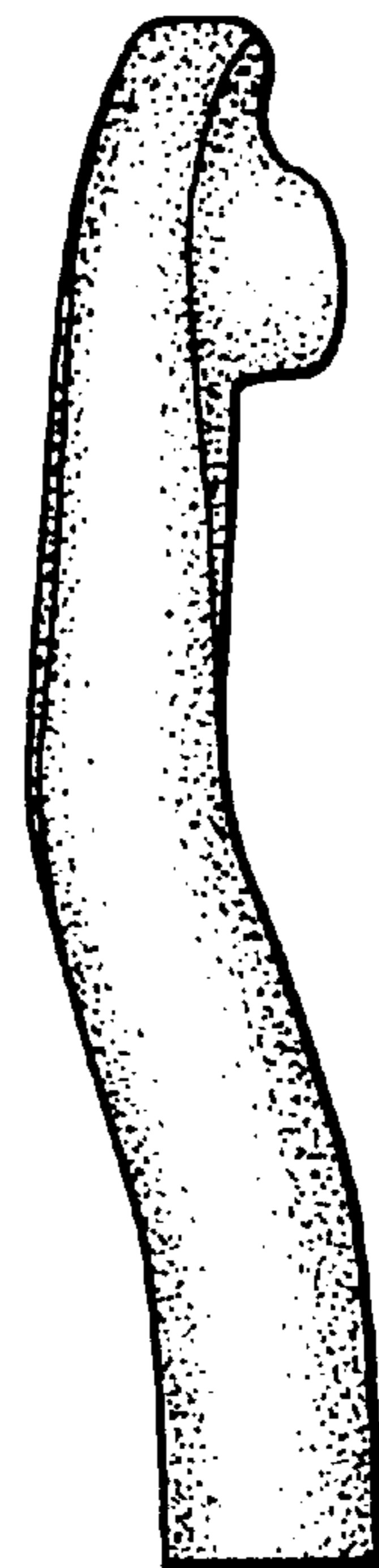

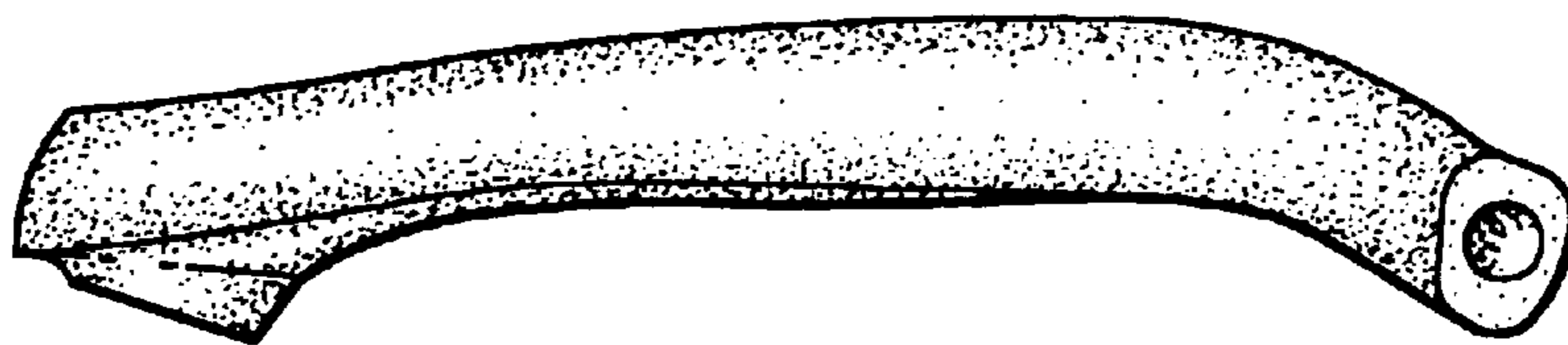
