The ornamental design for a floor mat, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of a floor mat showing my new design; FIG. 2 is a rear view of the floor mat shown in FIG. 1; FIG. 3 is a left side view of the floor mat shown in FIG. 1; FIG. 4 is a right side view of the floor mat shown in FIG. 1; FIG. 5 is a top view of the floor mat shown in FIG. 1; FIG. 6 is a bottom view of the floor mat shown in FIG. 1; and, FIG. 7 is a reduced top and left side perspective view of the floor mat shown in FIG. 1.

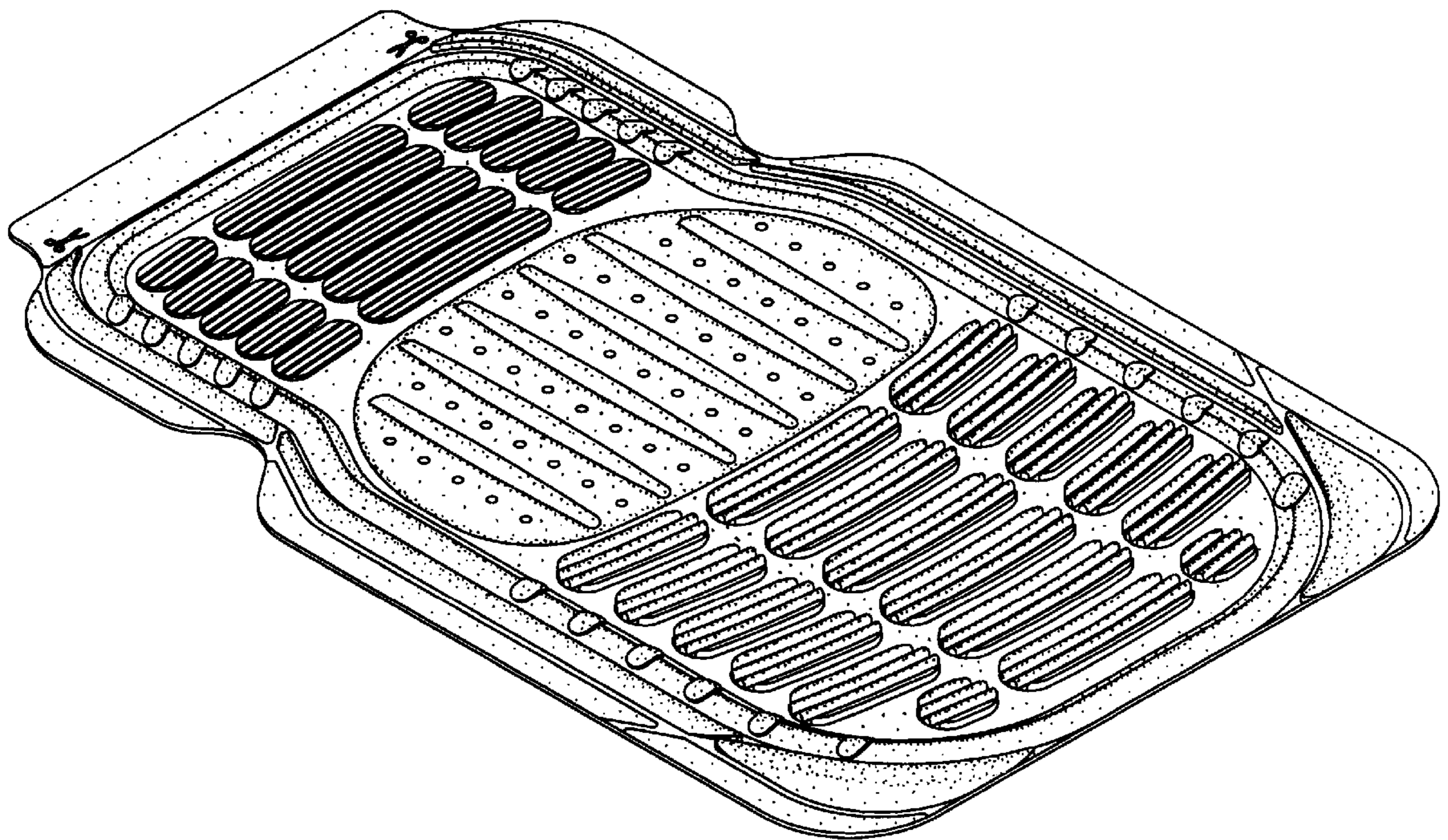

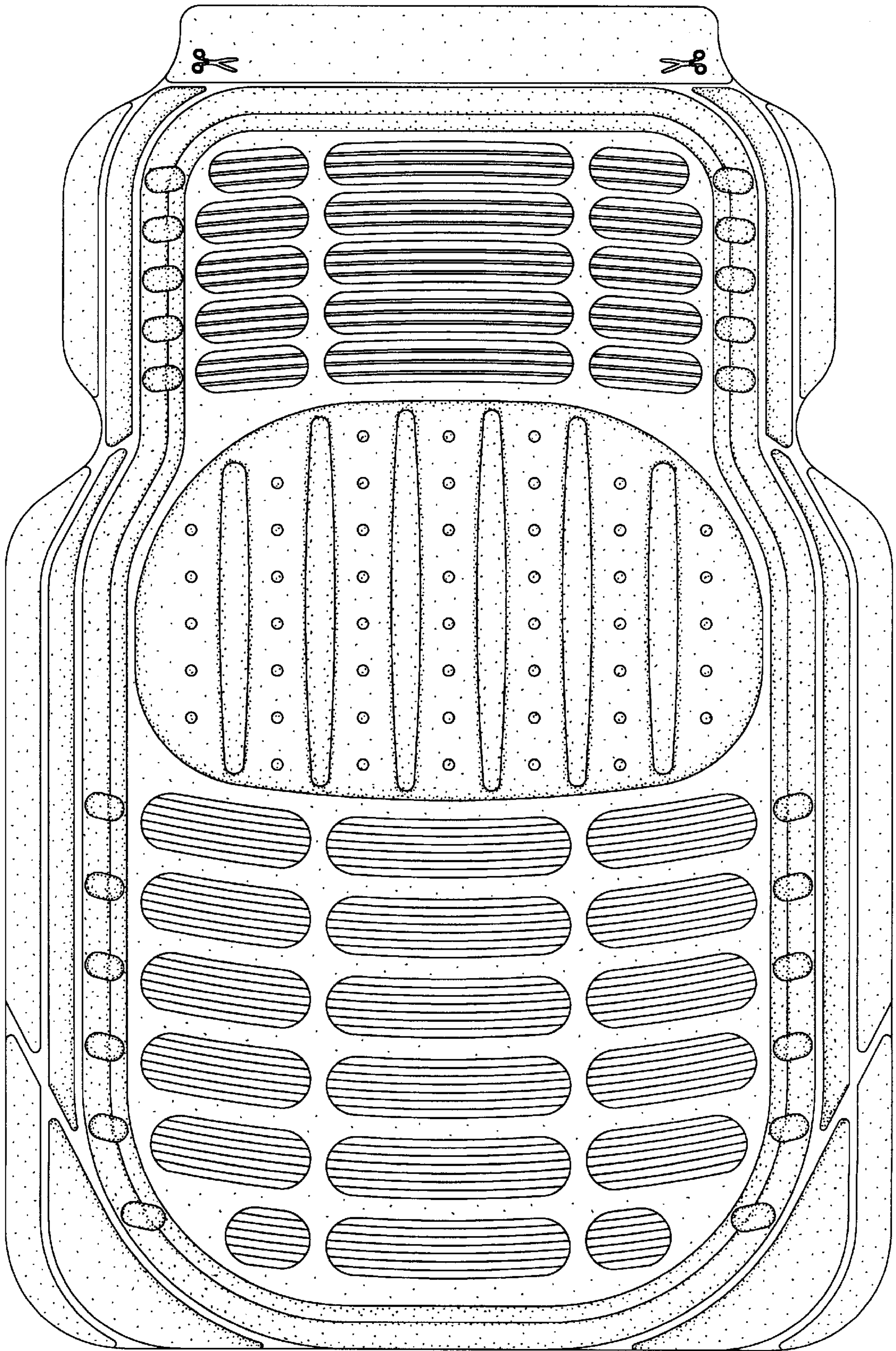

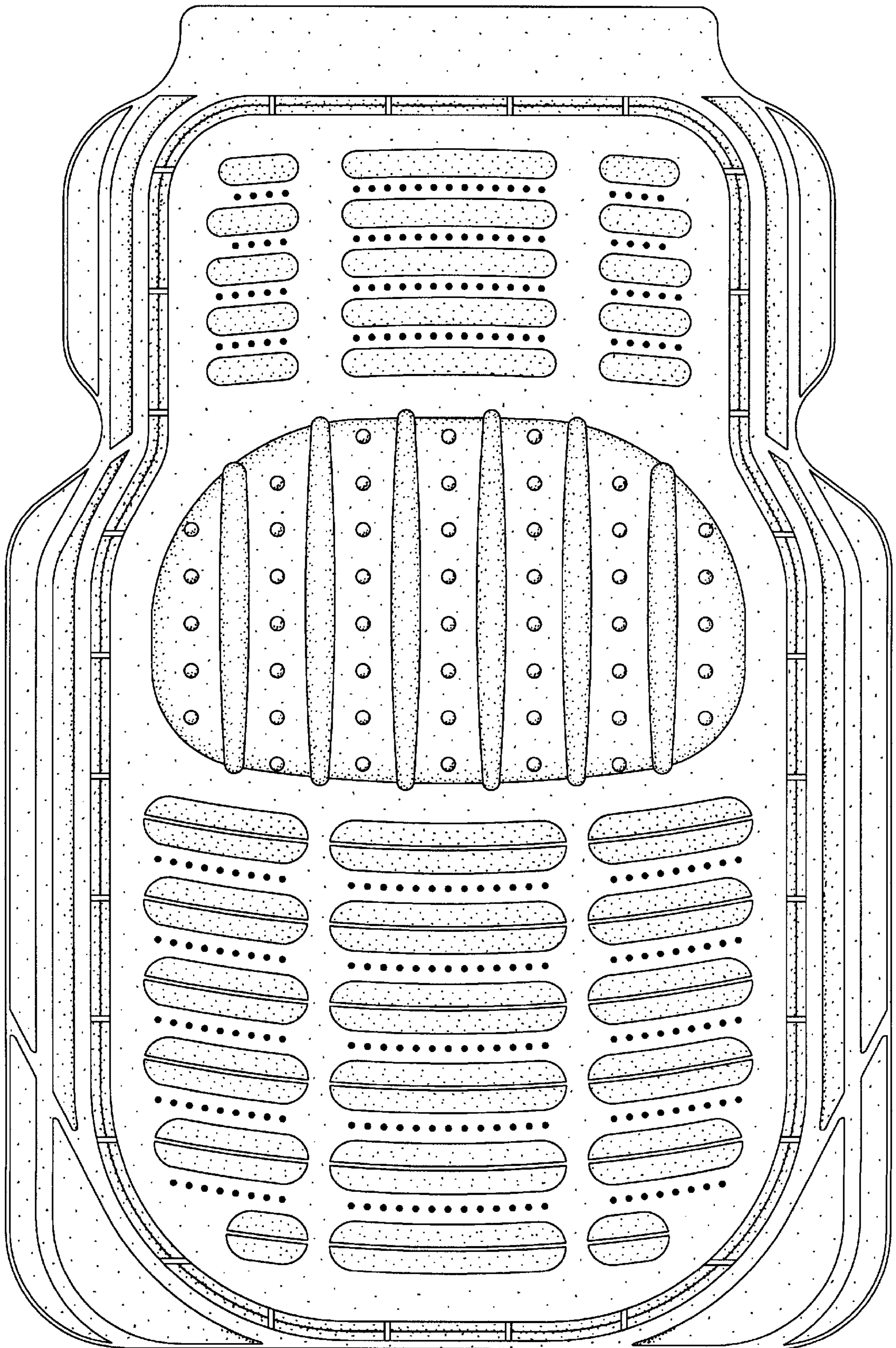

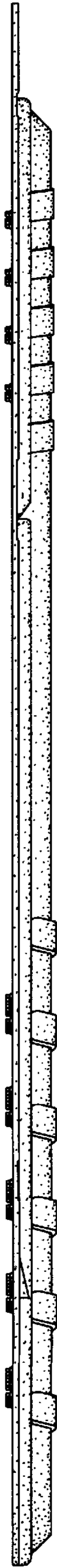

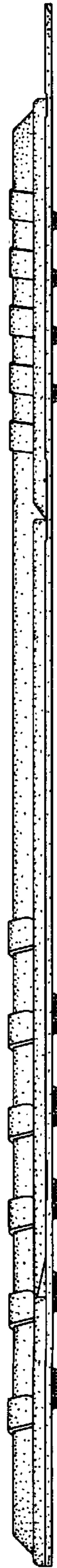

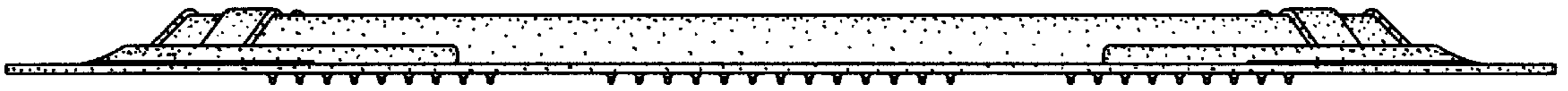
