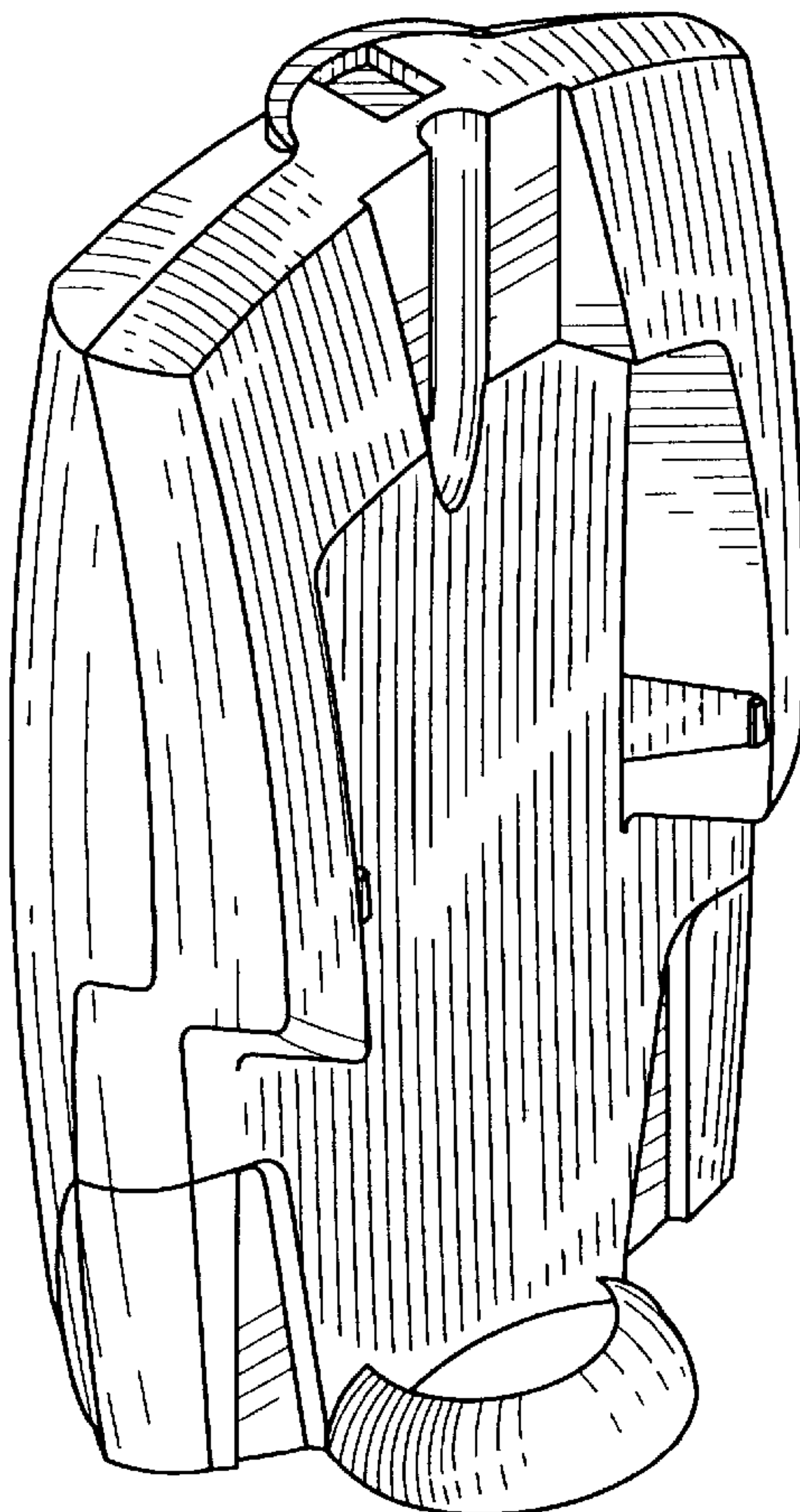
[57] **CLAIM**

The ornamental design for a car adapter for a portable telephone, as shown.

**DESCRIPTION**

FIG. 1 is a perspective view of the car adapter; FIG. 2 is a front plan view of the car adapter; FIG. 3 is a top plan view of the car adapter; FIG. 4 is a bottom plan view of the car adapter; FIG. 5 is a right side plan view of the car adapter; FIG. 6 is a left side plan view of the car adapter; and, FIG. 7 is a back plan view of the car adapter.

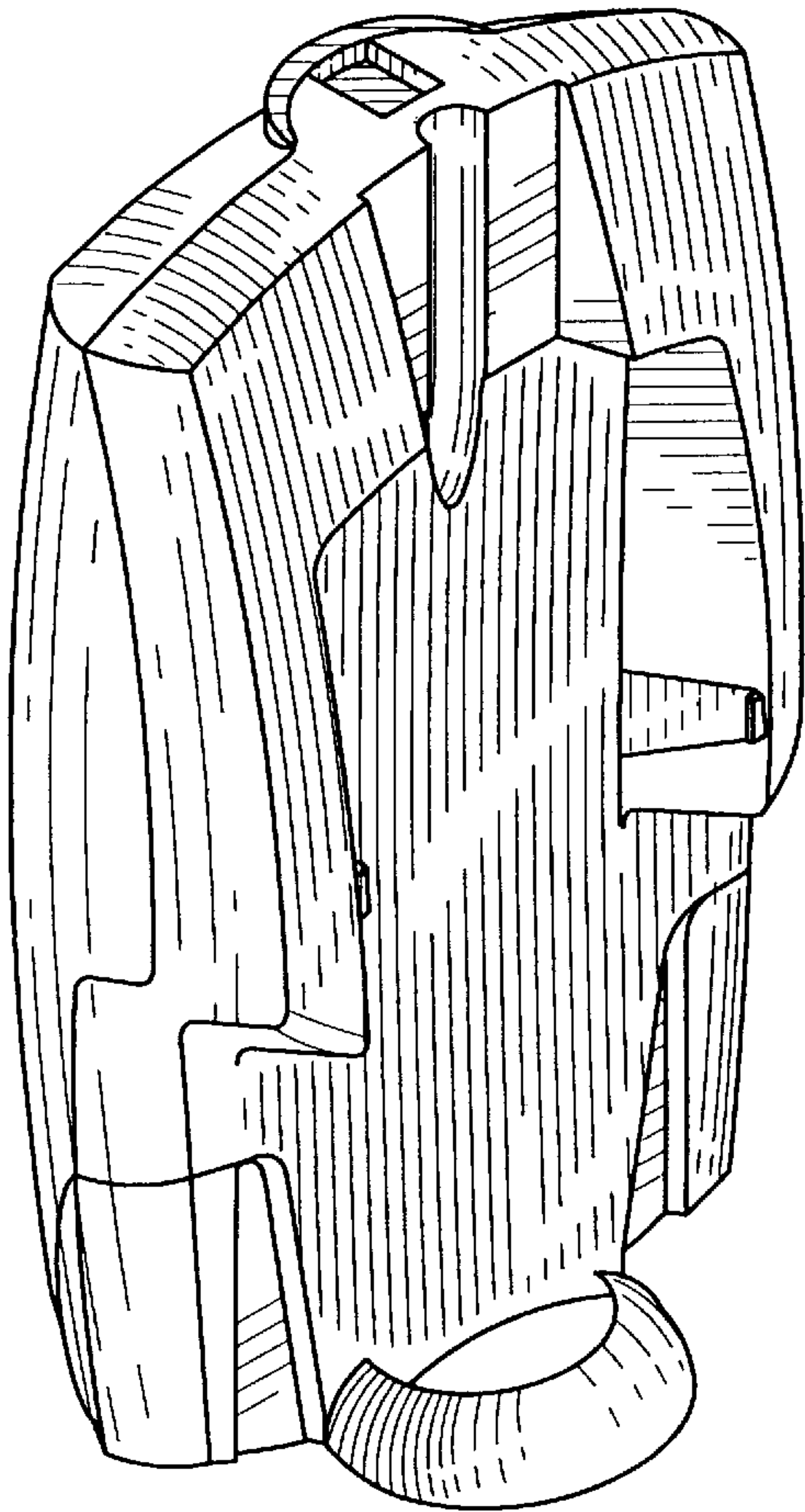

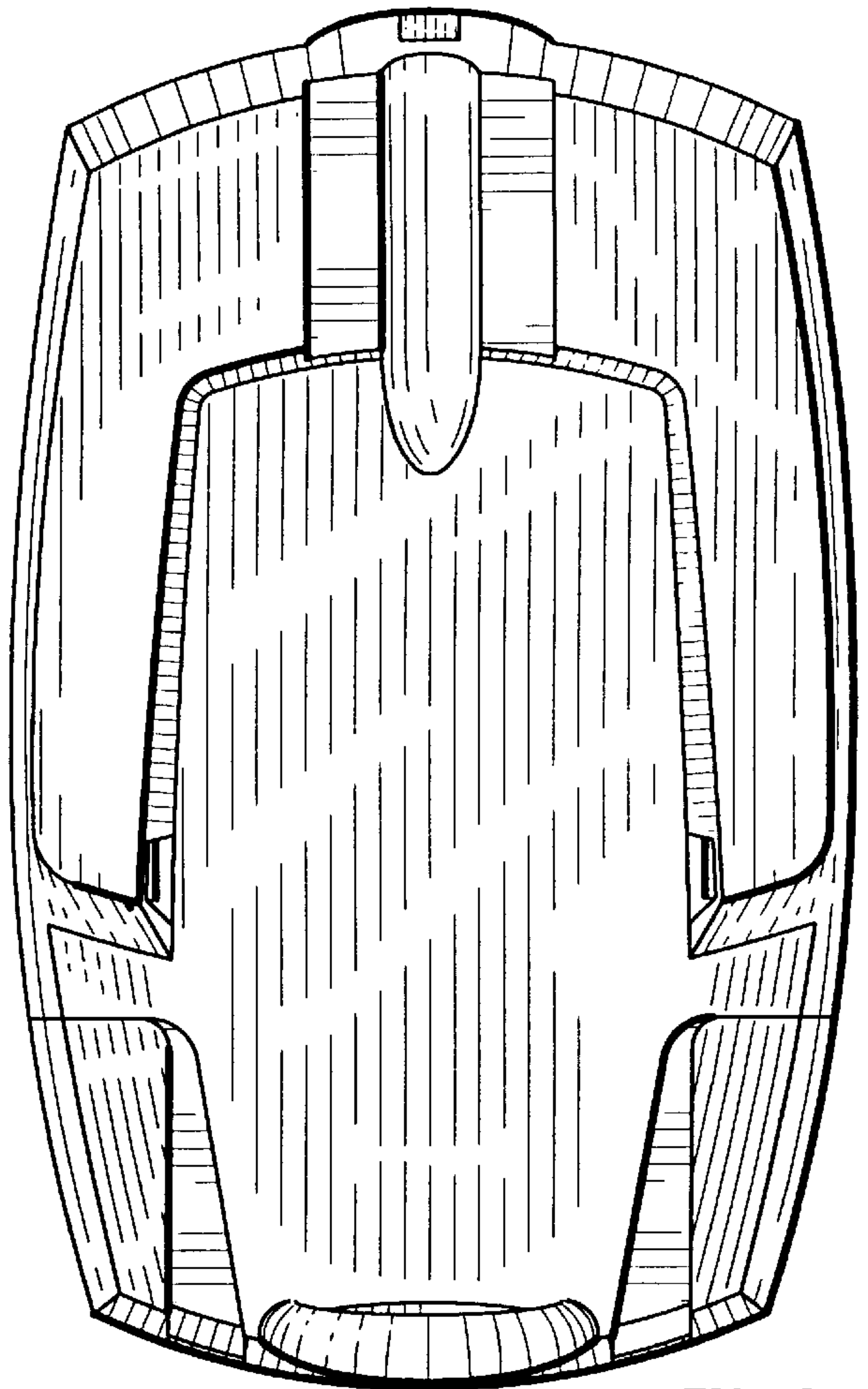

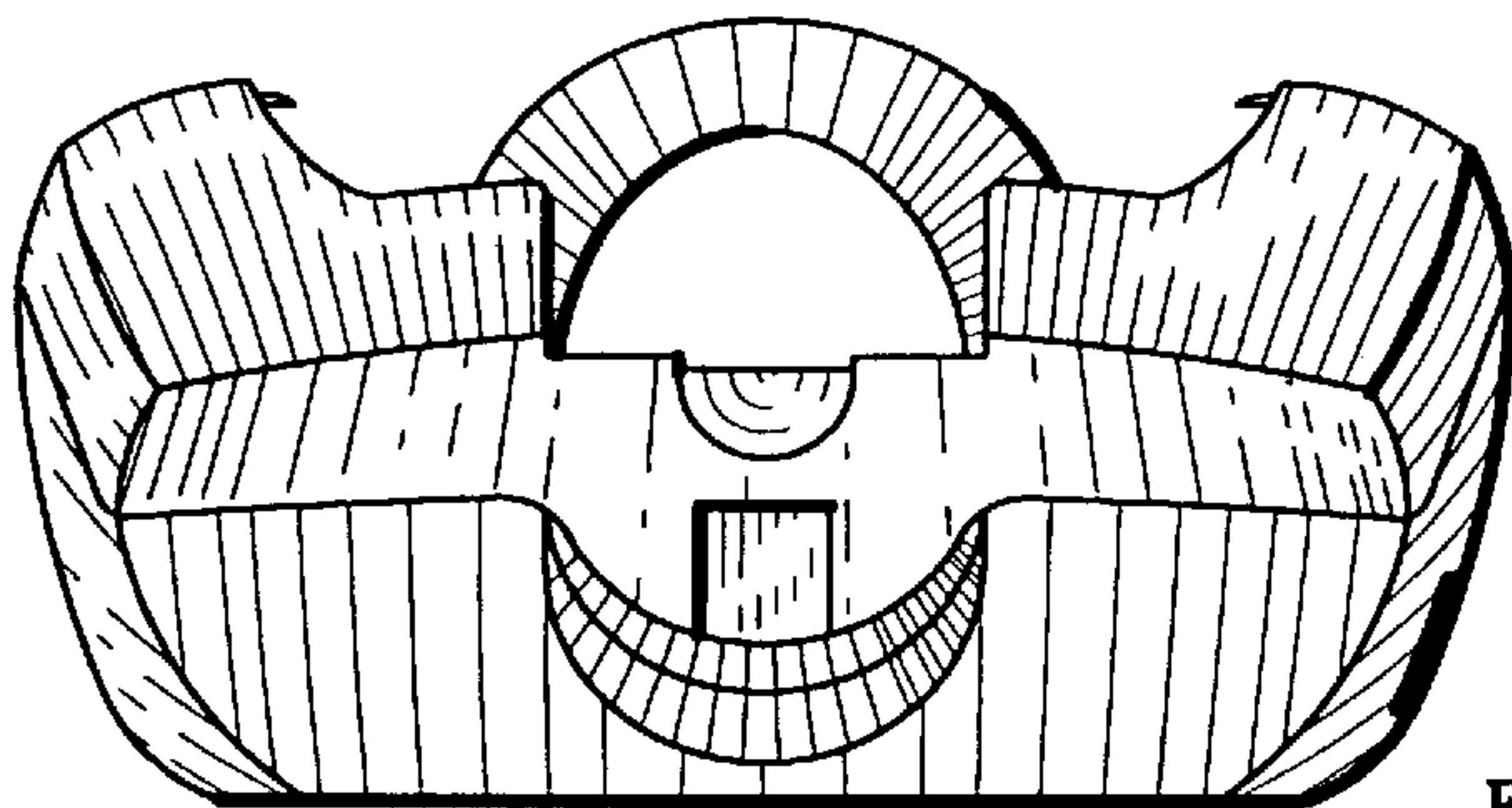

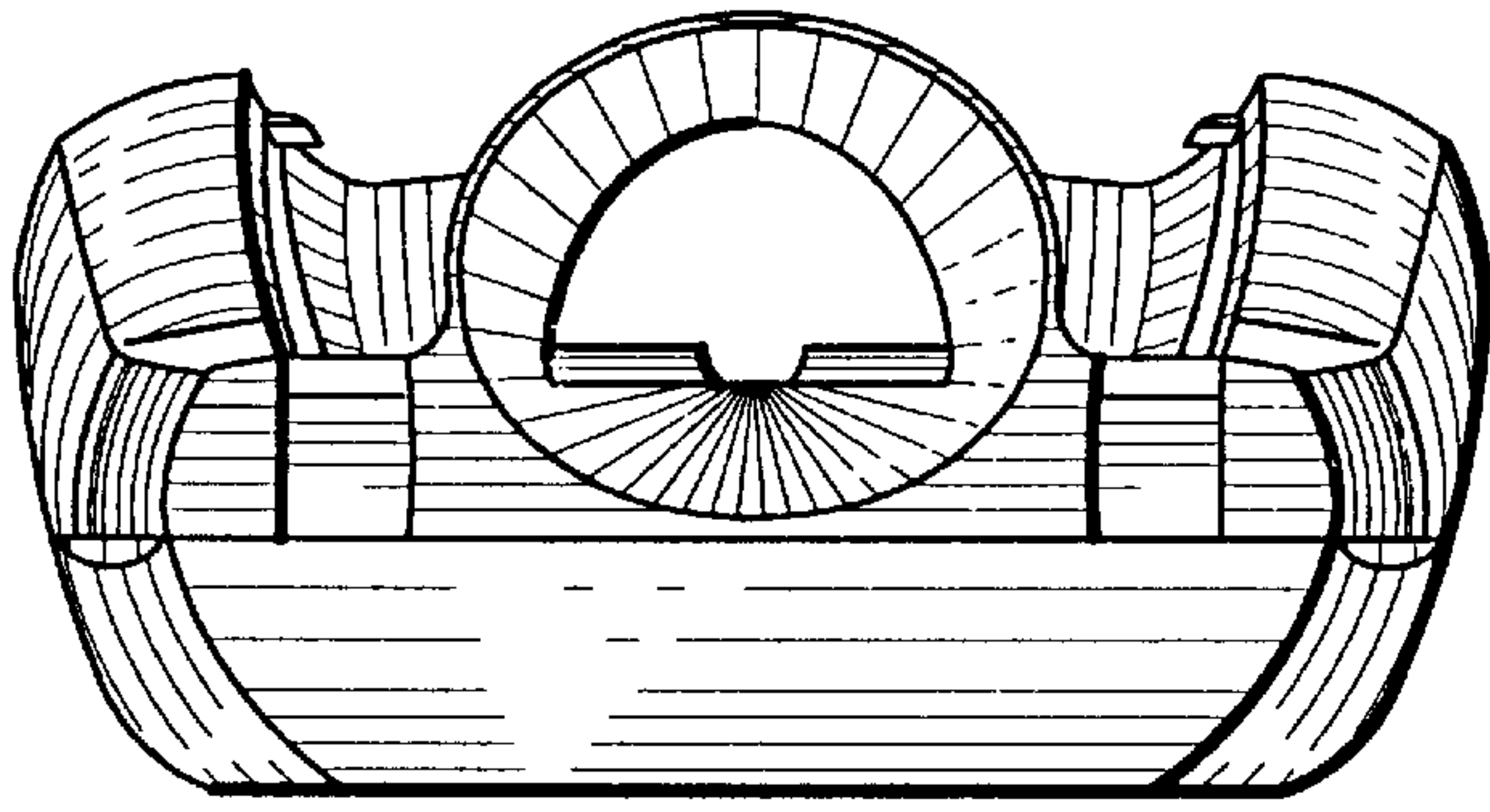

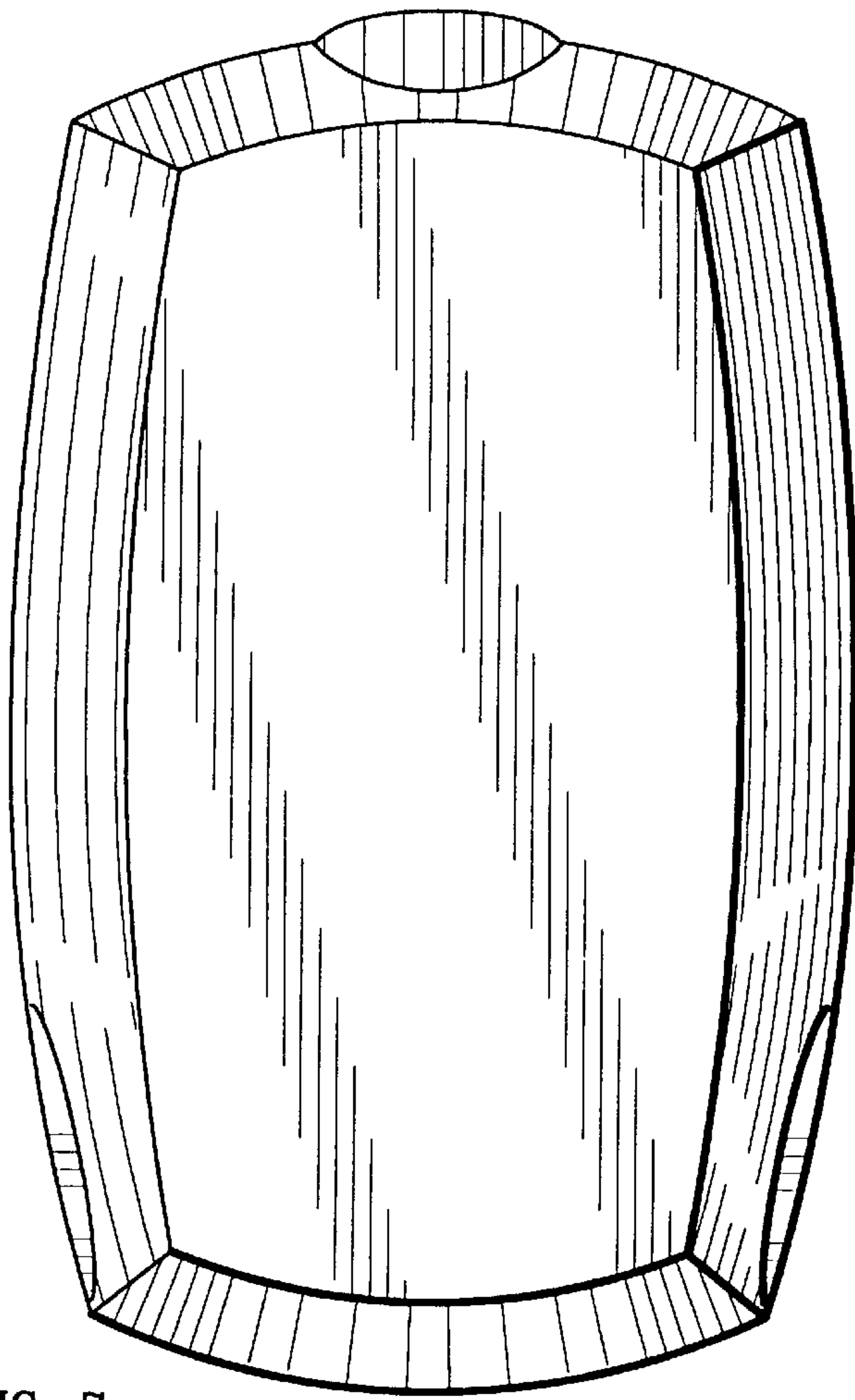

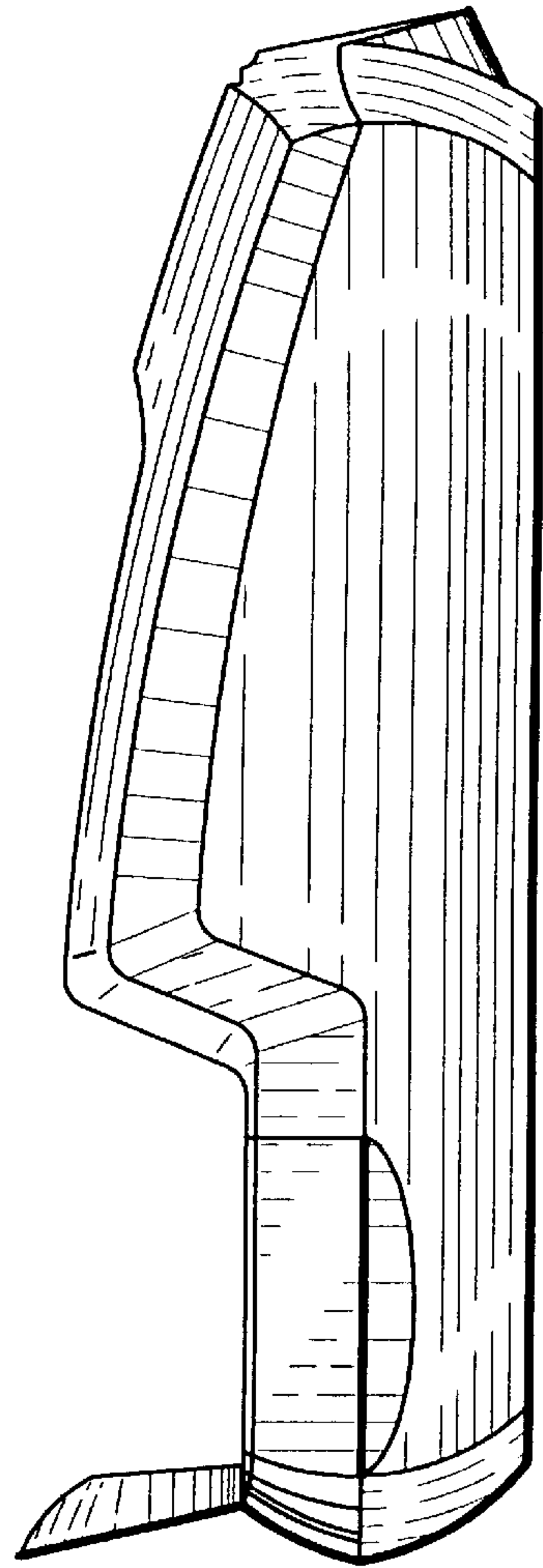

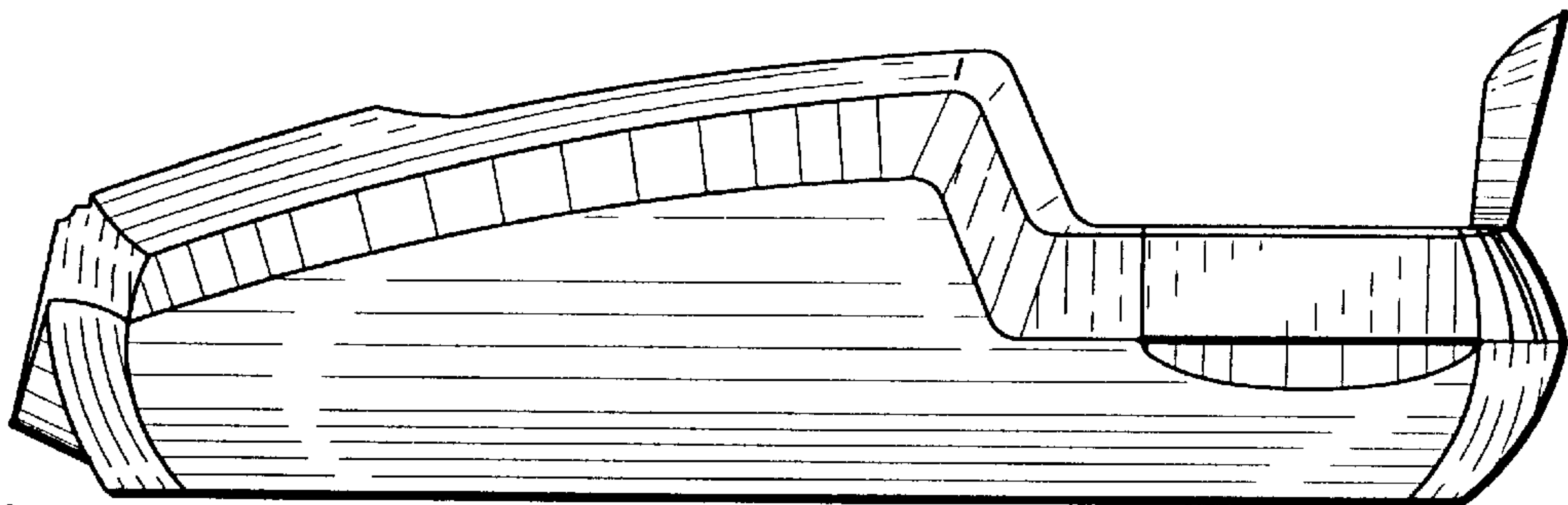
