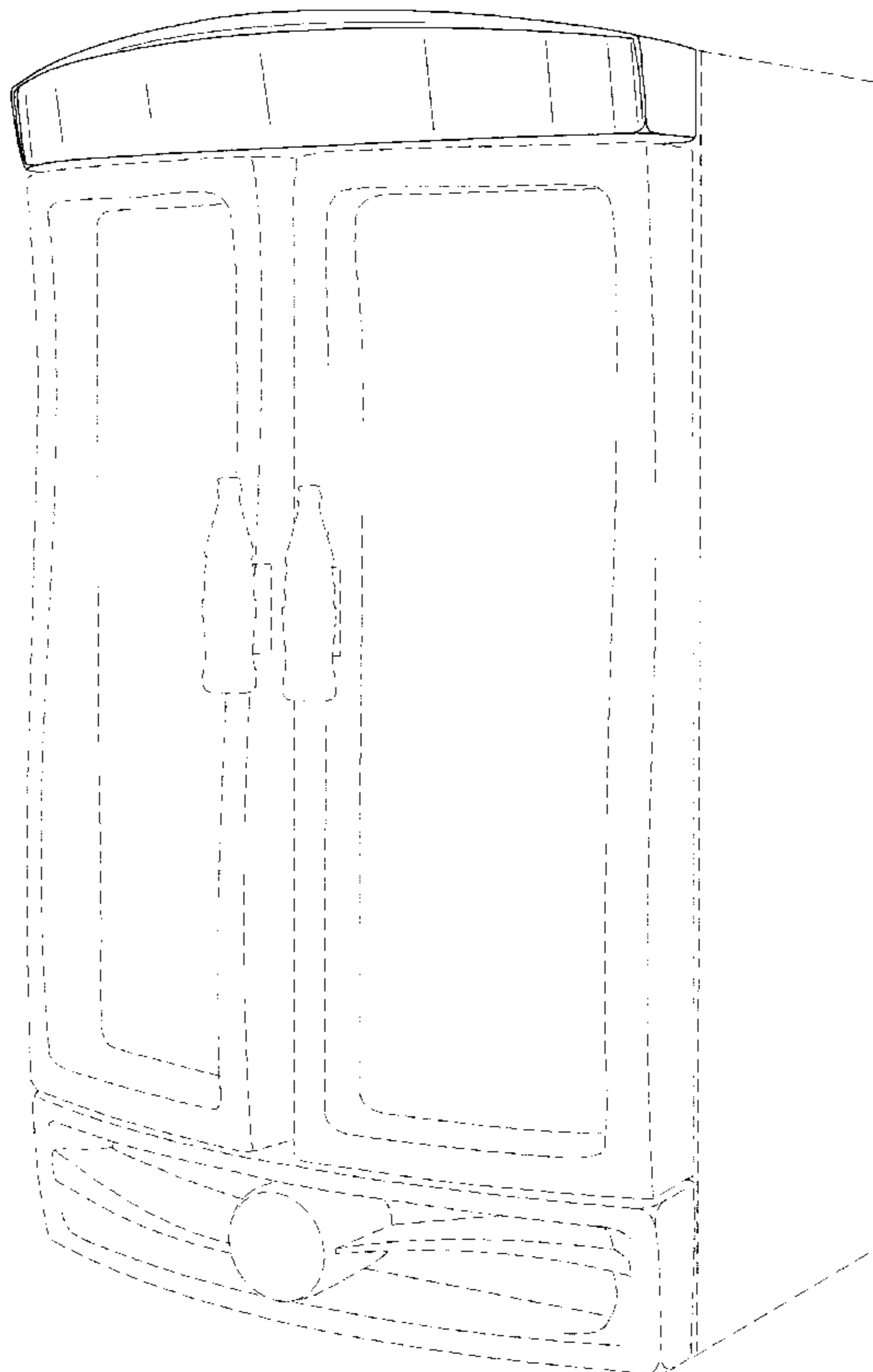
### [57] CLAIM

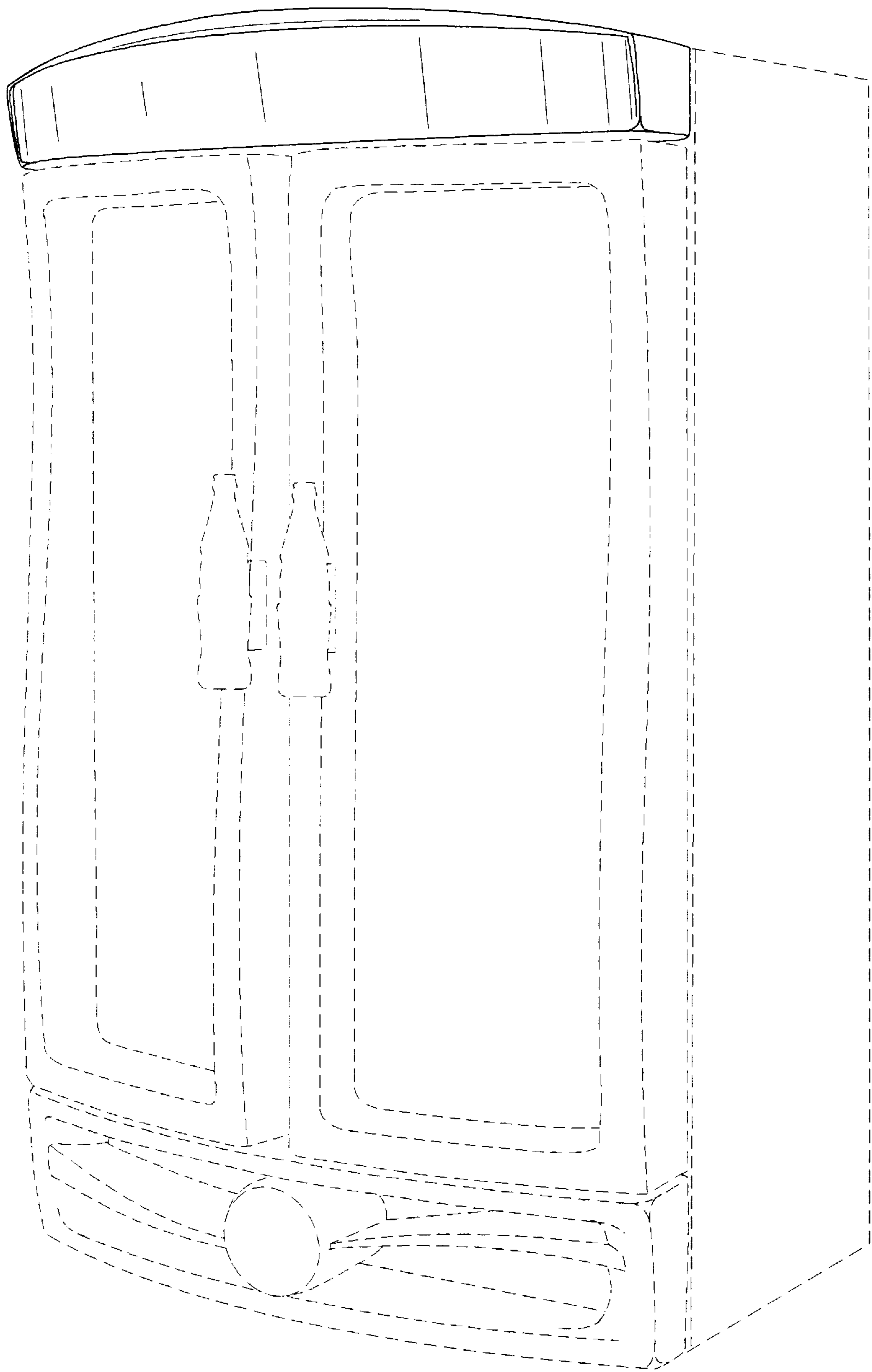
We claim the ornamental design for a cooler, as shown and described.

### DESCRIPTION

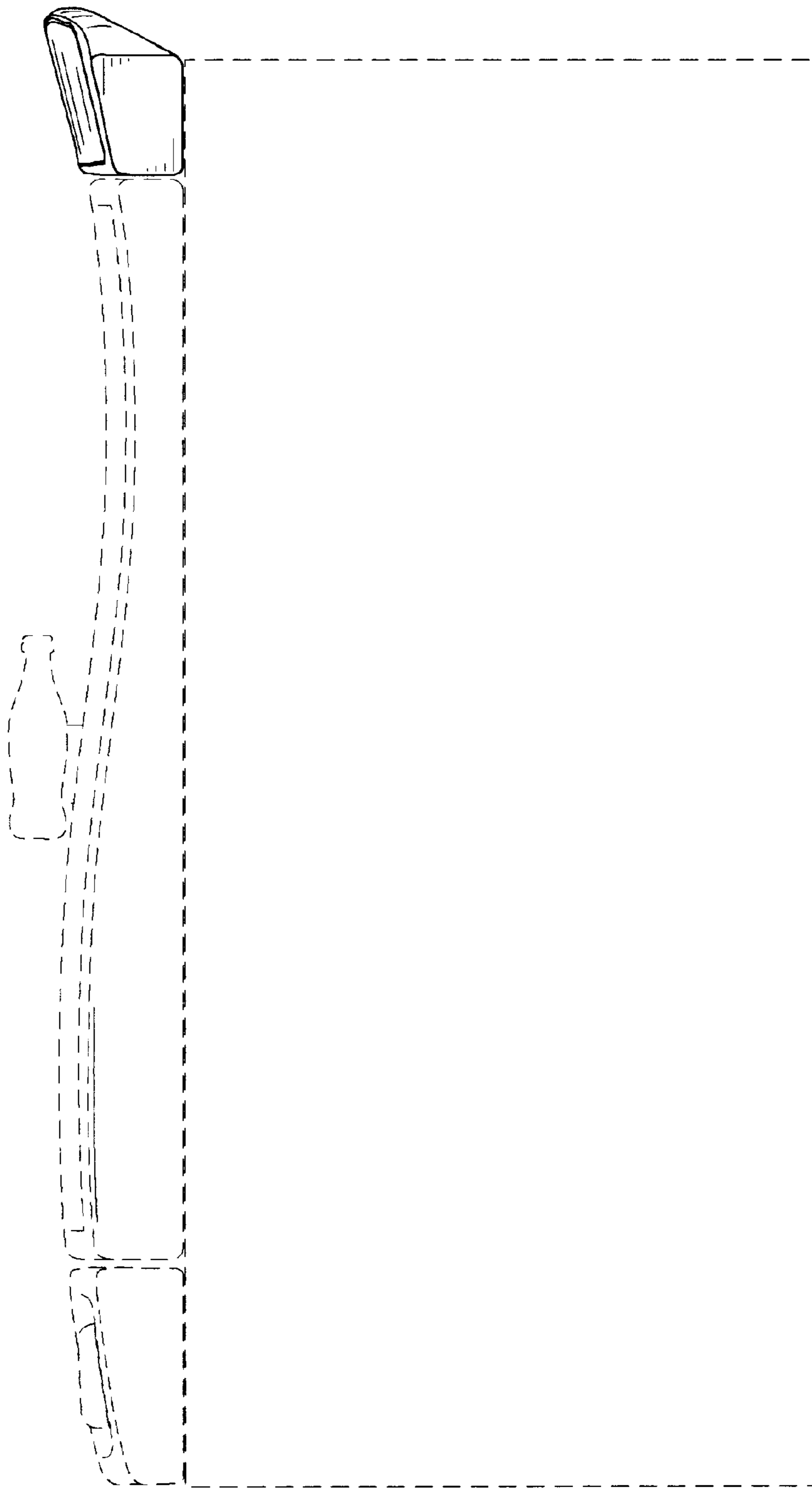
FIG. 1 is a top front right side perspective view of a showing our new design;

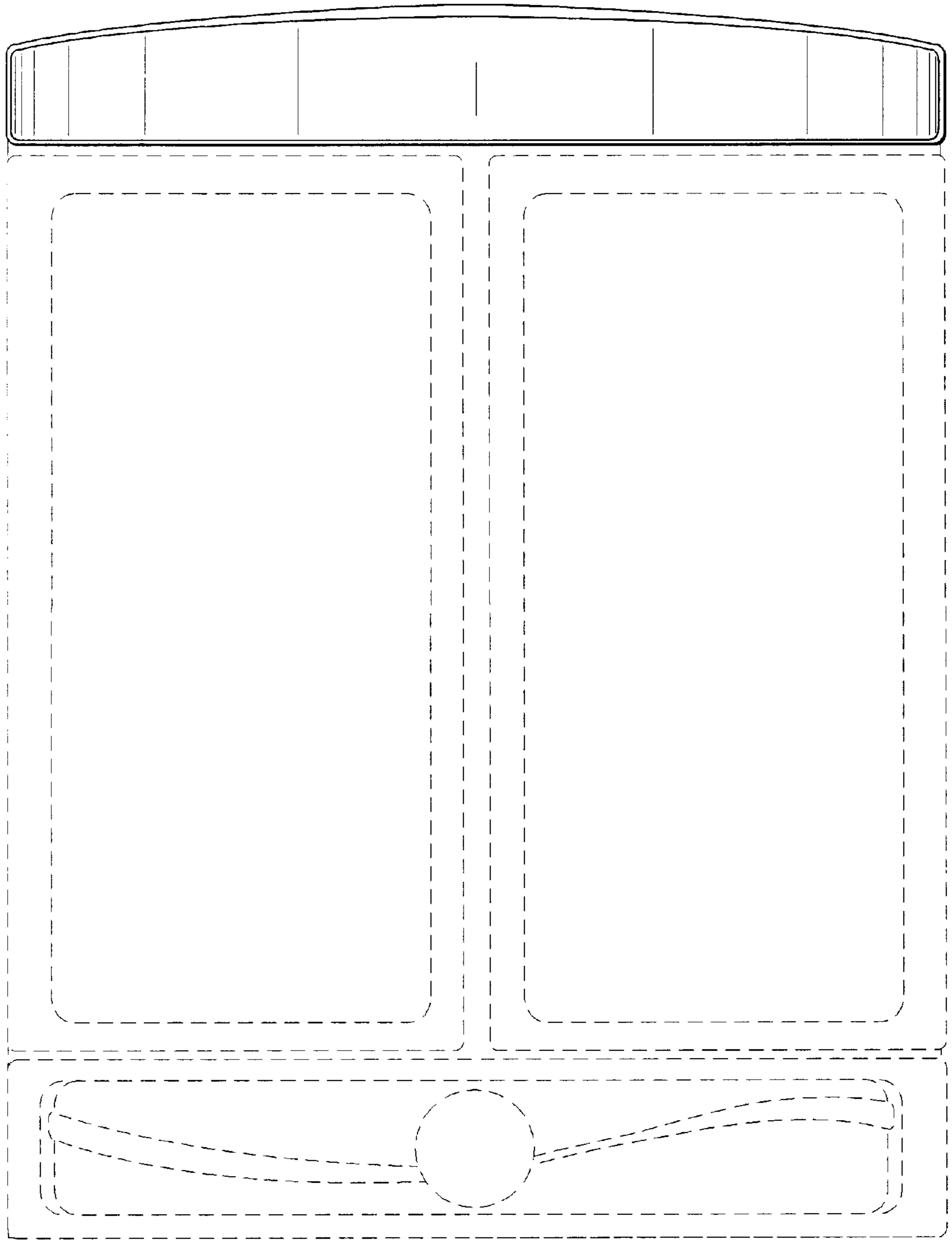




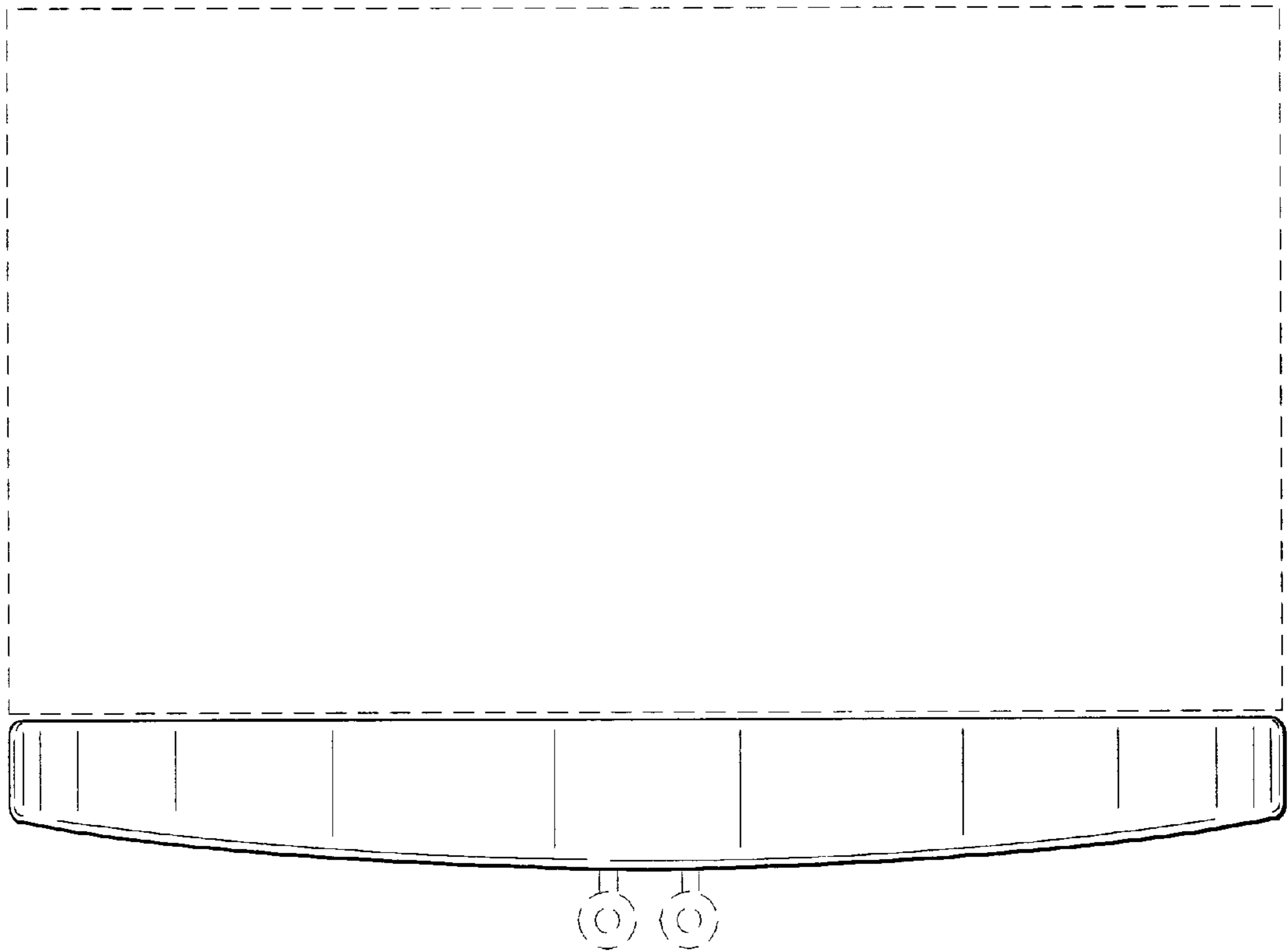
