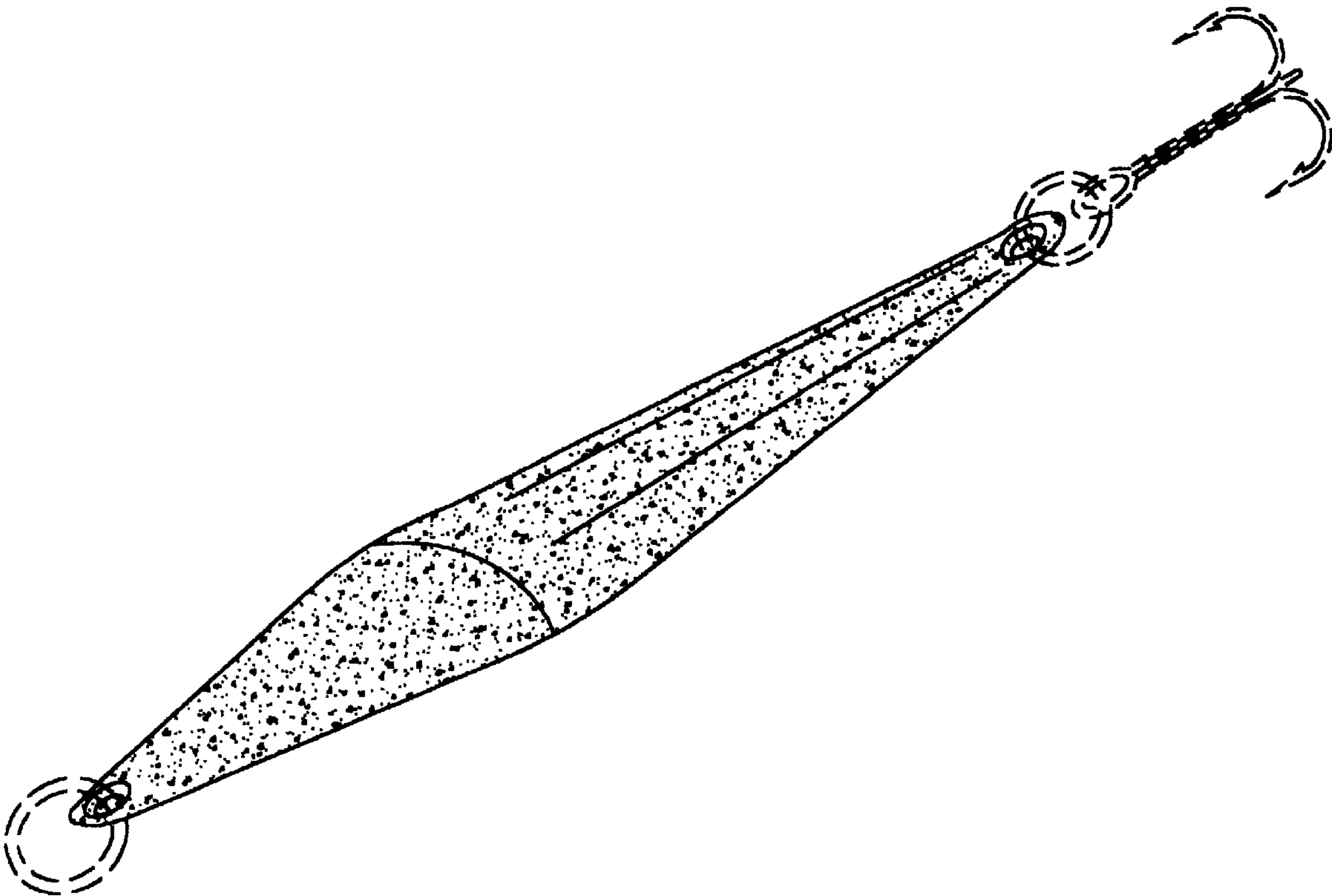

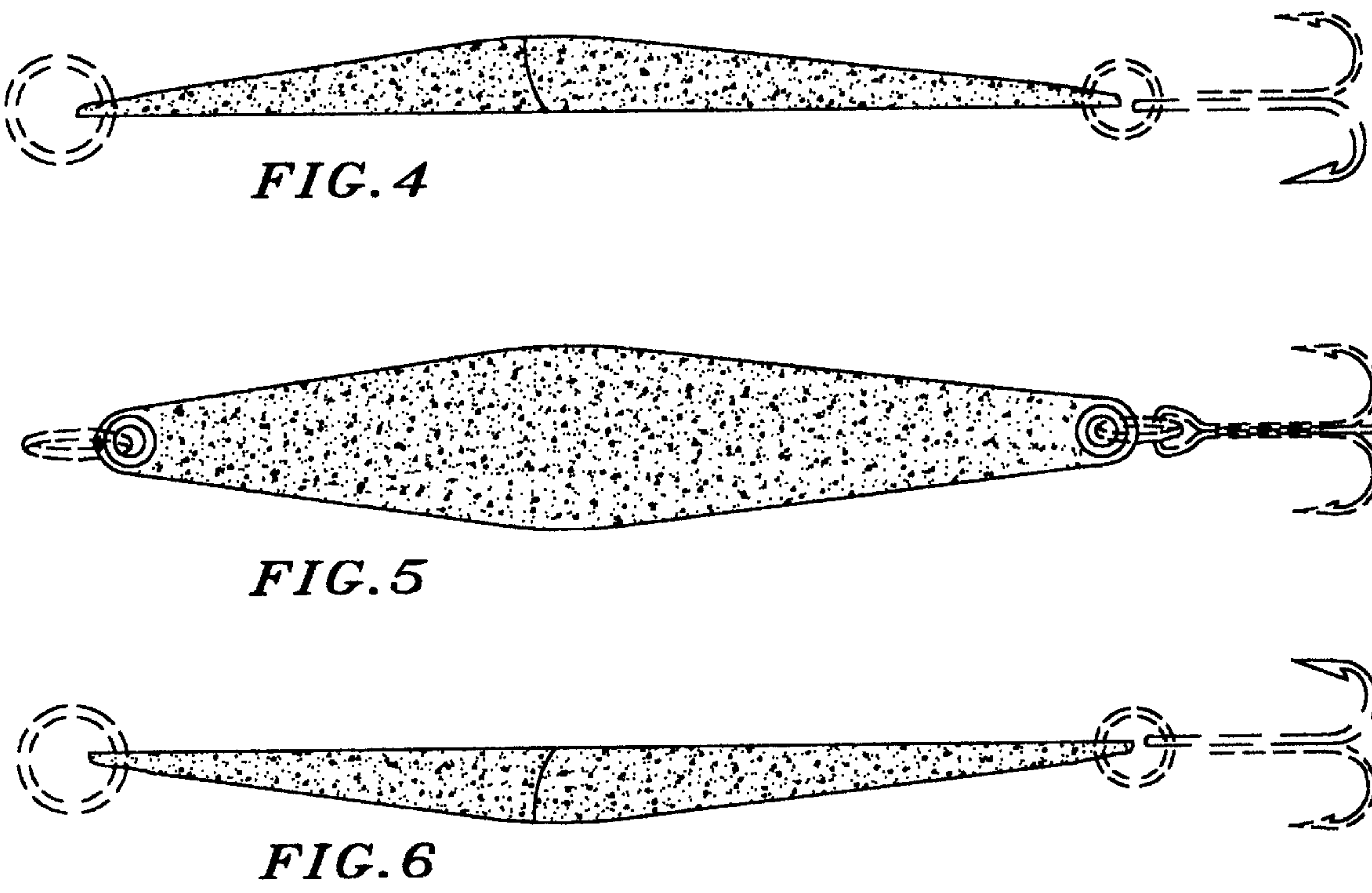
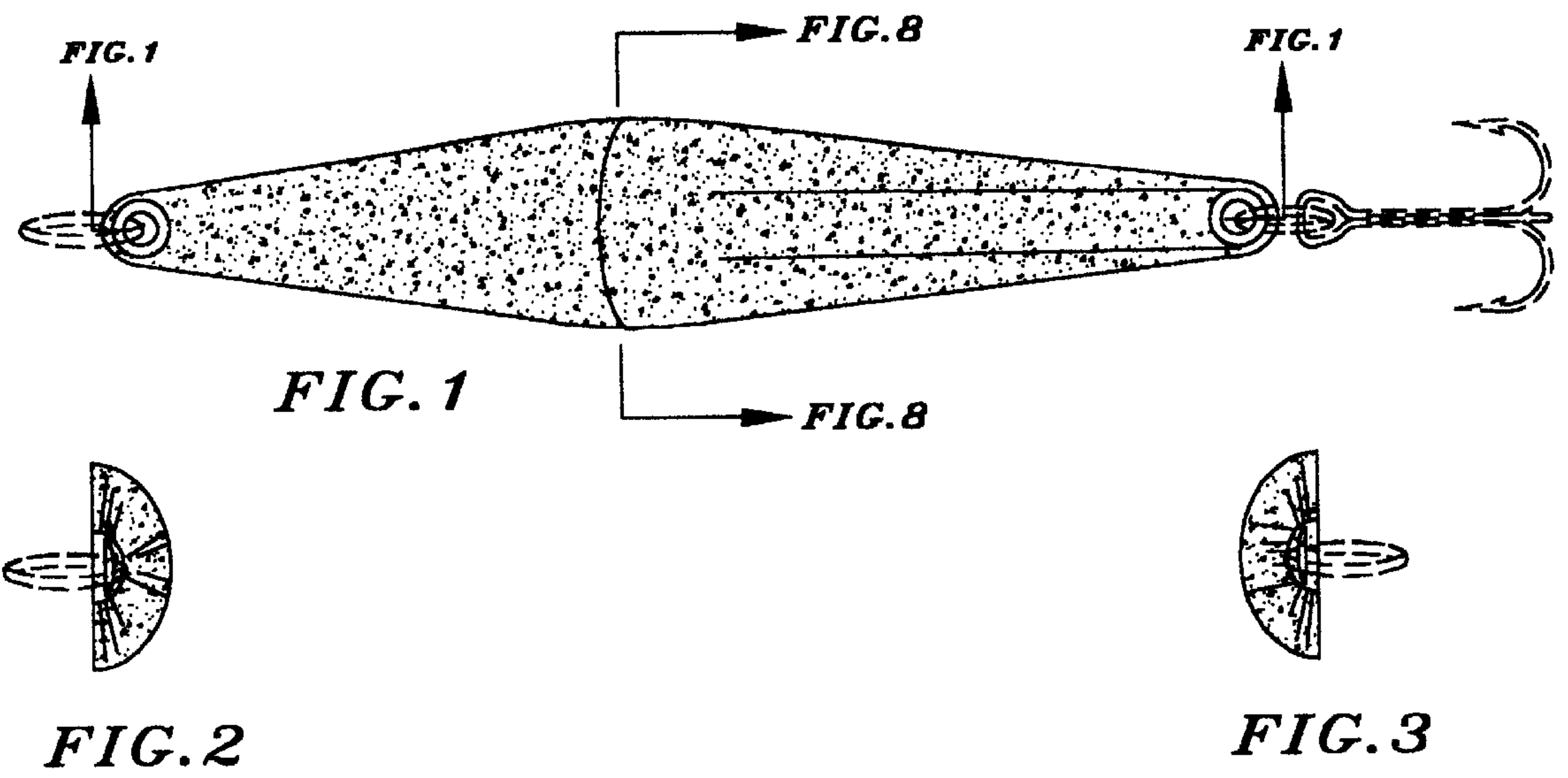

[57] **CLAIM**  
The ornamental design for a fishing lure, as shown and  
described.

**DESCRIPTION**

FIG. 1 is a top plan view of the fishing lure showing my new  
design;  
FIG. 2 is a ring end view thereof;  
FIG. 3 is a hook end view thereof;  
FIG. 4 is a side view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is an opposite side view thereof;  
FIG. 7 is a cross-sectional view thereof taken along the line  
7—7 in FIG. 1;  
FIG. 8 is a cross-sectional view thereof taken along the line  
8—8 in FIG. 1;  
FIG. 9 is a top perspective view thereof;  
FIG. 10 is a top perspective view of a fishing lure showing  
a second embodiment of my new design the sole difference  
being in the surface texture; and,  
FIG. 11 is a top plan view of FIG. 10.  
The broken line showing of the ring and hook in the Figures  
is for illustrative purposes only and forms no part of the  
claimed design.

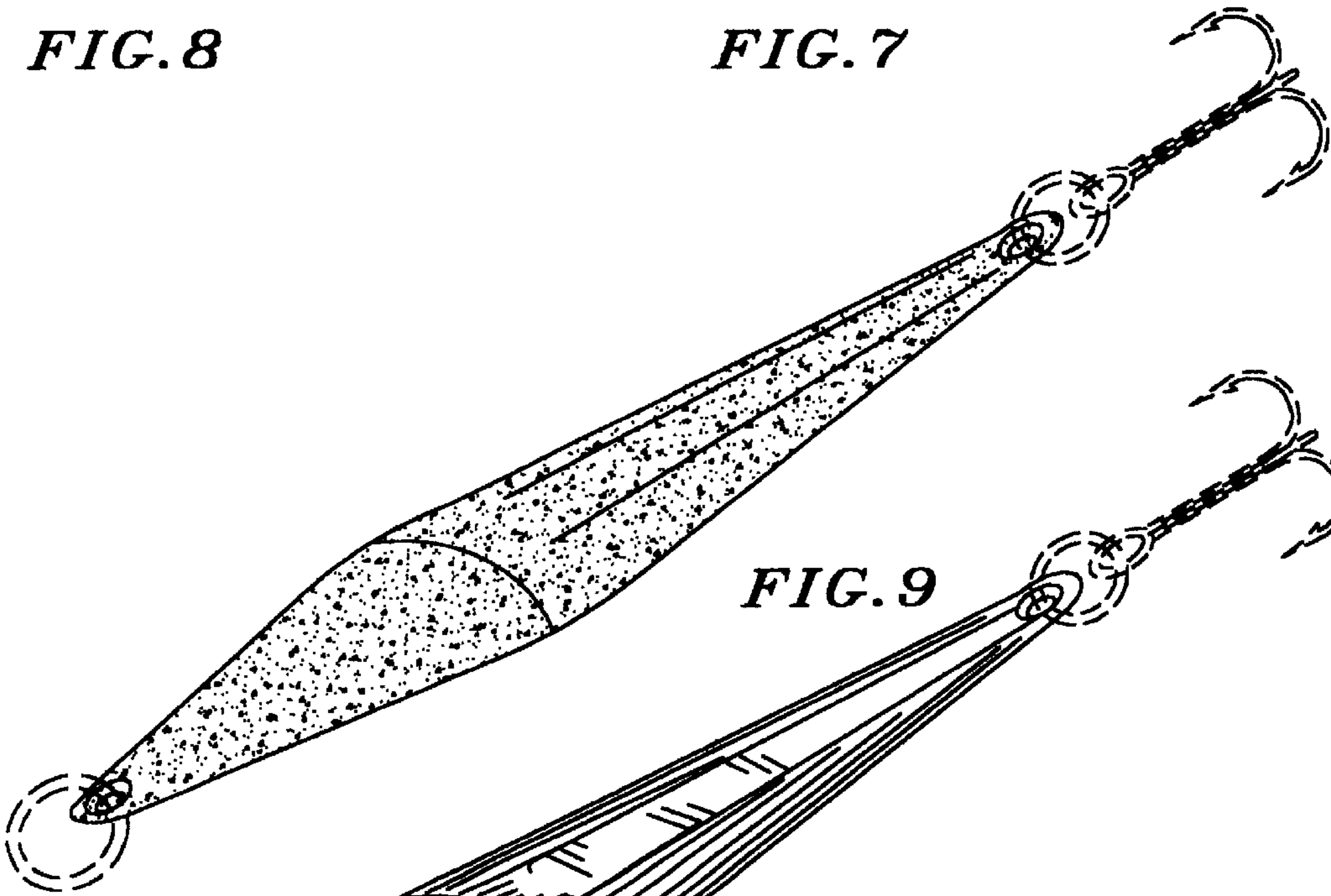




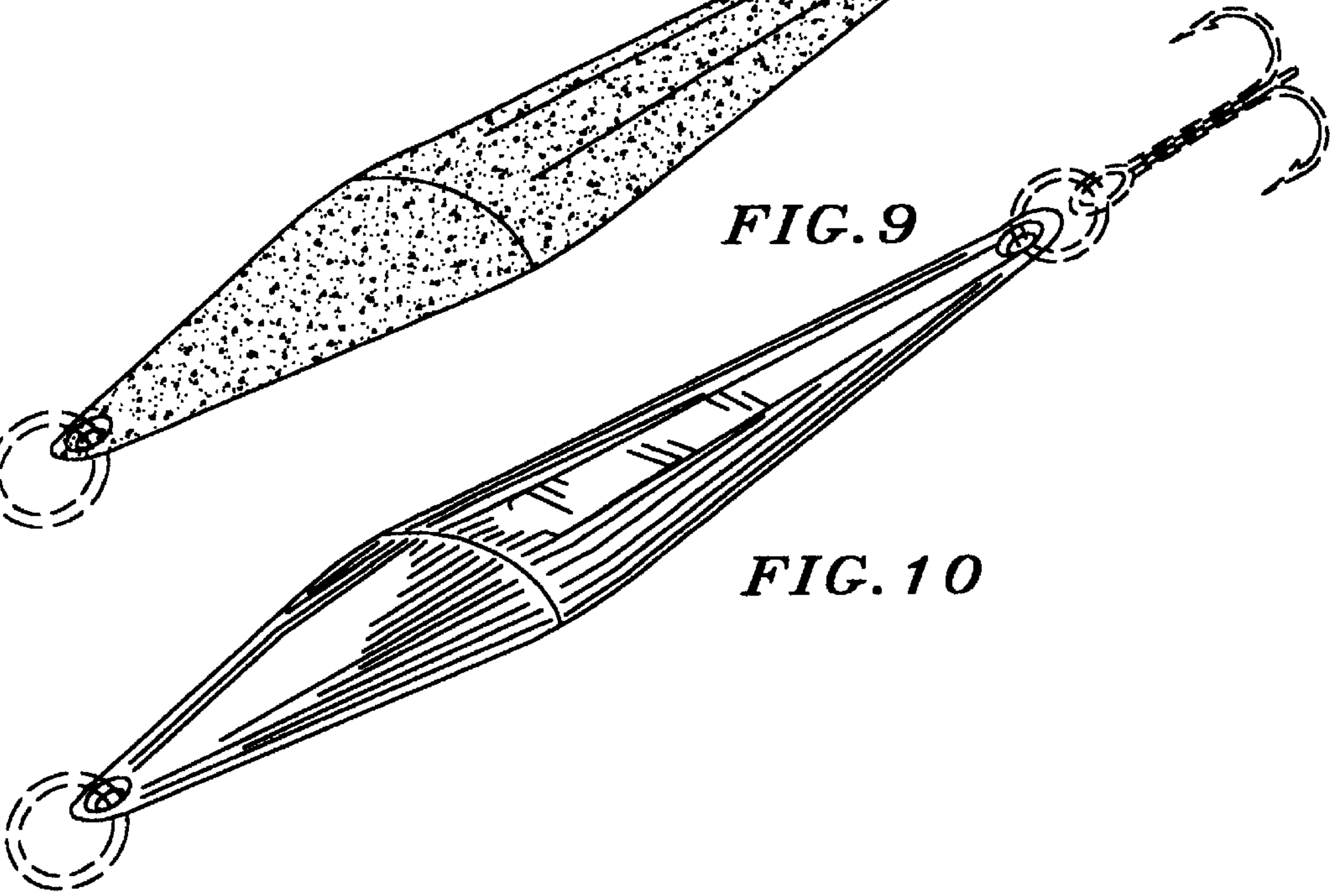

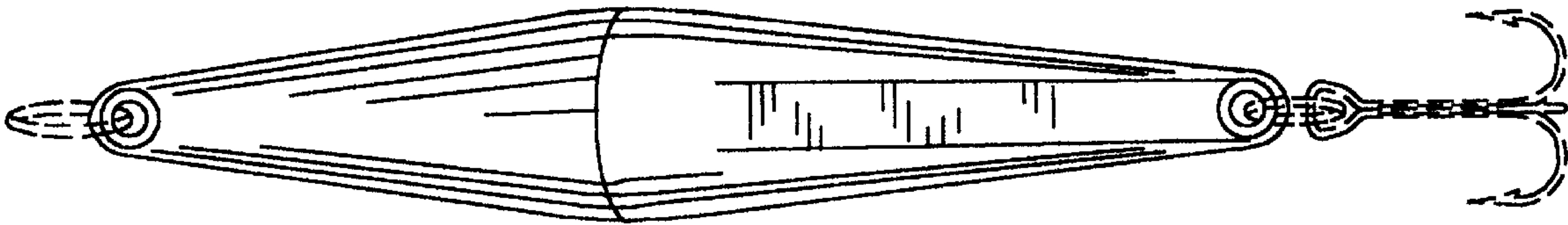
