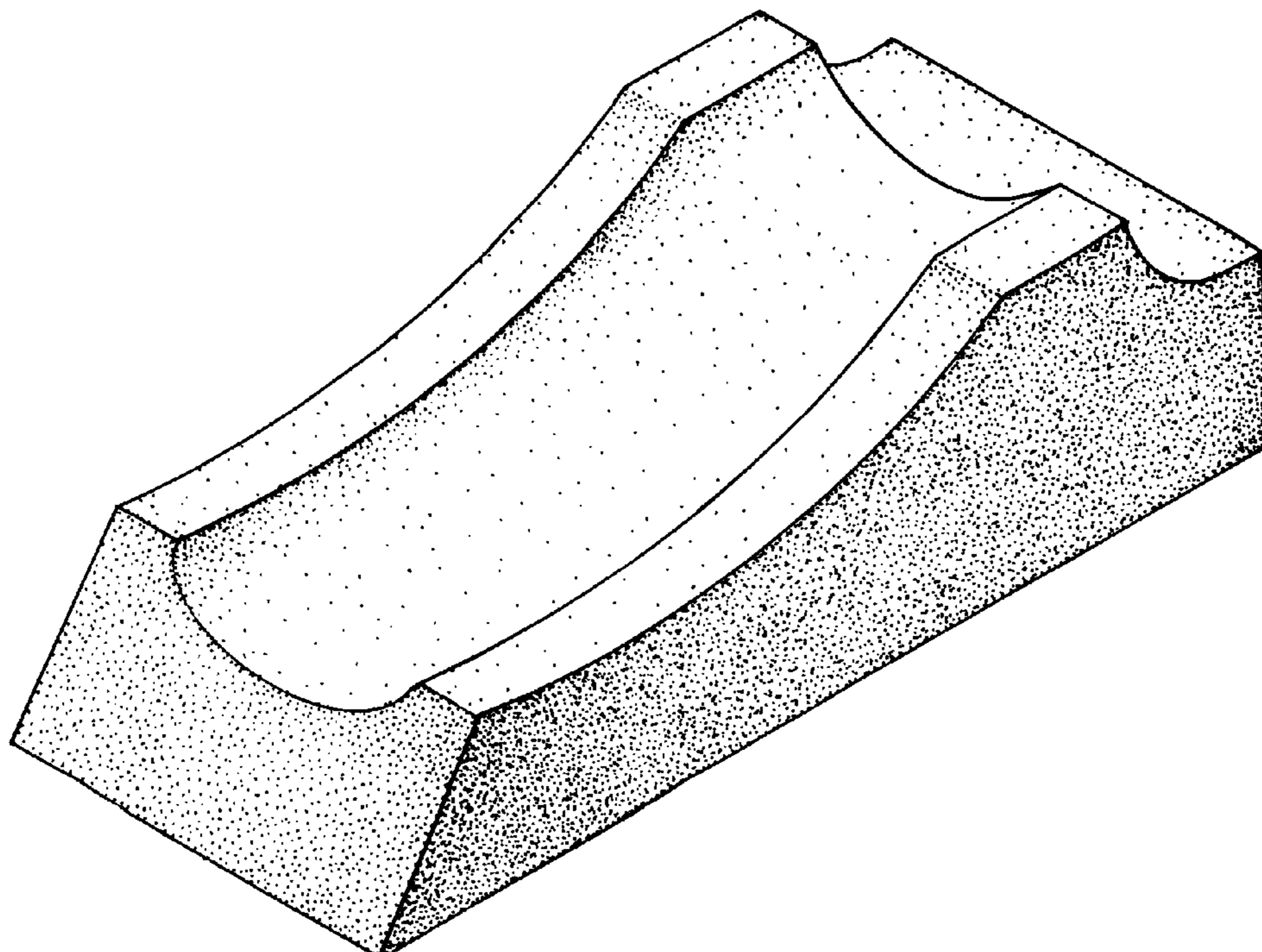
The right side of the therapeutic post-operative leg elevator is a mirror image of the left side illustrated in FIG. 1.

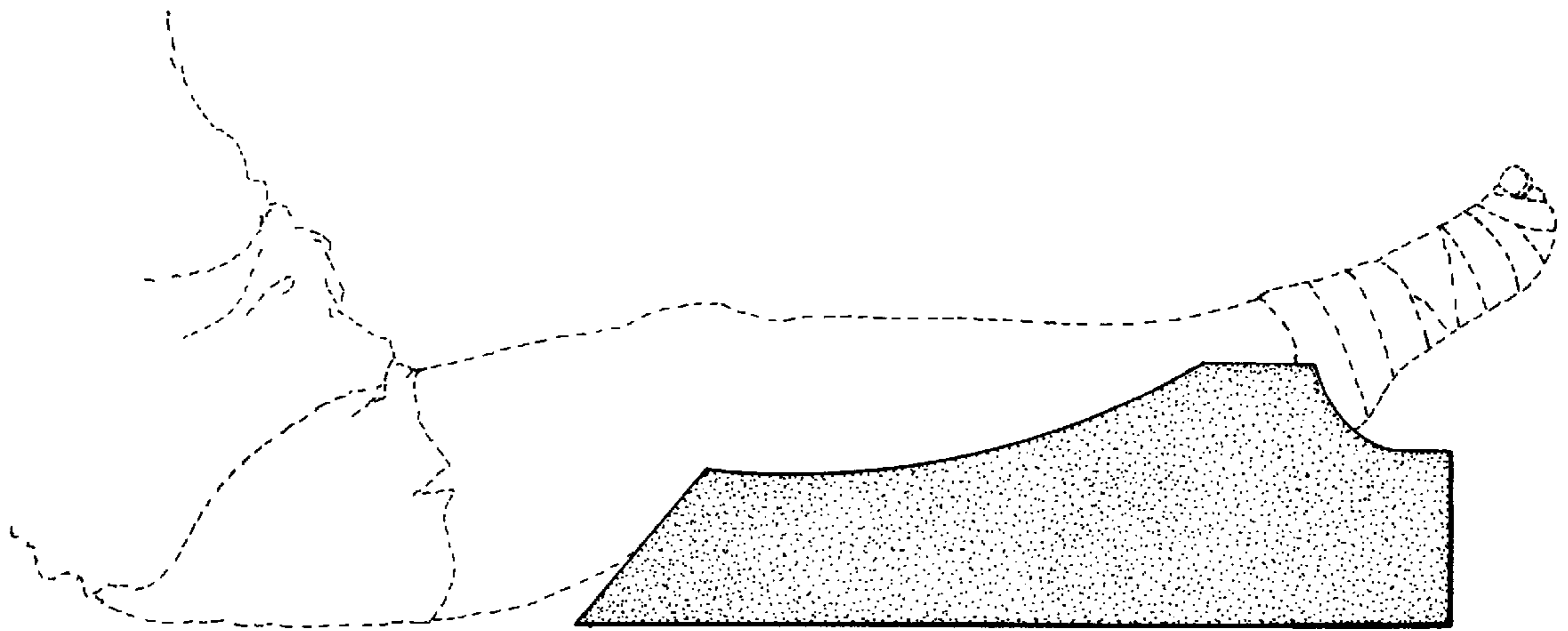

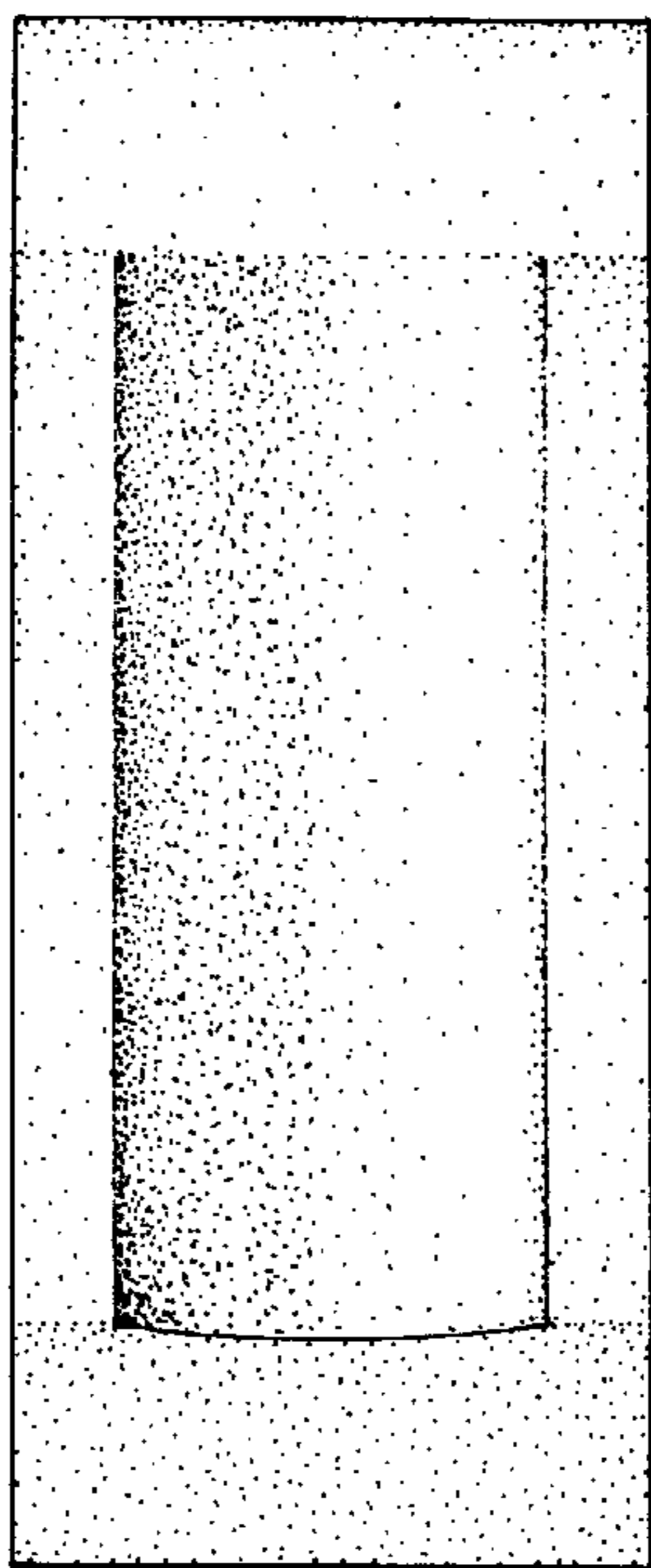

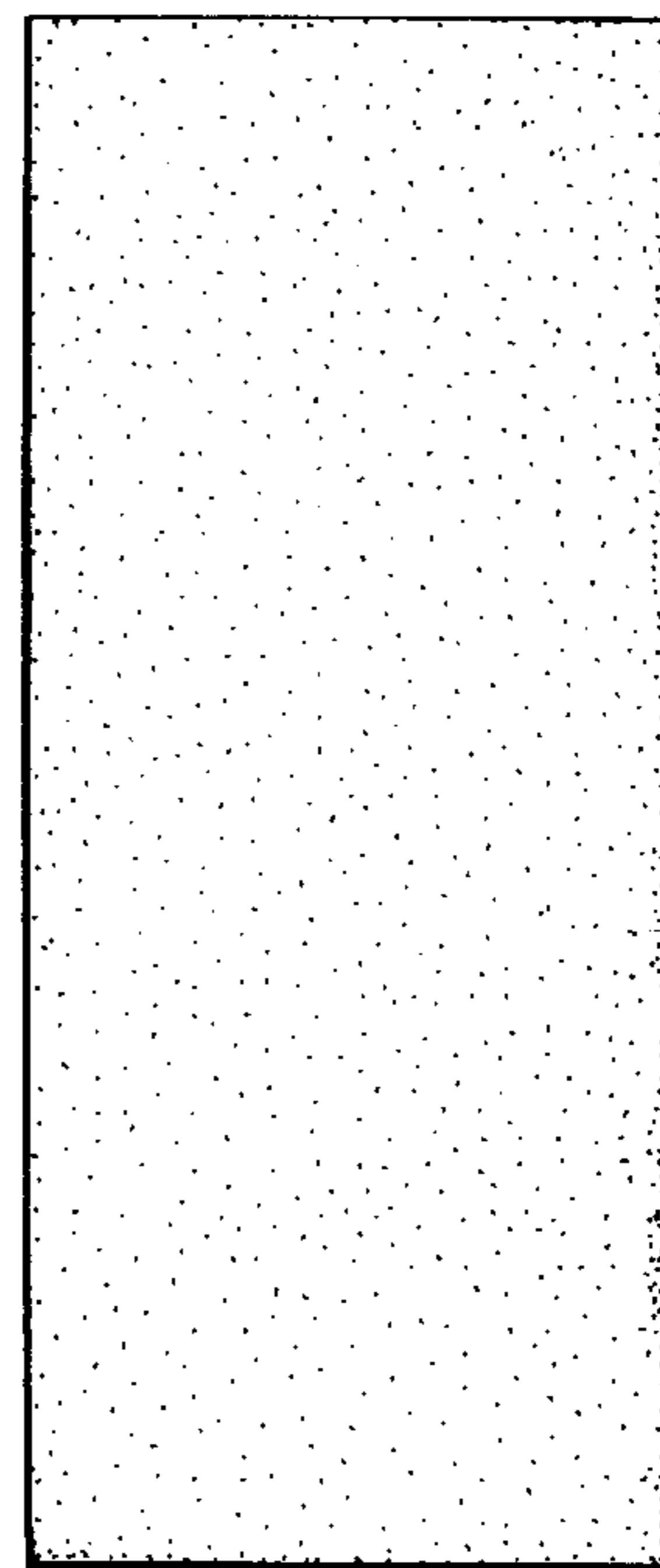

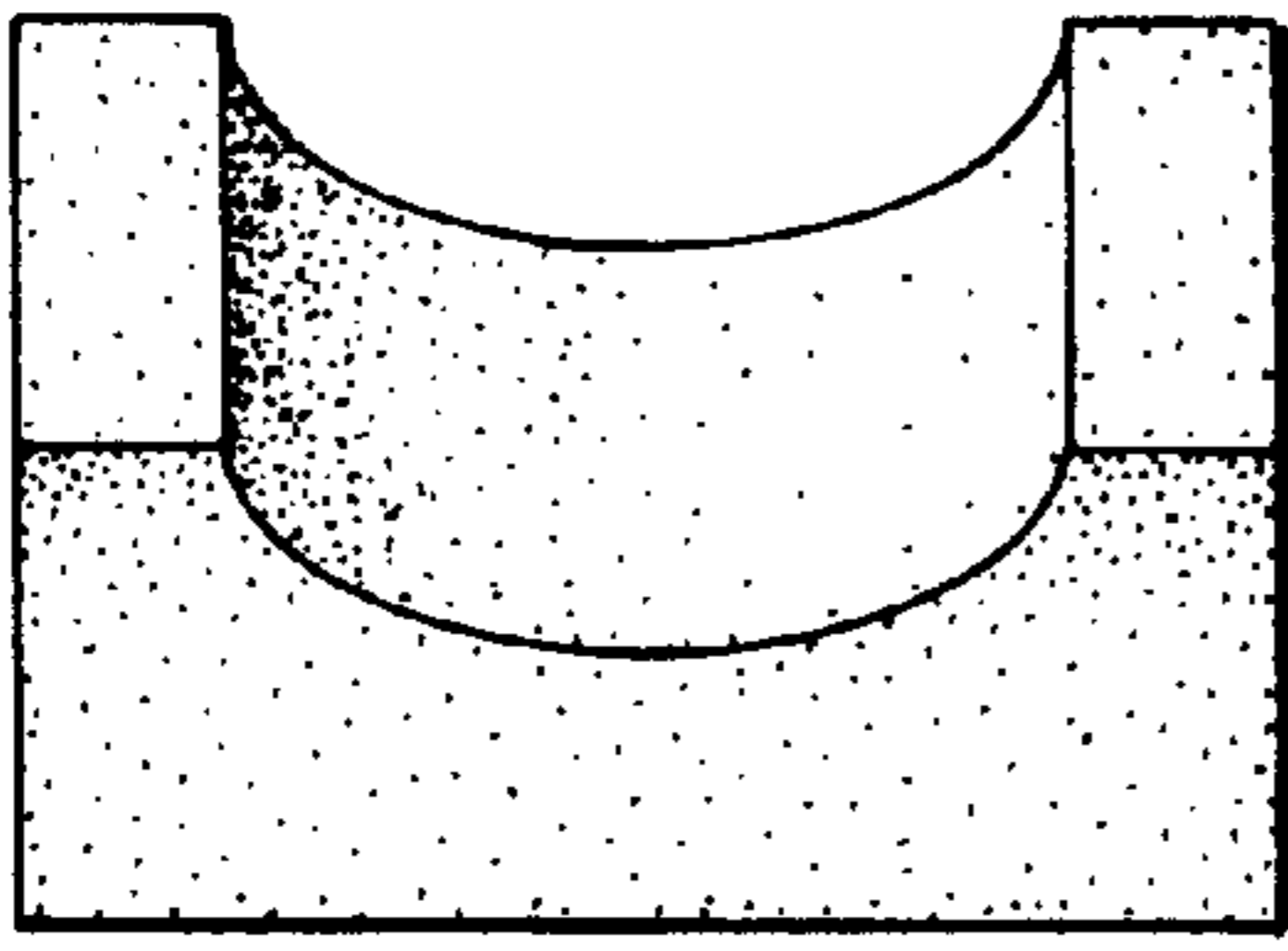

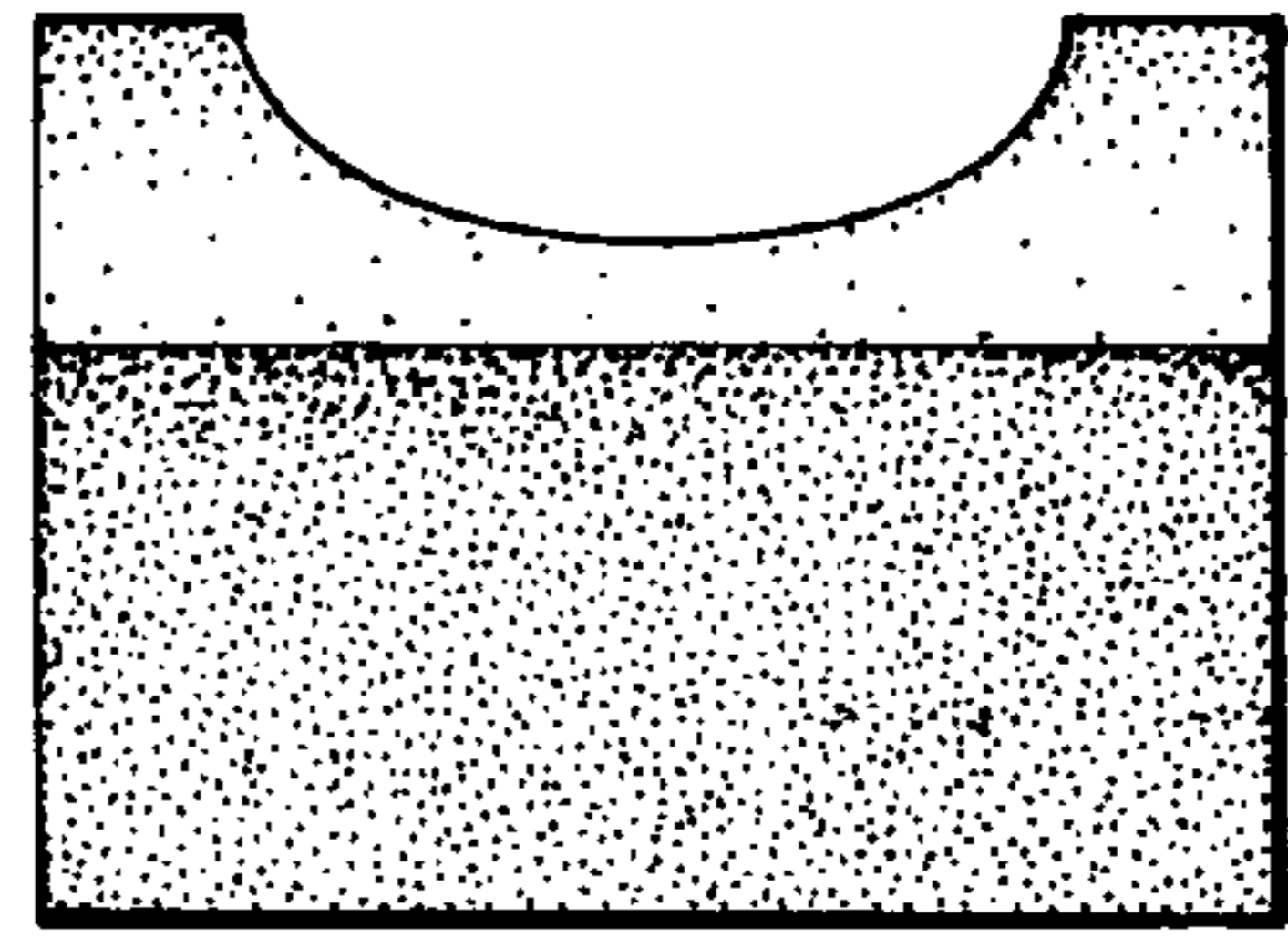

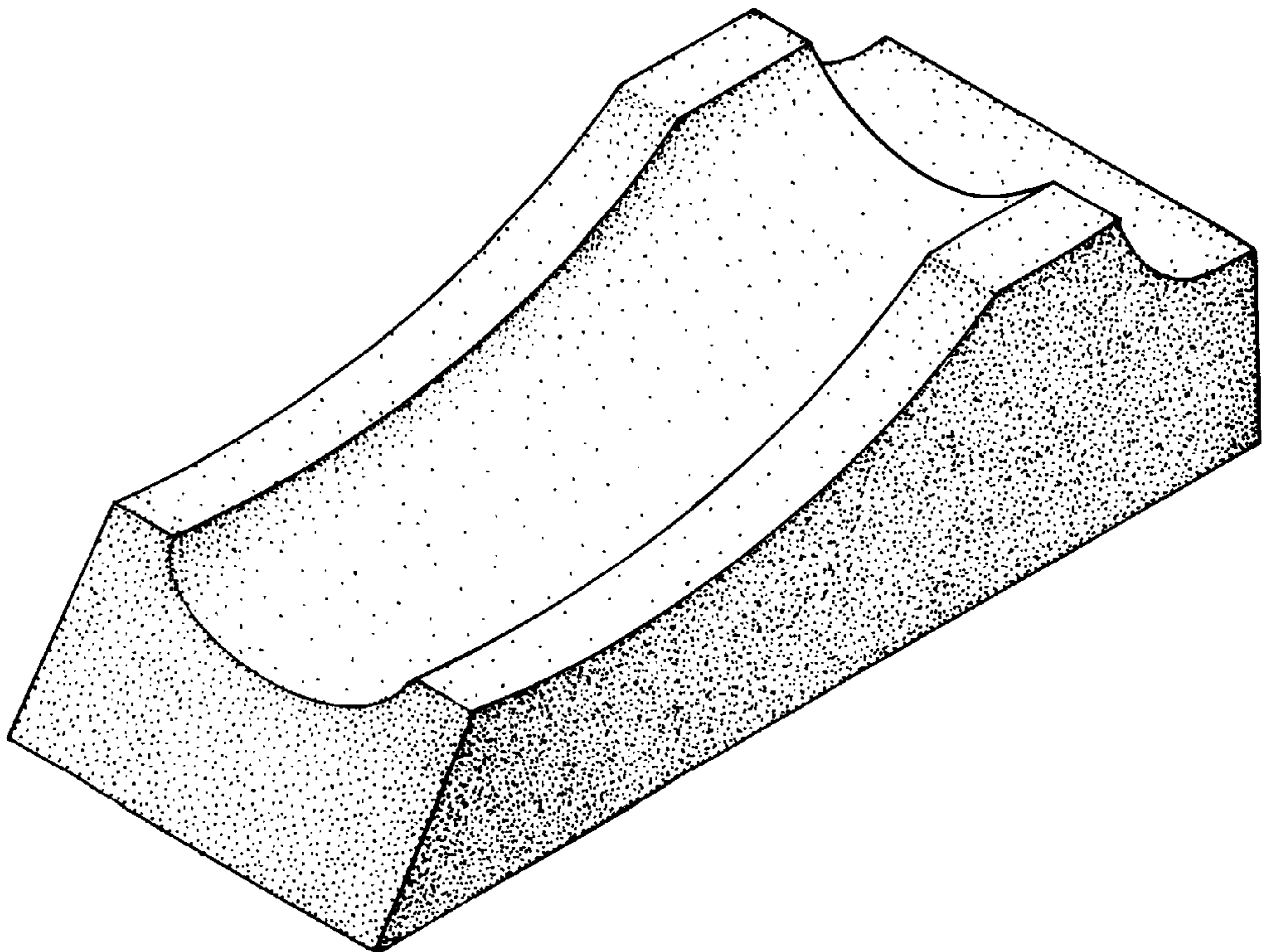
