[57] CLAIM

The ornamental design for a materials handling and maintenance vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a side elevational view of our new design showing the right side of the vehicle with a load tray and rail guide mechanism attached;

FIG. 2 is a right side elevation view of the design of FIG. 1 with an operator's platform in the raised position;

FIG. 3 is a plan view of the design of FIG. 1;

FIG. 4 is a front elevational view of the design of FIG. 1; and,

FIG. 5 is a rear elevational view of the design of FIG. 1.

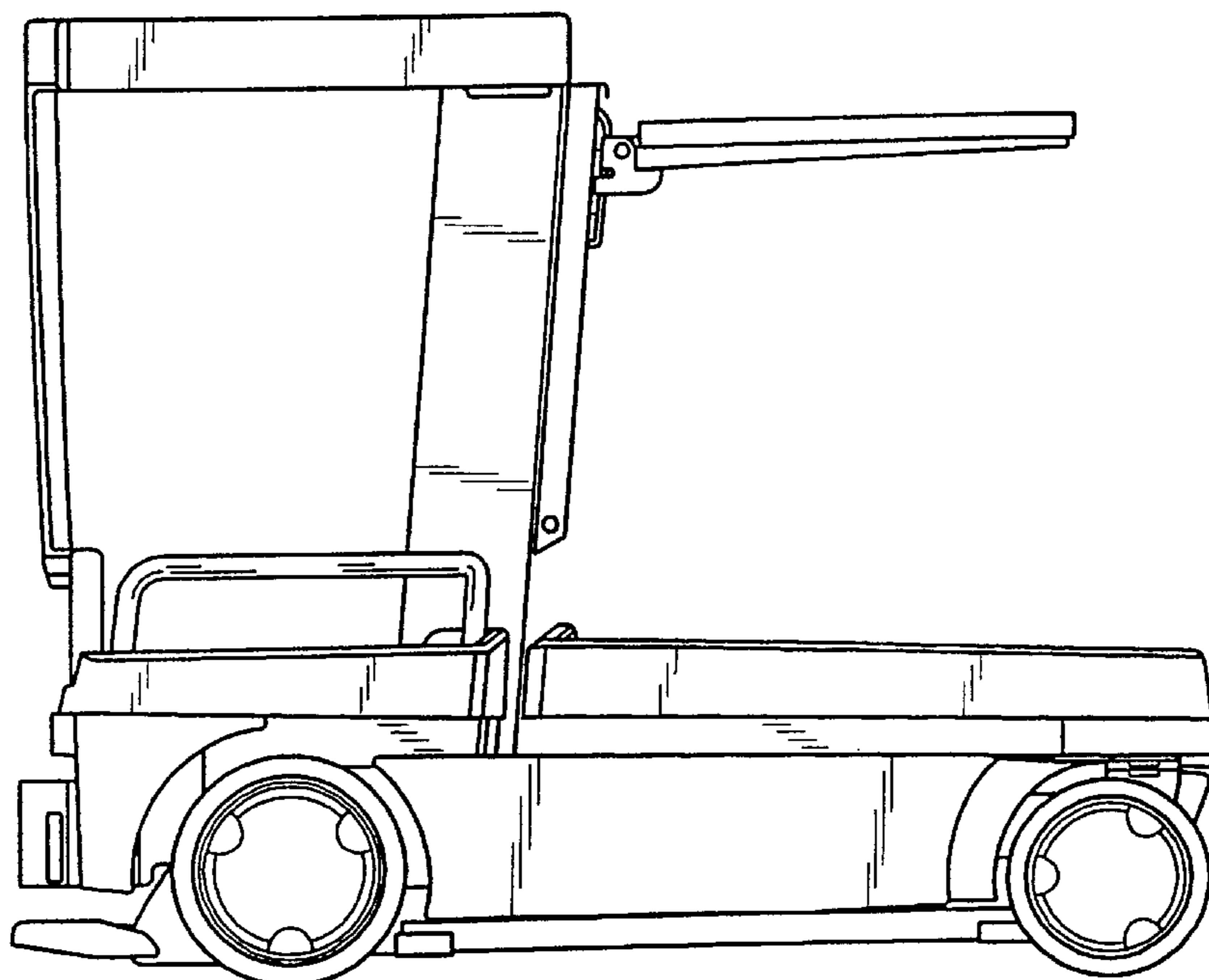

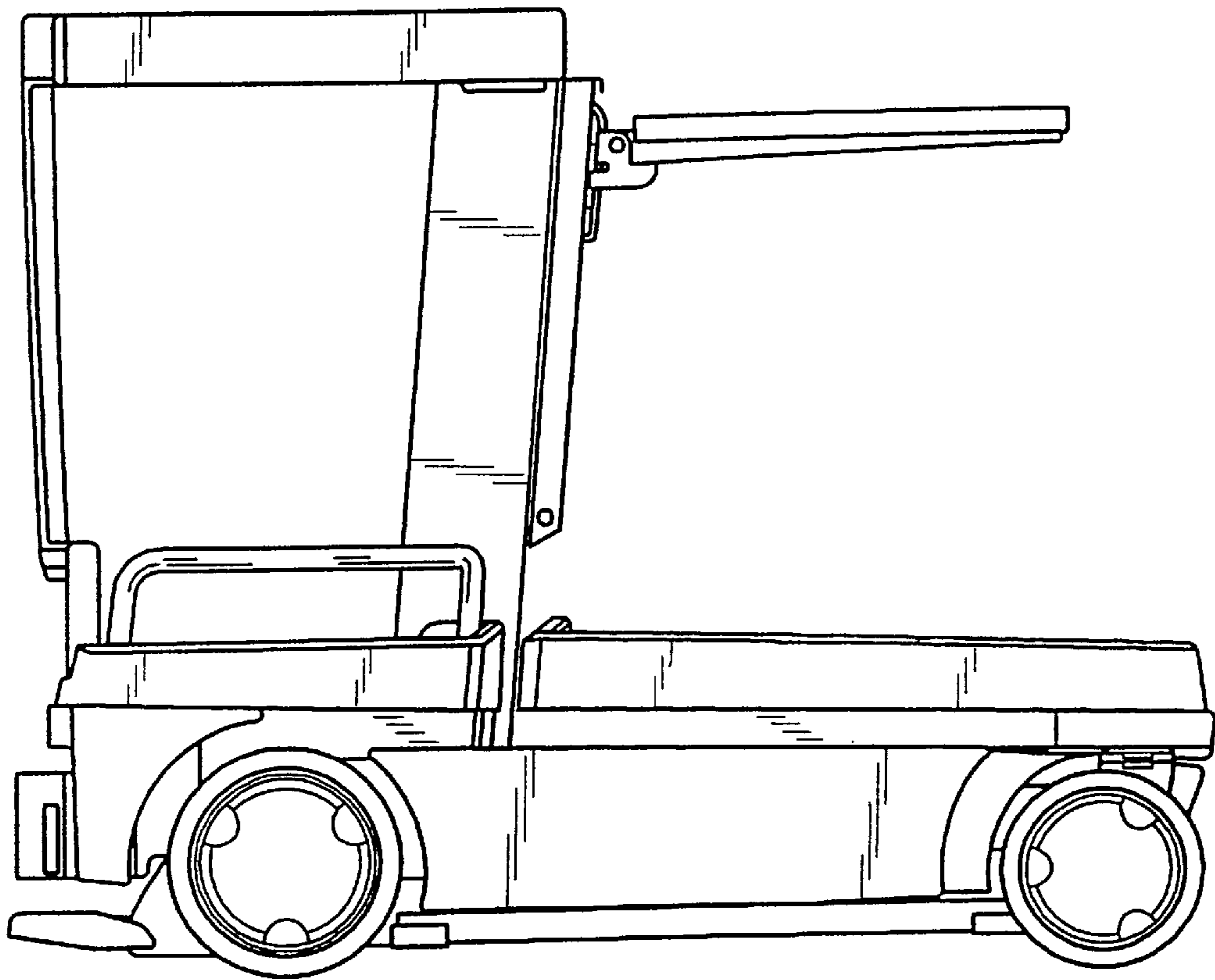

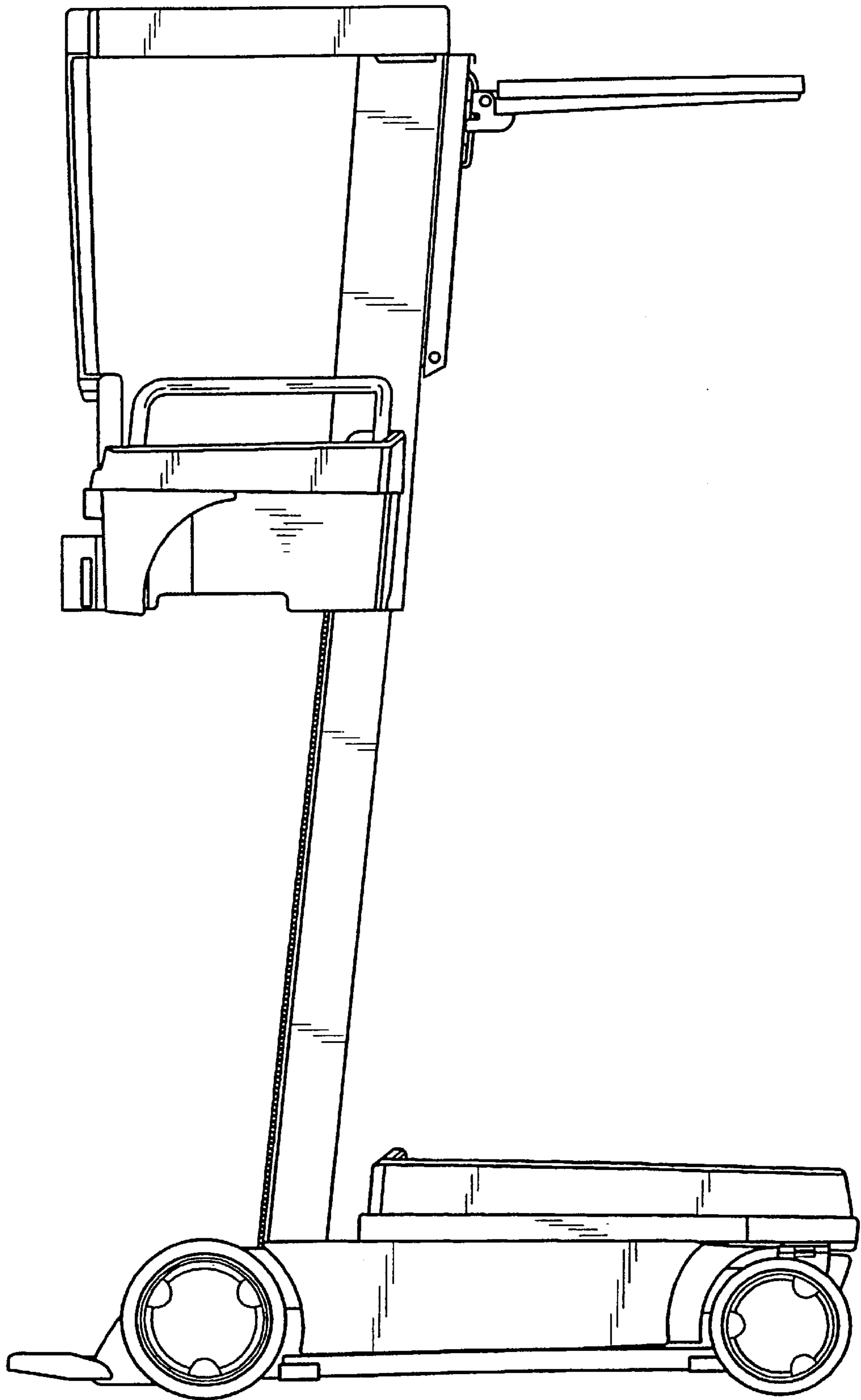

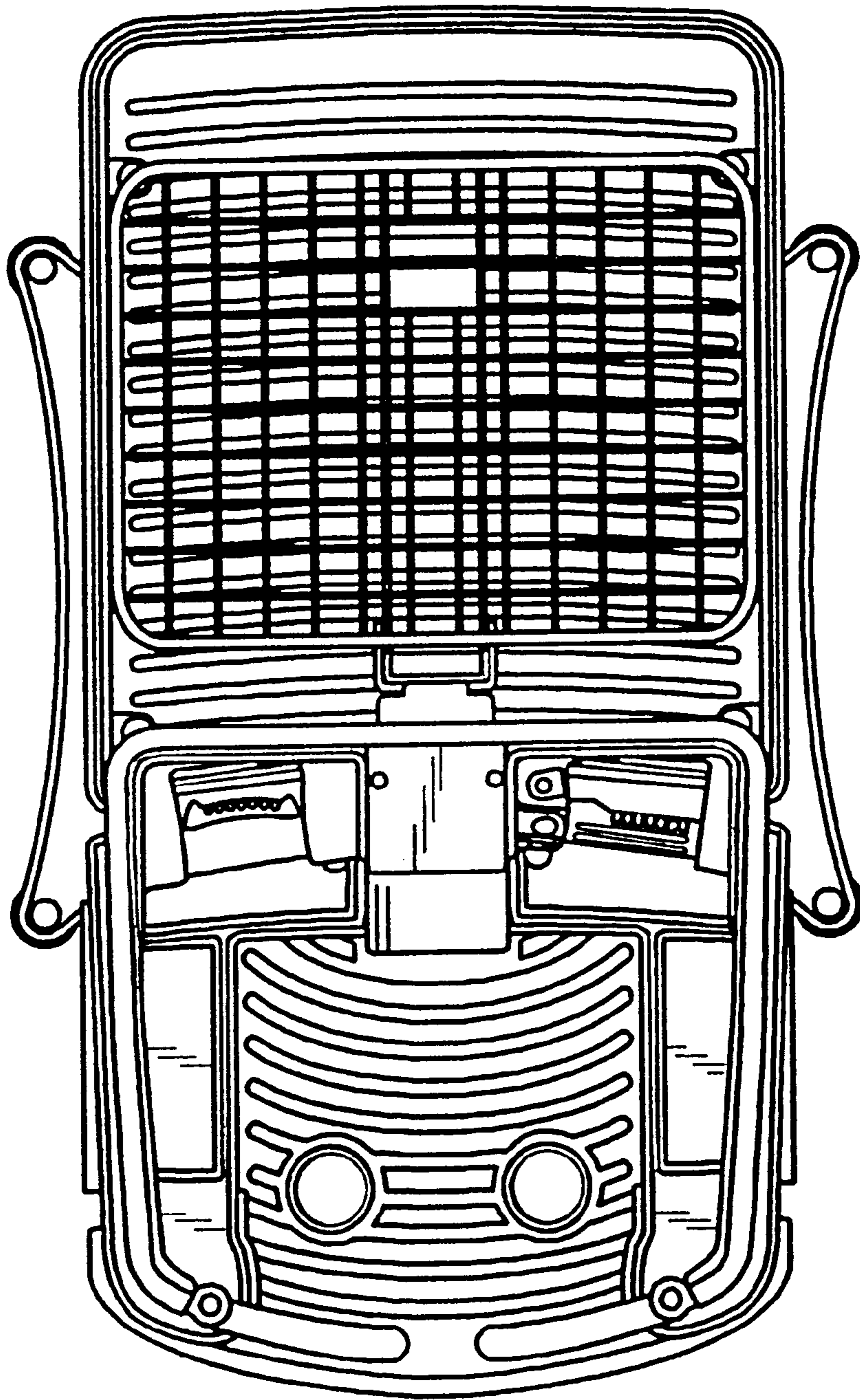

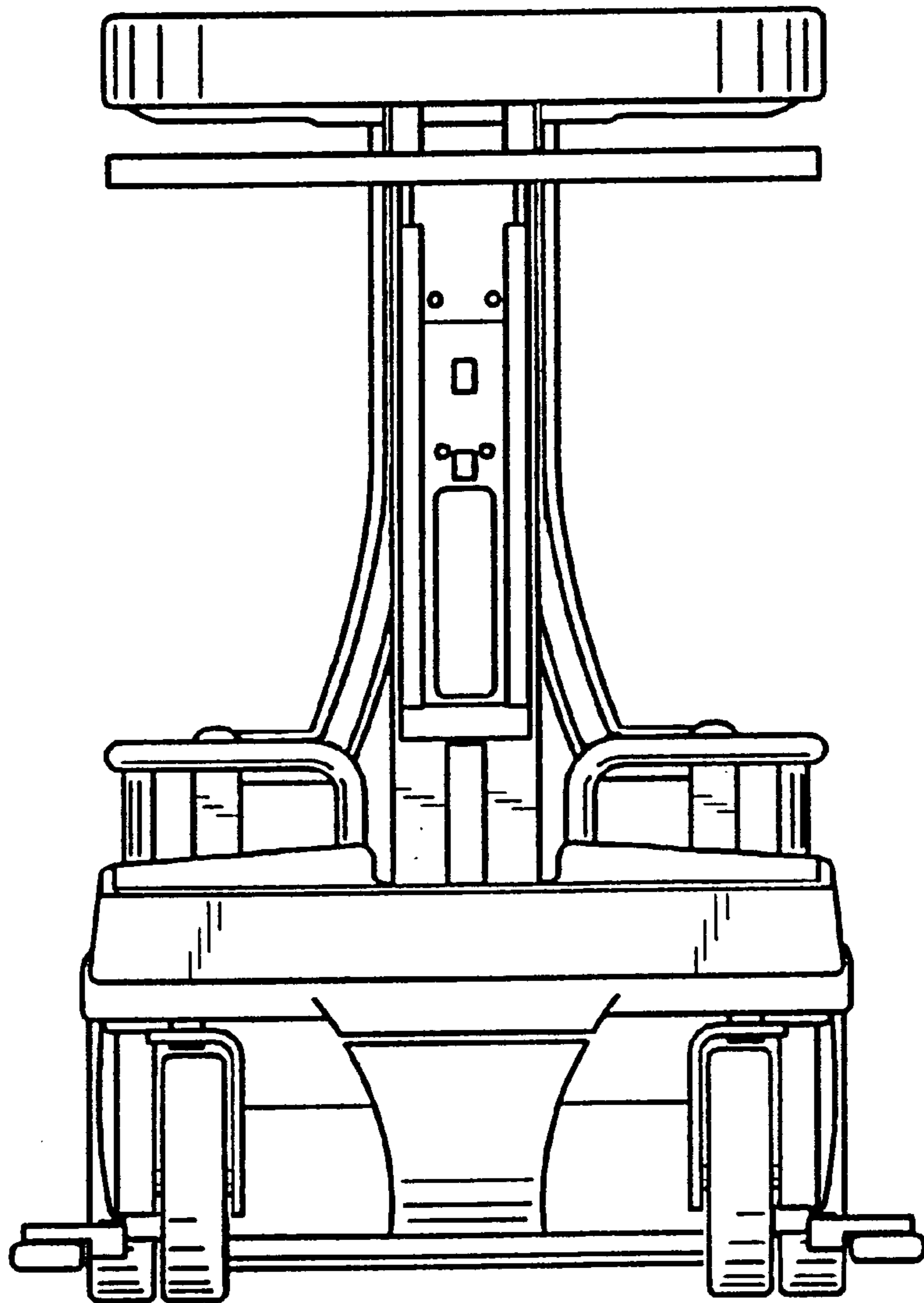
