[57] **CLAIM**

The ornamental design for a flexible trash bag for a vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the flexible trash bag for a vehicle showing my new design;

FIG. 2 is a rear elevation view of the flexible trash bag for a vehicle shown in FIG. 1;

FIG. 3 is a right elevation view of the flexible trash bag for a vehicle shown in FIG. 1;

FIG. 4 is a left elevation view of the flexible trash bag for a vehicle shown in FIG. 1;

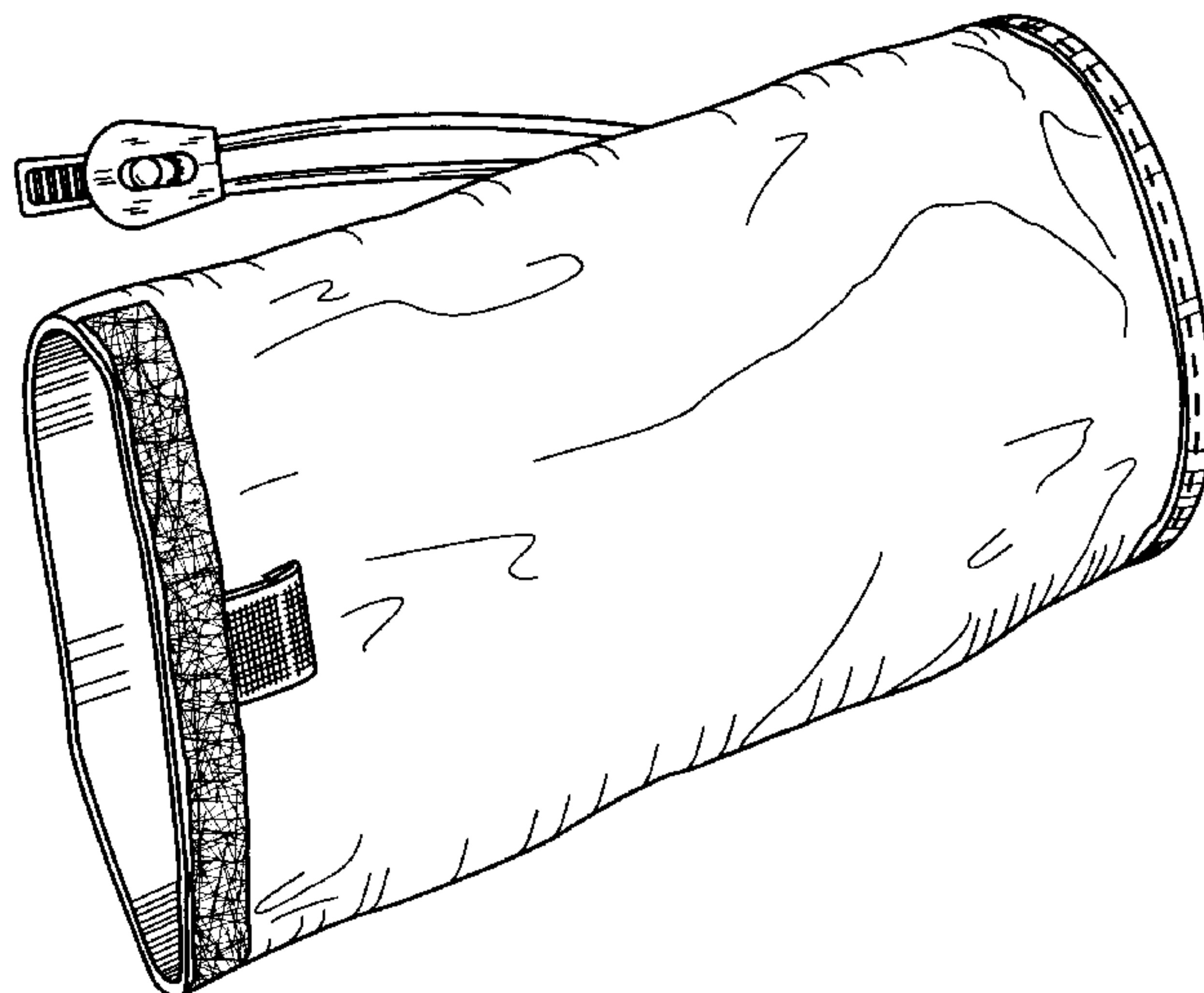
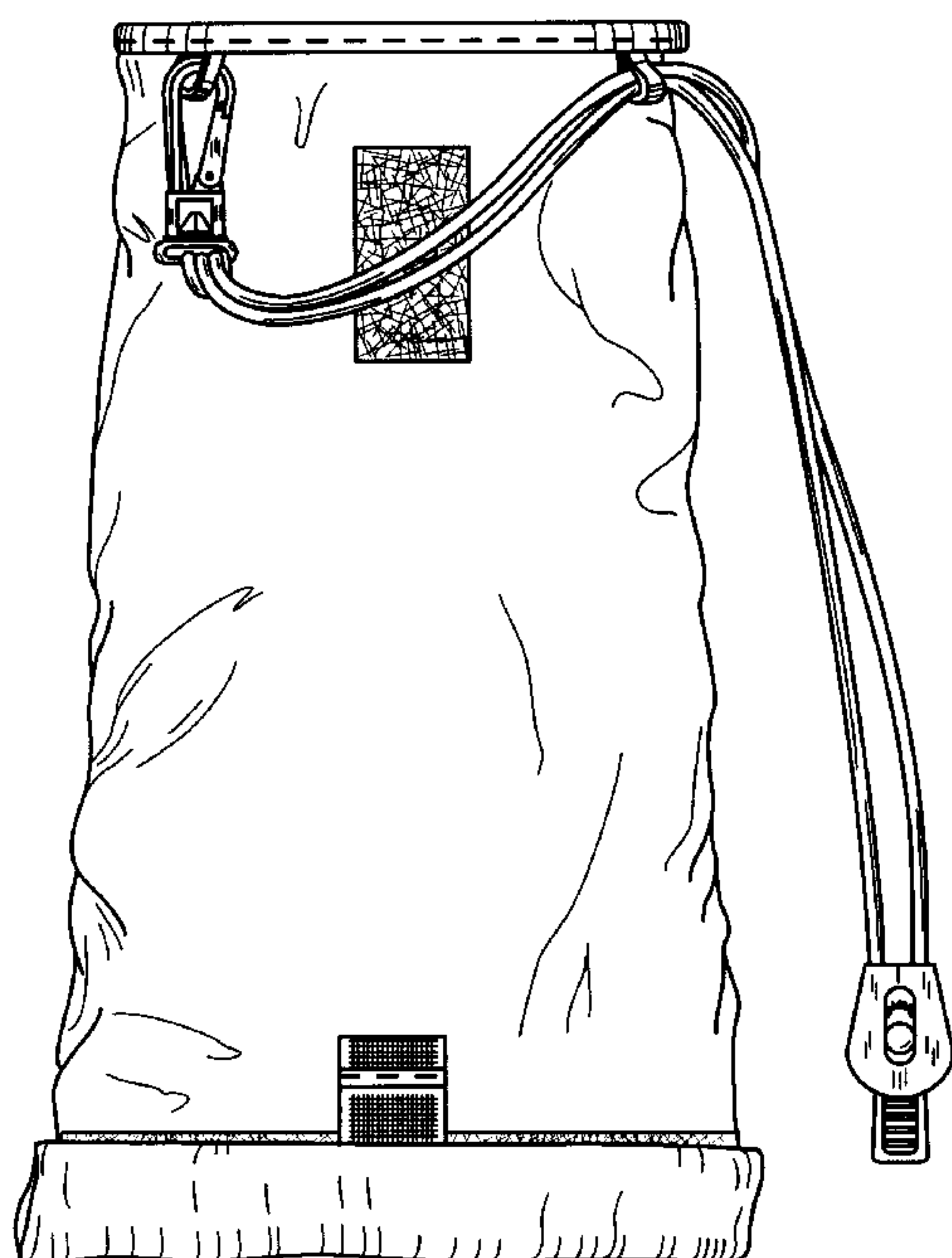
FIG. 5 is a top plan view of the flexible trash bag for a vehicle shown in FIG. 1;

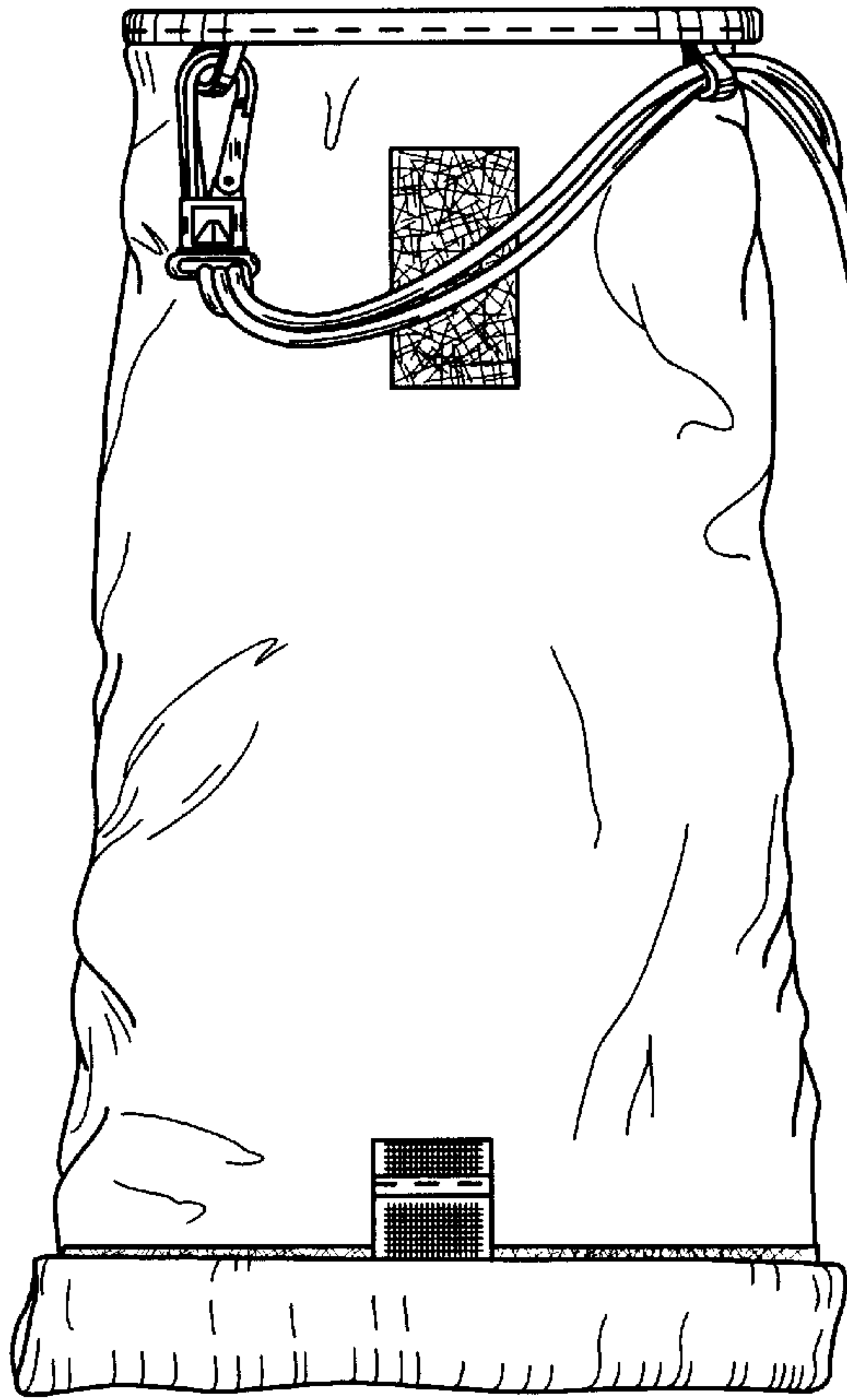

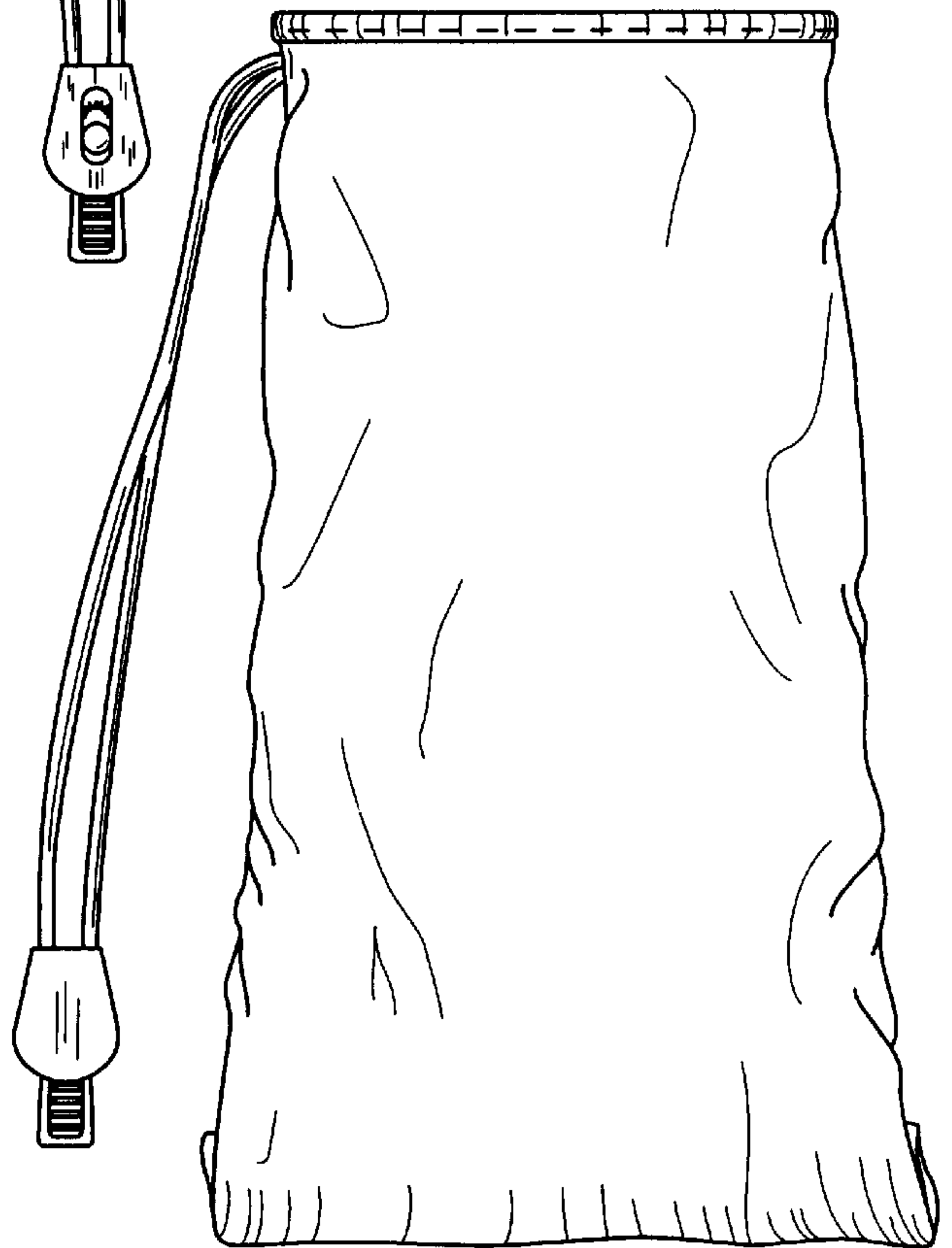

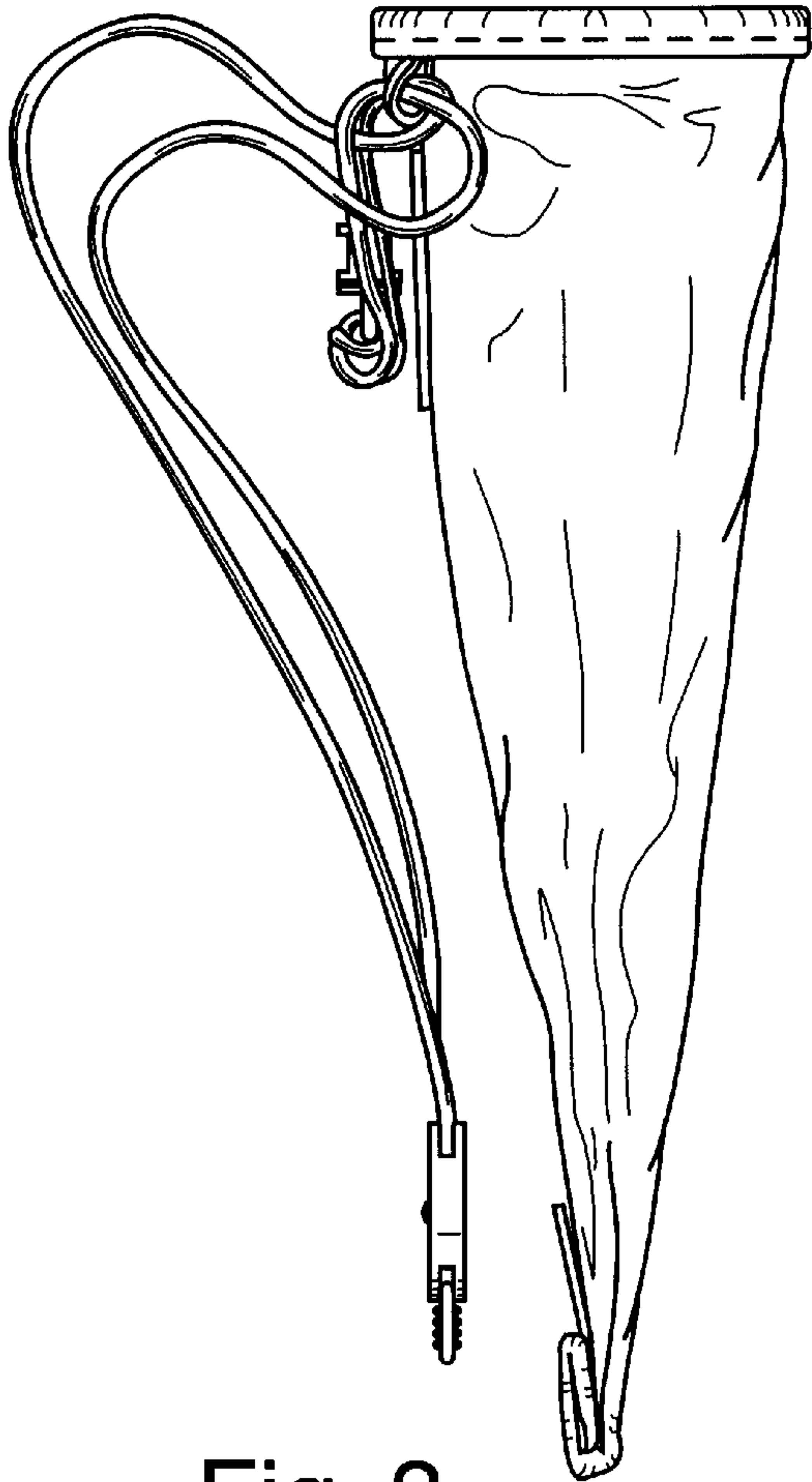

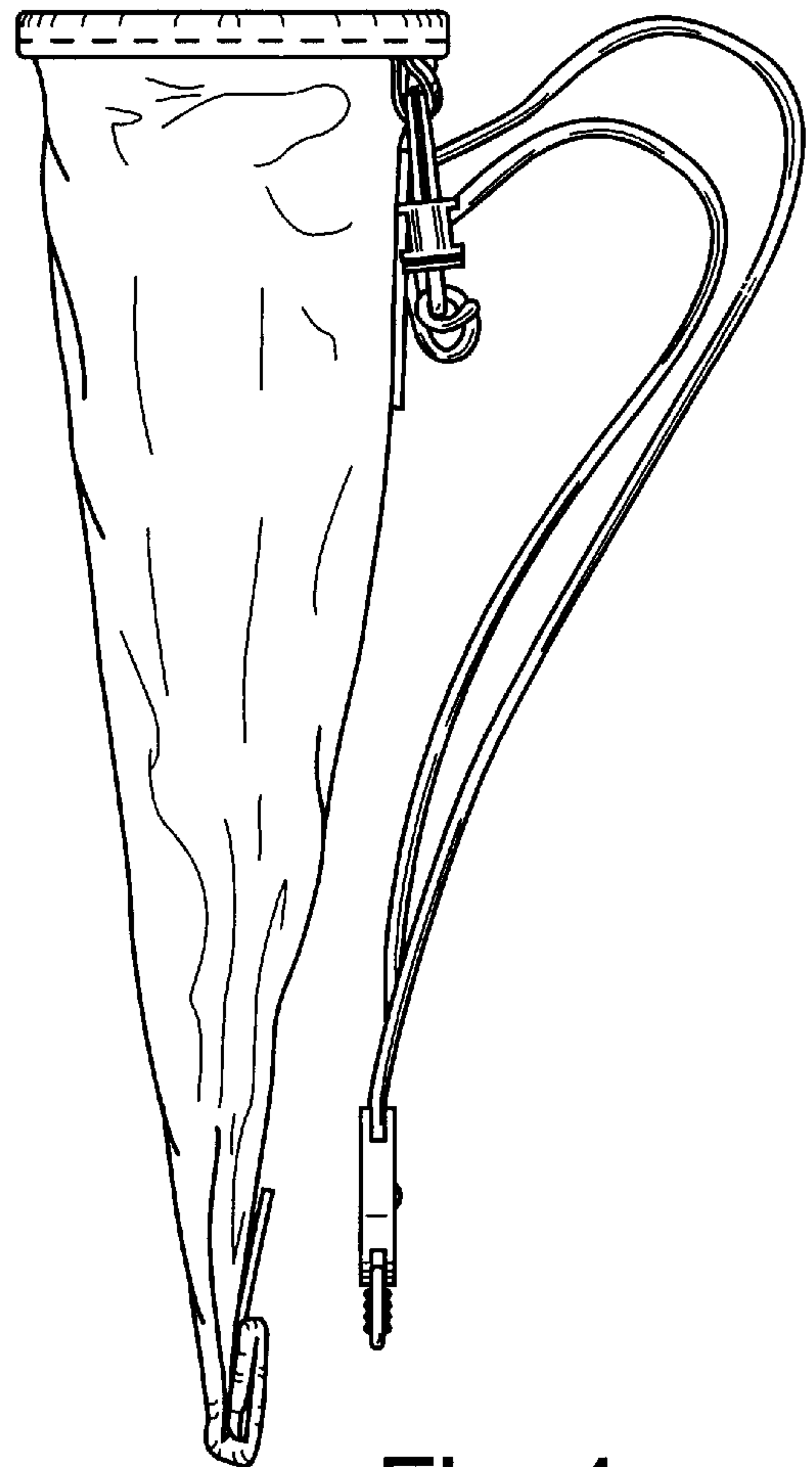

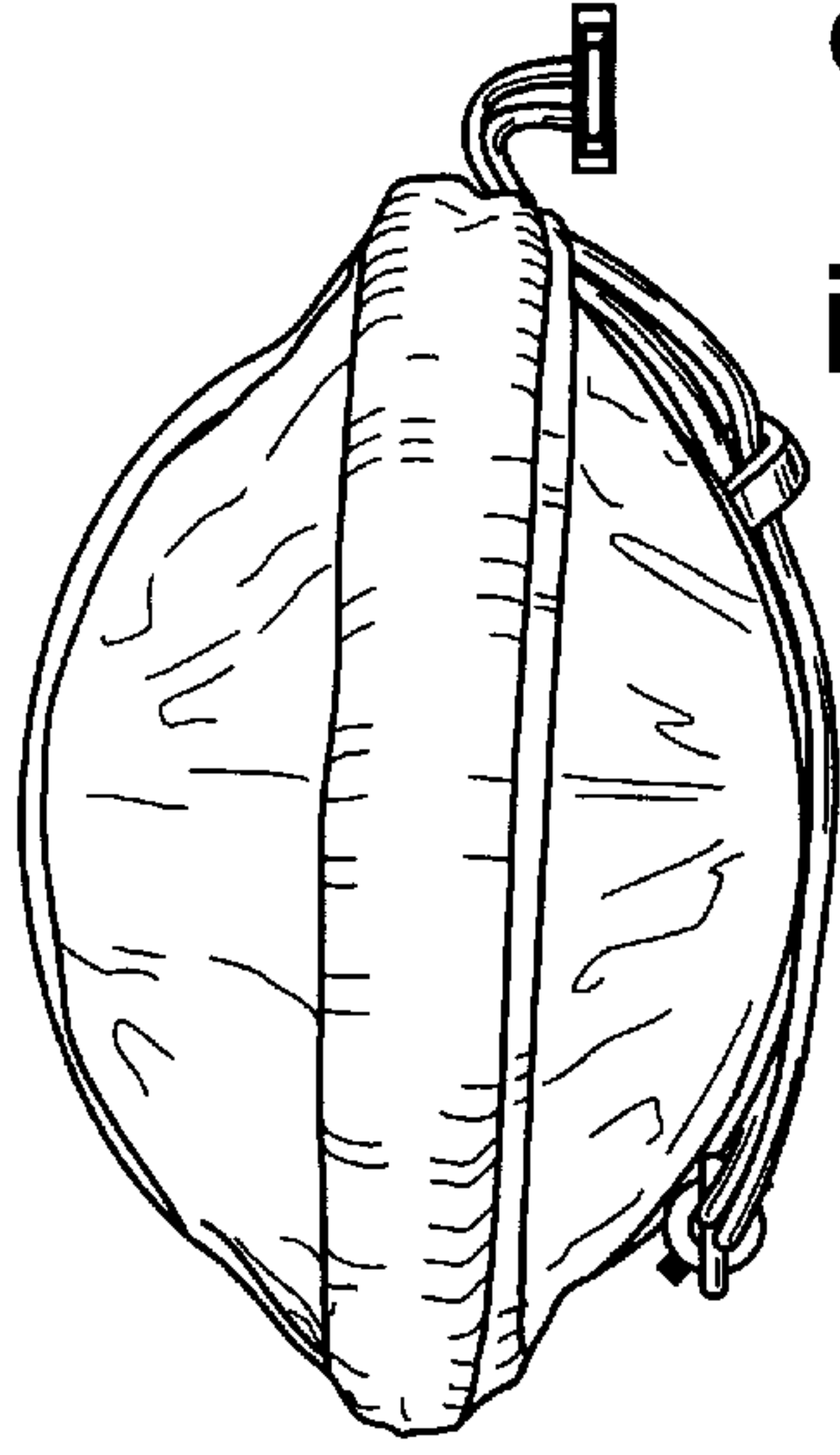

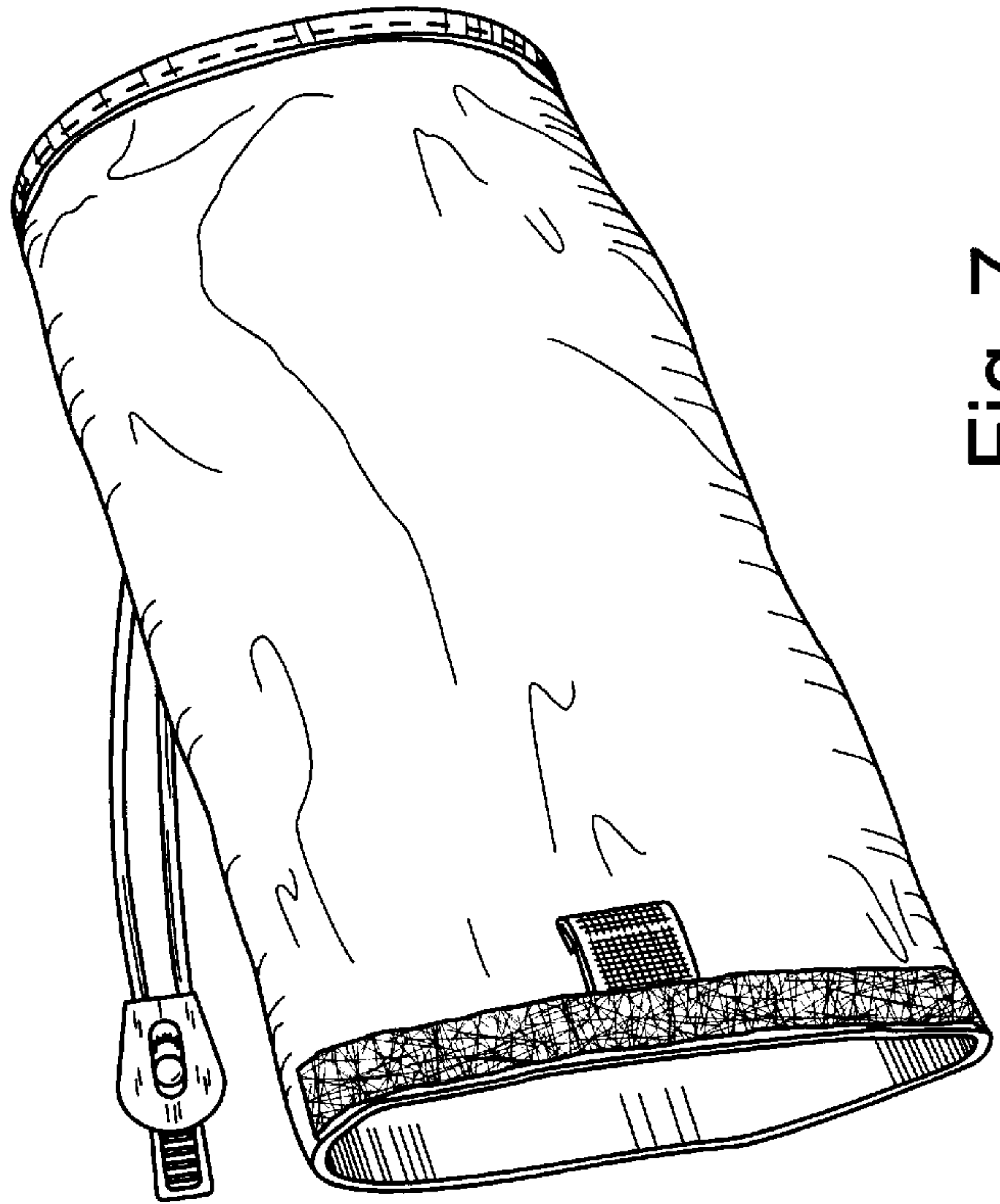
