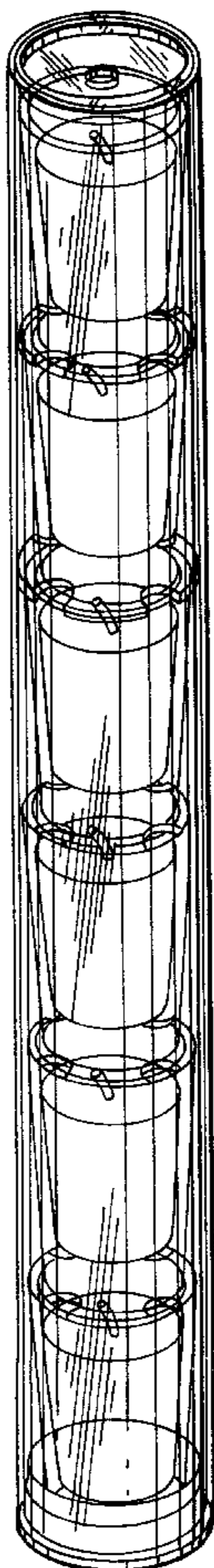
[57] **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a combined package with candle showing my new design;

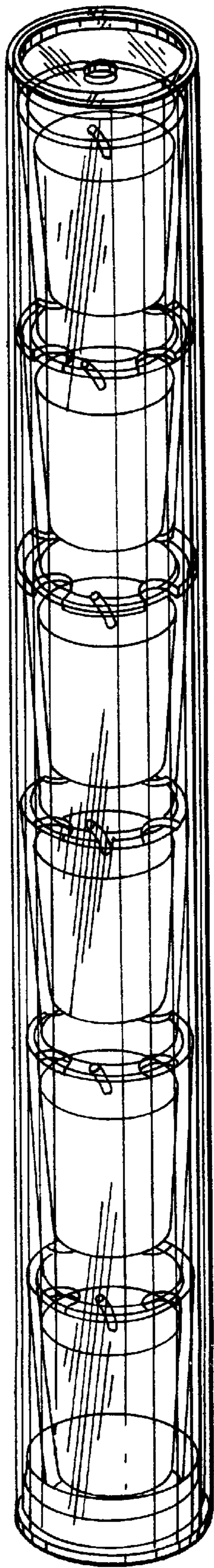

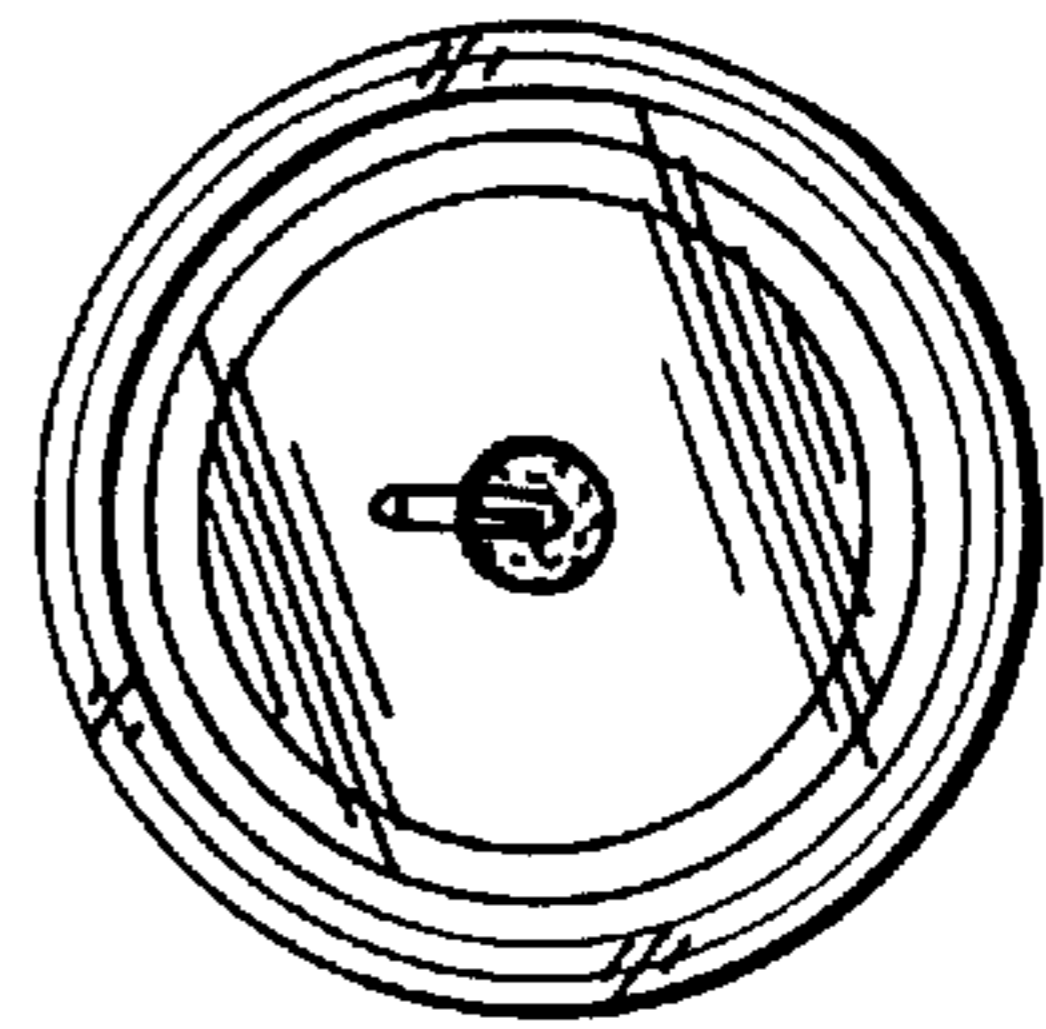

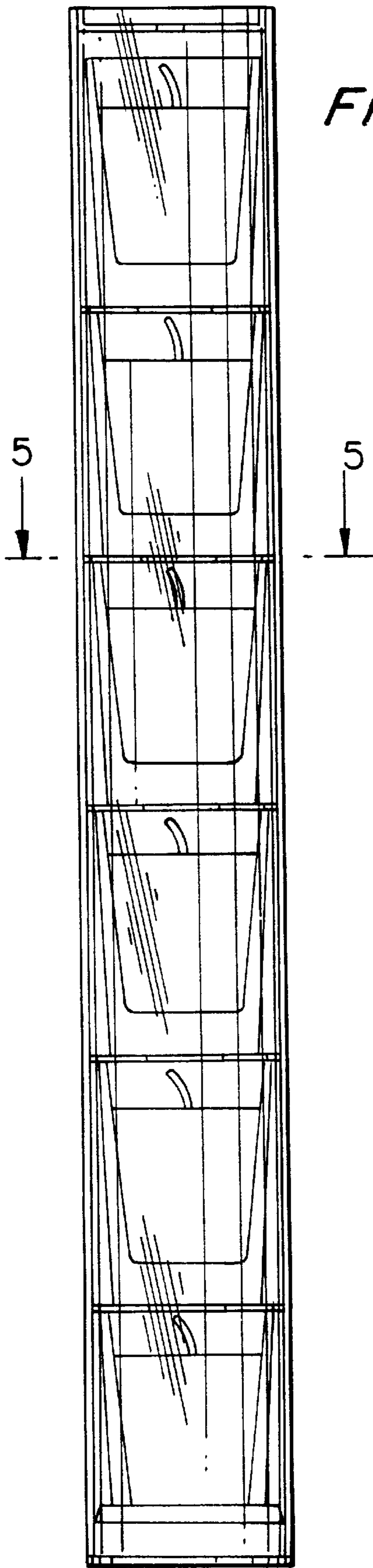

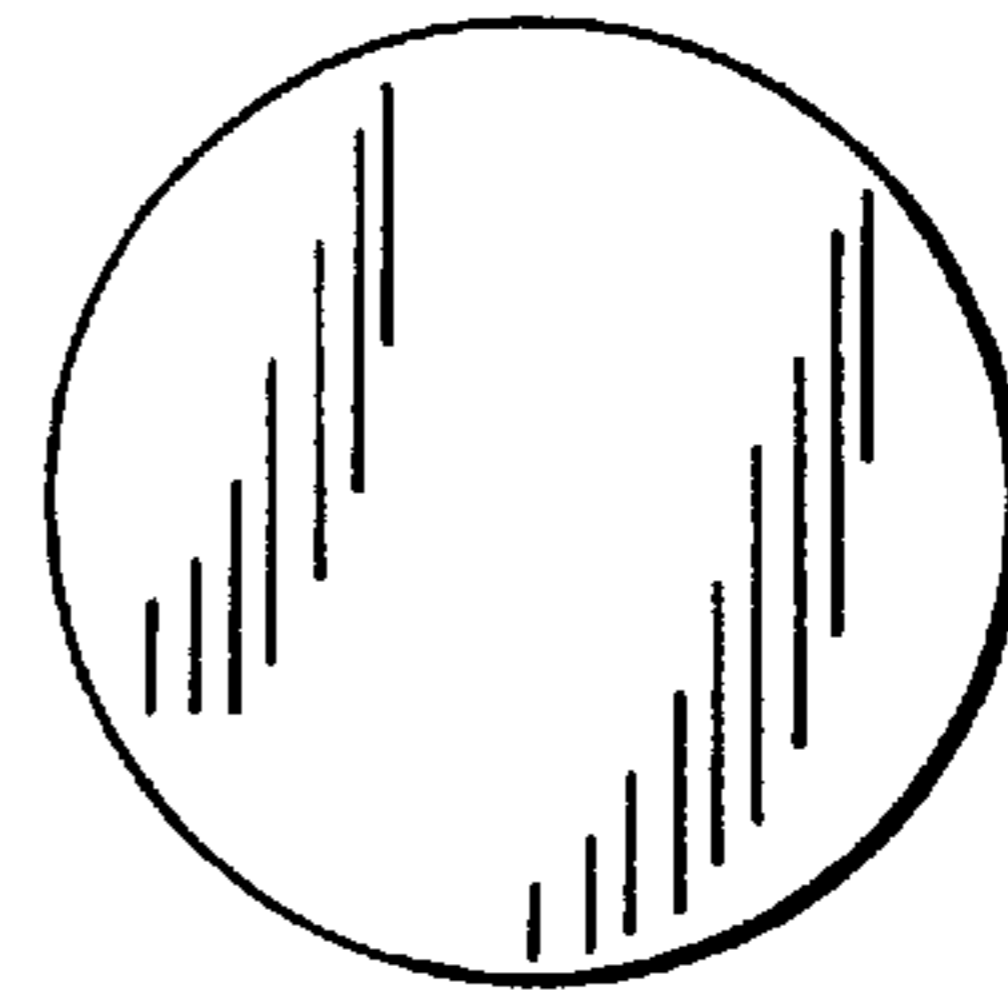

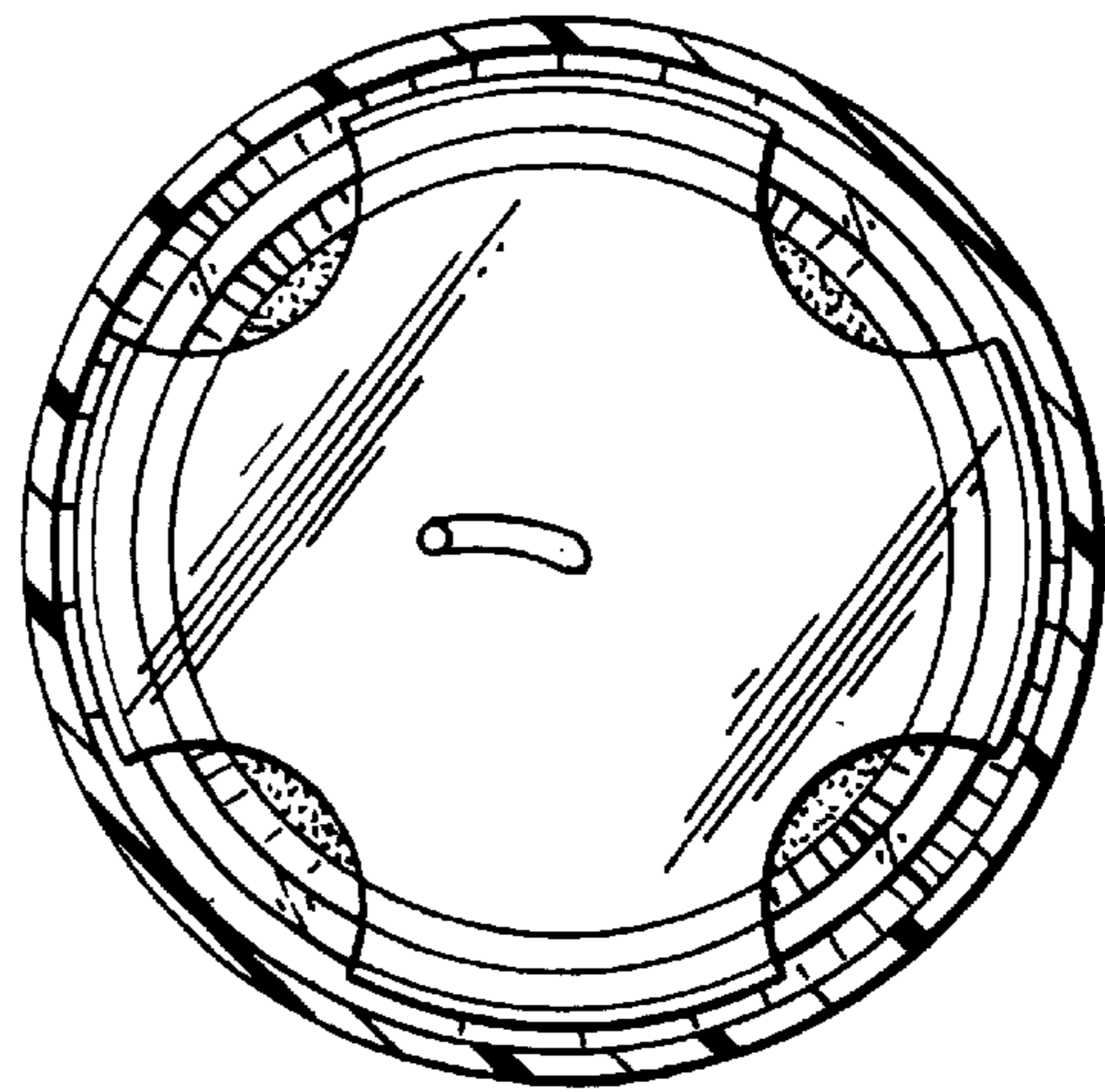
