FIG. 11 is a front elevational view of FIG. 7; and,

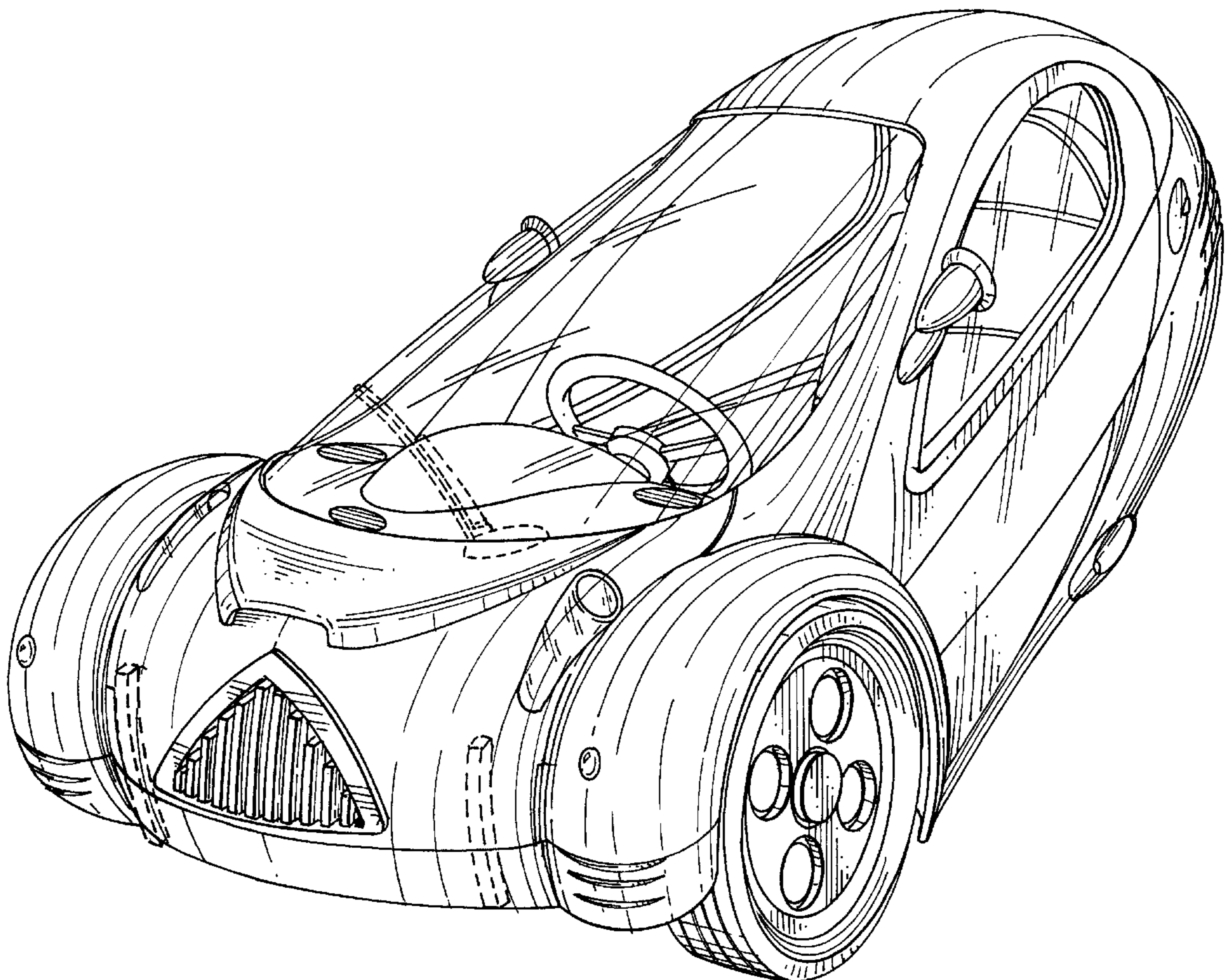
FIG. 12 is a rear elevational view of FIG. 7.

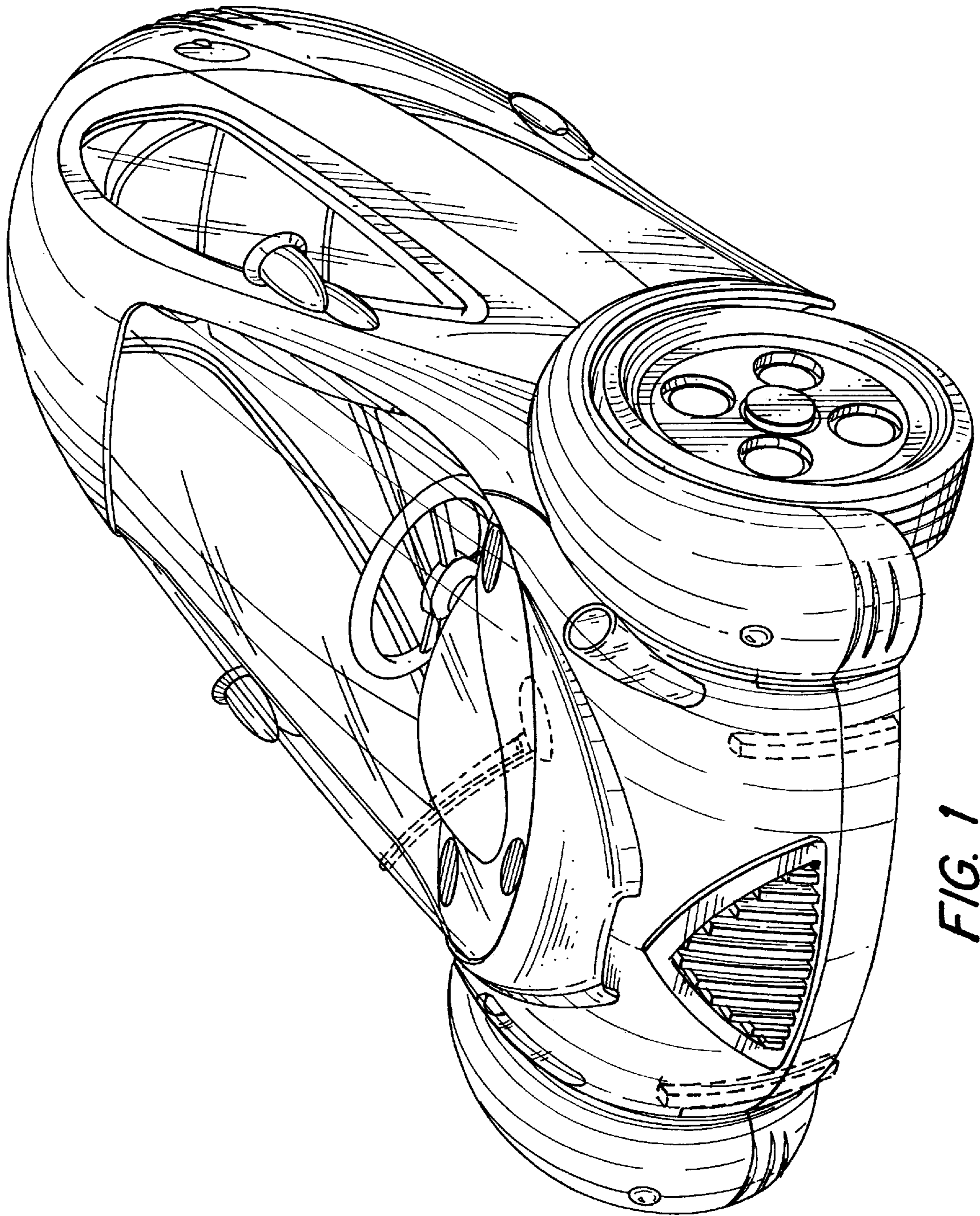

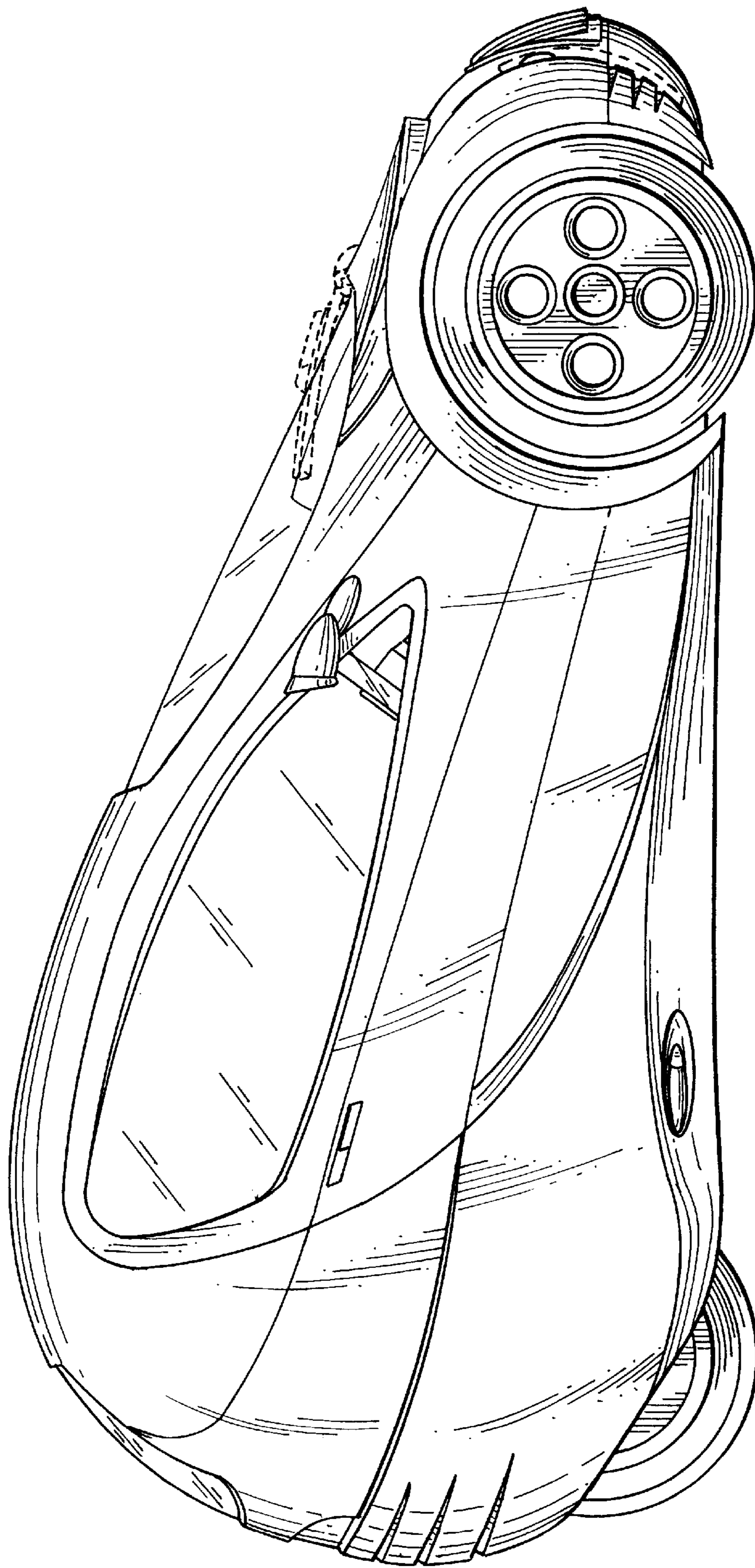

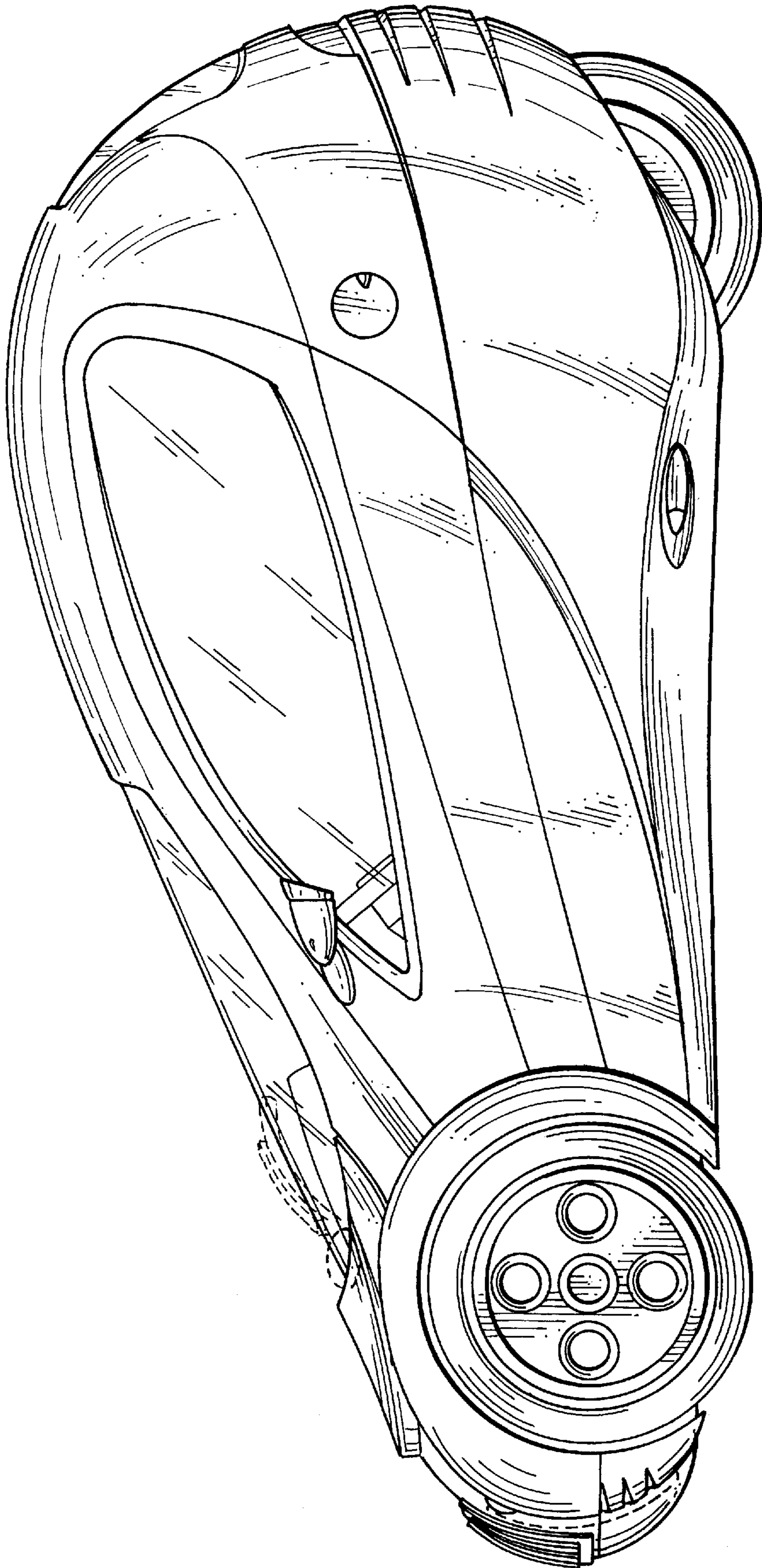

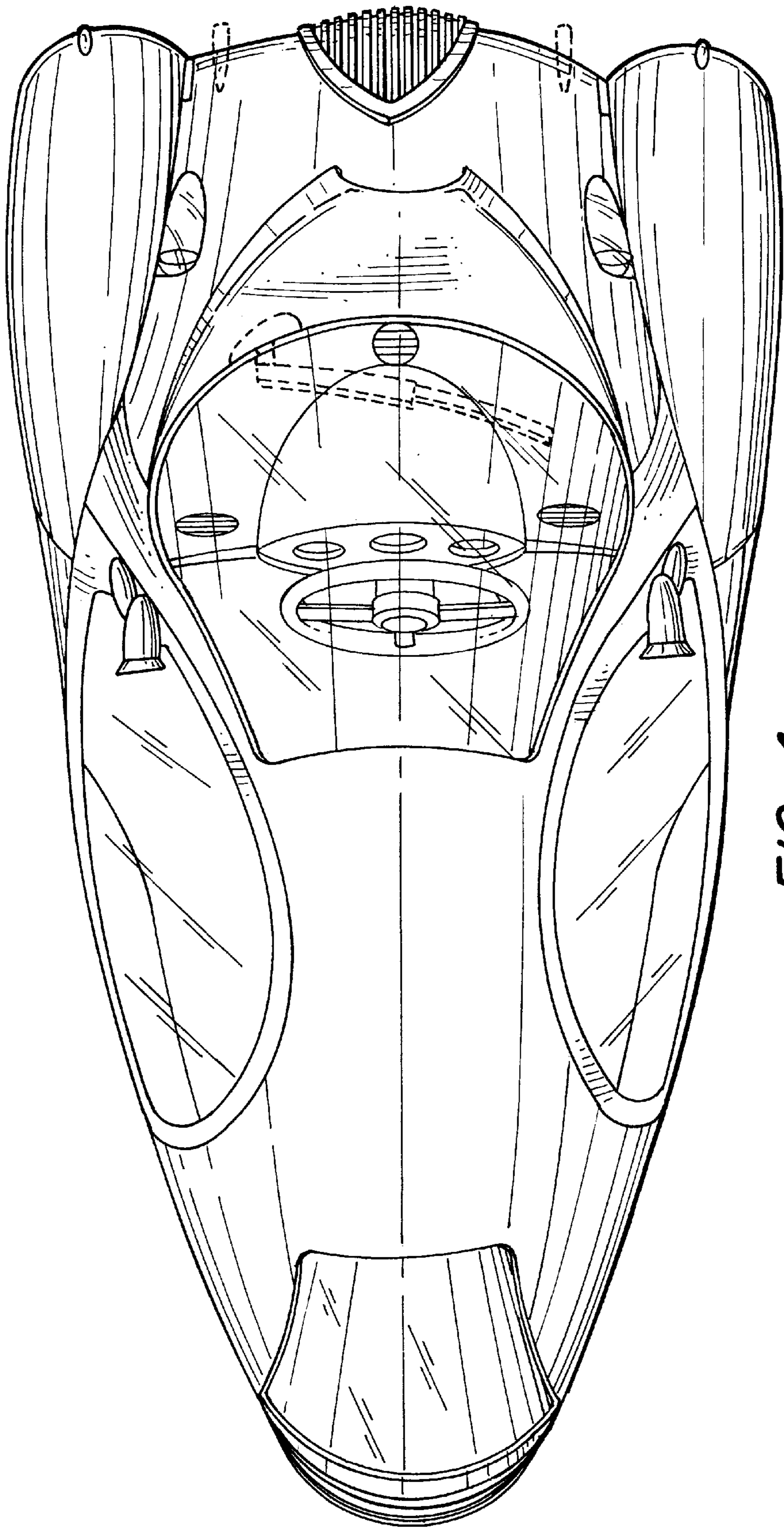

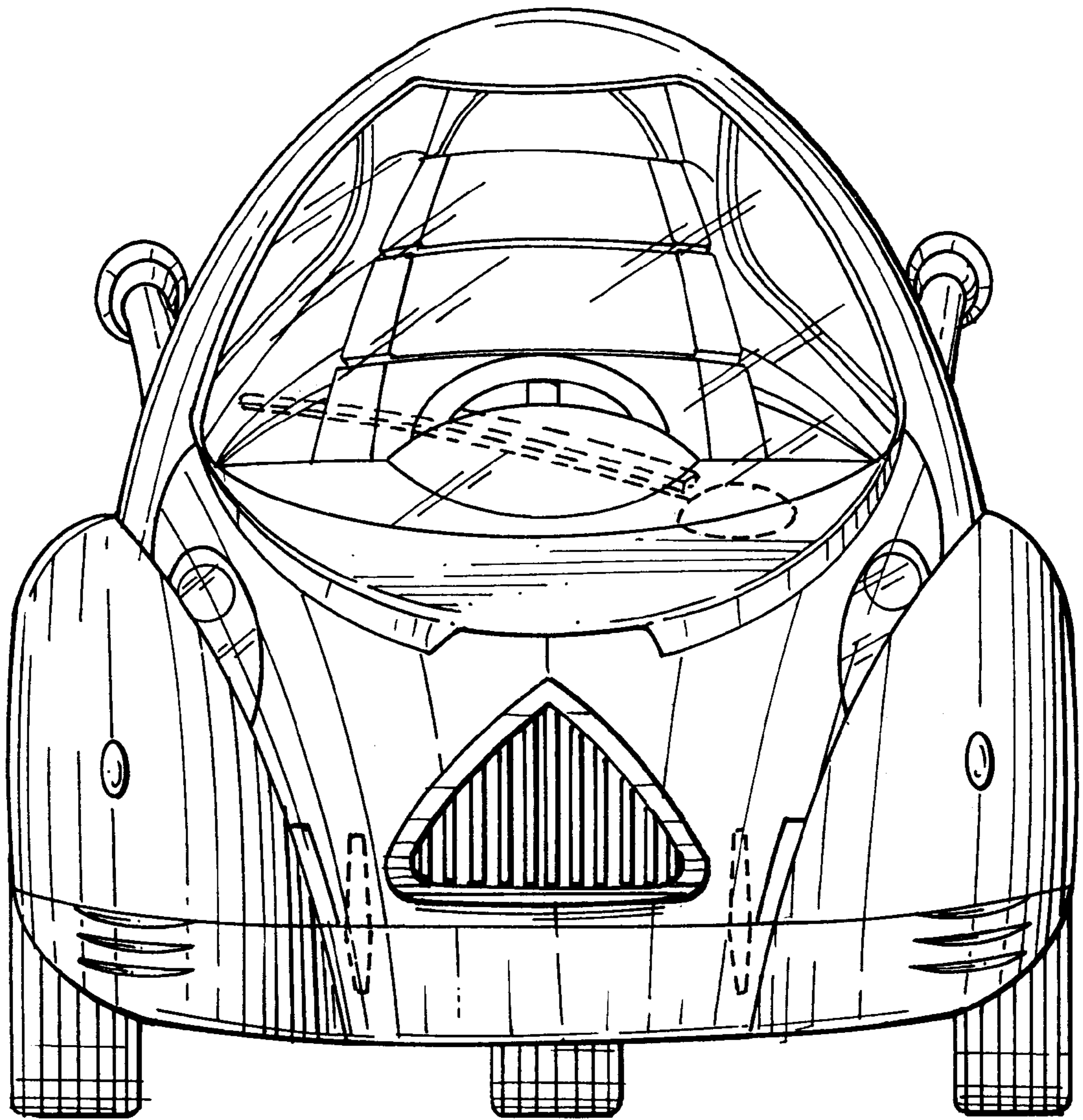

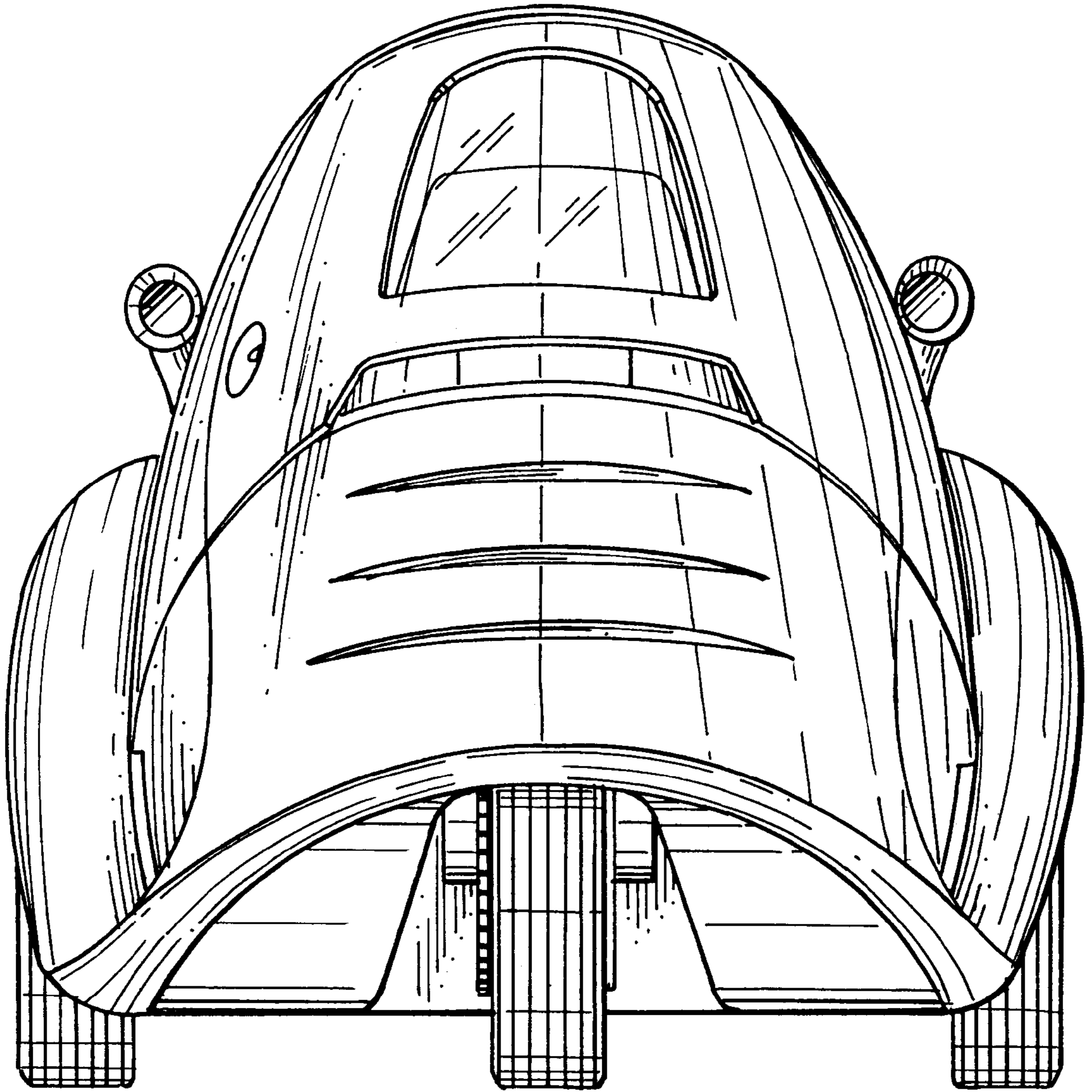

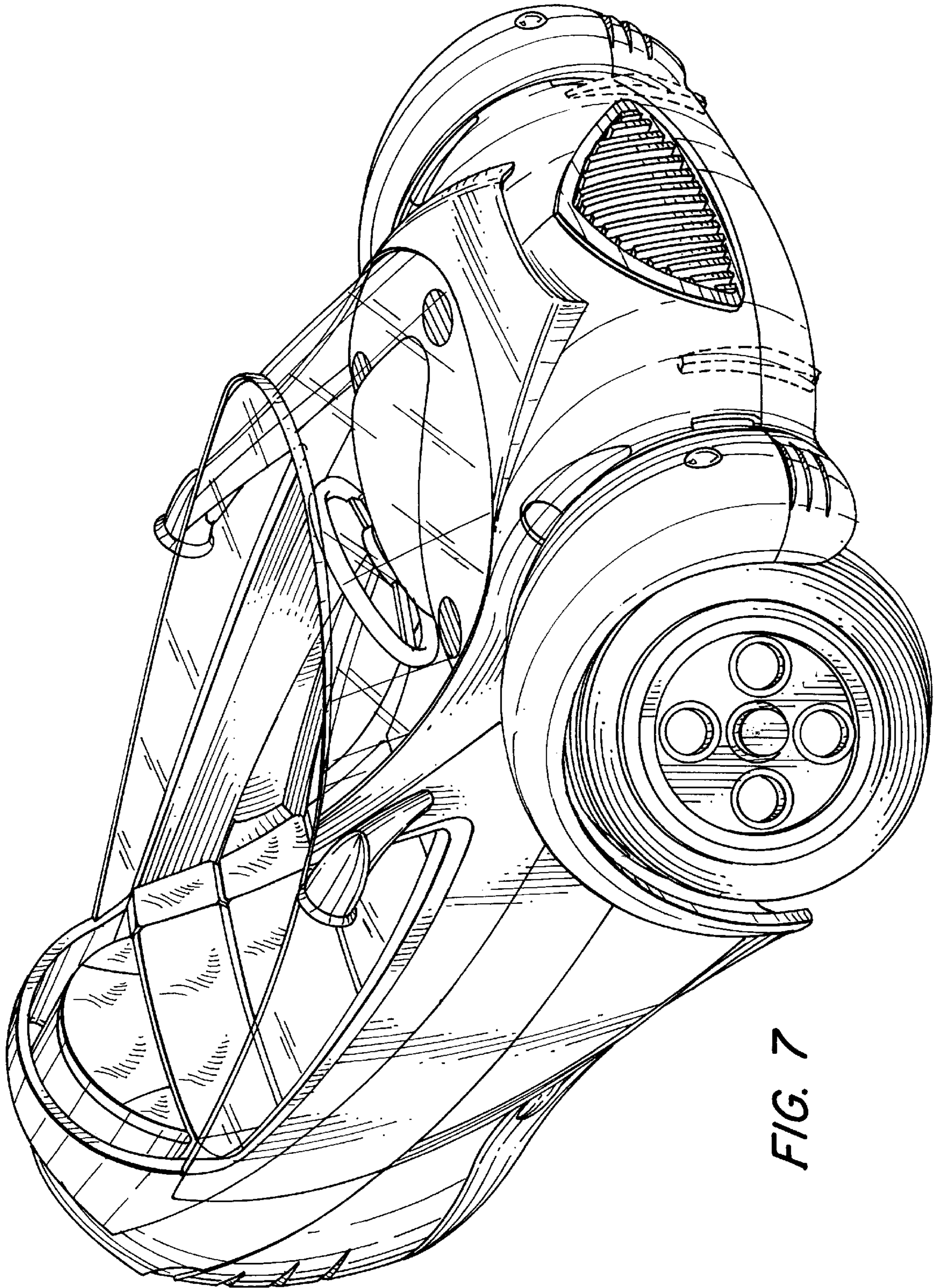

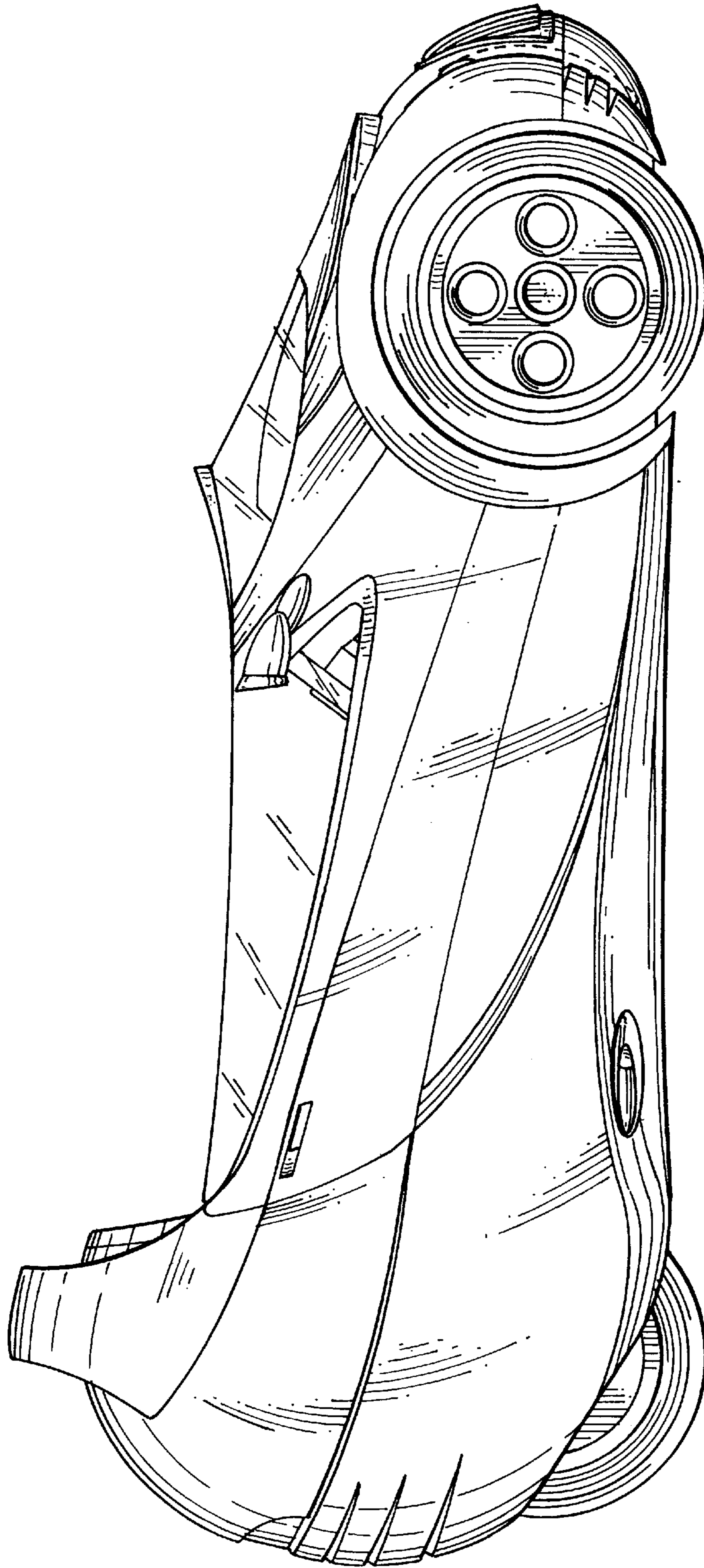

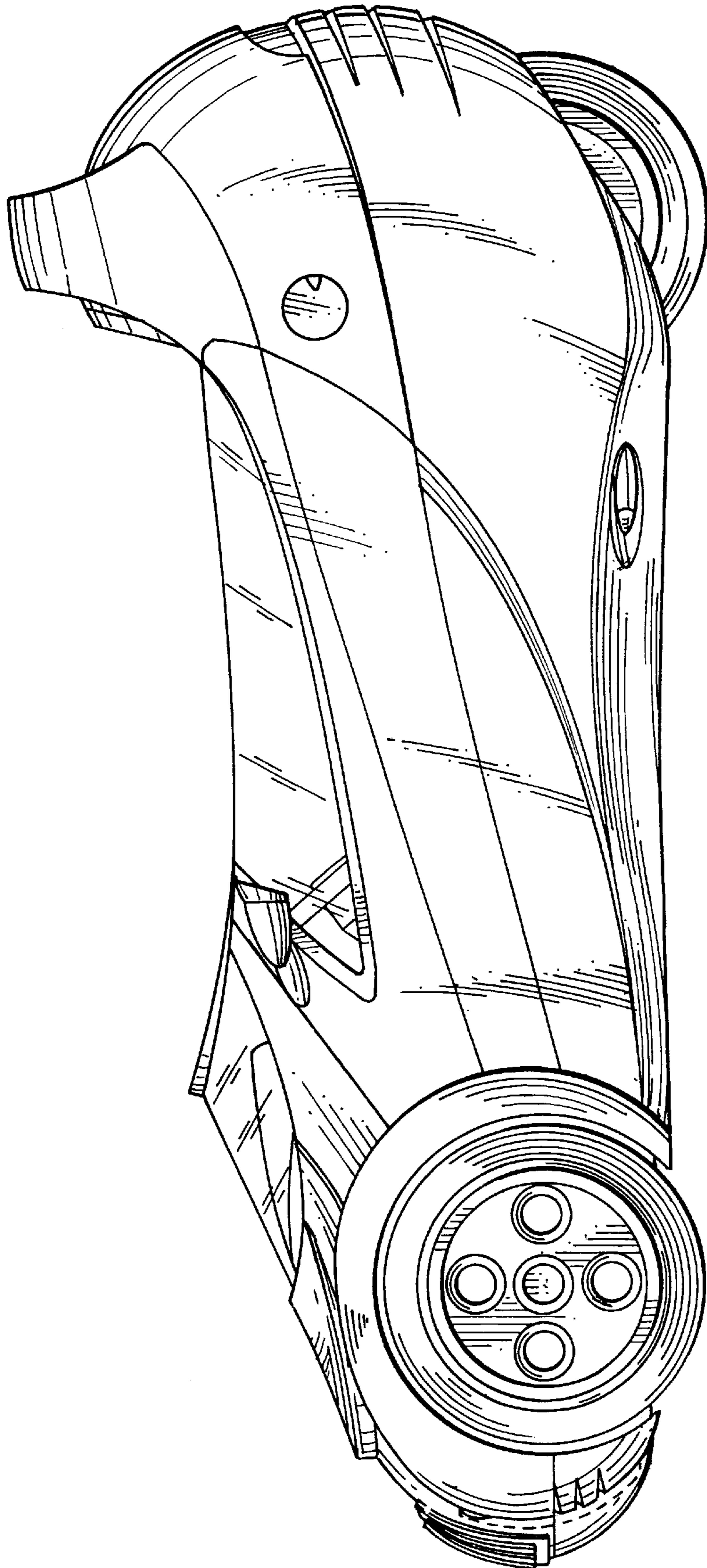

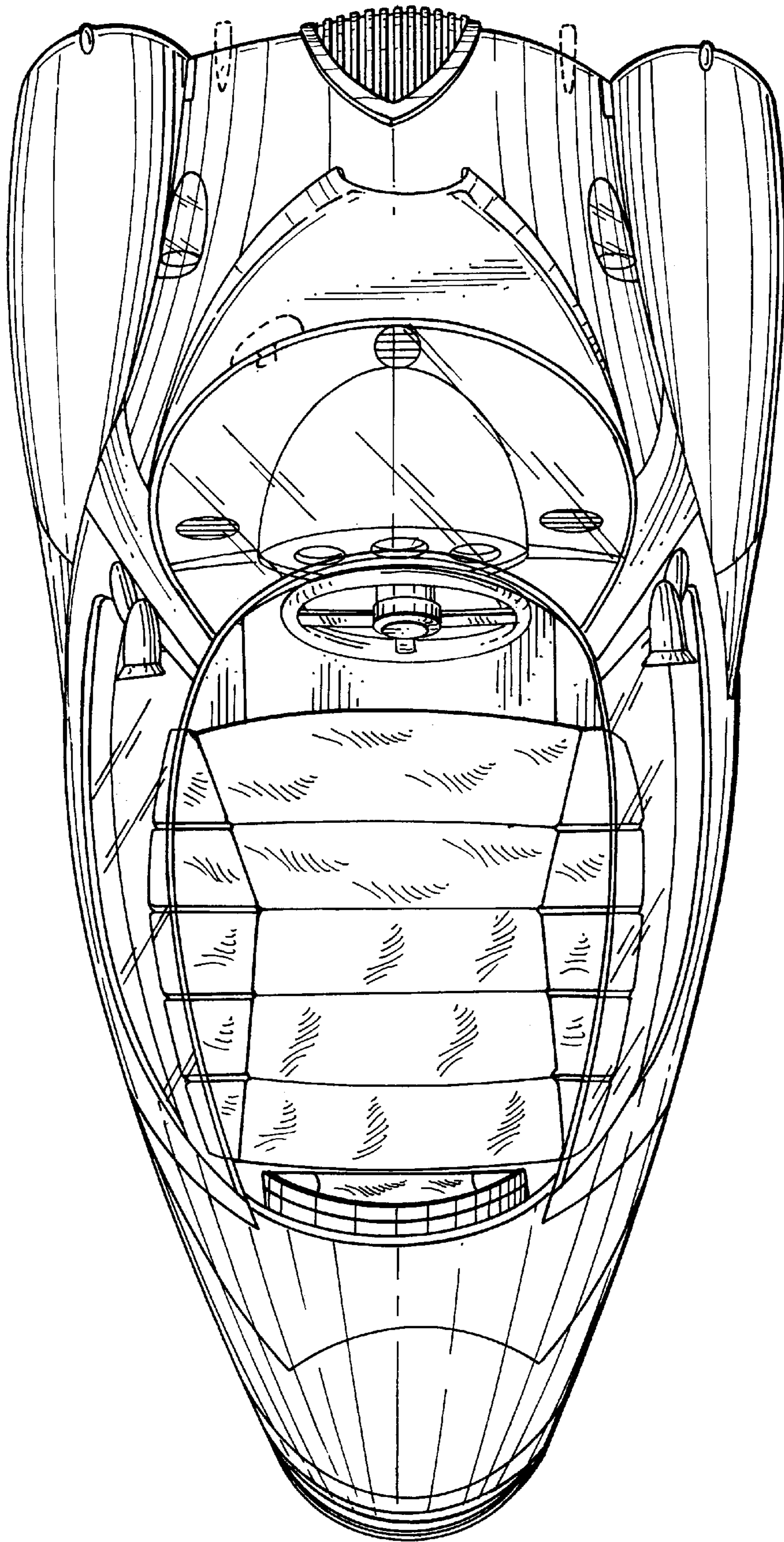

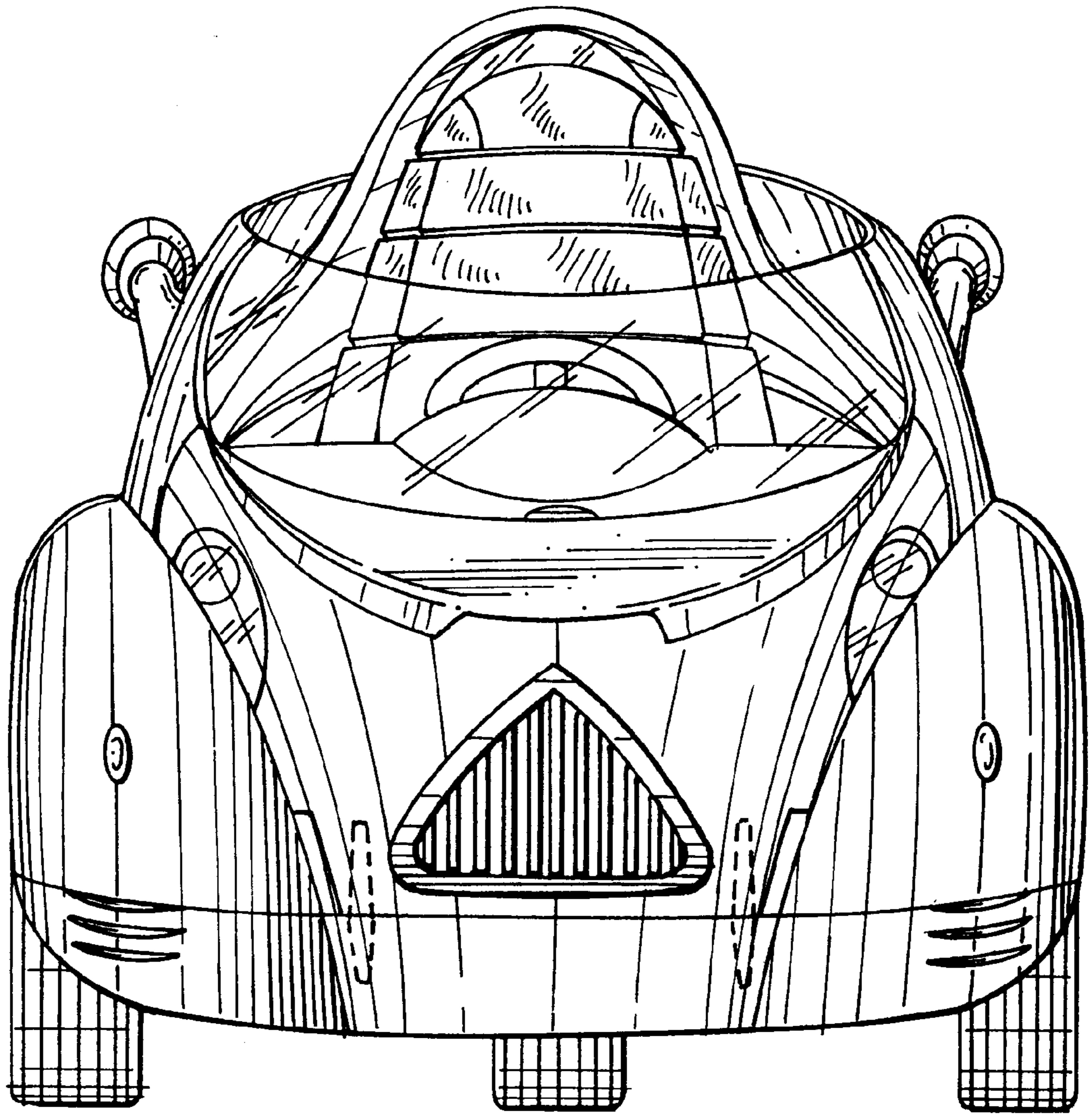

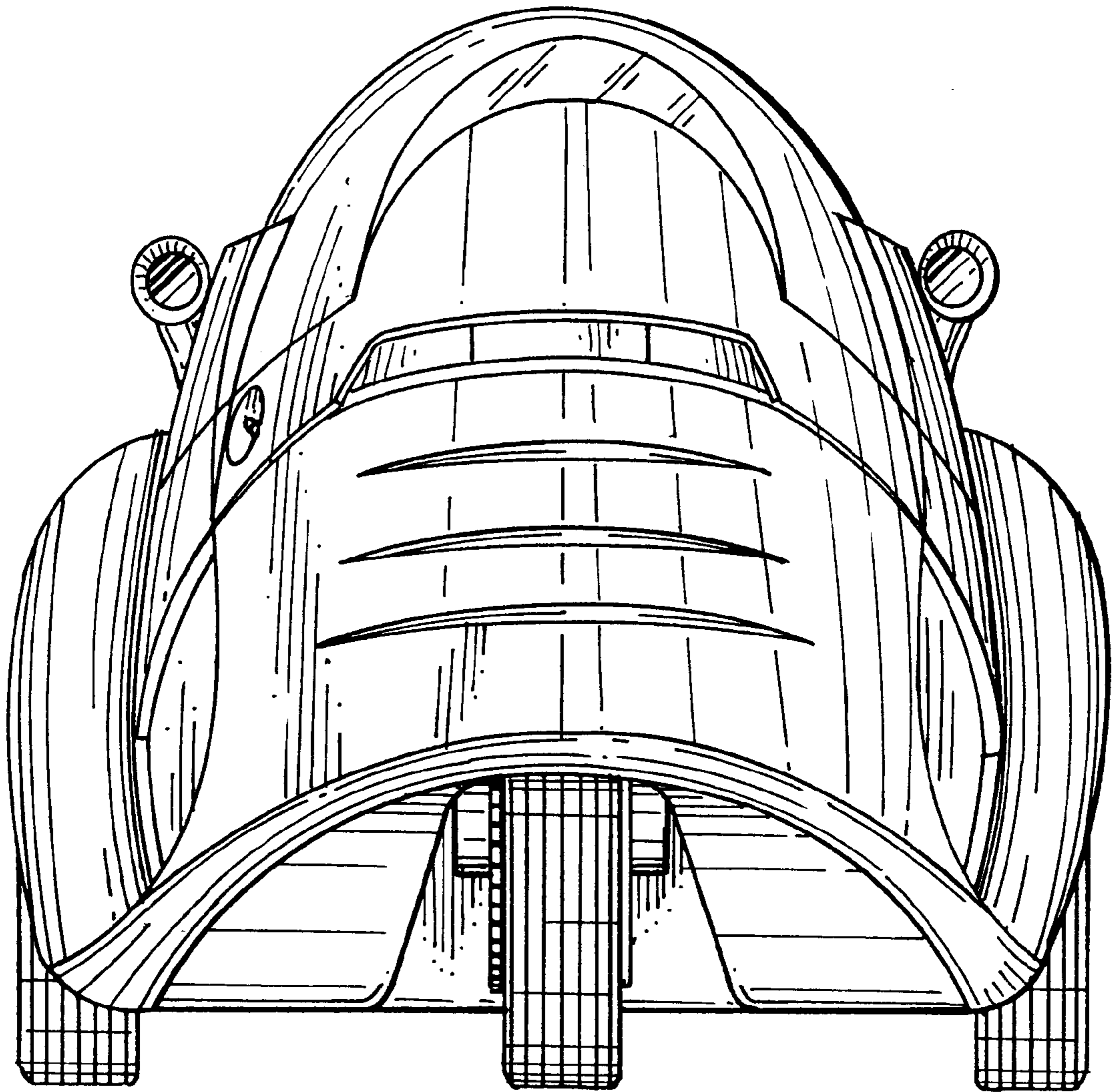
