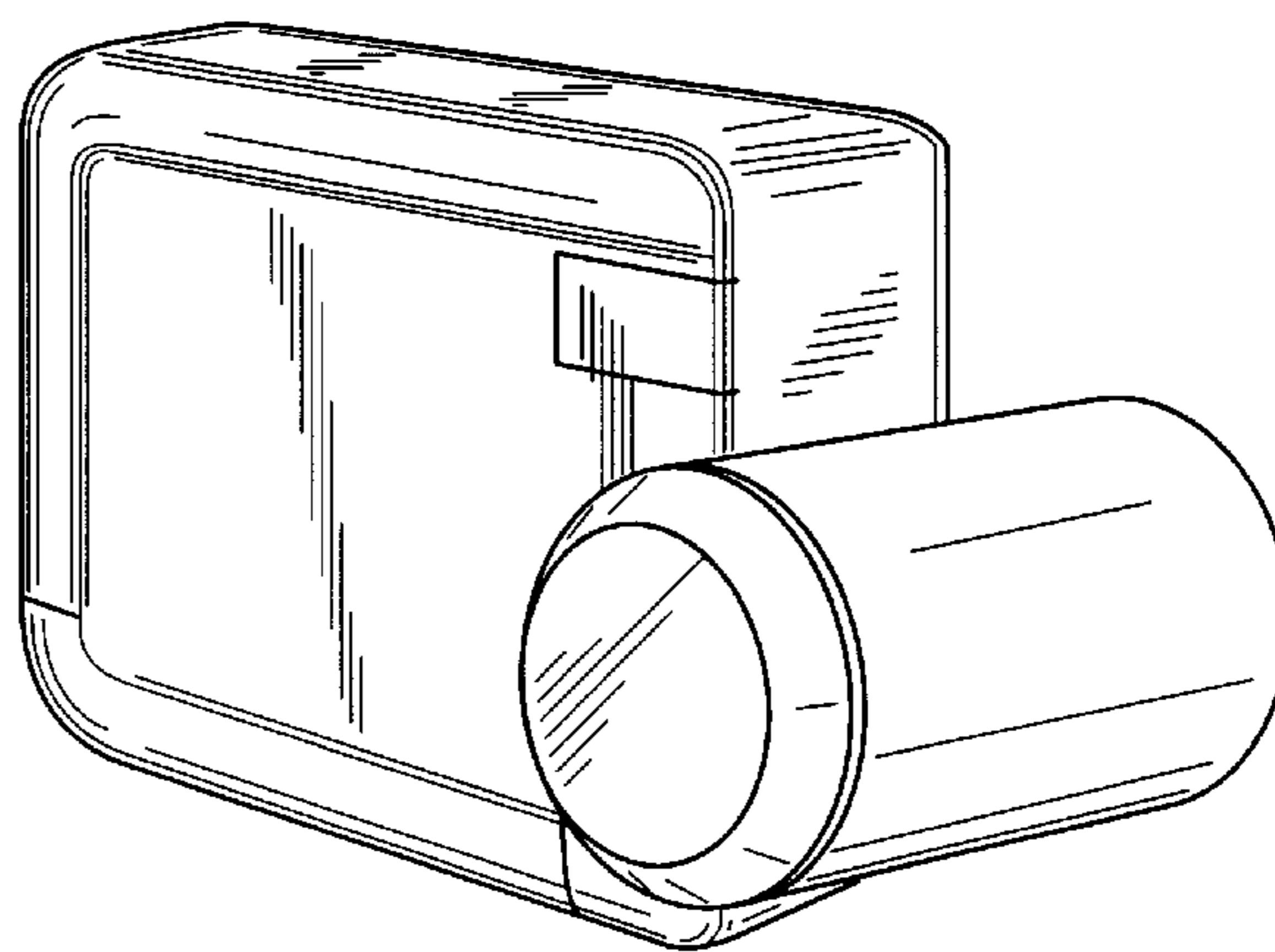
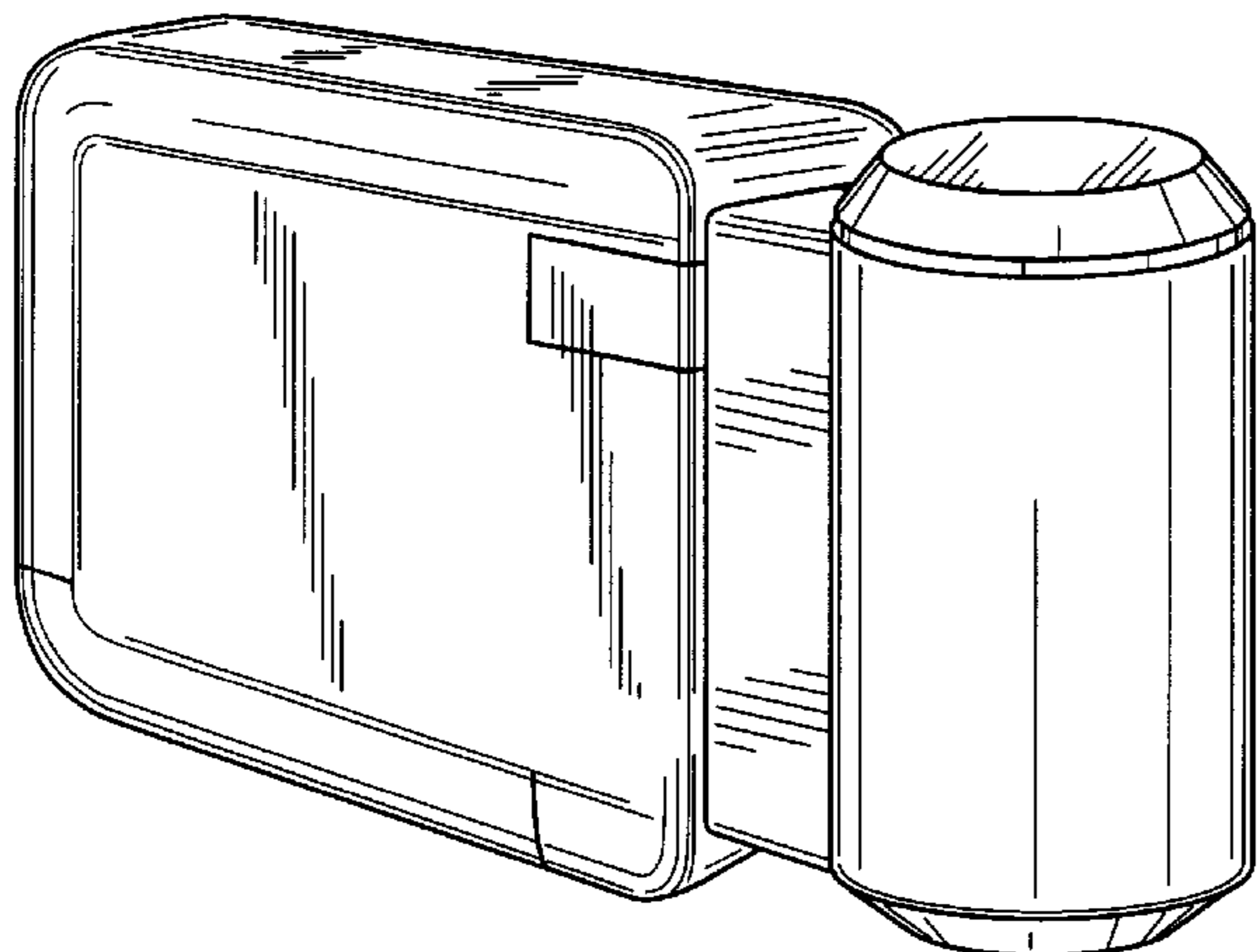
[57] **CLAIM**

The ornamental design for a combined camera and lens, shown and described.

**DESCRIPTION**

FIG. 1 is a front and right side perspective view of a combined camera and lens showing our design;  
 FIG. 2 is a front elevational view thereof;  
 FIG. 3 is a rear elevational view thereof;  
 FIG. 4 is a top plan view thereof;  
 FIG. 5 is a bottom plan view thereof;  
 FIG. 6 is a left side elevational view thereof;  
 FIG. 7 is a right side elevational view thereof;  
 FIG. 8 is a front and right side perspective view thereof, with the lens rotated to an alternate position;  
 FIG. 9 is a front and right side perspective view of a combined camera and lens shown with the broken lines removed for clarity of illustration.  
 FIG. 10 is a front elevational view of FIG. 9;  
 FIG. 11 is a rear elevational view of FIG. 9;  
 FIG. 12 is a top plan view of FIG. 9;  
 FIG. 13 is a bottom plan view of FIG. 9;  
 FIG. 14 is a left side elevational view of FIG. 9;  
 FIG. 15 is a right side elevational view of FIG. 9; and,  
 FIG. 16 is a front and right perspective view of FIG. 9, with the lens rotated relative to the camera.

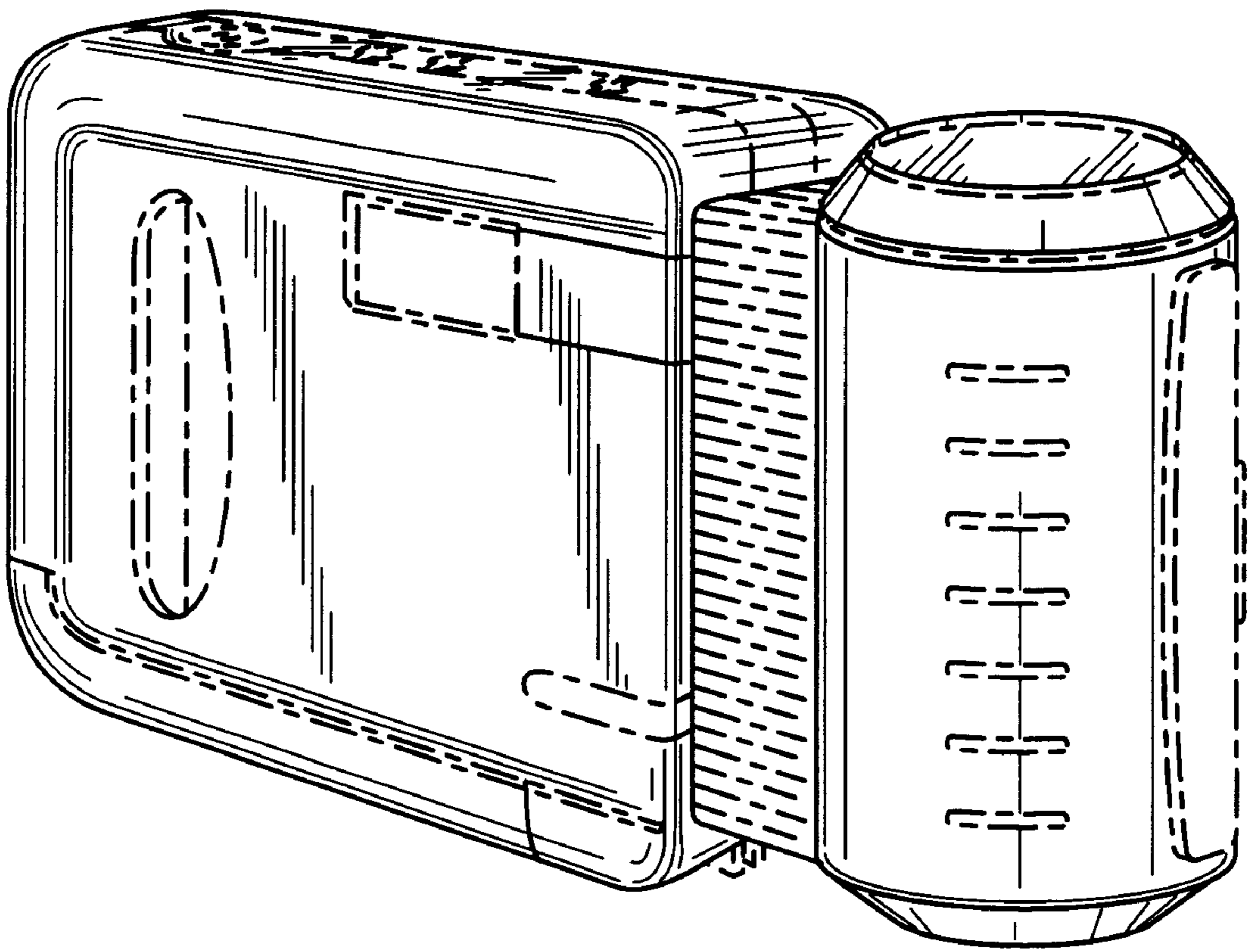

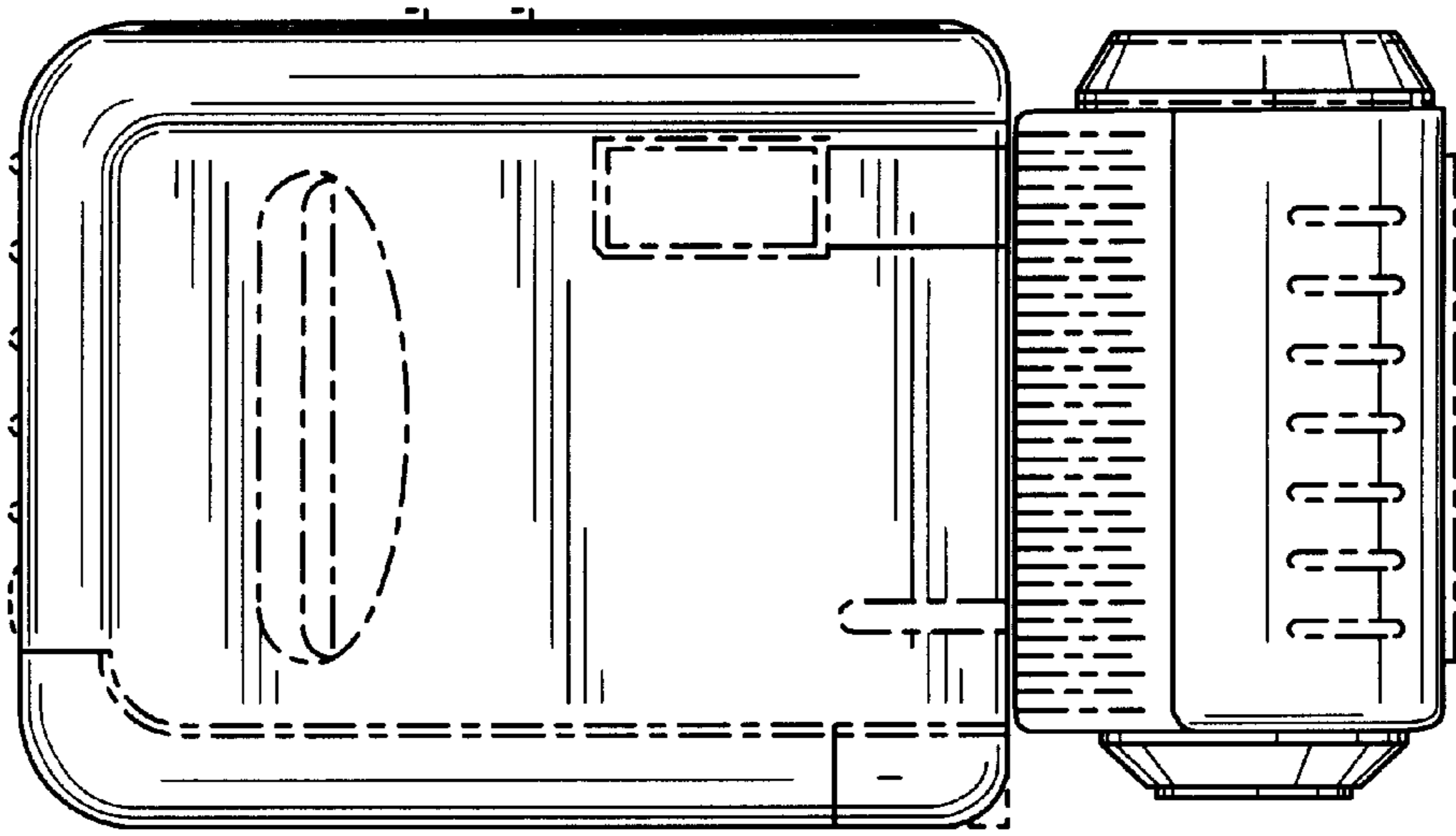

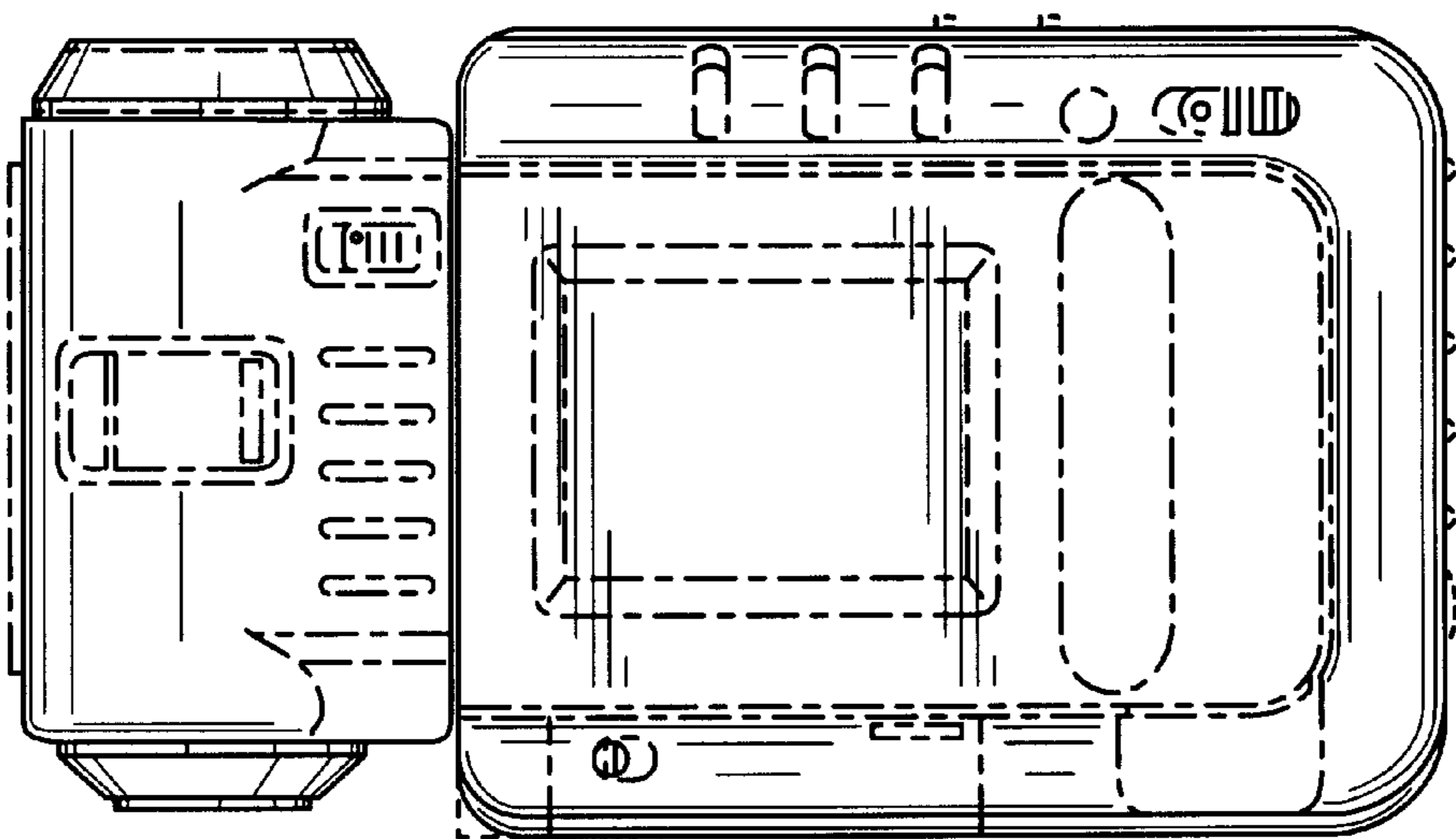

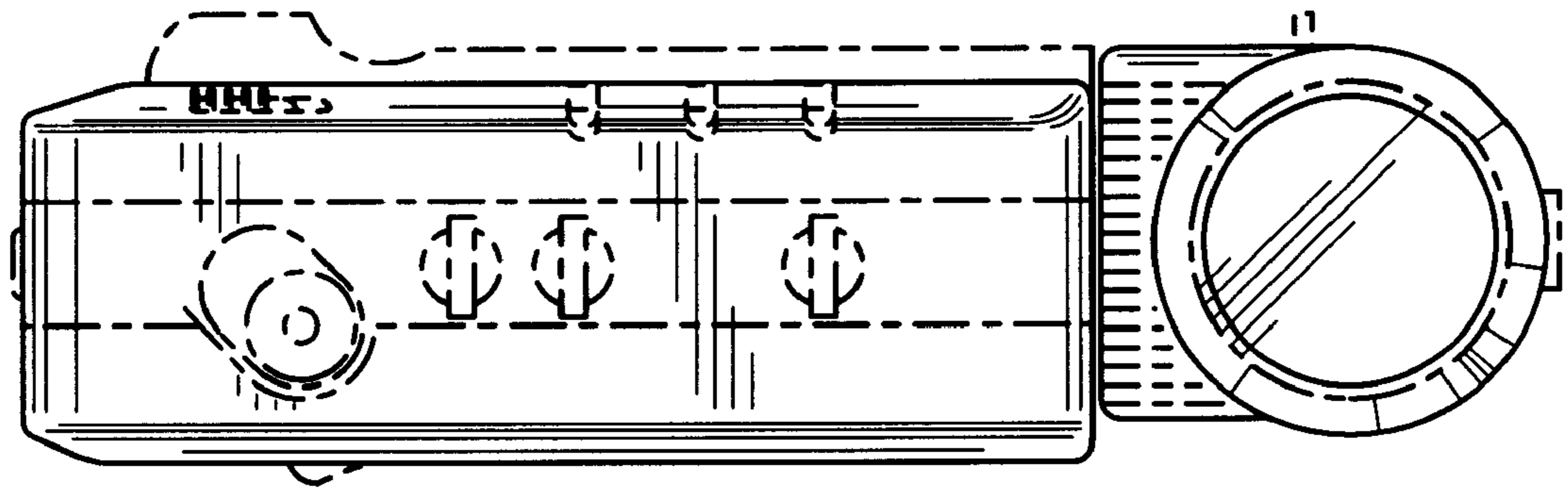

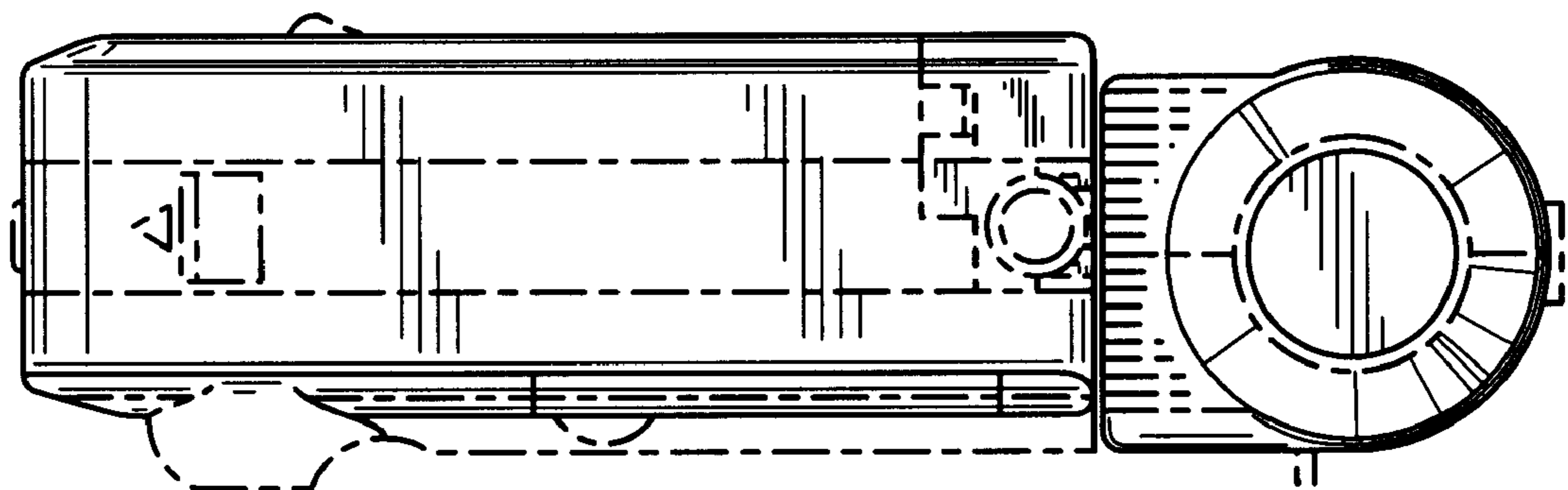

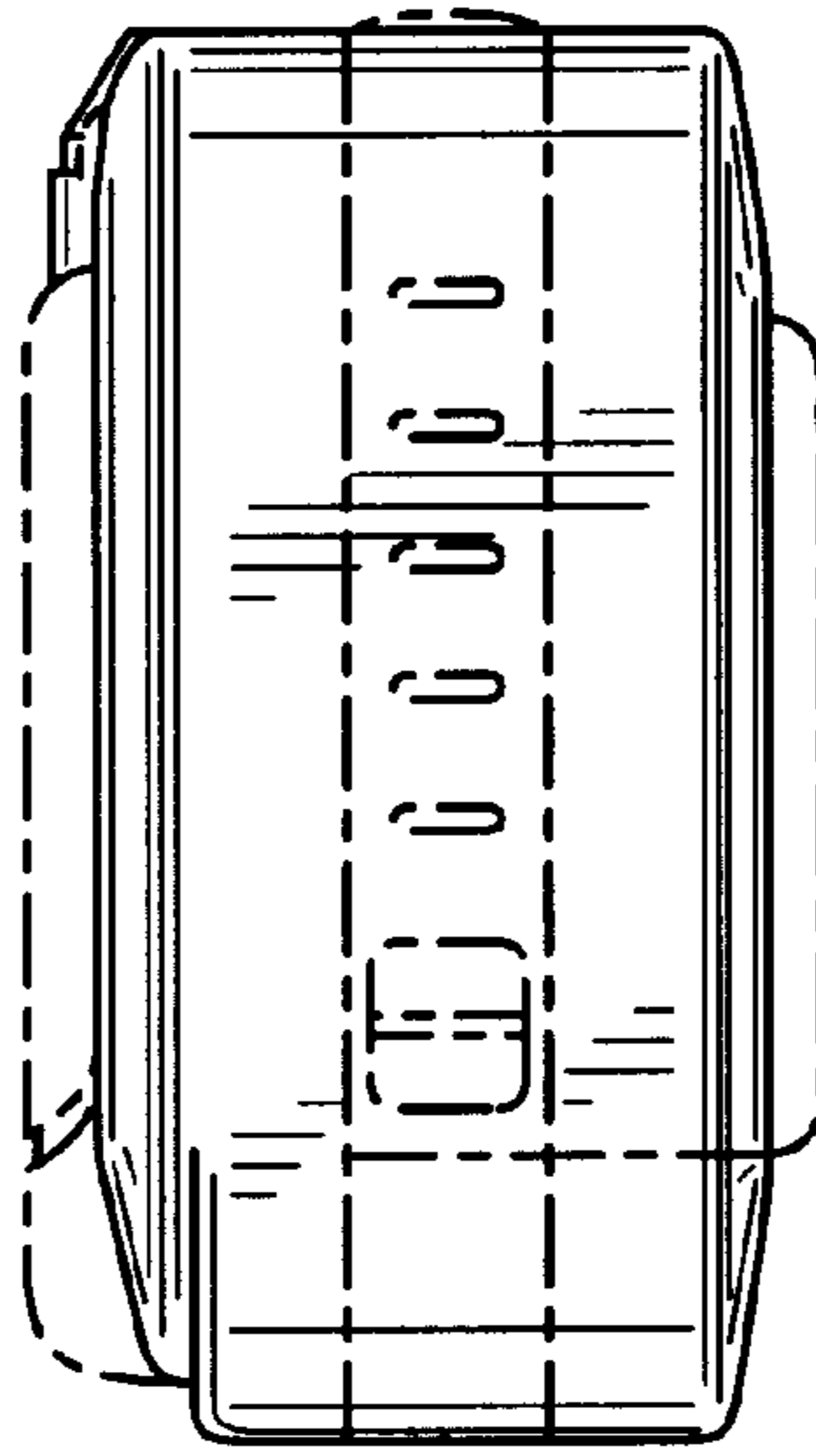

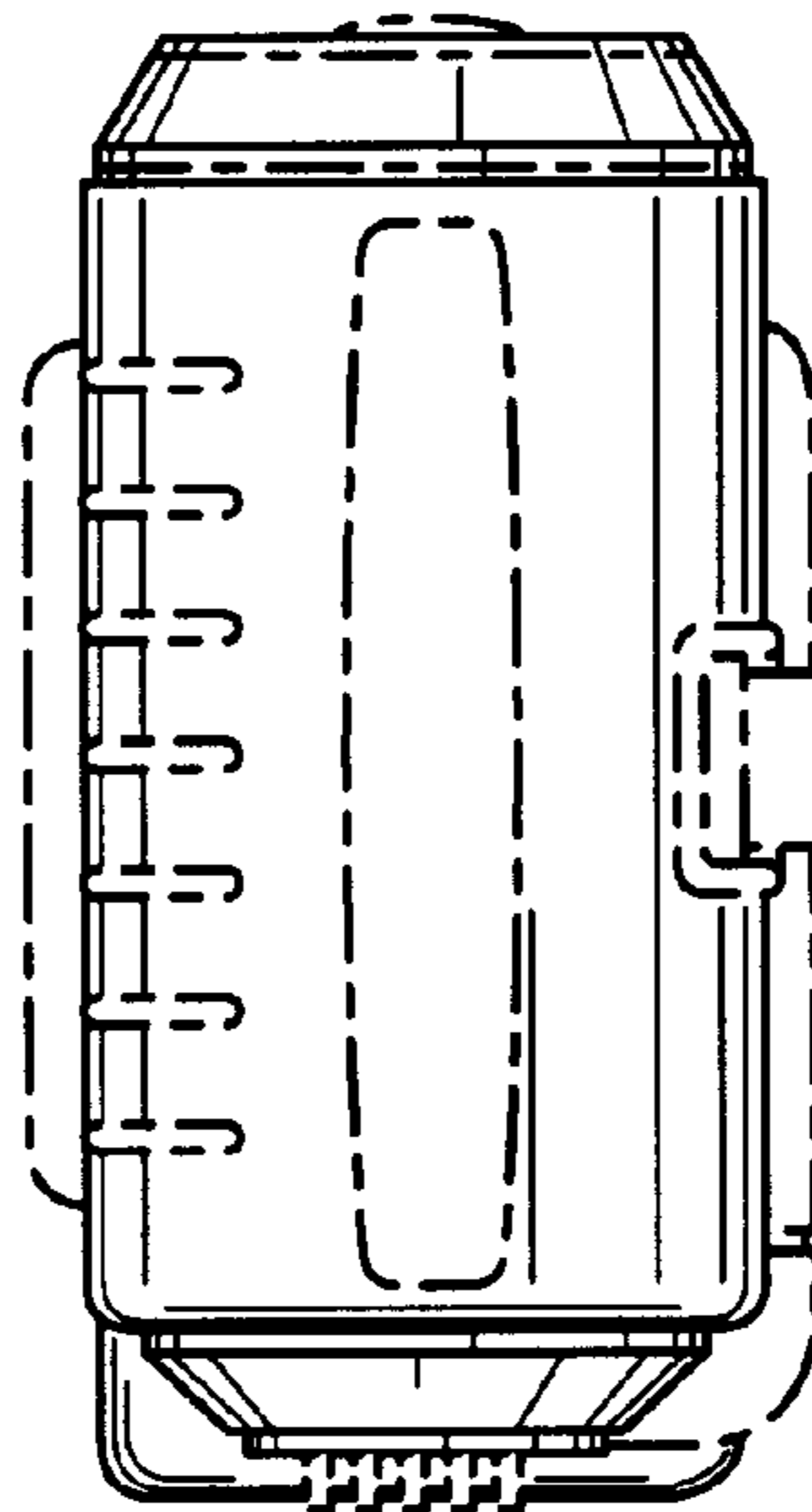

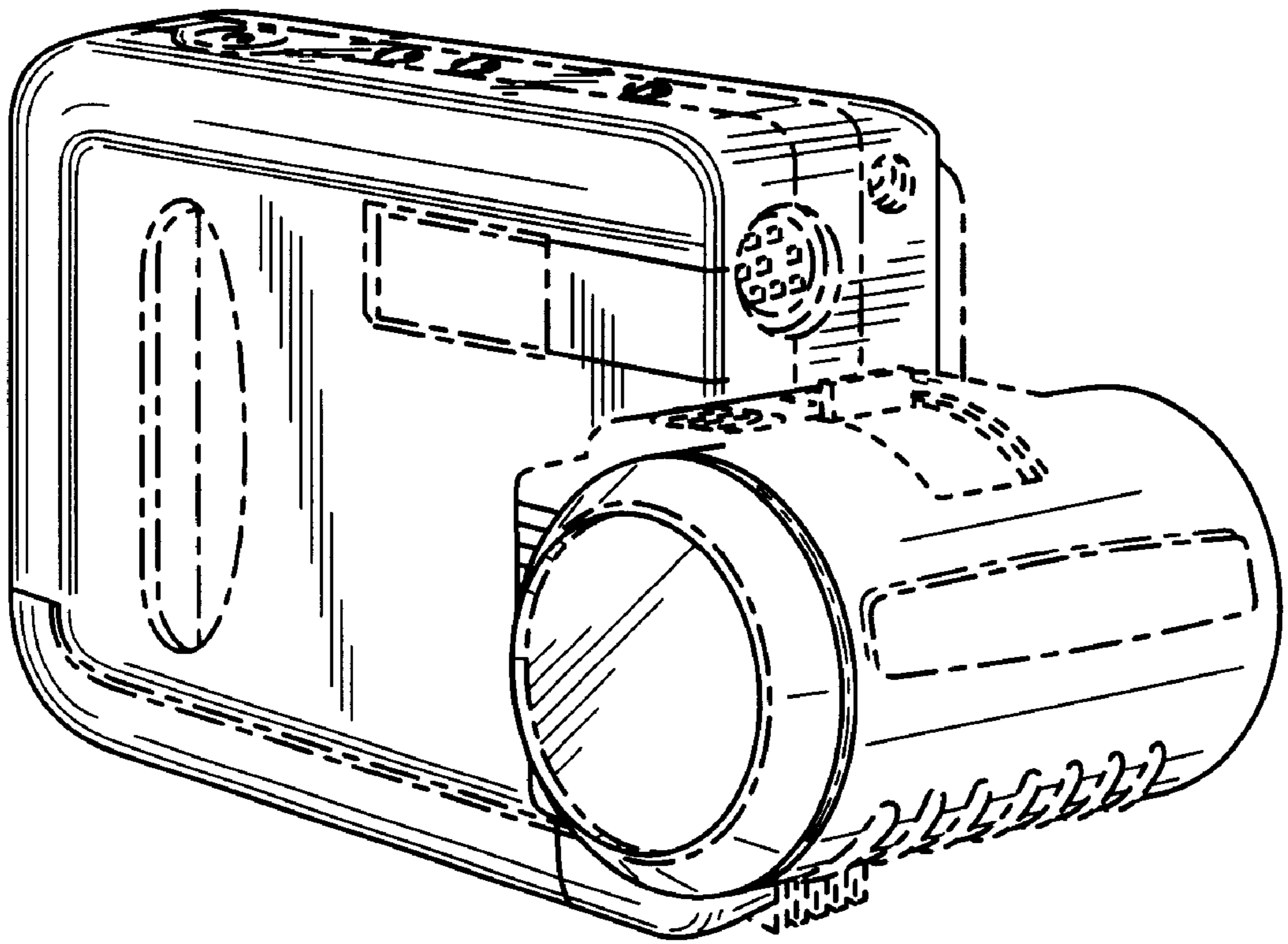

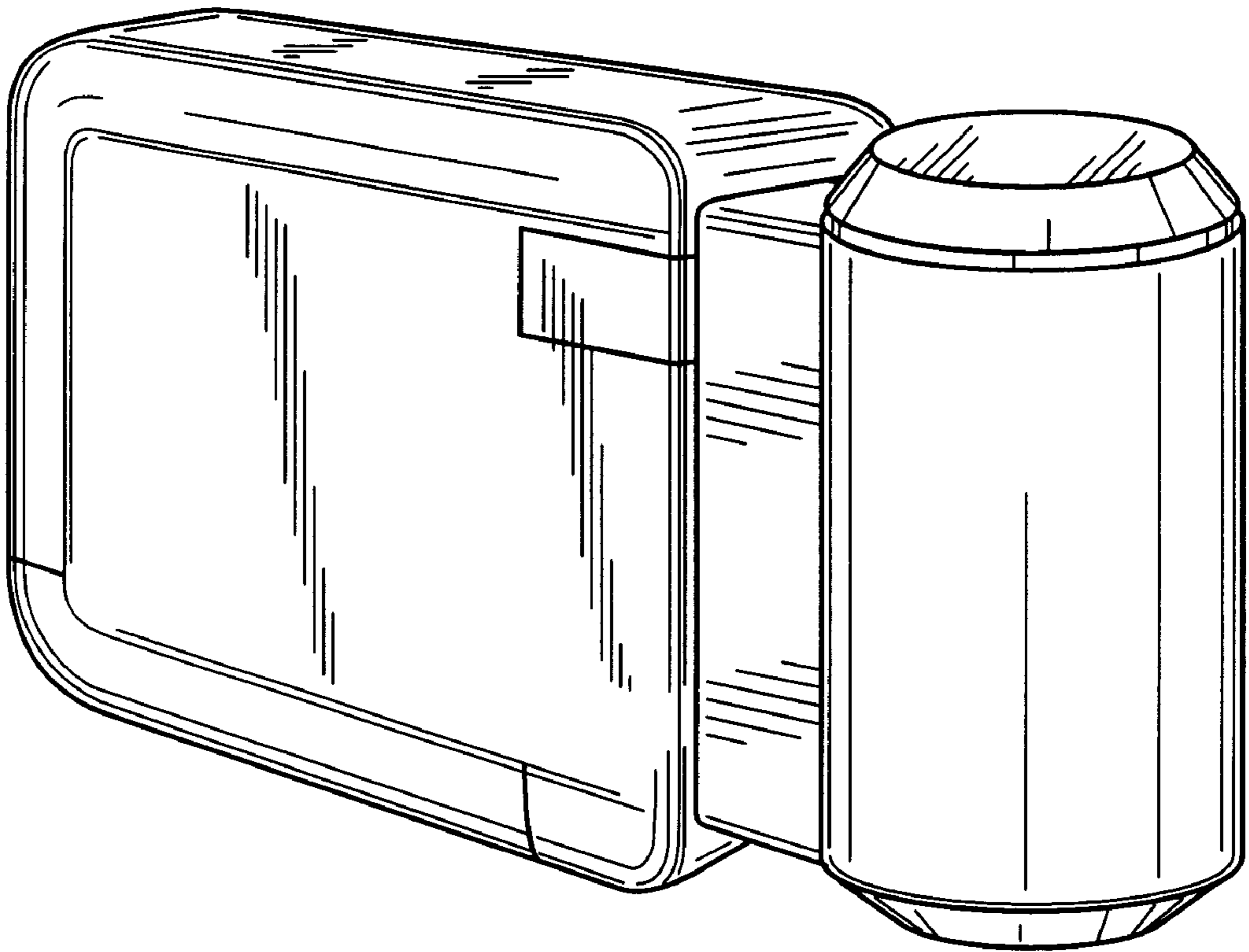

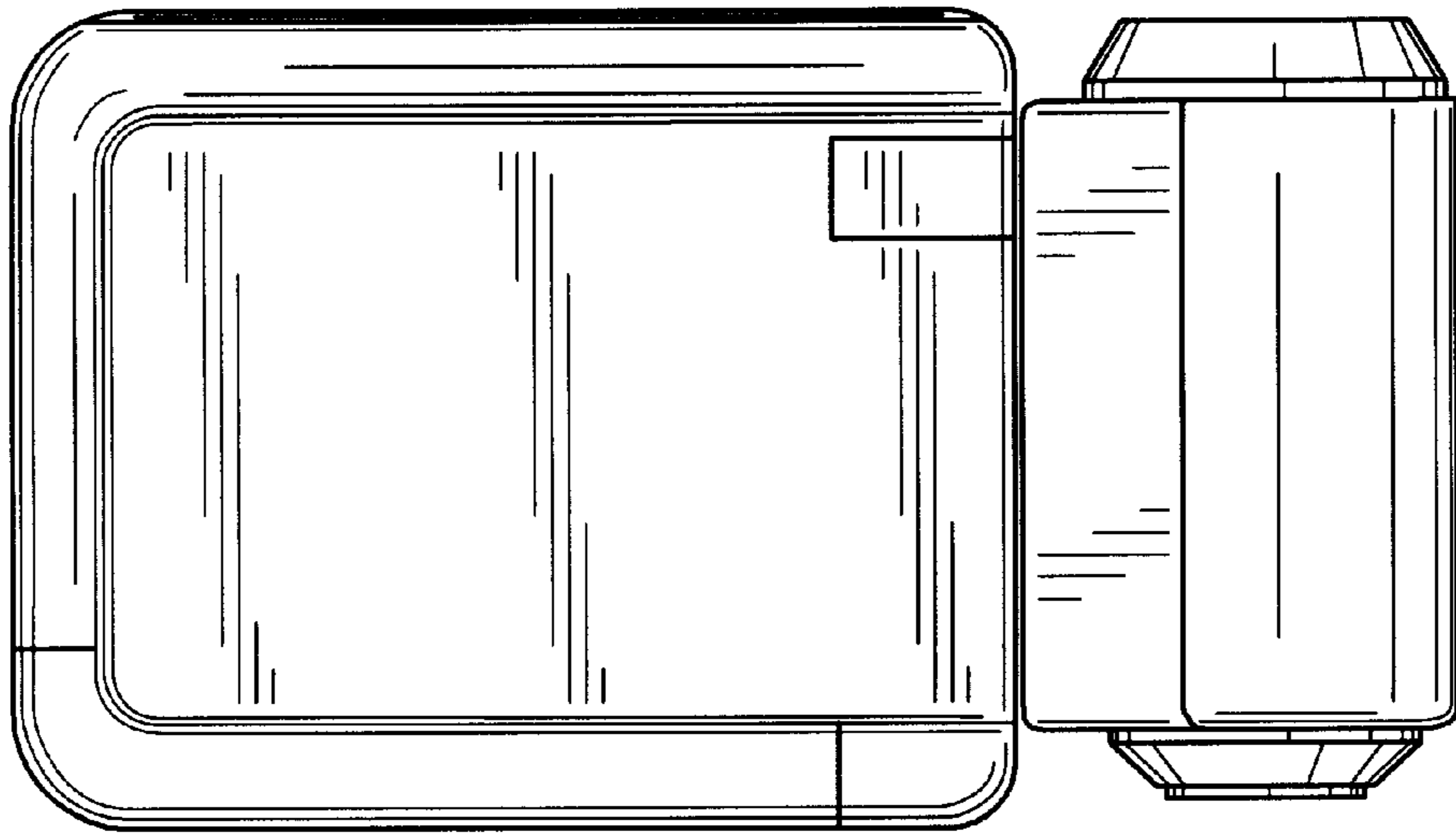

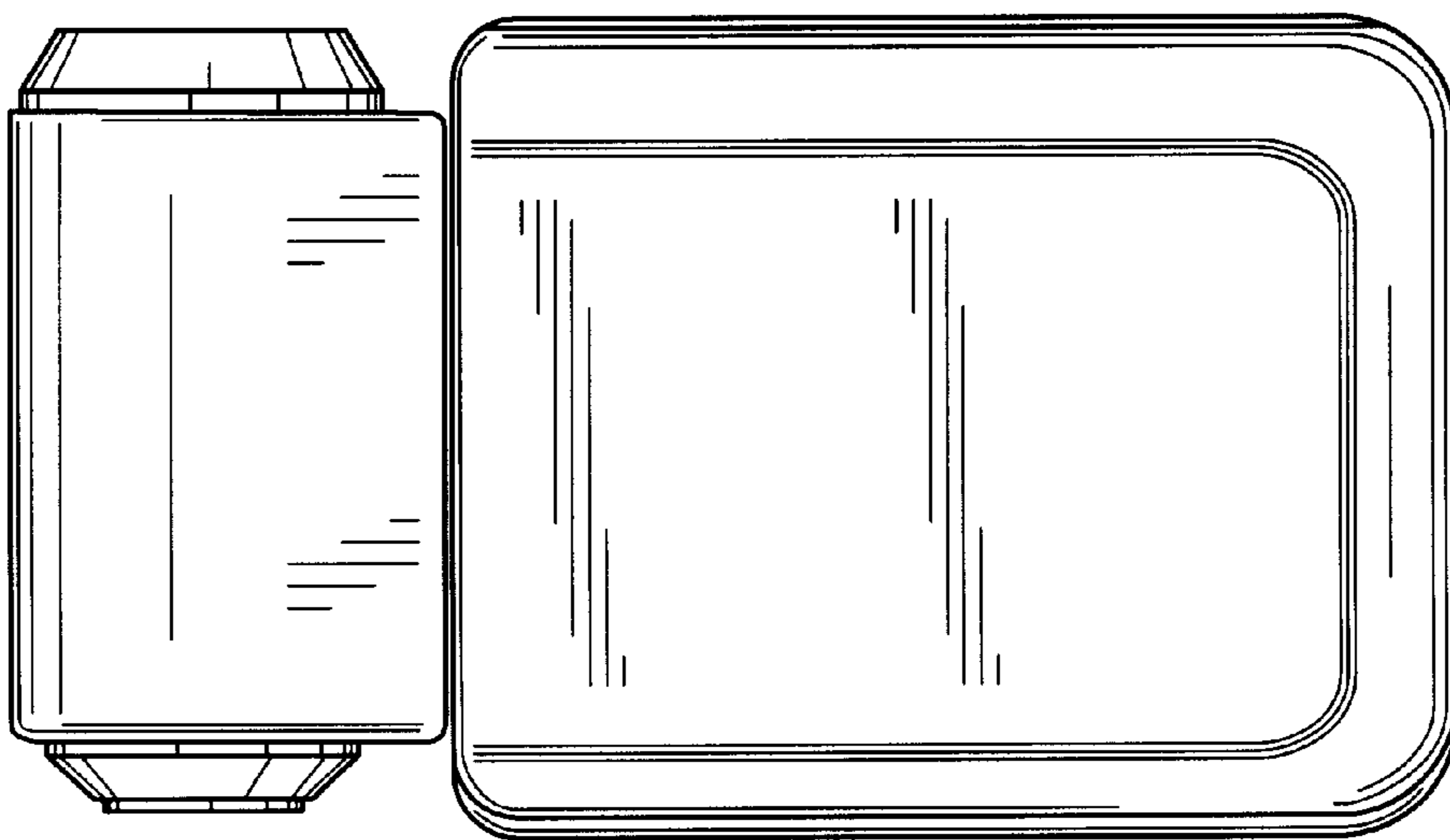

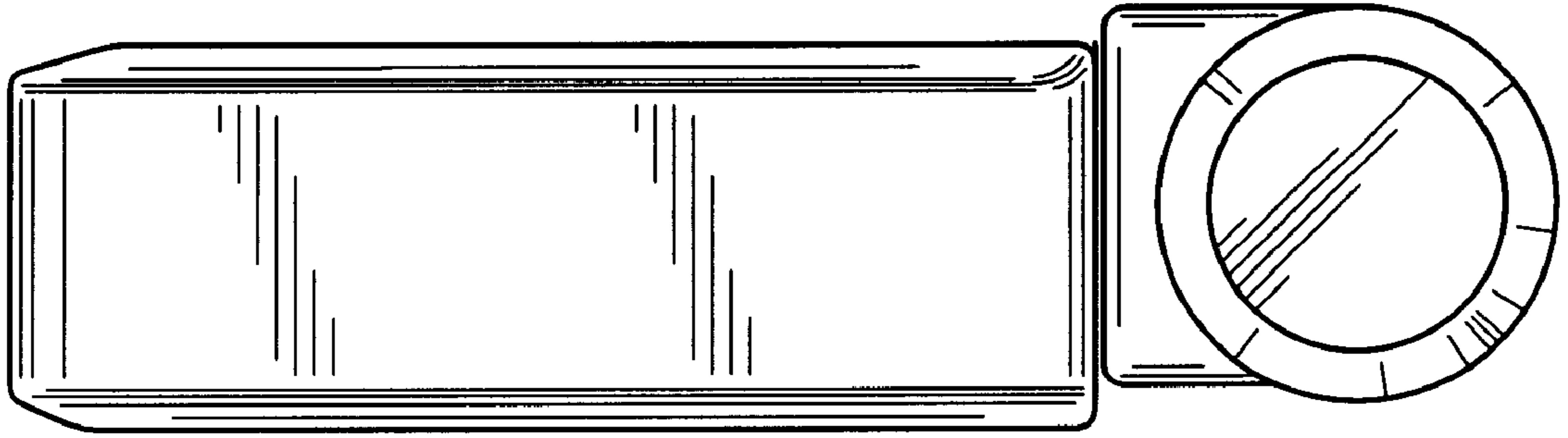

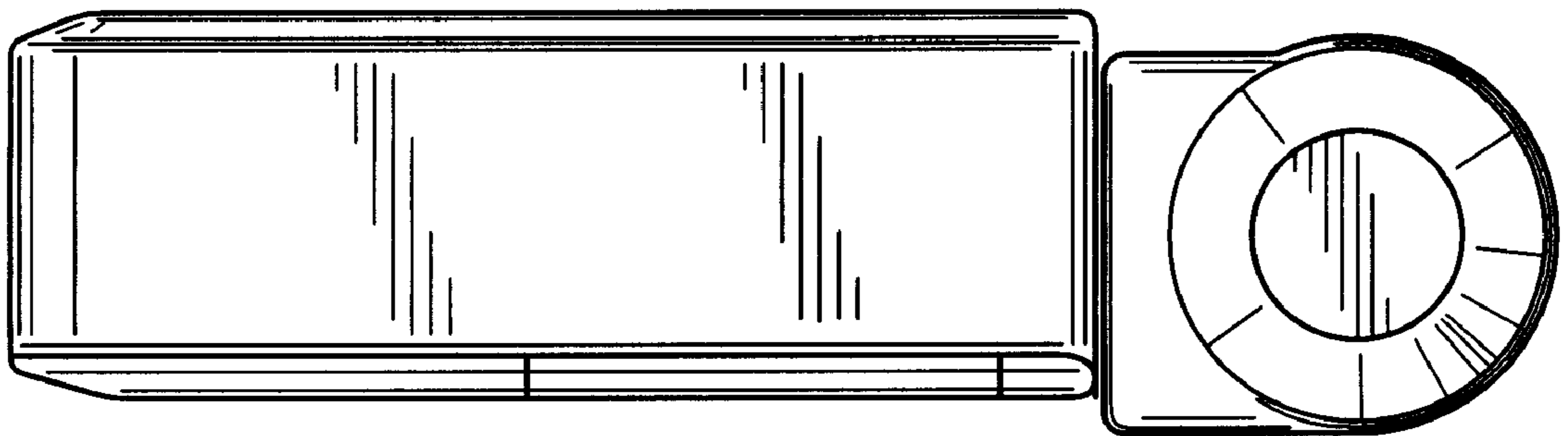

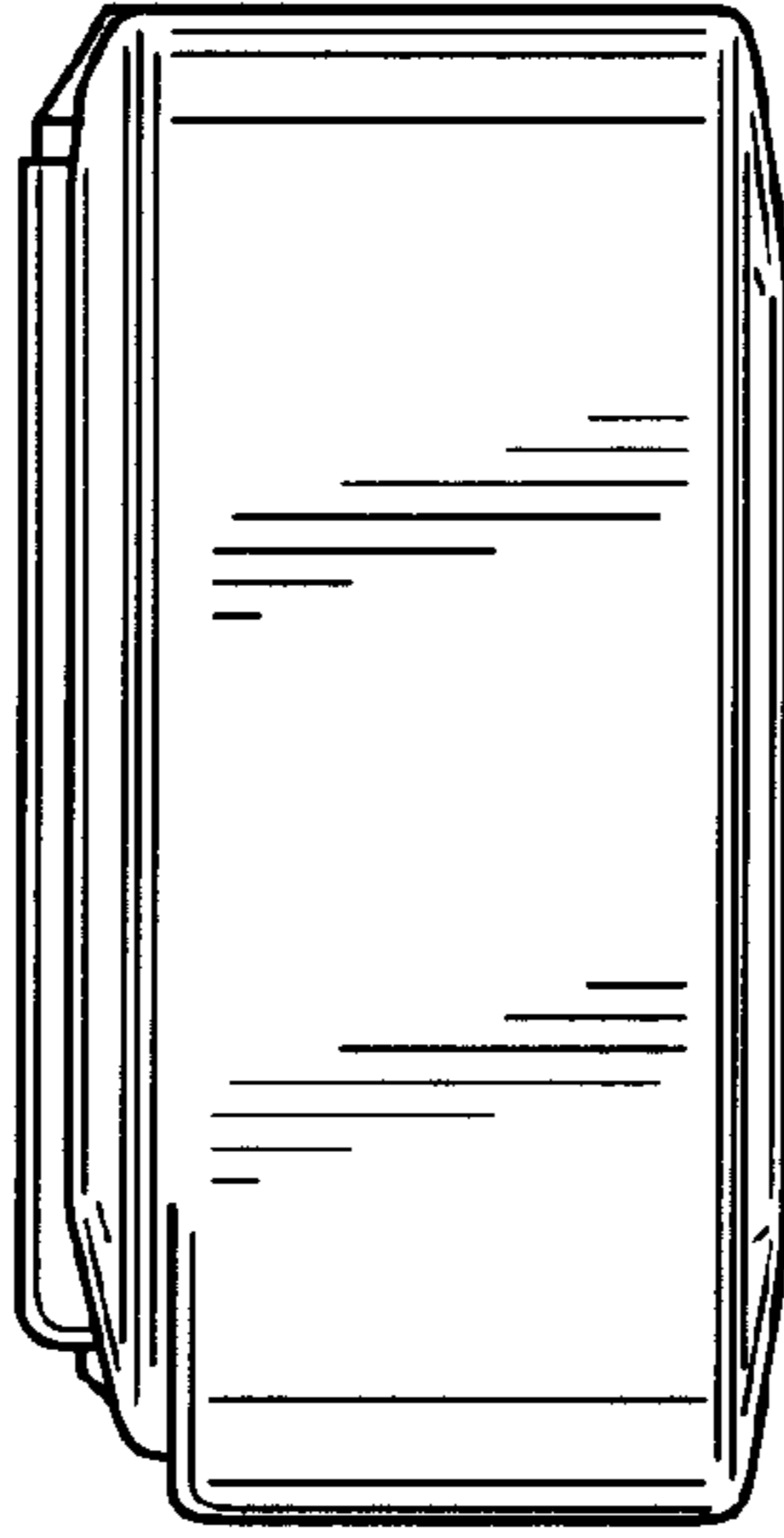

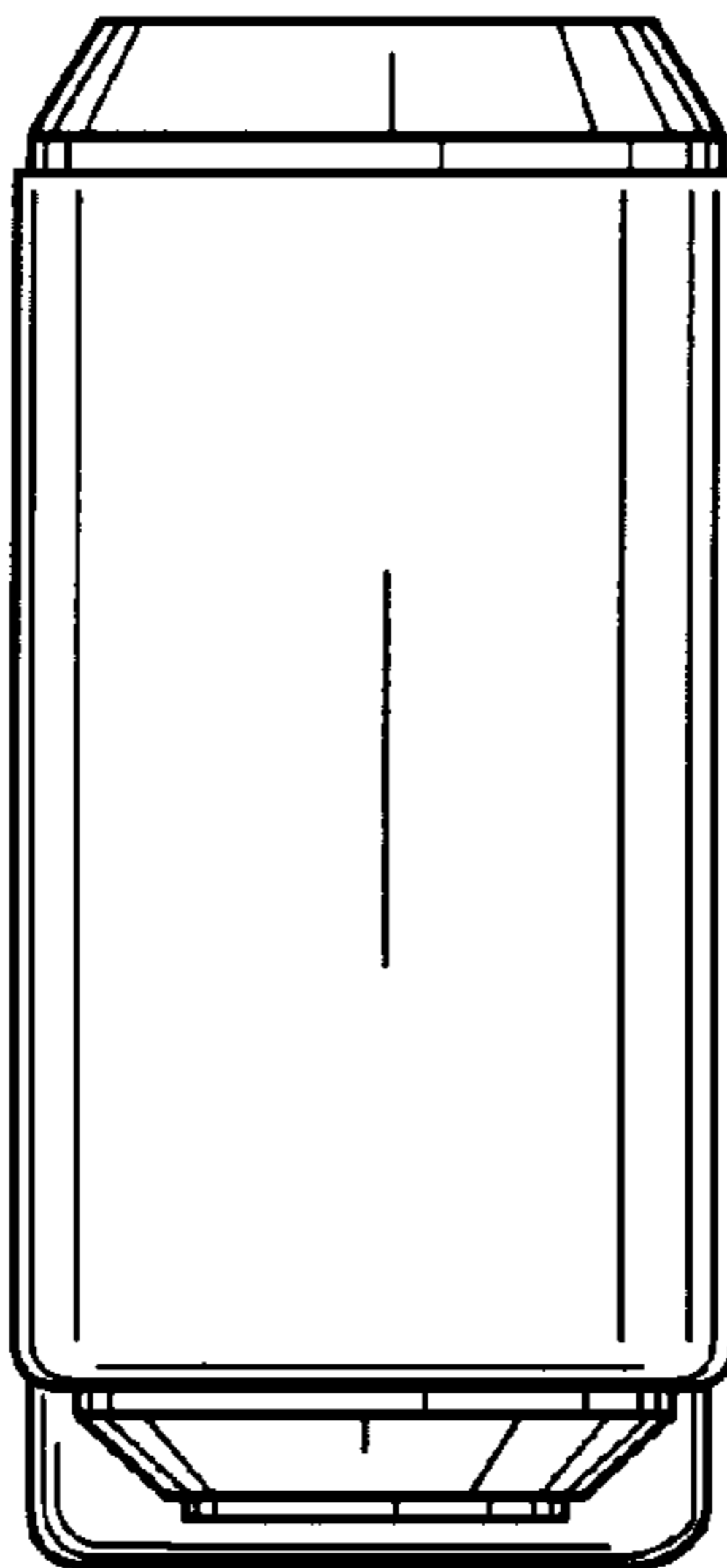

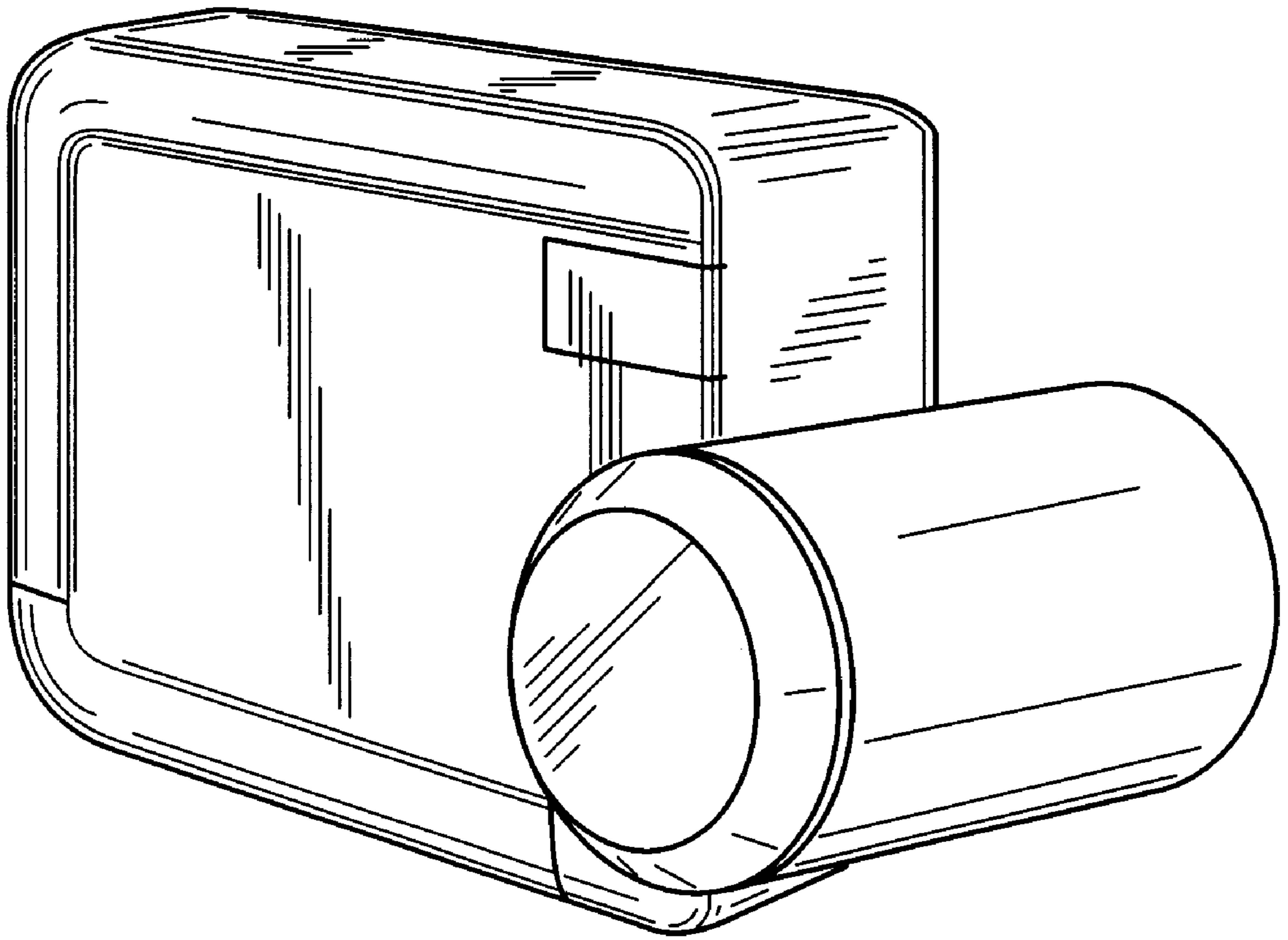
