[57] **CLAIM**

The ornamental design for a block for a flower bed, as shown and described.

DESCRIPTION

FIG. 1 is a plan view showing a block for a flower bed; FIG. 2 is a front elevational view thereof; FIG. 3 is a bottom plan view thereof; FIG. 4 is a left side elevational view, it being understood that the right side is a mirror image thereof; FIG. 5 is a rear elevational view thereof; and, FIG. 6 is a sectional view taken along line A—A of FIG. 1.

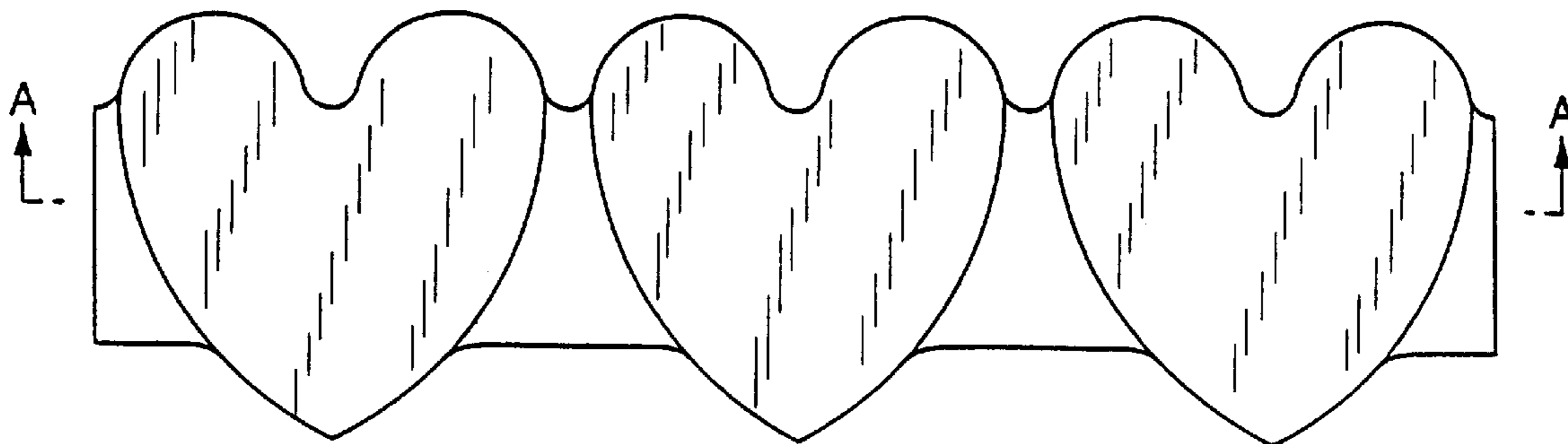

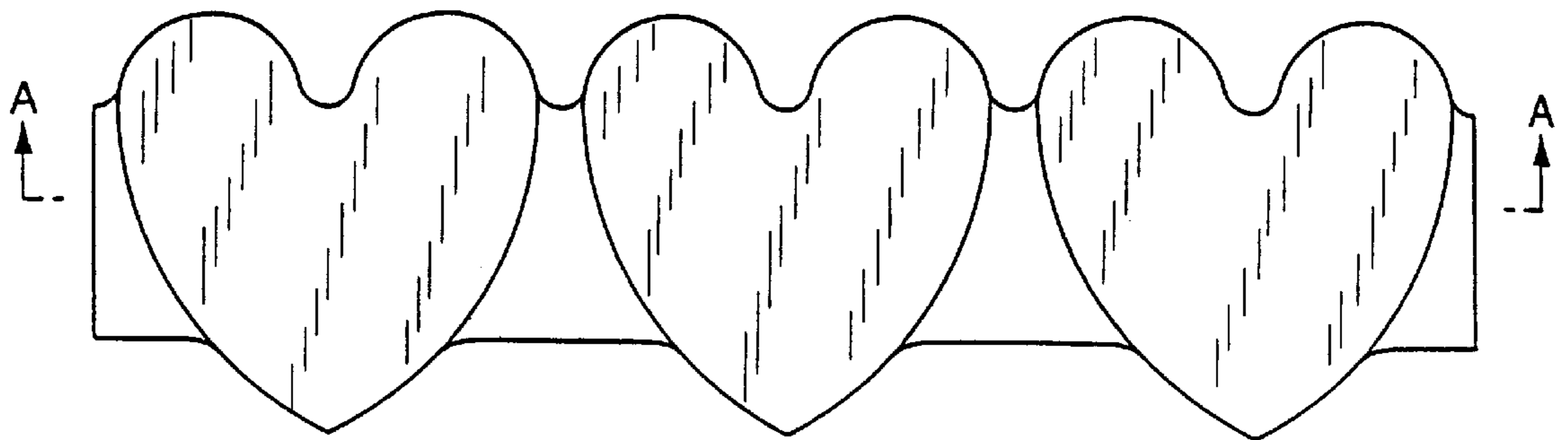

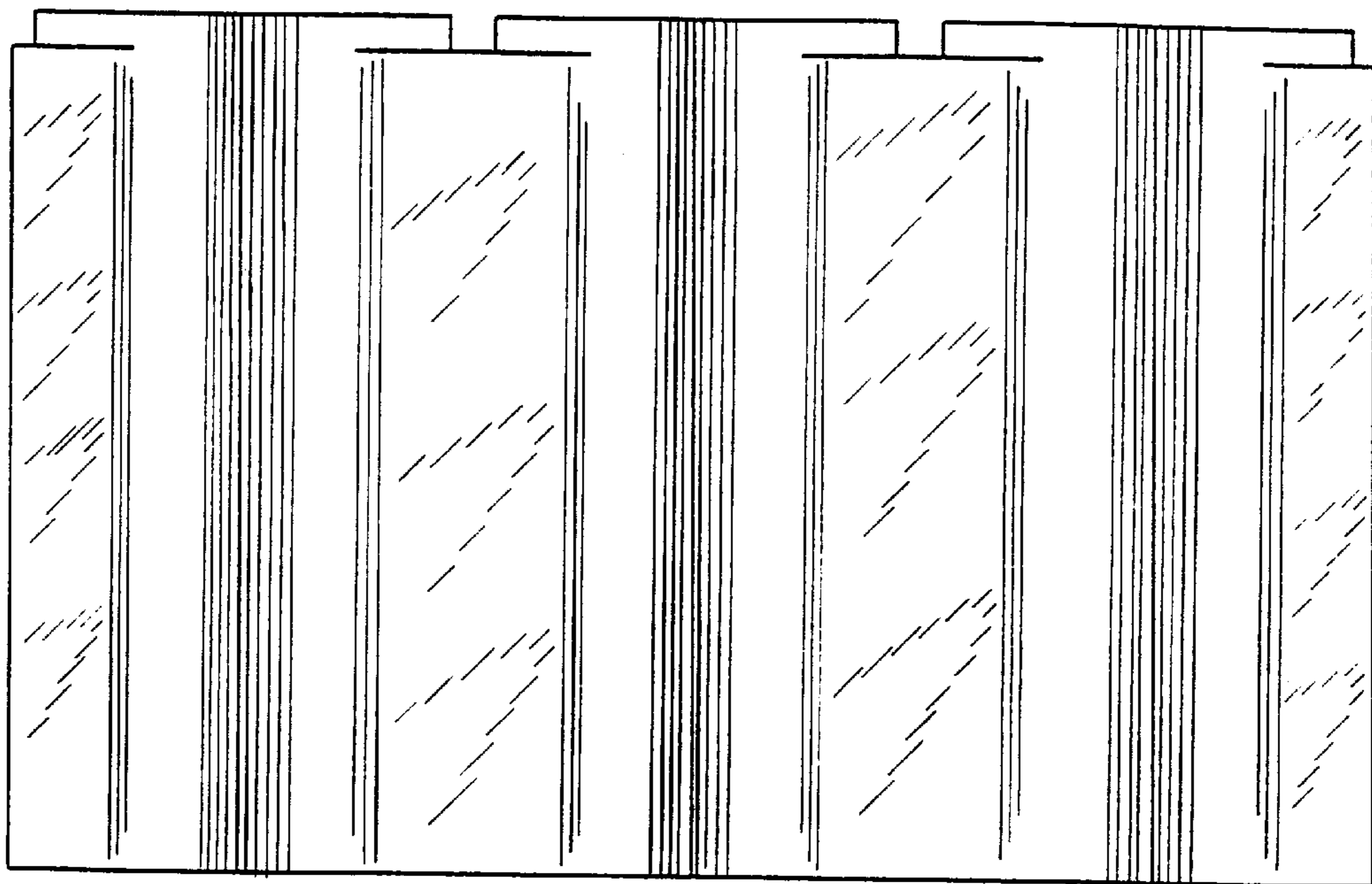

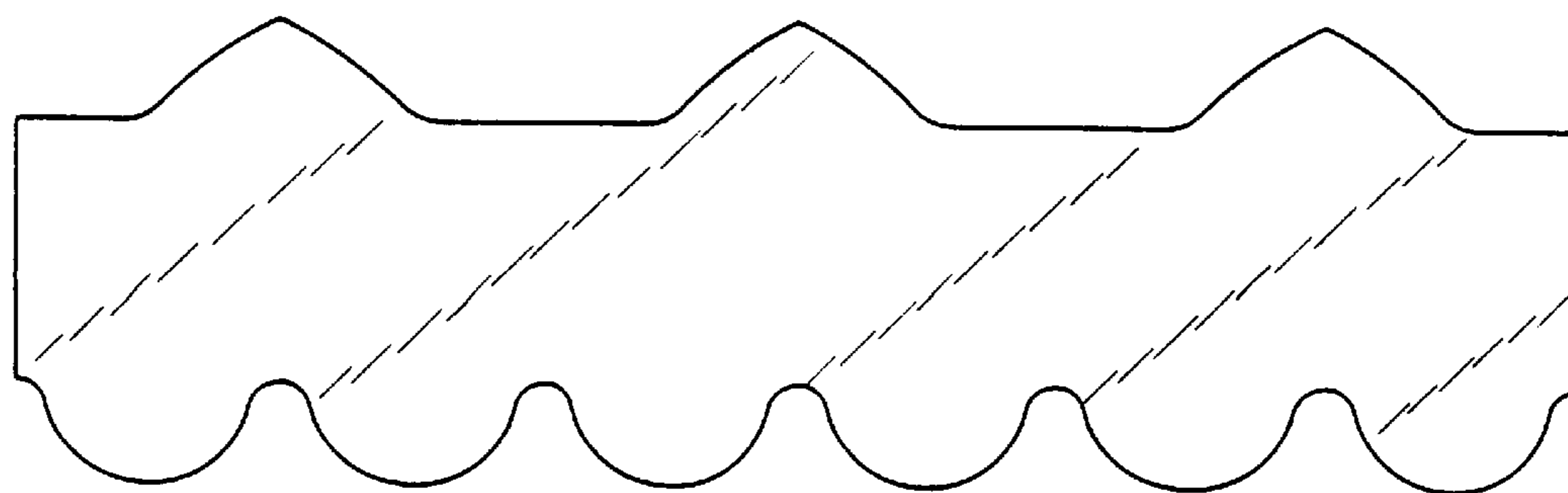

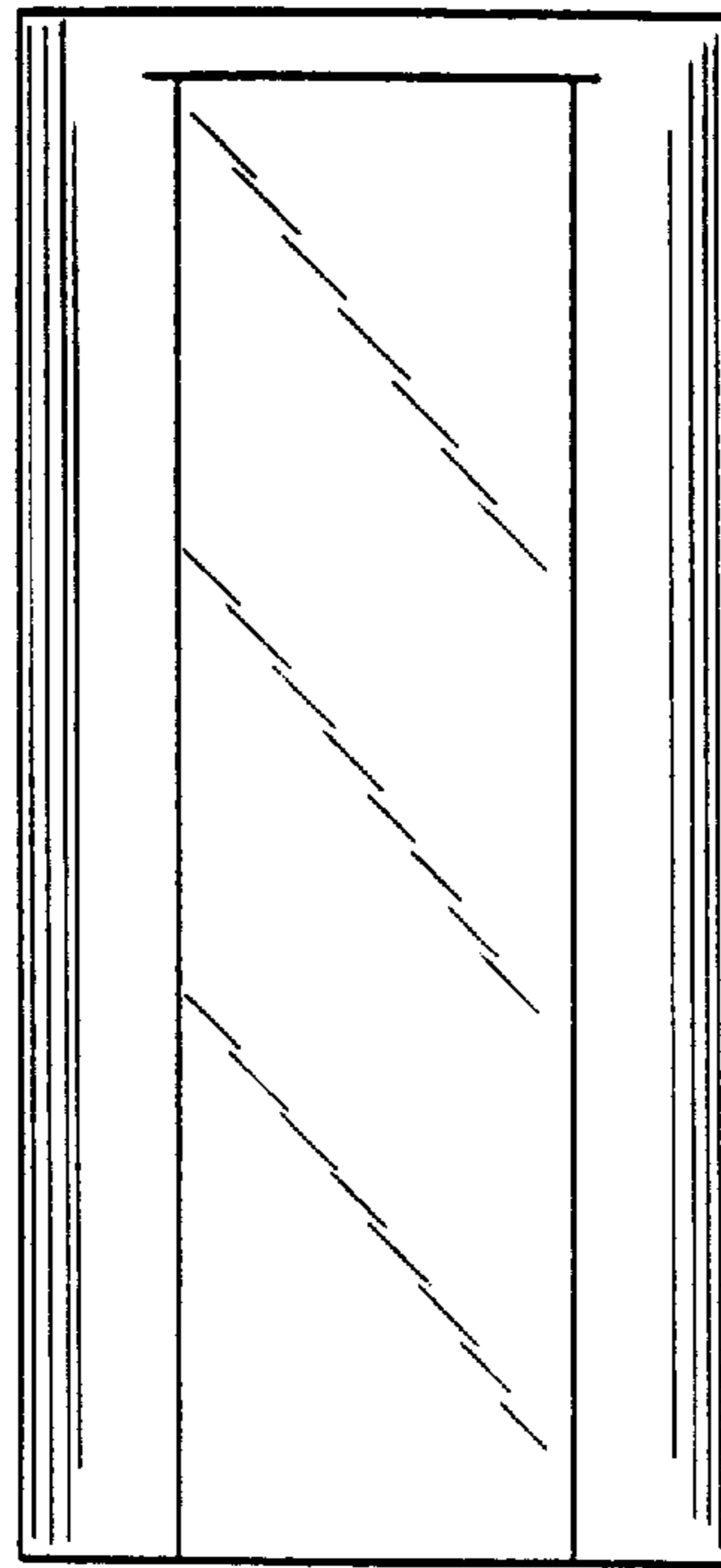

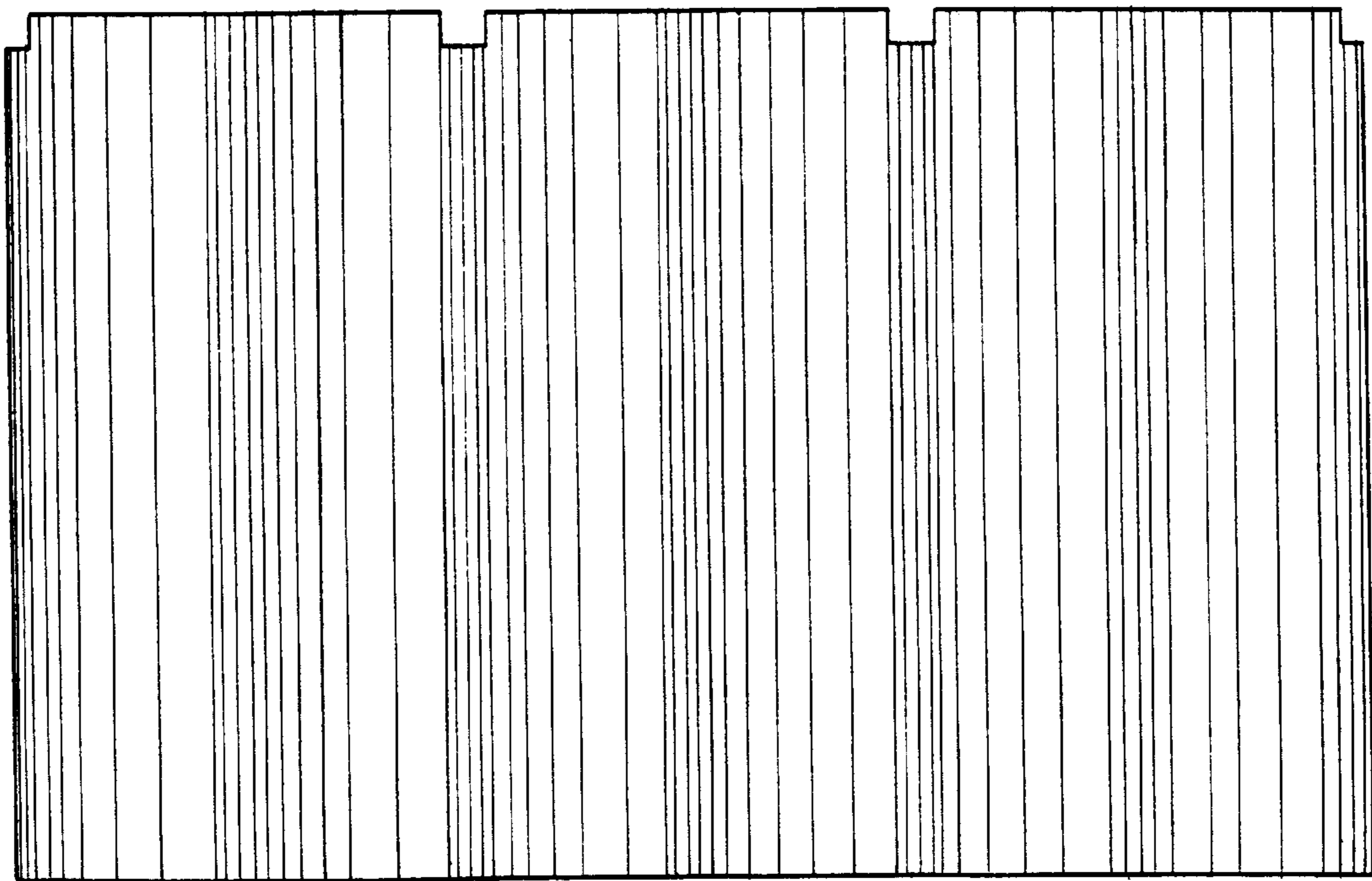
