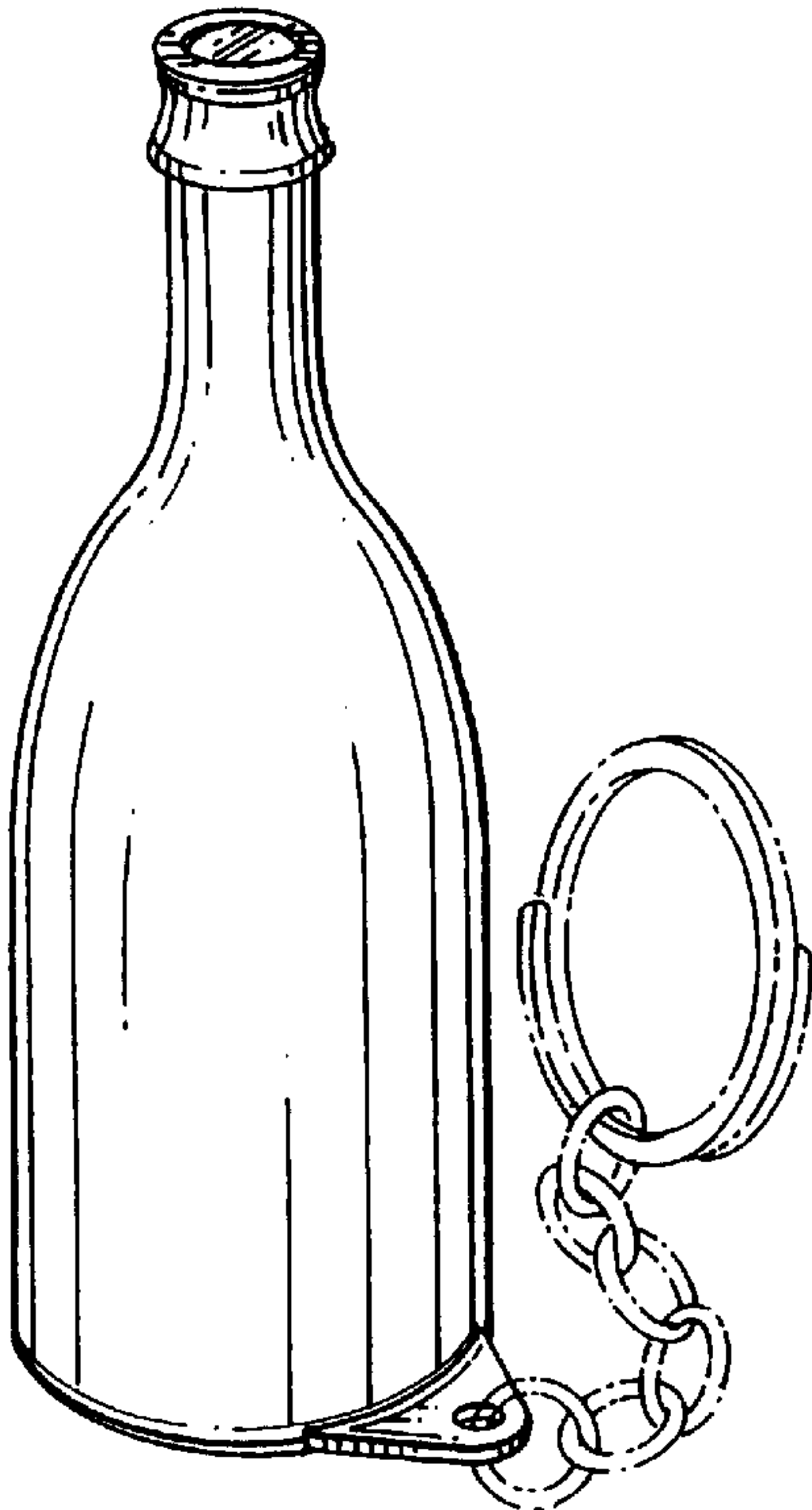
[57] **CLAIM**

The ornamental design for a replica bottle light, as shown and described.

DESCRIPTION

FIG. 1 is a top, left perspective view of a replica bottle light showing my new design;
FIG. 2 is a right side view thereof, the left side being a mirror image;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a perspective view of a second embodiment thereof;
FIG. 6 is a perspective view of a third embodiment thereof;
FIG. 7 is a perspective view of a fourth embodiment thereof;
FIG. 8 is a top, left perspective view of a fifth embodiment of FIG. 1;
FIG. 9 is a right side view thereof, the left side being a mirror image;
FIG. 10 is a top plan view thereof;
FIG. 11 is a bottom plan view thereof;
FIG. 12 is a perspective view of a sixth embodiment thereof;
FIG. 13 is a perspective view of a seventh embodiment thereof;
FIG. 14 is a perspective view of a eighth embodiment thereof;
FIG. 15 is a top, left perspective view of a ninth embodiment of FIG. 1;
FIG. 16 is a right side view thereof, the left side being a mirror image, remaining views are as illustrated for FIG. 1;
FIG. 17 is a perspective view of a tenth embodiment thereof;
FIG. 18 is a perspective view of a eleventh embodiment thereof; and,
FIG. 19 is a perspective view of a twelfth embodiment.

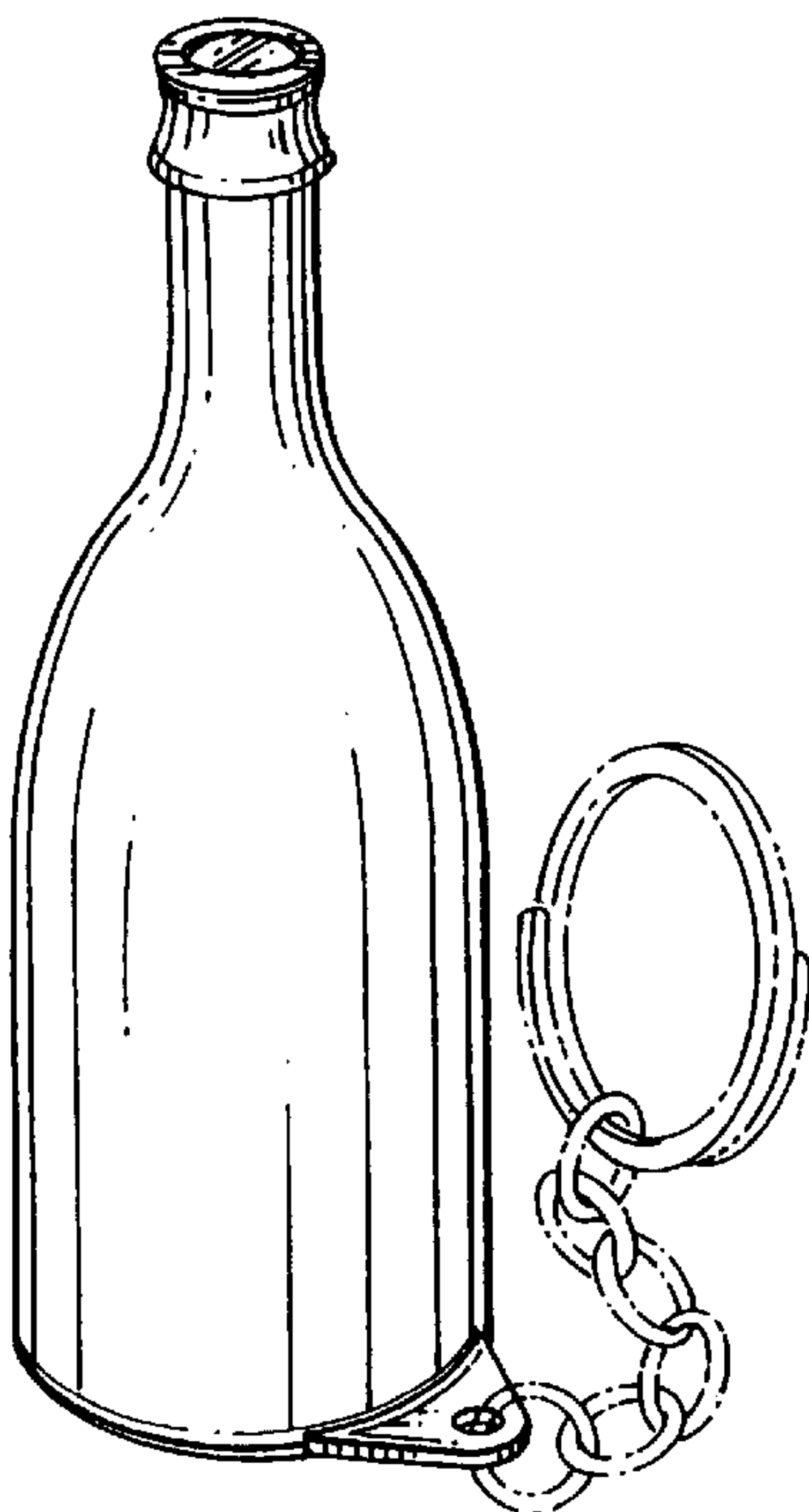

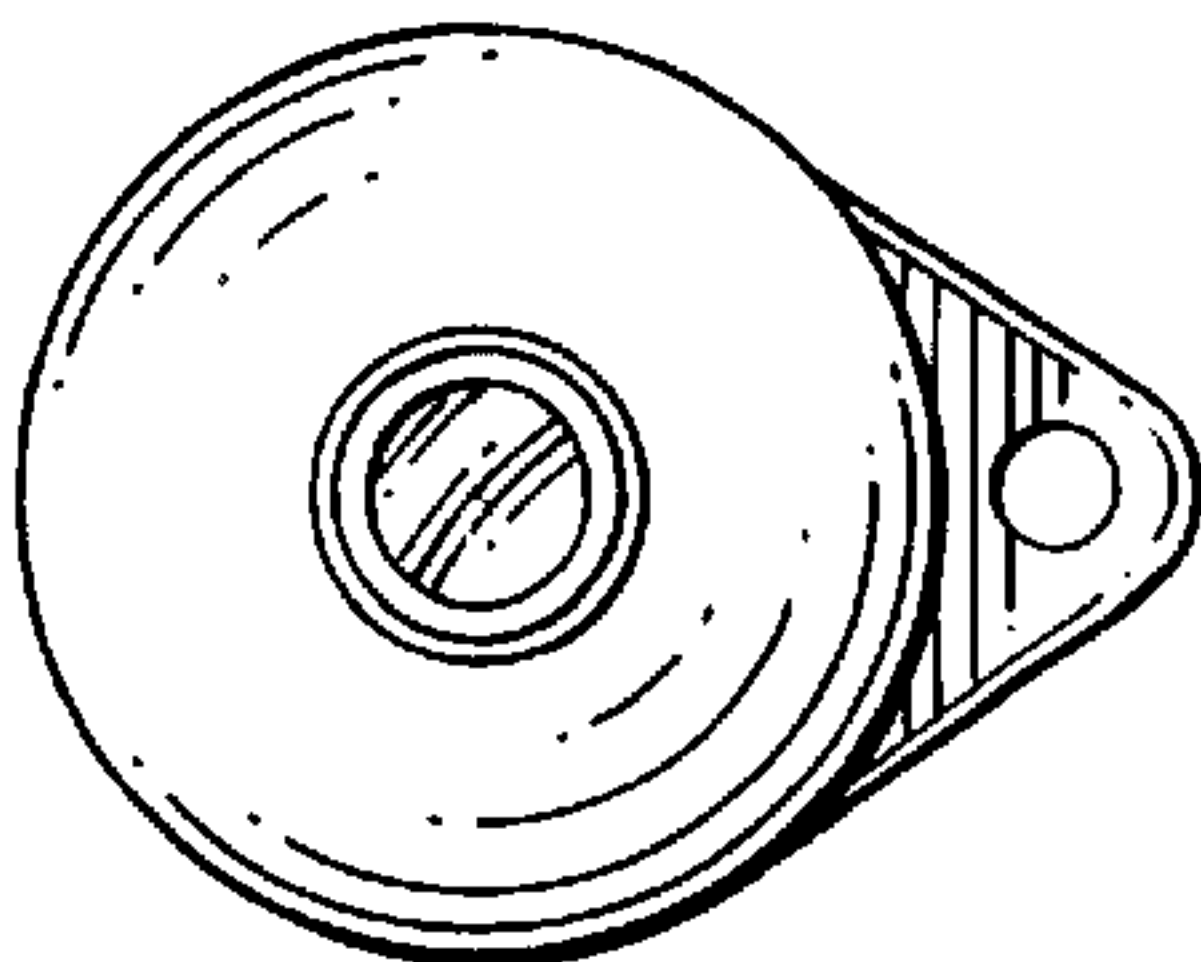

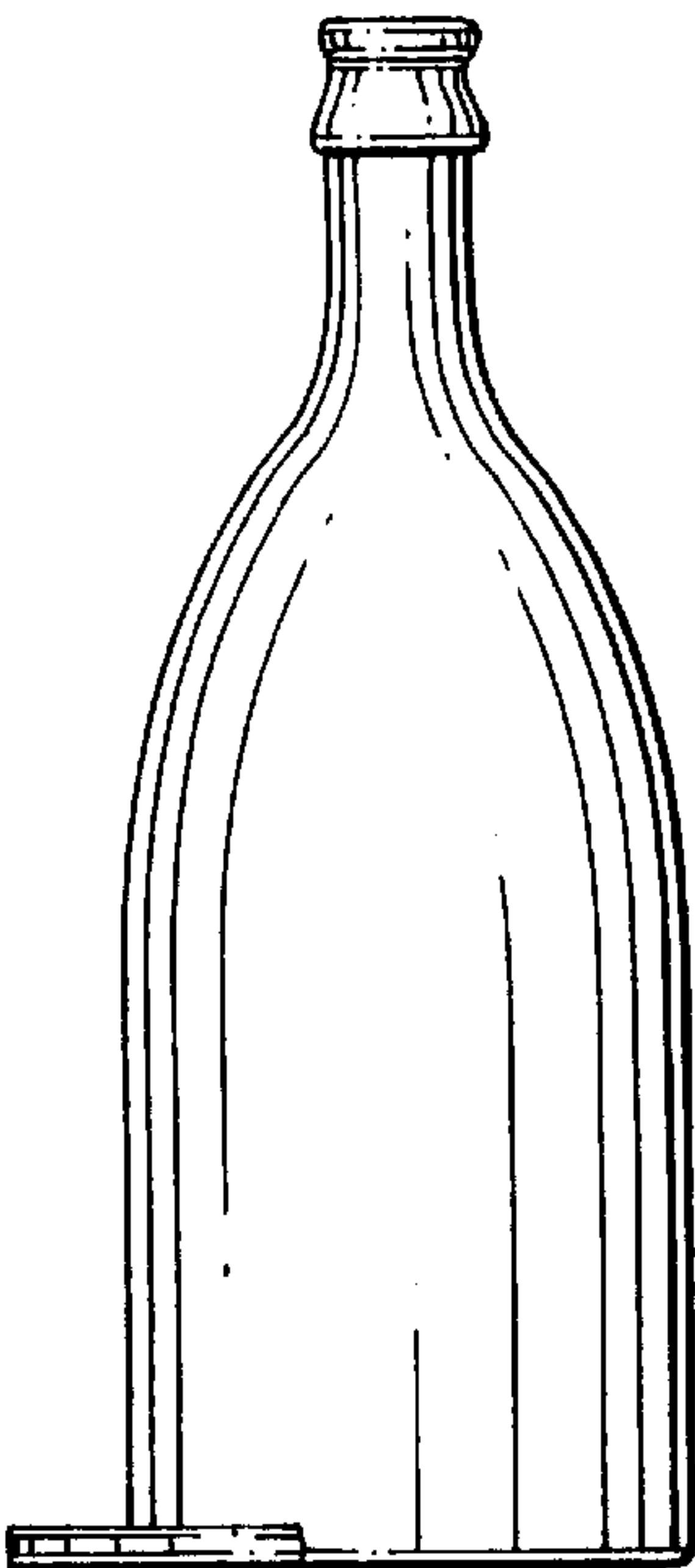

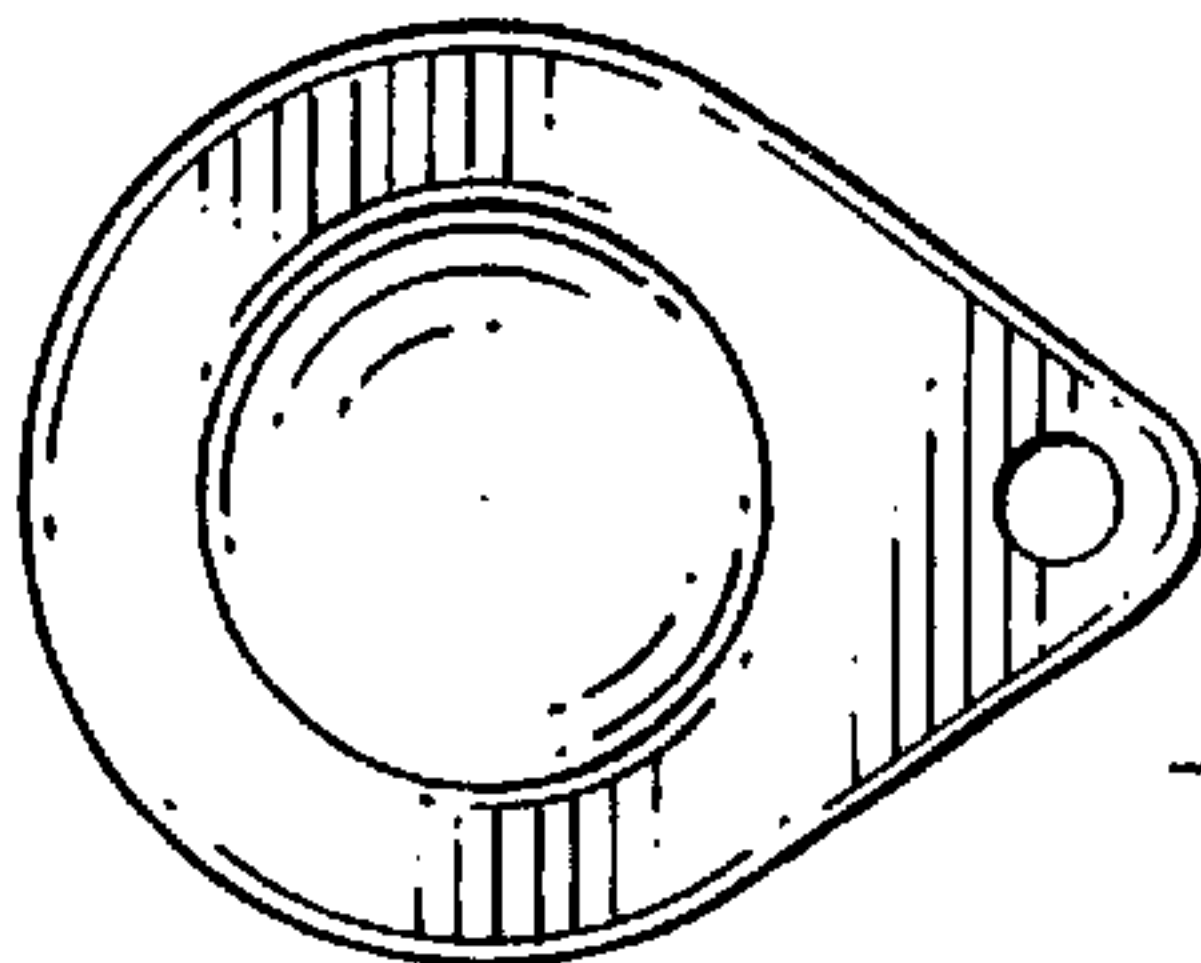

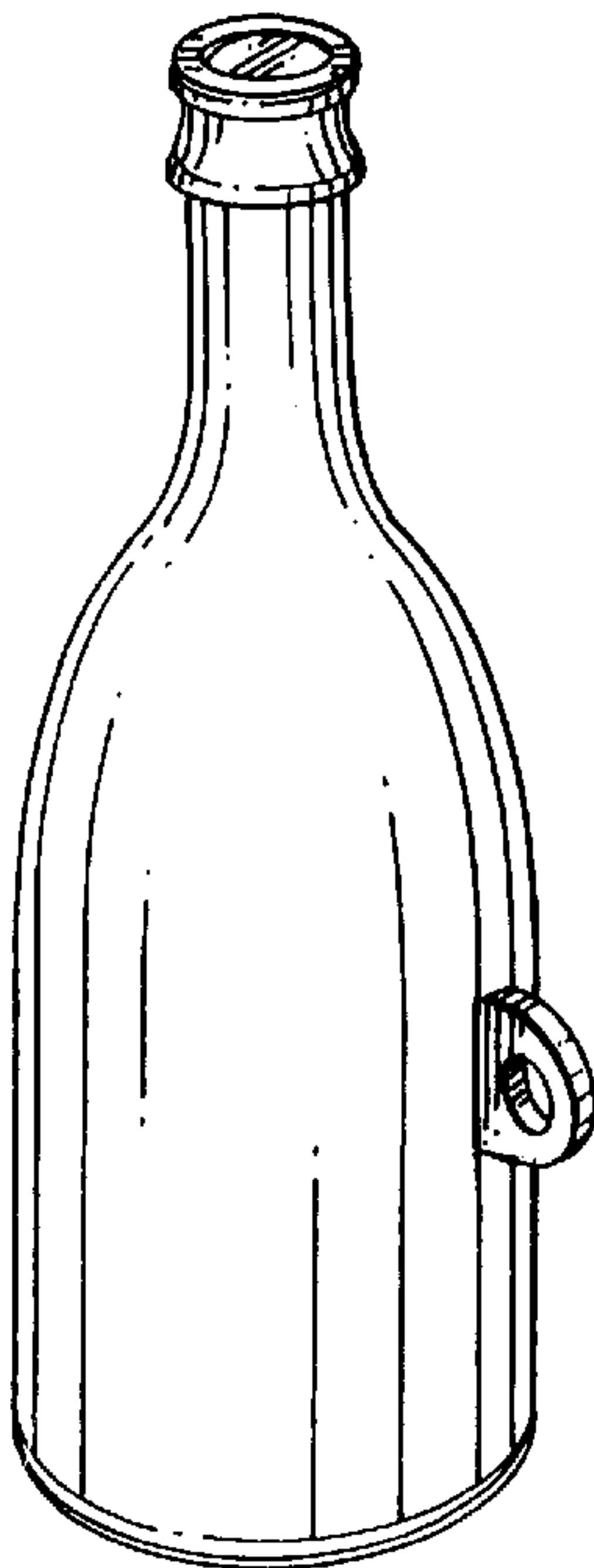

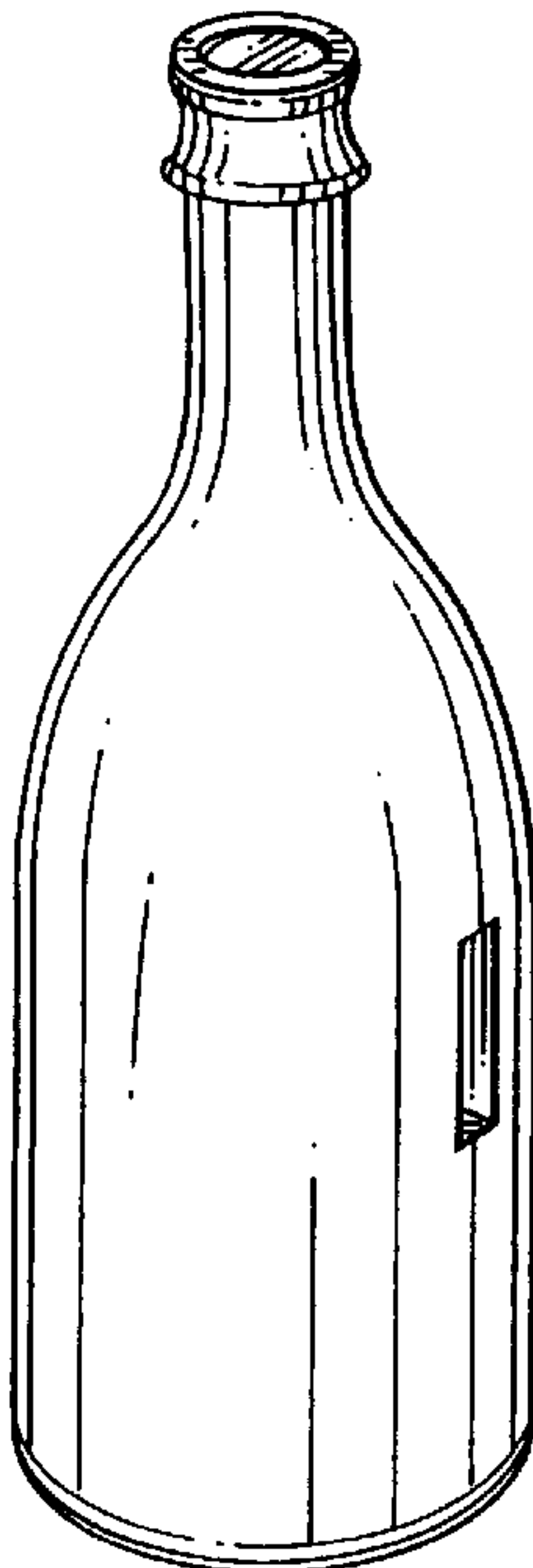

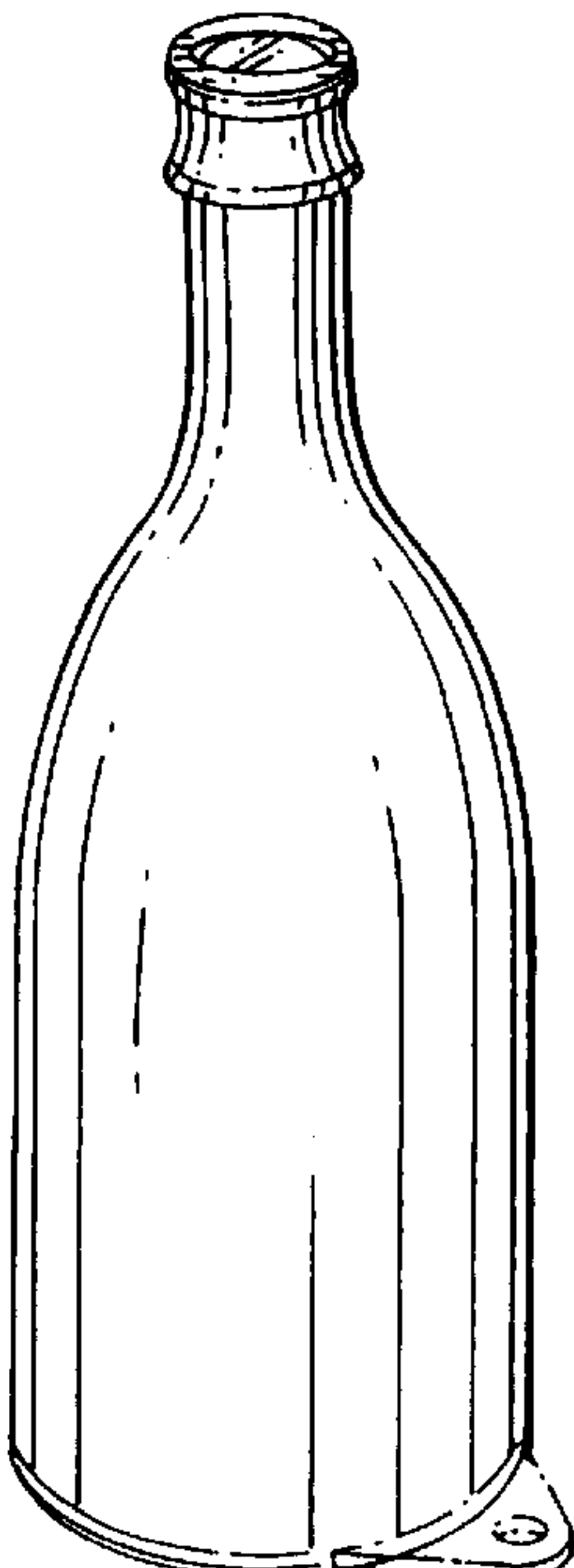

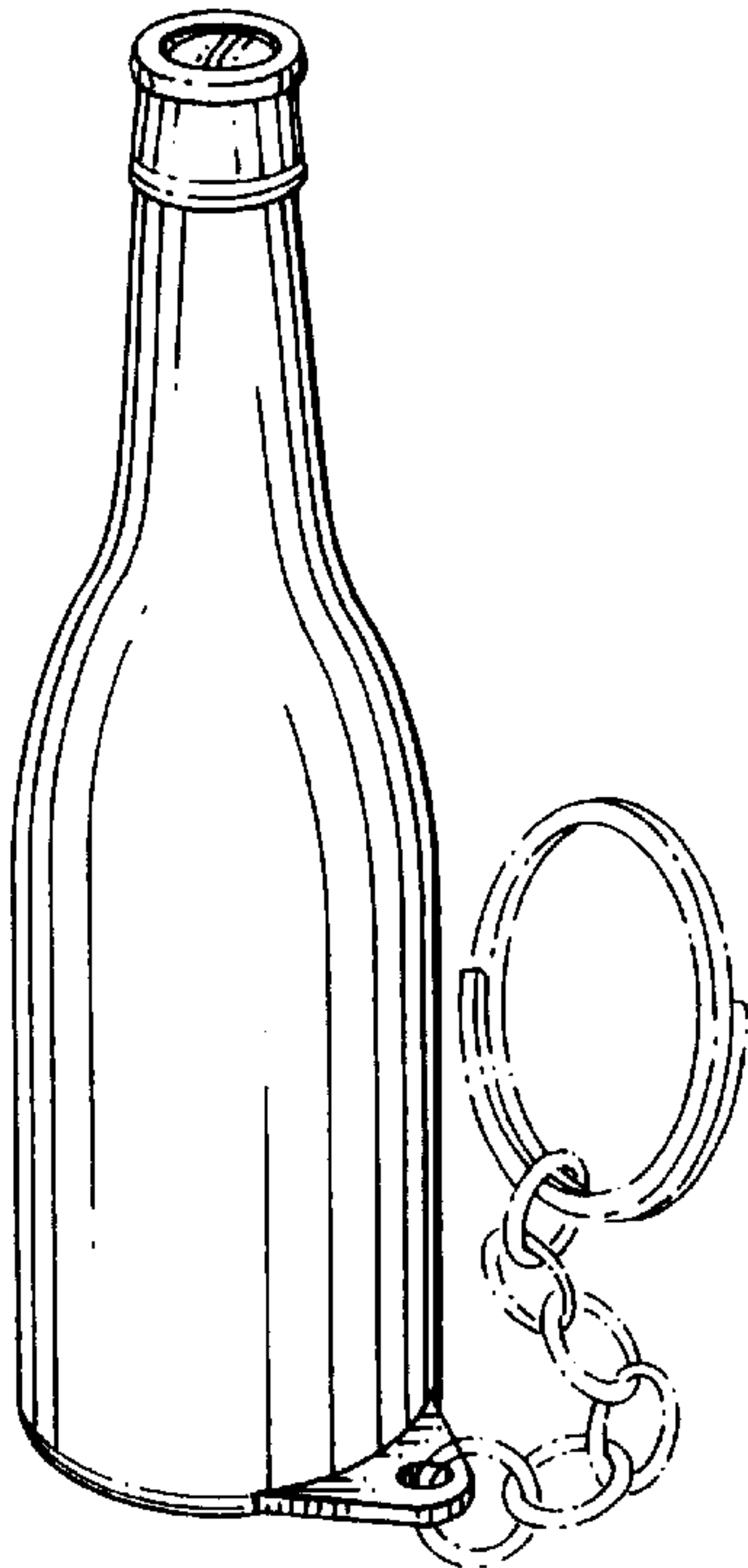

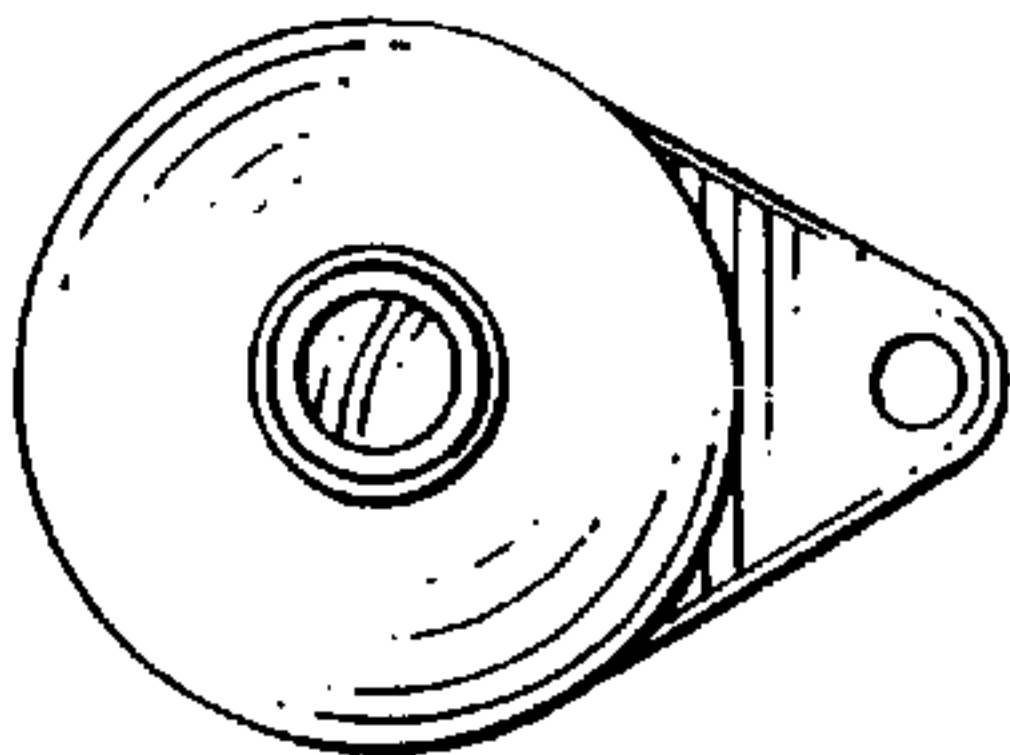

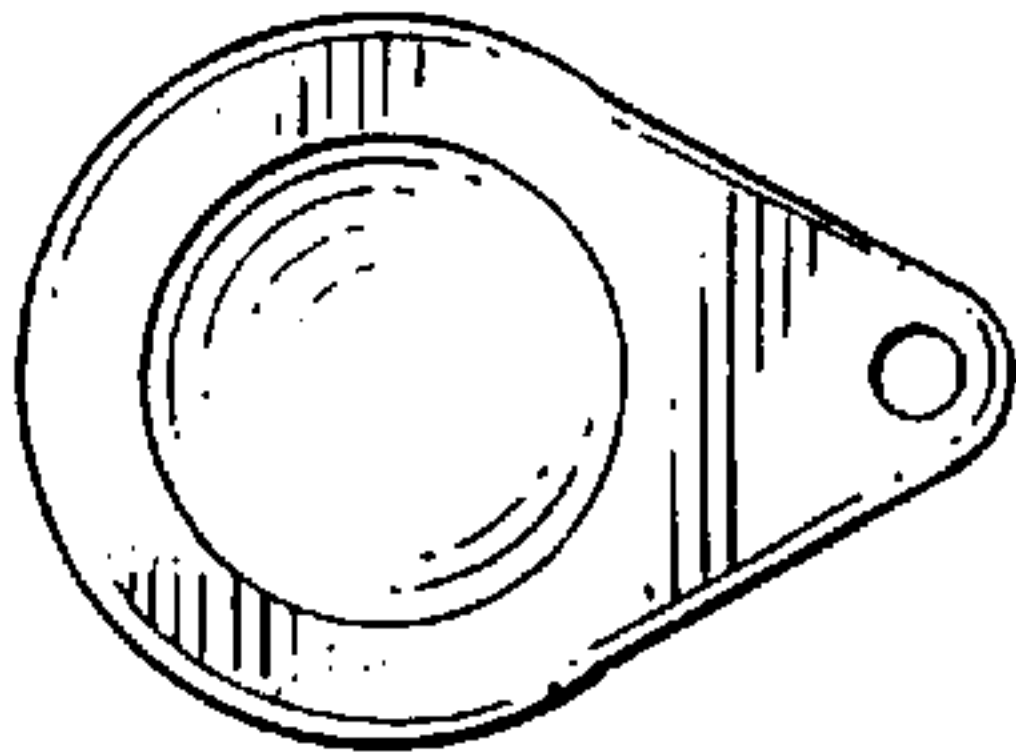

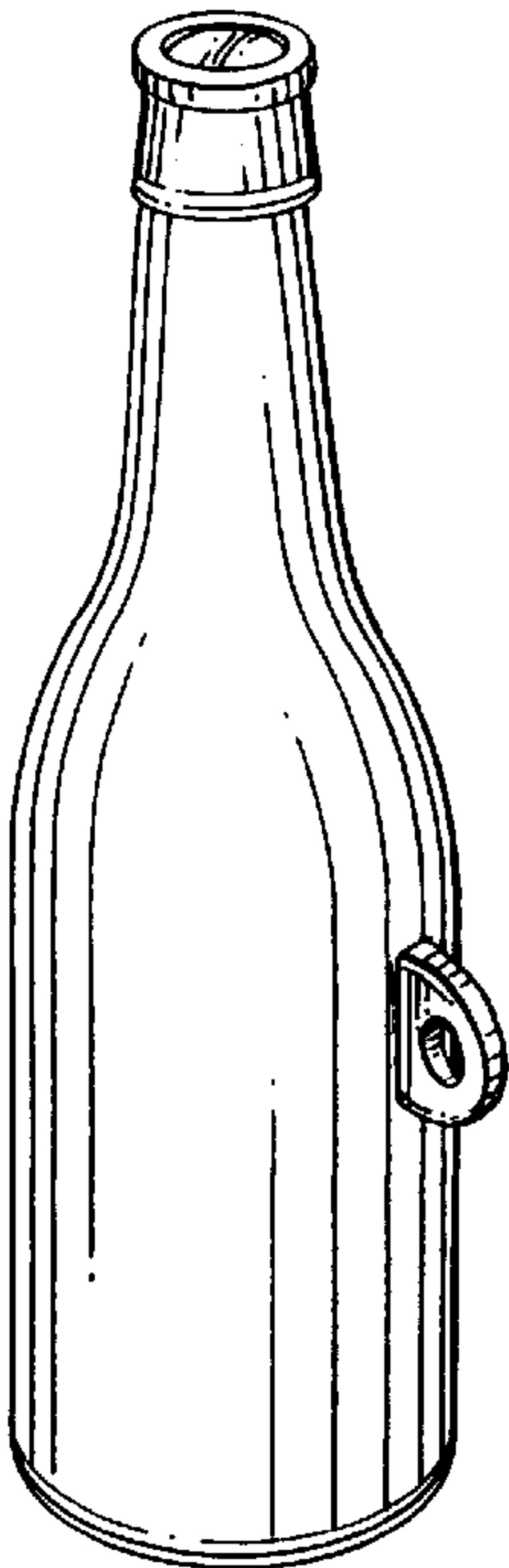

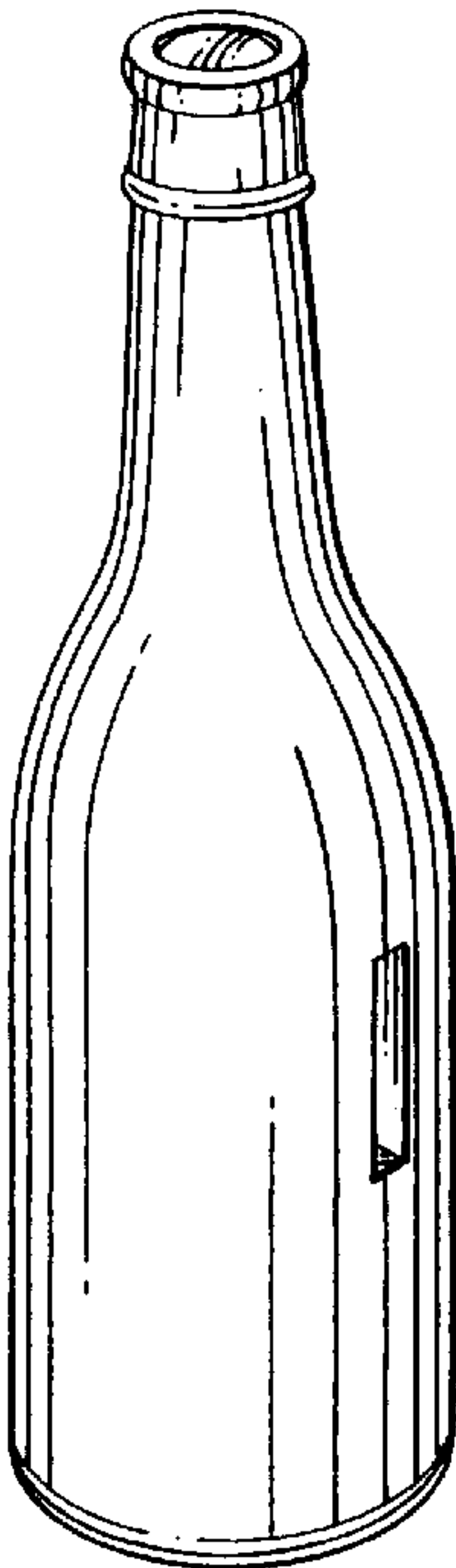

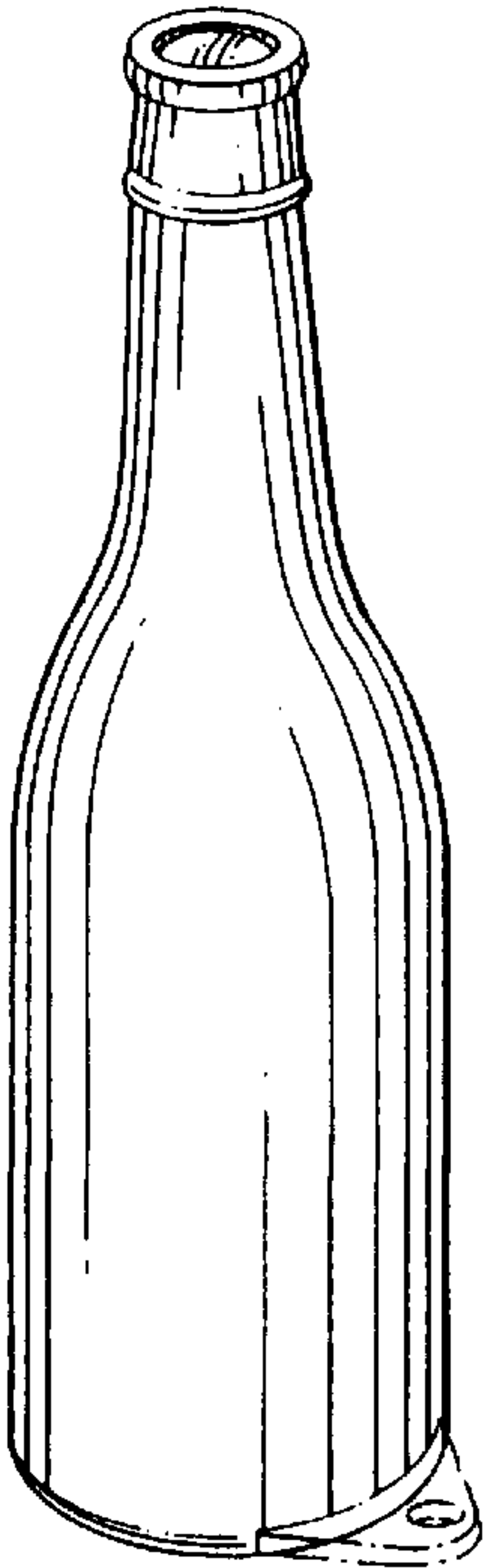

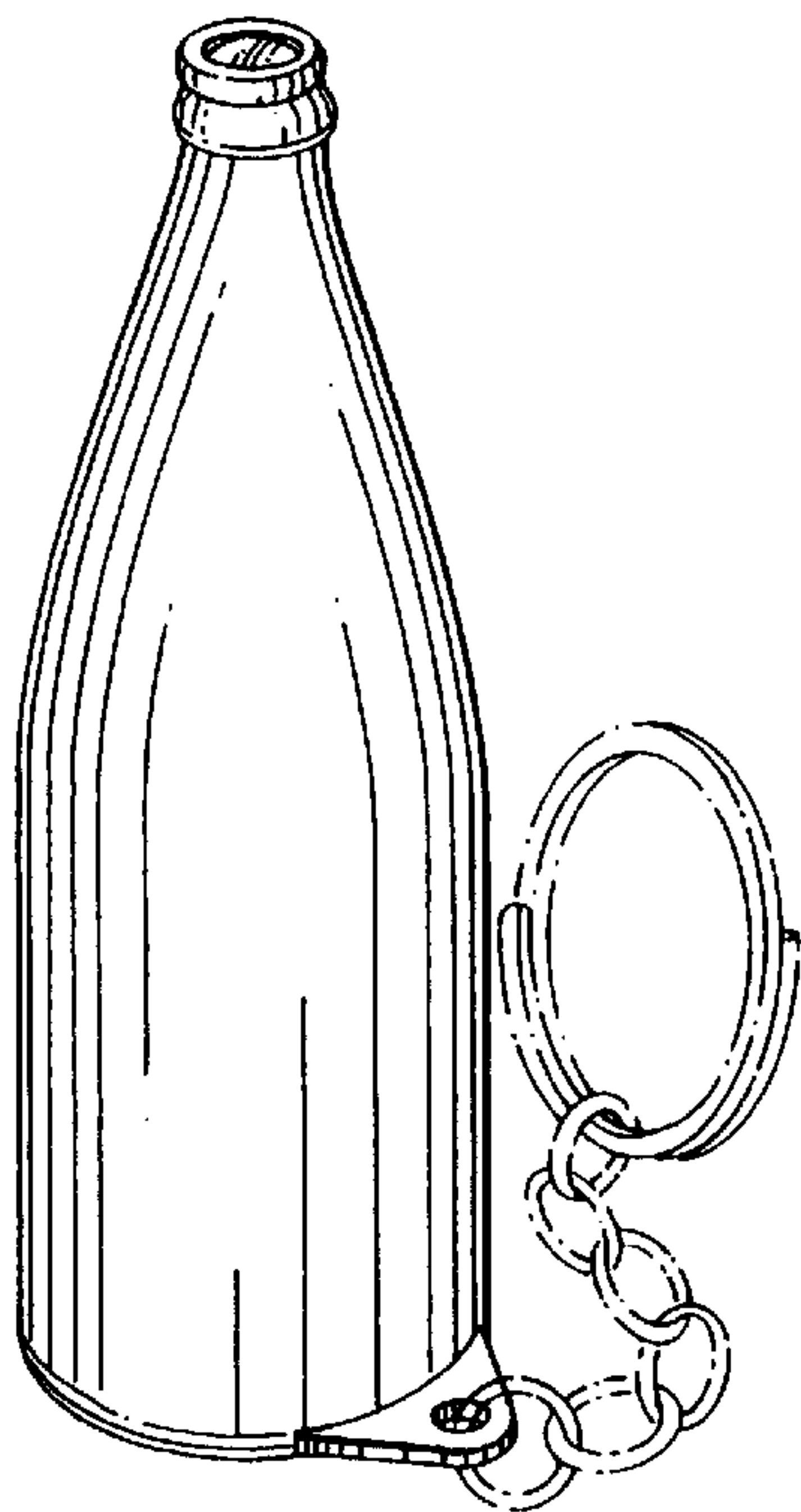

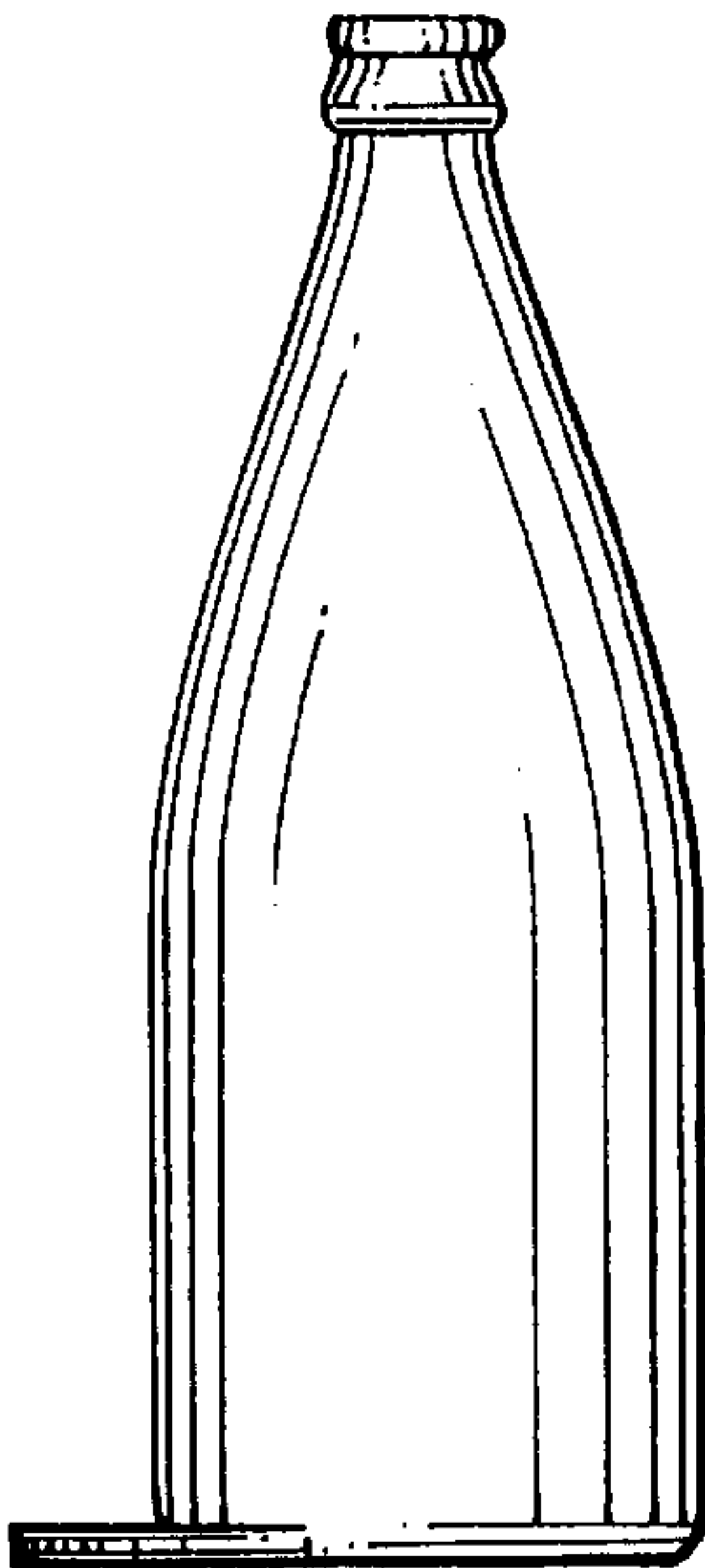

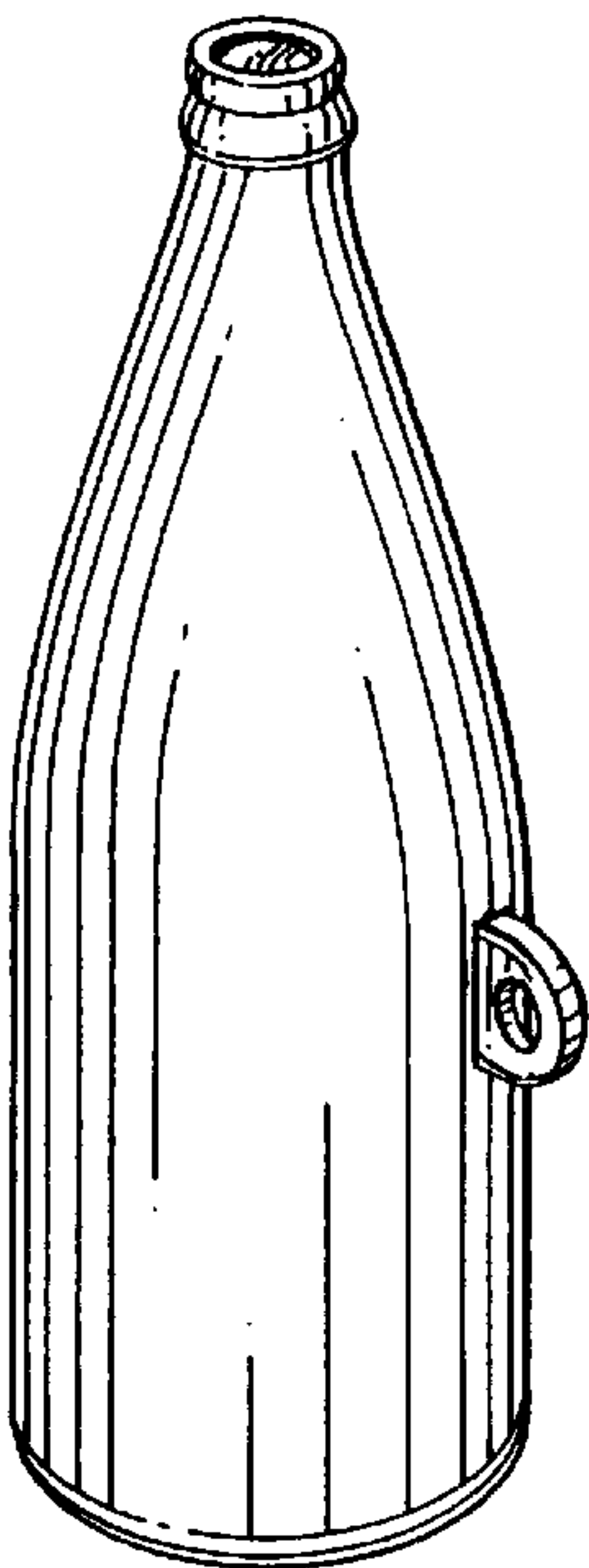

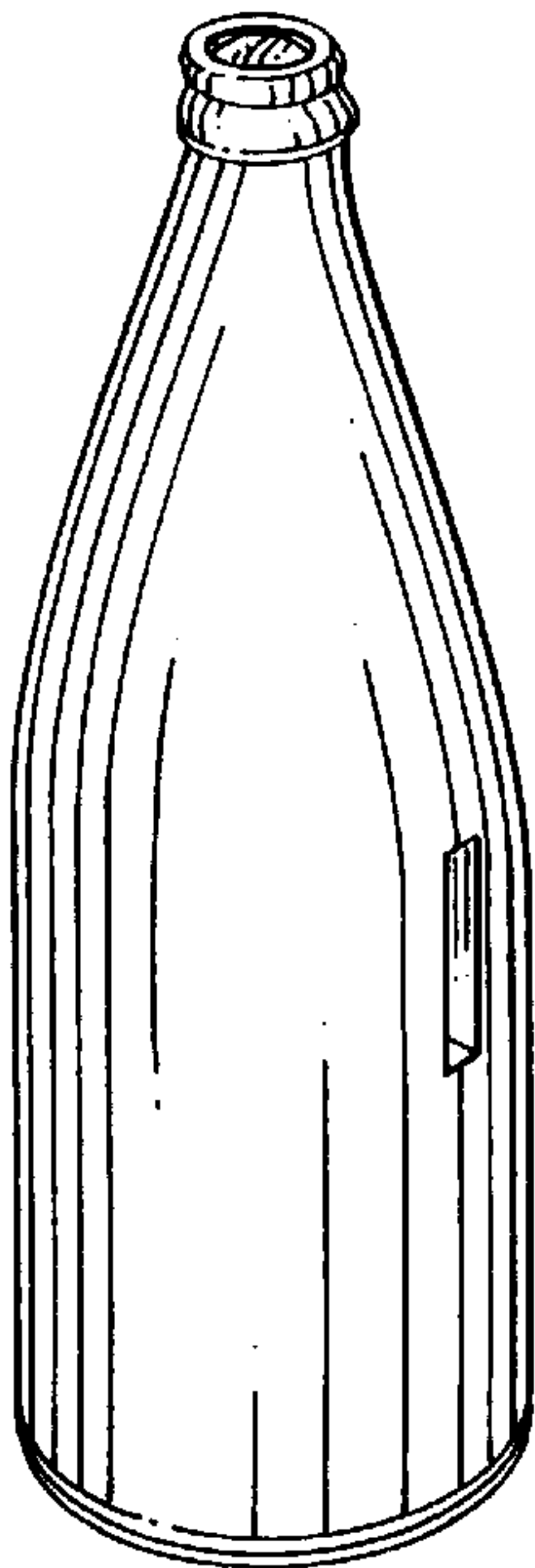

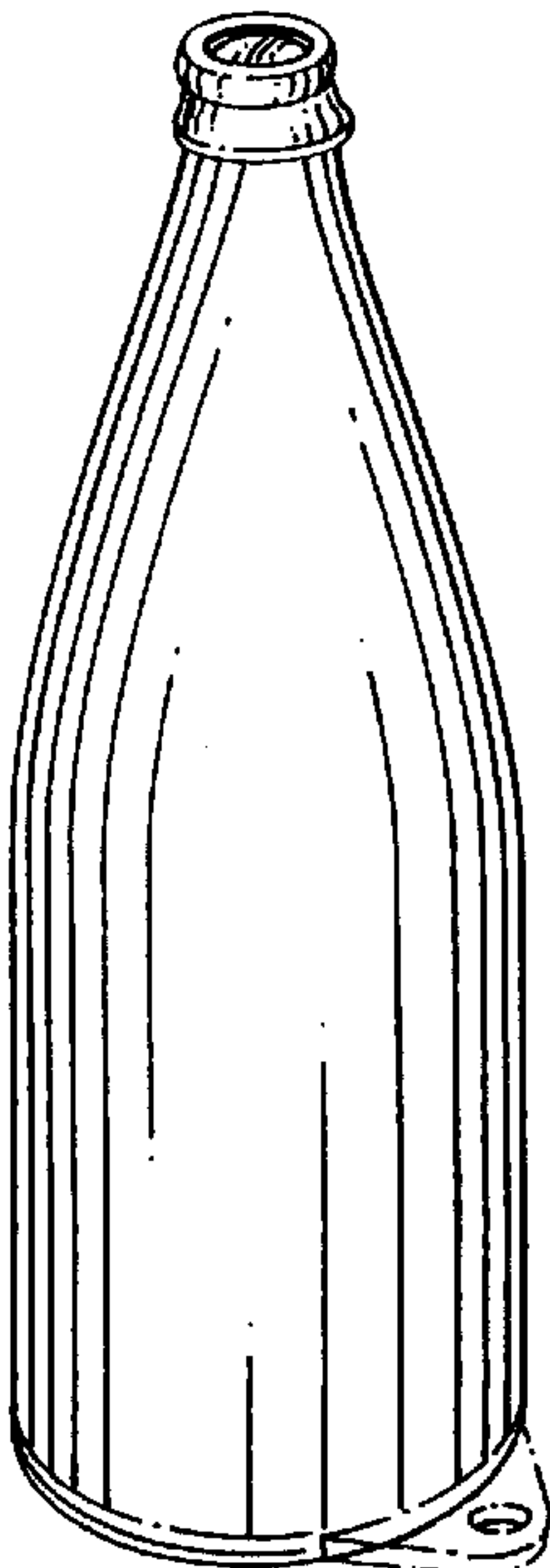
