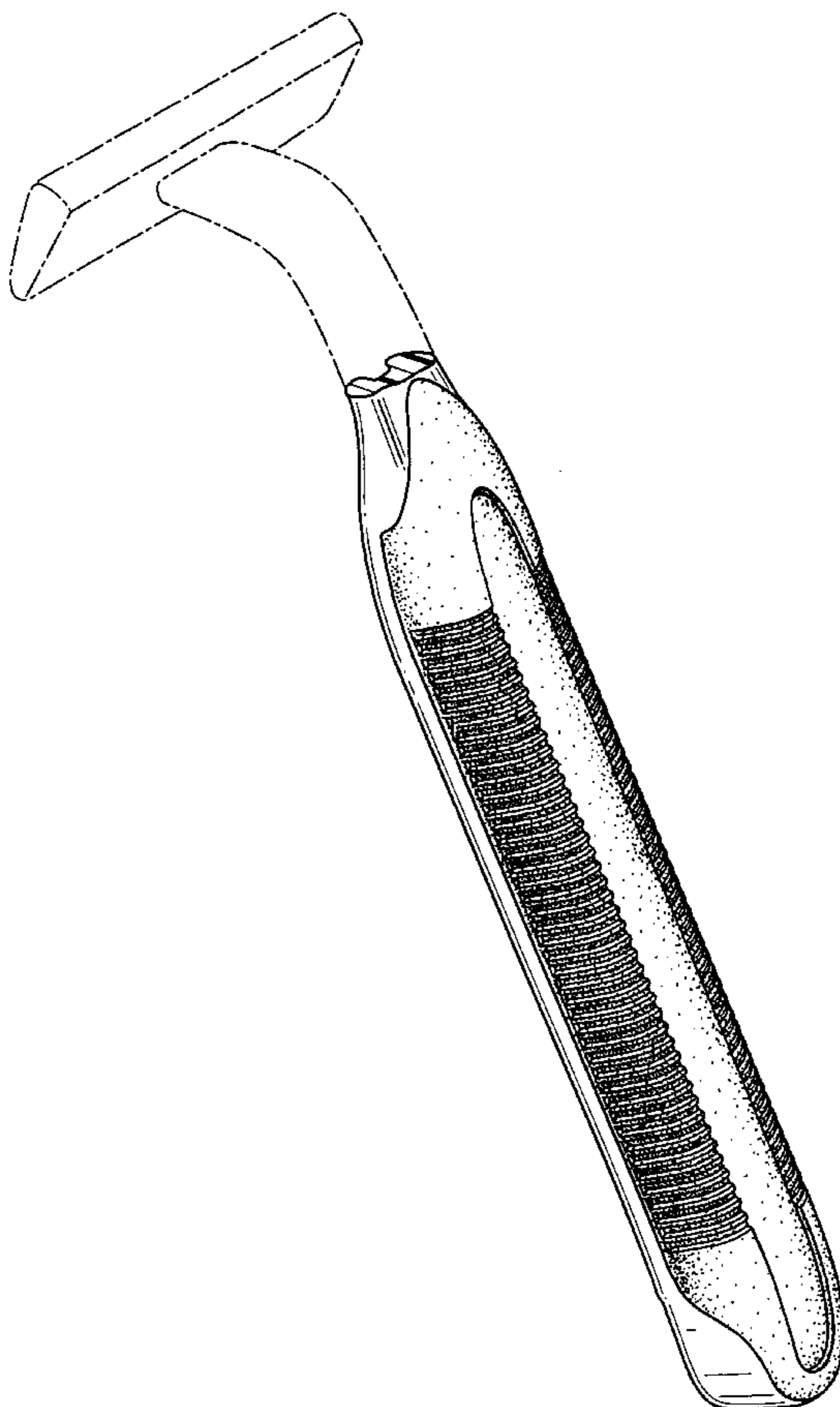
[57] **CLAIM**

I claim the ornamental design for a razor handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a razor handle;
FIG. 2 is a top plan view thereof;
FIG. 3 is a right side elevational view thereof, the left side elevation being a mirror image;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a front elevational view thereof; and,
FIG. 6 is a rear elevational view thereof.
The broken line disclosure of the shaving unit is for illustrative purposes only and does not constitute a part of the claimed design.

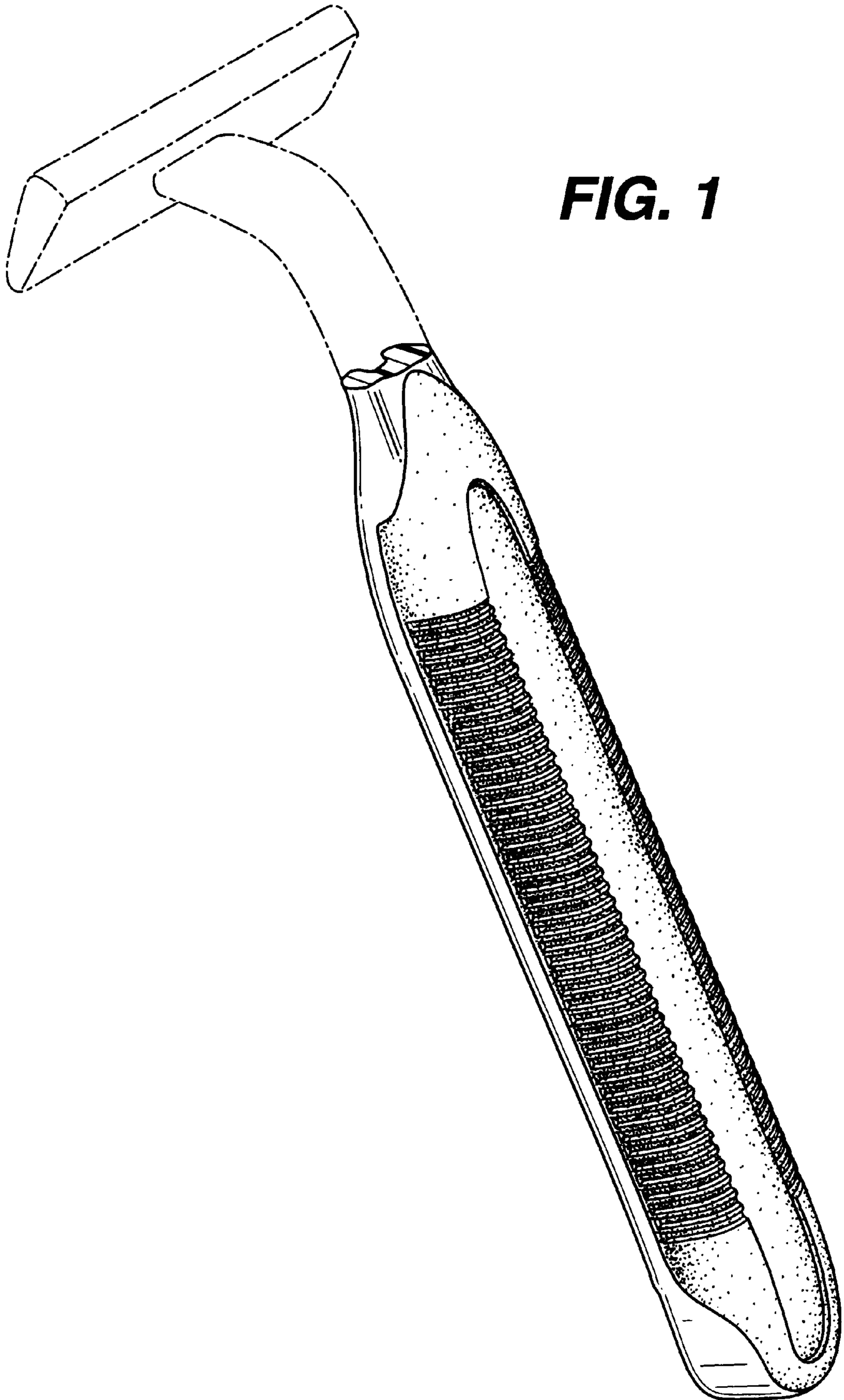

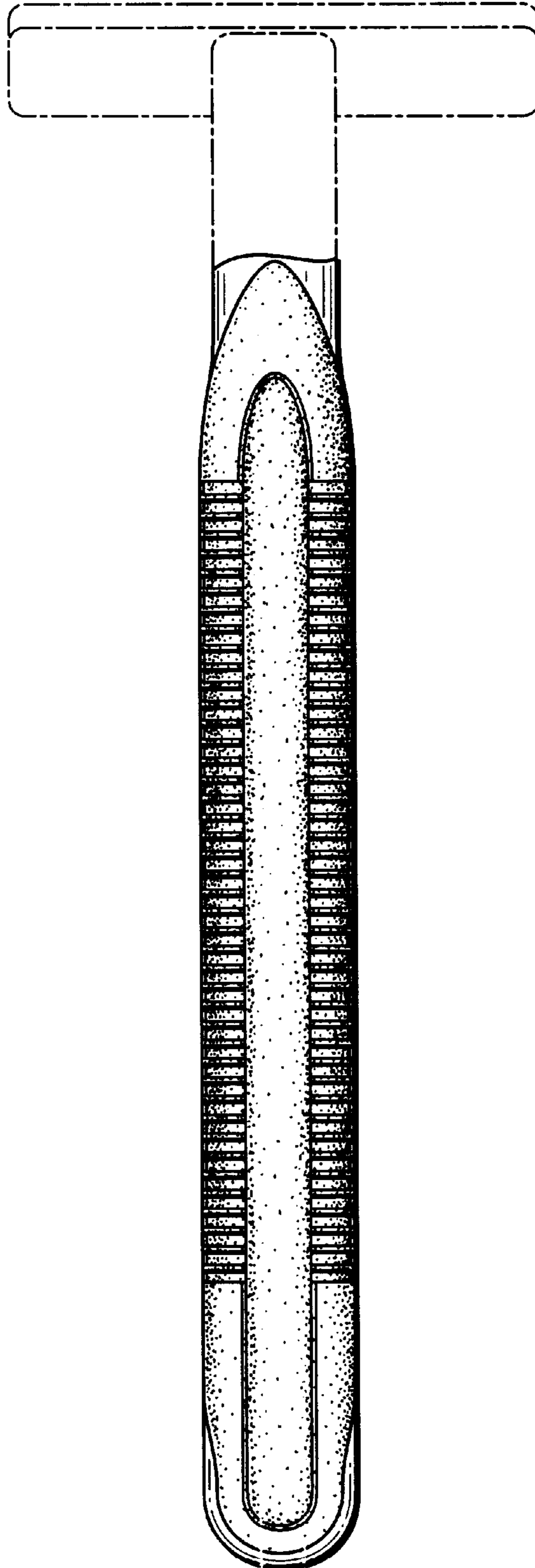

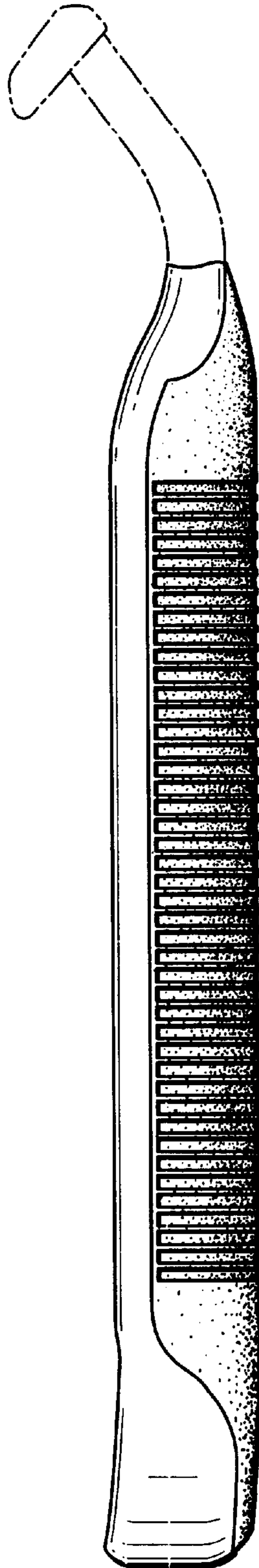

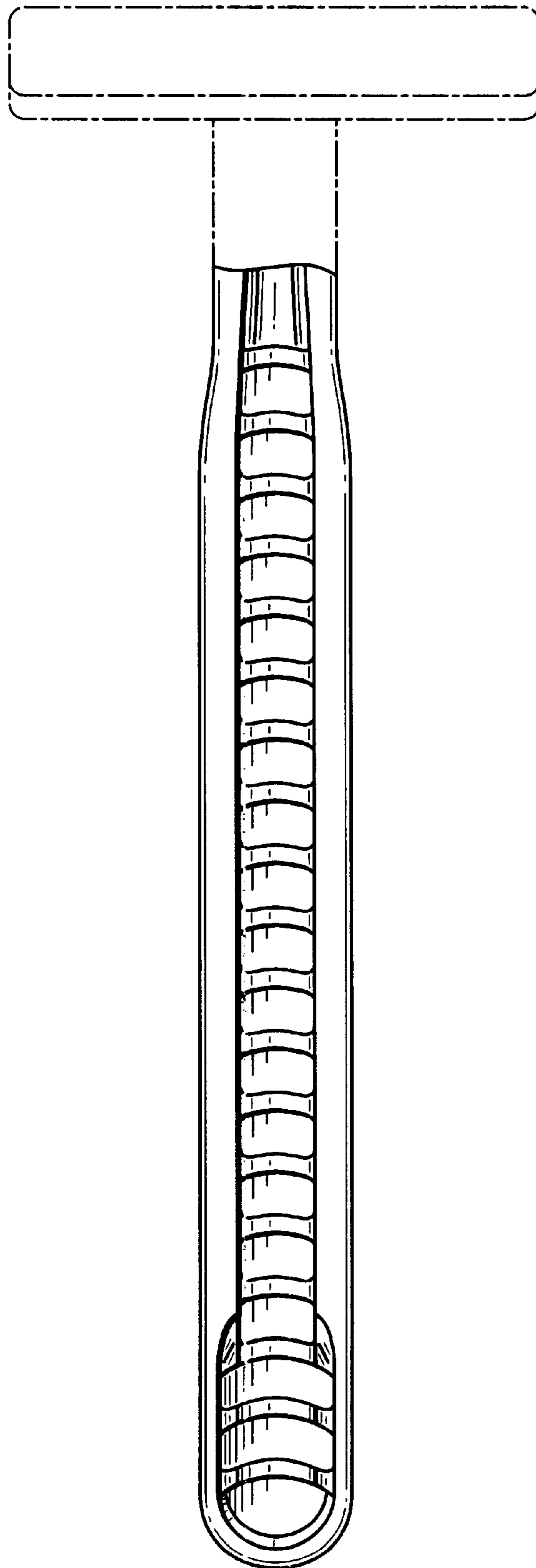

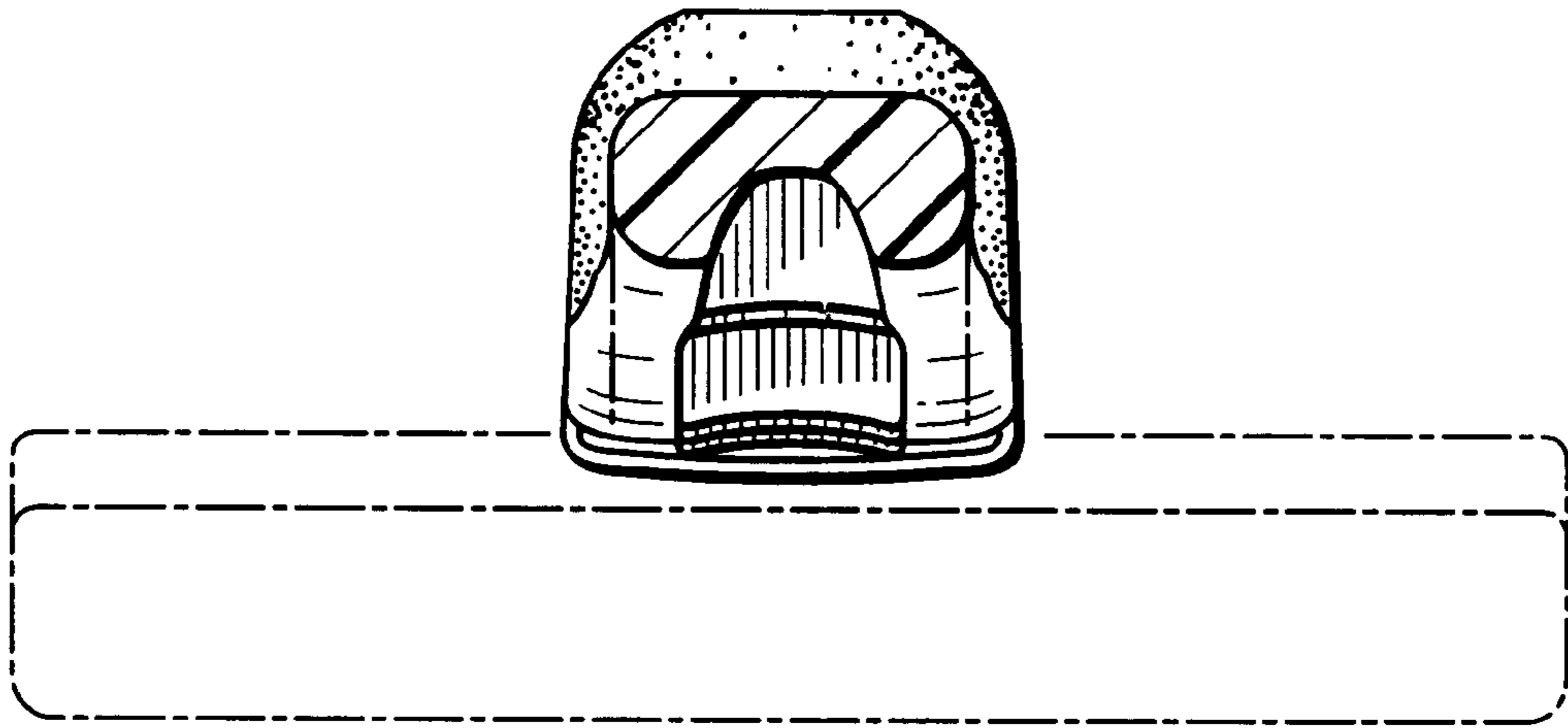
